# A SHORT COMMUNICATION ON THE CONSTANTS OF THE MULTILINEAR HARDY-LITTLEWOOD INEQUALITY

ABSTRACT. It was recently proved that for  $p > 2m^3 - 4m^2 + 2m$  the constants of the Hardy–Littlewood inequality for *m*-linear forms on  $\ell_p$ -spaces are less than or equal to the best known estimates of respective constants of the Bohnenblust–Hille inequality. In this note we obtain upper bounds for opposite side, i.e., the constants when  $2m \le p \le 2m^3 - 4m^2 + 2m$ . For these values of *p* our result improves previous estimates from 2014 of Araujo *et al.* for all  $m \ge 3$ .

### 1. INTRODUCTION

Let  $\mathbb{K}$  be the real scalar field  $\mathbb{R}$  or the complex scalar field  $\mathbb{C}$ . For any integer  $m \geq 2$ , the Hardy– Littlewood inequality (see [1, 7, 8, 12]) for *m*-linear forms asserts that for  $2m \leq p \leq \infty$  there exists a constant  $C_{m,p}^{\mathbb{K}} \geq 1$  such that, for all *m*-linear forms  $T : \ell_p^n \times \cdots \times \ell_p^n \to \mathbb{K}$  and all positive integers n,

(1) 
$$\left(\sum_{j_1,\dots,j_m=1}^n |T(e_{j_1},\dots,e_{j_m})|^{\frac{2mp}{mp+p-2m}}\right)^{\frac{mp+p-2m}{2mp}} \le C_{m,p}^{\mathbb{K}} \|T\|.$$

Moreover, the exponents  $\frac{2mp}{mp+p-2m}$  are optimal. The case  $p = \infty$  recovers the famous Bohnenblust-Hille inequality (see [6]):

**Theorem** (Bohnenblust–Hille inequality). There exists a constant  $B_{\mathbb{K},m}^{\text{mult}} \geq 1$  such that for all *m*–linear forms  $T : \ell_{\infty}^{n} \times \cdots \times \ell_{\infty}^{n} \to \mathbb{K}$  and all positive integers n,

(2) 
$$\left(\sum_{j_1,\dots,j_m=1}^n |T(e_{j_1},\dots,e_{j_m})|^{\frac{2m}{m+1}}\right)^{\frac{m+1}{2m}} \le B_{\mathbb{K},m}^{\text{mult}} \|T\|.$$

These inequalities are, in some sense, predecessors of the multilinear theory of absolutely summing operators (for details and recent results on multilinear summing operators we refer to [5, 9, 11, 13] and the references therein).

The achievement of the optimal values of  $B_{\mathbb{K},m}^{\text{mult}}$  and/or  $C_{m,p}^{\mathbb{K}}$  is a quite challenging problem and seems to be far from a definitive answer. From [4] we know that  $B_{\mathbb{K},m}^{\text{mult}}$  are dominated by constants with sublinear growth, or more specifically,

$$\begin{split} B^{\text{mult}}_{\mathbb{C},m} &< 1.3 \cdot m^{\frac{2 - \log 2 - \gamma}{2}} < 1.3 \cdot m^{0.36482}, \\ B^{\text{mult}}_{\mathbb{R},m} &< m^{\frac{1 - \gamma}{2}} < m^{0.21139}, \end{split}$$

where  $\gamma$  from now on denotes the Euler–Mascheroni constant. On the other hand, the best known upper bounds for the constants in (1) were, until very recently,  $(\sqrt{2})^{m-1}$  (see [1, 7]). In 2014, the upper estimate  $(\sqrt{2})^{m-1}$  was improved in the papers [2, 3]:

• (Araujo *et al.* [3]) For all integers  $m \ge 2$  and  $p \in [2m, \infty)$  we have

(3) 
$$C_{m,p}^{\mathbb{R}} < \left(\sqrt{2}\right)^{\frac{2m(m-1)}{p}} \left(1.3 \cdot m^{0.36482}\right)^{\frac{p-2m}{p}},$$
$$C_{m,p}^{\mathbb{C}} < \left(\frac{2}{\sqrt{\pi}}\right)^{\frac{2m(m-1)}{p}} \left(m^{0.21139}\right)^{\frac{p-2m}{p}}.$$

• (Araujo *et al.* [2]) For all integers  $m \ge 2$  and  $p \in (2m^3 - 4m^2 + 2m, \infty)$  we have

(4) 
$$C_{m,p}^{\mathbb{R}} < 1.3 \cdot m^{\frac{2 - \log 2 - \gamma}{2}} < 1.3 \cdot m^{0.36482}$$
$$C_{m,p}^{\mathbb{C}} < m^{\frac{1 - \gamma}{2}} < m^{0.21139}.$$

A close look at (3) and (4) shows a surprising lack of continuity when  $p = 2m^3 - 4m^2 + 2m$ , i.e., by making  $p \to 2m^3 - 4m^2 + 2m$  in (4) we do not recover the estimate (3) for  $p = 2m^3 - 4m^2 + 2m$ . In this note we provide better estimates for the case  $2m \le p \le 2m^3 - 4m^2 + 2m$ , improving (3) whenever  $m \ge 3$  (when m = 2 our argument would provide the same constants from [2]). Moreover, our estimates are continuous when compared with (4). More precisely, we prove the following result:

**Theorem 1.1.** Let  $m \ge 3$  be a positive integer. For  $2m \le p \le 2m^3 - 4m^2 + 2m$  there is a constant  $C_{m,p}^{\mathbb{K}} \ge 1$  such that, for all m-linear forms  $T : \ell_p^n \times \cdots \times \ell_p^n \to \mathbb{K}$  and all positive integers n,

$$\left(\sum_{j_1,\dots,j_m=1}^n |T(e_{j_1},\dots,e_{j_m})|^{\frac{2mp}{mp+p-2m}}\right)^{\frac{mp+p-2m}{2mp}} \le C_{m,p}^{\mathbb{K}} \|T\|,$$

and

(5) 
$$C_{m,p}^{\mathbb{R}} < \left(1.3 \cdot m^{\frac{2-\log 2-\gamma}{2}}\right)^{(m-1)\left(\frac{2m-p+mp-2m^2}{m^2p-2mp}\right)} \left(\sqrt{2}\right)^{\frac{1}{mp(m-2)}\left(p-2m-mp+6m^2-6m^3+2m^4\right)} \\ C_{m,p}^{\mathbb{C}} < \left(m^{\frac{1-\gamma}{2}}\right)^{(m-1)\left(\frac{2m-p+mp-2m^2}{m^2p-2mp}\right)} \left(\frac{2}{\sqrt{\pi}}\right)^{\frac{1}{mp(m-2)}\left(p-2m-mp+6m^2-6m^3+2m^4\right)} ,$$

where  $\gamma$  is the Euler–Mascheroni constant.

**Remark 1.2.** When  $p = 2m^3 - 4m^2 + 2m$  we easily note that the estimates (5) coincide with (4). It is also not difficult to verify that the estimates of (5) are better than (3).

#### 2. The proof

The proof follows the lines of the proof of [3] with a technical change in the interpolation procedure. Let

$$s = \frac{2mp}{mp + p - 2m}$$

and note that  $\frac{2m}{m+1} \leq s \leq 2$ . Let also

$$\lambda_0 = \frac{2s}{ms + s - 2m + 2}$$

 $\lambda_0 < s \le 2.$ 

and note that

$$\frac{m-1}{s} + \frac{1}{\lambda_0} = \frac{m+1}{2},$$

 $\mathbf{2}$ 

Since

from the generalized Bohnenblust-Hille inequality (see [1, Theorem 1.1]) we know that there is a constant  $C_m \geq 1$  such that for all *m*-linear forms  $T : \ell_{\infty}^n \times \cdots \times \ell_{\infty}^n \to \mathbb{K}$  we have, for all i = 1, ..., m and all positive integers n,

(6) 
$$\left(\sum_{j_i=1}^n \left(\sum_{\hat{j}_i=1}^n |T(e_{j_1},...,e_{j_m})|^s\right)^{\frac{1}{s}\lambda_0}\right)^{\frac{1}{\lambda_0}} \le C_m \|T\|$$

Above, as usual,  $\sum_{\hat{j}_i=1}^n$  means that we are summing over all  $j_k$  for all  $k \neq i$ .

Now we need a good estimate for the constant  $C_m$  in (6). For this task, note that the multiple exponent

 $(\lambda_0, s, s, ..., s)$ 

is the result of the interpolation (in the sense of [1, Section 2]) of the multiple exponents

$$\begin{cases} E_1 = \left(\frac{2m-2}{m}, \dots, \frac{2m-2}{m}, 2\right) \\ E_2 = \left(\frac{2m-2}{m}, \frac{2m-2}{m}, \dots, 2, \frac{2m-2}{m}\right) \\ \vdots \\ E_{m-1} = \left(\frac{2m-2}{m}, 2, \frac{2m-2}{m}, \dots, \frac{2m-2}{m}\right) \\ E_m = (1, 2, \dots, 2) \end{cases}$$

with, respectively,

$$\theta_1 = \dots = \theta_{m-1} = \frac{2m - p + mp - 2m^2}{m^2 p - 2mp}$$
  
 $\theta_m = 1 - (m-1) \left(\frac{2m - p + mp - 2m^2}{m^2 p - 2mp}\right)$ 

Above note that we have used the hypothesis  $2m \leq p \leq 2m^3 - 4m^2 + 2m$ . From [2, 4] we know that for the multiple exponents  $E_1, ..., E_{m-1}$  the inequality (6) is valid with constants  $1.3 \cdot m^{\frac{2-\log 2-\gamma}{2}}$  for real scalars and  $m^{\frac{1-\gamma}{2}}$  for complex scalars. On the other hand, it is well known that the constant associated with the multiple exponent (1, 2, ..., 2) is  $(\sqrt{2})^{m-1}$  for real scalars (see [10]) and less than or equal to  $(\frac{2}{\sqrt{\pi}})^{m-1}$  for complex scalars. Therefore, the optimal constant associated to the multiple exponent

$$(\lambda_0, s, s, ..., s)$$

is less than or equal to

$$\left(1.3 \cdot m^{\frac{2-\log 2-\gamma}{2}}\right)^{(m-1)\left(\frac{2m-p+mp-2m^2}{m^2p-2mp}\right)} \left(\sqrt{2}\right)^{\frac{1}{mp(m-2)}\left(p-2m-mp+6m^2-6m^3+2m^4\right)}$$

for real scalars and

$$\left(m^{\frac{1-\gamma}{2}}\right)^{(m-1)\left(\frac{2m-p+mp-2m^2}{m^2p-2mp}\right)} \left(\frac{2}{\sqrt{\pi}}\right)^{\frac{1}{mp(m-2)}\left(p-2m-mp+6m^2-6m^3+2m^4\right)}$$

for complex scalars.

Let

$$\lambda_j = \frac{\lambda_0 p}{p - \lambda_0 j}$$

for all j = 1, ..., m. Note that

$$\lambda_m = s$$

and that the conjugate number of  $\left(\frac{p}{\lambda_j}\right)$  is  $\frac{\lambda_{j+1}}{\lambda_j}$ , i.e.,

$$\left(\frac{p}{\lambda_j}\right)^* = \frac{\lambda_{j+1}}{\lambda_j}$$

for all j = 0, ..., m - 1. Now the proof follows straightforwardly the lines of [3].




FIGURE 1. Exponent of  $\sqrt{2}$  in (5)

## 3. FINAL REMARK: A MORE GENERAL APPROACH

The Hardy–Littlewood inequality for multilinear forms has the following version for multiple exponents: **Theorem (Generalized Hardy–Littlewood inequality, (**[1], **2014**)**).** Let  $m \ge 2$  be a positive integer,  $2m \le p \le \infty$  and  $\mathbf{q} := (q_1, ..., q_m) \in \left[\frac{p}{p-m}, 2\right]^m$  be such that  $1 \qquad 1 \qquad mn+n-2m$ 

(7) 
$$\frac{1}{q_1} + \dots + \frac{1}{q_m} = \frac{mp + p - 2m}{2p}$$

Then there exists a constant  $C_{m,p,\mathbf{q}}^{\mathbb{K}} \geq 1$  such that

(8) 
$$\left(\sum_{j_1=1}^n \left(\sum_{j_2=1}^n \left(\cdots \left(\sum_{j_m=1}^n |T(e_{j_1}, \dots, e_{j_m})|^{q_m}\right)^{\frac{q_{m-1}}{q_m}} \cdots \right)^{\frac{q_2}{q_3}}\right)^{\frac{q_1}{q_2}}\right)^{\frac{1}{q_1}} \le C_{m,p,\mathbf{q}}^{\mathbb{K}} \|T\|$$

for all m-linear forms  $T: \ell_p^n \times \cdots \times \ell_p^n \to \mathbb{K}$  and all positive integers n.

In [2] the following result is proved:

**Theorem 3.1.** ([2])Let  $m \ge 2$  be a positive integer and  $2m . Let also <math>\mathbf{q} := (q_1, ..., q_m) \in \left[\frac{p}{p-m}, 2\right]^m$  be such that  $\frac{1}{q_1} + \dots + \frac{1}{q_m} = \frac{mp+p-2m}{2p}$ . If  $\max q_i < \frac{2m^2 - 4m + 2}{m^2 - m - 1}$ , then  $C_{m,p,\mathbf{q}}^{\mathbb{R}} < 1.3 \cdot m^{\frac{2-\log 2 - \gamma}{2}} < 1.3 \cdot m^{0.36482}$ ,  $C_{m,p,\mathbf{q}}^{\mathbb{C}} < m^{\frac{1-\gamma}{2}} < m^{0.21139}$ .

Using the same ideas of the previous section and following the lines of [2] we can prove the following result (the proof is long, although the arguments are similar to the previous, and we left the details for the interested reader):

**Theorem 3.2.** Let  $m \ge 2$  be a positive integer and  $2m \le p \le \infty$ . Let also  $\mathbf{q} := (q_1, ..., q_m) \in \left[\frac{p}{p-m}, 2\right]^m$  be such that  $1 \qquad 1 \qquad mp+p-2m$ 

$$\frac{1}{q_1} + \dots + \frac{1}{q_m} = \frac{mp + p - 2r}{2p}$$

and

(9) 
$$\max q_i \ge \frac{2m^2 - 4m + 2}{m^2 - m - 1}.$$

For all m-linear forms  $T: \ell_p^n \times \cdots \times \ell_p^n \to \mathbb{K}$  and all positive integers n, we have

$$\left(\sum_{j_1=1}^n \left(\sum_{j_2=1}^n \left(\cdots \left(\sum_{j_m=1}^n |T(e_{j_1}, \dots, e_{j_m})|^{q_m}\right)^{\frac{q_{m-1}}{q_m}} \cdots \right)^{\frac{q_2}{q_3}}\right)^{\frac{q_1}{q_2}}\right)^{\frac{1}{q_1}} \le C_{m,p,\mathbf{q}}^{\mathbb{K}} \|T\|,$$

with

$$C_{m,p,\mathbf{q}}^{\mathbb{C}} \leq \left(\frac{2}{\sqrt{\pi}}\right)^{(m-1)\theta_1} (\eta_{\mathbb{C},m})^{\theta_2},$$
$$C_{m,p,\mathbf{q}}^{\mathbb{R}} \leq \left(\sqrt{2}\right)^{(m-1)\theta_1} (\eta_{\mathbb{R},m})^{\theta_2},$$

where  $(\theta_1, \theta_2) = (1, 0)$  if m = 2 and

(10) 
$$\theta_1 = 1 - \frac{(m+1)\left(2 - \max q_i\right)\left(m-1\right)^2}{(m^2 - m - 2)\max q_i} \text{ and } \theta_2 = \frac{(m+1)\left(2 - \max q_i\right)\left(m-1\right)^2}{(m^2 - m - 2)\max q_i}$$

for  $m \geq 3$ .

Note that now we have continuity between the estimates of Theorem 3.2 and Theorem 3.1 since

$$\frac{(m+1)\left(2 - \max q_i\right)(m-1)^2}{(m^2 - m - 2)\max q_i} = 1$$

when  $\max q_i = \frac{2m^2 - 4m + 2}{m^2 - m - 1}$ .
