

LICENSE AGREEMENT № _____
On the Use of the Work.

, hereinafter referred to as **the Licensor (Licensors)**, and the Institute of Molecular Biology and Genetics of the National Academy of Sciences of Ukraine represented by the Director, Academician of the National Academy of Sciences of Ukraine Tukalo Mykhailo Arsentiiiovych, acting on the basis of the Statute, hereinafter referred to as **the Licensee**, have made this Agreement on the following:

1. Subject of the Agreement

1.1. 1.1. The Licensor (Licensors) grants to the Licensee a free-of-charge exclusive license to use the written Work (scientific, technical, or other)

, hereinafter referred to as **the Work**, while the Licensee obtains the right to grant a sub-license to the Publishing Organization "Publishing House "Akademperiodyka" of the NAS of Ukraine", hereinafter referred to as **the Publishing Organization**, to the extent specified in clauses 2.1-2.4. of the Agreement.

2. Ownership rights to be granted to the Licensee

2.1. The Licensee obtains the following rights:

2.1.1. Use the Works by means of their publication in the journal "Biopolymers & Cell", hereinafter referred to as **the Publication**, in the Ukrainian and English languages;

2.1.2. Use the Works on the basis of terms and conditions of the open access license *Creative Commons CC BY-NC-ND* (Attribution — Non-Commercial — No Derivatives) or *CC BY-NC* (Attribution — Non-Commercial), as stated on the first pages of scientific articles;

2.1.3. Exercise, in the territory of Ukraine and other countries during the period of the copyright for the Publications and Works, the right to:

2.1.3.1. edit abstracts in the Ukrainian language,

2.1.3.2. prepare the original layout,

2.1.3.3. copy the Work in accordance with the approved Schedule of the preparation and release of the journal as agreed by the Licensor and the Publishing Organization,

2.1.3.4. distribute the Publication, on a free-of-charge basis, in the territory of Ukraine and other countries, in compliance with the relevant resolution of the Presidium of the National Academy of Sciences of Ukraine, by means of:

- (1) the subscription, prepayment, sale, and free-of-charge delivery, including electronic copies of the Publication and the Works and their translations;
- (2) providing Internet access, including on the basis of open access licenses *Creative Commons*;
- (3) incorporating in collections of articles, databases, etc.;
- (4) sending check and legal copies of the Publication in compliance with the effective legislation of Ukraine;
- (5) the preparation of additional copies of the published materials in paper and electronic forms;
- (6) the translation of the Publication and the Works;
- (7) the distribution of the Publication and Works in the territory of Ukraine and other countries by means of publishing the Publication and Works in other periodicals and collections, including the foreign ones.

2.2. The Licensor has the right to use the Work in compliance with terms and conditions of an appropriate open access license, including the right to:

2.2.1. upload the Work on the author's (Licensor's) website or on the website or server of the institution where the author (Licensor) works, provided that the original source of the publication is indicated;

2.2.2. distribute copies of the Work in electronic and paper forms;

2.2.3. incorporate the Work in collections of articles, databases, etc.;

2.2.4. revise and modify the Work, create and distribute the derivative Works.

3. Applicable geographical area of the use of the Work

3.1. The Licensor (Licensors) grants the Licensee the right to use the Work in the manner specified in clause 2.1. of this Agreement in the territory of Ukraine, as well as the right to distribute the Work or part thereof as an integral component of the Publication in the territory of Ukraine and other countries by means of subscription, sale, and free-of-charge delivery of the Publication.

4. Duration of the rights granted

4.1 The Agreement shall be effective from the date of its signing and shall be concluded for a term of 25 years, but not longer than the term of the exclusive ownership right to the Work.

4.2. The term of the Agreement may be extended in accordance with the effective legislation of Ukraine.

4.3. If the Work is not accepted for publication by the Editorial Board, or the Licensor(s) withdraws the manuscript before its release in the Publication, this Agreement shall be terminated.

5. Cautionary notes

5.1. The Licensor (Licensors) declares that:

- he/she is the author (co-author) of the Work;
- the copyright to this Work has not been previously transferred to third parties;
- this Work has not been previously published and will not be published in any other edition before its publication by the Licensee under this Agreement;

— he/she has the right to grant permission to use the Work under this Agreement if the Work was created by the Licensor(s) in the course of fulfillment of an employment or another contract (the Work is an assigned or commissioned work);

— he/she did not violate the intellectual property rights of other persons. If the Work contains materials of other persons, except for cases of citation to the extent justified by the scientific, informational, or critical nature of the Work, the Licensor shall use such materials in compliance with the law;

— he/she has obtained all necessary permissions to use the results, facts, illustrations, and other transferred materials, the copyright holder of which is not him/her;

— the Work does not contain information that is forbidden for publication by the current legislation of Ukraine, and its printing and/or distribution by the Licensee will not lead to the disclosure of secret (confidential) information (including state and official secrets).

5.2. The Licensor (Licensors) gives the Licensee his/her consent to the publication of the following personal data:

— surname, name, patronymic;

— information on professional qualifications (academic degree, academic title);

— information about the place of work and position;

— contacts of the authors;

— information on the availability of works published under the name of the Licensor (Licensors) in national and international scientific databases with the purpose of their further processing in order to carry out search operations in these databases.

6. Responsibility of the parties

The parties shall be responsible for the failure to fulfill or for the improper fulfillment of the provisions of this Agreement in accordance with the effective legislation of Ukraine.
