Beyond Collins and Sivers: further measurements of the target transverse spin-dependent azim uthal asymmetries in semi-inclusive DIS from COM PASS

In sem i-inclusive D IS of polarized leptons on a transversely polarized target eight azim uthalm odulations appear in the cross-section. W ithin QCD parton m odel four azim uthalasym m etries can be interpreted at leading order, two of them being the already m easured Collins and Sivers asym m etries. The other two leading twist asym m etries, related to di erent transverse m om entum dependent quark distribution functions, and also additional four asym m etries which can be interpreted as twist-three contributions have been m easured for the rst tim e at COM PASS, using a 160 G eV /c longitudinally polarized (P_{beam} ' 0:8) m uon beam and a transversely polarized ⁶L iD target. W e present here the prelim inary results from the 2002-2004 data.

1 Introduction

During last few years many exciting experimental results and theory development are obtained in SID IS on the transversely polarized target. Up to now only them easurements [1,2, 3] of Sivers and Collins asymmetries were performed by HERMES and COMPASS collaborations and together with data from BELLE [4] they allow a rst extraction the transversity and Sivers transversem on entum dependent (TMD) distribution functions (DFs) and Collins fragmentation function (FF). In addition to these, the general expression of SID IS cross section [5] contains six more target transverse polarization dependent azim uthal asymmetries. Here we present the preliminary results on these asymmetries for the rst timemeasured by COMPASS from the 2002-2004 data.

1.1 De nition of asym metries

In the following the notations of R ef. [6] are used. There are eight azim uthalm odulations related to the target transverse polarization:

where rst two correspond to Sivers and Collins e ects. The expression for the cross section in interest can be represented as

where S_T is the target transverse polarization. We factored out the explicitly calculable depolarization factors, $D^{W_1(h;s)}$, and dened the asymmetries as the ratios of corresponding structure functions to unpolarized one:

where B = L or B = U corresponds to beam polarization dependent or independent part of asymmetry.

The depolarization factors entering in Eq. (2) depend only on y and are given as

The asymmetries extracted from the data as amplitudes of corresponding azimuthal modulations (raw asymmetries) are then given by

where f is the target polarization dilution factor.

In the QCD parton model the asymmetries $A_{LT}^{\cos(h s)}$ and $A_{UT}^{\sin(3h s)}$ are given by the ratio of convolutions of spin-dependent to spin-independent twist two DFs and FFs, for example

and can be used for extraction of DFs g_{1T}^q and $h_{1T}^{? q}$ describing the quark longitudinal and transverse (along quark transverse m om entum) polarization in the transversely polarized nucleon. The other asymmetries can be interpreted as Cahn kinematic corrections to spin e ects on the transversely polarized nucleon [5], for example:

2 Results

The event selection and asymmetry extraction are done as described in [3]. The following kinematic cuts were imposed: $Q^2 > 1$ (G eV/c)², W > 5 G eV, 0:1 < y < 0.9, $P_T^h > 0:1$ G eV/c and z > 0:2. In Figs. 1 and 2 for the set time we present six target transverse spin dependent asymmetries extracted from COM PASS 2002{2004 data collected on deuterium target. The estimated systematic errors are smaller than statistical. All six new ly measured asymmetries are compatible with zero within statistical errors.
