# How particles em erge from decaying classical elds in heavy ion collisions: tow ards a kinetic description of the G lasm a

A bstract

We develop the form alism discussed previously in hep-ph/0601209 and hep-ph/0605246 to construct a kinetic theory that provides insight into the earliest \G lasm a" stage of a high energy heavy ion collision. Particles produced from the decay of classical elds in the G lasm a obey a Boltzm ann equation whose novel features include an inhomogeneous source term and new contributions to the collision term. We discuss the power counting associated with the di erent term s in the Boltzm ann equation and outline the transition from the eld dom inated regime to the particle dom inated regime in high energy heavy ion collisions.

#### Introduction 1

In two previous papers  $[1,2]$ , we introduced a form alism to compute multiparticle production in eld theories coupled to strong time-dependent external sources. The QCD exam ple of such a eld theory is the Color G lass Condensate (CGC) [3{16]. For simplicity, we considered a  $3$  theory; we believe however that m ost of our results are of general validity and can be extended to gauge theories [17].

In thispaper,wew illaddressa problem in m ulti-particleproduction thatwas not considered in R efs. [1,2]. Speci cally, the approach developed there did not include scattering processes that are in portant for the dynam ics of the system at late tim es. T hese are the so called secular term s w hich are ofhigher order in the coupling constant (loop corrections) and are accom panied by grow ing powers of time [18{20]. The secular contributions must be resum m ed to obtain sensible results. In a quantum  $\epsilon$  eld theory, this resum m ation is performed in principle by solving the D yson-Schw inger equations. In practice, the D yson-Schw inger equations are dicult to solve. For a system of elds coupled to an ensemble of particles, it is well known that the D yson-Schw inger equations can be approxim ated by a Boltzm ann equation for the distribution of particles. The goal of the present paper is to extend the approach of R efs.  $[1,2]$  to derive a kinetic equation that includes the late tim e contributions to m ulti-particle production in eld theories w ith strong externalsources. W e have in m ind the dynam ics after a heavy ion collision, w here the classical eld produced by the colliding nuclei expands rapidly into the vacuum along the beam direction. Our approach m ay also be of relevance to descriptions of the decay of the in aton eld and therm alization in the preheating and reheating phases of the early universe{a nice review with relevant references can be found in Ref. [21]. In both cases, as the classical eld evolves, the occupation num ber decreases and it is m ore appropriate to describe the higher m om entum m odes ofthe system in term s of particle degrees of freedom.

The connections between the classical approximation in eld theory and kinetic equations in the fram ework of nuclear collisions were previously discussed by M ueller and Son [22], and subsequently by Jeon [23]. T hey considered a system of elds in the presence of an ensem ble of particles described by a distribution f. Perform ing a classicalapproxim ation in the path integraldescribing the evolution of this system and a gradient expansion in the obtained D yson-Schw inger equations, these authors obtained a kinetic equation for f. An obvious question arises: w ith w hat accuracy does this kinetic equation reproduce the Boltzm ann equation one would obtain w ithout perform ing the classical approxim ation? The authors of Refs. [22,23] nd that the kinetic equation obtained from the classical path integral reproduces correctly the collision term in the Boltzm ann equation to leading pow er off and (surprisingly) the rst subleading term in f as well.

W e shalladopt a m ore ab initio approach here by considering a system that does not contain any particle degrees of freedom initially, but where the elds are coupled to a strong time-dependent external source j. The external source is assum ed to be a stochastic variable that belongs to an ensemble of charges specied by a distribution  $W$  [j]. This is the typical set up in the description of heavy ion collisions in the C olorG lass C ondensate fram ework w here W [j] represents the distribution of color charges. Because of the expansion of the system , one m ay anticipate that the system can be described by eld theory m ethods at early tim es and by kinetic theory and hydrodynam ics at later tim es. The matter in this regime in heavy ion collisions has interesting properties; two noteworthy possibilities are dynam ically generated topological charge [24,25] and plasm a

instabilities possibly leading to turbulent color elds [26]. This matter has been called an G lasm a [27,28] and understanding its dynam ical evolution holds the key to a deeper understanding of the strongly interacting Q uark G luon P lasm a  $(SQGP)$  that m ay be form ed at later times [29]. The

Wewilladdress here general questions about the dynam icalevolution of such m atter in the simplest possible context of a scalar  $\binom{3}{2}$  eld theory <sup>1</sup>:

- i. What is the kinetic equation one obtains in eld theories coupled to strong external sources? K now ing the answer to this question is in portant for one to handle correctly the transition region between a eld theory description and kinetic theory. Indeed, one expects from the work in Refs. [22,23] that there exists a window in time where both approaches correctly describe the dynam ics<sup>2</sup>. This suggests that the kinetic equation in the overlap regin emust know about the coupling of sources to elds at earlier times. How is thism anifest, how important is this e ect and how does it go away
- ii. W hat term s in the kinetic equation are in portant at di erent stages of the expansion? The previous question hints that we will obtain a kinetic equation that has additional term s absent in the conventional B oltzm ann equation. We would like to understand how this generalized Boltzmann equation converges to the usual one at late times.

The paper is organized as follows. In section 2, we shall rem ind the reader of relevant form ulae in the derivation [1] of the average number n of produced particles. In section 3, we shall write down the D yson-Schwinger equations for the two-point functions in theories with time dependent strong sources. These provide the starting point for a derivation in section 4 of the corresponding kinetic equation for the G lasm a. We observe that the coupling of the eld to an external source leads to an inhomogeneous term in this kinetic equation. In section 5, we discuss the properties of the di erent term s appearing in the kinetic equation. A beit the collision term in the kinetic equation looks identical to the collision term in the usual Boltzm ann equation, it contains novel contributions to the self energy that are of 0-loop and 1-loop order. We discuss the power counting for these di erent contributions and assess their relative contribution at di erent stages of the tem poral evolution of the G lasm a. We conclude with a brief sum m ary and outlook em phasizing unresolved issues. An appendix addresses how the averaging over the sources j in our form alism can be re-expressed in term s of the usual ensemble average implicit in the derivation of kinetic equations.

# 2 Ab initio com putation of n

We consider the theory of a real scalar eld with cubic self-interactions,  $\infty$ upled to an external time dependent source  $j(x)$ . The Lagrangian of the m odel is

In [1], we system atically calculated particle production from these sources. In the C olorG lass C ondensate fram ework that this toy m odelm im ics, the colliding projectiles are represented by a statistical ensemble of currents j. Physical quantities are obtained by averaging over all possible realizations of the j's. In this section, we shall discuss the calculation of the average num ber of produced particles in a given con guration of j's.

A general form ula for the average num ber n of produced particles is

The num ber of particles produced with a certain m om entum p is de ned as the expectation value of the  $\out"$  num ber operator in the initial state. This form ula gives the num ber of particles at asym ptotic tim es, after the particles have decoupled  $3$ .

A sim ple reduction form ula gives[30]

where Z is the wave function rem orm alization factor. The expectation value in the right hand side of this equation has two im portant features : (i) the vacuum state is the  $\infty$ " vacuum state on both sides and, (ii) the two elds inside the correlator are not tim e-ordered. The Schw inger-K eldysh form alism [31,32] provides techniques for com puting these types of correlators.

Figure 2: Exam ple of a tree diagram contributing to the eld expectation value. The black dots term inating branches of the tree represent insertions of the source j in the diagram on the right. The sum of these tree diagram s is represented (left) by a line attached to a gray blob.

W hen  $j_{+} = j = j$ , the expectation value of the eld is the same on the upper and lower branches of the contour:  $+(x) = (x)$ . This explains why we om itted the  $+=$  index in the expectation value of the eld.

A typical tree-level contribution to  $(x)$  is shown in gure 2. Note also that (x) vanishes if the external source  $j(x)$  is zero<sup>4</sup>. A t tree level, because  $j_{+}$  =  $j$  =  $j$ , the sum over the  $+=$  indices in the Schw inger-K eldysh form alism at all the internal vertices of the tree (including the sources) can be perform ed by using the identities

where G  $_{{\scriptscriptstyle \rm R}}^0$  is the free retarded propagator $^5.$  W hen this sum is perform ed, all propagators in the tree diagram can be sim ply replaced by retarded propagators. This is equivalent to the statem ent that  $(x)$  is the retarded solution of the classicalequation ofm otion,

w ith a vanishing boundary condition at  $x_0 = 1$ .

 $Eq.$  (7) is the com plete answer to the problem of particle production in the e ective theory described by the Lagrangian of  $eq. (1)$ . If one were able to com pute  $\mathfrak{E}(x; y)$  to allorders, this form ula would contain everything one needs. T here would be no need for tools such as kinetic theory.

H ow ever, evaluating eq. (7) to all orders is an unrealistic goal. W hat has been im plem ented thus far is the evaluation of eq.(7) at leading order (tree level) to calculate the gluon yield in high-energy nucleus-nucleus collisions [33{ 38]. In [1],an algorithm was sketched to com pute n at next-to-leading order (one loop) in term s of the retarded classical eld and of retarded uctuations propagating in the classical eld background.

In practice, one has to truncate the loop expansion. As we will discuss in the next section, the correct way to perform practical calculations is within the fram ework of the D yson {Schw inger equations.

# 3 D yson-Schw inger equations

T he m ain problem w ith the loop expansion described in the previous section is that, in general, truncations in  $\mathfrak{E}(x;y)$  w ill lead to an incorrect large time lim it ofthe num ber ofproduced particles. T his can be traced to secular term s containing powers of the tim e that invalidate the perturbative series in the large tim e lim it. This can be cured by appropriate resum m ation; the well known way to do this is to solve D yson-Schw inger equations  $[18{20}]$ . In this section, we shall discuss the D yson-Schw inger equations obeyed by the two-point functions  $G \circ (x,y)$  of the Schw inger-K eldysh form alism. We will see that the presence of a disconnected contribution to these 2-point functions leads to interesting features in the corresponding D yson-Schw inger equations.

### 3.1 D yson-Schw inger equation for the connected part

It is straightforw ard to w rite a D yson-Schw inger equation for the connected part of the 2-point function, G  $^{\circ}$   $_{\circ}$ , that resum s self-energy corrections:

where i is a 1-particle irreducible connected self-energy, evaluated in the presence of external sources. We shall not write here explicitly the indices carried by the various ob jects. Instead, we w rite the tim e integrations as integrals over the com plete Schw inger-K eldysh contour C.

It is convenient to extract from this self-energy a local piece, by w riting

Except for the background  $e$ k, w hich is a genuine local contribution to the self-energy, there is a certain arbitrariness in this separation because it depends on the m om entum scale atw hich we resolve the system . A contribution to the self-energy that does not change signi cantly over space-time scales on the order of the C om pton wavelength  $p^{-1}$  can be treated as a m ean eld at that scale.

 $T$  herefore, the m ean eld term  $(u)$  w ill contain the classical eld, and possibly changes in the dispersion relation due to m edium eects<sup>7</sup>.

The D yson-Schw inger equation then becom es

The only form aldierence between this D yson-Schwinger equation and the equation one obtains in the absence of the source j is the term proportional to in the right hand side.

In principle, the resummations performed by solving eqs.  $(20)$  and  $(26)$  (or, equivalently, eqs. (20) and (27)) would completely cure the problem of secular tem s. Such an approach has been pursued num erically in [39], but has not been attem pted yet in the context of heavy ion collisions in the CGC fram ework.

#### K inetic equation 4

The D yson-Schw inger equations we w rote down in the previous section contain all the necessary physics but their solution is likely too di  $\text{cut}$ ; they therefore by them selves do not provide any practical insight into the dynam ics of high energy heavy ion collisions. One can simplify the problem a step further by transform ing the D yson-Schw inger equations for the 2-point functions into kinetic equations. However, as we shall discuss shortly, doing so requires that certain assum ptions be satis ed.

### 4.1 Fields and particles

A s is well know n, the Boltzm ann kinetic equation describes the space{tim e evolution of particle phase space densities. Therefore, to achieve a kinetic description, the form alism considered thus far should be extended to incorporate an ensem ble of particles. This is simply done by m odifying the free propagators to add a term that depends on the distribution of particles f(p). In m om entum space, the  $m$  odied propagators are<sup>10</sup>

These m odied rules for the Schw inger{K eldysh propagators can be derived [40]w hen the initialdensity m atrix that describes the ensem ble has the form h Z i

where  $p$  is a m om entum dependent quantity. (N ote:  $p$  should not be confused w ith the inverse tem perature.) Such a form for the density m atrix is required if correlators com puted w ith this density m atrix are to satisfy W ick's theorem . From this form of the density m atrix, one obtains the Schw inger-K eldysh rules of eqs.  $(28)$ , with

The function f(p) in the propagators only represents the initial distribution of particles in the system. Thus the eld theory de ned by the Lagrangian of  $eq. (1)$  and the propagators of  $eqs. (28)$  describes a system of elds coupled to an external source j and to an ensem ble of particles with an initial distribution f(p). T he Feynm an rules then enable one to calculate the properties of this system at a later tim e.

H ow ever, eqs. (28) do not lead to a well behaved perturbative expansion, except when the function  $f(p)$  is the equilibrium Bose-Einstein distribution in our m odel of bosonic elds. In general, when  $f(p)$  is not a Bose-Einstein distribution, the perturbative expansion based on eqs.  $(28)$  is plagued by the previously m entioned pathological secular term s w hich need to be resum m ed. The tim e-scale at w hich resum m ation becom es necessary is related to the transport m ean free path in the system, namely, the time between two large angle scatterings undergone by a particle. This resum m ation m akes the distribution f (p) tim e{dependent re ecting the changes induced by collisions on the particle

phase space distribution. Under certain approximations to be discussed later, this tem poral evolution is governed by a Boltzm ann equation.

The problem form ulated in section 2 concerned a system that has no ensemble of particles at the initial time (f(p) = 0 in eqs. (28)). At rst sight, as  $f = 0$ is a particular case of the Bose (E instein distribution (with a vanishing temperature), secular divergences m ay appear to be absent. However, this conclusion is incorrect because of the presence of external sources which drive the system out of equilibrium. Thus it is also necessary to resum secular term s in this case, leading to changes in  $f(p)$ . The generalized propagators in eq. (28) constitute the natural fram ework to achieve this. Because the external source is both time and space dependent, one has m ore generally

An important point must be m ade here about the tree level expectation val- $11eS$ (x) in this f-dependent extension of our form alism. A crucial property of the propagators in eqs. (28) is that they still obey eqs. (14). The retarded propagator is therefore f-independent. Therefore, as long as loop corrections are not included, the eld expectation value does not depend on f and is identical to the result obtained from the retarded solution of the classical equations of m otion. Hence, the contribution from the disconnected part of the 2-point function lead to an inhomogeneous (f {independent) term in the Boltzmann equation.

#### 4.2 G radient expansion

The extension (28) of the propagators leads to D yson-Schw inger equations that are form ally identical to eqs.  $(20)$  and  $(26)$  { with all the building blocks now constructed with f-dependent propagators. The rst step in obtaining the Boltzm ann equation is to rew rite all the distributions in term s of their W igner transform s. For a two-point function F  $(x,y)$ , its W igner transform F  $(X, p)$  is de ned to be

The next step is to perform a gradient expansion where only long wavelength, low momentum modes are retained. In particular, all terms of order two or higher in  $\theta_{y}$  are neglected. A sour goal is to construct a kinetic theory for the G lasm a, we will discuss the validity of this gradient expansion in the context of heavy ion collisions in the CGC fram ework. In this fram ework [14{16], the color sources  $a(x_2)$  generating the color currents  $x_1$  are stochastic variables that vary from event to event with a distribution  $W$  [ ]. W hen calculating a given physical quantity, one rst com putes it for an arbitrary and then averages over all possible  $\prime$ s in the ensemble generated with the weight W  $[$  ]. For example,

Here  $\frac{2}{\pi}$  (x<sub>2</sub>) represents the density of color charges at a spatial position x<sub>2</sub> in the nucleus. The typicalm om entum scale of the sources{the saturation mom entum squared  $Q_s^2$  at  $x_2$  is simply related to  $\frac{2}{x}$ .

The dierence between one particular elem ent of the ensemble and the average weighted by W [ ] is illustrated in gure 4 for the quadratic form  $^2$ . Because

the  $(x_2)$  are uncorrelated at dierent points in the transverse plane of the nucleus, a particular con quration of  $\prime$ s leads to a very rough density pro le; in contrast, the average sm oothly follows the W oods-Saxon density pro le of a nucleus. This exam ple simply illustrates that the gradients are uncontrollably large for a given con guration rendering any gradient expansion meaningless. On the other hand, it is perfectly legitim ate for ensemble averaged quantities.

The typicalm om enta of \hard" particles is set by the saturation scale which is of order  $Q_s$ 1{2 GeV at RHIC energies; this scale m ay be higher at the  $LHC$ . In contrast, the gradient  $\mathfrak{g}_x$  for averaged quantities changes appreciably over distance scales of the inverse nuclear radius given by  $R^{-1}$ 40 M eV for a large nucleus. The sm all m agnitude of this scale in the gradient expansion relative to the typical saturation m om entum justi es the gradient expansion for quantities that are averaged over the ensemble of color charges.

The corresponding changes to the Feynm an rules are described in appendix A. Here it is su cient to note that the ensemble average is obtained by connecting all the external sources j in the m anner speci ed by the distribution  $W$  []. For instance, in the MV modelW [] is a G aussian, which implies that all the sources m ust be connected pairw ise. The objects  $\frac{s}{s}$ , and that appear in the Dyson-Schw inger equations (20) and (26) m ust be thought of as being averaged over j. In Feynm an diagram s, we will represent the average over j by

surrounding the diagram by a light gray halo:

This com pact notation encom passes a very large num ber of contributions. For  $intermediate, at leading order, one would reapproximate (x) as the sum of all$ the tree diagram s, an exam ple of which is represented in gure 2. For each such tree diagram, the sources  $\frac{1}{1}$  (the black dots in qure 2) are reconnected pairw ise in all the possible ways. A typical reconnection of the sources, corresponding to the topology of gure  $2$ , is displayed in gure 5. N ote that the \loop order"

of a given diagram is a m eaningful concept only for diagram s before they are averaged over  $j$ . Indeed, as one can see by com paring the gures 2 and  $5$ , the diagram before the j-average has 0 loops and is of order g  $\,{}^{1}$  . A fter the average is perform ed, w hile it has a large num ber of  $\log$ " w hich do not contain any inform ation about the order in g of the diagram.

### 4.3 B oltzm ann equation

The nalingredient in the derivation of the Boltzm ann equation is the so-called \quasi{particle ansatz" w hich can be expressed as

The physical assum ption here is that the interactions in the system are such that the collisional width of the dressed particles rem ains sm all compared to their energy; the system is m ade up of long-lived quasi{particles.

The Boltzm ann equation can now be obtained as follows:

- i. W rite a Dyson-Schwinger equation analogous to eq. (27), but with the di erential operator  $+ m^2 + q$  acting on the variable y instead of x, and subtract it from  $eq. (27)$ .
- ii. Rew rite this equation in term s of the W igner transform ed quantities and perform a gradient expansion keeping only leading term s in  $\theta_{v}$ .
- iii. Replace the G reen's functions with the quasi-particle ansatz and drop the spectral function (X; p) which appears as a factor in all the term s.

If the term s proportional to  $\degree$  were absent from eq. (27), the steps outlined above would result in the well-known Boltzm ann {V lasov equation,

The extra term we have in the D yson {Schw inger equations, proportional to  $\delta$ , willm odify the Boltzm ann {V lasov equation. Two key features of this novel term will prove essential in our derivation. The rst is that  $\sqrt[s]{(x,y)}$  does not depend on whether the points x and y are on the upper or lower branch of the time contour. This is because the expectation value of the eld, for equal values of the sources  $j_+$  and  $j_+$ , is the same on both branches of the contour. The second feature is that the non-connected part of the propagators drops out of the spectral function, for the same reason. Hence,

U tilizing these two properties, we can perform the gradient expansion for this additional term in the same way as performed for the usual self-energy correction. It m odi es the right hand side of the Boltzm ann equation by an additive correction<sup>12</sup> <sup>s</sup> (X ;p). Therefore, our nal expression for the kinetic equation  $is$

The novel \source term "  $S(X; p)$  in this equation is non-zero even if the particle distribution  $f(X, p)$  is zero. It is therefore responsible for  $f = 0$  not being a xed point of the above equation; the solution of this equation is non-zero at later times even if the initial condition had a vanishing particle distribution. In the next section, we will discuss further signi cant di erences between this kinetic equation and the conventional Boltzm ann-V lasov equation in eq. (38).

#### 5 Properties of the G lasm a kinetic equation

In this section, we shall discuss the various term  $s$  in eq. (40) with emphasis on the di erences between these and those appearing in the conventional Boltzm ann kinetic equation.

#### $5.1$ V lasov term

We rst consider the V lasov term  $(q\theta_{v})$  $\frac{1}{2}$  ) in the Boltzm ann equation. We note that in perform ing the average of the mean  $e$ k (X), over the external sources j, the various correlation functions  $j(x_1)$  $_{\rm n}$  ) (xperm itted by the distribution of sources W [j] are nearly translation invariant. The dependence  $_n$  )=x is very of these correlators on the barycentric co{ordinate X  $(x_1 +$ slow because it arises from the density pro le of the colliding nuclei<sup>13</sup>. Therefore the  $1$ -point function  $(X)$ , averaged over j, also has a very slow dependence on its argum  $ent X$ ; its Fourier transform with respect to  $X$  has only modes with m om enta on the order of the inverse nuclear radius. As discussed previously, this scale is very sm all relative to the typicalm om entum of the particles under consideration and  $\pm$  is therefore legitin ate to approximate  $\pm$  as a V lasov tem.

As is well known, the e ect of this term in the Boltzm ann equation is to change the m om entum of particles as they m ove between regions where the extemal eld is dierent. Indeed,  $q\theta_{v}$  is the force that acts on the particles at point X and accelerates them towards regions of lower potential<sup>14</sup>. The mean includes not only the classical eld directly produced by the external eld sources, but also possibly a contribution com ing from the particles encoded in  $f(X; p)$ . Such a m odi cation m ay arise from a m odi cation of the particle dispersion relation due to the collective action of the other particles. For instance, if the particles acquire a medium mass with a weak space-time dependence, this m ass can be represented by a potential in the V lasov term of the kinetic equation.

 $14$  For non central collisions, the shape of the overlap region between the two nuclei is elliptic; one has stronger gradients in the direction of the sm all axis of the ellipsis relative to those in the direction of its large axis. The V lasov term therefore accelerates particles preferentially in the direction of the small axis of the overlap region. This leads eventually to elliptic ow and to an anisotropy of the spectrum of particles in m om entum space. This e ect is obtained entirely within kinetic theory without any assumption about the degree of them alization of the system.

### 5.2 Source term in the kinetic equation

Let us now consider the e ect of the source term  $S(X;p)$  in eq. (40), which can be obtained as the W igner transform of the product S  $(x)S(y)$ . An interesting situation, relevant for heavy ion collisions, is w hen tree diagram s are dom inant because the external source is strong  $(qj - 1)$ . In this case, the expectation value  $(x)$  is dom inated by the retarded classical eld  $(x)$ ; the connected part of the 2-point function, G<sup>c</sup>, is simply the propagator of a uctuation on top of the classical  $e$ k,

W e see here that the e ective source  $S(x)$  receives two contributions :

- i. the external source  $j(x)$  itself. This term is only im portant if we want to use the Boltzm ann equation in regions of space-time where the external source is stillactive. In a heavy ion collision, the color sources are present only on the light-cone at a proper time  $= 0$ . We will not consider this term further.
- ii. A term quadratic in the classical eld produced by the external source; this term continues to contribute after the external sources have stopped acting.

equation at a stage where this non-linear term is still signi cant, the source tem in the Boltzm ann equation modies the number of particles in order to take this eect into account.

At tree level, the e ective source S(x), and hence  $S$ , is independent of the distribution of particles f.A s discussed previously, this is a straightforward consequence of the fact that, at tree level, the 1-point function in the Schw inger-K eldysh form alism can be rew ritten entirely in term s of retarded propagators that are f{independent.  $\degree$  is therefore non-zero even if  $f = 0$ . In contrast, the term s in the r.h.s of the Boltzm ann equation depend on f and vanish when  $f = 0$  as expected for collision term s.  $s$  is therefore a source term in the Boltzm ann equation, because it drives f to a non-zero value even if one has  $f = 0$  initially.

W hen we perform the average over j of the disconnected product S  $(x)$ S  $(y)$ , we get both disconnected and connected source term s,



depending on how the sources j are reconnected. In this picture, each light shaded area is sim ply connected after the average over  $j$  has been perform ed, and all the sources j it contains are linked in all the possible ways that preserve its connectedness.

The rst term in the r.h.s. of eq.  $(45)$  corresponds to contributions w here we connect together only j's that belong to the same factor S ,  $S$  (x)  $_{j}$   $S$  (y)  $_{j}$ . O ur previous rem ark about the average over j of the 1-point function (X ) also applies here to  $S(X)$ <sub>j</sub>: its Fourier transform only contains very soft modes of the order of the inverse of the nuclear radius. It is therefore nearly zero for the typical particle m om entum  $p \quad Q_s$  we are interested in here. Thus only the connected term s in the average of the source term  $S(x)S(y)$   $\frac{1}{1}$  m atter in the kinetic equation.

### 5.3 M agnitude of eld insertions

The source term in eq.  $(45)$ , as well as the other term s in the right hand side of the Boltzm ann equation, involve insertions of the classical  $e$ k (x). In this subsection, we present a simple power counting that enables us to estim ate the m agnitude of such insertions. To simplify the discussion, we shall assume that the space{tim e coordinate X corresponds to suciently late tim es w hen the external source j is zero and its in uence is only felt through the classical eld

 $(X)$  generated by the source at earlier times.

Follow ing the discussion after  $eq.$  (34), we assum e that there is hard m om entum scale  $Q_s$  in the problem {the saturation scale in heavy ion collisions. Typical particle m om enta are of order  $p \quad Q_s$ . In our toy m odel, the coupling constant q has the dim ension of a m ass in 4 dim ensions. To m im ic the power

counting in QCD, we will write it as

To estimate the order of magnitude of the source term given in eq.  $(45)$ , it is not su cient to know them agnitude of the classical eld. K inem atical phase space constraints can alter the naive power counting. As these considerations will apply equally to the collision term s in the Boltzm ann equation, it is worth our while to discuss the power counting for the source term at length here.

From  $eq. (25)$  and  $eq. (45)$ , the naive power counting for the source term would give

By analogy with eq. 28, the distribution  $f_{c1}(X; k)$  can be interpreted as representing the \particle content" of the classical eld. As eq. (52) has exactly the structure of a  $2!$  1 collision term with on-shell particles of equal m ass, it is zero because of energy-m om entum conservation.

T herefore, to correctly estim ate the m agnitude of the source term <sup>s</sup> when the classical eld is weak, one needs to properly account for the slight  $o$  shellness of the eld Fourier modes. From the equation of motion

W e are now in a position to estimate the power counting of contributions to the source term. First, the order of m agnitude of the denom inators  $k^2$  m  $m<sup>2</sup>$ is Q $_{{\rm s}}^2$  because the m om entum transfer k is of order Q  $_{{\rm s}}$  (and is not particularly close to them ass shell). Each G  $_{c1}^+$  contains a delta function. Two of them can be used to perform for free the integrations over the energies  $k^0$  and  $q^0$  , w hile the third provides the value of one angular integration variable. We nally obtain the estim ate

(58) is an oversim plied version of the actual form ula for  $S$  ), but it is a m om entum whose com ponents are of the sam e order of m agnitude as those of p, the m om entum of the produced particle. T his is an im portant point, because as time increases, the support of  $f_{\text{cl}}$  shrinks in the  $p_z$  direction because of the longitudinal expansion of the system, thus m aking  $f_{c1}(X; \overline{p})$  decrease as well (while in the center of its support, it would stay constant).

Even if  $eq.$  (56) is not valid (say, if the average over j were to generate connections am ong the elds that are not pairw ise), the estimate of  $S$  one obtains from it has a m uch w ider range of validity.  $(Eq. (58)$  is valid even in the saturated regim e.) We also note that as  $S$  is an inhom ogeneous term existing even w hen  $f = 0$ , its m agnitude depends only on the time dependence of the classical eld  $(x)$  through  $f_{c1}$  and  $n_{c1}$ .

### 5.4 C ollision term s

The estim ate of the various contributions to the collision term follow very closely that of the source term. Let us start by listing the term s we need to estimate. Because of the presence of the background eld and of the average over the

external source  $j$ ,  $+$  (X;p) can contain topologies that would not exist in the vacuum. In fact,  $+$  (X;p) can contain term s that have 0, 1 and 2 loops<sup>17</sup> before the average over the external source is perform ed. We will denote by  $C_0$  [f];  $C_1$  [f] and  $C_2$  [f] their respective contributions to the collision term.

Let us start with  $C_0$  [f]. D iagram m atically, it corresponds to

N ote that this represents only one of the diagram s that can possibly enter in  $C_0$  [f]. From the experience gained in the estimate of them agnitude of  $S(X; p)$ , we can readily see that there m ust be at least four insertions of the classical eld for such a contribution to be kinem atically viable when the classical eld becom esweak and has only nearm ass-shell Fourierm odes. The second equality show s one exam ple of the topology one obtains after the average over j. The corresponding expression reads

The only dierence between this expression and that of  $S$  in eq. (56) is that one of the correlators  $G_{c1}^+$  is now replaced by  $18$

that involves the distribution  $f(X; p)$  rather than the classical distribution  $f_{c1}(X ; p)$ . From this analogy, we can estim ate the m agnitude of  $C_0[f]$  directly from that of  $S$  in eq. (58), by substituting one factor  $f_{c1}$  or  $n_{c1}$  by respectively f or n. Here n is the spatial density de ned from f in the same way as in eq.(59). W e obtain

### 5.5 D iscussion

Follow ing the power counting in equations (58), (63), (66) and (69), we are now in a position to discuss qualitatively the relativem agnitude of the various term s at dierent stages of the evolution of the system. An important facet of the tem poralevolution is that the functions  $f_{c1}$  and  $n_{c1}$  are determ ined once and for all from the classical  $e$ k (x) itself. They do not receive any feedback from the particle distributions or densities, denoted by f and n respectively, that are created in the evolution by the source term  $\sim$   $\frac{1}{\pi}$ . The time dependence of  $n_{c1}(X)$ is driven by the expansion of the system ; therefore at times larger than  $(Q_s)^{-1}$ , one has

This reduction of the classical particle density  $n_{c1}$  w ith tim e happens because the support in  $m$  om entum space of the corresponding phase-space density  $f_{c1}$ shrinks. A t a given space-time location X (specied by the space-time rapidity

), only particles with a m atching m om entum rapidity  $y = \cos x$  an stay for a long  $t$ im e. Therefore, inside its support,  $f_{c1}$  rem ains constant satisfying

N ote that at times sm aller than  $(Q_s)^{-1}$  ,  $f_{\text{cl}}=f$  and  $n_{\text{cl}}(X$  )=n are also both of order 1 because the classical eld is completely saturated.

H ow ever, in all the estim ates of the previous subsection,  $f_{c1}$  is evaluated at som e arbitrary location X and m om entum  $\bar{p}$ . Therefore,  $\bar{p}$  w ill eventually fall outside of the support of  $f_{c1}$ , and  $f_{c1}$  w ill decrease quick  $y^{19}$  after that happens. For  $f_{\text{cl}}$ , which com es entirely from the classical eld , the only time-scale in the problem is  $1=Q_s$  and thus we expect  $f_{c1}$  to start decreasing at tim es larger than  $1=0$ .

A t early times,  $\cdot$  ! 0, the system does not have particles yet and we have  $f = n = 0$ . O by bush, in this regime, only the source term  $\delta$  is important in the right hand side of the Boltzm ann equation. The corresponding physics is that a population of particles, described by the occupation num ber  $f$ , is built up from the decay of the classical eld. However, these particles are still too few to have collisions at a signi cant rate. Eq. (58) tells us that  $S$  $rac{2}{2}$  in this regim e.

As a rough estimate, if we integrate this source term in the range  $0$  $Q_{\rm s}^{-1}$  , we nd that the occupation num ber for particles of m om entum  $\rm\,p\,$  Q<sub>s</sub> at a time  $Q_{\rm s}^{-1}$  is

At this time, all the components of the m om enta of these particles are typically of order  $Q_s$ . Therefore, we also have

Attim esaround (Q  $_{\rm s}$  )  $^{-1}$  alltheterm sin the rightside of the Boltzm ann equation are of equalm agnitude. Indeed, in this regim e, term s w ith an arbitrarily large num ber of loops contribute equally to the collision term when  $f = f$ . There would therefore be an equally large  $C_3[f]$ ;C<sub>4</sub>[f]; etc... In practice, this m eans that one should start using the Boltzm ann equation only at later tim es.

At later times,  $\mathbb{R}^1$ , collisions am ong the particles becom e im portant and their qualitative e ect is to broaden the m om entum distribution of the particles represented by  $f$ , thereby counteracting the e ect of the expansion<sup>20</sup> of the system. Thanks to these collisions,  $f(X ; \overline{p})$  falls at a lesser rate com pared to  $f_{c1}(X, \overline{p})$  (which is not a ected by collisions), which eventually leads to the

dom inance of  $C_2[f]$  over all the other term s in the right hand side of the Boltzm ann equation. W hen this occurs, our Boltzm ann equation is identical to the usualone. The detailed m echanism s of this transition between the classical eld dom inated regim e and the kinetic regim e w ill be discussed in a future work. In particular, it w ill be interesting to compare, for the  $QCD$  case, the tem poral evolution of the kinetic equation for the glasm a w ith the \bottom up" scenario of them alization [41].

# 6 Sum m ary and O utlook

In this work, we developed the form alism of Refs.  $[1,2]$  for particle production in the presence of strong sources to construct a kinetic theory relevant for the early \glasm a" stage of a heavy ion collision. In particular, we considered for sim plicity, the dynam ics of a $3$  theory in the presence of strong sources. Much of ourdiscussion howeveriscom pletely generaland could in principle be extended to describe the dynam ics of gauge elds exploding into the vacuum after a heavy ion collision. W e showed that the relevant kinetic equation for the particle distributions f has the structure of a Boltzm ann equation with an additional inhom ogeneous (f-independent) source term denoting particle creation from the decay of the classical eld. The collision term s in the Boltzm ann equation also have novel features. In addition to the usual contribution from the two loop self energy, there are 0-loop and 1-loop contributions that a ect the particle phase space distributions. W e outlined the power counting that controls the m agnitude ofthe contributionsofthe source term and the collision term s.T he tem poral evolution of these contributions was discussed only brie y and will be discussed in detailelsew here.

T here are severalunresolved issuesthatshould be addressed in future work. Prim arily, we would like to understand precisely how the derivation here plays out in the QCD case. In Refs. [42{45], it was shown that instabilities of the W eibel type  $[46{51}]$  can spoil the bottom up scenario of them alization. Such an instability is also seen in the CGC fram ework in the explosive grow th of sm all
uctuationsaboutthe classicalbackground eld [52{54]and hasa natural interpretation as quantum uctuations about the classical background elds on the light cone [55]. A num erical study of instabilities in a eld+ particle fram ework has been perform ed [56] but we would like to better understand how the e ects of such instabilities m anifest them selves in the kinetic equation for the glasm a. It would be especially interesting to uncover w hether K olm ogorov turbulent spectra [57] arise as a consequence of these instabilities [58,59] and w hether this phenom enon of \turbulent therm alization" can be accom m odated in our kinetic fram ework.

#### A verage over the sources A

We have seen that it is crucial for the validity of the gradient expansion to consider quantities averaged over the source j coupled to the elds. We shall discuss brie y here how this average can be accounted for in our form alism.

Let us start from the generating functional for G reen's functions of the Schw inger-K eldysh form alism  $^{21}$  Z<sub>j</sub>[ ], for a given con guration j of the extemal source. We dene it in such a way that the n-point G reen's functions is obtained by di erentiating  $n$  times with respect to  $\,$ , and then by setting the auxiliary source to zero. From what we have said in section 2, this generating functional is related to the sum of all the vacuum -vacuum diagram s by :

where we have again used a compact notation compared to eq. (9). We do not use a boldface letter for the external source j, in order to emphasize the fact that it is identical on both branches of the closed time path.

From this object, it is very easy to construct the generating functional for G reen's functions that are averaged over some ensemble of external sources, with a distribution  $W$  [j], as:

In order to see how this average over j can be accounted for in the Feynm an rules, it is useful to write the generating functional for a xed j as follows:

where V is the sum of all the interaction term s in the theory under consideration (i.e. all the term s of the Lagrangian density that are of degree 3 in the eld). In this formula, G<sup>o</sup>(x;y) denotes the free propagator in the Schw inger-Keldysh

form alism (as opposed to the full propagator dened in eq. (9)). It is now convenient to w rite the second exponential in the r.h.s. of eq. (76) as the action of a translation operator on a functional that does not depend on j,

T he term s on the second line are nothing but the generating functionalfor the sam e theory w ithout any external source (since it does not depend on j). As we can see, the e ect of the average over the external source j is to bring a prefactor w hich is a certain functional of the operator  $=$  . Such a term can be interpreted as additional couplings am ong the elds, since one can always w rite :

W hat this derivation m akes obvious is that, for calculating averaged quantities over the ensem ble of external sources j, one can forget the external sources altogether, and include additional vertices to the theory<sup>22</sup>, as prescribed by eq. (79). Note that this is equivalent to calculating a quantity in an arbitrary j, and then reconnecting all the j's am ong them selves in all the possible ways perm itted by ln(W [j]).
