## M oduli Stabilization, Large-Volum e dS M inim um W ithout D3-B ranes, (N on-)Supersym m etric B lack H ole A ttractors and Two-Param eter Sw iss C heese C alabi-Yau's

#### A bstract

We consider two sets of issues in this paper. The rst has to do with moduli stabilization, existence of  $\area \codes"$  [1] and the possibility of getting a non-supersymmetric dS minimum without the addition of  $\overline{D}$  3-branes as in KKLT for type II ux compactications. The second has to do with the \Inverse Problem " [2] and \Fake Superpotentials" [3] for extrem al (non)supersymmetric black holes in type II compactications. We use (orientifold of) a \Sw iss Cheese" Calabi-Yau [4] expressed as a degree-18 hypersurface in W C P<sup>4</sup>[1;1;1;6;9] in the \large-volum e-scenario" lim it [5]. The main result of our paper is that we show that by including non-perturbative <sup>0</sup> and instanton corrections in the Kahler potential and superpotential [6], it may be possible to obtain a large-volum e non-supersymmetric dS minimum without the addition of anti-D 3 branes a la KKLT. The chosen Calabi-Yau has been of relevance also from the point of other studies of Kahlerm oduli stabilization via nonperturbative instanton contributions [7] and non-supersymmetric AdS vacua (and their subsequent dS-uplifts) using (<sup>0</sup>)<sup>3</sup> corrections to the Kahler potential [5, 8, 9, 10].

#### 1 Introduction

Flux com pacti cations have been extensively studied from the point of view of moduli stabilization (See [11] and references therein). Though, generically only the complex structure moduli get stabilized by turning on uxes and one needs to consider non-perturbative moduli stabilization for the Kahler moduli[12]. In the context of type II compactications, it is naturally interesting to look for examples wherein it may be possible to stabilize the complex structure moduli (and the axion-dilaton modulus) at di erent points of the moduli space that are nitely separated, for the same value of the uxes. This phenom enon is referred to as \area codes" that leads to form ation of dom ain walls. A nother extrem ely important issue related to m oduli stabilization is the problem of getting a non-supersymm etric de Sitter vacuum in string theory. The KKLT scenario which even though does precisely that, has the problem of addition of an uplift term to the the potential, corresponding to addition of  $\overline{D3}$ -branes, that can not be cast into an N = 1 SUGRA form alism. It would be interesting to be able to get a de Sitter vacuum without the addition of such  $\overline{D}$  3branes. The Large Volum e Scenarios' study initiated in [5] provides a hope for the sam e. Further, there is a close connection between ux vacua and black-hole attractors. It has been shown that extrem al black holes exhibit an interesting phenom enon - the attractor m echanism [13]. In the same, the moduli are \attracted" to some xed values determ ined by the charges of the black hole, independent of the asymptotic values of the moduli. Supersymmetric black holes at the attractor point, correspond to minimizing the central charge and the e ective black hole potential, whereas nonsupersymm etric attractors [14], at the attractor point, correspond to m inim izing only the potential and not the central charge. The latter have recently been (re)discussed [15] in the literature.

In this paper, we try to address all the issues of the previous paragraph by exploring di erent perturbative and non-perturbative (in <sup>0</sup> and instanton contributions) aspects of (non)supersymmetric ux vacua and black holes in the context of type II com pacti cations on (orientifold) of com pact C alabi-Y au's of a projective variety with multiple singular conifold loci in their moduli space. The compact Calabi-Yau we work with is of the \Swiss cheese" type. The paper is planned as follows. In section 2, based on [16], we perform a detailed analysis of the periods of the Calabi-Yau three-fold considered in this paper, working out their form s in the symplectic basis for points away and close to the two singular conifold loci. The results of section 2 get used in the subsequent section (3). We then discuss, in section 3, stabilization of the com plex structure m oduli including the axion-dilaton m odulus by extrem izing the ux superpotential for points near and close to the two conifold loci, arguing the existence of \area codes" and domain walls. In section 4, we show that by the inclusion of non-perturbative <sup>0</sup>-corrections to the Kahler potential that survive orientifolding and instanton contributions to the superpotential, one can, analogous to [5], get a largevolume non-supersymmetric dS vacuum without the addition of  $\overline{D3}$ -branes. We consider this to be the most signi cant result of this paper. In section 5, we explicitly solve the \inverse problem " using the techniques of [2]. In section 6, using the techniques of [3] we show the existence of multiple superpotentials (including therefore  $\delta$  superpotentials"). Section 7 has the conclusions.

## 2 The M oduli Space Scan and the Periods

In this section, based on results in [16], we bok at di erent regions in the moduli space of a two-param eter Calabi-Yau three fold of a projective variety expressed as a hypersurface in a weighted complex projective space, and write out the explicit expressions for the periods. The explicit expressions, though cum bersom e, will be extrem ely useful when studying complex structure moduli stabilization and existence of \area codes" in section 3, solving explicitly the \inverse problem " in section 4 and show ing explicitly the existence of \fake superpotentials" in section 5 in the context of non-supersymmetric black hole attractors. M ore precisely,

based on [16], we will consider the periods of the Sw iss cheese" <sup>3</sup> Calabi-Yau three-fold obtained as a resolution of the degree-18 hypersurface in W C P<sup>4</sup>[1;1;1;6;9]:

Similar to the explanation given in [17], it is understood that only two complex structure moduli and are retained in (1) which are invariant under the group G of footnote 3, setting the other invariant complex structure moduli appearing at a higher order (due to invariance under G) at their values at the origin.

#### 3 Extrem ization of the Superpotential and Existence of \A rea C odes"

In this section, we argue the existence of area codes, i.e., points in the moduli space close to and away from the two singular conifold loci that are nitely separated where for the same large values (and hence not necessarily integral) of RR and NS-NS uxes, one can extrem ize the (com plex structure and axion-dilaton) superpotential (for di erent values of the com plex structure and axion-dilaton moduli)<sup>7</sup>.

Now, the constants appearing in (29) (and therefore (26)) are cubic in the uxes (more precisely, they are of the type  $h^2f$  in obvious notations), which for (1) would be  $10^3$  (See [7]). In other words, for the same choice of the NS-NS and RR uxes -12 in num ber -one gets 6 or 9 or 12 com plex (inhom ogenous [in ; ] algebraic/transcendetal) constraints (com ing from (26)) on the 6 or 9 or 12 extrem um values of the com plex structure moduli (i; i; i; i = 1;2;3;4) nitely separated from each other in the moduli space. In principle, as long as one keeps  $f^T$ : the xed, one should be able to tune the uxes  $f_i;h_i; i = 0;:::;5$  to be able to solve these equations. Therefore, the expected estimates of the values of the moduli space as discussed in section 2, are reasonable im plying the possibility of existence of \area codes", and the interpolating dom ain walls [21]. Of course, com plete num erical calculations, which will be quite involved, will be needed to see explicitly everything working out.

## 4 Non-supersymmetric dS m in im um via Non-perturbative <sup>0</sup>- and Instanton Corrections

In this section, using the results of [6], we show that after inclusion of non-perturbative <sup>0</sup>-corrections to the K ahler potential, in addition to the perturbative <sup>0</sup> corrections of [8], as well as the non-perturbative instanton contributions to the superpotential, it may be possible to obtain a large volum e non-supersymm etric dS m inimum (analogous to [5] for the non-supersymm etric AdS m inimum) without the addition of  $\overline{D}$  3-branes – see also [9].

Let us begin with a sum m ary of the inclusion of perturbative  $^{0}$ -corrections to the K ahler potential in type IIB string theory compacti ed on C alabi-Y au three-folds with NS-NS and RR uxes turned on, as discussed in [8]. #### 5 The \Inverse Problem " for Extrem al B lack H oles

We now switch gears and address two issues in this and the subsequent sections, related to supersymmetric and non-supersymmetric black hole attractors<sup>11</sup>. In this section, using the techniques discussed in [2], we explicitly solve the \inverse problem " for extrem alblack holes in type II compactications on (them innor of) (1) -given a point in the moduli space, to nd the charges ( $p^{I};q_{I}$ ) that would satisfy  $@_{i}V_{BH} = 0$ ,  $V_{BH}$  being the black-hole potential. In the next section, we address the issue of existence of \fake superpotentials" in the same context.

W e w ill now sum marize the \inverse problem " as discussed in [2]). Consider D = 4; N = 2 supergravity coupled to  $n_V$  vector multiplets in the absence of higher derivative terms. The black-hole potential can be written as [14]:

As argued in [3], dS-curved dom ain wall solutions in gauged supergravity and non-extrem al black hole solutions in M axwellE instein theory have the same e ective action. W e therefore see that the non-supersym m etric black-hole corresponding to the fake superpotential Q<sup>T</sup> S<sup>T</sup> IV, S being given by (95), corresponds to the change of sign of two of the three electric and m agetic charges as compared to a supersymmetric black hole. The symmetry properties of the elements of M and hence M m ay make it generically possible to nd a constant S like the one in (95) for two-paramater Calabi-Yau compacti cations.

## 7 Conclusion

We looked at several aspects of complex structure moduli stabilization and inclusion, in the large volum e lim it, of perturbative and specially non-perturbative <sup>0</sup>-corrections and instanton contributions in the K ahler potential and superpotential in the context of K ahler m oduli, for a two-param eter \Sw iss cheese" C alabi-Yau three-fold of a projective variety expressed as a (resolution of a) hypersurface in a complex weighted projective space, with multiple conifold loci in its moduli space. A sregards N = 1 type IIB com pactications on orientifold of the aforem entioned Calabi-Yau, we argued the existence of (extended) \area codes" wherein for the same values of the RR and NS-NS uxes, one is able to stabilize the complex structure and axiondilaton moduliat points away from and close to the two singular conifold loci. It would be nice to explicitly work out the num erics and nd the set of uxes corresponding to the aforem entioned area codes (whose existence we argued), as well as the ow of the moduli corresponding to the domain walls arising as a consequence of such area codes. Further, in the large volum e lim it of the orientifold, we show that with the inclusion of non-perturbative <sup>0</sup>-corrections that survive the orientifolding alongwith the nonperturbative contributions from instantons, it is possible to get a non-supersymmetric dS m inimum without the inclusion of anti-D 3 branes. It would interesting to investigate the e ect of string loop corrections in the context of orientifolds of com pact C alabi-Y au of the type considered in this work (See [25]). As regards supersymmetric and non-supersymmetric black-hole attractors in N = 2 type II compactications on the same Calabi-Yau three-fold, we explicitly solve the \inverse problem " of determ ining the electric and m agnetic charges of an extrem alblack hole given the extrem um values of the moduli. In the same context, we also show explicitly the existence of \fake superpotentials" as a consequence of non-unique superpotentials for the same blackhole potential corresponding to reversal of signs of som e of the electric and m agnetic charges. There m ay be interesting connection between the existence of such fake superpotentials and works like [26]<sup>12</sup>
