The zero age main sequence of W IM P burners

W e modify a stellar structure code to estim ate the e ect upon the main sequence of the accretion of weakly interacting dark matter onto stars and its subsequent annihilation. The e ect upon the stars depends upon whether the energy generation rate from dark matter annihilation is large enough to shut o the nuclear burning in the star. Main sequence W IM P burners look much like protostars moving on the H ayashi track, although they are in principle com pletely stable. W e make som e brief com ments about where such stars could be found, how they might be observed and more detailed simulations which are currently in progress. Finally we comment on whether or not it is possible to link the paradoxically young O B stars found at the galactic centre with W IM P burners.

There is growing evidence that for each gram of baryonic matter in the universe, there are around ve gram s of dark matter which does not couple to the electrom agnetic force [1]. One of them ore convincing candidates for this dark matter are weakly interacting massive particles (W IM Ps). Because W IM Ps have masses and couplings close to the weak scale, they naturally give rise to a relic abundance of dark matter close to that observed after freeze out in the early universe.

Because W \mathbb{M} Ps couple weakly to standard model particles, there is a small but non-zero W \mathbb{M} P-nucleon cross section. The tightest constraints for the spinindependent cross section come from the XENON experiment [2]. The W \mathbb{M} P-nucleon interaction means that som eW \mathbb{M} P sare gravitationally captured by stars, a process which has been well studied [3, 4]. U sually the focus of such investigations is the possibility of dark matter annihilating into high energy neutrinos, which then escape the star to be potentially detected by neutrino experiments like LeeC ube. If the accretion of dark matter were large enough however, one might expect that the stars them selves could change.

The rst way W \mathbb{M} Ps can a ect a star is by annihilating into standard model particles in its core, providing another energy source in addition to standard nuclear buming. We refer to stars where the energy produced by W \mathbb{M} P annihilations is greater than or comparable to that from nuclear buming as \mathbb{W} \mathbb{M} P bumers'. Recent work has focused upon white dwarfs and neutron stars [5, 6]. Here we instead focus on main sequence W \mathbb{M} P bumers. Previous work in this direction was carried out by Salati & Silk [7] som e years ago, in the context of cosm ion dark matter. These authors used an n = 3 polytropic approximation to estimate the in uence of \mathbb{W} \mathbb{M} P annihilation on the main sequence. We instead employ full num erical solutions to the hydrostatic equations of stellar structure and present results from a simple code, as well as supporting preliminary results from a more advanced code. We also update the discussion in the context of fm odern W IM Ps' rather than cosm ions, as the nuclear scattering cross-sections and the W IM P m ass are m ore constrained than in the past.

The second way W M Ps can in uence stellar structure is by providing an additional mechanism of heat transport in the core. This could reduce the local tem – perature gradient [8], potentially inhibiting convection and enhancing the pulsation of horizontal branch stars [9, 10]. At least for the Sun however, the values currently favoured for the W M P self-annihilation cross section [1] and the upper lim it on the W M P-nucleon cross section [2] indicate that this e ect is not signi cant [11]. In this work, we neglect heat transport by W M Ps, but will in a later work include this e ect in m ore detailed, tim e-dependent simulations [12]. For the current work, we have checked that this om ission does not a ect our results signi cantly.

Experiments give relatively weak constraints on the spin-dependent W ${\rm I\!M}$ P-nucleon cross section, so it may contribute far more to W ${\rm I\!M}$ P capture than the spin-independent one. For simplicity, we assume that the spin-dependent cross section dominates and is $_{\rm SD}$ = 10 $^{38}\,{\rm cm}^2$. For a Sun-like star with mass 1M , a circular velocity of 220 km s 1 , a W ${\rm I\!M}$ P velocity dispersion of v = 270 km s 1 and a W ${\rm I\!M}$ P mass of 100G eV, the capture rate (as calculated with the full capture expressions [4] in D arkSU SY [13]) is then

W e assume a hydrogen m ass fraction of 75%, uniform ly distributed in the star. This is not a good approximation for the Sun, but reasonable for new ly born stars. The capture rate on an arbitrary star is then approximately

where M is the star's mass and v_{esc} its surface escape velocity, w is the am bient W MP density and m w is the W MP mass. h i = $hv_{esc}^2(r)=v_{esc}^2$ i is the average potential the height of the scattering nuclei (hydrogen in this case, for which h i = 3:16). For sim plicity, we assume h i=h i = 1. Even if this approximation is not perfect, Eq. (2) is only necessary for converting between the am bient W MP density w and the capture rate c, so it is easy to rescale if the reader wishes. We also assume $v = 270 \,\mathrm{km \ s^{-1}}$, though for stars in very dierent environm ents to our own this must be adjusted. Throughout this paper, we use a W MP mass of 100G eV although to a rst approximation the energy accreted by a star immersed in some xed density of dark matter is only a function of the cross section, not the mass of the W MP.

O noe dark m atter is captured by the star, it will form an approximately thermal (Gaussian) internal distribution, of characteristic radius [9, 11, 14]

where $_{\rm c}$ and $T_{\rm c}$ are the central density and tem perature. Having been concentrated in the centre of the star, the dark matter annihilates with itself, so the equation for the evolution of the number of W IM Ps in the star over time is

W hen $_{\rm c} = 2$ a, the capture and annihilation rates are in equilibrium and any dark matter which accretes onto the star is instantly converted into additional lum inosity. Here we assume that all of the annihilation products interact either electrom agnetically or strongly, so that they have short mean free paths in the star and the energy therm alises quickly. In reality, some fraction of the energy will be lost to neutrinos, but this is a small e ect (typically on the order of 10% or less). The time scale for the steady state to be reached will be much less than the typical evolutionary timescale of a main sequence star, so we assume that this equilibrium has been achieved.

W e studied the e ect of this energy input upon stars by altering the FORTRAN code ZAMS [15], which looks for stable stellar solutions assum ing a constant chem ical com position and a sim ple equation of state. The code was m odi ed by adding the energy generation due to W IM P annihilation to the nuclear energy generation rate.

Self gravitating system s have negative speci c heat, so as dark m atter injects energy into the core of the star, the tem perature goes down. Since the nuclear reaction rates depend exponentially on tem perature, they are signi cantly reduced for even a small drop in tem perature. A s the am bient density of dark m atter is increased and the capture rate goes up, the injection of energy due to W IM P annihilations eventually reduces the tem perature enough to shut o nuclear burning. W IM P annihilation is then the primary source of the star's lum inosity.

Since W M P annihilation occurs in a more centralised region than nuclear burning, the temperature gradient is much steeper in the core of the star than it would otherwise be, and the core becomes convective. Outside the core, less energy is generated per unit volume than if nuclear burning were proceeding normally, so the temperature gradient is less. The actual temperature is lower than in a normal star, but for small dark matter accretion rates it remains high enough to prevent any major increase in opacity, ensuring that energy transport in the region above the core remains radiative. The energy from the core is easily transmitted through this radiative zone to the surface layers of the star. The overall radius of the star remains approximately constant while the temperature decreases, so the lum inosity also decreases.




FIG.1: The zero age main sequence of W IM P burners. The black solid line is the norm al zero age main sequence for stars with solar metallicity. The points moving o the main sequence correspond to solutions where stars contain increasing amounts of dark matter in their cores. The gaps in the lines are addressed in the text.

As the W ${\mathbbm P}$ accretion rate is raised, the star continues to cool until H ions are able to survive at increasingly large depths below the surface. If the stardid not already have an appreciable surface convection zone, one develops. At high enough W IM P capture rates, the surface convection zone m erges with the inner zone and the star becom es com pletely convective. The addition of more W IM Ps and hence central lum inosity beyond this point requires the star to grow in order to transport the additional energy to the surface. The two distinct stages of this 'evolution' can clearly be seen in Figure 1. This gure shows a black solid line corresponding to the zero age main sequence, along with 'evolutionary tracks' plotted as the ambient density of W MPs is increased. These tracks are strongly rem iniscent of the Hayashi tracks which proto-stars travel along on the nal stages of their evolution towards the main sequence. The di erence is that such stars are shrinking in size on the Kelvin-Helm holtz timescale as they radiate away gravitational potential energy. In W IM P burners, there is constant energy generation in the core (provided the W \mathbb{M} P capture rate remains constant) and the stars can in principle remain at that position in the HR diagram for an arbitrarily long time.

The analysis of Salati & Silk [7] led to qualitatively similar conclusions about the backing up of the main sequence along the Hayashi track with increasing W IM P density. The shapes of the tracks are di erent in our more detailed analysis, and thus the actual positions of the resulting W IM P burners in the HR diagram di er. The e ects require higher am bient W IM P densities also, as we have considered modern W IM Ps rather than cosmions (i.e. with lower nuclear scattering cross-sections).




FIG.2: The temperature of main sequence stars of mass 1M (upper curve) and 0.7M as a function of W IM P density. A spin dependent W IM P-nucleon cross section of $= 10^{-38}$ cm² is assumed.

In Figure 1, tracks for stars of mass 0.8M are not complete, and show increasingly large gaps for larger masses. Using the modi ed ZAMS code, we could not nd solutions corresponding to all temperatures between the main sequence stars and the cooler Hayashi-like W IMP burners. In Figure 2 we plot temperature as a function of am bient W IMP density. The discontinuity occurs where the temperature of the star drops rapidly,

shortly before the star becom es fully convective.

It was not initially clear whether this lack of solutions was a real e ect or an artefact of the code. We have put som e e ort into understanding whether som e of the physical sim pli cations in the code (e.g. surface boundary conditions, a sim pli ed equation of state and thus too rigid a criterion for the onset of surface convection, or the treatm ent of convective heat transport itself) are responsible for the lack of solutions. We could nd no evidence to support this idea. Nonetheless, the gaps do not appear to have a physical basis. They seem to be a num erical artefact arising from the 'shooting' technique used by the ZAM S code to solve the boundary-value problem of stellar structure. In the region of the gaps, sm all changes in the stellar radius cause large changes in the internal tem perature. The surface de ned by the discrepancy between the inwardly and outwardly integrated partial solutions employed in this technique then becomes a highly non-trivial function of the model parameters. Finding the global m in im um of this function is then nearly im possible without an initial guess extrem ely close to the true solution, and the algorithm fails to converge.

To check that solutions do exist in this region, we investigated the gaps using a prelim inary version of our nextgeneration W IM P burner code D arkStars. This code has been created from generalised versions of capture rou-




FIG.3: Diagram for M = 2M showing that solutions can be found corresponding to all tem peratures when the more so-phisticated D arkStars code is used.

tines in DarkSUSY [13] which use the full capture rate expressions in [4], and the stellar evolution package EZ [16] derived from Eggleton's stars code [17]. The code is tim e-dependent, uses relaxation rather than shooting and includes W IM P energy transport, more detailed treatments of the W IM P distribution, capture rates, equation of state, nuclear reaction rates and opacities. Dark-Stars and results obtained with it will be described in full in an upcom ing publication [12]. The results of the m ore detailed code (Figure 3), w hilst consistent with the ZAM S code close to the main sequence and in the fully convective regions on the right-hand side of the HR diagram, show that interm ediate solutions do exist and that the gaps are not physical. This cross-check also shows that we can trust the solutions of the ZAM S code, but shouldn't take the actual gaps in the curves seriously.

Figure 2 shows that for a spin-dependent W IM Pnucleon cross section of $= 10^{-38}$ cm², stars only start to change their behaviour when imm ersed in a dark matter density of around 10^8 or 10^9 G eV cm 3 . This is much larger than the $0.3 \,\text{GeV}$ cm 3 which is thought to be the approxim ate density of dark matter in the solar system . Most modern simulations of galactic dark matter halos do suggest that the density of dark matter should be much higher in the centre of the galaxy. This density should be made more pronounced by the phenom ena of adiabatic contraction and dark matter spikes created around black holes, though tem pered by self-annihilation of dark m atter and gravitational heating due to the motion of stars. It is suggested [18] that densities larger than 10^8 G eV cm 3 can be found at radii closer than 10^{-2} pc from the galactic centre. O bservational challenges associated with constructing an HR diagram from stars in this crowded eld are severe though, as the very centre of the galaxy is shrouded in dust.

Finally, we comment upon the 'paradox of youth' in – plied by what appear to be hot, young stars close to the centralblack holes of M 31 and our own galaxy [19,20]. In our galaxy, these stars look like 15M main sequence stars with lum inosities of the order 1,000 L . Such a massive main sequence star should only be around 10 M yr old, so these objects would appear to have form ed very recently. How ever, tidal forces close to the central black

hole are thought to be too large to be compatible with the collapse of a gas cloud to begin star form ation. It is not easy to make norm al UBV measurements of stellar temperatures at the galactic centre due to extinction, but spectral lines found in the atm osphere of such stars appear to be consistent with a temperature of 30,000 K [19]. If this is the case, then it would be di cult to imagine that these are norm al stars which have been converted into fully convective and highly lum inous W M P burners from the accretion of dark matter, as such stars would have a temperature of only a few thousand degrees.

A possible explanation for the 'paradox of youth' is a com bination of collisional stripping of red giant envelopes and m erger events [20], ow ing to the high stellar densities near the centres of the two galaxies. If this is the case, then the anom alously hot stars in fact derive from an older population. Such a population should therefore also contain less lum inous, unperturbed stars, including low er m ass stars still on the main sequence. Provided that this explanation is correct, and if main sequence W IM P bumers exist at all, then such low er m ass stars should be exam ples of them. W ith upcoming observations of the galactic centre expected to probe objects as faint as 1L , a very real possibility exists for the detection of W IM P bumers in the near future.
