# Strategy for early SUSY searches at ATLAS

> Abstract. The CERN Large Hadron Collider (LHC) is scheduled to commence operation in 2008 and inclusive searches for supersymmetry (SUSY) will be one of our primary tasks in the rst days of LHC operation. It is certain that the nal state of \multijets + m issing transverse energy" w ill provide a superior perform ance in SUSY searches. Strategies to understand the instrum ental background and to understand the Standard M odel (SM) background are still under development and are urgent issues for the com ing data. We describe the strategy for early SU SY searches at the ATLAS experiment using the st data corresponding to an integrated lum inosity up to  $1\text{fb}^{-1}$ , which comprises much progress in the data-driven technique for the SM background estimations.

# 1 Introduction

Supersymmetry (SUSY) in poses a new symmetry between the ferm ions and bosons  $[1,2,3,4,5]$ . The supersymmetric extension of the Standard Model (SM) m akes im provem ents to phenom enological problem s in the physics of elem entary particles: it provides a natural solution for the gauge hierarchy problem, if sparticles exist at the TeV scale. M oreover, the extrapolation of LEP data within the fram ework of supersym m etric extension yields a precise uni cation of gauge couplings at a scale of  $10^{16}$  G eV [6,7]. Due to these properties, SU SY is one of the m ost attractive alternatives beyond the SM and has been the sub ject ofm any studies in particle physics. However, up to now, no direct evidence for SUSY has been found. It is essential to exam ine the properties of any new states of m atter at energy scales close to the threshold for the new phenom ena, or in high energy collisions at the TeV energy scale.

The CERN Large Hadron Collider (LHC), a p-p collider, is scheduled to operate at the center-of-m ass energy of 14 TeV in 2008. The ATLAS experiment is one of two general purpose experiments being nearly constructed for the CERN LHC. The ATLAS detector is designed to have a good sensitivity to the full range of high- $p_T$  physics in  $p$  p collisions. Details regarding the detector and its perform ance are described in Ref. [8]. Currently we focus on preparation for the early data in 2008, aim ing for early SUSY discoveries. We describe the strategy for early SUSY searches at the ATLAS experiment using the data from the rst year of data taking corresponding an integrated lum inosity of  $1 \text{ fb}^{-1}$ . The results in this paper are obtained using the full detector simulation to understand recon-

struction perform ances, trigger e ciencies and system atic e ects of the detector.

## 2 Inclusive searches

Sparticle production of quinos (q) and squarks (q) occurs dom inantly via strong interactions and its rate m ay be expected to be considerably large at the LHC. G luino production leads to a large rate for events with multiets via series of cascade decay and the neutral lightest supersym m etric particle (LSP) in the nalstate which rem ains stable and undetectable, if R-parity is conserved. LSP's carry o apparently large m issing transverse energy  $(E_T^{m \text{ iss}})$ . We note that there are no third generation partons in the initial state, gluino and squark production rates are xed by QCD in terms of the gluino and squark m asses (m  $_{\alpha}$  and m  $_{\alpha}$ ). Thus, inclusive SUSY searches with the early data rely on excesses of events in the channel of \multipts + large  $E_T^{m}$  iss" [9] which is a m odel-independent feature.

In our searches, the events are classi ed based on the topology, the number of identied isolated leptons, and we try to cover a broad range of experim ental signatures. The experim ental signatures, corresponding SU SY scenarios and their background processes are sum m arized in Table 1. They cover realistic supersymm etric models of m in im al supergravity (m SUGRA) [10,11,12,13], anom aly-m ediated SUSY breaking (AM SB) [14,15] and gauge-m ediated SUSY breaking (GM SB) [16,17].

#### 2.1 Event selection

C onsidering the features of sparticle production and its decay, the signal candidate events are selected by requiring:

where N  $_{\rm jet}$ ,  $p_T^{\rm J1(4)}$  , S<sub>T</sub> and M  $_{\rm e}$  are the num ber of <del>j</del>ets , the transverse m om entum of rst (fourth) leading jet, the transverse sphericity and the e ective m ass, respectively. In addition, for the singlelepton signature, the events are selected by requiring one isolated lepton w ith  $p_T$  larger than 20 G eV and the transverse m ass  $(M_T)$  should be larger than 100 G eV. The selection cuts described here are based on the def-inition given in R ef. [\[8\]](#page-3-7), but w ill be optim ized.

Finally, we look for SU SY events with large M  $_{\rm e}$ at w hich the signal exceeds the SM backgrounds. The value of  $M_e$  also provides a rst estimate of the spar-ticle m asses. Fig. [1](#page-1-1) show s the M  $_{\rm e}$  distributions for no and single-lepton signatures.For the SU SY signal, we set a bench m ark point in the bulk region, where  $m_0 = 100 \text{ GeV}$ ,  $m_{1=2} = 300 \text{ GeV}$ ,  $A_0 = 300 \text{ GeV}$ , tan =  $6$  and  $\rightarrow 0$ , referred to SU 3. If SU SY exists we expect there is an excess over the SM background expectation in the distribution for each event topology w ith an integrated lum inosity up to  $1\text{fb}^1$ .

#### 2.2 D iscovery reach

Figure [2](#page-2-0) shows 5 discovery reach in the m  $_{\sigma}$ -m  $_{\sigma}$ space for each event topology in the m SU G R A m odel. We see that even for sparticle m ass as heavy as 1 TeV, discoveries are expected for an integrated lum inosity of  $1\text{ fb}^{-1}$  . The discovery reach also show s good stability against the values of tan.

3 In-situm easurem ents for the  $E_T^{m \text{ ins}}$  scale and resolution

As stated above, the E  $_\mathrm{T}^{\mathrm{m}}$  iss the discrim inating sig– nature for the SU SY searches, but it is also a com plex object: apart from undetected neutral particles, it will com prise contributions from beam halo, cosm icray m uons and instrum entale ects such as noise, hot or dead channels or cracks of the detector. The m ism easurem ents or ine ciencies for jets and m uons also contribute to the  $E_T^{m \text{ } \text{iss}}$  ; these m ake up the fake  $E_T^{m \text{ } \text{iss}}$  . A precise understanding of these contributions and their reduction are crucial, especially in the tails of the distribution.

For the calibration and commissioning of  $\mathrm{E}^{\ \mathrm{m} \ \mathrm{iss}}_{\ \mathrm{T}}$  , we use the transverse m ass distributions of  $W$  ! l and the invariant  $m$  ass of  $Z$  ! where 's decay into a lepton and hadrons. For the  $Z$  !, as an exam ple, the invariantm ass is reconstructed using the collinear approxim ation;it is sensitive to the E m iss <sup>T</sup> scale and resolution. Fig. [3](#page-2-1) show s the  $Z$  ! invariant m ass peak as a function ofthe E m iss <sup>T</sup> scale.A variation of 10% in the  $E_T^{m}$  iss scale results in a 3% shift on the Z m assscale.T he Z m ass can be reconstructed w ith an error of 1% using an accumulated data of 100 pb  $^{\perp}$ . C onsidering the uncertainty of1% on the absolute energy scale of the calorim eters, we can evaluate the  $E_T^{m \text{ } is}$  scale with an accuracy of 4% accordingly.

The fake  $\texttt{E}_\texttt{T}^{\texttt{m}}$  iss originating from the instrum ental e ects of the detector have also been studied. A ll the results for the com m issioning are given in R ef.[\[18\]](#page-3-17).

# 4 D ata-driven approaches for background estim ations

Even if we get early indications of SU SY, we should justify \beyond SM " signatures w ith fullunderstandings of generator-level uncertainties and instrum ental

e ects of the detector because they a ect the norm alization and shapes of predicted backgrounds. H ow ever, these uncertainties are hard to estim ate in the early stage of the experim ent, and they are also expected to be large. Thus, in the early SU SY searches, we take data-driven approaches for the SM background estim ation.

#### 4.1 Z=W boson production background

The process of  $Z$  ! in association with multipts will give rise to nal states with large E  $^{\text{m}}_{\text{T}}$  iss and could be a dom inant background for the no-lepton signature. For this background contam ination, the expectation is derived from the M C distribution of Z ! with the norm alization determ ined by the  $Z$  !  $\Box$  data, where lis e or . W e can better m easure the Z ! llyield thanks to sm all backgrounds in the nal state. This norm alization factor can be also applied to the W ! l background. D i erences due to di erent m asses and production m echanism s can be taken from theory.

## 4.2 Q CD m ultiet background

The Q C D m ultiet production could be one of the m ost dom inantSM background sources due to its large cross section. In Q C D events, neutrinos via leptonic decays and them ism easurem ents of jets contribute to the tails of  $E_T^{m \text{ }iss}$  distribution. For the QCD background contam ination, the estim ation is derived from them ultijet data w ith a function representing the 
uctuations of m easured jet energies. The uctuation of jet energy is evaluated using eventsof

w here  $T_{\text{T}}^{\text{m}}$  iss;  $\text{jet}$ ) is the -angle between the m issing transverse energy and an isolated jet in radian. W e suppose that  $E_T^m$  is originated from the uctuating jet close to the  $\bar{E}_T^{m}$  iss direction, and the  $p_T$  of initial jet is estimated to be the vectorial sum of  $p_T^{jet}$  and  $E_T^{m \text{ }iss}$ . Then we can obtain the uctuating function of jet energies (R  $\label{eq:3.1} \begin{array}{ll} \frac{\dot{p}\mathrm{t}}{\mathrm{T}} & \left( \frac{\dot{p}\mathrm{t}}{\mathrm{T}} + \mathrm{E}\frac{\mathrm{m}}{\mathrm{T}}\frac{\mathrm{iss}}{\mathrm{S}} \right) = \dot{\mathrm{p}}\frac{\dot{p}\mathrm{t}}{\mathrm{T}} + \mathrm{E}\frac{\mathrm{m}}{\mathrm{T}}\frac{\mathrm{iss}}{\mathrm{T}} \hat{\mathrm{y}} \end{array} \bigg) \, .$ The jets in QCD multijet events with  $\sin \alpha \leq \frac{m \text{ }}{T}$  iss are sm eared according to the jet uctuating function, which result in uctuations of  $E_T^m$  iss. Fig. 4 show s the jet uctuating function and the  $E_T^{m}$  iss distribution with the superim posed QCD background estimation. We can obtain a fairdescription ofthe Q C D background w ith thism ethod, especially in the tails of the distribution.

# 4.3 M  $<sub>T</sub>$  discrimination method</sub>

A nother advanced m ethod to estim ate the SM backgrounds, especially for single-lepton signature, is to use  $M_T$  which show s a discrim inating power between SU SY and SM backgrounds but are less dependent on  $E_T^m$  iss. At rst, we select events of M  $_T < 100$  G eV to

enhance the backgrounds (background controlsam ple) and suppose the  $E_T^{m}$  iss distribution of these events represents that of all the SM backgrounds. Then, the overall nom alization of SM backgrounds is determ ined by com paring the num ber of events with M  $_T$  < 100 G eV and that with M  $_T$  100 G eV in the low  $E_T^{m}$  iss region below 200 GeV.

The M  $_T$  distribution and the resultant M  $_e$  are shown in Fig. 5. The estimated number of SM backgrounds with large  $M_e$  (> 800 GeV) and the MC prediction are 22.0 0.9 and 24.8 1.6, respectively. They show a good agreem ent, how ever, there could be a contam ination of signal events in the background control sample, which results in the overestimation of backgrounds by a factor of 2. We will make further investigations to improve this method and to reduce the signal contam ination in the norm alization region. Results will be reported in Ref. [18].

# 5 Conclusions

We described the strategies for early SUSY searches at the ATLAS experiment. Using the inclusive signature of multipts plus large  $E_{T}^{m}$  iss, we can make an early discovery of SU SY . Our searches are less modeldependent but sensitive to models with squark and gluino m asses up to 1 TeV with an integrated luminosity of  $1\text{fb}^{-1}$ . However, the precise understanding of the SM backgrounds is crucial for the early discovery. To settle this issue, we have been making much progress in the in-situ calibration of  $E_{\tau}^{m}$  iss and the data-driven technique for the SM background estimations. The opening of a new era of physics beyond the SM is coming with the LHC.
