# Strategy for early SUSY searches at AT LAS

Abstract. The CERN Large Hadron Collider (LHC) is scheduled to commence operation in 2008 and inclusive searches for supersymmetry (SUSY) will be one of our primary tasks in the rst days of LHC operation. It is certain that the nal state of \multijets + missing transverse energy" will provide a superior performance in SUSY searches. Strategies to understand the instrumental background and to understand the Standard M odel (SM) background are still under development and are urgent issues for the coming data. We describe the strategy for early SUSY searches at the ATLAS experiment using the st data corresponding to an integrated luminosity up to 1fb<sup>1</sup>, which comprises much progress in the data-driven technique for the SM background estimations.

#### 1 Introduction

Supersymmetry (SUSY) imposes a new symmetry between the ferm ions and bosons [1,2,3,4,5]. The supersymmetric extension of the Standard M odel (SM ) m akes in provem ents to phenom enological problem s in the physics of elementary particles: it provides a natural solution for the gauge hierarchy problem, if sparticles exist at the TeV scale. M oreover, the extrapolation of LEP data within the fram ework of supersym m etric extension yields a precise uni cation of gauge couplings at a scale of  $10^{16}$  G eV [6,7]. D ue to these properties, SUSY is one of the most attractive alternatives beyond the SM and has been the subject of m any studies in particle physics. How ever, up to now, no direct evidence for SUSY has been found. It is essential to exam ine the properties of any new states of matter at energy scales close to the threshold for the new phenom ena, or in high energy collisions at the TeV energy scale.

The CERN Large Hadron Collider (LHC), a p-p collider, is scheduled to operate at the center-ofm ass energy of 14 TeV in 2008. The ATLAS experiment is one of two general purpose experiments being nearly constructed for the CERN LHC. The ATLAS detector is designed to have a good sensitivity to the full range of high-p<sub>T</sub> physics in p p collisions. Details regarding the detector and its perform ance are described in R ef. [8]. Currently we focus on preparation for the early data in 2008, aim ing for early SUSY discoveries. We describe the strategy for early SUSY searches at the ATLAS experiment using the data from the rst year of data taking corresponding an integrated lum inosity of 1 fb<sup>-1</sup>. The results in this paper are obtained using the full detector sin ulation to understand recon-

struction perform ances, triggere ciencies and system - atic e ects of the detector.

### 2 Inclusive searches

Sparticle production of gluinos (g) and squarks (q) occurs dom inantly via strong interactions and its rate m ay be expected to be considerably large at the LHC. G luino production leads to a large rate for events with multiples via series of cascade decay and the neutral lightest supersym metric particle (LSP) in the nalstate which remains stable and undetectable, if R -parity is conserved. LSP's carry o apparently large missing transverse energy ( $E_T^{miss}$ ). We note that there are no third generation partons in the initial state, gluino and squark production rates are xed by QCD in terms of the gluino and squark masses (m<sub>g</sub> and m<sub>g</sub>). Thus, inclusive SUSY searches with the early data rely on excesses of events in the channel of \multiples + large  $E_T^{miss}$  [9] which is a model-independent feature.

In our searches, the events are classi ed based on the topology, the number of identi ed isolated leptons, and we try to cover a broad range of experimental signatures. The experimental signatures, corresponding SUSY scenarios and their background processes are summarized in Table 1. They cover realistic supersymmetric models of minimal supergravity (mSUGRA) [10,11,12,13], anom aly-mediated SUSY breaking (AMSB) [14,15] and gauge-mediated SUSY breaking (GMSB) [16,17].

#### 2.1 Event selection

C onsidering the features of sparticle production and its decay, the signal candidate events are selected by requiring:

where N  $_{\rm jet}, p_{\rm T}^{\rm J1(4)}, S_{\rm T}$  and M  $_{\rm e}$  are the number of jets , the transverse momentum of rst (fourth) leading jet, the transverse sphericity and the e ective mass, respectively. The e ective mass is form ulated as M  $_{\rm e}$  =  $^{\rm i}$   $^{\rm i}_{\rm i=0} p_{\rm T}^{\rm i}$  + E  $_{\rm T}^{\rm m \, iss}$ , where  $p_{\rm T}^{\rm i}$  is the transverse momentum of i-th leading jet. In addition, for the single-lepton signature, the events are selected by requiring one isolated lepton with  $p_{\rm T}$  larger than 20 G eV and the transverse m ass (M  $_{\rm T}$ ) should be larger than 100 G eV. The selection cuts described here are based on the definition given in R ef. [8], but will be optim ized.

Finally, we look for SUSY events with large M  $_{\rm e}$  at which the signal exceeds the SM backgrounds. The value of M  $_{\rm e}$  also provides a rst estimate of the sparticle masses. Fig. 1 shows the M  $_{\rm e}$  distributions for no and single-lepton signatures. For the SUSY signal, we set a bench mark point in the bulk region, where m  $_0$  = 100 G eV, m  $_{1=2}$  = 300 G eV, A  $_0$  = 300 G eV, tan = 6 and > 0, referred to SU3. If SUSY exists we expect there is an excess over the SM background expectation in the distribution for each event topology with an integrated lum inosity up to  $1 {\rm fb}^1$ .

#### 2.2 D iscovery reach

Figure 2 shows 5 discovery reach in the m $_g$ -m $_q$  space for each event topology in the m SUGRA model. W e see that even for sparticle mass as heavy as 1 TeV, discoveries are expected for an integrated luminosity of 1fb<sup>-1</sup>. The discovery reach also show s good stability against the values of tan .

# 3 In-situ m easurem ents for the $E_{\rm T}^{\,\rm m\,iss}$ scale and resolution

As stated above, the  $E_T^{m iss}$  is the discriminating signature for the SUSY searches, but it is also a complex object: apart from undetected neutral particles, it will comprise contributions from beam halo, cosm icray muons and instrumental elects such as noise, hot or dead channels or cracks of the detector. The mismeasurements or ine ciencies for jets and muons also contribute to the  $E_T^{m iss}$ ; these make up the fake  $E_T^{m iss}$ . A precise understanding of these contributions and their reduction are crucial, especially in the tails of the distribution.

For the calibration and comm issioning of  $E_{T}^{m}$  iss, we use the transverse mass distributions of W ! 1 and the invariant m ass of Z ! where 's decay into a lepton and hadrons. For the Z ! , as an exam ple, the invariant m ass is reconstructed using the collinear approximation; it is sensitive to the E  $_{\rm T}^{\rm m \ iss}$  scale and resolution. Fig. 3 shows the Z ! invariant m ass peak as a function of the  $E_T^{m iss}$  scale. A variation of 10% in the  $E_{T}^{m}$  is scale results in a 3% shift on the Z mass scale. The Z mass can be reconstructed with an error of 1% using an accumulated data of 100 pb  $^{\perp}$ . Considering the uncertainty of 1% on the absolute energy scale of the calorim eters, we can evaluate the  $E_{T}^{m \text{ iss}}$  scale with an accuracy of 4% accordingly.

The fake  $E_T^{m \text{ iss}}$  originating from the instrumental e ects of the detector have also been studied. All the results for the commissioning are given in Ref. [18].

# 4 D ata-driven approaches for background estim ations

Even if we get early indications of SUSY, we should justify \beyond SM " signatures with full understandings of generator-level uncertainties and instrum ental e ects of the detector because they a ect the norm alization and shapes of predicted backgrounds. How ever, these uncertainties are hard to estimate in the early stage of the experiment, and they are also expected to be large. Thus, in the early SUSY searches, we take data-driven approaches for the SM background estimation.

#### 4.1 Z=W boson production background

The process of Z ! in association with multijets will give rise to nal states with large  $E_T^{m iss}$  and could be a dom inant background for the no-lepton signature. For this background contam ination, the expectation is derived from the MC distribution of Z ! with the norm alization determ ined by the Z ! Il data, where l is e or .We can better measure the Z ! Il yield thanks to small backgrounds in the nal state. This norm alization factor can be also applied to the W ! 1 background. D i erences due to di erent masses and production mechanism s can be taken from theory.

#### 4.2 QCD multijet background

The QCD multijet production could be one of them ost dom inant SM background sources due to its large cross section. In QCD events, neutrinos via leptonic decays and them ism easurem ents of jets contribute to the tails of  $E_T^{m iss}$  distribution. For the QCD background contam ination, the estimation is derived from them ultijet data with a function representing the uctuations of m easured jet energies. The uctuation of jet energy is evaluated using events of

Then we can obtain the uctuating function of jet en $p_T^{jet}$   $(p^{jet} + E_T^{m iss}) = p_T^{jet} + E_T^{m iss}$ ). ergies (R 1 The jets in QCD multijet events with small  $E_{\tau}^{m}$  is are sm eared according to the jet uctuating function, which result in uctuations of  $E_T^{m \text{ iss}}$ . Fig. 4 shows the jet uctuating function and the  $E_{\,\rm T}^{\,\rm m\,iss}$  distribution with the superim posed QCD background estimation. We can obtain a fair description of the QCD background with this method, especially in the tails of the distribution.

#### $4.3 \text{ M}_{\text{T}}$ discrim ination m ethod

A nother advanced m ethod to estim ate the SM back-grounds, especially for single-lepton signature, is to use M<sub>T</sub> which shows a discriminating power between SUSY and SM backgrounds but are less dependent on E<sub>T</sub><sup>m iss</sup>. At rst, we select events of M<sub>T</sub> < 100 G eV to

enhance the backgrounds (background controlsam ple) and suppose the  $\rm E_{T}^{m\ iss}$  distribution of these events represents that of all the SM backgrounds. Then, the overall norm alization of SM backgrounds is determined by comparing the number of events with M $_{T}$  < 100 G eV and that with M $_{T}$  100 G eV in the low  $\rm E_{T}^{m\ iss}$  region below 200 G eV .

The M  $_{\rm T}$  distribution and the resultant M  $_{\rm e}$  are shown in Fig. 5. The estimated number of SM backgrounds with large M  $_{\rm e}~(>800~{\rm GeV})$  and the M C prediction are 22:0 0.9 and 24:8 1:6, respectively. They show a good agreement, however, there could be a contam ination of signal events in the background control sample, which results in the overestimation of backgrounds by a factor of 2. W e will make further investigations to improve this method and to reduce the signal contam ination in the normalization region. Results will be reported in Ref. [18].

## 5 Conclusions

We described the strategies for early SUSY searches at the ATLAS experiment. Using the inclusive signature of multijets plus large  $E_T^{m iss}$ , we can make an early discovery of SUSY.Our searches are less modeldependent but sensitive to models with squark and gluino masses up to 1 TeV with an integrated lum inosity of 1fb<sup>1</sup>. However, the precise understanding of the SM backgrounds is crucial for the early discovery. To settle this issue, we have been making much progress in the in-situ calibration of  $E_T^{m iss}$  and the data-driven technique for the SM background estimations. The opening of a new era of physics beyond the SM is coming with the LHC.
