Som e aspects of ultra-relativistic heavy ion collisions

In this talk,I discuss som e recent results obtained in H eavy Ion C ollisions and w hat they tellus { or w hat questions they raise { about the physics ofthe system ofquarksand gluons form ed in these collisions.

1.Q uark-G luon plasm a and heavy ion collisions

The existence of a decon ned phase of nuclear m atter was conjectured long ago on the basis of asymptotic freedom, and has now received ample support from QCD sim ulations on the lattice $[1]$. Som e of these results are displayed in qure [1.](#page-0-0) On the left qure is displayed the potential between

two static quarks as a function of the distance between them . T he solid line is the zero tem perature potential, that show s a linear rise at large distance - a sign of quark con nem ent. The dotted lines show the same potential at increasing tem peratures. The m ain feature is that, while the short distance behavior is not much a ected, the linearly increasing tail eventually disappears. This indicates that above a certain tem perature, it \cos ts only a nite energy to separate the two quarks. A nother evidence for a

phase transition is shown in the right plot of gure 1, where one can see that the pressure rises very rapidly at a certain tem perature (the value of which depends on the quark content of the theory), indicating a sudden increase in the num ber of degrees of freedom in the system. This is interpreted as a transition from hadronic bound states to a plasm a of quarks and gluons.

This phase transition has occurred in the expansion of the early universe (left panel of gure 2), but unfortunately this has not left any visible relic in today's observable sky. A nother place to look for experimental evidence of color decon nem ent is in the collisions of large nuclei at high energy (see the right panel of qure 2). The basic idea of these experiments is to deposit a large am ount of energy in order to create m atter w ith an energy density larger than the critical one, and to do so in an extended volume, i.e. large com pare to the typical hadronic size, so that them odynam ical concepts have a chance to apply. Such collisions have been perform ed at the AGS (BNL), at the SPS (CERN), presently at the RHIC (BNL), and in the near future at the LHC.

The standard scenario for a high energy nucleus-nucleus collision involves several stages (see qure 3). At extremely short time scales take place the very hard processes that account for the hard particles in the nalstate. It is believed that they can be calculated using the standard tools of perturbative Q C D and collinear factorization. H owever, m ost of the particles that m ake the nal state are in fact quite soft $(99\% \tof the multiplicity in a collision)$ at R H IC is m ade of particles w ith p_2 2 G eV). The bulk of this particle production takes place slightly later $(t \t 0.2 \text{ fm})$, and since it involves the low x part of the nuclear wavefunction, i.e. large parton densities, it is expected to be am enable to a treatm ent in term s of classical elds. The Color G lass Condensate [\[2\]](#page-7-1)e ective theory is a fram ework in which such calculations can be carried out in a system atic way. Eventually, this decon ned m atter reaches a state of local therm alequilibrium, and can be described by hydrodynam ics. Because it is in expansion, it cools down and reaches the critical tem perature w here hadrons are form ed again. At a later stage, the density becom es too low to have an interaction rate high enough to sustain equilibrium, and the system freezes out. Experim entally, one is trying to infer properties of the early and interm ediate stages of these collisions from the m easured hadrons in the nalstate.

2.Sm allcoupling w isdom

U ntil recently, the theoretical studies of the properties of the quark gluon plasm a have been based on the assum ption that the tem perature is high enough to apply weak coupling techniques, thanks to asymptotic freedom (the average distance between two particles in the plasm a goes like T^{-1}). W hen the coupling constant g is an all, there is a useful separation between various distance scales, each of them corresponding to dierent physical phenom ena, and being described by a speci c e ective theory $[3]$. These scales are :

 \cdot T^1 . This is the mean distance between two particles in the plasm a . A ∞ , T is the typical energy of a plasm a particle, and it is therefore this scale that dom inates the bulk of the pressure (P T^4).

 $'$ (gT)¹. This is the scale at which them ain collective eects occur in the $Q G P$. For instance, the D ebye screening length is of the order of (gT) $^{-1}$, and plasm a particles acquire a therm alm ass of order gT due to their interactions w ith the other particles.

 \int (g $\ln(1=g)$) ¹ is the mean free path between two collisions with a soft m om entum transfer, i.e. a scattering angle of order g. This is the relevant scale for phenom ena such as electrom agnetic em ission from the plasm a.

 $\left(\frac{1}{2} \right)^{-1}$ is the mean free path between two hard scatterings, i.e. w ith a scattering angle of order unity. This is the natural scale for the transport of m om entum.

H owever, one also sees from this sm all coupling analysis that the scale that characterizes them alization is the last one, i.e. $(g^4T)^{-1}$. In other words, it is quite unnatural to have a fast therm alization in a weakly coupled system.

3.R H IC results

In seven years of operation, the RH IC has obtained m any results relative to heavy ion collisions [\[4\]](#page-7-3). Let me only discuss two speci c results, that are am ongst the m ost im portant.

The rst one is the phenom enon of jet quenching. In proton-proton collisions, one is used to nal states being predom inantly 2-jet events. Jets are very hard to m easure directly in nuclear collisions due to the high nal state m ultiplicity, but one can m easure the azim uthal correlation function between pairs of particles (see the left panel of qure 4). In pp collisions, this correlation function is peaked both at $= 0$ and at $= 0$. The same is true in deuteron-nucleus collisions. However, in nucleus-nucleus collisions, one observes only a correlation around $= 0$, and no correlation at $= -1$. T his led to the idea that the m atter form ed in nuclear collisions is opaque to the propagation of hard partons (i.e. they fragm ent m uch m ore than in the vacuum and are undistinguishable from the bulk ofthe other particles when they come out on the other side). The correlation at $= 0$ would be from i ets produced near the surface of the m edium, a con quration in which the partner jet in the opposite direction has a much larger length of m atter to cross before escaping, hence its disappearance.

The second striking phenom enon observed at RHIC is elliptic ow. In peripheral collisions, the initial shape of the m atter form ed in the collision has an elliptic azim uthal shape (see qure [5\)](#page-4-0). Since its pressure is zero at

the outer surface, and m axim al at the center, the pressure gradients are larger in the direction of the small axis of the ellipsis. This means that the particles will acquire a larger ow velocity in this direction, and the net result of this is an anisotropy of the transverse m om enta of the particles m easured in the nalstate. This anisotropy is characterized by the m easure of a num ber called v_2 , de ned by

where sittle azimuthaldirection of the reaction plane, i.e. the plane that contains the in pact parameter of the collision. Experimental results for v_2 are displayed for various particles, as a function of their p_2 , in the left panel of gure 5. The solid curves in this plot are the result of a simulation based on ideal hydrodynam ics, in which one treats the matter produced in the collision as a uid that has no viscosity. Let us recall here that no viscosity means that the uid must be in equilibrium so that it is not the siege of dissipative phenom ena. M oreover, it has been arqued that the system must have been close to equilibrium from early times, in order to produce an elliptic ow of that m agnitude (dissipative e ects tend to reduce v_2), which is hard to explain in the conventional weak coupling approach.

4. A dS/CFT duality and the OGP

The parameter that controls viscous e ects in hydrodynamics is the dim ensionless ratio of the viscosity to entropy density, =s. W hen evaluated $(\mathbb{d} \ln(1=a))$ ¹ [5]. It is therefore in perturbative QCD , this ratio is =s large in the weak coupling lim it, in apparent contradiction with the fact that non viscous hydrodynam ics reproduces well RH IC data on v_2 . = s cannot be evaluated in the strong coupling lim it of QCD . However, one can perform

such strong coupling calculations in an $N = 4$ super-symm etric Y ang-M ills theory, thanks to the AdS/CFT correspondence.

The AdS/CFT correspondence states that this particular gauge theory is dual to a type IIB string theory on an AdS_5 S₅ background. M oreover, the correspondence between the param eters of the two theories is such that the $\lim \text{if } q^2 \quad 1 \text{; } q^2N_c$ 1 of the gauge theory corresponds to the lim it where the string theory simplies into classical super-gravity. Then, correlators in the gauge theory can be calculated from classical solutions in the gravity dual, w ith boundary conditions on the 4 -dim ensional boundary of the AdS₅ that depend on the specic problem one wants to study in the 4-dim ensional gauge theory.

U sing this correspondence, $=$ s was calculated exactly in the strong coupling lim it of an $N = 4$ super-symmetric Yang-M ills theory, and it was found to be = $s = 1=4$ [6]. It was also argued that = s m ust have a lower bound of order unity because of the uncertainty principle $($ =s is of the order of the ratio of the m ean free path to the De B roglie wavelength of the particles), and that the $N = 4$ SU SY Yang-M ills theory in the strong coupling lim it actually realizes the lower bound. A lthough one cannot use these techniques in QCD , it is believed that the strong coupling regime of QCD also exhibits a sm all value of $=s$, but it is at the m om ent im possible to m ake this statem ent m ore rigorous than an educated quess.

5. Early time dynamics

A swe have seen, invoking a strong gauge coupling m ay explain why the viscosity is so sm all, and also why the system them alizes early. Another point of view exists in the community, which assumes that the early stages of high energy heavy ion collisions can be studied by perturbative techniques. First of all, one should recall that the bulk of particle production in heavy ion collisions is due to partons that carry a sm all m om entum fraction x in the incom ing nuclei. Because of the rise of the gluon distribution at

 \sin all x, the density of such partons is high, leading to the phenom enon of saturation: the gluon phase-space density cannot grow larger than $1=$ s due to the repulsive interactions am ong the gluons. Thus, the gluons at low x must occupy higher $p_?$ modes: at a given x, all the modes up to $p_? = Q_{sat}(x)$ are occupied with a phase-space density of the order of $1 = s$. $Q_{sat}(x)$, the saturation m om entum, grows like x 0.3 at sm all x. It also depends on the nuclear atom is number like $A^{1=3}$, which means than nuclei have a larger saturation m om entum than protons at a given x.

In the saturated regime (Q^2) $Q_{\text{sat}}^2(x)$ in the diagram on the left of gure 7), gluon recombination and multiple scatterings play a crucial role in the m echanism s of particle production (see the right panel of gure 7). The Color G lass Condensate [2] is an e ective theory in which these e ects are system atically taken into account, based on the separation of the degrees of freedom into color elds (that represent the low x partons), and static cobr sources (that represent the large x partons). In particular, the single inclusive spectrum of the gluons and quarks produced in the collision of two heavy ions have been computed at leading order [7] in this fram ework. Work is underway in order to evaluate the NLO corrections to the gluon spectrum, and to establish a factorization theorem for nucleus-nucleus collisions in the saturated regin e [7]. Note that these calculations only give the distribution of produced particles at a short time after the impact (of the order of Q_{sat}^{-1} , which can then be used in order to model the initial conditions for the subsequent hydrodynam ical evolution.

These studies of the initial conditions in heavy ion collisions have also led to an interesting development, which is expected to have connections with the issue of them alization. It has been noted that the classical color eld con qurations encountered in the CGC form alism at leading order are unstable: sm all rapidity dependent perturbations grow exponentially in time

and eventually become as large as the classical eld itself [\[8\]](#page-7-7). It turns out that perturbations of this kind are generated by quantum uctuations $[9]$, and therefore occur naturally am ong the N LO corrections. These quantum uctuations, am pli ed by the instability, would lead to extrem ely disor-dered con qurations of strong elds (see qure [8\)](#page-7-9). Particles m oving in such a m edium would also have a very short m ean free path, and the viscosity would be close to the uncertainty lower bound [\[10\]](#page-7-10). T his opens up an interesting alternative to the strongly coupled scenarios: the quasi-perfect uidity inferred from R H IC data m ay be due to strong disordered color elds, even if the coupling is rather weak.
