H igh energy factorization in nucleus-nucleus collisions II-Multigluon correlations

A bstract

We extend previous results (arX iv: 0804.2630 [hep-ph]) on factorization in high-energy nucleus-nucleus collisions by computing the inclusive multigluon spectrum to next-to-leading order. The factorization formula is strictly valid for multigluon em ission in a slice of rapidity of width s^{-1} . Our results shows that often neglected disconnected graphs Y dom inate the inclusive multigluon spectrum, and are crucial in order to achieve factorization for this quantity. These results provide a dynamical fram ew ork for the G lasm a ux tube picture of the striking \ridge"-like correlation seen in heavy ion collisions.

$\mathbf 1$ Introduction

In a recent work, henceforth referred to as Paper I [1], we investigated the form all basis for the application of the C obr G lass C ondensate (CGC) fram ework $[2{8}]$ to the collision of two high energy nuclei. In Paper I, we focused on the form alism to compute the single gluon inclusive spectrum in the Leading Log x approxim ation. Them ain result of Paper I is a proof that term s containing leading logarithm s of $1=x_{1,2}$ that arise in all order loop corrections to this spectrum can be factorized in the distributions of color sources W [$_{1/2}$] in each of the two nuclei, evolved with the JMW LK equation [9{16] from the beam rapidity to the rapidity of the measured gluon. One obtains for the single inclusive gluon

distribution the result

The W functionals are universal properties of the nuclear wavefunctions at high energies and (in analogy to the parton distribution functions of collinear factorization) can be extracted from deep inelastic scattering or proton-nucleus scattering experim ents o nuclei. The inclusive single gluon spectrum (dN = $d^3p)$ that appears under the integral in the right hand side is the Leading O rder spectrum corresponding to one con guration of the sources $_{1,2}$ { it is obtained by solving the classical Y ang-M ills equations for this xed distribution of sources. T his factorization theorem allow s for considerable predictive power by relating m easurem ents in a variety of scattering processes. It should be particularly useful at the LHC, where the rapidity reach in proton-nucleus and nucleusnucleus collisions w ill be considerable and the eects of energy evolution of the distribution of color sources clearly visible.

The derivation of the factorized expression in eq. (1) relied on two essential steps:

- 1. The 1-loop corrections to the gluon spectrum can, in the leading logarithm approxim ation, be expressed as the action of a certain linear operator on the leading order spectrum 1 ,
- 2. This operator acting on the initial color elds on the light-cone is, again in the leading log approxim ation, the JIM W LK H am iltonian.

In the present paper, we will show that a straightforward generalization of the rst of these two steps is succient to extend our factorization result to inclusive m ultigluon spectra w hen allthe m easured gluonsare located in a rapidity region of m axim alwidth $Y \cdot s^1$.

The paper is organized as follow s. In section 2, we de ne a generating functional for m ultiparticle production in nucleus-nucleus collisions. This extends to the QCD case our previous results $[17,18]$ for a sim ilar ob ject introduced for $a³$ theory. We discuss key features of this generating functional and develop a diagram m atic interpretation of this object. We show how (at leading order) its rst derivative can be expressed in term s of classical solutions of the Yang-M ills equations that obey both advanced and retarded boundary conditions. In section 3, we consider in detail the inclusive two-gluon spectrum . We obtain an expression of this spectrum at next-to-leading order (N LO) using the previously dened generating functional. W e end the section by show ing that the leading logs of $1=x_{1;2}$ in this quantity can be factorized in the distributions of incom ing color sources, provided the rapidity separation between the two gluons is sm all enough. We show that our form alism gives rise to the G lasm a ux tube picture [19], w hich has been suggested as a m echanism to describe the ridge-like structure observed in heavy ion collisions at RH \mathbb{E} [20{24]. In section 4, we

generalize this factorization result to the case of the inclusive n-gluon spectrum. K now ing all the m om ents de nes the complete probability distribution. We dem onstrate how the leading logarithm is corrections to the multiplicity distribution can be factorized into the JIMW LK evolution of the sources. We end w ith a brief sum m ary. The three appendices are devoted to the m ore technical aspects of our discussion.

G enerating functional \mathcal{L}

In Paper I, we developed the tools for studying at LO and NLO the single inclusive gluon spectrum in AA collisions in the CGC fram ework. Our goal is to generalize these techniques to obtain similar results for the n-gluon spectrum. Towards that purpose, we will de ne in this section a generating functional for n-gluon production, discuss its properties and develop a diagram m atic interpretation. We then discuss the LO computation of the rst derivative of this object in term s of solutions of classical Y ang-M ills equations with both retarded and advanced boundary conditions.

De nition and properties 2.1

We de ne the generating functional as

where we use the following compact notation for phase-space integrals²,

In this de nition, $z(p)$ is an arbitrary function over the 1-gluon phase-space. The matrix element squared that appears in the right hand side is in plicitly sum m ed over the polarizations and colors of the produced gluons. Note that in this section, we consider the external current J coupled to the gauge eld to be xed. This is the case in the CobrG lass Condensate (CGC) fram ework [8] where the xed sources represent the large x light cone color charge densities in the nuclear wavefunctions. We will address the issue of averaging over the external color sources later in this paper.

The generating functional generalizes the generating function F (z) we introduced in ref. [17]. This previously de ned function is simply obtained as

when $z(p)$ is a constant z . A nother obvious property of $F [z(p)]$ is

which is a consequence of the fact that the theory is unitary.

The generating functional encapsulates the entire inform ation content of the nuclear collision w ithin the CGC fram ework. Indeed, if F [z(p)] were known, one could use it to build an event generator for the early G lasm a $[25,18,8]$ stage of nucleus-nucleus collisions. In particular, one can com pute the inclusive multigluon spectra. For instance, the single inclusive³ gluon spectrum is obtained as

Likew ise, the inclusive 2-gluon spectrum is obtained by dierentiating F [z] tw ice,

where the integral over p and q on the left hand side of this expression is the average value of N $(N-1)$. Physically, this quantity, in an event, corresponds to a histogram of all pairs of distinct gluons with m om enta $(p;q)$. We will discuss the average over all such events later. Eqs. (6) and (7) are the two sim plest exam ples of the use of this generating functional, but in principle one can derive from it any observable that is related to the distribution of gluons produced in the collision.Eq.(7) can be generalized to

for the inclusive n-gluon spectrum . Note that the lh s, integrated over the nparticle phase space, is norm alized to the average value of $N(N - 1)$ (N $n + 1$).

From ϵq . (8), it is possible to represent the generating functional F [z] as

T his form ula w illlater be the basis ofour strategy to obtain an expression for F [z] at Leading Log. We will rst obtain Leading Log expressions for the ngluon spectra⁴, and w ill show that the in nite sum in eq. (9) leads to a very sim ple expression.

 $3N$ ote that setting z(p) to zero instead, after taking the functional derivative, one obtains the dierential probability for producing exactly one gluon in the collision,

O nce we know $F [z]$ (with a given accuracy), one can use the fact that its Taylor coe cients at $z(p) = 0$ are the dierential probabilities for producing a xed num ber of particles⁵,

From this second representation of F [z], one can extract from F [z] detailed inform ation about the distribution of produced gluons.

2.2 D iagram m atic interpretation ofF [z]

In order to see w hat are the diagram sthat contribute to F [z], let us rst de ne Z

This operator has already been introduced in $[17,18]$ to write P_n in term s of vacuum diagram s. The only dierence here is that we extend its de nition to the case of vector particles and QCD. The sum over the gluon polarizations

spans the two physicalpolarization states. By m im icking the m anipulations perform ed for scalar elds, one can prove that

w here iV [J] is the sum of the connected vacuum diagram sevaluated w ith the external current J . It is easy to check that all the formulas we previously obtained in $[17,18]$ for P_n or for the generating function F (z) are all particular casesofthis form ula.

From the interpretation of the operator D as an operator that m akes cuts through vacuum diagram s, we see that the functional F [z(p)] is the sum of all the cutvacuum diagram s (connected ornot) in w hich every cut propagator w ith m om entum p is weighted by $z(p)$. Let us call iW $[J, jJ, z]$ the sum of all such connected diagram s (before the currents J_+ and J_- are set equal to the physical value J) :

 5 N ote that there is no 1=n! in this formula. A quick way to convince oneself that this is correct is to set $z(p) = 1$; the integrals over the m om enta p_i give the total probabilities P_n , w hich add up to unity.

It is useful to compute the rst derivative of F [$z(p)$] with respect to $z(p)$,

The nalexponential in this formula is nothing but F [z] itself. Therefore, we can write

This form ula tells us that this quantity is m ade up of only connected diagram s since iW is a sum of connected diagram s. We also observe that this formula is very similar to the formula for the single inclusive particle spectrum with one very important di erence: the function $z(p)$ is not set to 1 at the end, and therefore appears as a multiplicative factor attached to each cut propagator.

2.3 $\ln F$ [z = z(p) at leading order

Let us now show that, in the regine of strong external color sources, the expression in eq. (17) can be expressed at leading order (LO) in term s of classical solutions of the Yang-M ills equations.

First of all, note that the rst derivatives $W = J$ are of order 6 q 1 , while the second derivative ${}^{2}W = J_{1}$ J is order q⁰. Thus the rst tem, composed of the product of two rst derivatives, is the leading one. The second term begins to contribute only at next-to-leading order (NLO). At LO, we can thus w rite

A ll the argum ents developed to com pute the generating function F (z) at leading order [18] can be extended trivially to the present situation, and one obtains the follow ing results :

We see that the dependence of the classical elds A on the function $z(p)$ com es entirely from the boundary conditions⁹, since the Yang-M ills equations them selves do not explicitly contain $z(p)$. In term s of the Fourier coe cients $f^{(-)}$, eq. (18) reads

The two conditions at $x^0 = +1$ im ply that $A_+ (x) = A$ (x) everywhere. The two conditions at $x^0 = 1$ then im ply that $\lim_{x^0 \downarrow -1} A(x) = 0$. Therefore, when $z(p) = 1$, the two classical elds A becom e identical to the retarded classical eld w ith a vanishing initial condition in the rem ote past, and eq. (18) gives the single inclusive gluon spectrum as expected.

Eqs.(20),(22) and (23) do not provide a practicalway to obtain the LO generating functionalF [z(p)]because the solutionsdepend on boundary conditions at both 1. It is not known at present how to solve Y ang {M ills equations w ith sim ultaneous advanced and retarded boundary conditions. N evertheless, the procedure outlined here provides a powerful theoretical tool to com pute other quantities, that can be obtained as derivatives of the generating functional. A concrete illustration of this strategy is revealed in the case of the 2-gluon spectrum in the follow ing section.

3 T w o-gluon inclusive spectrum

In this section, we will specialize our discussion of the generating functional in the previous section to the 2-gluon inclusive spectrum at LO and NLO. We will dem onstrate that, just as in the case of the single gluon spectrum discussed in Paper I, the leading logarithm contributions that arise at NLO can be absorbed in the JIM W LK wave functionals of the two nuclei, provided the rapidity separation between the two gluons is \sin all enough. As in Paper I, one obtains a factorized expression for the leading log 2-gluon inclusive spectrum . In the follow ing section, this result w ill be extended to m ultigluon spectra.

3.1 Leading O rder

T he inclusive 2-gluon spectrum is obtained by taking the second derivative of the generating functional F [z], and by setting the functions $z(p)$ and $z(q)$ to unity afterwards (see eq. (7)). A lternately, it is easy to obtain this derivative from the derivative of $ln F$ [z]. We get

The rst term is simply the product of two singlegluon spectra (see eq. (6)), and therefore corresponds to the disconnected (independent) production of a gluon of m om entum p and a gluon ofm om entum q. In contrast, because $\ln F$ [z] contains only connected diagram s, the second term corresponds to the two gluons being produced in the sam e graph. N ote that these expressions correspond to the 2-gluon spectrum for a xed con guration of the external sources $_{1:2}$. W hen we average over these sources, som e graphs that were disconnected prior to averaging becom e connected. Therefore, even the rst term in eq. (24) can lead to correlations in the m easured 2-gluon spectrum.

The two term s in this expression do not begin at the same order in g^2 . In our power counting,

This implies that the rst term in eq. (24) is of order g⁴, while the second term is of order g^{-2} only. For the 2-gluon spectrum, λ leading order" therefore means 9^{4} , and we simply have¹⁰

No new computations are necessary here because we know how to express the single gluon spectrum at LO in terms of classical solutions of the Yang-M ills equations with retarded boundary conditions. Note that at this order the N tem contributing to N_2 is subleading relative to the N 2 contribution because it starts only at the order q^{-2} therefore does not appear on the right hand side of eq. (26) which is of order q⁴.

3.2 N ext to Leading 0 rder - I

We shall now study the inclusive 2-gluon spectrum at NLO {the contribution at order g^{-2} in our power counting. At this order, the tree level contribution to second term in eq. (24) must be included. We can write therefore

The rst two term sagain do not require a new computation because we studied in great detail the single gluon spectrum at NLO in Paper I [1]. In particular, we recall here the previously derived formula

In this formula, a_{k} a denotes small eld uctuations that propagate over the classical ebl A. The subscripts indicate that these uctuations begin in the rem ote past as plane waves of m om entum k , polarization and color a. Sim ilarly, is also a small eld uctuation propagating on top of A, but this uctuation has a vanishing initial condition in the past and is driven by a non zero source tem. is a surface on which the initial value of the classical elds are de ned, and d^3u is the measure on this surface. The operator \mathbb{T}_u is the

generator of translations of the initial eld at the point u^2 . N_{NLO} (p) is a term contributing to the full expression. It will not be explicited further because it does not contain a leading logarithm is contribution (see the discussion of this term in [1]. Because we are interested here in these leading log contributions, this term will be dropped in all further equations in this paper.

At this point, we can rew rite the rst two term s of the rh s. of eq. (27) as

where the subscript \disc" added to the operator between the square brackets indicates that when the combination $\mathbb{T}_u \mathbb{T}_v$ in L_2 acts on the product (dN = d^3p)(dN = d^3q), we keep only the term s where the two T 's act on the same $factor¹¹$. The subscript here rem inds us that these term s are disconnected contributions that are the product of a function of p and a function of q.

3.3 Next to Leading 0 rder - II

The third term of eq. (27), involving the second derivative of the log of the generating functional, is new and will be computed here. Fortunately, we need this term only at leading order (i.e. 0 (g²). Therefore, our starting point in evaluating this term is eq. (23) . D i erentiating this equation with respect to $z(q)$, we obtain

at $x^0 = +1$. The equation of m otion obeyed by this object can be obtained by di erentiating, with respect to $z(q)$, the equation of motion for A . We see that we have non hom ogeneous boundary conditions, which will lead to a non zero b $_{\text{M}}$ despite the fact that this uctuation obeys an hom ogeneous equation of motion. This leads to the simplication that when $z(p) = 1$, the classical $eksA_+$ and A become identical (as can be checked from their boundary conditions (see footnote 9). In fact, their com m on value is nothing but the classical eld that vanishes when x^0 ! 1. We will simply denote by A the common value of these two elds and $f^{(-)}(x^0;p a)$ its Fourier coe cients.

O bviously, eqs. (34) are not sim ple retarded boundary conditions. O ur task is now to relate the uctuations $\frac{1}{N}$ and their Fourier coe cients to uctuations that satisfy sim ple retarded boundary conditions. The last term in eq. (40) , proportional to $(p - q)$ tim es the single particle spectrum, arises because the quantity $dN_2 = d^3pd^3q$ is de ned in such a way that its integral over p and q gives the average value¹⁴ of N (N \quad 1). This term provides the N contribution to this quantity. Because the logs in the multiplicity N arise only at the order O (g⁰), this term cannot provide any leading log in the 2-gluon spectrum and can thus be dropped.

3.4 Leading log resum m ation ofthe 2 gluon spectrum

C om bining the results in eq. (40) and eq.(28) in eq. (27), we now have a form ula for the 2-gluon spectrum, including both LO and NLO contributions. As mentioned previously, it can in principle be evaluated, in full generality, by num erical solutions of sm all uctuation partialdi erential equations w ith retarded boundary conditions. H ow ever, if one is interested prim arily in the leading logarithm ic piece of the N LO contributions, we can go signi cantly further analytically. In deed, as we will now show by using the inform ation obtained thus far, we can com pute the leading logarithm ic contributions to the two gluon spectrum in perturbation theory.

The rst step in this derivation is to obtain an even m ore compact form for eq. (40) by using the linear operator \mathbb{T}_n that we used previously in the expression for the 1-loop corrections to the single particle spectrum {see eq. (28). In Paper I, we dem onstrated explicitly that this operator allow sone to express the value of a retarded uctuation at a point x in term s of the value of the classical eld at the same point as Z

A ll of our discussion thus far has been for a xed distribution of sources $\frac{1}{2}$ in the two nuclei. The CGC eective theory $[2{4,9{16}]$, prescribes to average physical quantities over all the possible con qurations $_{1:2}$ of the fast color sources representing the projectiles, with gauge invariant weight functionals W $\left[1,2\right]$ that describe the probability of each con guration. W hen we integrate eq. (47) over $1:2$, we can exploit the hem iticity of the JIM W LK H am iltonians H $_{1,2}$ in order to integrate by parts, so that the H am iltonians are now acting on the distributions W $[1,2]$. By reproducing the argum ents developed in Paper

I for the single gluon spectrum, we obtain nally the factorization formula for inclusive two-gluon production,

W e now address the prim ary lim itation of the present calculation. As the previous discussion hints, it is valid w hen the m om enta p and q of the two observed gluons are close enough in rapidity so that they have sim ilar longitudinal com ponents. M ore precisely, we need to have

If this is the case, we can simply take M to be the common value¹⁵ of p;q. Physically, the condition of eq. (50) m eans that the probability of radiating a gluon between the two m easured gluons is sm all. W hen the rapidity separation between the two gluons is large such that eq. (50) is violated, we need to resum gluon em issions between the tagged gluons; this would require a generalization of the present form alism , w hich is not discussed here.

3.5 Factorization and the ridge in A A collisions

A striking \ridge" structure has been revealed in studies ofthe near side spectrum of correlated pairs of hadrons by the STAR collaboration [20{22]. The spectrum of correlated pairs on the near side of the detector (de ned by an accom panying unquenched jet spectrum) extends across the entire detector acceptance in pseudo-rapidity of order 2 units but is strongly collim ated for azim uthalangles . Prelim inary analysesofm easurem entsby the PH EN IX [23] and PH O BO S [24] collaborations appear to corroborate the STAR results. In the latter case, w ith a high m om entum trigger, the ridge is observed to span the w ider PH O BO S acceptance in pseudo-rapidity of 4 units.

In Ref. [19], it was argued that the ridge is form ed as a consequence of both long range rapidity correlations that are generic in hadronic and nuclear collisions at high energies, plus the radial ow of the hot partonic matter that

is speci c to high energy nuclear collisions. Let us rst focus on the long range correlations that are essential to this picture{how are they generated?

In the leading order form alism of the CGC, classical solutions of Y ang-M ills equations are boost invariant [26{29]. Real time num erical simulations [30{ 38] also demonstrate that the Yang-M ills elds form ux tubes of a typical transverse size $1=Q_s$ (where Q_s is the saturation scale) with parallel chrom of electric and chrom o{m agnetic eld strengths. (An important consequence is that these G lasm a elds [25] have non-trivial topological charge [39].) Now, in section 3.1, we showed that the leading order 2-gluon spectrum, for a xed con guration of sources, was given by eq. (26). Because each of the single particle distributions is boost invariant, the two particle spectrum is also, at this order, independent of the rapidity separation of the gluons. While the two gluons are uncorrelated for a xed con guration of sources, correlations are built in through the averaging over the source distributions. In Ref. [19], the source distribution was assum ed to be G aussian as in the M cLerran (Venugopalan (M V) m odel $[2\{4]$. The ridge spectrum was shown to have the simple form

There are several conceptual issues in this context. Firstly, how does one justify this averaging procedure for the 2-gluon spectrum from rst principles? Secondly, how does one build in energy evolution of the sources? And nally, do NLO contributions spoil this picture? Our results in this paper solve most of these conceptualissues. Our result, in eq. (48), show s that the trivial LO result of $eq. (26)$ can be promoted to a full Leading Log result simply by averaging it over the sources $_{1,2}$ (with distributions of sources that evolve according to the JMW LK equation. Most importantly, this shows that all higher order corrections, to leading logs in $x_{1,2}$, do not spoil the form in eq. (51) of the G lasm a ux tube picture and provides compelling evidence that it is a robust result beyond LO. A s discussed previously, this picture will have to be modied when the rapidity separation between the gluons is greater than $s^1(Q_s)$.

These initial state considerations are not a ected by the nalstate transverse ow of the G lasm a ux tubes which is the other important feature determining the near side ridge seen in heavy ion collisions. Its been shown very recently that a proper treatm ent of ow and hadronization e ects of the G lasm a ux tubes provides excellent quantitative agreem ent with the RHIC data on the dependence of the ridge am plitude on centrality and as a function of energy, as well as the angular width of the ridge as a function of centrality [40]. Further

sophisticated treatm ents of both the initial state e ects discussed here and the nal state e ects discussed in R ef. [40], therefore open the door to quantitative 3-D im aging ofheavy ion collisions.A deeper relation between initialand nal state e ects, as outlined in Paper I, can be obtained by studying quantum uctuations at NLO, that are not accompanied by logs in $x_{1:2}$, but grow rapidly in tim e $[41,42]$ in a m anner analogous to plasm a instabilities $[43]$.

W e should also m ention that the initial state e ects described here are also present in proton/deuteron-nucleus collisions [44{46], without the nal state e ects characteristic of the ridge in nucleus-nucleus collisions. These collisions are therefore useful in order to isolate the initial state e ects and to corroborate the fram ework of multiparticle production in high energy QCD developed here.

4 M ultigluon inclusive spectrum

In this section, we w ill show how the results of the previous section m odify m ulti-gluon probability distributions, w ith the caveat, as previously, that these gluons are em itted in a narrow rapidity w indow . W e w illalso derive a sim ple expression for the dierential probability of producing n gluons.

4.1 n-gluon spectrum at LO and N LO

O ur starting point in evaluating the inclusive n-gluon spectrum is eq. (8) . Because we have thus far obtained expressions up to NLO for the rst and second derivatives of $ln F$ [z], it is convenient to rew rite this expression as¹⁶

Because $\ln F$ [z] = 0 (g²) in our power counting, the LO term in the r.h.s. is oforderg 2n , the NLO term is oforderg $^{2(n-1)}$, and NNLO and higher term s represented by the ellipses are om itted at the level of the present discussion. The n-gluon spectra on the l.h.s. of eq. (53) are quantities that, for $n > 1$, are given by the rst term on the r.h.s. By computing them to NLO we gain access to the rst correction to the Poisson distribution, the deviation of the variance of the m ultiplicity distribution from the Poissonian result hN (N $1)$ i = hN \hat{f} and the corresponding m odi cations for the higher m om ents of the distribution. W e refer to the appendix C for a m ore detailed discussion of the interpretation of our result for the probability distribution of the gluon m ultiplicity.

Setting the argum ent of the generating functional to unity outside of the phase space region of interest m eans that we de ne observables that are completely inclusive with respect to this unobserved part of the phase space.

We see from eq. (9) that F [z (p)] can be obtained by multiplying eq. (59) by $(z (p_1) 1)$ $(p_1|2 \t 1)=n!$, integrating over the n-gluon phase space and sum m ing over n. Because z (p) is unity outside of the strip of width Y in rapidity, the n-gluon spectrum outside of the regime of validity of eq. (59) is not needed. This procedure leads to a simple exponentiation of the leading log factorized fom ula for the generating functional F_{y} , as

This leading log result for the generating functional, in turn, allow sus to extract the corresponding form ula for the di erential probability of producing exactly n gluons in the rapidity slice of interest. This gives

This simple result, valid, we emphasize, in the leading log approximation, suggests that the particle distribution in a sm all rapidity slice can be written as the average over $_{1:2}$ of a Poisson distribution with the leading bg corrections com pletely factorized into the JIM W LK evolution of the sources. Note that, despite appearances, $eq. (62)$ is not a Poisson distribution after the integration over the sources, because particles produced uncorrelated in each con quration of $_1$ and $_2$ are correlated in the averaged distribution because of the correlations am ong the color sources
 $^{\!\! 18}$.

 18 For instance, two color sources m ay be correlated because they result from the splitting of a common \ancestor" in the course of JMW LK evolution.

In general, even for a xed distribution of sources, the probability distribution is not Poissonian [17]. To som e extent, the fact that we get a Poissonian functional form in the integrand of eq. (62) is a consequence of the way we have organized our calculation. In eq. (53) we are perform ing a weak coupling expansion of the m om ents $hN(N - 1)$ $(N - n + 1)i$, that includes the orders g²ⁿ and the leading log part of the order g^{2(n 1)}. Term s starting at the order $g^{2(n-2)}$ are beyond the accuracy of our calculation, and therefore their value in our form ulas are arbitrary. The arbitrariness of these subleading term s in
uences the precise form of the resulting generating functional. For exam ple, if we had perform ed the weak coupling expansion of hNⁿ i instead of hN (N 1) (N $n + 1$)i, we would have obtained a dierent generating functional. O fcourse, the two generating functionals so obtained would lead to the sam e m om ents of the distribution to the order of our calculation. The nontrivial aspect of our result in eq. (62) is that all the deviations from a Poisson distribution that result from the large logarithm sofx at NLO can be factorized into the JIM W LK evolution of the sources. Equation (62) shows how these correctionsm odify the n gluon production probabilities.T he Poissonian nature of the multiplicity distribution and deviations from it are discussed in more detail in appendix C .

5 C onclusion and outlook

We dem onstrated in this paper that our result of Paper I on initial state JIM W LK factorization forthesingleinclusivegluon spectrum in nucleus-nucleus collisions can be extended to inclusive m ultigluon spectra. O ur result is valid provided all the gluons are produced in a rapidity window of width Y \cdot \cdot \cdot \cdot \cdot \cdot Our nal result for the generating functional for multigluon production, in the leading logarithm ic approximation in $x_{1:2}$, is very simple; the distribution of gluons produced in the stated rapidity w indow can be w ritten as the average over the JIM W LK -evolved distributions of sources of a Poisson distribution. It is im portant to keep in m ind that the result of this source average is not a Poisson distribution, due to the correlations between the evolved color sources.

A s we discussed in section 3.5, our results are of great interest in detailed im aging of the space{time evolution of nucleus{nucleus collisions. A n im portant ingredient in future studies w ill be to extend the present result to the case of correlations between gluons produced at rapidity dierences $\frac{1}{s}$. Y.A full leading log com putation of these initial long range rapidity correlations requires that one identi es and resum sthe additional large logarithm ic corrections that m ay arise when the rapidities in the two-gluon spectrum are widely separated.

An im portant caveat (also applicable to our previous study of the single gluon spectrum in nucleus-nucleus collisions) is that nal state e ects, related to the grow th of unstable uctuations, need to be resummed. While the details are still unknown, the structure of the result is known. The result of the

resum m ation of unstable uctuations, as shown in Paper I, can be expressed as

Here, we have traded the sources $\gamma_{1;2}$ in covariant gauge for the corresponding gauge elds $\mathcal{R}_{1,2}$ $\frac{1}{r^2}$ $\gamma_{1,2}$. The functional $\mathcal{B}[a(\alpha)]$ is the spectrum of small uctuations of the classical eld on the forward light-cone. In Paper I, 0 corresponded to the single inclusive spectrum but this formula also applies to the multigluon spectrum because the proof does not depend on the nature of the observable being measured. However, the complete functional form of $\mathcal{E}[a(\alpha)]$ is still unknown { for a rst attem pt, see Ref. [47].

These considerations are eased som ewhat if we take the \dilute{dense" lim it of proton/deuteron {nucleus collisions because we don't expect instabilities to play a m a pr role in that case. Several studies have been performed in this \lim it [44{46,48{50}. A particular focus is on the applicability of the so called AGK cutting rules [51{54]. We plan to address these issues in a future work.

However, in $[17]$, we did not m anage to solve these equations and suggested that one m ay have to solve them num erically. It turns out that one can in fact obtain an analytical solution of the $eqs.$ (39), thanks to the relations

C P oisson distribution

At rst sight, eq. (62) appears to be the average over the distributions of sources of a Poisson distribution. T his seem s to contradict a result we stressed in [17], that the distribution of multiplicities calculated in a xed con quration of sources $_{1,2}$ is not a Poisson distribution. For the sake of the discussion in this appendix, let us introduce the generating function $F(z)$ for the m ultiplicity distribution in the region of rapidity $[Y \t Y=2;Y \t Y=2]$. In the language of the present paper, it is obtained by using in eq. (61) a constant function $z(p)$ whose value is equal to the num ber z.

C onsider rst this generating function for a given con guration $_{1:2}$ of the external color sources. In [17], $F(z)$ was param eterized as¹⁹

In Ref. [17], we also showed that b_r is the sum of all the cut connected vacuum graphs, w here exactly r internal lines are cut. Because b_r is a sum of connected graphs, it has a perturbative expansion that starts at the order $1=q^2$,

Since for a generic eld theory, the b_r for $r = 2$ have no reason to vanish or to be sm aller than b_1 , the distribution of the multiplicities in a xed con guration of sources is in general not a Poisson distribution. M or ever, since $b_{2,3}$, are of the same order in g^2 as b_1 , the deviations from a Poisson distribution is an e ect of order unity, not a subleading correction.

In order to m ake the connection w ith the present paper easier, it is preferable to param eterize $F(z)$ as

At this order of truncation, one can obviously get a Poisson distribution, since this approximation is compatible with $c_2 = c_3 =$ = 0, i.e., ib₃ = 0. However, the coe cients $b_{2,3}$, could have any value of order g² without a ecting our Leading 0 rder truncation. The arbitrary choice one is allowed to m ake for these subleading term s in general alters the Poissonian nature of the distribution.

The actual paradox arises only at the Next to Leading Order. There, one keeps the term s

This does not correspond to a Poisson distribution anym ore, since one needs a non-zero b₂ in order to obtain these form ulas. In fact, at this order of truncation, one has $b_2 = c_2$ while the higher b_r's are still zero. Even worse, our calculation of the second derivative of $\ln F$ shows that c_2 is enhanced by a large logarithm, and is actually of order g² $\ln(1=x_{1,2})$ rather than the naive expectation g². Therefore, not only the distribution is not Poissonian, but the deviations from a Poisson distribution are logarithm ically large.

However, the main result of the present paper is that one can obtain the NLO corrections to the inclusive n-particle spectra by the action of a certain operator on the product of n 1-particle spectra at LO. In the present language, this reads

Rem ember that so far all the discussion is for a xed con quration of the sources 1.2 . Then, by averaging over these sources and by using the hem iticity of the operator $L_1 + L_2$, one can transfer the action of this operator from the quantity $[c_1]_0^n$ to the distribution of sources. As we have seen, this am ounts to letting the distribution of sources evolve according to the JIM W LK equation. In other words, eq. (85) deviates strongly from a Poisson distribution, but does so in such a way that all correlations can be interpreted as com ing from correlations am ong the sources that are generated by the JMW LK evolution.

Let us end this appendix with a word of caution in the interpretation of eq. (61). Strictly speaking, our Leading Log approximation gives us control only over the g² h(1=x_{1,2}) part of the coe cient b₂, but not over its g² part (without a log). The latter would only show up in a Next to Leading Log calculation. Thism eans that in principle one could modify the argum ent of the exponential in the integrand of eq. (61) by a term of second degree in $z(p)$ 1 and with a coe cient of order q², without a ecting any of our results for the inclusive gluon spectra at the order at which we calculate them. Obviously, such a modi cation of the integrand in eq. (61) would be a deviation from a Poisson distribution. Thus, the statem ent according to which the deviations from Poisson come from the JMWLK evolution of the distributions of the sources $_{1,2}$ is true only for the largest of these deviations {i.e. those that are enhanced by large logarithm s of the m om entum fractions x_1, y . O ther deviations from Poisson exist, that are not enhanced by such logarithm s{these are beyond the scope of the present calculation.
