Propagation of eld disturbances in the Y ang-M ills theory

The propagation of eld disturbances is exam ined in the context of the e ective Y ang-M ills Lagrangian, which is intended to be applied to QCD system s. It is shown that birefringence phenom ena can occur in such system s provided some restrictive conditions, as causality, are ful lled. Possible applications to phenom enology are addressed.

I. INTRODUCTION

Sm all disturbances on nonlinear elds propagate with velocity depending on the polarization states. In general there will be two polarization modes, leading to the existence of two waves propagating with di erent velocities. This phenom enon is known in the literature as birefringence. In the M axwell theory (i.e., A belian gauge eld) it can be found when light propagates inside certain m aterialm edia [1]. It can also appear in the context of nonlinear spin-one elds $[2, 3, 4]$, as it occurs in the quantum electrodynam ics (QED). The e ective Lagrangian for QED was derived long ago [5] for slow ly varying but arbitrary strong electrom agnetic elds. Its nonlinearities lead to e ects like birefringence and photon splitting [2]. Som e other investigations on this issue can be found in $[6, 7, 8, 9].$

For the case of non-A belian gauge theories, the quantum uctuations lead to a vaccum state which does not coincides with the vacuum coming from the perturbation theories. The structure of the vacuum state was discussed for severalm odels in [10, 11, 12, 13, 14, 15]. The one-loop e ective action for Yang-M ills theory was presented and discussed in, e.g., [10, 11]. For the asymptotically free theory in the regin e of largem ean elds the e ective action is controlled by perturbation theory. In this context the issue of event horizon form ation in the physical vacuum associated with color con nement was considered in [16].

Them athem atical form alism (see Section II for details) to dealw ith the propagation of sm all disturbances in nonlinear spin-one ebls [2, 4] depends on the Lagrangian as a general function of the eld invariant. Thus, it can be used to exam ine the wave propagation in system s govemed by an Yang-M ills e ective Lagrangian. Particularly, it is worthwhile to analyze if e ects like birefringence can occur in this context. Quantum Chromodynam ics (QCD) could be taken as a speci c application, since it presents strong nonlinear properties.

In this manuscript the one-parameter e ective Lagrangian presented in [11] is used as a 'working model' when discussing Yang-M ills elds. Due to the possibility of two polarization modes presenting di erent velocities, as derived from our theoretical fram ework, it is shown that the birefringence phenom ena can occur provided that causal conditions are fulled. In QCD case, we discuss how to observe the birefringence phenom ena associated with the propagation of sm all disturbances of the gluon eld. Though the gluon is not directly observable due to con nement, a bulk of decon ned hot (and/or dense) quark-gluon matter is expected to exist in the ultra-relativistic heavy ion interactions, as well as in the early phase of the universe [17]. In those cases when the gluon propagates in the quark gluon matter, it is argued that the birefringence of gluon eld leads to local polarization of gluons. The polarization correlation is suggested to be measured in Gold-Gold collision on Relativistic Heavy Ion Collider (RHIC) at Brookhaven National Laboratory and Lead-Lead collision on Large Hadron Collider (LHC) at CERN.

The paper is organized as follow s. In the Section II the light cone conditions associated with the propagation of sm alldisturbances in one-param eter spin-one theories are reviewed. In the Section III the e ective Lagrangian for Yang-Mills eld [11] is presented and the procedure of taking volum etric spatial average is de ned. Then it is discussed the non-trivial behavior of the phase velocity. The conditions on the causal propagation are stated and some lim iting cases from the e ective Lagrangian are exam ined. Sections IV and V are dedicated to the possible applications to phenom enology and the e ective geom etry issue, respectively. Finally, some nal remarks are presented in the conclusion section.

The present investigation is considered under the regin e of the eikonal approximation, as addressed in [4]. Latin indices run in the range $(1,2,3)$ and G reek indices run in the range $(0,1,2,3)$. The M inkow ski spacetime

is used, em ploying a C artesian coordinate system. The background m etric is denoted by \blacksquare , which is denoted by diag(+ $1, -1, -1, -1$). Heaviside non-rationalized units are used and $c = 1 = \sim$. The completely anti-symmetric tensor is dened such that $0123 = 1$.

II. LIG H T C O N E C O N D IT IO N S

A . F ield equations for one-param eter spin-one theories

The strength tensor eld $F^{(a)}$ and the gauge eld A $^{(a)}$ are related by

where C $^{\rm abc}$ represent the structure constant for a com – pact Lie group G. This tensor eld can be conveniently de ned in term s of the (non-A belian) electric E $^{\rm (a)}$ and m agnetic H $^{(a)}$ elds as

w here V represents the four-velocity of an observer at rest w ith respect to the laboratory. In C artesian coordinates it is given by V $\,$ = $\,$ 0 . In order to alleviate the notation, the 'color' indices in the upper brackets w ill be om itted in what follow s.

Let us assum e the gauge invariant density of Lagrangian as a general function of the Lorentz invariant $F = F$ as $L = L(F)$. From the m inim al action principle we getthe equation ofm otion

Let us now derive the expression for the light cone conditions for this class of theories.

B . T he propagation of the eld disturbances

In this section we analyze the propagation of waves as-sociated with the discontinuities of the eld [\[18](#page-5-15)]. Let us consider a surface of discontinuity de ned by $Z(x) =$ $0.$ W henever is a global surface, it divides the space- $\tan \theta$ in two distinct regions U and U⁺ (Z < 0 and

 $Z > 0$, respectively). G iven an arbitrary function of the coordinates, $f(x)$, we de ne its discontinuity on as

For the case w here f is the wave propagation tensor given by equation [\(7b\)](#page-1-3), for which equation [\(9\)](#page-1-4) applies, it follow sthat

where is the strength of the wavelet and represents the polarization vector. W orking with Eqs. $(8)-(10)$ $(8)-(10)$ we obtain the eigenvalue equation

with $k^2 = k \, k \,$. The eigenvectors of Z represent the dynam ically allowed polarization modes $(e_+;e_-)$. The general solution for the eigenvalue equation is form ally given by det $\ddot{\mathcal{L}}$ j= 0, and results in the follow ing light cone conditions [\[2](#page-4-1)[,4](#page-5-1)[,19](#page-5-16)]:

The signs are related w ith the two possible polarization m odesassociated w ith the wavepropagation [\[2](#page-4-1)].T he existence of these two solutions show s that birefringence e ects m ay appear, provided that $L_{FF} = L_F 60$. In the form alism of geom etrical optics it is usually said that generally there will be two rays inside the medium, the ordinary ray (o-ray) and the extraordinary ray (e-ray). T he form er does not depend on the direction of wave propagation and its velocity is equal to the light velocity in the classical vacuum of electrodynam ics. The latter presents an explicit dependence on the direction of propagation. T he light cone conditions for two-param eters Lagrangians can be obtained in the sam e lines. For further details see R efs. $[2, 4]$.

III. WAVE PROPAGATION IN THE YANG - MILS FIELD

A. The e ective Lagrangian

The e ective Lagrangian for QCD in term s of the param eter background e^{lt} F can be presented $[11]$ in the form

where the e ective coupling $q(t)$ is in plicitly given by

with (q) the Callan-Sym anzik -function and q the gauge eld coupling constant appearing in the basic QCD Lagrangian.

In fact, there are m any invariants of the Yang-M ills eld with the number dependent on the specic gauge group [20]. The ansatz used to derive this e ective Lagrangian takes in consideration only the algebraic invariant F and imposes consistency with the trace anomaly for the energy-m om entum tensor [21].

For the present proposes the system described by Eq. (15) is assum ed to satisfy the follow ing requirem ents:

- 1. the volum etric spatial average of the color eld strength is independent of direction;
- 2. it is equally probable that the products E^iE^j and HⁱH^j (with i θ j), at any time, take positive or negative values;
- 3. there is no net ow of energy as measured by a observer at rest with respect to the system.

The abovem entioned volum etric spatial average of an arbitrary quantity X for a given instant of time t is dened AS $\overline{7}$

with $V = {R p \over q d^3 x^i}$, and V_o stands for the time dependent volum e of the whole space. Sim ilar average procedure has been a lready considered in the context of general relativity solutions [22, 23, 24].

In term s of the color elds, these requirem ents im ply that:

where we have dened $E^2 = E^i E_i$ and $H^2 =$ H^iH_i . The above average procedure consists in an idealization

to deal with systems like a quark-gluon plasma. Nevertheless, it has adequate elements for our discussions. From the point of view of a statistical ensemble, we can assume that the eld average over the whole bulk is vanishing comparing to the uctuation, so it is isotropic as whole, while anisotropic for each local area.

B. Application to the e ective Y ang-M ills Lagrangian

For the special Lagrangian presented in Eq. (15) , the factor in Eq. (13) is given by

The phase velocity for the wave perturbation can be obtained from the dispersion relation as $v_a^2 = 1 = \tilde{\kappa} j$, where the index e stands for the e-ray. The o-ray propagates with the light velocity, as determined by Eq. (14). Now using the previous results, we obtain

In order to guarantee causality, the physical solutions m ust satisfy the requirem ent $0 \t v_e = 1$, which implies that:

From the analysis of the energy density for the e ective action associated with this problem, it can be inferred that the case $E^2 > H^2$ leads to a m etastability of the vaccum. The interpretation for this behavior is that if a region in the system develops a large E eld, it will decay fastly to a con quration where H 2 > E 2 [11]. Therefore it is adopted here that $H^2 > E^2$ (which means $Z^2 > 1$ and $F > 0$) and the condition stated by Eq. (25) yields

Now we are going to exam ine two cases in which the explicit form of the e ective coupling was presented in the literature. The rst one is obtained when the regine of sm all coupling is taken in consideration, and the second one was previously proposed in [25] as a suggestion for the case of large coupling constant.

For the case of sm all coupling the beta function can be expanded as [\[25,](#page-5-22)[26](#page-5-23)[,27](#page-5-24)[,28\]](#page-5-25)

where b_0 and b_1 are constants. Now, taking the lim it of largemean elds $(F \mid 1)$ we obtain from Eq. [\(16\)](#page-2-2) that

Since $t > 1$ at the large mean eld regime we conclude that G (g) < 0, and there w ill be no propagation associated w ith the e-ray. T he o-ray travels w ith the unperturbed velocity $v = 1$ and does not depend on the direction of propagation.

The non-perturbative expression for the beta function is stillunknow n. N evertheless, a suggestion about the strong coupling form of the beta function was presented long ago [\[25\]](#page-5-22), and is given by

w ith a a positive constant. If we assume this form for the beta function, we obtain from Eqs. (16) and (31) :

Thus since $a > 0$ we conclude that $G(g) < 0$, and again there w illbe no propagation associated w ith the e-ray. In the both cases, once the superlum inalpropagation is suppressed, the m edium allow s just one polarization m ode to propagate. So it seem s to behave like a polarizer.

IV . OBSERVABLE FOR BIREFRINGENCE

7) As shown in the previous section, birefringence e ects can occur in the Yang-M ills elds. N evertheless, due to con nem ent phenom enon, a direct measurem ent of these e ects on gluons propagating in an external color e k seem s to be im probable. However, decon ned quarkgluon m atter,also know n asquark-gluon plasm a (Q G P), is expected to be produced in the G old-G old interaction atR H IC orLead-Lead interaction atLH C .T hisprovides an opportunity to investigate the issue ofgluon propagation in Q G P system s.

The dierent velocities in which the eld disturbances can propagate are associated w ith di erent polarization m odes. It can be sim ply understood as a quantum m easurem ent on the gluon, by which the gluon fall onto the eigenstate of the polarization m ode. In the special cases w here the e-ray gluon is forbidden by causality, the external eld works like a polarizer, and only the o-ray gluon is allowed there. T he polarization is assigned by the extemal eld. W hen one gluon propagates in a QGP , it is m easured' t im e and t im e by the local eld. H ence, the last polarization direction before its hadronization into hadrons is completely out of control. This will also destroy any globalpolarization inform ation [\[35](#page-5-27)]. H owever, due to the com plete polarization at any localarea, the polarization correlation w illbe very strong.A crucialpoint ishow to identify two particles at the same localarea with the sam e polarization. In order to explore this point let us consider, for sim plicity, a 'gluon plasm a'. W hen the hard parton propagates in the m edium , it works as a source of sm all disturbances on the external eld, and could lead to the em ission ofC herenkov radiation. T he o-gluon can exist w ithin the C herenkov cone, but the egluon must be outside. If the gluon is not conned it can be m easured that the polarizations for two gluons inside the cone are parallel. M ore specically γ_1 $\gamma = 1$. The experim entalresultsdepend notonly on the polarization transfer from the gluon to a certain kind of hadron in hadronization process, but also on the identi cation of the C herenkov cone. So, one suggestion is to m easure the polarization correlation of two particles of the same kind (2 vectorm esons, 2 hyperons, etc.) with alm ost parallelm om enta and within the same jet cone (when the \pm can be identi ed, as expected in LHC). By studying the correlation dependent on the jet cone angle, one m ay have a way to m easure the C herenkov angle.

O ne experim entalobservable for the polarization correlation can be suggested. T his can be extracted from the idealcase of two particles with the same polarization P, w ith P = \ddot{P} j representing the polarization rate. The conventional way to m easure $P~$ of a single is by m easuring the direction vector (denoted as \hat{p}) of the m om enta of the daughter particles, e.g., proton or pion from the $decay$, at the rest frame of. Then the angular

distribution,

can give the information on the polarization. Here is the hyperon decay parameter. From this equation we see that if the direction of \tilde{P} is random, the average of all 0 s gives zero, then P is not able to be measured. However, for the two $\,^0$ s with the same polarization, in the rest fram e of each , respectively, the direction vectors \hat{p}_1 and p_2 can be m easured. Then we calculate the expectation value < \hat{p}_1 \hat{p} > , which results in

Because < \hat{p}_1 \hat{p} > is a SO (3) scalar, it does not depend on the direction of polarization. Thus, it can be averaged for all the $jets$ of all the (QGP) events in order to get the scalar value of averaged polarization from Eq (37). In an experiment, the pair of the same ist [36] are expected to have the sam e polarization with larger probability, as discussed above.

V. THE EFFECTIVE GEOMETRY ISSUE

The e ective theory approach has long been considered as a possible way to understand con nem ent phenom ena. O ne of the possible ways to investigate these phenom ena consists in the construction of analogue models in which con nement would be related with an event horizon formation, as it occurs in the black hole physics. Such a interpretation was considered in [16, 30] (see also the references therein).

The results discussed in this paper can be read in the context of the optical geometry. In this context some comments are in order. Eqs. (13){(14) can be presented in the appealing form

The inverse symmetric tensor q is de ned in such way that $g =$. Therefore, for each propagation vector k, the corresponding tensor g plays the role of an e ectivem etric tensor. Indeed, k is a light-like (or null) vector with respect to the associated metric tensor. It

can be shown [34] that it also satis es a geodesic equation in term s of the Christo el symbols associated with this metric. In this way we can refer to k as a geodesic null vector with respect to the e ective metric tensor q . This geometric interpretation could be used in order to produce an analogue model for con nement based on the possible form ation of an event horizon. In this case, the requirem ent of causal propagation would assum e a nontrivial role. Inside the hadron, where quark and gluons can interact and propagate, the velocity of the eld disturbances would be expected to be sm aller than 1. On the other hand, if the vacuum outside the hadron is described by the e ective Lagrangian, the larger than 1 velocity could be interpreted as an indication of connem ent, since no physical observable could propagate there.

VI. CONCLUSIONS

In this paper the propagation of eld disturbances was investigated in the context of the e ective Yang-M ills Lagrangian. The general dispersion relations for oneparam eter Lagrangians, Eqs. (13) and (14), were derived em ploying the method presented in $[2, 4]$. It was shown that birefringence phenom ena can occur.

Let us rem ark som e points. First, it should be stressed that the method depends on the e ective Lagrangian as L (F), so the conclusions are quite general. Second, the assum ption of causal propagation of the signals sets nontrivial constraint when exploring speci c solutions. Finally, for the case of a decon ned quark gluon system, which naturally provides an e ective external eld, the birefringence phenomena with gluons and its local polarization e ects are expected to be observed at RHIC and LHC by measuring the strong local spin correlations of various hadrons from QGP. The measurements of the spin correlations suggested here, at the same time, can be useful in assigning the details of the e ective elds in QGP. These informations provide opportunities to develop the e ective Lagrangian fram ework and hence the better understanding of QCD.
