# The glasm a initial state and JIM W LK factorization

#### A bstract

W e review recent work on understanding the next to leading order corrections to the classical eds that dom inate the initial stages of a heavy ion collision. W e have recently shown that the leading ln 1=x divergences of these corrections to gluon multiplicities can be factorized into the JIM W LK evolution of the color charge density distributions.

## 1. Introduction: G lass and G lasm a

At large energies (sm all x) the hadron or nucleus wavefunction is characterized by a saturation scale  $Q_s$  arising from the strong nonlinear interactions of the color eld. In the Color G lass C ondensate (CGC) (for reviews see [1,2]) fram ework the sm all x part of the hadron wavefunction is described in terms of a classical W eizsacker-W illiams (WW) eld radiated by the hard, large x, sources. The color sources are stochastic variables uctuating according to a probability distribution W  $_y$ [(x  $_2$ )], where y is the rapidity scale separating fast and slow partons [3].

The matter during the rst fraction of a ferm i in a collision of two such objects is what we refer to as the G lasm a [4]. The glasm a conguration after the collision, at times  $0 1=Q_s$ , consists of longitudinal chromom agnetic and electric eld which depend on the transverse coordinate on a typical scale  $1=Q_s$ . As the system expands the elds are diluted and can be treated as particles, forming the leading order (LO) production is the contribution that is computed in the num erically solving the classical Yang-M ills equations [5,6,7].

In the following we are concerned with the next to leading order (NLO) in  $g_{,} \sim or$ , equivalently, loop corrections to this classical eld. At NLO one can produce pairs of quarks (see R efs. [8,9,10]) or gluons (real corrections) and one must take into account one loop corrections to the classical eld (virtual corrections). We shall argue that these corrections have logarithm ically divergent contributions, which must then be resum m ed into the renorm alization group evolution of the sources W [ (x<sub>2</sub>)][11,12].

#### 2. Factorization theorem

It is perhaps useful to look rst at the weak eld lim it of the CGC, where particle production can be computed using  $k_T$ -factorization ([13], see e.g. [14] for an application to heavy ion collisions). The leading order multiplicity is

For the real part of the Leading Log correction to this result one must take the corresponding expression for double inclusive gluon production

and integrate it over the phase space of the second gluon (q<sub>2</sub>; y<sub>q</sub>). Note that at leading log accuracy we have here taken the multiRegge kinematical limit, assuming that the two produced gluons are far apart in rapidity (see e.g. [15]). The integral over y<sub>q</sub> diverges linearly (this is the general behavior of the gg ! gg scattering am plitude in the high energy limit t xed, s u ! 1). This divergence is compensated (to the appropriate order in  $_{s}$ ) by the real part of the BFK L evolution equation for ' y (k<sub>2</sub> 1).

In the fully nonlinear case of AA collisions the  $k_T$  -factorization is broken (see e.g. [5,16]), and one must solve the equations of motion to all orders in the strong classical eld. The analogue of the unintegrated parton distributions  $\prime_{\rm y}$  (k  $_{
m 2}$  ) is the color charge density distribution W  $_{\rm v}$  [ ]. These are sim ilar in the sense that they are not (com plex) wavefunctions but (at least loosely speaking) real probability distributions. Factorization can be understood as a statem ent that one has found a convenient set of degrees of freedom in which one can compute physical observable from only the diagonal elements of the density matrix of the incoming nuclei. The di erence is that when in the dilute case these degrees of freedom are num bers of gluons with a given momentum, in the nonlinear case the appropriate variable is the color charge density and the relevant evolution equation is JIM W LK, not BFKL. The kinem atical situation, however, remains the same. To produce a gluon at a very large rapidity (or a contribution in the bop integral of the virtual vergent.

contribution with a large  $k^+$ ) one must get a large + -m om entum from the right-m oving source. Thus one is probing the source at a large  $k^+$ , i.e. sm all distances in x, and the result must involve W $_y$ [] at a larger rapidity. The underlying physical interpretation of factorization is that this uctuation with a large  $k^+$  requires such a long interval in  $x^+$  to radiated that it must be produced well before and independently of the interaction with the other (left moving and thus localized in  $x^+$ ) source. The concrete task is then to show that when one computes the NLO corrections to a given observable in the G lasm a, all the leading logarithm ic divergences can be absorbed into the RG evolution of the sources with the same H am iltonian that was derived by considering only the D IS process. This is the proof [11,12,17] of factorization that we will brie y describe in the follow ing.

#### 3. Deriving JIM W LK factorization

Consider the single inclusive gluon multiplicity which is a sum of probabilities to produce n + 1 particles, with the phase space of the additional n must be integrated out

Because we have a theory with external color sources of order 1=g; all insertions of source appear at the same order [18]. A calculation using the Schwinger-K eldysh form alism leads to the following results: At LO, the multiplicity is obtained from the retarded solution of classical eld equations (here (:::) includes the appropriate normalization and projection to physical polarizations)

The NLO contribution includes the one loop correction to the classical eld and the + component of the Schwinger-Keldysh (SK) propagator in the background eld

Because of the SK index structure (also satis es an equation of motion with a retarded boundary condition), one can express the propagation of a sm all uctuation a (x) above the past light cone as a functional derivative  $T_u$  of the LO classical eld A (x) with respect to its initial condition on : a (x) =  $u_2$  a(u) TA (x): This leads after some rearrangements to the expression for the NLO contribution to the multiplicity as a functional derivative operator acting on the leading order result:

Here the two point function below the light cone G (u;v)  $\frac{d^3k}{(2)^{3}2E_k}a_k(u)a_{+k}(v)$  is bilinear in the small uctuation edd a (x) satisfying the small uctuation equation of motion with and initial condition given by a plane wave  $\lim_{x^0!}a_k(x) = (k)e^{-ik}x^{*}$ ; see Fig. 2 for a pictorial representation of this structure.

The leading logarithm is contribution comes from the longitudinal component of the integral over k, the momentum of the initial plane wave perturbation (and the corresponding momentum in the one loop source term for the equation of motion satis ed by

). This LLog part of the functional derivative (6) operator turns out to be precisely equivalent to the sum of the JMW LK Ham iltonians describing the RG evolution of the source distributions W  $_{\rm y}$ []. The fact that no other terms with the same logarithm ic divergences appear is the crucial result for factorization. The JMW LK Ham iltonian

is most naturally expressed in terms of Lie derivatives  $D_{a} \frac{f_{x}}{K}$ , operating on the W ilson lines form ed from the classical eld (U (x<sub>2</sub>) = P exp ig dx 1=r<sup>2</sup><sub>2</sub> (x<sub>2</sub>;x) for the nucleus moving in the +z direction) in terms of which the kernel in Eq. (7) is

Let us conclude by sum marizing some important aspects of the JIM W LK factorization theorem of Refs. [11,12]. We are interested in the high energy kinematical limit, with transverse momenta  $Q_s$  and the energy s large; the dilute limit is that of BFKL physics. The relevant degrees of freedom in this fram ework are the color charge densities

of the fast partons and the classical elds of the smallx ones. The color charges 1=g are param etrically large, and thus the problem is inherently nonperturbative, but there is, how ever, a consistent weak coupling or loop expansion. The primary observables of interest are inclusive single and multiplicities (not cross sections for producing a xed num ber of particles), which leads to results that can be expressed in terms of retarded (and advanced) propagators. We express these propagators as functional derivatives with respect to the eld on an initial surface on the light cone, which can then be m apped to the functional derivatives of the color elds of the individual nuclei appearing in the JIM W LK Ham iltonian.
