The electric quadrupole m om ent and the m agnetic m om ent of the $^{11}{\rm Li}$ halo nucleus have been m easured with m ore than an order ofm agnitude higher precision than before, ${\rm D}$ j= 33:3(5) m b and = 3:6712(3) $_{\rm N}$, revealing a 8.8(1.5)% increase of the quadrupole m om ent relative to that of $^9{\rm Li}$. This result is compared to various models that aim at describing the halo properties. In the shell m odel an increased quadrupole m om ent points to a signi cant occupation of the 1d orbits, w hereas in a sim ple halo picture this can be explained by relating the quadrupole m om ents of the proton distribution to the charge radii. A dvanced m odels so far fail to reproduce sim ultaneously the trends observed in the radii and quadrupole m om ents of the lithium isotopes.

Since nuclear physicists could produce and investigate bound systems of nucleons in many possible combinations, a wealth of isotopes with unexpected properties have been discovered. For example, som e neutron-rich isotopes of light elements, such as ¹¹Li, were found to have exceptionally large radii [1]. Upon discovery in 1985, this phenom enon was attributed to either large deform ation or to a long tail in the matter distribution [2]. Deform ation was soon excluded by the spin and magnetic m om ent of ¹¹Libelonging to a spherical $p_{3=2}$ state [3]. Considering the weak binding of the last two neutrons [4], one could conclude that such a nuclear system consists of a core with two loosely bound neutrons around it [5]. This is the concept of 'halo' nuclei which has been related to similar phenomena in atomic and molecular physics [6], showing the universality of the concept. To fully unravel the mechanisms leading to the existence of halo nuclei, m any types of experim ents have been devoted to the investigation of their properties. An observable that gives inform ation on the nuclear charge deform ation is the spectroscopic quadrupole m om ent. By com paring the quadrupole m om ent of ¹¹Lito that of ⁹Li, one can investigate how the two halo neutrons modify the deform ation of the core which contains the three protons. A lready fleen years ago, a rst attempt to do so giving Q (¹¹Li)=Q (⁹Li) = 1:14(16), suggested just a slight increase in agreem ent with the halo concept [7]. Unbiasedly, for a nucleus with a neutron m agic num ber of N = 8one would expect a minimum value of the quadrupole such as for ¹³B [8]. If ¹¹Lihas a larger quadrupole moment than ⁹Li, it can not be considered as sem i-m agic, and the two halo neutrons have to be responsible for an expansion or polarization of the proton distribution in the core. The latter, in term s of the shellm odel, m ust be understood by an excitation of halo neutrons to the 1d orbits, and a precise value of the ¹¹Liquadrupolem om ent

m ay provide evidence for this. The e ect of a more extended charge distribution can be estim ated on the basis of a recent laser spectroscopy m easurem ent of the charge radius [9]. The increase of the charge radius for ¹¹Li, as well as other properties of Li isotopes are well described by cluster models [10, 11] which also explain the large quadrupole mom ent of ⁷Li [12]. For ¹¹Li they predict a quadrupole mom ent over 30% larger than that of ⁹Li. Again, this calls for a more precise m easurem ent.

In this Letter, we report the measurement of the quadrupole moment of ¹¹Li relative to that of ⁹Li, intended to resolve a di erence at the percent level. Improvements over the rst study were made to gain an order of magnitude in precision. These concern the experimental method which is based on the nuclear magnetic resonance (NMR) technique. Spin-polarized beams of -decaying isotopes are implanted into a crystal with a non-cubic lattice structure placed between the poles of an electrom agnet. Due to the electric eld gradient V_{zz} in such a crystal, in combination with the static magnetic

eld B, the Zeem an levels of the nuclear spin are shifted by the m_I-dependent quadrupole interaction which is proportional to the interaction constant $_Q = eQ V_{zz} = h$ (as illustrated e.g. in [13] for ⁹L i) and thus to the nuclear quadrupolem om ent Q. The frequency $_{rf}$ of an additionally applied radio-frequency (rf) m agnetic eld is scanned over the resonances between ad jacentm $_{I}$ quantum states. Whenever $_{rf}$ m atches one of the transition frequencies, a reduction of the spin polarization shows up as a drop in the -decay asymmetry [14]. The resonances are equidistant and symmetric with respect to the Larm or frequency $_{L}$, with the spacing given by $_{r} = 6_{Q} = [4I(2I \ 1)].$

The resonance amplitude is enhanced by more than an order of magnitude by applying all resonance frequencies simultaneously, thus mixing all m_I states [7]. For nuclei with spin I = 3=2, such as ⁹Li and ¹¹Li, this in-

volves the three correlated frequencies $_{\rm L}$, $_{\rm L}$ + and $_{\rm L}$. A spectrum is then measured as a function of the parameter , with the resonance value $_{\rm r}$ determ ining the quadrupole interaction frequency $_{\rm Q}$. The signal enhancement and the width, thus also the error on $_{\rm Q}$, depend on the su ciently precise knowledge of the Larmor frequency, measured in a crystal with cubic lattice structure.

In the previous study of A mold et al. [7] the resonance width, mainly determined by variations of the electric

ekł gradient over the implantation sites in the LiNbO₃ crystal, was of the same order as the splitting $_{\rm r}$ itself. Now, we have reduced this width by an order of magnitude to less than 2 kHz [13], by using a metallic Zn crystal. This also means that less rf power is needed to saturate the resonances. The known magnetic moment (11 Li) = 3.6673(25) $_{\rm N}$ [3] corresponds to an uncertainty of 3.5 kHz on the Larm or frequency of about 5 M Hz, but an accuracy much better than the expected line width is needed for a multiple-rf resonance measurement. This is achieved by implanting into a Si crystal [13] where the NMR line width is an order of magnitude smaller than in Au [15] or LiF [3].

The experiments have been performed at ISOLDE/CERN.Beams of ⁹Li and ¹¹Liwere produced by a 1.4 GeV proton beam (3 10¹³ protons per pulse every 2.4 s) on a thin-foilTa [16] or a conventionalUC₂ target. With the short release times of both targets typical production rates of a few 1000 ions/pulse were realized for the short-lived ¹¹Li (T₁₌₂ = 85(2) m s). The experimental setup and the method of optically polarizing Li beams have been described in detail in Borrem ans et al. [13], where we report results from our studies on the resonance properties in di erent crystals for the less exotic isotopes⁸Li and ⁹Li.

The results include the magnetic moment $(^{9}Li) =$ 3:43678(6) N which was measured relative to that of ⁸Li. Now we present a similarly accurate m easurement for ¹¹Li relative to ⁹Li. Typical NMR resonances of both isotopes in planted in a Sicrystal at room tem perature are shown in Fig.1. Seven spectra on ⁹Li and three spectra on ¹¹Liwere recorded in total, while the magnetic eld of about 0.29 T was kept constant. During the measurements, the magnetic eld drifted by 0.005% at most, which is consistent with the scatter of the ⁹Li resonance frequencies and gives an upper lim it. for a systematic di erence between the elds applied for both isotopes. The weighted means of the Larm or frequencies yield $g({}^{9}Li)=g({}^{11}Li) = 0.93615(6)$ and with the q factor of ${}^{9}\text{Li}[13]$ we have $q({}^{11}\text{Li}) = 2:44746(17)$. W ith the spin I = 3=2 this gives the magnetic moment $(^{11}Li) = 3.6712(3)$ _N, improved by an order of magnitude and m eeting the requirem ent for a precise m easurem ent of the quadrupole m om ent.

The quadrupole m om ents of ⁸Liand ⁹Lihave been reported from m easurem ents in several di erent crystals

(see [13]). A lthough some of the values seem to be in poor agreem ent with one another, we found that for ⁸Li they become consistent [13], if they are evaluated with respect to the same reference value Q (⁷Li) = 40.0(3) mb. From this we adopted a weighted mean value of Q (⁸Li) = 31.4(2) mb. For ⁹Li, in order to remove a discrepancy between two earlier measurements, we remeasured the quadrupolem om ent relative to that of ⁸Li. Two im plantation hosts, a metallic Zn crystal (hep structure) and a LiTaO₃ crystal (orthorhom bic structure) gave consistent results, leading to Q (⁹Li) = 30.6(2) mb [13].

W ith this precise value, and by measuring the quadrupole frequency of ¹¹Li relative to that of ⁹Li, we can now determ ine the ¹¹Liquadrupole moment to a sim ilar precision. Three independent experim ental runs were performed, during which the quadrupole splitting r was measured successively for ⁹Li and ¹¹Li im planted in the Zn crystal. Typical multiple-rf resonances are shown in Fig.2. Each run started by measuring the Larm or frequency of ⁹Li in Zn, which was then used to calculate the Larm or frequency of ¹¹Li from the qfactor ratio given above. These two values de ne the center frequencies of the multiple-rf scans. The resonance values r for ⁹Li and ¹¹Li directly give the ratio of the quadrupole m om ents. R esults from the three runs are presented in Fig.3, with the weighted mean of \mathcal{Q} (¹¹Li)=Q (⁹Li)j= 1:088(15). Thus the quadrupole m oment of the halo nucleus, $\mathcal{D}(^{11}\text{Li})j = 33:3(5) \text{ mb, with}$ a negative sign from theoretical considerations, is nearly 10% larger than that of bare ⁹Li.

In Table I we sum m arize the experim ental quadrupole and m agnetic m om ents of the Li isotopes, which are now all known to about 1% or better, thus allowing tests of

various nuclear m odels (Fig.4). In the shell m odel it is known that some magic numbers which are valid near stability, disappear in nuclei with extrem e isospin due to the changing strength of the spin-isospin dependent term in the residual nucleon-nucleon (N N) interaction [17]. In light neutron-rich nuclei this leads to the disappearance of the N = 8 m agic num ber when protons are taken out of the $p_{3=2}$ orbital. A rst experimental proof for this was found in the positive parity of the $^{11}{\rm Be}\,{\rm ground}$ state, shown to be dom instead by $2s_{1=2}$ [18, 19] and not $1p_{1=2}$ as expected for 7 neutrons. In ¹¹Li this is manifest in the halo structure which has about 45% of $(2s_{1=2})^2$ occupancy [20]. It is also re ected in the quadrupole m om ents, but the increase from ⁹Lito ¹¹Lican not be understood by an excitation of neutrons to the spherical 2s orbit only. Comparing our result to large-scale shellm odel calculations m ay provide a clue for som e 1d

occupancy of the halo neutrons. Suzuki et al. m odi ed an e ective shell-m odel interaction in order to describe both stable and exotic nuclei in this p-sd region assum – ing ⁴H e as an inert core [21]. The calculated quadrupole m om ent of ¹¹Li relative to that of ⁹Li approaches the experimental value if the m odel space is extended from the p shell only (Q_p = 28.2 mb) to include excitations into the sd shell (Q_{psd} = 32.5 mb), and e ective charges $e_p = 1.2e$ and $e_n = 0.3e$ are used [22]. The halo wave function then has 50% of $(2s_{1=2})^2$, 25% of $(1p_{1=2})^2$ and 25% of $(1d_{5=2})^2$ occupation probability. A dvanced Q uantum M onte C arlo calculations, including additionally a three-nucleon potential [23], have been successful in describing the m om ents of ^{7,8,9}Li [24], but so far no results are available for ¹¹Li.

M ore sophisticated m odels abandon the assumption of an inert core: all nucleons are active in the no-core shell m odel (NCSM). Navratil et al. have performed such calculations, using an elective interaction derived m icroscopically from a NN potential tted to NN scattering data [25], and they ind good agreement with the ground state properties of A = 7-11 nuclei. The model does not explain the charge radii, but it perfectly reproduces the trend of experimental quadrupolem on ents of the Li isotopes. Only an overall scaling factor is m issing, which is

explained by a limited model space and might be com - pensated by using e ective charges.

An alternative approach is to consider the Li nuclei made of and triton clusters plus additional neutrons. In them icroscopic clusterm odelby Varga et al. [12], various cluster arrangem ents are com bined to include all possible correlations between the clusters. In this approach, the quadrupole mom ents are underestim ated, except the one of 11 Li which is about 30% larger than that of 9 Li [10]. This is surprising, because the model happened to reproduce best the developm ent of the charge radii [9].

The microscopic antisymm etrized molecular dynamics (AMD) approach [26] has been rather successful in describing many features of light nuclei including their electrom agnetic moments. For the quadrupole moments it predicts an 8% increase from 9 Li to 11 Li, very close to the experimental value. How ever, this agreement should not be overrated as long as halo properties, in particular the large matter radius of 11 Li, are not reproduced.

Finally, it is not clear to what extent the dimension of the proton distribution introduced by the two halo neutrons. Therefore we try to describe the observations assuming the very simple picture of a ⁹Licore surrounded by two halo neutrons known to be in spherical orbits. From experiment [9] we know that the rm s charge radius $hr^2 i^{1=2}$ increases by 11(2)%, from 2.185(33) fm for ⁹Lito 2.423(34) fm for ¹¹Li according to the most recent evaluation [27], while we nd that the quadrupole moment increases by 8.8(1.5)%.

If the deform ation of the charge distribution would be the same for ⁹Liand ¹¹Li, one should expect an increase of the quadrupole moment proportional to the mean square radius hr²i. How ever, if we ascribe the increase of the radius to a recoile ect caused by the spherical halo, the center-of-m assm ovem entproduces a spherical expansion of the (non-spherical) charge distribution for which the quadrupole moment increases only with the square root hr²i¹⁼². This can explain the striking analogy between the quadrupole m om ents and the rm s charge radii without any additional change of the ⁹Li-core structure caused by the presence of the halo neutrons. In particular, the ¹¹Liquadrupole m om ent seems to be una ected by quadrupole core polarization involving a substantial 1d component in the halo wave function. We note that this intuitive relationship between the ¹¹Li guadrupole m om ent and charge radius is independent of correlations in the movem ent of the halo neutrons, although these a ect strongly the behavior of both quantities.

In conclusion, we have measured the quadrupole moment of the ¹¹Li halo nucleus relative to that of its ⁹Li core, with a precision in proved by an order of magnitude, thus providing a test of m odern nuclear theories. W hile these theories have di culties to reproduce simultaneously the charge radii and quadrupole m om ents of both isotopes, we found a relationship between both quantities in a simple halo picture that is surprisingly wellful led.
