Energy dependence of transverse momentum uctuations in Pb+Pb collisions at the CERN Super Proton Synchrotron (SPS) at 20A to 158A GeV

A bstract

Results are presented on event-by-event uctuations of transversem on entappin centralPb+Pb interactions at 20A, 30A, 40A, 80A, and 158A GeV. The analysis was performed for charged particles at forward center-of-mass rapidity (1:1 < y < 2:6). Three uctuation measures were studied: the distribution of average transverse momentum -M (p_T) - in the event, the p_T uctuation measure and two-particle transversem on entum correlations. Fluctuations of p_T are smalland show no signi - cantenergy dependence in the energy range of the CERN SuperProton Synchrotron. Results are compared with QCD -inspired predictions for the critical point, and with the UrQMD model. Transversem on entum uctuations, similar to multiplicity uctuations, do not show the increase expected for freeze-out near the critical point of QCD.

1 Introduction and M otivation

For m ore than 30 years, experiments studying relativistic nucleus-nucleus (A + A) collisions have been carried out in laboratories in Europe and the United States. The main motivation has been to test the hypothesis that strongly interacting matter at energy densities exceeding about $1 \text{ GeV}/\text{fm}^3$ exists in the form of decon ned quarks and gluons, eventually forming the quark-gluon plasma (QGP) [1]. Recent results from the CERN Super Proton Synchrotron (SPS) and BNL Relativistic Heavy Ion Collider (RHIC) seem to con rm this conjecture. The data suggest that the threshold for the onset of deconnem ent is located at the low SPS energies [2,3].

The phase diagram of strongly interacting matter can be presented in terms of tem – perature T and baryochem ical potential $_{\rm B}$. QCD –inspired calculations suggest that the phase boundary between hadrons and QGP is of rst order at large values of $_{\rm B}$, ending in a critical point of second order and then turning into a continuous rapid transition at low $_{\rm B}$ [4]. The location of the critical point may be close to the (T; $_{\rm B}$) values found for the freeze-out of the hadron system produced in collisions of heavy nuclei at SPS energies.

The study of uctuations is an important tool for localizing the phase boundary and the critical point. In particular, signi cant transverse momentum and multiplicity uctuations are expected to appear for systems that hadronize from QGP and freeze-out near the critical point of QCD [5]. The location of the freeze-out point in the phase diagram can be moved by varying the collision energy and the size of the collision system. A nonmonotonic evolution of uctuations with these collision parameters can serve as a signature for the phase transition and the critical point. These considerations motivated an extensive program of uctuation studies at the SPS and RHIC accelerators.

So far for central Pb+ Pb collisions, the analysis of multiplicity uctuations has found only smalle ects without signi cant structure in the energy dependence in the whole SPS energy dom ain [6]. The measured net charge uctuations can be explained by the e ects of global charge conservation [7]. The energy dependence of event-by-event uctuations of the K = ratio, on the other hand, shows an interesting increase toward lower energies [8] that can be attributed to the onset of decon nem ent [9] rather than to the critical point.

This paper presents results of the NA 49 experim ent from a study of transverse momentum p_T uctuations in central Pb+ Pb collisions at 20A, 30A, 40A, 80A, and 158A GeV. It extends a previous study [10] that investigated the system size dependence of p_T uctuations at the top SPS energy.

Fluctuations in nucleus-nucleus collisions are susceptible to two trivial sources: the nite and uctuating number of produced particles and event-by-event uctuations of the collision geometry (see the discussion of this point within HSD and UrQMD transport models in Ref. [11]). Suitable statistical tools have to be chosen to extract the uctuations of interest. As in the previous NA 49 study [10], mainly the global $_{P_T}$ measure will be used. Alternative measures used in the literature, e.g. $_{P_T}$ given [12], $_{P_T}$ [13], F_{P_T} [14], and $_{P_T}$ (%) [15,16] are related [17].

To obtain further information on the possible source of uctuations, two additional m ethods will be employed. The distribution of event-wise average transverse m om entum M (p_T) will be compared against the corresponding histogram for m ixed events, which represents purely statistical uctuations. Moreover, two-particle transverse m om entum correlations, as proposed in R ef. [13], will be analyzed.

This paper is organized as follows. In Sec. 2 the statistical tools used in this analysis are introduced and brie y discussed. The NA 49 setup is presented in Sec. 3. Experim en-

tal e ects such as detector acceptance and two-track resolution are discussed in Sec. 4. The NA 49 results on the energy dependence of transverse momentum uctuations are presented and discussed in Sec. 5. A summary closes the paper.

2 Measures of uctuations

Various m ethods can be used to measure event-by-event p_T uctuations. A natural observable is the distribution of the average transverse m om entum of the events de ned as

where N is the multiplicity of accepted particles in a given event and $p_{T\,i}$ is the transverse momentum of the i-th particle. The distribution of M (p_T) will be compared with the corresponding histogram obtained for articially produced "mixed events". In mixed events, all particles are by construction uncorrelated (each particle in a given mixed event is taken from a di erent realevent with the sam emultiplicity) but follow the experimental inclusive three momentum spectra as well as the distribution of multiplicity.

The second observable used in this work is the $_{p_T}$ measure, proposed in Ref. [18] and used also in our previous analysis [10]. Following the authors of Ref. [18], one can de ne the single-particle variable $z_{p_T} = p_T$ \overline{p} with the bar denoting averaging over the single-particle inclusive distribution. As seen, $\overline{z_{p_T}} = 0$. Further, one introduces the event variable Z_{p_T} , which is a multiparticle analog of z_{p_T} , de ned as

where the sum m ation runs over particles in a given event. Note, that $hZ_{p_T} i = 0$, where h::: represents averaging over events. Finally, the p_T m easure is de ned as

The $_{P_T}$ m easure has two in portant properties. First, $_{P_T}$ vanishes when the system consists of particles that are emitted independently (no interparticle correlations), and the single particle momentum spectrum is independent of multiplicity. Second, if an A + A collision can be treated as an incoherent superposition of independent N + N interactions (superposition model), then $_{P_T}$ has a constant value, the same for A + A and N + N interactions. This in plies that, in particular, $_{P_T}$ does not depend on the in pact parameter (centrality), if the A + A collision is a simple superposition of N + N interactions. Furthermore, $_{P_T}$ is independent of changes of the size of a compact acceptance dom ain provided the correlation scale (range), k, is much smaller than the size of the acceptance region, k. In the limit of large correlation length and small acceptance the magnitude of $_{P_T}$ approaches zero. The approximately linear dependence of $_{P_T}$ on the fraction of accepted particles in the limit $k_{A} = k_{C}$ suggested the introduction of the uctuation measures should be $_{P_T}$ else properties of the uctuation measures should be

taken into account when results are compared and discussed. Finally, we note that the magnitude of p_T decreases with the fraction of random ly lost particles, e.g., due to incomplete reconstruction e ciency.

In spite of the above mentioned advantages, there is an important disadvantage of using $_{P_T}$ in the uctuation analysis. While $_{P_T}$ is sensitive to the presence of particle correlations in a system, it does not provide inform ation on the nature of the correlation. Several e ects can contribute to $_{P_T}$. Therefore, to achieve a better understanding of the uctuation structure, it is useful to also employ a more di erential method [13].

The correlations can be studied by plotting the cumulative p_T variables for particle pairs. Namely, instead of p_T , one can introduce the variable x, de ned for a particle i as [19]

where (p_T) is the inclusive p_T distribution, normalized to unity, which is obtained from all particles used in the analysis. By construction, the x variable varies between 0 and 1 with a at probability distribution. Two-particle correlation plots, as presented in this paper, are obtained by plotting $(x_1;x_2)$ points for all possible particle pairs within the same event. The number of pairs in each $(x_1;x_2)$ bin is divided by the mean number of pairs in a bin (averaged over all $(x_1;x_2)$ bins). This two-dimensional plot is uniform by populated when no interparticle correlations are present in the system. Nonuniform ity signals the presence of interparticle correlations. For example, when identical particles are studied, Bose statistics lead to a ridge along the diagonal of the $(x_1;x_2)$ plot, which starts at (0;0) and ends at (1;1), whereas event-by-event temperature uctuations produce a saddle-shaped structure [13].

3 Experim ental Setup




Figure 1: Experim ental setup of the NA 49 experim ent [20] with di erent beam de nitions and target arrangem ents.

NA 49 is one of the xed target experiments at the CERN SPS. The detector (see Fig. 1 and R ef. [20]) is a large acceptance hadron spectrom eter used for the study of the hadronic nal states produced in p + p, p + nucleus, and nucleus + nucleus collisions. In particular, centrality selected Pb + Pb interactions were recorded at 20A, 30A, 40A, 80A, and 158A G eV projectile energies.

The main components of the detector are four large-volumetime projection chambers (TPCs), which are capable of detecting about 80% of approximately 1500 charged particles created in a centralPb+Pb collision at 158A G eV (the acceptance losses are concentrated mainly in the backward rapidity region and at azim uthal angles along the magnetic eld direction). The vertex TPCs (VTPC-1 and VTPC-2), are located in the magnetic eld of two superconducting dipole magnets (1.5 and 1.1 T, respectively, at 158A G eV; for lower energies, the magnetic eld is scaled down in proportion to the beam energy). Two other TPCs (MTPC-L and MTPC-R) are positioned downstream of the magnets symmetrically to the beam line. The results presented in this paper are analyzed with a global tracking scheme [21], which combines track segments that belong to the same physical particle but were detected in di erent TPCs. The NA 49 TPCs allow precise measurements of particle momenta p with a resolution of (p)=p² = (0.3 7) 10 (G eV/c)¹. A precise measurement of speci c energy loss (dE =dx) in the region of relativistic rise is possible in the TPCs, however, dE =dx information is not used in this analysis.

The centrality of nuclear collisions is selected by using the energy of the projectile spectator nucleons measured in the downstream calorim eter (VCAL). The geometrical

acceptance of the VCAL is adjusted to cover the projectile spectator region by setting the collimator (COLL).

The target is a thin Pb foil (224 m g/cm²) positioned about 80 cm upstream from VTPC-1. Pb beam particles are identi ed by m eans of their charge as seen by a counter (S2') situated in front of the target. The beam position detectors (BPD-1/2/3 in Fig. 1), which are proportional cham bers placed along the beam line, provide a precise m easurem ent of the transverse positions of the incom ing beam particles. For Pb beam s, interactions in the target are selected by an anti-coincidence of the incom ing beam particle with a counter (S3) placed directly behind the target.

Details of the NA49 detector setup and performance of the tracking software are described in [20].

4 Data selection and analysis

4.1 Data sets

The data used for the analysis consist of sam ples of Pb+ Pb collisions at 20A, 30A, 40A, 80A, and 158A GeV energy for which the 7.2% most central reactions were selected. Table 1 describes the data sets used in this analysis.

4.2 Event and particle selection

Event selection criteria were aimed at reducing possible contamination with nontarget collisions. The primary vertex was reconstructed by thing the intersection point of the measured particle trajectories. Only events with a proper quality and position of the reconstructed vertex are accepted in this analysis. The vertex coordinate z along the beam has to satisfy j_z $z_j j < z, where <math>z_0$ is the nominal vertex position and z is a cut parameter. The values of z_0 and z are -581.05 and 0.25 cm for 20A G eV, -581.3 and 0.3 cm for 30A G eV, -581.1 and 0.3 cm for 40A G eV, -581.2 and 0.3 cm for 80A G eV, and -578.9 and 0.3 cm for 158A G eV. The maximal allowed deviation of the x and y positions of the tted vertex (x and y) from the measured beam position varies from 0.1 cm (for 158A G eV) to 0.25 cm (for low energies). The cut on the ratio of the number of tracks used to t the primary vertex divided by the total number of tracks registered in TPC s (ntf=nto) was required to be higher than 0.25 for all energies.

To reduce the possible contam ination by nonvertex tracks such as particles from secondary interactions or from weak decays, several track cuts are applied. The accepted particles are required to have measured points in at least one of the vertex TPCs. A cut on the so-called track in pact parameter, the distance between the reconstructed main vertex and the back extrapolated track in the target plane $j_x j < 2$ cm and $j_y j < 1$ cm, is applied to reduce the contribution of nonvertex particles. Moreover, particles are accepted only when the potential number of points (nm p), calculated on the basis of the geometry of the track, in the detector exceeds 30. The ratio of the number of points on a track to the potential number of points (np=nm p) is required to be higher than 0.5 to avoid using fragments of tracks. This set of cuts signi cantly reduces the possible contam ination of particles from weak decays, secondary interactions, and other sources.

In this analysis only tracks with $0.005 < p_T < 1.5 \text{ GeV}/\text{c}$ are used. For all ve energies, the forward-rapidity region is selected as 1:1 < y < 2.6, where y is the particle rapidity calculated in the center-of-m ass reference system. As the track-by-track identication is not always possible in the experiment, the rapidities are calculated assuming the pion m ass for all particles.




Figure 2: (Color online) NA 49 (;p_T) acceptance of all charged particles for 2:0 < y < 2:2. Additional cut on y_p (see the text) is not included. The solid lines represent the analytical parametrization of the common acceptance.

The NA 49 detector provides a large, though incom plete, acceptance in the forward hem isphere. Figure 2 presents examples of ($;p_T$) acceptance ¹ for 2:0 < y < 2:2. The regions of com plete azim uthal acceptance are di erent for various energies. The quantitative com parison of p_T values among the velenergies requires selection of the regions of common acceptance.

The solid lines in Fig.2 represent a parametrization of the common acceptance limits for all ve energies by the form ula -

where the parameters A and B depend on the rapidity range as given in Table 2. The same lim its are used for both the negatively charged and positively charged particles with the appropriate rede nition of azim uthal angle ¹. Only particles within the acceptance lim its are used in the analysis.

¹ All charged particles are plotted, with the azim uthal angle of negatively charged particles (assuming standard polarity of the magnetic edd) rejected: namely for all negatively charged particles with < 0 degrees their azim uthal angle is changed as follows: goes to + 360 degrees, and nally for all negatively charged particles goes to 180 degrees. In the case of the opposite polarity of the magnetic edd (40A G eV data) one has to rede ne the azim uthal angle of positively charged particles, instead.

Due to the described kinem atic cuts (mostly on rapidity) and track selection criteria, together with the requirement to use the same limited ($;p_T$) acceptance, only about 5.0 – 5.2 % of charged particles produced in central Pb+ Pb interactions (at each of the ve energies) enter into the subsequent analysis.




Figure 3: (Cobronline) (y ;p_T) plots of all accepted (see Fig. 2) particles assuming pion (left), kaon (middle) and proton (right) mass. Additional cut on y_p (see the text) is not included. Top, middle, and bottom panels correspond to 20A, 30A, and 80A G eV data, respectively. Black lines represent beam rapidities (y_{beam}) in the center-of-mass reference system.

Figure 3 presents (y ;p_T) plots of all charged particles accepted in the analysis (additional cut on y_p - see below - not applied in the plots). Top, middle and bottom panels correspond to 20A, 30A, and 80A G eV data, respectively, whereas left, middle, and right panels are obtained by assuming pion, kaon and proton masses when evaluating rapidities. B lack lines represent beam rapidities (y_{beam}) in the center-of-mass reference system. At lower energies the NA 49 TPC acceptance extends to the projectile rapidity domain and the selected particles may be contaminated by e.g. elastically scattered or diractively produced protons. This domain has been excluded from the analysis by applying an additional cut on the rapidity y_p of the particles, calculated with the proton mass. Namely, at each energy, the rapidity y_p is required to be lower than y_{beam} 0.5.

The above cut was introduced because the prelim inary analysis (without the additional y_p cut) manifested an unexpected e ect: the p_T measure showed a dimension for particles of dimension charges [22]. p_T was independent of energy and consistent with zero

for negatively charged particles, but it signi cantly increased for lower SPS energies for both all charged and positively charged particles. This e ect, however, was found to be connected with protons only, and can be explained by event-by-event in pact param eter uctuations or, m ore precisely, by a correlation between the num ber of protons (nucleons) in the forward hem isphere and the num ber of protons (nucleons) that are closer to the production region [23]. For m ore central events the num ber of forward-rapidity protons is sm aller, and consequently, the num ber of protons in the production region is higher. The situation is opposite for less central collisions. The existence of those di erent event classes results in the increased prevailes for positively charged particles. One can elim inate this trivial source of correlations by either centrality restriction or rejection of the beam rapidity region [23]. In this analysis, the second m ethod is employed by applying a cut on y_p at each energy (see above).

4.3 Corrections and error estim ates

The statistical error on p_T has been estimated as follows. The whole event sample was divided into 30 independent subsamples. The value of p_T was evaluated for each subsample, and the dispersion -D - of the results was then calculated. The statistical error of p_T is taken to be equal to D = 30.

The event and track selection criteria reduce the possible system atic bias of the measured $_{\rm PT}$ values. To estimate the remaining systematic uncertainty, the values of cut parameters were varied within a reasonable range. For a given cut parameter, the "partial" systematic error was taken as half of the di erence between the highest and the lowest $_{\rm PT}$ value. Two event cuts and two track cuts were considered in the analysis. The nalestimate of the total systematic error on $_{\rm PT}$ was taken as the maximum of the changes resulting from this study.




Figure 4: Dependence of p_{T} on one of the event cuts (ntf=nto ratio). Note: the values and their errors are correlated. The dashed line indicates the cut used in the analysis.




Figure 5: Dependence of P_T on the allowed distance z from the nom inal position of the main vertex. Note: the values and their errors are correlated. The dashed line indicates the cut used in the analysis of 30A and 80A G eV data. The dotted line represents the cut used in the analysis of 20A G eV data.

Event cuts are used to reject possible contam ination of nontarget interactions, how ever there is always a small fraction of remaining nontarget events that can in uence the values. This system atic bias can be estimated by investigating the dependence of two vertex cut parameters -ntf=nto and z. Figure 4 presents the dependence of p_T on the ratio ntf=nto for 20A, 30A, and 80A G eV data. The observed system atic error of with respect to changes of ntf=nto varies from 0.35 M eV/c for 20A G eV to 0.85 M eV/c for 30A G eV and 80A G eV. In Fig. 5 the dependence of from the nom inal position of the main vertex is shown for three energies. The observed variation of p_T with this cut is quite small for all studied data sets. The highest "partial" system atic error (for 80A G eV data) was found to be 0.75 M eV/c.




Figure 6: Dependence of p_T on upper cut in the impact parameter $j_x j$. For each point, the cut on $j_y j$ is equal to half the cut on $j_x j$. Note: the values and their errors are correlated. The dashed line indicates the cut used in the analysis.




Figure 7: Dependence of p_T on lower cut on np=nm p ratio. Note: the values and their errors are correlated. The dashed line indicates the cut used in the analysis.

The majority of tracks selected by the track selection criteria are main vertex tracks and the remaining fraction (10%) originates predominantly from weak decays and secondary interactions with the material of the detector. The in uence of this remaining fraction can be estimated by studying the dependence of p_T on the track cut parameters p_x jand p_y jand the np=nm p ratio. Figures 6 and 7 present how the values of p_T change with the impact parameter cut and with the cut on the np=nm p ratio, respectively. O ne nds that p_T is rather stable with respect to both cut parameters. A sm all increase of p_T with increasing in pact parameter cut may be due to the increasing contribution of nonvertex tracks for higher p_x jand p_y jvalues. This e ect has been studied quantitatively,

for central Pb+ Pb collisions at 158A G eV, in our previous paper [10]. The system atic error contribution from the impact parameter cut dependence varies from 0.15 M eV/c for 80A G eV to 0.55 M eV/c for 20A G eV, whereas the contribution from the change of cut in the np=nm p ratio varies from 0.45 M eV/c for 40A G eV and 80A G eV up to 1.45 M eV/c for 158A G eV.

Finally, the typical system atic error on $_{\rm Pr}$, determ ined as the maximum resulting from the above analysis, has been estimated as not higher than 0.7 M eV/c for 20A G eV, 0.9 M eV/c for 80A G eV, 1.1 M eV/c for 40A G eV, and 1.6 M eV/c and 1.7 M eV/c for 30A and 158A G eV data, respectively. M ore detailed values (also for various charge selections) are given in Table 4.

The NA 49 experim ent registered 158A G eV Pb+Pb interactions at various beam intensities, magnetic eld con gurations ("norm al" polarity of the magnetic eld STD+




Figure 8: p_T values for di erent central and m in im um -bias (M B) data sets. Data used for the further analysis are central STD + norm al intensity.

and opposite polarity of the magnetic eld STD –), and with di erent centrality triggers. Figure 8 presents $_{\rm PT}$ values for these di erent data sets. An additional cut on the energy deposited in VCAL has been applied to select the 7.2% most central Pb+ Pb interactions from each data sample. A lthough the num bers of events extracted from minimum -bias data are relatively bw, one observes good agreem ent between the $_{\rm PT}$ values obtained for di erent experimental conditions.




Figure 9: Dependence of p_{T} on the fraction of random ly rejected particles.

The observed $_{P_T}$ values can be a ected by the losses of tracks resulting from the reconstruction ine ciency of the detector and from the track selection cuts. The dependence of $_{P_T}$ on the fraction of random ly rejected particles is shown in Fig. 9. W ithin the considered forward-rapidity region, at all ve energies (only three example energies are shown), the tracking e ciency of the NA 49 detector is higher than 95% and therefore Fig. 9 in plies that the bias due to tracking ine ciency and track selection cuts is lower than 0.5 - 1.0 M eV/c.

It has already been shown in our previous paper [10] that the limited two-track resolution in uncess the measured p_T values. To quantitatively estimate this contribution,

ve sam ples (30 000 events in each) of mixed events were prepared (for 20A, 30A, 40A, 80A, and 158A GeV data). Multiplicities of mixed events were chosen to be the same as those of real events, but each particle in a mixed event was taken at random from a di erent real event. Such a mixing procedure ensures that the inclusive spectra (e.g., transverse momentum or rapidity) are the same for data and for mixed events, but all possible correlations vanish. Indeed, it was veri ed for all data sets and all particle charge selections that the $_{p_T}$ value calculated for the sample of mixed events is consistent with zero. In a second step, the prepared m ixed events were processed by the NA 49 simulation software. The resulting simulated raw data were then reconstructed and the pr measure calculated. The obtained p_{T} values are negative, as expected for the anticorrelation introduced by the losses due to the limited two-track resolution. The additive two-track resolution correction is calculated as the di erence ($_{p_{T}}$) between the values of $_{p_{T}}$ after detector simulation and reconstruction and before this procedure (mixed events). The values of $_{p_{T}}$ were calculated for all ve energies and for various particle charge selections, separately, and are listed in Table 3.

The magnitude of the two-track resolution corrections is higher for higher energies (from 2 to 4 M eV/c for 158A G eV) where them ultiplicities of produced particles are higher and consequently the densities of tracks are relatively high. The two-track resolution corrections become much smaller for low-multiplicity interactions, namely for 20A and 30A G eV data ($_{\rm Pr}$ values close to zero). The absolute values of $_{\rm Pr}$ are typically higher for positively than for negatively charged particles, which is mainly due to higher track density for positively charged particles caused by the larger number of protons

relative to antiprotons. The $_{p_T}$ values are typically negative thus indicating that $_{p_T}$ m easured with an ideal detector would be higher. The value of $_{p_T}$ corrected for the limited two-track resolution e ect equals the "raw" $_{p_T}$ m inus the corresponding $_{p_T}$. The error of the corrected $_{p_T}$ is calculated by adding in squares the statistical error of the raw $_{p_T}$ value and the statistical error of the correction. As $_{p_T}$ is very sm all for 20A and 30A G eV data, no corrections for the two-track resolution e ect were applied at these energies. Instead, the upper limits of the system atic errors were increased by 0.3 M eV/c (see Table 4).

5 Results and Discussion

5.1 Results

The results shown in this section refer to accepted particles, i.e., particles that are accepted by the detector and pass all kinem atic cuts and track selection criteria as discussed in Sec. 4.2. Results are not corrected for limited kinem atic acceptance, and this acceptance has to be taken into account when the data are compared with model predictions. The measured p_T values are corrected for limited two-track resolution of the NA 49 detector (see below and Sec. 4.3). A possible bias due to particle losses and contam ination in the accepted kinem atic region is included in the system atic error.




Figure 10: (Color online) D istributions of mean transverse momentum for data (points) and mixed events (histogram s). D ata points are not corrected for acceptance and limited two-track resolution. Events with accepted particle multiplicity equal to zero are not used.




Figure 11: Distributions of mean transverse momentum for data divided by distribution for mixed events (see the previous gure).

Figure 10 shows the distributions of mean (per event) transverse momentum M (p_T) for central 20A, 30A, 40A, 80A and 158A GeV Pb+Pb interactions. Points represent results from real events, and histograms are calculated from mixed events, in which there are no interparticle correlations by construction. Data are not corrected for experimental

e ects such as two-track resolution or acceptance. Events with zero multiplicity (after cuts, there can be a few of them especially at low erenergies) are not taken into account in Figs. 10, 11. How ever, when evaluating $_{p_T}$ such events are included in the data sam ple ². All charged particles are used to prepare these plots. No signi cant di erences between the distributions of M (p_T) for data and mixed events are observed at any SPS energy, indicating the absence of substantial event-by-event uctuations. The di erence between the histogram s for data and mixed events can be better seen in Fig. 11, which presents the ratio of the two. At all energies, the ratio is close to unity, thus con rm ing that average transverse momentum uctuations are very close to the statistical uctuations. The widths of the distributions of M (p_T) decrease with increasing energy of the colliding system as expected from the increasing particle multiplicities.




Figure 12: (C olor online) p_T as a function of energy for the 7.2% m ost central Pb+ Pb interactions. D at a points are corrected for limited two-track resolution. Errors are statistical only. System atic errors are given in Table 4.

The uctuation measure p_T , which is more sensitive to small average p_T uctuations, is shown in Fig. 12. The measured values are corrected for limited two-track resolution. Results are presented for all charged particles and separately for negatively and positively charged particles³. For all three charge selections, p_T seems to be independent of energy and consistent with the hypothesis of independent particle production (p_T 0). The

 $^{^{2}}$ It was veried that the $_{p_{T}}$ value does not depend on whether zero multiplicity events are included or not (in agreement with the denition of $_{p_{T}}$). However, in Table 4, the mean multiplicities of accepted particles are shown, where events with zero multiplicity are normally taken into account. Thus, for consistency, the code calculating $_{p_{T}}$ values includes events with zero multiplicity.

³ The sam ple of negatively charged particles is composed mainly of negative pions, whereas the sam ple of positively charged particles is dominated by positive pions and protons. Therefore, the measured uctuations could dier between both charges. Moreover, the sam ple of all charged particles can include additional sources of correlations which are not present in positively or negatively charged particles, separately. Therefore the $_{p_T}$ measure obtained from all charged particles will not necessarily be a sum of $_{p_T}$ for positively and for negatively charged particles.

m easured $p_{\rm T}$ values do not show any anom alies which m ight appear when approaching the phase boundary or the critical point. However, it should be noted that because of the limited acceptance of NA 49 and the additional restrictions used for this analysis, the sensitivity for uctuations may be signile cantly reduced if the underlying scale of the correlations is large (see Sec. 2).

q Table 4 presents the mean multiplicities of accepted particles, the dispersions $_{\rm N} = \frac{1}{1000} \frac{1}{2}$ i $\frac{1}{1000} \frac{2}{1000}$ f of the multiplicity distributions, the mean inclusive transverse momenta, the dispersions $_{\rm PT}$ of inclusive transverse momentum distributions, and $_{\rm PT}$ values for all analyzed data sets. The $_{\rm PT}$ values (with their statistical and system atic errors) shown in this table have been calculated for all accepted charged particles as well as for negatively and positively charged particles, separately. All $_{\rm PT}$ values are corrected for the two-track resolution e ect of the NA 49 detector.




Figure 13: (Cobr) Two-particle correlation plots $(x_1;x_2)$ using the cumulant p_T variable x. The bin contents are normalized by dividing with the average number of entries per bin. Plots are for all charged particles for central Pb+ Pb collisions at 20A - 158A GeV. Note that the color scale is the same in all panels.

Two-particle correlation plots (for all charged particles) of the cum ulant transverse momentum variable x are presented in Fig. 13 for 20A, 30A, 40A, 80A, and 158A GeV central Pb+ Pb collisions. One observes that the plots are not uniform ly populated. The color scale is the same for all plots in order to check whether the correlation pattern changes with the energy. For all ve energies, short-range correlations (Bose-E instein and C oulom b e ects) are visible as an enhancem ent of the point density in the region close to the diagonal. The analysis of events sim ulated by the UrQMD m odel (see below) resulted in uniform ly populated two-particle correlation plots without diagonal enhancem ent.




Figure 14: (Cobr) Two-particle correlation plots $(x_1;x_2)$ using the cumulant p_T variable x. The bin contents are normalized by dividing with the average number of entries per bin. Plots are for central Pb+ Pb collisions at 20A GeV for unlike-sign particles (+), and for negatively and positively charged particles, separately. Note that the color scale can be slightly di erent for di erent panels.




Figure 15: (Cobr) Two-particle correlation plots $(x_1;x_2)$ using the cumulant p_T variable x. The bin contents are normalized by dividing with the average number of entries per bin. Plots are for central Pb+ Pb collisions at 158A GeV for unlike-sign particles (+), and for negatively and positively charged particles, separately. Note that the color scale can be slightly di erent for di erent panels.

Figures 14 and 15 present two-particle correlation plots for di erent charge com binations. The correlations of both positively and negatively charged particle pairs look sim ilar (enhancem ent along diagonal) and can be explained by the Bose-Einstein e ect. On the other hand, there is no signi cant correlation observed for unlike-sign particles. The prelim inary analysis for (+) pairs without azim uthal angle restrictions (see the acceptance lim its in Fig. 2) showed a small maxim um restricted to the region of low x (i.e. low transverse m om enta) [24]. Such a low x (low p_T) maxim um for unlike-sign particles was observed in the STAR data [13] and recently also by the CERES experiment [25]. This maxim um was interpreted as an e ect of C oulom b attraction of particles with di erent charges and contam ination from e⁺ e pairs. W hen the azim uthal angle is restricted (Figs. 14 and 15) the maxim um at low x is not observed any more.

5.2 Comparison with the UrQMD model

The measured $_{\rm PT}$ values have been compared with the predictions of the ultrarelativistic quantum molecular dynamics (UrQMD) model [26, 27], a transport model producing hadrons via formation, decay, and rescattering of resonances and strings. In the UrQMD model, no uctuations due to a phase transition are incorporated. However, resonance decays and elects of correlated particle production due to energy (momentum) and quantum number conservation laws are included. In the analysis default parameters of the UrQMD model were used (meson-meson and meson-baryon scattering included). For each energy the most central 7.2% interactions were selected, in accordance with the real NA 49 events.

In the study of the NA49 data, the $_{\rm PT}$ measure was calculated from all charged particles, consistent with originating from the main vertex. This means that mostly main vertex pions, protons, kaons, and their antiparticles are used in the analysis, because particles coming from the decays of K $_{\rm S}^0$, and are suppressed by the track selection cuts. Therefore, also in the analysis of the UrQMD events only charged pions, protons and kaons were taken into account for evaluating $_{\rm PT}$. Due to the speci c parameter applied in the UrQMD model – the time during which all particles are tracked (taken as 80 fm/c) – the list of generated kaons, pions and (anti)protons does not contain the products of weak decays. In the analysis of the UrQMD events, the same kinematic restrictions were applied as in the case of the NA49 data. In particular, the selected (;pT) acceptance is common for all ve energies, and as a result of all the kinematic and acceptance cuts, only about 5-6% of all charged particles are used to study transverse momentum uctuations.




Figure 16: (Color online) Comparison of $_{P_T}$ as a function of energy from data (data points, corrected for limited two-track resolution) with UrQMD model calculations (black lines) with acceptance restrictions as for the data. The panels represent results for all charged (left), negatively charged (center) and positively charged particles (right).

Figure 16 com pares the the energy dependence of $_{p_T}$ for the data and for the UrQMD model. Similar to the data, the UrQMD model does not show any signicant energy dependence of transverse momentum uctuations for any charge selection. The range of $_{p_T}$ values obtained from the UrQMD calculations is similar to that found in the data. Quantitative comparisons are not conclusive, since in spite of the same kinematic and acceptance restrictions the model does not contain the elects of Bose-Einstein correlations and Coulomb interactions. Correlations in plemented in the UrQMD model (due

to conservation laws and hadron resonance production and decays) apparently do not increase the observed $_{P_T}$ values. In particular the observed di erences between m odel and experim ental data do not point to any onset of unusual uctuations as expected for hadronic freeze-out close to the critical point.

The sensitivity of the results on the energy dependence of $_{P_T}$ to variations of the upper p_T cut was checked by repeating the analysis for three di erent upper p_T cuts. Figures 17, 18 and 19 show the dependence of $_{P_T}$ on energy for upper p_T cuts of 750 M eV/c, 500 M eV/c and 250 M eV/c, respectively. The measurements (data points) are corrected for limited two-track resolution. The lines represent the UrQMD predictions with the same kinematic and acceptance restrictions. The results with a decreased upper p_T cut do not show any signi cant energy dependence, which is similar to the corresponding results for the wide- p_T interval ($p_T < 1500 \text{ M eV/c}$). The UrQMD results seem to lie system atically below the NA 49 data. This e ect m ight be explained by the neglect of B ose-E instein and C oulom b correlations (see also F ig. 13) in the model.




Figure 17: (Color online) $_{P_T}$ as a function of energy for the 7.2% most central Pb+ Pb interactions, with additional cut $p_T < 750$ MeV/c. Data (points) are corrected for limited two-track resolution. Lines show results of UrQMD calculations with the same kinematic and acceptance restrictions. Errors are statistical only.

5.3 Search for the critical point

Recent results on the energy dependence of hadron production properties at the CERN SPS [2,3] indicate that decon ned matter is formed at the early stage of central Pb+ Pb collisions at energies as low as 30A G eV. Thus, at higher collision energies, the expanding matter crosses the phase boundary between decon ned matter and hadron gas and may freeze-out close to it. The nature of the transition is expected to change with increasing baryochemical potential $_{\rm B}$. At high potential, the transition is believed to be of the rst order with the end point of the rst order transition line being a critical point of the second order. A characteristic property of the second-order phase transition is a divergence of the susceptibilities. Consequently, an important signal of the critical




Figure 18: (C olor online) Sam e as Fig. 17, but with additional cut $p_T < 500 \text{ M eV}/\text{c}$.




Figure 19: (Color online) Same as Fig. 17, but with additional cut $p_T < 250 \text{ M eV}/c$.

point are large uctuations, in particular, an enhancement of uctuations of transverse momentum and multiplicity [5]. These predictions are to a large extent qualitative, as QCD at nite temperature and baryon number is one of the least accessible domains of the theory. Thus quantitative estimates of the critical point signals were performed within QCD -inspired models [5, 28, 29].

It was found that assuming a correlation length = 6 fm and freeze-out at the critical point $_{P_T}$ in full phase space m ay be increased by about 40 and 20 M eV/c for all charged and for like-charge hadrons, respectively [5]. These predictions are independent of particle charge and scale with multiplicity. Therefore $_{P_T}$ for all charged hadrons is two times larger than for like-charge hadrons. The value of $_{P_T}$ is expected to decrease because of the limited acceptance, namely, by a factor of 0.6 and 0.4 for the NA 49 acceptance in rapidity and in azim uthal angle, respectively. The particle correlator [5] at the critical point was calculated to be independent of azim uthal angle and charge of hadrons, whereas it changes with rapidity. Therefore the predicted $_{P_T}$ values scale with azim uthal acceptance (40%

in this analysis, independent of energy (see Fig. 2)). Together, these reduce the expected signal to about 10 and 5 M eV/c for all charged and like-charge hadrons, respectively [5] (private communication). These estimates are based on a correlation length = 6 fm. However, because of the nite lifetime of the reball, the correlation length may not exceed 3 fm /c [30]. Since the uctuations scale with the square of the correlation length the expected signal is further reduced by $(6=3)^2 = 4$. This leads to estimates for p_{τ} of 10 M eV/c for all charged hadrons within full phase space and about 2.4 M eV/c for all charged hadrons and 1.2 M eV/c for like-sign charged hadrons in the acceptance of the analysis. Theoretical estimates based on lattice QCD calculations locate the critical point at T 162 M eV and $_{\rm B}$ 360 M eV [4]. Guided by the considerations of R ef. [31], we param etrize the increase of $_{p_T}$ due to the critical point by G aussian shapes in T and $_{B}$ 10 M eV and $(_{\rm B})$ 30 M eV, respectively. w ith (T)




Figure 20: (Color online) p_T as a function of baryochem ical potential ($_B$ values from statistical hadron gas model ts [32]) for the 7.2% most central Pb+ Pb interactions. Results with $p_T < 1.5$ GeV/c (as in Fig. 12). Data (points) are corrected for limited two-track resolution. Errors are statistical only. The Gaussian curves show estimated p_T values in the case of the existence of the critical point (see text for details).

The results on $_{P_T}$ in central Pb+ Pb collisions at the SPS energies for $0.005 < p_T < 1.5G \text{ eV}/c$ and the restricted acceptance of the analysis are shown as a function of $_B$ in Fig. 20. The baryochem ical potential $_B$ at each energy was obtained from the solutions for the elects of the critical point for the two assumptions on the correlation length (3 and 6 fm) are illustrated by the dashed and full G aussian curves, respectively. The base lines of the model curves are set to the mean level of $_{P_T}$ in the SPS energy range (here the mean level is calculated separately for all charged and negatively charged particles). The data do not support the predictions for the critical point. Neither a nonmonotonic increase of $_{P_T}$ nor a characteristic di erence between $_{P_T}$ for all charged and like-charge hadrons are observed. However, the freeze-out in central Pb+ Pb collisions appears [32] to take place at tem peratures signi cantly below the transition tem perature and thus could make the critical point signal invisible. This possibility motivates the continuation of the search for the critical point in NA 61/SH INE [33] by a scan in both tem perature and baryochem ical potential which will be performed by changing the collision energy and size

of the colliding nuclei.




Figure 21: (C obr online) ! [6] as a function of baryochem ical potential ($_{\rm B}$ values from statistical hadron gas model ts [32]) for the 1% most central Pb+Pb interactions in 1 < y < $y_{\rm beam}$. Errors are statistical only. The Gaussian curves show estimated ! values in the case of the existence of the critical point (see text for details).

Since publication of the NA 49 results on multiplicity uctuations [6], the estimates for the e ects of the critical point have been updated. In the following, we therefore present these new predictions for multiplicity uctuations for consistency. The estimates of the critical point signals were again perform ed [5] (private communication) assuming rst a correlation length = 6 fm, and they suggest an increase of the scaled variance of the multiplicity distribution ! in full phase space by 2 for all charged and by 1 for sam e-charge particles (uncorrelated particle production results in ! = 1). The limited acceptance used in the multiplicity uctuation analysis [6] leads to correction factors for the increase of 0.6 and 0.7 due to the rapidity and azim uthal acceptance, respectively. In the analysis of multiplicity uctuations, the azimuthal acceptance was chosen dependent on the energy with a mean of about 70%. Thus the measured multiplicity uctuations are expected to be increased by 0.84 and 0.42 for all charged and like-charge hadrons, respectively. For a correlation length = 3 fm, the increase should be four times smaller, i.e., 0.5 for all charged and 0.25 for same charge particles in full phase space and, respectively, 0.21 and 0.10 in the NA 49 acceptance. Figure 21 shows the experimental results for ! as a function of baryochem ical potential in the rapidity interval 1 < y < y_{beam} for the 1% m ost central Pb+ Pb collisions [6]. The expectations for the critical point are represented by the Gaussian curves above base lines at the level of the mean measured values of !. Sim ilar to transverse m om entum uctuations, multiplicity uctuations do not exhibit the e ects expected for hadronic freeze-out close to the critical point. How ever, one should note that the predicted width of the critical point signal is comparable to the size of the B steps in the NA 49 energy scan. In future experiments, one should consider scanning with narrower steps in $_{\rm B}$.

5.4 Comparison with other experiments




Figure 22: (C obr online) $_{\rm Pr}$ as a function of energy measured for all charged particles by the NA 49 and CERES experiments. The NA 49 points are obtained for the forward-rapidity region in a limited azim uthal angle acceptance; the CERES data [16] are calculated for the midrapidity region within a complete azim uthal acceptance. All data points include sm all-scale correlations (HBT, etc.).

Event-by-event transverse momentum uctuations have been studied by other experiments both at SPS and at RHIC energies. This section compares the NA49 results with those from the CERES and the STAR experiments. In such comparisons, one has to remember that the magnitude of any uctuation measure may depend on the acceptance used in the analysis. The CERES experiment measured somewhat higher values of p_T uctuations in them idrapidity region for centralPb+Au collisions at 40A, 80A, and 158A GeV. However, no signi cant energy dependence was found for either the p_T (%) or the p_T uctuation measures [16, 34]. Figure 22 compares NA49 and CERES [16] results on the energy dependence of the p_T measure. One observes only very weak (if any) energy dependence of p_T over the whole SPS energy range. It should, how ever, be stressed that quantitative comparison of p_T values from NA49 and CERES is ham pered by di erent acceptances (NA49: forward rapidity and limited azim uthal angle, CERES: midrapidity and complete azim uthal acceptance).




Figure 23: (Color online) p_T or $p_T n$ as a function of energy measured for all charged particles by the NA 49, CERES, and STAR experiments. The NA 49 points are obtained for the forward-rapidity region in a limited azim uthalangle acceptance; the CERES [16] and STAR (Fig. 3, left, in Ref. [35]) points are calculated for midrapidity regions within complete azim uthal acceptances. All data points include small-scale correlations (HBT, etc.). STAR data are corrected for tracking ine ciency.

The $_{P_T}$ measure is close to zero at SPS energies, but the STAR [35] results show a strong increase of $_{P_T}$ from top SPS to RHIC energies. The energy dependence of $_{P_T}$ is shown for central Pb+Pb (Pb+Au, Au+Au) collisions in Fig. 23. The data of NA49 (this paper), CERES, [16] and STAR [35] are compiled. The STAR results are presented for the related measure $_{P_T T}$ instead of $_{P_T}$. The di erence between both measures is smaller than a few percent for high multiplicity collisions as considered here (no signi cant di erence within the SPS energy dom ain and only few-percent di erences at RHIC energies [35]).




Figure 24: (Cobronline) P_T or P_T m as a function of percent of charged particles accepted in the analysis. D at a are presented for the top SPS and the low est R H IC energies. The NA 49 points (R ef. [10] and this analysis) are obtained for the forward-rapidity region in a limited azim uthal angle acceptance; the CERES [16] and STAR [35] points are calculated for m idrapidity regions within complete azim uthal acceptances. A ll data points include sm all-scale correlations (HBT, etc.).

The results of NA 49 and CERES at $p_{\overline{S_{N N}}} = 17.3 \text{ GeV}$ dier signi cantly from those of STAR at $p_{\overline{S_{N N}}} = 19.6 \text{ GeV}$. These dierences are likely due to dierences in the acceptance in momentum space. This is illustrated in Fig. 24, where p_{T} ($p_{T n}$) is plotted as a

function of the fraction of accepted charged particles 4 . The values of $_{p_T}$ ($_{p_T m}$) increase with increasing fraction of accepted particles.

The striking feature of the data presented in Fig. 23 is the rapid increase of $_{P_T}$ ($_{P_T}$ n) with increasing collision energy. For a given experiment, the fraction of accepted charged particles is constant (NA 49), increases (CERES), or decreases (STAR) with increasing collision energy ⁵. It was already explained in Sec.2 that $_{P_T}$ is independent of acceptance changes provided the correlation scale is much smaller than the size of the acceptance region. On the other hand, when the range of correlations is signily larger than the acceptance, $_{P_T}$ linearly decreases with decreasing fraction of accepted particles. The increase of $_{P_T}$ ($_{P_T}$ n) with energy is not caused by an increasing m agnitude of short range (com pared to the acceptance) correlations. A smentioned above, these correlations, if dom inant, would lead to an independence of $_{P_T}$ ($_{P_T}$ n) of the acceptance, in contrast to the results shown in Fig. 24. Curiously enough, the increase of

 p_{T} n with growing $p_{\overline{S_{N}N}}$ for the STAR data is associated with a decrease of the fraction of accepted particles. Consequently, we conclude that the increase is caused by a growing magnitude of medium – and long-range correlations (correlation length comparable to or larger than the acceptance). This e ect may result from an increasing contribution of particles originating from decays of high mass resonances and/or from (mini) jet fragm entation [35].

In contrast to the p_T ($p_T n$) uctuation measure, p_T used by the CERES experiment, does not show any dramatic di erences when going from SPS to RHIC energies [16,25] (see also Fig. 25⁶). Also the PHENIX results con rm that the magnitude of the p_T (%) uctuation measure exhibits only a small variation in a very wide energy range between $p_{\overline{N}N} = 22$ and 200 G eV [37]. It appears that the increase of p_T ($p_T n$) with the accepted particlem ultiplicity is approximately linear (Fig. 24). Consequently, p_T (%), which is proportional to $p_T = hN$ i, becomes approximately independent of multiplicity or collision energy.

A direct comparison of event-by-event p_T uctuations between di erent experiments, based on the method of determining the magnitude of residual temperature uctuations




Figure 25: (Color online) p_{T} (%) as a function of energy measured for all charged particles by the NA 49, CERES, and STAR experiments. The NA 49 points are obtained for the forwardrapidity region in a limited azimuthal angle acceptance; the CERES ([16]; point for 8% most centralPb+Au collisions taken from Ref. [25]) and STAR [36] points are calculated for midrapidity regions within complete azimuthal acceptances.

[38], has been presented in Ref. [39]. For the most central interactions, the estimated temperature uctuations are on the level of 1.8%, 1.7%, 1.3%, and 0.6% for PHENIX $\binom{p}{S_{N N}} = 200 \text{ GeV}$, STAR $\binom{p}{S_{N N}} = 130 \text{ GeV}$, CERES $\binom{p}{S_{N N}} = 17 \text{ GeV}$, and NA49 $\binom{p}{S_{N N}} = 17 \text{ GeV}$, respectively. This analysis con rm sthat, indeed, there is no signi cant energy dependence of temperature uctuations between SPS and RHIC energies.

6 Summary and outlook

Transverse m om entum event-by-event uctuations were studied for central Pb+Pb interactions at 20A, 30A, 40A, 80A, and 158A GeV. The analysis was limited to the forward-rapidity region (1:1 < y < 2:6). Three uctuation observables were studied: the uctuations of average transverse m om entum (M (p_T)) of the event, the $_{p_T}$ uctuation measure, and transverse m om entum two-particle correlations. The following results were obtained:

The distribution of event-by-event average transverse m om entum M (p) is close to that for m ixed events, indicating that uctuations are predom inantly of statistical nature.

The uctuation measure $_{\rm p_{T}}$ has values close to zero and shows no signi cantenergy dependence.

Two-particle transverse momentum correlations are found to be negligible except for contributions from Bose-Einstein correlations.

The $\operatorname{U} r \operatorname{Q} \operatorname{M} \operatorname{D}\,$ m odel reproduces the trend of the data.

The observed smallness of p uctuations in the SPS energy range is consistent with other published m easurem ents.

No sudden increase or nonmonotonic behavior was observed in the energy dependence of $_{p_T}$ nor the scaled variance ! of multiplicity uctuations. Such e ects have been suggested for freeze-out near the critical point of QCD.

Since the limited acceptance of NA 49 is expected to reduce the signal from possible critical uctuations, measurements in larger acceptance are still needed. Moreover, employing intermediate size nucleimay possibly move the freeze-out point closer to the critical point. These considerations motivated several new experiments planned in the SPS energy region: NA 61 at the CERN SPS [40, 41, 33, 42], STAR and PHENIX at the BNL RHIC [43], MPD at the Joint Institute for Nuclear Research (JINR) Nuclear new experiments for Antiproton and Ion Research (FAIR) heavy-ion synchrotron (SIS-300) [45]. The future results, together with the existing data, will cover a broad range in the (T, $_{\rm B}$) plane and should lead to signi cant progress in the search for the critical point.
