M odel independent constraints on m ass-varying neutrino scenarios

M odels of dark energy in which neutrinos interact with the scalar eld supposed to be responsible for the acceleration of the universe usually in ply a variation of the neutrino masses on cosm ological time scales. In this work we propose a parameterization for the neutrino mass variation that captures the essentials of those scenarios and allows to constrain them in a model independent way, that is, without resorting to any particular scalar eld model. Using WMAP 5yr data com bined with the m atter power spectrum of SD SS and 2dFG R S, the lim it on the present value of the neutrino m ass is m $_0$ m (z = 0) < 0:43 (0:28) eV at 95% C L. for the case in which the neutrino mass was lighter (heavier) in the past, a result competitive with the ones in posed for standard (i.e., constant mass) neutrinos. M oreover, for the ratio of the m ass variation of the neutrino m ass m over the current $massm_0$ we found that $\log[jm_j=m_0] < 1:3(2:7)$ at 95% CL.for m < 0 (m > 0), totally consistent with no mass variation. These stringent bounds on the mass variation are not related to the neutrino free stream ing history which may a ect the matter power spectrum on small scales. On the contrary, they are in posed by the fact that any signi cant transfer of energy between the neutrino and dark energy components would lead to an instability contradicting CMB and large scale structure data on the largest observable scales.

I. IN TRODUCTION

Since the accelerated expansion of the universe was rst observed with Type Ia supernovae (SN) [1, 2], the case for a cosm ological constant-like uid that dom inates the energy density of the universe has become stronger and is well established by now with the new pieces of data gathered [3].

Several candidates for the accelerating component of the universe, generically dubbed dark energy (DE), have been proposed [3, 4, 5, 6], but understanding them theoretically and observationally has proven to be challenging. On the theoretical side, explaining the small value of (10³ the observed dark energy density component, eV)⁴, as well as the fact that both dark energy and m atter densities contribute signi cantly to the energy budget of the present universe requires in general a strong ne tuning on the overall scale of the dark energy models. In the case in which the dark energy is assumed to be a scalar eld slowly rolling down its at potential V (), the so-called quintessence models [7], the e ective mass of the eld has to be taken of the order $= id^2 V$ ()= $d^2 \frac{1}{2} = 2$ 10³³ eV for elds with vacm uum expectation values of the order of the Planck mass.

On the observational side, choosing among the dark energy models is a complicated task [8]. Most of them can m in ic a cosm obgical constant at late times (that is, an equation of state w p = = 1) p], and all data until now are perfectly consistent with this limit. In this sense, boking for di erent in prints that could favor the existence of a particular model of dark energy is a path worth taking.

Our goal in this paper consists in understanding whether the so-called M ass-Varying N eutrinos (M aVaN s) scenario [10,11,12,13,14] could be constrained not only via the dark energy e ects, but also by indirect signs of the neutrino m ass variation during cosm ological evolution, since neutrinos play a key role in several epochs [15,16]. An indication of the variation of the neutrino m ass would certainly tend to favor this m odels (at least on a theoretical basis) with respect to m ost DE m odels. One should keep in m ind that M aVaN s scenarios can su er from stability issues for the neutrino perturbations [17], although there is a wide class of m odels and couplings that avoid this problem [18,19,20,21,22].

Sim ilar analyses have been m ade in the past, but they have either assum ed particular m odels for the interaction between the neutrinos and the DE eld [23, 24, 25], or chosen a param eterization that does not re ect the richness of the possible behavior of the neutrino m ass variations [26].

In order to be able to deal with a large number of m odels, instead of focusing on a particular m odel for the coupling between the DE eld and the neutrino sector, we choose to param eterize the neutrino m ass variation to place general and robust constraints on the M aVaN s scenario. In this sense, our work com plem ents previous analyses by assuming a realistic and generic param eterization for the neutrino m ass, designed in such a way to probe alm ost all the di erent regim es and m odels within the same fram ew ork. In particular, our param eterization allows for fast and slow m ass transitions between two values of the neutrino m ass, and it takes into account that the neutrino m ass variation should start when the coupled neutrinos change their behavior from relativistic to nonrelativistic species. We can m in ic di erent neutrino-dark energy couplings and allow for alm ost any m onotonic behavior in the neutrino m ass, placing reliable constraints on this scenario in a m odel independent way.

O urwork is organized as follows: in Section II we give a brief review of the M aVaNs scenario and its main equations. In Section III we present our parameterization with the results for the background and the perturbation equations obtained within this context. The results of our comparison of the numerical results with the data and the discussion of its main in plications are shown in section IV. Finally, in section V the main conclusions and possible future directions are discussed.

II. MASS-VARYING NEUTRINOS

In what follows, we consider a hom ogeneous and isotropic universe with a Robertson-Walker at metric, $ds^2 = a^2 d^2 + dr^2 + r^2 d^2$, where is the conformal time, that can be written in terms of the cosm ic time t and scale factor a as d = dt=a, in natural units (~ = c = k_B = 1). In this case, the Friedmann equations read

where the dot denotes a derivative with respect to conform al time, and the reduced Planck mass is $m_p = 1 = \frac{P}{8} = 2.436 = 10^{18} \text{ GeV}$. As usual, and p correspond to the total energy density and pressure of the cosm ic uid, respectively. The neutrino mass in the models we are interested in is a function of the scalar eld that plays the role of the dark energy, and can be written as

where M is a constant and di erent models are represented by distinct f().

The uid equation of the neutrino species can be directly obtained from the Boltzm ann equation for its distribution function [24],

where () = d ln [m ()]=d takes into account the variation of the neutrino m ass, and w_x = p_x = $_x$ is the equation of state of the species x. For com pleteness and later use, we will de ne $_{x0}$ = $_x$ = $_{c0}$, the standard density parameter, where the current critical density is given by $_{c0}$ = $_{3H}^2_{0}m_p^2$ = $8:099 h^2$ 10 ¹¹ eV⁴ and H₀ = 100 h km s ¹ M pc ¹ is the Hubble constant.

Since the total energy m om entum tensor is conserved, the dark energy uid equation also presents an extra right-hand side term proportional to the neutrino energy m om entum tensor trace, $T_{()} = (3p)$, and can be written as

For a hom ogeneous and isotropic scalar eld, the energy density and pressure are given by

and both equations lead to the standard cosm ological K lein-G ordon equation for an interacting scalar eld, namely,

From the above equations one sees that, given a potential V() for the scalar eld and a eld-dependent mass term m () for the neutrino mass, the coupled system given by equations (1), (4), and (7), together with the uid equations for the baryonic matter, cold dark matter and radiation (photons and other massless species) can be num erically solved [24]. Notice that a similar approach has been used for a possible variation of the dark matter mass [27] and its possible interaction with the dark energy [28, 29], with several interesting phenom enological ram i cations [30, 31, 32, 33, 34, 35].

Following [31, 33], equations (4) and (5) can be rewritten in the standard form ,

The elective equation of state can be understood in terms of the dilution of the energy density of the species. In the standard noncoupled case, the energy density of a uid with a given constant equation of state w scales as $/ a ^{3(1+w)}$. However, in the case of interacting uids, one should also take into account the energy transfer between them, and the energy density in this case will be given by

where the index 0 denotes the current value of a param eter, and the redshift z is de ned by the expansion of the scale factor, $a = a_0 (1 + z)^{-1}$ (in the rest of this work we will assume $a_0 = 1$). For a constant elective equation of state one obtains the standard result, / $a^{-3(1+w^{(eff)})}$, as expected.

Notice that this m ism atch between the e ective and standard DE equations of state could be responsible for the \phantom behavior" suggested by supernovae data when tting it using a cosm ological model with noninteracting components [33]. This e ect could be observable if dark energy was coupled to the dom inant dark matter component. For the models discussed here, how ever, it cannot be signi cant: the neutrino fraction today ($_{0}=_{0}$ 10²) is too small to induce an \e ective phantom -like" behavior.

As we commented before, the analysis until now dealt mainly with particular models, that is, with particular functional form s of the dark energy potential V () and eld dependence of the neutrino mass (). A noticeable exception is the analysis of R ef. [26], in which the authors use a param eterization for the neutrino m ass a la C hevallier-Polarski-Linder (CPL) [9, 36, 37]: m (a) = m $_0+m_1(1 a)$. How ever, although the CPL parameterization works well for the dark energy equation of state, it cannot reproduce the main features of the mass variation in the case of variable mass particle models. In the case of the models discussed here, for instance, the mass variation is related to the relativistic/nonrelativistic nature of the coupled neutrino species. With a CPL mass parameterization, the transition from m_1 to m_0 always takes place around z 1, which is in fact only com patible with masses as small as 10 $^3\,$ eV . Hence, the CPL m ass param eterization is not suited for a self-consistent exploration of all interesting possibilites.

O ne of the goals in this paper is to propose and test a param eterization that allows for a realistic simulation of m ass-varying scenarios in a model independent way, with the minimum possible number of param eters, as explained in the next section.

III. MODEL INDEPENDENT APPROACH

A. Background equations

A susual, the neutrino energy density and pressure are given in terms of the zero order Ferm i-D irac distribution function by

where q = ap denotes the modulus of the com oving momentum $q_i = qn_i$ ($^{ij}n_in_j = 1$), g corresponds to the number of neutrino degrees of freedom, and T₀ is the present neutrino background temperature. Notice that in the neutrino distribution function we have used the fact that the neutrinos decouple very early in the history of the universe while they are relativistic, and therefore their equilibrium distribution depends on the com oving

m om entum, but not on the mass [16]. In what follows we have neglected the small spectral distortions arising from non-instantaneous neutrino decoupling [38]. Thus, the neutrino energy density and pressure are given by

where $^2 = q^2 + m^2 (a)a^2$ (assuming that m depends only on the scale factor). Taking the time-derivative of the energy density, one can then obtain the uid equation for the neutrinos,

where u $\ln a = \ln(1 + z)$ is the number of e-folds counted back from today. Due to the conservation of the total energy momentum tensor, the dark energy uid equation is then given by

W e can write the e ective equations of state, de ned in eqs. (8), as

The above results only assume that the neutrino mass depends on the scale factor a, and up to this point, we have not chosen any particular parameterization. Concerning the particle physics models, it is important to notice that starting from a value of w and a function m (a) one could, at least in principle, reconstruct the scalar potential and the scalar interaction w ith neutrinos following an approach similar to the one in R ef. [39].

B. M ass variation param eters

Some of the main features of the M aVaN s scenario are: (i) that the dark energy eld gets kicked and m oves aw ay from its minimum (ifm > H) or from its previous slow – rolling trajectory (if m < H) when the neutrinos become non-relativistic, very m uch like the case when it is coupled to the full matter content of the universe in the so-called cham eleon scenarios [40]; and (ii) that as a consequence, the coupling with the scalar eld generates a neutrino m ass variation at that time. A ny param eterization that intends to m in ic scalar eld m odels interacting with a m ass-varying particle (neutrinos, in our case) for the large redshift range to which the data is sensitive should at least take into account those characteristics. M oreover, the variation of the mass in most models (see [24], for instance) can be well approximated by a transition between two periods: an earlier one, in which the mass is given by m₁, and the present epoch, in which the mass is given by m₀ (we will not consider here models in which the neutrino mass behavior is nonmonotonic). The transition for this param eterization, as mentioned before, starts when neutrinos become nonrelativistic, which corresponds approximately to

where m $_1$ corresponds to the m ass of the neutrino during the period in which it is a relativistic species. Before $z_{\rm N\,R}$ we can treat the neutrino m ass as essentially constant, since the right-hand side (RHS) of the uid equation is negligible compared to the left-hand side (LHS), and therefore there is no observable signature of a possible m ass variation.

W hen the neutrinos become nonrelativistic, the RHS of the DE and neutrino uid equations becomes important, and the neutrino m ass starts varying. In order to m odel this variation, we use two parameters, namely the current neutrino m ass, m₀, and , a quantity related to the amount of time that it takes to complete the transition from m₁ to m₀. That behavior resembles very much the parameterization of the dark energy equation of state discussed in [41], except for the fact that in our case the transition for the mass can be very slow, taking several e-folds to complete, and m ust be triggered by the time of the nonrelativistic transition, given by equation (17). Dening f = $[1 + e^{[u(1+)]u_{NR}]} = 1^{-1}$ and f = $[1 + e^{u_{NR}}]^{-1}$ we can use the form

Starting at $u_{NR} = \ln(1 + z_{NR})$, the function $(u; u_{NR};)$ decreases from 1 to 0, with a velocity that depends on . The top panel in Figure 1 gives the behavior of eq. (18) with di erent param eters; the bottom panels shows that in this param etrization, the derivative of the mass with respect to e-fold number resembles a Gaussian function. The peak of the quantity dm =du occurs at the value $u = u_{NR} = (1 +)$; hence, for 1, the mass variation takes place in mediately after the nonrelativistic transition (u ' u_{NR}) and lasts a fraction of e-folds (roughly, 3 e-folds); for 1 ju_{NR} j the variation is smooth and centered on some intermediate redshift between z_{NR} and 0; while for $j_{1}N_{R}j$, the

transition is still on-going today, and the present epoch roughly coincides with the maximum variation.

A lthough the functional form of ,eq. (19), seem s com – plicated, one should note that it is one of the sim plest form s satisfying our requirem ents with a minimal num – ber of parameters. An exam ple that could look sim pler, but that for practical purposes is not, would be to assume that the two plateaus are linked together by a straight line. In this case, we would need a parameterization of the form

where u_{end} corresponds to the chosen redshift in which the transition stops. Notice that in this case not only we still have three parameters to describe the mass variation, but also the function is not smoooth. Moreover, the derivative of the mass with respect to u gives a tophat-like function which is discontinuous at both u_{NR} and u_{end} . In this sense, it seem ed to us that equation (18) would give us the best \price-to-earnings ratio" am ong the possibilities to use phenom enologically m otivated param eterizations for the mass-varying neutrinos, although certainly there could be similar proposals equally viable, such as for instance the possibility of adapting for the mass variation the param eterization used for the dark energy equation of state in [42, 43]. There, the transition between two constant values of the equation of state exhibits a tanh [$_t(u = u_t)$] dependence, where $_t$ is responsible for the duration of the transition and u_t is related to its half-way point.

In the rest of our analysis, we will use a couple of extra assumptions that need to be taken into account when going through our results. First, we will consider that only one of the three neutrino species is interacting with the dark energy eld, that is, only one of them ass eigenstates has a variable mass. The reason for this approximation is twofold: it is a simpler case (compared to the case with 3 varying-mass neutrinos), since instead of 6 extra parameters with respect to the case of constant mass, we have only 2, namely the early mass of the neutrino whose mass is varying, m₁, and the velocity of the transition, related to \cdot .

Besides sim plicity, the current choice is the only one allowed presently in the case in which neutrinos were heavier in the past. Indeed, we expect our stronger constraints to come from those scenarios, especially if the neutrino species behaves as a nonrelativistic com ponent at the time of radiation-matter equality, given 4:05 10 ($_{c0}h^2 + _{b0}h^2$)=(1 + 0:23N_e) by 1 + z_{ea} (here the indexes c and b stand for cold dark matter and baryons, respectively, and N $_{\rm e}$ is the e ective num ber of relativistic neutrinos). Taking the three neutrino species to be nonrelativistic at equality would change signi cantly the value of z_{eq} , contradicting CMB data (according to W MAP5, $1 + z_{eq} = 3141^{+154}_{157}$ (68% C L.) [44]). Instead, a single neutrino species is still marginally allowed to be non-relativistic at that time.

To sim plify the analysis, we also assumed that the dark energy eld, when not interacting with the neutrinos, reached already the so-called scaling solution (see, e.g., [4] and references therein), i.e., the dark energy equation of state w in eq. (15) is constant in the absence of interaction. Notice how ever that when the neutrinos become e non-relativistic the dark energy uid receives the analogous of the cham eleon kicks we mentioned before, and the dark energy e ective equation of state, eq. (16), does vary for this period in a consistent way.

The upper panel of Figure 2 shows how the density parameters of the di erent components of the universe evolve in time, in a typical M aVaN s m odel. The lower panel displays a comparison between m ass-varying and constant m assmodels, in particular during the transition from m_1 to m_0 . A s one would expect, far from the time of the transition, the densities evolve as they would do in the constant m ass case.

C. Perturbation equations

The next step is to calculate the cosm ological perturbation equations and their evolution using this param eterization. We chose to work in the synchronous gauge, and our conventions follow the ones by M a and Bertschinger [45]. In this case, the perturbed metric is given by

Since the neutrino phase space distribution [45] can be written as f $x^i;q;n_j; = f^0(q) \ 1 + x^i;q;n_j;$, one can show that the rst order Boltzm ann equation for a massive neutrino species, after Fourier transform ation, is given by [24, 25]

where and h are the synchronous potentials in the Fourier space. Notice that the perturbed neutrino energy density and pressure are also going to be modied due to the interaction, and are written as

This extra term comes from the fact that the comoving energy depends on the dark energy density, leading to an extra-term which is proportional to $\ .$

M or eover, if we expand the perturbation (k;q;n;) in a Legendre series [45], the neutrino hierarchy equations will read,

For the dark energy, we use the $\$ uid approach" [46] (see also [47, 48, 49]), so that the density and velocity perturbations are given by,

where the dark energy anisotropic stress is assumed to be zero [50], and the sound speed c^2 is de ned in the fram e comoving with the dark energy uid [51]. So, in the synchronous gauge, the quantity c^2 p= is related to c^2 through

IV. RESULTS AND DISCUSSION

A . Num erical approach

Equipped with the background and perturbation equations, we can study this scenario by modifying the num erical packages that evaluate the CMB anisotropies and the matter power spectrum. In particular, we modi ed the

CAM B code¹ [52], based on CM BFast² [53] routines. We use Cosm oM C³ [54] in order to sam ple the parameter space of our model with a M arkov Chain M onte Carlo (M CM C) technique.

W e assume a at universe, with a constant equation of state dark energy uid, cold dark matter, 2 species of m assless neutrinos plus a massive one, and ten free param eters. Six of them are the standard CDM param eters, namely, the physical baryon density $_{b0}h^2$, the physical cold dark matter density $_{c0}h^2$, the dimensionless Hubble constant h, the optical depth to reionization $_{reion}$, the am plitude (A_s) and spectral index (n_s) of primordial density uctuations. In addition, we vary the constant dark energy equation of state param eterw and the three param eters accounting for the neutrino mass: the present mass m₀, the logarithm of the param eter related to the duration of the transition, and the logarithm of the parameter related to the duration of the transition, and the logarithm of the parameter of the standard the logarithm.

rithm of the ratio of the modulus of the mass di erence over the current mass, log , where we de ne

All these parameters take implicit at priors in the regions in which they are allowed to vary (see Table I).

C oncerning the last parameter, notice that we choose to divide the parameter space between two regions: one in which the mass is decreasing over time ($_+$) and one in which it is increasing (). We chose to make this separation because the impact on cosmological observables is di erent in each regime, as we will discuss later, and by analyzing this regions separately we can gain a better insight of the physics driving the constraints in each one of them. Moreover, we do not allow for models with w < 1, since we are only considering scalar eld models with standard kinetic term s.

For given values of all these parameters, our modied version of CAMB rst integrates the background equations backward in time, in order to nd the initial value of leading to the correct dark energy density today. This problem does not always admit a solution leading

to well-behaved perturbations: the dark energy perturbation equations (28), (29) become singular whenever one of the two quantities, or [1+ (1 3w)], appearing in the denom inators vanishes. As we shall see later, in the case in which the neutrino mass decreases, the background evolution is compatible with cases in which the dark energy density crosses zero, while the second term can never vanish. We exclude singular models by stopping the execution of CAMB whenever < 0, and giving a negligible probability to these models in Cosm oM C. The physical interpretation of these pathologicalm odels will be explained in the next sections. For otherm odels, CAMB integrates the full perturbation equations, and passes the CMB and matter power spectra to Cosm oMC for com parison with the data.

We constrain this scenario using CMB data (from WMAP 5yr [44, 55], VSA [56], CBI [57] and ACBAR [58]); matter power spectrum from large scale structure (LSS) data (2dFGRS [59] and SDSS [60]); supernovae Ia (SN) data from [61], and the HST Key project measurements of the Hubble constant [62]⁴.

Once the posterior probability of all ten parameters has been obtained, we can marginalize over all but one or two of them, to obtain one-or two-dimensional probability distributions. We veried that the condence lim - its on the usual six parameters do not dier signicantly from what is obtained in the \vanilla model" [44], and

therefore we only provide the results for the extra neutrino and dark energy parameters (Figures 7, 6, 4, 3, and Table II).

B. Increasing neutrino m ass

In this model, the background evolution of the dark energy component obeys to equation (15), which reads after division by :

where the two positive quantities $_{\rm d}$ and $_{\rm i}$ represent respectively the dilution rate and interaction rate of the dark energy density. For any parameter choice, can only decrease with time, so that the integration of the dark energy background equation backward in time always nd well-behaved solutions with positive values of

. M oreover, the quantity [1 + (1 3w)] appearing in the denom inator of the dark energy perturbation equations is equal to the contribution of the dilution rate to the total energy loss rate, d = (d + i). This quantity is by construction greater than zero, and the dark energy equations cannot becom e singular. However, when the the interaction rate becom es very large with respect to the dilution rate, this denom inator can becom e arbitrarily close to zero. Then, the dark energy perturbations can be enhanced considerably, distorting the observable spectra and con icting the data. A ctually, this am pli cation mechanism is well-known and was studied by various authors [20, 64, 65]. It was found to a ect the largest wavelengths rst, and is usually referred as the large scale instability of coupled dark energy models. The condition for avoiding this instability can be thought to be roughly of the form

where A is some number depending on the cosm ological parameters and on the data set (since a given data set tells how constrained is the large scale instability, i.e. how small can be the denom inator $[1 + (1 \quad 3w)]$, i.e. how small should the interaction rate remain with respect to the dilution rate). The perturbations are am – pli ed when the denom inator is much smaller than one, so A should be a number much greater than one. In-tuitively, the condition (39) will lead to the rejection of models with small values of (w ,) and large values of

. Indeed, the interaction rate is too large when the mass variation is signi cant (large) and rapid (sm all). The dilution rate is too sm all when w is sm all (close to the cosm ological constant lim it). Because of that, it seems that when the dark energy equation of state is allowed to vary one can obtain a larger num ber of viable models if w > 0.8 early on in the cosm ological evolution [66, 67].

W e ran Cosm oM C with our fulldata set in order to see how much this mass-varying scenario can depart from a standard cosm ological model with a xed dark energy equation of state and massive neutrinos. In our param eter basis, this standard model corresponds to the lim it 1, with whatever value of log. The ob-<u>loa</u> ! servational signature of a neutrino m ass variation during dark energy or matter domination is encoded in wellknown e ects, such as: (i) a modi cation of the smallscale matter power spectrum [due to a dierent freestream ing history], or (ii) a change in the time of matter/radiation equality [due to a di erent correspondence between the values of $(!_{b}, !_{m}, !)$ today and the actual matter density at the time of equality]. On top of that, the neutrino and dark energy perturbations can approach the regime of large-scale instability discussed above.

Our nal results - namely, the marginalized 1D and 2D parameter probabilities - are shown in gures 3 and 4. The shape of the contours in (log ; log) space is easily understandable with analytic approximations. The necessary condition (33) for avoiding the large-scale instability reads in terms of our model parameters

where we expressed the mass variation as

Two limits can be clearly seen from this equations. For

This corresponds to the diagonal lim it in the lower half of the right upper panel of gure 4. In fact, the appearance of the large-scale instability is seen in models localized at the edge of the allowed region, as shown in gure 5.

In the opposite case of a very slow transition, 1, it is clear from eq. (34) that the lim it on should be independent on ,

This lim it corresponds to the almost vertical cut in the upper part of the plane (log ; log) (upper right panel, g. 4).

These conditions are easier to satisfy when at the time of the transition, (1 + w) is large. So, in order to avoid the instability, large values of w are preferred. However, it is well-known that cosm obgical observables (lum inosity distance relation, CMB and LSS power spectra) better t the data for w close to 1 (cosm ological constant limit). In the present model, the role of the large-scale instability is to push the best-t value from -1 to -0.96, but w = 1 is still allowed at the 68% C L.

The main result of this section is that the variation of the neutrino mass is bounded to be small, not so much because of the constraining power of large-scale structure observations in the regime where neutrino free stream ing is im portant (i.e., small scales), but by CMB and LSS data on the largest scales, which provide limits on the possible instability in DE and neutrino perturbations.

Indeed, for the allowed models, the mass variation could be at most of order 10% for masses around 0:05 eV, and less than 1% for masses larger than 0:3 eV: this is undetectable with small scale clustering data, showing that the limit really comes from large scales. W ith those results, we conclude that there is no evidence for a neutrino mass variation coming from the present data. In fact, as form ost cosm ological data analyses, the concordance CDM model remains one of the best ts to the data, lying within the 68% interval of this analysis.

Nonetheless, better constraints will possibly be obtained with forthcom ing data, especially the ones that probe patches of the cosm ological \desert" between z ' 1100 and z ' 1, like CMB weak lensing [68], and/or cross-correlations of di erent pieces of data, like CMB and galaxy-density m aps [69]. W e can estim ate, for instance, what is the favored redshift range for the neutrino mass variation according to our results. Taking $m_0 = 0:1 \text{ eV}$ and the mean likelihood values for log and $\log[m_1=m_0]$, one can see that the bulk of the mass variation takes place around z 20, a redshift that possibly will be probed by future tom ographic probes like weak lensing [70, 71] and especially 21 cm absorption lines [72, 73, 74, 75]. Those will help not only to disentangle som e degeneracies in the param eter space, but will also allow for direct probes of the neutrino mass in di erent redshift slices.

C. Decreasing neutrino m ass

In this case, the evolution rate of the dark energy density is still given by equation (32) but with an opposite sign for the interaction rate: in can be sum marized as

with $_{\rm d}$ and $_{\rm i}$ both positive. In principle, the interaction rate could overcom e the dilution rate, leading to an increase of . Hence, the integration of the dark energy evolution equation backward in time can lead to negative values of , and the prior > 0 im plemented in

our CAMB version is relevant. Still, the denom inator $[1 + (1 \quad 3w)]$ can never vanish since it is equal to $d = (d \quad i)$.

W ell before before the transition, the interaction rate is negligible and _ is always negative. W e conclude that = d ln m =d starts from small positive values and increases. If the condition

is violated during the transition, _ will cross zero and become positive. This corresponds to growing from zero to +1, and from 1 to some nite negative value. After $_{i}$ = $_{d}$ has reached its maximum, undergoes the opposite evolution. Reaching = 0 is only possible if

has a non-m onotonic evolution, i.e. if (39) is violated. However, the perturbations diverge even before reaching this singular point: when tends to in nity, it is clear from eq. (26) that the neutrino perturbation derivatives become arbitrarily large. We conclude that in thism odel, the condition (39) is a necessary condition for avoiding instabilities, but not a su cient condition: the data is expected to put a limit on the largest possible value of , which will always be reached before _ changes sign, is a hoffing the inequality (20) is estimated. Hence, the

i.e. before the inequality (39) is saturated. Hence, the condition for avoiding the instability is intuitively of the form of (33), but now with A being a number smaller than one.

We then ran C osm oM C with the full data set and obtained the marginalized 1D and 2D parameter probabilities shown in gures 6 and 7. The major dierences with respect to the increasing mass case are: a stronger bound on m₀, a much stronger bound on , and the fact that large values of are now excluded. This can be understood as follows. In order to avoid instabilities, it is necessary to satisfy the inequalities (36), (37), but with a much smaller value of A than in the increasing mass case; hence, the contours should look qualitatively similar to those obtained previously, but with stronger bounds. This turns out to be the case, although in addition, large values are now excluded. Looking at the

m ass variation for large in gure 1, we see that in this lim it the energy transfer takes place essentially at low redhsift. Hence, the interaction rate is large close to z = 0. In m any m odels, this leads to positive values of _ at the present time, to a non-m onotonic behavior of the dark energy density, and to diverging perturbations. This can only be avoided when w is large with respect to -1, i.e. when the dilution rate is enhanced. Hence, in this model, the need to avoid diverging perturbations im poses a strong parameter correlation between w and . However, values of w greater than -0.8 are not com - patible with the supernovae, CM B and LSS data set; this slices out allm odels with large .

The fact that the bound on m₀ is stronger in the decreasing mass case is also easily understandable: for the same value of the mass di erence $= jn_1 m_0 j m_0$, a given m₀ corresponds to a larger mass m₁ in the decreasing mass case. It is well-known that CMB and LSS data constrain the neutrinos mass through its background e ect, i.e. through its in pact on the time of matter/radiation equality for a given dark matter abundance today. The impact is greater when m₁ is larger, i.e. in the decreasing mass case; therefore, the bounds on m₀ are stronger.

V. CONCLUDING REMARKS

In this work we analysed som e m ass-varying neutrino scenarios in a nearly m odel independent way, using a general and well-behaved param eterization for the neutrino m ass, including variations in the dark energy density in a self-consistent way, and taking neutrino/dark energy perturbations into account.

O ur results for the background, CMB an isotropies, and matter power spectra are in agreement with previous analyses of particular scalar eld models, showing that the results obtained with this parameterization are robust and encompass the main features of the $\ensuremath{\mathsf{M}}\xspace{\,\mathsf{aVaN}}\xspace{\,\mathsf{scenario}}$.

M oreover, a com parison with cosm ological data show s that only sm allm ass variations are allow ed, and that M a-VaN s scenario are m idly disfavored with respect to the constant m ass case, especially when neutrinos become lighter as the universe expands. In both cases, neutrinos can change signi cantly the evolution of the dark energy density, leading to instabilities in the dark energy and/or neutrino perturbations when the transfer of energy between the two components per unit of time is too large. T hese instabilities can only be avoided when the m ass varies by a very sm all am ount, especially in the case of a decreasing neutrino m ass. Even in the case of increasing m ass, constraining better them odelw ith forthcom ing data will be a di cult task, since it m in ics a m assless neutrino scenario for m ost of the cosm ological tim e.

O ne should keep in m ind that our analysis assum es a constant equation of state for dark energy and a m onotonic behavior for the m ass variation. Even though those features are present in m ost of the sim plest possible m odels, m ore com plicated m odels surely can evade the constraints we obtained in our analysis.

F inally, those constraints will improve with forthcom – ing tom ographic data. If any of the future probes indicate a m ism atch in the values of the neutrino m ass at di erent redshifts, we could arguably have a case m ade for the m ass-varying m odels.
