N onlinear Supersymmetry, Brane-bulk Interactions and Super-Higgs without Gravity

A bstract

We derive the coupling of a hypermultiplet of N = 2 global supersym – metry to the D irac-Bom-Infeld M axwell theory with linear N = 1 and a second nonlinear supersymmetry. At the level of global supersymmetry, this construction corresponds to the interaction with M axwell brane elds of bulk hypermultiplets, such as the universal dilaton of type IIB strings compactified on a Calabi-Yau manifold. It displays in particular the active role of a four-form eld. Constrained N = 1 and N = 2 super elds and the formulation of the hypermultiplet in its single-tensor version are used to derive the nonlinear realization, allowing a fully o -shell description. Exact results with explicit symmetries and supersymmetries are then obtained. The electric-magnetic dual version of the theory is also derived and the gauge structure of the interaction is exemplied with N = 2 non-linear QED of a charged hypermultiplet. Its Higgs phase describes a novel super-Higgs mechanism without gravity, where the goldstino is combined with half of the hypermultiplet into an N = 1 massive vector multiplet.

1 Introduction

It is notorious that (linear) N = 2 supersym m etry, globalor local, forbids a dependence on hypermultiplet scalars of gauge kinetic term s. For instance, in N = 2 supergravity, the scalar manifold is the product of a quaternion-K ahler (E instein) manifold, for hypermultiplet scalars [1], and a K ahler manifold of a special type for vector multiplet scalars [2]. In global N = 2 supersymmetry, the quaternion-K ahler manifold of hypermultiplet scalars is replaced by a R icci- at hyperkahler space [3].

If how ever (at least) one of the supersymmetries is nonlinearly realized, these restrictions on the action are expected to change. For instance, string theory indicates that the D irac-B om-Infeld (D B I) Lagrangian describing kinetic terms of brane gauge elds m ay interact with the dilaton and with its hypermultiplet partners. M oreover, if the dilaton supermultiplet is formulated with one or two antisymmetric tensors, m ore involved interactions dictated by the gauge symmetries of the theory are certainly allowed. An interesting problem is then to construct an interaction Lagrangian in which, when the second supersymmetry turns nonlinear, both the DBI Lagrangian and its necessary dilaton dependence are simultaneously generated. In other words, if we consider a theory with a broken, nonlinear supersymmetry realized in a goldstino mode, another unbroken linear supersymmetry and a DBI super-M axwell system coupled to hypermultiplet elds, we certainly expect that the allowed Lagrangians are severely restricted. A nalyzing these restrictions is the main motivation of this paper.

In this work, we construct an action invariant under N = 2 global supersymmetry, one of them being nonlinearly realized, involving the M axwell goldstino multiplet of the nonlinear supersymmetry coupled to a single-tensor N = 2 multiplet [4, 5, 6], or equivalently to a hypermultiplet with one abelian (shift) isometry. In the absence of this multiplet, the action reduces to the standard super-M axwellDBI theory, derived in the past from the same symmetry principle [7, 8, 9]. The coupling of the two multiplets is shown to arise from a N = 2 Chem-Simons (CS) term which, under electric-m agnetic duality, amounts to shifting the gauge eld strength by the antisymmetric tensor. M oreover, under Poincare duality of the antisymmetric tensor to a pseudoscalar, the CS coupling becomes a Stuckelberg gauging of the pseudoscalar axionic symmetry.

An important property of the single-tensor multiplet is that it adm its an o-shell (superspace) formulation, unlike the generic hypermultiplet that can be formulated o - shell only at the cost of introducing in nite number of auxiliary elds in the context of harm onic superspace [10]. Thus, our form alism using the single-tensor N = 2 m ultiplet allows to construct o -shell supersymmetric Lagrangians. By an appropriate change of variables from the N = 2 single-tensor multiplet, one nds an action that couples

the goldstino vector multiplet (of the linear supersymmetry) to an N = 2 charged hypermultiplet, describing the low-energy limit of a theory with partial spontaneous supersymmetry breaking from N = 2 to N = 1 [11, 12].

The vacuum of this theory exhibits an interesting novel feature: the goldstino is 'absorbed' into a massive vector multiplet of N = 1 linear supersymmetry, leaving a massless N = 1 chiral multiplet associated to atdirections of the scalar potential. The goldstino assembles with one of the two W eyl fermions in the single-tensor multiplet to form a massive D irac spinor. A tone particular point along the atdirections, the vector multiplet becomes massless and the U (1) is restored. This phenomenon is known from D-brane dynamics, where the U (1) world-volume eld becomes generically massive due to the CS coupling. A crucial role for the invariance of the action under nonlinear supersymmetry is played by a non-dynamical four-form gauge potential, know n again from D-brane dynamics. Hence, a globally supersymmetry combination of Higgs and super-Higgs mechanisms, in the presence of a four-form eld, eliminates any massless goldstino fermion related to partial supersymmetry breaking. This interesting new mechanism can be studied in the context of nonlinear N = 2 quantum electrodynamics with one charged hypermultiplet, which after a holom orphic eld rede nition and a duality transform ation, is equivalent to our setup.

In type IIB superstrings com pacti ed to four dimensions with eight residual supercharges, the dilaton scalar (associated to the string coupling) belongs to a universal hyperm ultiplet, together with the (N eveu-Schwarz) NS {NS antisym metric tensor and the (R am ond) R {R scalar and two-form. Its natural basis is therefore a double-tensor superm ultiplet,¹ having three perturbative isom etries associated to the two axionic shifts of the antisym metric tensors and an extra shift of the R {R scalar. These isom etries form a H eisenberg algebra, which at the string tree-level is enhanced to the quaternion-K ahler and K ahler space SU (2;1)=SU (2) U (1). At the levelof global N = 2, im posing the H eisenberg algebra of isom etries determ ines a unique hyperkahler manifold of dimension four, depending on a single parameter, in close analogy with the local case of a quaternionic space where the corresponding parameter is associated to the one-loop correction [15]. This manifold is not trivially at and should describe the rigid lim it of the universal hyperm ultiplet.

The plan of the paper is as follows. In Section 2, we review the construction of the $N = 2 \sin ple$ -tensor and M axwell supermultiplets in term sof N = 1 super elds and we describe their interaction in a Chem-Sim ons term, as was earlier partly done in R ef. [9]. In addition we explain how the intricate web of gauge variations in the Stuckelberg

coupling of the M axwell and single-tensor supermultiplets leads to the interpretation of one (non-propagating) component of the single-tensor as a four-form eld. In Section 3, we reform ulate the supermultiplets in chiral N = 2 superspace and then demonstrate how this construction can be used to describe electric-m agnetic duality in a manifestly N = 2 covariant way. In Section 4, we rst review the construction of the D irac-Borm-Infeld theory from constrained N = 2 super elds describing the goldstino of one non-linear supersymmetry and then extend it to construct its coupling to a single-tensor supermultiplet, engineered by a CS term. We also perform an electrom agnetic duality to determ ine the fm agnetic' version of the theory. W Ith the dilaton hypermultiplet of type IIB superstrings in m ind, we impose the H eisenberg algebra of perturbative isometries to our theory. In Section 5, we derive the coupling of the M axwell goldstino multiplet to a charged hypermultiplet and m ake a detailed analysis of the vacuum structure of N = 2 super-QED with partial supersymmetry breaking. We conclude in Section 6 and two appendices present our conventions and the resolution of a quadratic constraint applied on a N = 2 chiral super eld.

2 The linear N = 2 M axwell-dilaton system

Our rst objective is to describe, in the context of linear N = 2 supersymmetry, the coupling of the single-tensor multiplet to N = 2 super-M axwell theory. Since these two supermultiplets admit o -shell realizations, they can be described in superspace without reference to a particular Lagrangian. G auge transform ations of the M axwell multiplet use a single-tensor multiplet, we then begin with the latter.

2.1 The single-tensor multiplet

In global N = 1 supersymmetry, a real antisymmetric tensor eld b is described by a chiral, spinorial super eld with $8_B + 8_F$ elds $[16]^2$:

Considering bosons only, the gauge transformation (2.3) eliminates three of the six components of b and the scalar eld C⁰. A coordingly, L only depends on the invariant curl h and on the invariant real scalar C. The linear L describes then $4_{B} + 4_{F}$ elds. U sing either or L, we will not two descriptions of the single-tensor multiplet of global N = 2 supersymmetry [4, 5, 6].

In the gauge-invariant description using L , the N = 2 m ultiplet is completed with a chiral super eld (8 $_{\text{B}}$ + 8 $_{\text{F}}$ elds in total). The second supersymmetry transformations (with parameter) are

where D and \overline{D} are the usual N = 1 supersymmetry derivatives verifying fD; \overline{D} g = 2i()_0. It is easily verified that the N = 2 supersymmetry algebra closes on L and .

W e m ay try to replace L by with second supersymmetry transformation = $\frac{p_1^i}{2}$, as suggested when comparing Eqs. (2.2) and (2.4). However, with super elds and only, the N = 2 algebra only closes up to a gauge transformation (2.3). This fact, and the unusual number $12_B + 12_F$ of elds, indicate that (;) is a gauge-xed version of the o-shell N = 2 multiplet. with ⁰ real, is then postulated. W e will see below that this variation is actually dictated by N = 2 supersymmetry. There exists then a gauge in which Y = 0 but in this gauge the supersymmetry algebra closes on only up to a transformation (2.3). This is analogous to the W ess-Zum ino gauge of N = 1 supersymmetry, but in our case, this particular gauge respects N = 1 supersymmetry and gauge symmetry (2.3).

Two remarks should be made at this point. Firstly, the super eld Y will play an important role in the construction of the D irac-Born-Infeld interaction with non-linear N = 2 supersymmetry. A swew ill see later on⁴, it includes a four-index antisymmetric tensor eld in its highest component. Secondly, a constant ({independent}) background value h ibreaks the second supersymmetry only, $= \frac{pi}{2}h i + :::$ It is a natural source of partial supersymmetry breaking in the single-tensor multiplet. Notice that the condition h i = 0 is equivalent to \overline{D} (D \overline{D}) = 0.

A n invariant kinetic action for the gauge-invariant single-tensor multiplet involves an arbitrary function solution of the three-dimensional Laplace equation (for the variables L, and) [5]:

In the dual hypermultiplet formulation the Laplace equation is replaced by a M onge-Am pere equation. We will often insist on theories with axionic shift symmetry = ic (c real), dual to a double-tensor theory. In this case, H is a function of L and + so that the general solution of Laplace equation is

2.2 The Maxwell multiplet, Fayet-Iliopoulos terms

with real parameters $_1$, $_2$ and a. They may generate background values of the auxiliary components f_X and d_2 of X and V_2 which in general break both supersymmetries:

The Maxwell multiplet with super elds (X ;W) and the single-tensor multiplet (Y; ;) have a simple interpretation in terms of chiral super elds on N = 2 superspace. W e will use this form alism to construct their interacting Lagrangians in Section 3.

2.3 The Chern-Sim ons interaction

W ith a M axwell eld F = 2 @[A] (in W) and an antisymmetric tensor b (in or L), one may expect the presence of a b^F interaction

This equality suggests that its N = 2 supersymmetric extension also exists in two forms: either as an integral over chiral superspace of an expression depending on , W, X, and Y, or as a real expression using L, + , V₁ and V₂.

In the 'real' formulation, the $N = 2 C hern-Sim ons term is^{8}$

with a real coupling constant g. It is invariant (up to a derivative) under the gauge transform ations (2.10) of V_1 and V_2 with L and left inert. Notice that the introduction

of Fayet-Iliopoulos terms for V_1 and V_2 corresponds respectively to the shifts + + ____1=g and L ! L __2=g in the Chern-Sim ons term.

The 'chiral' version uses the spinorial prepotential instead of L. Turning expression (2.18) into a chiral integral and using $X = \frac{1}{2}\overline{DD}V_1$ leads to

The consistent Lagrangian for the M axwell single tensor system with Chem-Sim ons interaction is then

The rst two contributions include the kinetic term s and self-interactions of the multiplets while the third describes how they interact. Each of the three term s is separately N = 2 supersymmetric.

Using a N = 1 duality, a linear multiplet can be transformed into a chiral supered with constant shift symmetry and the opposite transformation of course exists. Hence, performing both transformations, a single-tensor multiplet Lagrangian (L;) with constant shift symmetry of the chiral has a 'double-dual' second version. Suppose that we start with a Lagrangian where M axwell gauge symmetry acts as a Stuckelberg gauging of the single-tensor multiplet:⁹

The dual theory is then the sum of the ungauged Lagrangian (2.7) and of the Chem-Sim ons coupling (2.18). This single-tensor { single-tensor duality is actually N = 2 covariant: if H solves Laplace equation, so does H, and every intermediate step of the duality transform ation can be form ulated with explicit $N = 2 \circ -$ shell supersymmetry.

We have then found two classes of couplings of Maxwell theory to the single-tensor multiplet. Firstly, using the supersymmetric extension of the b ^ F coupling, as in Eqs. (2.20). Secondly, using a Stuckelberg gauging (2.21) of the single-tensor kinetic terms. The rst version only is directly appropriate to perform an electric-magnetic duality transformation. However, since the second version can always be turned into the rst one by a single-tensor { single-tensor duality, electric-magnetic duality of the second version requires this preliminary step: both theories have the same 'magnetic' dual.

2.4 The signi cance of V_1 , X and Y

In the description of the N = 2 M axwell multiplet in terms of two N = 1 real supereds, V₂ describes as usual the gauge potential A, a gaugino and a real auxiliary edd d₂ (in W ess-Zum ino gauge). We wish to clarify the signi cance and the edd content of the super edds V₁ and X = $\frac{1}{2}\overline{D}DV_1$, as well as the related content of the chiral super edd Y used in the description in terms of the spinorial potential of the single-tensor multiplet (Y; ;).

The vector super eld V_1 has the N = 2 M axwell gauge variation $_{U(1)}V_1 = \cdot$, with a real linear parameter super eld \cdot . In analogy with the W ess-Zum ino gauge commonly applied to V_2 , there exists then a gauge where

is the gauge-invariant curl of A \cdot . It follows that the eld content (in Wess-Zum ino gauge) of V₁ is the second gaugino $_X$, the complex scalar of the Maxwellmultiplet x, a real auxiliary eld d₁ and the three-form eld A , which corresponds to a single, non-propagating component eld. The gauge-invariant chiral X includes the four-form curvature F \cdot .

3 ChiralN = 2 superspace

M any results of the previous section can be reform ulated in terms of chiral super elds on N = 2 superspace. We now turn to a discussion of this framework, including an explicitly N = 2 covariant form ulation of electric-m agnetic duality.

4 Nonlinear N = 2 supersymmetry and the DBI action

In the previous sections, we have developed various aspects of the coupling of a M axwell multiplet to a single-tensor multiplet in linear N = 2 supersymmetry. W ith these tools, we can now address ourmain subject: show how a D irac-B orn-Infeld Lagrangian (D B I) coupled to the single-tensor multiplet arises from non-linearization of the second supersymmetry.

It has been observed that the DBIL agrangian with nonlinear second supersymmetry can be derived by solving a constraint invariant under N = 2 supersymmetry imposed on the super-M axwell theory [7,8]. We start with a summary of this result, following mostly Rocek and T seytlin [8], and we then generalize the method to incorporate the elds of the single-tensor multiplet.

4.1 The N = 2 super-M axwell D B I theory

The deform ed second supersymmetry variations $_{deformed}$ act on W as the usual variations act on the shifted super eld W $\frac{1}{2}$ ~~. In fact, this super eld transforms like a chiral N = 2 super eld (3.3) with Z = X, ! = iW verifying the Bianchi identity and with $_{Z}$ = i=. The latter background value of $_{Z}$ may be viewed as the source of the partial breaking of linear supersymmetry.

Hence, the scale parameter introduced in the nonlinear constraint (4.1) appears as the scale parameter of the DBIL agrangian and also as the order parameter of partial supersymmetry breaking. The Fayet-Iliopoulos term (4.4) has in principle an arbitrary coecient $_1=4$, as in Eq. (2.17). We have chosen $_1 = ^1$ to canonically normalize gauge kinetic terms.

The DBI Lagrangian is invariant under electric-m agnetic duality.¹⁵ In our N = 2 case, the invariance is easily established in the language of N = 2 superspace. We rst

The same mass is acquired by the U (1) gauge eld coupled to the antisymmetric tensor b, and by the goldstino (the U (1) gaugino in W) that forms a D irac spinor with the ferm ion of the linear multiplet. In other words, the Chem-Simons coupling W pairs the M axwell goldstino with the linear multiplet to form a massive vector, while the chiral multiplet remains massless with no superpotential.

At hC i = hR e i = 0, gauge kinetic term s are canonically norm alized if $_1 = 1$. The M axwell D B I theory (4.4) is of course recovered when the Chern-Sim ons interaction decouples with g = 0. The phenom enon described above provides a rst instance of a super-H iggs m echanism without gravity: the nonlinear goldstino multiplet is 'absorbed' by the linear multiplet to form a massive vector N = 1 super eld. One may wonder how this can happen without gravity; norm ally one expects that the goldstino can be absorbed only by the gravitino in local supersymm etry. The reason of this novel mechanism is that the goldstino sits in the same multiplet of the linear supersymm etry as a gauge eld which has a Chem-Sim ons interaction with the tensor multiplet. This will become clearer in Section 5, where we will show by a change of variables that this coupling is equivalent to an ordinary gauge interaction with a charged hypermultiplet, providing non derivative gauge couplings to the goldstino. A ctually, this particular super-H iggs mechanism is an explicit realization of a phenom enon known in string theory where the U (1) eld of the D-brane world-volum e becomes in general massive due to a Chem-Sim ons interaction with the R {R antisymmetric tensor of a bulk hypermultiplet.¹⁹

We have chosen a description in terms of the single-tensor multiplet because it admits an o -shell formulation welladapted to our problem . Our DBIL agrangian (4.9),

To establish the connection of the general form alism described in the previous subsections with string theory, we would like to identify the double-tensor multiplet with the universal dilaton hypermultiplet and study its coupling to the M axwell goldstino multiplet of a single D-brane, in the rigid (globally-supersymmetric) limit. To this end, we transform the N = 2 double-tensor into a single-tensor representation by dualizing one of its two N = 1 linear multiplet components L^0 , containing the R {R elds C and C ⁽⁰⁾, into a chiral basis + \cdot . In this basis, the two R {R isometries correspond to constant complex shifts of the N = 1 super eld \cdot . Imposing this symmetry to the kinetic function of Eqs. (2.7){(2.8), one obtains (up to total derivatives, after superspace integration):

We expect that this action describes the globally-supersymmetric limit of the elective four-dimensional action of a D-brane coupled to the universal dilaton hypermultiplet of the perturbative type II string. A smentioned previously, its general form in the local case depends also on two constant parameters, upon imposing the perturbative H eisenberg isometries, that correspond to the tree and one-loop contributions [15]. It is tempting to identify these two parameters with and of our action. Moreover, by identifying the two antisymmetric tensors b and b⁰ with the respective NS {NS B and R {R C and the combination C⁰=(C +) with the R {R scalar C⁽⁰⁾, as the H eisenberg transformations indicate, one nds that the two actions match up to normalization factors depending on the NS {NS dilaton that should correspond to the scalar C. Finding the precise identi cations, which certainly depend on the way one should take the rigid limit that decouples gravity, is an interesting question beyond our present analysis restricted to global supersymmetry.

5 Nonlinear N = 2 Q E D

W e will now show that the e ective theory presented above describing a super-H iggs phenom enon of partial (global) supersymmetry breaking can be identied with the H iggs phase of nonlinear N = 2 QED, up to an appropriate choice of the single-tensor multiplet kinetic terms. We will then analyze its vacuum structure in the generally allowed parameter space.

In linear N = 2 quantum electrodynamics (QED), the Lagrangian couples a hypermultiplet with two chiral super elds (Q₁;Q₂) to the vector multiplet (V₁;V₂) or (X;W). The U(1) gauge transform ations of the hypermultiplet are linear, and Q₁ and Q₂ have opposite U(1) charges:

The dual single-tensor QED theory has o -shell N = 2 invariance (the Laplace equation (2.7) is veried) and the two multiplets are now coupled by a N = 2 Chem-Sim ons interaction (2.19). The rst condition is the usual D {term equation $hd_2i = 0$ for the M axwell super eld. The second condition is necessary to have a well-de ned DBI gauge kinetic term at the m inimum. Hence, if m = 0, conditions (5.67), which can always be solved, de ne the vacuum of the theory.  $\frac{p_1^2}{2}$ + :::, has been absorbed in the massive U (1) gauge boson multiplet. This is possible only because the second supersymmetry transformation of the four-formed compensates the gaugino nonlinear variation. The fermion

is massless and corresponds to the ferm ion of the chiral super eld in the single-tensor form alism, in agreem ent with our analysis in Section 4.2 [see below Eq. (4.16)]. With two real scalars, it belongs to a massless N = 1 chiral multiplet.

If $m \notin 0$, a supersymmetric vacuum has $hQ_1 i = hQ_2 i = 0$. It only exists if $_2 = 0$ and $_1 \notin 0$. The second condition is again to have DBI gauge kinetic terms on this vacuum. In this case, the U(1) gauge symmetry is not broken, the goldstino vector multiplet remains massless and the hypermultiplet has mass m. If $m \notin 0$, a nonzero Fayet-Iliopoulos coe cient $_2$ breaks then N = 1 linear supersymmetry. Note that the single tensor formalism is appropriate for the description of the H iggs phase of nonlinear QED in a manifest N = 1 super eld basis (with respect to the linear supersymmetry), while the charged hypermultiplet representation is obviously convenient for describing the C oulom b phase.

One can nally expand the action (5.65) in powers of in order to nd the lowest dimensional operators that couple the goldstino multiplet of partial supersymmetry breaking to the N = 2 hypermultiplet. Besides the dimension-four operators corresponding to the gauge factors e V_2 , one obtains a dimension-six superpotential interaction $Q_1Q_2W^2$ coming from the solution of the nonlinear constraint X = $W^2 + O(^3)$; it amounts to a eld-dependent correction to the U(1) gauge coupling.

6 Conclusions

In this work we have studied the interaction of the M axwell goldstino multiplet of N = 2 nonlinear supersymmetry to a hypermultiplet with at least one isometry. The starting point was to describe the hypermultiplet in terms of a single-tensor multiplet, which admits an o -shell N = 2 formulation, and introduce a coupling using a Chern-Sim ons interaction. This system describes the coupling of a D-brane to bulk elds of N = 2 compactications of type II strings, in the rigid limit of decoupled gravity. U sing N = 1 and N = 2 dualities, we have also obtained equivalent formulations of the nonlinear M axwell theory coupled to a matter N = 2 supermultiplet. This web of theories is summarized in the Figure.



Figure 1: W eb of dualities: double arrows indicate duality transform ations preserving o -shell N = 2 supersymmetry, simple arrows are N = 1 o - shell dualities only, leading to theories with on-shell N = 2 supersymmetry. The N = 1 super edds and the related equations are indicated.

Specializing to the case of the universal dilaton hypermultiplet, we determ ined the action completely in the rigid limit, using the Heisenberg symmetry of perturbative string theory, up to an arbitrary constant parameter which, in the quaternion-Kahler case of N = 2 supergravity, corresponds to the string one-loop correction [15]. An interesting open question is to realize this decoupling limit directly from the supergravity-coupled system.

We have shown how the above system applies to the Higgs phase of N = 2 nonlinear QED coupled to a charged hypermultiplet. A llowing a hypermultiplet mass scale and a Fayet-Iliopoulos term in the two-dimensional parameter space, the vacuum structure includes phases with broken and unbroken linear N = 1 supersymmetry and/or U (1) gauge symmetry.

It is interesting to note that in the Higgs phase the goldstino vector multiplet combines with the hypermultiplet to form a N = 1 massive vector and a massless chiral super eld. This novel super-Higgs mechanism is possible without gravity because the hypermultiplet is charged under the U (1) partner of the goldstino. In the N = 1 case, the goldstino multiplet can be gauged only by gravity and is absorbed by the gravitino that acquires a mass.

In principle, it is straightforward to introduce additional hypermultiplets. O bviously only one of them will 'absorb' the goldstino providing mass to the U(1) vector. This action describes also the low energy lim it of spontaneous partial supersymmetry breaking N = 2! N = 1, when the breaking is 'sm all' in the matter (hypermultiplet) sector. This is analogous, in the case of a single N = 1 nonlinear supersymmetry, to the elective action of the goldstino coupled to N = 1 multiplets at energies higher than their soft breaking m asses. It is then known that this action is obtained by sim ply identifying the constrained goldstino multiplet with the so-called spurion [23]. One may try to develop the analogy in the N = 2 nonlinear case and derive the structure of possible 'soft' term s associated to the partial N = 2! N = 1 breaking. As a step further, one could try to integrate out the N = 2 superpartners and obtain the elective action at much lower energies, describing the interactions of the N = 2 goldstino multiplet to N = 1 super eds. This would be directly relevant for constructing brane e ective theories involving non-abelian gauge groups and charged matter. It could also be used for studying a supersymmetric extension of the Standard M odel in the presence of a second supersymmetry nonlinearly realized due to its breaking at a high scale.
