Supergravity Supertubes

A bstract: We nd the supergravity solution sourced by a supertube: a $(1/4)$ -supersym m etric D 0-charged IIA superstring that has been blown up to a cylindricalD 2-brane by angularm om entum. The supergravity solution captures all essential features of the supertube, including the D 2-dipole m om ent and an upper bound on the angular m o m entum: violation of this bound im plies the existence of closed tim elike curves, with a consequent ghost-induced instability of supertube probes.

1. Introduction

It has been recently shown by two of us that a cylindrical D 2-brane can be supported against collapse by the angular m om entum generated by electric and m agnetic Bom-Infeld elds [1]. These elds can be interpreted as some number q_s of dissolved IIA superstrings and some number per unit length q_0 of dissolved D0-branes. The angular m om entum J is proportional to gog, and the energy is m in in ized for a cylinder radius proportional to $P\overline{q_0q_s}$. Som ew hat surprisingly, this con guration preserves 1/4 of the supersymm etry of the IIA M inkow ski vacuum, hence the name supertube. A s discussed in [1], and extended here to the case of N > 1 D 2-branes¹, one can also consider a combined system consisting of a supertube and D0-charged strings with given total string and D0 charges Q_s and Q_0 , respectively. In this case supersymmetry does not x the angularm om entum but instead implies the upper bound \vec{y} j R $\hat{D}_s Q_0 \vec{J}^{=2}$, with the radius of an N -times-wound supertube given by $R^2 = \vec{v} + N$.

The gravitational back-reaction was not considered in [1], but when this is taken into account a supertube becom es a source for the IIA supergravity elds that govern the bw-energy lim it of the closed string sector of IIA superstring theory. A lithough

this source is a distributional one (in the lim it of weak string coupling), one m ight still expect it to generate a solution of IIA supergravity that is non-singular everywhere away from the source. Such a solution should carry the same string and D0-brane charges as the D 2-brane supertube, as well as the same angular m om entum, and preserve the same $1/4$ of the supersymm etry of the IIA vacuum. The aim of this paper is to exhibit this solution, which we call the supergravity supertuke, and to study its properties.

As we shall see, the supergravity solution accurately reproduces the features of the D 2-brane supertube described above. In particular, the bound on the angular m om entum arises from the requirem ent of causality: if J exceeds the bound then the K illing vector eld associated w ith the angular m om entum becomes timelike in a region near the supertube; since its orbits are closed this in plies the existence of closed tim elike curves (CTCs). This is a global violation of causality that cannot cause unphysical behaviour of any local probe (as we verify for a D 0-brane probe) but it can and does cause unphysical behaviour for D 2-brane probes, due to the appearance of a ghost-excitation on the D 2-brane worldvolume.

Since the D 2-brane supertube is a supersymmm etric solution one m ight expect the force between parallel or concentric² supertubes to vanish, allow ing them to be superposed. I his is certainly the case for the D 0-charged superstrings to which the supertube reduces in the lim it of zero angular m om entum, and it has been argued in the context of m atrix theory [2] that it is also true of supertubes. As any force between parallel supertubes is transm itted by the IIA supergravity elds, it would seem necessary to consider the supergravity supertube solution to verify this, and this is one motivation for the present work. In fact, we shall exhibit in ulti-tube' solutions representing a number of parallel supertubes with arbitrary locations and radii, which implies the existence of a 'no-force' condition between parallel supertubes. By considering D 0 and IIA string probes in this background we also establish a 'no-force condition' between supertubes and strings and D0-branes.

A snoted in [1], the D 2-brane supertube is T-dual to a helical rotating IIB D-string (the S-dualofw hich is T-dualto a helical rotating IIA string). These (1/4)-supersymm etric rotating helical strings have since been studied in two recent papers $[3, 4]$. A supergravity solution representing the asymptotic elds of a IIB rotating helical D-string was also presented in [4]. In fact, this solution is T-dual to a six-dim ensional version of the supertube; we shall comm ent further on lower-dim ensional supertubes in a concluding section. We should also mention that a IIA supergravity solution for a D 2-brane tube w ith D 0-branes and IIA string charges was constructed previously by one of the authors [5]; how ever, as a lready noted in [5] this solution does not describe a supertube because

it has no angular m om entum 3 .

2. W orldvolum e Supertubes

In this section we will review the results of $[1]$ that are relevant to this paper, with a slight extension to allow for multiply-wound D 2-branes. The conventions used here di er slightly from those of [1].

The starting point is a D 2-brane in the ten-dim ensional M inkow ski vacuum of IIA superstring theory. We write the M inkow skim etric as

where we have identied the work volume time with t. We will allow for a timeindependent electric eld E in the x-direction, and a time-independent magnetic eld B, so the Bom-Infeld 2-form is

Since this equation must be satis ed for all values of ', both term s must vanish independently. The vanishing of the second term requires that $E = 1$ and $E = 0$. W ithout loss of generality we choose $E = 1$ and

Now the rst term in (2.10) vanishes identically if $B = 0$, in which case we have $1/2$ supersymmetry. We shall therefore assume that $B \oplus 0$. The two conditions (2.11) and (2.12) on $_0$ are compatible and imply preservation of 1/4 supersymmetry. They are respectively associated with string charge along the x-direction and with D0-brane charge.

This result shows that the positive energies associated to D 2-brane tension and rotation are exactly cancelled by the negative binding energy of the strings and D 0-branes with the D 2-brane, and hence that the supertube is a genuine bound state. A swe shall see later, this has som e counter-intuitive consequences.

The crossed electric and m agnetic elds generate a Poynting 2-vector-density with

as its only non-zero com ponent. The integral of J over' yields an angularm om entum per unit length

along the axis of the cylinder. It is this angular m om entum that supports the tube against collapse at the constant radius (2.17) . In ten dim ensions, the angularm om entum 2-form L m ay have rank atm ost 8. This rank is 2 for the supertube, J being the only non-zero skew-eigenvalue ofL. N ote also that the angular m om entum selects a 2-plane in the 8-dim ensional space transverse to the strings, where the cross-section of the cylinder lies.

At this point we wish to consider a slight generalization of the results of [1] to allow for the possibilty of N coincident D 2-brane tubes, or a single D 2-brane supertube wound N tim es around the '-circle, or com binations of coincident and m ultiply-wound D 2-brane tubes. In any of these cases the local eld theory on the D 2-branes will be a U (N) gauge theory 4 . The results obtained in this paper will depend only on the total number N of D 2-branes, so we need not distinguish between these possibilities; for convenience we shall consider the con quration of N D 2-branes as a single N -timeswound D 2-brane. In this case and B m ust be promoted to m atrices in the Lie algebra of U (N), and their relationship to the string and D 0-brane charges becomes

A s discussed in [1] for the N = 1 case, the quantity \oint _sQ₀ j=N is actually an upper bound on the angular m om entum of a supersymm etric state with given string and D 0-brane charges Q_s and Q_0 . For

there exist in ixed ' con qurations consisting of an N -times-wound D 2-brane supertube w ith charges q_s and q_0 such that $J = q_s q_0 = N$, together w ith parallel IIA strings and

A round the string scale a complex eld coupling to the U (1) factor arising from strings connecting opposite points on the ' circle m ay become tachyonic, in which case the tube would decay to the vacuum with the em ission of strings, D 0-branes and m assless closed string m odes carrying the angular m om entum; this is possible because the circle param eterized by ' is topologically trivial in spacetime.

D 0-branes (and possibly D 0-charged IIA strings) with charges $\mathrm{q}_{\mathrm{s}}^0$ and $\mathrm{q}_{\mathrm{0}}^0$ such that $Q_s = q_s + q_s^0$ and $Q_s = q_0 + q_0^0$. Since the D 0-branes and strings carry no angular m om entum, the com bined system possesses totalangularm om entum $q_sq_0=$ N, which is less than the m axim alvalue allowed by the bound. By transferring charge from the strings and D 0-branes to the supertube one can increase the angular m om entum at χ ed Q $_0$ and $x \in \mathbb{Q}_s$, whilem aintaining the 1/4 supersymm etry. However, this process can only be continued until $q_s = Q_s$ and $q_0 = Q_0$. If one were to continue beyond this point, obtaining a con guration with \dot{y}_s j> \mathcal{D}_s j, then q_{s} and $\mathrm{q}_{\mathrm{s}}^0$ would have dierent signs, and their associated supersymm etry projectors would have no comm on eigenspinors.

Thus we conclude that the angular m om entum of a supersym m etric state of IIA string theory with charges Q_s and Q_0 is bounded from above as in (2.27). Since the supersym m etric radius of the supertube is always

3. Supergravity Supertubes

O ur starting point will be a solution of $D = 11$ supergravity found in [6] that describes the intersection of two rotating M 5-branes and an M 2-brane, with an M -wave along the string intersection. A lthough the generic solution of this type preserves only 1/8 of the 32 supersymm etries of the M-theory vacuum, the special case in which we set to zero the M 5-brane charges preserves 1/4 supersymm etry. The m etric and 4-form eld strength of this solution are (in our conventions)

H ere \texttt{y} = fyⁱg are Cartesian coordinates on \mathbb{E}^8 . The m embrane extends along the xand z-directions, and the wave propagates along the z-direction. The functions U and K and the 1–form A depend only on $\mathbf y$. U and K are harm onic on $\mathbb E^8$ and are associated w ith the m em brane and the wave, respectively. A determ ines the angular m om entum of the solution, and its eld strength dA satis es the source-free M axwell-like equation

We have chosen a gauge for the potentials B_2 , C_1 and C_3 such that they all vanish at in nity if U and V are chosen such that the metric at in nity is the $D = 10$ M inkow ski m etric in canonical C artesian coordinates. We note here for future use that

The Killing spinors of the solution (3.3) follow from those in eleven dimensions given in [6], but we have also veri ed them directly in $D = 10$ with the conventions of $[7]$. They take a simple form when the metric is written as

where $_0$ is a constant 32-com ponent spinor sub-ject to the constraints (2.11) and (2.12). A s m entioned before, these two constraints preserve 1/4 supersymm etry and are those associated with a IIA string charge aligned with the x-axis and D0-brane charge, as required for a supertube, although we stillmust specify the functions U and V and the 1-form A before we can make this identi cation.

To m otivate the choice for these functions, consider rst the solution describing D 0-charged fundam entalstrings located at a point $\mathrm{y} = ~\mathrm{y} ~\;$ in \mathbb{E}^8 and aligned with the x -axis. This solution is given by (3.3) with

where is the volume of the unit 7-sphere. The constant Q $_{\rm s}$ is the string charge, while Q_0 is the D 0-brane charge per unit length; this can be seen from their asym ptotic contributions to their respective eld strengths H₃ and F_2 . (The signs of these charges are

N ow consider distributing the charged strings hom ogeneously on a circle of radius R in a 2-plane in \mathbb{E}^8 . Let $r; r'$ be polar coordinates on this plane, and the radial coordinate on the orthogonal 6-plane (see gure 1). The m etric then takes the form

N ote that (by construction) these functions satisfy Laplace's equation on \mathbb{E}^8 w ith D irac delta-like sources with support on the $r = R$; = 0 circle. In addition, they have the same asymptotic behaviour as those in (3.9) in the limit \cdot 1, where = \dot{y} j is the radial coordinate in \mathbb{E}^8 . Hence the constants Q_s and Q₀ in (3.12) are again the string and D 0 charges.

The solution (3.3) with $A = 0$ and U and V as in (3.12) displays a tubular structure but possesses no angular m om entum, and the eld strength G $_4$ sourced by D 2-branes vanishes. To describe the supertube we must incorporate the angular m om entum, with the source of rotation being located at the tube. We know that the asymptotic form must be

where the constants $L_{ii} = L_{ii}$ are the com ponents of the angular m om entum 2-form L. As explained above, L must have rank 2 for the supertube, in which case we may w rite the asymptotic form as

which has the correct asymptotic behaviour (3.15) . A swe shall see in the next section, this choice of A autom atically generates the correct D 2- elds.

The supertube solution is thus given by (3.3) with U and V as in (3.12) and A as in (3.17) ; we shall analyze its properties in detail below. However, we wish to note here

that evaluation of the A DM integral for brane tension $[8]$ (in the sam e conventions as for the angularm om entum) yields the tube tension

exactly as for the D 2-brane supertube (no factors of the string coupling constant appear in this form ula because the asym ptotic value of the dilaton vanishes for our chosen solution).

H aving com pleted our construction of the supertube solution, we close this section by presenting its generalization to a 'm ulti-tube' solution representing N parallel tubes w ith arbitrary locations, radii and charges. These are easily constructed because of the linearity of the harm onicity conditions on U and V and of the M axwell equation for A. The generalexpression is

Clearly, by setting som e of the radii and angular m om enta to zero, we obtain a solution representing a superposition of D 0-charged strings and supertubes.

The existence ofthis m ultitube solution shows that there isno force between stationary parallel supertubes⁵. N ote that, as far as the supergravity solution is concerned, two (orm ore) tubes can intersect each other, as described by the solution above when the radii and centres are chosen appropriately.

4. D 2-D ipole Structure and C losed T im elike C urves

We have now found a $(1/4)$ -supersymm etric solution of IIA supergravity that carries all the charges required for its interpretation as the solution sourced by a supertube source. A lthough it also displays the appropriate tubular structure, we have not yet identi ed clearly the presence of a D 2-brane. Even though there cannot be any D 2-brane charge, we would still expect the elds of the D 2-brane supertube to carry a non-zero D 2-brane dipolem om ent determ ined by the size of the tube. There is certainly a local D 2-brane charge distribution because the electric components of G_4 are non-zero. Speci cally, for A given by (3.17) , we have, asymptotically,

The solution in the form (4.7) clearly exhibits the properties expected from the planar lim it close to the supertube. The angular m om entum becom es linear m om entum along the tangent direction to the circle, that is, along \hat{z} . The SO (6)-sym m etry associated to rotations in \mathbb{E}^6 is enhanced to SO (7): the ^-coordinate in the near-tube m etric com bines with the coordinates on the 5-sphere to yield the m etric on a round 6-sphere. The functions U and V are sourced by delta-functions at $\hat{r} = 0$, hence the gauge potentials B₂ and C₁ correspond to charge densities Q $_{\rm s}=2R$ and Q $_{\rm 0}=2R$ along the 2-direction. A s the radius of the 6-sphere increases, the 7-disc will eventually intersect the D 2-circle at a second point and the above integral then vanishes, as happens for any 6-sphere at in nity 6 .

F iqure 2: The little 7-disc intersects the supertube (suppressing the x-direction) at one point, hence the ux of G_4 through its boundary (the little S^6) is non-zero. On the contrary, the large disc intersects the supertube at two points which correspond to local D 2-brane charge densities of opposite sign, hence the ux through the large S⁶ vanishes; the sam e happens for any 6-sphere at in nity.

We have now identied all the elements present in the supertube solution. There are four independent parameters, say Q_s , Q_0 , R and N (or J). So far, the solution displays all the features of the worldvolum e supertube except for the bound (2.29). We shall now show that this arises by dem anding that there be no causality violations in the supertube spacetime.

 6 It follow s from the considerations above that the lim it R $\,$! 1 w ith xed charge densities results in a planar con quration of D 2-branes with strings and D 0-branes distributed on it, and with m om entum in the direction transverse to the strings. This preserves the sam e am ount of supersymm etries as the supertube. To our know ledge, this con quration has not been previously considered.

These CTCs are 'naked' in the sense that there is no event horizon to prevent them from being deformed to pass through any point of the spacetime. Neither can they be removed by a change of fram e, since the causal structure is unchanged by any non-singular conform al rescaling of the metric. It should be appreciated that the surface de ned by $\vec{j}'\hat{f} = 0$ (present when J exceeds the bound) is not singular; it is not even a coordinate singularity. In particular, the m etric signature does not change on this surface despite the fact that for $\dot{\mathcal{T}}^2$ < 0 there are two commuting timelike K illing vector elds. In fact, the only physical singularity of the solution (3.3) is at $r = R$; = 0, where both $\dot{f}f^2$ and the

dilaton diverge. Thus, the over-rotating supertube spacetime is locally as physical as the under-rotating one, with a m etric that is singular only at the location of the tube.

The CTCs of the over-rotating supertube metric have a very simple origin in eleven dim ensions. The IIA supergravity supertube lifts to the solution (3.1) of elevendim ensional supergravity from which we started, with U and V as in (3.12) and A as in (3.17) . If the eleventh coordinate z is not periodically identi ed then this elevendim ensional spacetim e has no CTCs, but CTCs are created by the identications needed for compacti cation on a circle if J exceeds the bound (2.29) . To see this, consider an orbit of the vector eld = θ , + θ _z, for real constant . W hen z is periodically identi ed this curve will be closed for some dense set of values of . This inequality can be satis ed for real only if $r^2 < U^{-1}V^{-1}f^2$, but this is precisely the condition that ' be timelike. Thus, there will be closed timelike orbits of in the $D = 11$ spacetime precisely when the closed orbits of ' become timelike in the $D = 10$ spacetime. However, from the eleven-dimensional perspective, these CTCs arise from periodic identi cation and can therefore be rem oved by passing to the universal covering space. An analogous phenom enon was described in $[10]$, where it was shown that the CTCs of over-rotating supersymm etric ve-dimensional black holes are removed by lifting the solution to ten dim ensions and passing to the universal covering space.

5. Brane Probes: Supersym metry

We shall now exam ine the behaviour of brane probes in the supertube spacetime. Speci cally, we shall consider D 0-branes, strings and D 2-branes. We shall rst show that the $1/4$ supersymm etry of the background is preserved by stationary D0-brane, IIA-string and D 2-supertube probes (when suitably aligned).

These two -matrices commute and the Killing spinors of the background are simultaneous eigenstates of $_{\text{D}0}$ and $_{\text{string}}$ with unit eigenvalue, so the inclusion of these D 0-brane and IIA-string probes does not break any supersymmetries that are preserved by the background. In particular, this means that a D0-brane or a string can be placed arbitrarily close to the supertube without experiencing any force. This result is counter-intuitive because one would expect the D 2-cylinder in this situation to behave approxim ately like a planar D 2-brane, and hence to exert an attractive force on D0-branes and strings. The explanation is presum ably that the supertube is in fact a true bound state of strings, D 0-branes and cylindrical D 2-branes, in which the D 2-branes behave genuinely di erently as compared to their free counterparts⁷.

Now we consider a probe consisting of a supertube itself, that is, a D 2-brane of cylindrical topology with string and D 0-brane charges. The analysis is very similar to that of section 2 except that the Bom-Infeld eld strength F must now be replaced by the background-covariant eld strength $F = F$ B_2 . 6. B rane P robes: Energetics

We now turn to the energetics of probes in the supertube spacetime. Our aim is to uncover any e ects of the presence of CTCs on brane probes, so in this section we shall assume that the bound (2.29) is violated. We shall see that the global causality violation due to the CTCs causes a local instability on the work volume of extended probes such as a D 2-brane tube, the reason for this being of course that the probe itself is non-local. On the contrary, we would not expect any unphysical e ect on a local probe such as a D 0-brane, and we shall begin by verifying this.

There is therefore nothing to prevent a D0-brane from entering the region where 1^2 < 0, and its dynamics in this region is perfectly physical, at least locally. The same applies to x-aligned IIA superstrings; again this is not surprising because this is a probe that is local in '.

We now turn to the supertube itself. This is a more signi cant test of the geometry because one could in agine building up the source of the supergravity solution by accretion of concentric D 2-brane supertubes. We begin by considering a general tubular D 2-brane aligned with the background. For our purposes we m ay assume that the worldvolume scalar elds r and a are uniform in x, but we shall also assume, initially, that they are time-independent (as will be the case for a supertube, since this is a D 2-brane tube at a m inimum of the potential energy).

Note that the supertube does not become tachyonic; its tension continues to be given by (6.11). A tachyon instability leads to runaway behaviour in which the kinetic energy increases at the expense of potential energy. The instability here is instead due to the possibility of negative kinetic energy, characteristic of a ghost 11 . This instability indicates that it is not physically possible to construct a supertube spacetime with naked CTCs starting from M inkowski space. One m ight im agine assembling such a spacetin e by accretion from in nity of 'supertube shells' carrying in nitesin al fractions of charges and angularm om entum. W hen a nite m acroscopic fraction of charges and

angular m om entum have been accum ulated, it is fully justi ed to treat the next shell as a probe in the background generated by the rest. The instability on this probe when the bound (2.29) is violated signals that this procedure m ust be physically forbidden beyond the bound (2.29).

7. D iscussion

W e have found the exact IIA supergravity solution corresponding to a source provided by the D 2-brane supertube found in $[1]$. We have also found multi-tube solutions, which shows that parallel supertubes exert no force on each other, and we have conrm ed this by showing that when (suitably aligned) stationary D 0-brane,IIA -string and D 2-supertube probes are introduced into the background, they preserve all supersym m etries of the background. This provides con m ation from supergravity of the m atrix m odel results of [2] for m ulti-supertubes.

The supertube spacetim e reproduces with rem arkable accuracy the worldvolum e analysis of [1]. It carries the appropriate charges as m easured by surface integrals at in nity: string charge Q_s,D 0 charge per unit length Q₀ and angularm om entum J. Its tension is = $\oint g_s j + \oint g_0 j$, as in [1], and it also preserves the same eight supercharges $(1/4$ of those of the IIA M inkowski vacuum). It is singular exactly on a cylindrical surface of radius R (but is regular everywhere else). The only m odi cation relative to the analysis in $[1]$ com es from considering the possibility that the D 2-brane winds N tim es around the tube. Taking this into account, all the form ulas for the supertube are precisely reproduced. The radius is related to the angular m om entum as $\overline{\psi}$ j = N R². Finally, the requirem ent that there are no closed tim elike curves in the supertube spacetim e im poses the bound \overrightarrow{v}_1 \overrightarrow{v}_sQ_0 \overrightarrow{v} on the angularm om entum , which is the sam e as in $[1]$, once m ultiwinding is allowed for.

If \overline{J} jexceeds the bound above then the K illing vector eld ', associated to rotations in the plane of the angularm om entum, becomes tim elike suciently close to the tube region, which leads to a global violation of causality. A lthough this has no e ect on the local physics of D 0-brane or IIA string probes, it causes an instability of D 2-supertube probes due to the fact that the supertube tension no longer m inim izes the energy for xed D 0 and string charges. This is m ade possible by the appearance of a negativenorm state (a ghost) on a supertube in the region where ' becomes timelike. The q bbalviolation of causality that this produces (due to the occurrence of $CTCs$) is thus m anifested by a localpathology on supertube probes (which is possible because these probes are them selves non-local). This constitutes evidence that a globally causalityviolating supertube spacetim e cannot be physically assem bled by starting with

space and continuously bringing in from in nity 'supertube shells' with in nitesimal fractions of charge and angular m om entum.

It is straightforw and to m odify the IIA supergravity supertube solution to one that provides the elds for a supertube in a K aluza-K lein vacuum spacetime of the form $\mathbb{E}^{(1,n)}$ M_{9n}, n 4, with M_{9n} a compact Ricci-atmanifold. The metric then takes the form

For even n the solutions involve elliptic functions, and therefore are som ew hat aw kw ard to work with. For odd n, instead, they take $\sin p \ge \tan s$. For $n = 7$ (a supertube in eight dimensions),

V is as U with Q_s replaced by Q_0 , and is again given by (3.13). In all cases it is possible to verify that the absence of CTCs in plies the bound (2.29).

The maximally rotating six-dimensional ($n = 5$) solution is in fact dual to the solution for a helical D-string constructed in [4]. One of the two methods applied in $[4]$ to the construction of this solution (the one based on the chiral null model) is essentially equivalent to the one employed in this paper. The other approach, which starts from the neutral rotating black hole and sub-jects it to several transform ations, does not lead to supertubes in dimensions higher than six. Instead, it can be seen to result in lled-in cylinders, that is, continuous distributions of concentrical tubes inside a cylinder. These solutions do not possess CTCs either provided that J does not exceed the bound.

This six-dim ensional supertube is particularly interesting when the compact four dim ensional space is K 3. A lihough at weak string coupling the supertube source is distributional, and hence singular, one m ight expect it to be non-singular at strong

coupling. To exam ine this possibility we should look for solutions of the six-dim ensional supergravity/Y ang-M ills theory that governs the low-energy lim it of the T^4 -com pactied S-dual heterotic string theory. The distributional D 2-brane of the IIA theory now appears as a non-singular 2-brane with a m agnetic m onopole core. C onceivably, a tubelike con quration of this m onopole 2-brane can be supported against collapse by angular m om entum in just such a way that its e ective work volume description is as a $D = 6$ supertube (that is, a d2-brane supertube of iia 'little' string theory). In this case, one m ight hope to nd a 'full' non-singular supergravity/SYM solution that reproduces the ebds of the dualized IIA supergravity tube (after the rede nition of ebds required by the IIA /heterotic duality) but completed in the interior by a solution with the SYM supertube' source. The case of the heterotic dyonic instanton [12] provides a model for this kind of non-singular completion of a rotating brane solution of supergravity, although in that case the angularm om entum is xed by the charges rather than just being bounded by them.

In view of these connections, it appears that the supergravity supertube spacetine studied here will eventually take its place in a more general theory of supergravity solutions for supersymmm etric sources supported by angular m om entum.
