These can include but are not limited to: personal computers, a wireless or mobile device or any other technology.

**By using or accessing the metaverse platform or any application developed by Alpha City Holding Company Corp. in any manner, you agree:**

1. **that you have read, understand and agree to be bound by all of the terms and conditions set forth in these Terms of Service (including any additional terms, policies and agreements specified or referenced);**
2. **that you have the right and capacity to enter into these Terms of Service (on behalf of yourself or the entity that you represent) and meet all of the eligibility and other requirements and;**
3. **that your access and use of Alpha City Holding Company Corp. applications inclusive of Alpha City Metaverse is permitted by, and shall not violate, any applicable laws, including those in your jurisdiction. If you do not agree with all of the terms in these Terms of Service, you are prohibited from visiting, accessing, using, or transacting on metaverse platform.**

#### **1. Modifications.**

We reserve the right to revise the Terms of Service, at any time, for any reason in our sole discretion by posting an updated Terms of Service without advance notice to you. It is within our discretion, to either post or display notices of material changes, e-mail you or notify you upon login about any changes made. Once the changed Terms of Service has been posted these changes become effective immediately and, by using your account or engaging with any application developed by Alpha City Holding Company Corp. after they become effective, it will signify your agreement to be bound by the changes. The responsibility to check for changes to the Terms of Service is the Users

## **2. Privacy Policy.**

## **3. Metaverse Accounts.**

**3.3. **7.1. Rights and Licenses.** Alpha City Metaverse may provide you with the opportunity to submit, post, display, transmit or otherwise make available certain content. By submitting, transmitting, posting, displaying or otherwise making available any User Content, you grant us a worldwide, non-exclusive, sublicensable, royalty-free license to exploit such User Content for our lawful business purposes, including to provide, promote, and improve Alpha City Holding Company Corp. applications (including to facilitate the transactions between Buyers and Sellers as described herein), without obligation. You warrant and declare that you have, or have obtained, all rights, licenses, consents, permissions, power and/or authority necessary to grant the rights granted herein for any User Content.

**7.2. **9.3.   - (i) the subject of economic sanctions, embargoes or other trade restrictions in any jurisdiction, including those administered and enforced by the United States, European Union, United Kingdom, United Nations Security Council, or other applicable sanctions authority (collectively, "Sanctions"), or
  - (ii) located, organized, or resident in a country or territory that is the subject of Sanctions (including Crimea, Cuba, Iran, North Korea, and Syria) (collectively, "Sanctioned Jurisdictions");
- (e) payment of the Purchase Price will not be funded directly or indirectly by or from anyone that is the subject of Sanctions or located, organized, or resident in a Sanctioned Jurisdiction;
- (f) no party directly or indirectly involved in the purchase will be the subject of Sanctions, nor owned or controlled by any individual or entity that is the subject of Sanctions or otherwise located, organized, or resident in a Sanctioned Jurisdiction, unless expressly authorized in writing by the government authority having jurisdiction/
- (g) if you are acting as agent on behalf of a principal, you have taken steps reasonably designed to ensure compliance with Sanctions, anti-money laundering, anti-terrorism, and anti-bribery or anti-corruption laws, including but not limited to, conducting appropriate due diligence on your principal and screening source of funds.

**11.1.
