10. RECOVER Meeting with Adler "Barry" SEAL, Ramada Airport Inn, 9/16/81

SYNOPSIS

On Wednesday, 9/16/81, [REDACTED] met with Adler "Barry" SEAL to discuss the delivery of approximately 150,000 d.u. of methaqualone for retableting.

DETAILS:

1. Pursuant to a telephone conversation with Adler "Barry" SEAL, a/k/a BILL, at approximately 12:55 PM on Wednesday, 9/16/81, [REDACTED] proceeded to an undercover meeting with SEAL. At approximately 1:10 PM, [REDACTED] arrived at the Ramada Airport Inn located at 3941 N.W. 22 Street, Miami, Florida, (305) 871-1700. SEAL had told [REDACTED] that he would be seated in a car parked under the entrance to the hotel. When [REDACTED] arrived he observed a maroon Oldsmobile bearing a current Florida tag number [REDACTED] parked at the entrance of the hotel. The car was occupied by a white male, 40-45 YOA, small grey mustache, short dark hair, heavy build, seated on the passenger side of the vehicle. [REDACTED] first thought the individual was SEAL.

2. After [REDACTED] entered the hotel he observed SEAL standing at the pay telephone area. SEAL asked [REDACTED] if everything was ready and when he (SEAL) could expect to have the "pieces repainted". SEAL, when referring to the "pieces", is referring to methaqualone tablets and to be "repainted" as being retableted. Before [REDACTED] could answer, SEAL answered a ringing pay telephone which was apparently for him, as he conversed with an unknown person.

3. When SEAL got off the telephone he again asked [REDACTED] when the pills would be ready for resale. [REDACTED] explained that the individual who would be retableting the pills had said that it would take three or four days to complete the job and that he did not work on the weekends. SEAL laughed and asked what kind of individual the retabletor was that he did not work weekends. [REDACTED] told SEAL that he could expect to have the completed tablets by Wednesday, 9/23/81.

4. SEAL asked [REDACTED] if he would be able to sell the methaqualone tablets for SEAL. [REDACTED] told SEAL that there was a buyer waiting but that the quality had to be good. SEAL asked how the quality was on the first batch. [REDACTED] told SEAL that part of the pills (50,000) that had been sent down were weak but when the retableting had been completed they were acceptable. SEAL told [REDACTED] that he (SEAL) wanted to get the prices squared away prior to the delivery. SEAL stated that it was his understanding that the "repainting" would cost .12 a unit and that the units could then be sold at .75. [REDACTED] told SEAL that the prices were correct.

5. At this point, SEAL told [REDACTED] that the prices were alright and that SEAL wanted \$50,000.00 for the pills, which would leave a profit for [REDACTED] of approximately \$12,000.00. [REDACTED] advised SEAL that the \$50,000.00 would have to be paid after the sale as [REDACTED] was not in a position to pay the \$50,000.00 prior to the sale of the pills. SEAL asked [REDACTED] if there might be any foreseeable problems. [REDACTED] said there should be none. SEAL asked [REDACTED] if he would be responsible for the pills. [REDACTED] said that he would and that SEAL should have his money by the following Wednesday, no later than a week from Friday. SEAL advised [REDACTED] that he (SEAL) would be out of town all of the following week and would get in touch with [REDACTED] with reference to payment of the money.

6. [REDACTED] and SEAL walked out to the parking lot and the two story parking area. SEAL advised [REDACTED] that a heavy set white male with a mustache and short hair would be making the delivery. SEAL further advised that the delivery would be made in a red Ford Thunderbird which would be parked at the entrance of the parking garage. SEAL advised [REDACTED] to walk up to [REDACTED] individual and ask where he had parked the car. [REDACTED] should then proceed to the car. The keys would be inside. SEAL asked [REDACTED] how long it would take to transfer the boxes which SEAL described as being cardboard file boxes taped closed with aircondition duct tape. [REDACTED] advised that it would be less than fifteen minutes. SEAL further advised [REDACTED] to just park the car when he returned, leaving the keys inside. [REDACTED] advised SEAL that his plan was satisfactory.

7. SEAL asked where [REDACTED] could be reached as SEAL did not expect his driver for at least another hour or so. [REDACTED] told SEAL to contact him [REDACTED] at the number that SEAL had for him. SEAL advised [REDACTED] that when he did that SEAL would just ask to join him for coffee and that would be the signal that SEAL's man was in place. [REDACTED] agreed and parted company with SEAL.

8. [REDACTED] departed the Ramada Airport Inn at approximately 1:30 PM. While he was departing, [REDACTED] observed SEAL departing with the previously described individual via the rental car bearing a current Florida tag [REDACTED]. The tag shows registered to North American Rental Car, DBA Budget Rent A Car, 1770 N.W. LeJeune Road, Miami, Florida. [REDACTED] when leaving the area, observed SEAL and friend exiting their vehicle which they parked at the rear of the Skyways Motel located at 2373 LeJeune Road, Miami, Florida, (305) 871-3230.

SYNOPSIS:

On December 10, 1979, [redacted] was telephonically contacted by [redacted] of EPIC. Available information indicated that Adler BERRIMAN Seal and other unidentified individuals were believed to be enroute to Ecuador to obtain 100 kilograms of cocaine. Flight plan data revealed that a/c N-8658E would arrive at La Ceiba, Honduras on its return flight. The BEDE acting on this information, subsequently arrested Adler BERRIMAN Seal, [redacted] in possession of 17.5 kilograms of cocaine and seized N-8658E.

2. On Dec. 10, 1979, [redacted] of the Costa Rica D.O. was telephonically contacted by [redacted] of DEA, El Paso Intelligence Center. [redacted] advised the agent that Adler BERRIMAN Seal aka Adler Barry Seal had departed with other unknown individuals via N-8658E enroute to Guayaquil, Ecuador. At the time, it was believed that [redacted] accompanied BERRIMAN.

3. Flight plan data indicated that N-8658E would depart Guayaquil on Dec. 11, 1979 enroute to La Ceiba, Honduras. Acting on this information, [redacted] contacted the Honduran Narcotic Unit, BODE, and formulated plans to search the aircraft upon its arrival, however, the aircraft did not arrive at La Ceiba Coloso International Airport until Dec. 12, 1979.

4. Upon its arrival, BERRIMAN, [redacted] and N-8658E were searched with negative results for narcotics. However, an AR-180 automatic rifle was discovered and both individuals were detained. When informed of this, the agent then instructed the narcotic officers to observe the aircraft's tires for evidence of mud which proved positive. In view of this finding, [redacted] contacted [redacted] Chief of the Honduran Air Force and requested assistance in conducting a systematic search of surrounding clandestine airstrips. This effort was undertaken to no avail.

or the person who rented it. There were no documents in the car, only a pair of blue jeans and a cloth bag containing a man's toiletry items.

6. At approximately 4:07 PM, [REDACTED] returned the Thunderbird to the lower deck of the parking garage. [REDACTED] parked the car and left the keys inside. [REDACTED] departed the Ramada Inn parking lot at approximately 4:08 PM via OGV S-80-0130. [REDACTED] observed the as yet unidentified male enter the Thunderbird and depart the area. Surveillance was terminated at this point.

DESCRIPTION AND CUSTODY OF EVIDENCE

Exhibits 4A thru 4H are eight cardboard "Perma-Pak" brand file storage boxes, blue and white in color. Each box had airconditioning duct tape wrapped around the box at the ends to seal the top to the box. The exhibits were received by [REDACTED] from the trunk of a Ford Thunderbird, Louisiana tag number [REDACTED]. The delivery of the exhibits was caused by Adler "Barry" SEAL. [REDACTED] turned the exhibits over to [REDACTED] who transported them back to the MDO, followed by [REDACTED]. At the office, [REDACTED] processed the exhibits for temporary storage. Each exhibit was found to contain a black plastic bag which contained clear plastic bags which contained white circular tablets scored "Lemon 714". [REDACTED] conducted a preliminary field test on one of the tablets. The test proved positive for the presence of methamphetamine. The exhibits, after processing, were placed in the non-drug evidence vault for safekeeping. The exhibits were submitted to the Southeast Regional Laboratory on Friday, 9/18/81, after first being photographed by [REDACTED].

2. During the month of August 1979, the U.S. Attorney's office issued Grand Jury subpoenas for Barry SEALS and his attorney Roy FUGLER to attempt to gain further information about SEALS' drug organization.

[REDACTED] All subjects were to appear on August 16, 1979, however the Grand Jury was continued and all subjects were to return on another date not given at that time.

3. On December 15, 1979, SEALS was arrested in Honduras along with one [REDACTED] in possession of 17.5 kilos of cocaine, part of 100 kilos shipment. SEALS remained incarcerated in Honduras until July 1980, when he was released.

5. SAs of the New Orleans District Office along with members of U.S. Customs and the Louisiana State Police narcotics unit, maintained a surveillance on SEALS upon his return to New Orleans, Louisiana where he was met by his brother [REDACTED] and an unidentified white male. All three subjects then drove to Baton Rouge, Louisiana where Barry SEALS visited his parents' residence and then went to his residence. Surveillance was maintained throughout the night and next day at Barry SEALS' residence, however, no significant activity occurred and the surveillance was terminated on 7/23/80.

6. Since Barry SEALS' return from Honduras, U.S. Customs and DEA have received information that SEALS' would attempt to smuggle quantities of cocaine into U.S. via private airplane.

Intelligence Regarding Barry SEALS Cocaine Smuggling Organization

DETAILS:

1. On 12/15/79, members of the Hondurian Narcotics Division received information that approximately 100 kilos of pure cocaine would be coming into La Cieba, Honduras, the Goloson International Airport. Information also stated that an aircraft N-8658E owned and operated by Barry SEALS would contain the cocaine.
2. As a result of the aircraft arriving in Honduras from Guayaquil, Ecuador, piloted by SEALS and occupied by [REDACTED] who were detained and searched by the Hondurian authorities with negative results for narcotics. Subsequently, both subjects were arrested when an automatic rifle was found on the aircraft.
3. Subsequent investigation by Honduras authorities revealed a prior landing on 12-12-79 at the island of Guayaquil off the Hondurian coast by the aircraft before coming to Goloson airport. The investigation revealed that one subject had departed the aircraft carrying a large green duffel bag. A search was then conducted in the area and on defendant. [REDACTED] was arrested in possession of 17.5 kilos of cocaine.

- On December 20, 1984, a Federal Grand Jury in the Middle District of Louisiana returned an indictment against Adler B. SEAL, charging him with violation of 21 USC 846, relative to a conspiracy to possess with intent to distribute approximately 210 kilograms of cocaine during October, 1982. SEAL was also charged in the indictment with violation of 18 USC 1001, relative to the acquisition of several cashier's checks in the Baton Rouge area in a manner which caused a financial institution not to report a currency transaction as required by law.
- On December 21, 1984, SEAL surrendered to [REDACTED] at the office of the U. S. Marshal in Baton Rouge, Louisiana. At that time, [REDACTED] obtained fingerprints, photographs, and personal history information from SEAL. On the same date, SEAL appeared before U. S. Magistrate Shelly Zwirk, who released SEAL under a \$250,000 personal recognizance bond. It should be noted that SEAL is under a \$1,000,000 appeal bond relative to a drug conviction in the Southern District of Florida.

DETAILS:

1. This case was initiated as an OCDETF investigation on June 3, 1983. All previous reports and documents in GP-83-0010 are being incorporated into OCDETF case GP-83-Z002. The United States Attorney for the Middle District of Louisiana has accepted this case as an OCDETF investigation.

2. The investigation was initiated on the basis of information from [redacted] other sources which indicates that the Adler Berriman SEAL organization has been engaged in the air and marine smuggling, and distribution of large quantities of cocaine and other controlled substances for several years. [redacted] indicated that SEAL's organization is operating out of Baton Rouge, LA; Houston, TX, and Miami, FL, and is smuggling cocaine into the United States from Colombia and other Latin American countries. Current information indicates that the organization has control over at least 19 aircraft, including Lear Jets, other fixed wing aircraft, and helicopters, all of which are equipped with extensive navigational and communications equipment. SEAL also has control over at least two ocean-going vessels which are equipped with sophisticated electronics and other equipment, including helicopters. The objective of this investigation is to effect a substantial seizure of controlled substances and financial assets from the SEAL organization, and to develop a prosecutable drug smuggling and distribution conspiracy case relative to all members of the organization. 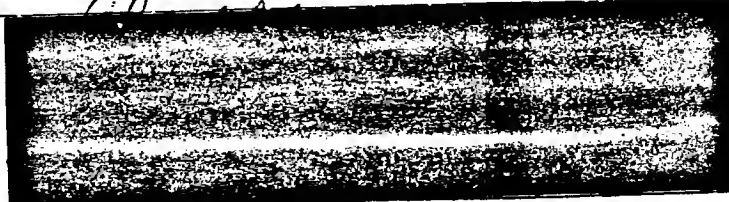
