Offices receiving copies of this letter are instructed to immediately establish a control file, captioned as above, and to assign responsibility for following and coordinating this new counterintelligence program to an experienced and imaginative Special Agent well versed in investigations relating to black nationalist, hate-type organizations. The field office control file used under this program may be maintained in a pending inactive status until such time as a specific operation or technique is placed under consideration for implementation.

The purpose of this new counterintelligence endeavor is to expose, disrupt, misdirect, discredit, or otherwise neutralize the activities of black nationalist, hate-type organizations and groupings, their leadership, spokesmen, membership, and supporters, and to counter their propensity for violence and civil disorder. The activities of all such groups of intelligence interest to this Eureau must be followed on a continuous basis so we will be in a position to promptly take advantage of all opportunities for counterintelligence and to inspire action in instances where circumstances warrant. The pernicious background of such groups, their duplicity, and devious maneuvers must be exposed to public scrutiny where such publicity will have a neutralizing effect. Efforts of the various groups

to consolidate their forces or to recruit new or youthful adherents must be frustrated. No opportunity should be missed to exploit through counterintelligence techniques the organizational and personal conflicts of the leaderships of the groups and where possible an effort should be made to capitalize upon existing conflicts between competing black nationalist organizations. When an opportunity is apparent to disrupt or neutralize black nationalist, hate-type organizations through the cooperation of established local news media contacts or through such contact with sources available to the Seat of Government. in every instance careful attention must be given to the proposal to insure the targeted group is disrupted, ridiculed, or discredited through the publicity and not merely publicized. Consideration should be given to techniques to preclude violenceprone or rabble rouser leaders of hate groups from spreading their philosophy publicly or through various mass communication media.

Many individuals currently active in black nationalist organizations have backgrounds of immorality, subversive activity, and criminal records. Through your investigation of key agitators you should endeaver to establish their unsavory backgrounds, Be alert to determine evidence of misappropriation of funds or other types of personal misconduct on the part of militant nationalist leaders so any practical or warranted counterintelligence may be instituted.

Intensified attention under this program should be afforded to the activities of such groups as the Student Nonviolent Coordinating Committee, the Southern Christian Leadership Conference, Revolutionary Action Movement, the Deacons for Defense and Justice, Congress of Racial Equality, and the Nation of Islam. Particular emphasis should be given to extremists who direct the activities and policies of revolutionary or militant groups such as Stokely Carmichael, H. "Rap" Brown, Elijah Muhammad, and Maxwell Stanford.

At this time the Bureau is setting up no requirement for status letters to be periodically submitted under this program. It will be incumbent upon you to insure the program is being afforded necessary and continuing attention and that no opportunities will be overlooked for counterintelligence action.

This program should not be confused with the program entitled "Communist Party, USA, Counterintelligence Program, Internal Security - C." (Bufile 100-3-104), which is directed

against the Communist Party and related organizations or the program entitled "Counterintelligence Program, Internal Security, Disruption of Hate Groups," (Eufile 157-9), which is directed against Klan and hate-type groups primarily consisting of white memberships.

All Special Agent personnel responsible for the investigation of black nationalist, hate-type organizations and their memberships should be alerted to our counterintelligence interest and each investigative Agent has a responsibility to call to the attention of the counterintelligence coordinator suggestions and possibilities for implementing the program. You are also cautioned that the nature of this new endeavor is such that under no circumstances should the existence of the program be made known outside the Bureau and appropriate within-office security should be afforded to sensitive operations and techniques considered under the program.

Mo counterintelligence action under this program may be initiated by the field virtuour specific prior infeau authorization.

You are urged to take an enthusiastic and imaginative approach to this new counterintelligence endeavor and the Eureau will be pleased to entertain any suggestions or techniques you may recommend.

BACKGROUND

By letter dated 8/25/67 the following offices were advised of the beginning of a Counterintelligence Program against militant Black Nationalist-Hate Groups:

Each of the above offices was to designate a Special Agent to coordinate this program. Replies to this letter indicated an interest in counterintelligence against militant black nationalist groups that foment violence and several offices outlined procedures which had been effective in the past. For example, Washington Field Office had furnished information about a new Nation of Islam (NOI) grade school to appropriate authorities in the District of Columbia who investigated to determine if the school conformed to District regulations for private schools. In the process WFO obtained background information on the parents of each pupil.

The Revolutionary Action Movement (RAM), a pro-Chinese communist group, was active in Philadelphia, Pa., in the summer of 1967. The Philadelphia Office alerted local police, who then put RAM leaders under close scrutiny. They were arrested on every possible charge until they could no longer make bail. As a result, RAM leaders spent most of the summer in jail and no violence traceable to RAM took place.

The Counterintelligence Program is now being expanded to include 41 offices. Each of the offices added to this program should designate an Agent familiar with black

nationalist activity, and interested in counterintelligence, to coordinate this program. This Agent will be responsible for the periodic progress letters being requested, but each Agent working this type of case should participate in the formulation of counterintelligence operations.

GOALS

For maximum effectiveness of the Counterintelligence Program, and to prevent wasted effort, long-range goals are being set.

- 1. Prevent the coalition of militant black nationalist groups. In unity there is strength; a truism that is no less valid for all its triteness. An effective coalition of black nationalist groups might be the first step toward a real "Mau Mau" in America, the beginning of a true black revolution.
- 2. Prevent the rise of a "messiah" who could unify, and electrify, the militant black nationalist movement. Malcolm X might have been such a "Messiah;" he is the martyr of the movement today. Martin Luther King, Stokely Carmichael and Elijah Muhammed all aspire to this position. Elijah Muhammed is less of a threat because of his age. King could be a very real contender for this position should he abandon his supposed "obedience" to "white, liberal doctrines" (nonviolence) and embrace black nationalism. Carmichael has the necessary charisma to be a real threat in this way.
- 3. Prevent violence on the part of black nationalist groups. This is of primary importance, and is, of course, a goal of our investigative activity; it should also be a goal of the Counterintelligence Program. Through counterintelligence it should be possible to pinpoint potential troublemakers and neutralize them before they exercise their potential for violence.
- 4. Prevent militant black nationalist groups and leaders from gaining respectability, by discrediting them to three separate segments of the community. The goal of discrediting black nationalists must be handled tactically in three ways. You must discredit these groups and individuals to, first, the responsible Negro community. Second, they must be discredited to the white community,

both the responsible community and to "liberals" who have vestiges of sympathy for militant black nationalist simply because they are Negroes. Third, these groups must be discredited in the eyes of Negro radicals, the followers of the movement. This last area requires entirely different tactics from the first two. Publicity about violent tendencies and radical statements merely enhances black nationalists to the last group; it adds "respectability" in a different way.

5. A final goal should be to prevent the long-range growth of militant black nationalist organizations, especially among youth. Specific tactics to prevent these groups from converting young people must be developed.

Besides these five goals counterintelligence is a valuable part of our regular investigative program as it often produces positive information.

TARGETS

Primary targets of the Counterintelligence Program, Black Nationalist-Hate Groups, should be the most violent and radical groups and their leaders. We should emphasize those leaders and organizations that are nationwide in scope and are most capable of disrupting this country. These targets should include the radical and violence-prone leaders, members, and followers of the:

Student Nonviolent Coordinating Committee (SNCC) Southern Christian Leadership Conference (SCLC) Revolutionary Action Movement (RAM) Nation of Islam (NOI)

Offices handling these cases and those of Stokely Carmichael of SNCC, H. Rap Brown of SNCC, Martin Luther King of SCLC, Maxwell Stanford of RAM, and Elijah Muhammed of NOI, should be alert for counterintelligence suggestions.

INSTRUCTIONS

Within 30 days of the date of this letter each office should:

1. Advise the Bureau of the identity of the Special Agent assigned to coordinate this program.

- 2. Submit a very succinct summary of the black nationalist movement in the field office territory. Include name, number of members and degree of activity of each black nationalist group. Also state your estimate of each group's propensity for violence. This is for target evaluation only, not for record purposes. Second, list Rabble-Rouser Index subjects who are militant black nationalists and any other militant black nationalist leaders who might be future targets of counterintelligence action because of their propensity for violence. Include a minimum of background information on each person listed; a few descriptive sentences should suffice.
- 3. List those organizations and individuals you consider of such potential danger as to be considered for current counterintelligence action. Briefly justify each target.
- 4. Submit any suggestion you have for overall counterintelligence action or the administration of this program. Suggestions for action against any specific target should be submitted by separate letter.
- 5. Submit, by separate letter, suggestions for counterintelligence action against the targets previously listed as field-wide. These should not be general, such as "publicize Stokely Carmichael's travel to communist countries," but should be specific as to target, what is to be done, what contacts are to be used, and all other information needed for the Bureau to approve a counterintelligence operation.

Thereafter, on a ninety_day basis, each office is to submit a progress letter summarizing counterintelligence operations proposed during the period, operations effected, and tangible results. Any changes in the overall black nationalist movement should be summarized in this letter. This should include new organizations, new leaders, and any changes in data listed under number two above. Suggestions for counterintelligence operations should not be set out in this progress letter. Use the following captions:

1. Operations Under Consideration, 2. Operations Being Effected, 3. Tangible Results, and 4. Developments of Counterintelligence Interest. These 90-day progress letters are due at the Bureau the first day of March, June, September, and December, excepting March, 1968.

The effectiveness of counterintelligence depends on the quality and quantity of positive information available regarding the target and on the imagination and initiative of Agents working the program. The response of the field to the Counterintelligence Program against the Communist Party, USA, indicates that a superb job can be done by the field on counterintelligence.

Counterintelligence operations must be approved by the Bureau. Because of the nature of this program each operation must be designed to protect the Bureau's interest so that there is no possibility of embarrassment to the Bureau. Beyond this the Bureau will give every possible consideration to your proposals.

RE: WASHINGTON SPRING PROJECT

On March 20, 1968, a confidential source, who has furnished reliable information in the past, furnished the following information:

On March 28, 1968, at 8 P.M., in the Walnut Hill Elementary School in Petersburg, Virginia, one Julia Brown, who is connected with the American Opinion Speakers' Bureau. Belmont, Massachusetts, will be featured as a speaker.

The speaking engagement is open to the public and is sponsored by a group known as "Truth About Civil Turmoil" (TACT).

The source further added that one Charles W. Cover, 1755 East Boulevard, Petersburg, Virginia, is the President of "TACT".

The source stated that according to Cover, "TACT" is a local nonpolitical organization which is interested in local and civic activities.

The source advised that "TACT" was formed after C. W. Cover received notification that Julia Brown could be obtained as a speaker. In the proposed speech to be held on March 28. 1968, Brown will speak on the Communist connections of Martin Luther King and various civil rights organizations. She will depict how she, thinking she was joining a legitimate civil rights organization, in fact was initiated into the Communist Party, and then became a confidential source of information to the Federal Bureau of Investigation (FBI).

RE: WASHINGTON SPRING PROJECT

Leaders of "TACT" have indicated that the principal reason for scheduling Brown as a speaker was to have her precede the appearance of Martin Luther King in the southside Virginia area. King is scheduled to tour Virginia on March 30, 1968. Charles W. Cover has indicated that Brown's speaking engagement should have the effect of diminishing King's recruiting efforts for the WSP and possibly keep King from coming to the southside Virginia area entirely.

On March 19, 1968, Captain J. E. Towler, Danville Police Repartment, Danville, Virginia, advised that Mrs. Julia Brown, above, will speak at the Danville City Armory (auditorium) on March 27, 1968. Captain Towler stated her appearance in Danville is being sponsored by the Committee described as 'an ad hoc committee", and that the identities of persons serving on this committee are not known. According to Captain Towler, Mrs. Brown is to be advertised in advanced publicity as a former undercover agent of the FBI. She will speak on the Communist connections of Dr. Martin Luther King. Captain Towler stated it appears that Mrs. Brown's appearance in Danville is aimed at being disruptive of the efforts of Dr. King in this area and of southside Virginia during his visit on March 30, 1968.

Captain Towler stated that to date this 'ad hoc committee" has declined to reveal its name or membership.

It is noted that it has been reported previously that tentative plans of Dr. King call for his appearance in Danville, Virginia, on March 30, 1968.

A characterization of the Southern Christian Leadership Conference is attached.

SOUTHERN CHRISTIAN LEADERSHIP CONFERENCE (SCLC)

The November 19, 1960 issue of "The Richmond Times-Dispatch" reported that approximately sixty Negro church, professional and lay leaders throughout Virginia met on November 18, 1960 in Petersburg, Virginia and organized the Virginia Christian Leadership Conference (VCLC) for the purpose of "Bringing about civil rights for all."

It was pointed out that VCLC is an affiliate of the SCLC of Atlanta, Georgia.

The purpose of SCLC was reported to "redeem the soul of America by creating the beloved community through organization, by consent of population, for the purpose of creative protest by education, training, developing leadership based on Christian non-violent principles."

- 1. SA THOMAS J. O'DONNELL, JR. has been assigned to coordinate captioned program for the Richmond Division.
- 2. The only Black Nationalist Movement known to exist in the Richmond territory is the Nation of Islam (NOI). This organization consists of one Mosque (Muhammad Mosque #24) in the City of Richmond, with about 35 hard-core members, 8 of whom are officers. This Mosque holds regular weekly meetings.

It should be pointed out that in 1957, when the NOI was formed in the Richmond area, it had approximately 75 to 80 members. This membership figure remained fairly constant for the next three to five years after which a steady decline in membership began and is continuing today.

It is also noted that the Richmond Office has informant coverage of this organization and through its informants and other sources has determined that the NOI in Richmond is a non-militant black nationalist group. Richmond NOI members are constantly taught to avoid all forms of violence and to use force only to defend oneself and then only when absolutely necessary. Any infraction of this rule results in the guilty member being suspended.

The members of Muhammad Mosque #24 generally have little schooling and hold menial jobs such as porters, etc. About one-third of the current members are unskilled farmers from the suburbs, Richmond. The Richmond Office knows of no member of this Mosque who possesses the potential to be a rabble-rouser.

Accordingly, Richmond believes that the Richmond NOI's propensity for violence is low.

The Richmond Division does not have any militant black nationalists on its Agitator Index. The Richmond Division knows of no militant black nationalist leaders within its territory who have a propensity for violence.

3. As set forth in paragraph 2 above, Richmond knows of no organizations and individuals within its territory that should be considered for current counterintelligence action under the present standards of this program.

It is noted that Richmond is constantly on the alert for information regarding militant organizations. Intensive efforts have recently been undertaken to develop Negro racial informants in order to assure Richmond is cognizant of the formation of any militant black groups as well as to develop additional coverage in the NOI and Negro ghetto-type areas.

- 4. Richmond believes that one of the best ways to thwart the efforts of militant black nationalist groups and individuals is to discredit them. In this regard it is felt that the offices of origin on said groups and individuals should fully develop and furnish to interested offices any derogatory information developed so that this information can be "released" to appropriate news media, informants and sources. By "releasing" derogatory data prior to a speech or appearance of a militant would assist in planting the seed of distrust and thereby diminish the militants' effect.
- 5. Since Richmond has not been in a position to have first-hand experience in investigating any of the field-wide militant targets of this program, it is not in a position to furnish other than general type suggestions for counterintelligence action. However, inasmuch as the Bureau does not desire general suggestions, none will be submitted herewith.

In view of the information set out above, on a UACB basis, Richmond will not submit a 90-day progress letter summarizing

proposed counterintelligence operations, operations effected and tangible results. In lieu thereof, Richmond will submit a 90-day letter on the dates designated in re Buairtel, which will advise the Burcau of the results of Richmond's efforts to identify any militant black organizations and/or individuals within the Richmond territory. Should any such organization and/or individuals be identified, Richmond will propose appropriate counterintelligence operations for Bureau approval.

The Bureau authorized furnishing the source data on a confidential basis and the show appeared 7/7/68. A great deal of research was done by Miami Agents and it resulted in an excellent program. The show, which ended with quotes from the Director on the nature of the New Left, was so well received that the television station received requests for a film of the show by local civic groups.

As you are aware publicity about New Left and black nationalist groups, especially television coverage, sometimes enhances the stature of these groups. At the same time, Miami has demonstrated that a carefully planned television show can be extremely effective in showing these extremists for what they are. Local New Left and black nationalist leaders were interviewed on the show and seemed to have been chosen for either their inability to articulate or their simpering and stupid appearance.

Miami furnished a film of this show for Bureau review and it was apparent that the television source used the very best judgment in editing comments by these extremists. He brought out that they were in favor of violent revolution without their explaining why. But he also brought out that they, personally, would be afraid to lead a violent revolution, making them appear to be cowards. The interview of black nationalist leaders on the show had the leaders seated, ill at ease, in hard chairs. Full-length camera shots showed each movement as they squirmed about in their chairs, resembling rats trapped under scientific observation.

Each counterintelligence office should be alert to exploit this technique both for black nationalists and New Left types. Miami learned from sources that those who appeared on the show realized that it presented them in a most unfavorable light. One even complained to the television station about it, This counterintelligence operation will be of great value in the South Florida area

and the Bureau hopes these results can be duplicated in other offices. Success in this case resulted from hard work and acumen on the part of the Agents who handled the matter. Especially important was the choice of individuals interviewed as they did not have the ability to stand up to a professional newsman. The fine job of interviewing and editing done by the news people involved was also most important.

Each office should be alert to the possibility of using this technique. No counterintelligence action should be taken without Bureau authority. For your information operations of this type must be handled through reliable, established sources and must be set up so that the FBI is not revealed as the source.

Investigation by the Richmond Division has failed to develop any additional information regarding the existence of a group called the "Council for Cultural Consciousness" or of its alleged purposes.

The initial information developed regarding this organization was received from a person who claimed to be associated with said organization. Subsequent interviews with this person succeeded in eliciting information concerning meetings and membership of the alleged organization; however, investigation has proven this information to be false.

However, a PRI, who is under development regarding Negro matters, has been determined to be an associate of the person who furnished the initial information regarding the Council for Cultural Consciousness. This PRI has been instructed to be alert for information regarding the existence of said group and should such information be received, Richmond will determine whether it is a militant organization.

Richmond is continuing its efforts to identify militant black organizations and/or individuals within its territory and should positive results be achieved, Richmond will propose appropriate counterintelligence operations for Bureau approval.

THE TO ULTIME UP

The deepening schies within the Negro community over toctics goals, gleefully fostered by insensitive and irresponsible medio, is headed toward a region internal crisis requiring each of us to stand up and be counted. Differences among black folk in this country are not new, but a new ingredient has been added—the attempt by a small minority of black extremists to force compliance with its views and tactics. This nihilistic minority professes disdain for all "white" values while at the same time invoking and utilizing, as instruments of controversy, the worst proctices of the most benighted stratum of white society, to wit, obscene name-calling, threats, intimidation, suppression of opposing views and violence.

The emergence of this swoggering band of black extremists demanding abondonment of democratic methods and goals and a reversal of the trend toward integration must be met head-on by the vost majority of Negroes who reject the minority's toolics and goals. To be sure, the new mood has been generated by white America's historic racism. In turn, the new black mood nurtures further white racism.

Compaigning in New York City lost month, Senotor Edmund S. Muskie, the Democratic namines for Vice President, challenged responsible people of both races to speak up. "We must break through the terrible cycle of action and reaction, assoult and counter-assoult, hatred and response to hatred," he soid.

"The only way to break this vicious cycle," Senator Muskie continued, "is for the moderates in both communities to cope with the merchants of hate and violence within their own ranks. To date, the moderates—both black and white—have been too silent."

On our part, os on the port of white folk, there is urgent need for strong and unequivocal re-affirmation of our commitment to the democratic processes as a means of attaining, here in our homeland, full, equal and unfettered rights for America's 22,000,000 block folk. This means a repudiation of the nihilism of the extremists who are shrilly and insistently espousing apartheid; rocism, including anti-Semitism; intimidation and violence.

Most fotuous of the extremists' exhortations is the call for "black revolution"—the seizure of power by the Negro minority. Any revolution remotely possible in this country of this time would not be one that advances the position and couse of Negroes. Rather it would be a revolution of the Right suppressing not only the black community but also curtailing the basic liberties of the total society.

Repeated surveys and polls by reputable and importial opinion testers show that this minority misrepresents the true views and aspirations of the majority of the nation's Negro population. A September, 1969, survey by the Columbia Broadcasting System found that the "great majority of Negroes still want integration and want to achieve equality through legal means. Only a very small minority of Negroes approve of violent toctics, nine out of ten in the survey expressing disapproval of violence to achieve equality."

Notwithstanding the evidence that the Negro masses remain committed to the program and tactics which have brought substantial gains in the struggle for equality, the voices within the Negro community which publicly express this majority view have been few and, often, lanely. Partly this has been because of a tendency on the part of the news media to by-pass spakesmen for the majority and to project the minority spakesmen as the authentic voices of the Negro community. There is the additional factor that responsible leaders who speak out against the extremists have been subjected to threats of violence. Marcover, Negro leaders have traditionally been reluctant to speak out publicly in apposition to other black spakesmen.

But the time has come for speaking out loud and clear lest the entire race be branded as hate-mangers, segregationists, advocates of violence, and warse. The silent majority must let its views be known not merely in polls but also in print, on the rostrum, and via radio and television. The time for silence or muted voices is past. The extremists must be answered promptly and forthrightly in the name of the majority. Their racisin and anti-Sentitism DocId: 59167143 Page 34

In a message to the founding conference of the National Association for the Advancement of Colored People in 1909, William Llayd Garrison expressed the hope "that the Conference will utter no uncertain sound on any point affecting the vital subject. No part of it is too delicate for plain speech."

So it is today. Let there be "no uncertain sound" on the issue confronting us. To make the record clear, let us repeat again and again so that none need be unaware of the Truth: Black America rejects and condemns separation, racism, intimidation, suppression of free speech, and violence. Let it be known that the preachers of hate, the defeatists afraid to campete in the open market, the name callers who substitute epithets and slogans for reason, the exherters who summon Negra youth to death in futile shoot-outs with the police and the military—let it be known that these media-created "leaders" ore not our spokesmen.

Dissent, protest and militancy, yes. Intimidation, disruption, suppression of free speech, extremism and violence, nol

The time to speak up in no uncertain terms, to rally the silent block majority to a constructive program of responsible militancy and resistance to extremism, is now. Tomprov may be too late.

Efforts to identify militant black organizations within the Richmond territory have, to date, met with negative results. However, through Negro racial informants, Richmond has identified EDDIE SLATER, JR., as a militant black individual.

Information received from a Richmond informant identified SLATER as the person responsible for the burning of a U. S. flag at the Van de Vyver School, Richmond, Va., in early February, 1959. As a result of this information Richmond opened a case now entitled "EDDIE SLATER, JR., aka Eddie Slater, Eddie McGee, McGee Slater, Desecration of the Flag", 00: RH, RH 180-2, and was able to furnish pertinent information to the Richmond PD which assisted that agency in conducting an investigation of the aforementioned flag burning.

It is noted that the Richmond PD arrested SLATER on 2/26/69, and charged him with burning a U. S. flag at the Van de Vyver School on 2/7/69. This information has been brought to the Bureau's attention under the 180-classification. It is further noted that SLATER's arrest received publicity on Richmond radio and TV and in the Richmond morning newspaper, which publicity exposed SLATER as a "militant."

Richmond anticipates that SLATER's case in local court will continue to receive publicity adverse toward SLATER. Richmond is following SLATER's case closely with the local authorities and should any counterintelligence action be deemed appropriate, fitting recommendations will be submitted to the Eureau.

Richmond is continuing its efforts to identify militant black organizations and/or individuals within its territory and should positive results be achieved, Richmond will propose appropriate counterintelligence measures for Eureau approval.

Washington, DC September 4, 1969

There was a regular membership meeting of the Black United Front held at the Douglas Memorial Methodist Church, 11th and R Streets NV, Washington, DC on the evening of 9-3-59; the meeting started about 8:30PM. The reverend Douglas Moore presided.

The minutes of the previous BUF meeting were approved. Tony Cox, the Field Chairman said that all BUF legal business would be handled in the future by Mrs Wilhelminia Jackson Rolark, who is the wife of Calvin Rolark.

Ab Jordan of the Communications Committee said that they had filed the petition for the prot est against the renewal of the TV license for station WMAL with the FCC; he believes that the BUF case against WMAL is air tight. Other members of BUF are to visit other TV stations in order to check on programming and employment for blacks. Jordan thanked Oscar Griffin for his part in supplying the transportation in getting the petitions ready.

Stanley Williams of the Youth Committee said that they are conducting orientation sessions in various sections of the black community for the youth.

They have a commitment from MOTOWN for sometime in 10-69 for a benefit performance. No place as yet has been secured in which to hold this performance however.

Jan Bailey said that his Pan African Committee would hold at meeting in his apartment at 2400 16th Street NV on 9-11-69.

Arthur Young for the Educational Committee said that they have not endorsed any candidates for the DC School Board as yet, but are waiting until all the candidates have declared themselves. Cox said that Young was up for induction in the army soon and is thinking about refusing to go; he might need some BUF assistance.

Moore appointed Clyde Smith and a new comer Julius Mack to head up a Labor Committee; they will handle local labor disputes concerning blacks. He also wants them to look into the status of Negroes in labor unions.

Mack thought that the BUF should set up some sort of draft counselling service. He said however that for the time being, that they use of the facilities of the service at the All Souls Unitarian Church.

Moore said that the New Mobilization Committee had approached the BUF in seeking BUF participation in an anti-PVIL 19216 West Research tration on 11-15-69. He said that he was not asking any members or the Central Committee to vote on this participation as yet as he did not think that they would approve of such participation. Moore said that this would violate the policy that the Central Committee established that if the BUF is going to participate in anything, they must be the dominant group. He said that he demanded \$25,000 to be paid in advance or else a colonial head tax of \$1 for everyone who participates in the demonstration. He said that on this basis, the Central Committee is continuing to negotiate with the New Mobilization Committee. Moore said that if the New Mobilization refuses to pay, he will get some of the young boys and the demonstrators will think they are in Tony Cox said that as far as he was concerned, he was not interested in the BUF participating in the demonstration at all; all he wanted was the money and he was not particular how they got it. Moore said the policy of demanding money from all groups who want to demonstrate will apply to all groups, white, balck or mixed. He said it would apply to all groups coming to Washington for demonstrations, parades and conventions.

Moore announced that a BUF Chapter has been founded in Arlington, Va., consisting primarily of young men. Moore said that he was out of town last Sunday, but gave this Chapter permission to have a trial run to upset the bourgeoisie Negroes who attend his church in Arlington. He understands that members of the Chapter marched into the Church in dashikis and bare feet, and one of the borthers conducted a sermon on revolution and violence. The Arlington BUF chapter has voted that at 11:00 a.m. on this coming Sunday, 9/7/69, they will march into Resurrection Lutheran Church in Arlington, and which is the Church attended by US Congressman Joel Broy-The group will demand 10 per cent of the Church's captial budget. Cox said that this is not to be considered part of the Black Manifesto of James Forman, but is the action of the BUF Chapter in Arlington. Moore asked the Wash. D. C. BUF to support the Arlington chapter in this They voted to support the Arlington Chapter and Tony Cox is in charge of the participation of the Wash. D.C. chapter. At the meeting printed directoions were issued as to the location of the Resurrection Lutheran Church.

Moore then authorized Julius Mack to lock into the dates of the various Jewish Holydays and to determine the location of the various Synagogues in Washington, Moore is looking into the possibility of making the Jewish Holy Days in September, days of reparation for the poor blacks. He is also looking into the month of October in regard to provide the said that one day in October is known

as the Protestant Reformation Day, and he would make this the Protestant Reparation Day.

Moore advised that his plans for the black UGF have not been completed, especially in regard to the leagal work. He said everything must be legal in this matter as he intends to ask employees to deduct contributions from employees contributing to the black UGF. He is to also ask the employers if he can solicit funds on company time.

Concerning the reception for Dr. James Cheek, President of Howard University, Moore advised that everything has just been about arranged. He advised that it was not to be a social gathering but really, a political gathering. He is not really honoring Cheek but wants Chekk to know who the community is. Each BUF member has five invitation to give out and these should be given to people who might join the BUF.

RE: BLACK UNITED FRONT (BUF)

A source, who has provided reliable information in the past, advised that on September 17, 1969, a group of 13 males and 3 females, all Negro students and juveniles, were suspended for three days from Washington-Lee High School in Arlington, Virginia for disruption of a school day, a violation of a county ordinance.

The source stated that at approximately 8:25 a.m., the above group walked out of Washington-Lee High School, stating that there were no black students represented on the floor of the student assembly that day. The students were told to return to their classes immediately, however, a delay occurred as a result of a discussion period, but they did return to their classes. This source mentioned that they were later suspended for a three day period until they return to school with their parents or legal guardians. The source mentioned that there are 83 Negro students in a total enrollment of 1950 at this high school.

Sergeant Charles Hyden, Arlington County, Virginia, Police Department advised that no arrest and no further disturbances occurred.

A second source, who has provided reliable information in the past, advised on September 11, 1969, that two representatives of the Arlington, Virginia Chapter of the Black United Front (BUF), appeared at the Washington-Lee High School

BLACK UNITED FRONT (BUF)

A source advised that on January 9, 1968, a meeting was held at Washington, D. C., by Stokely Carmichael. At this meeting, the Black United Front, an organization consisting of representatives of Black organizations and individuals was formed in the District of Columbia in order to effect operational unity among and for Black people.

During June, 1968, a second source advised that the Black United Front in an official statement of purpose stated it was established for the purpose of expanding the lines of communication between, and effecting togetherness among all the Black people in the District of Columbia in order that they might obtain a rightful and proportionate share in the decision making councils of the District, and rightful and proportionate control of the economic institutions in the Black community.

The standards for qualification as a member were listed as:

- 1. Any Black individual who has concern and interest in the Black community.
- 2. Any organization whose primary involvement is for the benefit of Black people, provided it has at least a 50% Black constituency and its representative in the BUF is black.

"The Washington Post and Times Herald," a daily newspaper printed at Washington, D. C., in an article on page A-1, dated July 6, 1963, captioned "Slaying of Police Defended," stated:

"The Black United Front issued a statement yesterday describing the slaying of a District Policeman Tuesday night as a 'justifiable homicide.'

"The statement said in part:

"The methods of self defense used by the family charged with the alleged slaying of the honky cop is justifiable homicide in the same sense that police are allowed to kill black people and call it justifiable homicide."

"Several hours later, Mayor Walter E. Washington asserted that the BUF resolution with respect to the slaying of Officer (Stephen A.) Williams....is inflamatory, irresponsible and unfortunate."

"The Washington Daily News," another daily newspaper printed in Washington, D. C., in an article on page 5, dated July 17, 1968, captioned "BUF Takes New Tact" stated in part that the BUF plans to find ways and means to take control of the police force in the District of Columbia.

SA JOHN'HENRY LOVE, JR., has recently replaced SA ROLAND M. COCKER, JR., as coordinator of captioned matter for the Alexandria Division.

Daily contacts with various law enforcement agencies in the Northern Virginia area and close contacts with established sources and racial informants have developed the following information of current interest.

On 9/4/69, FOIA(b)(7) - (D) reported that Rev. DOUGLAS MOORE had announced on 9/3/69, at the Washington meeting of the Black United Front (BUF), that a chapter was being formed at Arlington, Virginia. To date the activities of the Arlington BUF have consisted of a monitary request for reparation at Resurrection Lutheran Church in Arlington and the submission of a list of grievances to the principal of Washington-Lee High School and the Arlington School Board. At the Resurrection Lutheran Church approximately 50 individuals appeared claiming to be members of the Arlington BUF; however, it was noted that TONY COX and a number of other Washington, D. C., BUF members were present in the group. Local spokesmen for the Arlington BUF have been identified as OLIVER BROWN, JR., a U. S. Post Office employee, and SIDNEY WILLIAMS, currently away attending St. Augustine College in North Carolina. Information concerning recent arrest of BROWN for lottering was reported in LHM, resulting in a &GE investigation re BROWN,

and interview of BROWN by a United States Post Office inspector. To date the Arlington BUF has not engaged in or indicated a propensity toward violence. It consists of a small group led by Rev. MOORE, is relatively inactive since MOORE spends most of his time in Washington, D. C., and consists mostly of teenagers.

An incident involving Alexandria Police Department Patrolman CLAIBURN T. CALLAHAN on 10/4/69, led to a series of demonstrations in Alexandria led by LEO BURROUGHS then an official of the Alexandria Urban League, calling for CALLAHAN's dismissal by the police department. no violence occurred at the demonstrations, a series of fire bombings occurred in the evening hours in Alexandria. Four Negro juveniles were arrested by the police department, none of which were identified as being connected with the Urban League, and the bombings ceased thereafter. However, the Alexandria Urban League fired BURROUGHS for not clearing his activities with them and not acting in the best interests of the Negro community. BURROUGHS has since announced organization of a new group called the Black Association for Cultural Advancement (BACA). To date the group has proposed a demonstration calling for CALLAHAN's job. There is no indication that it has a propensity toward violence. According to RI (PROB) Rev. A. A. BOOKER, BURROUGHS' new group suffers from a lack of funds and is likely to fold in the near future.

In view of the lack of activities of black nationalist hate groups in the Northern Virginia area, no counterintelligence operations have been effected or under consideration at the present time. However, Alexandria has pending cases on BUF and BACA as well as its leaders, and their future activities will be closely followed. In the event future activities of these groups fall into a category covered by the above case, appropriate counterintelligence operations will be proposed for Bureau approval.

security officers "Your days are numbered. We're going to kill you." When asked to leave, they called the security people several abusive names and were forcibly ejected from the store. During the altercation, OLIVER BROWN, JR., tried several times to strike one of the security officers but was repulsed.

That same day, OLIVER BROWN, JR., was arrested for using abusive language with trial set for 1/5/70. On 1/5/70, OLIVER BROWN, JR., was found guilty of using abusive language and fined \$350 plus costs, with \$200 suspended.

WARD BRADLEY, Postal Inspector covering Arlington, Va., was previously made aware of the first arrest of BROWN on 9/6/69, but advised that in view of the fact that he was not given a sentence, they would be unable to discontinue his employment with the U. S. Post Office.

Alexandria requests Bureau permission to contact Arlington County Commonwealth Attorney WILLIAM HASSIN, with whom the Alexandria Office has established good rapport for the purpose of making known to him OLIVER BROWN, JR's., recent conviction, with the hope that BROWN will receive a sentence on his original conviction for loitering. It is believed that should he be given a jail term on the original charge, coupled with the recent conviction, these may constitute basis for his dismissal by the U. S. Post Office.

Although the Arlington, Va. chapter of the Black United Front cannot be classified as a hate-type group, they have unsuccessfully attempted to stir up racial hostilities in the Arlington, Va., area, particularly where the police are involved. It is hoped that another conviction for BROWN and dismissal by the Post Office would result in BROWN being discredited in the eyes of local Negroes, lessening his chances of gaining any following in Arlington.

SA JOHN HENRY LOVE, JR., continues to co-ordinate captioned matter for the Alexandria Division. There are currently no operations under consideration or being effected in captioned program in view of the lack of Black Nationalist-Hate Group activities in the Northern Virginia area.

Since referenced Alexandria letter, one counterintelligence measure has been effected by the Alexandria
Division. Referenced Alexandria letter reported the arrest
of OLIVER BROWN, JR., for loitering and subsequent SGE
investigation re BROWN due to his employment as a U.S. Postal
employee. BROWN has been previously identified as a leader
of the Black United Front (BUF) in Arlington, Va., a summary
report has been prepared on BROWN, and Alexandria is awaiting
Bureau approval to place him on the Agitator Index. BROWN
was convicted on instant loitering charge and received a
suspended sentence for a one year period on condition that
he not get in any additional trouble during that one year.

On 1/5/70 BROWN was found guilty of Using Abusive Language and fined \$350 plus cost concerning an altercation he was involved in at the Hecht Company. On 1/19/70, Bureau approval was granted to confidentially advise Arlington County Commonwealth Attorney WILLIAM HASSAN of the 1/5/70 conviction in an effort to bring about grounds for BROWN's dismissal by the U.S. Post Office. This information was confidentially furnished to HASSAN, who brought it to the attention of the

judge who originally sentenced BROWN on the loitering charge. Although the judge has not taken any action on it to date, HASSAN also brought the second conviction to the attention of Arlington Post Master, C. F. SIMPSON, mentioning to him that the second offense occured while BROWN was in a Postal uniform. As a result of this action, BROWN has been fired from the Post Office for conduct unbecoming a Postal employee and reflecting unfavorably upon the postal service during his probation period.

Among developments of Bureau interest during the previous three-month period, it is noted that there has been minimal activity on the part of the Arlington County, Va., The BUF has not had any further confrontations with the Arlington County School Board and has apparently discontinued its program to obtain "reparations" from area churches. Arlington police officials advise that they have not had any problems with the BUF in recent weeks and feel this is due to the fact that Arlington BUF members are spending most of their time in Washington. Alexandria police officials advise that the CALLAHAN incident which lead to racial demonstrations last fall has become a dead issue. They advise that LEO WESLEY BURROUGHS, leader of the Black Association for Cultural Advancement (BACA), a community action group, has recently announced his candidacy for Mayor of Alexandria. During recent weeks BURROUGHS! main project was some picketing of the Diamond Cab Company who BURROUGHS claimed is discriminatory in their hiring practices. Police officials advise that. since BURROUGHS has announced his candidacy for Mayor, he has ceased his militant activities and is even attempting to obtain police votes by including demands for higher police salaries and better working conditions as part of his platform.

LEONARD VICTOR HERNANDEZ, one of BURROUGHS' past associates in militant activities, is currently under application as a patrolman with the Metropolitan Police Department in Washington, D. C., and has been carefulin recent weeks not to

involve himself in controversial issues. With the exception of spontaneous racial confrontations between unassociated individuals of ghetto areas and police, there has not been any racial activities in the Northern Virginia area of a violent nature. Neither the BUF of Arlington nor the BACA of Alexandria have shown a propensity towards violence, and therefore, no counterintelligence action against these groups is presently contemplated. Alexandria has pending cases for BUF and BACA, and their activities are being closely followed. In the event any future counterintelligence action is deemed necessary, Alexandria will submit appropriate recommendations to the Bureau.

The racial situation continues to remain calm in the Northern Virginia area, and no appreciable activity by Black Nationalists - Hate Groups has been reported. On 4/22/70, two Negro males claiming to represent the Black Panther Party appeared for a one-hour speech at George Washington High School in Alexandria but left without incident. The Black United Front of Arlington, Virginia, has been relatively inactive in recent weeks. The Black Association for Cultural Advancement of Alexandria has ceased meeting since its leader, LEO WESLEY BURROUGHS, JR., announced his candidacy for mayor of Alexandria. Most of the Black Association for Cultural Advancement members are currently involved in local political campaigns.

No counterintelligence operations are in effect or under consideration by Alexandria at the present time. Alexandria will continue to remain alert for the appearance of any Black Nationalists - Hate Groups in the Northern Virginia area and will initiate counterintelligence action where needed.

The shooting death of Negro youth ROBIN GIBSON by a white 7-11 Store manager on the evening of 5/29/70, triggered a week of racial violence in Alexandria, Va., that included groups of Negro youths throwing rocks and bottles at vehicles and several fire bombings. However, the situation in Alexandria has returned to normal and the racial situation remains calm in other areas of Northern Virginia. The racial violence in Alexandria was sporadic and not linked to any organized group. There has been a minimum of activity by Black Nationalist Hate Groups in the Northern Virginia area during the past three-month period.

No counterintelligence operations are in effect or under consideration by Alexandria at the present.

Alexandria will continue to remain alert for the appearance of any Black Nationalist - Hate Groups in the Northern Virginia area and will initiate appropriate counterintelligence action when needed.



- INSIDE LABOR -Panthers Urge More Cop Killings

By VICTOR RIESEL-

WASHINGTON—There is an amateurish impression that Black Panther Party

olutionists for sheer desperate want of any other racial base - especially among the youth.

So unique are the Panthers as a guerrilla strike force, they've been sought out by the Maoist Peking Central Com-mittee as "equal brothers" and the Chinese Communists "American Section". There is, in fact, a Black Panther subsidiary international, launched recently in Pyongyang, North-ern Korea, dubbed the New World Liberation Front. It is the Maoist avant-garde in the U.S. and can easily be controlled because it has but 750 hard core members in 27 active chapters-down from the original 41 chapters, many of which were wiped out when the party's central committee in Oakland discovered the "or-ganization" had been infiltrat-

Thus, the black strike force can be easily financed, controlled, directed and purged at will—though the thousands of sympathizers are less disciplined and get themselves caught up in the killer rhetor-

THE SYMPATHIZERS get on the hook. like an addict to a needle, by taking the Black Panther, official party publication. Trouble with the "outside" world is few ever bother to read it and thus can't un-

derstand its deadly impact.
As recently as Nov. 22, 1969, Panther leader Eldridge Cleaver, now setting up a BPP embassy in Algiers, is quoted as saying, "...we will kill Richard Nixon..." Mr. Cleaver is officially Minister of Information.

There have been vicious anti-Semitic attacks. There have been gay and ghoulishly gloating reports of the killing of police. As, for example the shooting of a Cleveland cop. The Oct. 3, 1970, issue of the Panther newspaper says:
"...one pig dead, one pig
wounded at the hands of the
Lumpen." Meaning the lumpenproletariat, an old Leninist word.

So the people now are the "lumpen" in the new uptight guerrilla community.

This cop was shot when he rushed to help his partner — who had been hit by bullets who had been hit by bullets in the mouth, chest and groin. The rescuer was thrown into the gutter. Then, says the Panther newspaper, "after a scuffle with this pig, the lumpen (in the correct manner) knocked the pig down, took his gun and fired into the pig, bang, bang, dead pig!" bang, bang, dead pig!'

Each week there are car-toons, such as the one showing a worker with three sticks of dynamite in one pocket, a shovel in his right hand and an old-fashioned "Colt" in the other. Or there is a drawing of a man about to hit a cop over the head with an axe. The patrolman has his back to the assailant. Little of this goes

unobserved by big city police -especially such as those in Los Angeles or New York City (where the 25,000-member police union, Patrolmen's Benevolent Association, has learned soon will be flooding streets under the swinging title of "Pigs Today, Bacon Tomorrow"). that new Panther literature

Well, cops are brothers, be they black or white. And their brothers are Teamsters, construction workers as well as doctors, university people and bricklavers.

And each week, brothers of brothers are assailed by 180,-000 copies of the Panther newspaper—"assailed" being a euphemism for outright calls for their murder.

Late this summer some West Coast authorities were approached by a brother of brothers. He was-and is-a black union Teamster. He had with him some of the Panther material being distributed in his community. This black teamster was tough—and mili-tant—but the "literature" was not his thing.

The authorities listened, and in turn pulled out sheafs of editions of "The Black Pan-ther." They leafed through pages of vituperation, threats to national authorities, happy reports of police killings and the ubiquitous cartoons. They read the rules, one of which prohibits a Panther from joining any "other armed force other than the Black Liberation Army."

They read attacks on labor and urgings by the Panthers that unions be seized, and used for revolutionary action.

The Teamster asked how the 180,000 copies were distributed to and inside the nation's major cities - since at 25 cents apiece 180,000 sales weekly can develop quite an income. The Teamster, an air freight handler, was told much of the distribution was by air.

HE RECALLED reading reports on the East Coast International Longshoremen's Association (AFL-CIO) boycotting the Soviet merchant and passenger ships for some 20 ears. So he returned to his fellow unionists with the suggestion they refuse to handle or help airlift the Panther newspaper.

The boycott may or may not come off. It may turn out to be little more than a one-man counter-revolution. That's not as important as the fact that some men of the "outside" world have read the Panther strike force agitational material. Those who have not, haven't the slightest conception of Pantherism. More's the pity. The Panthers print it right out in the open. Not even in the days of ancient anar-cho-syndicalism has there been such tough talk, such blunt calls for blood and killings as in the Panther literature. It's Maoist all the way.

I write this with restraint. Some of the provocative quotes are unprintable anywhere but in some underground press. But the same restraint will not be shown sooner or later by those whose brothers are killed on the streets protecting others.

At least let reason prevail among the public, regardless of race, color or creed. At least let the public be aware of the force striking from within.

Portion of column deals with proposal that union members refuse to handle shipments of BPP newspapers. Obviously if such a boycott gains national support it will result in effectively cutting off BPP propaganda and finances; therefore, it is most desirable this proposal be brought to attention of members and officials of unions such as Teamsters and others involved in handling of shipments of BPP newspapers. These shipments are generally by air freight. The column also deals with repeated calls for murder of police that appear in BPP paper; therefore, it would also be desirable to bring boycott proposal to attention of members and officials of police associations who might be in position to encourage boycott.

Each office anonymously mail copies of enclosed to officials of appropriate unions, police organizations or other individuals within its territory who could encourage such a boycott. Use commercially purchased envelopes and take appropriate measures to insure mailing cannot be traced to Bureau. Make no dissemination of this column other than anonymously.

Handle promptly and advise Bureau of any positive results noted. Any publicity observed concerning proposed boycott should be brought to attention of Bureau.

Be alert for any other opportunities to further exploit this proposal. Submit any suggestions to Bureau for approval prior to taking action.

During the past three months period, the Alexandria Division had one spontaneous racial outbreak in the rural Gum Springs area of Fairfax County that led to a week of racial disorders by local Negro youths. The situation in Gum Springs has presently returned to normal. BPP sympathizers attempting to organize and gain support in the Alexandria Division have been unsuccessful to date.

Alexandria has determined that BPP newspapers for the NCCF Chapter in Washington, D.C., are delivered to the area via TWA and United Air Lines. Copies of the editorial entitled, "Panthers Urge More Cop Killings" by VICTOR RIESEL were anonymously mailed in unmarked "store bought" envelopes on November 25, 1970, from Arlington, Virginia, to:


