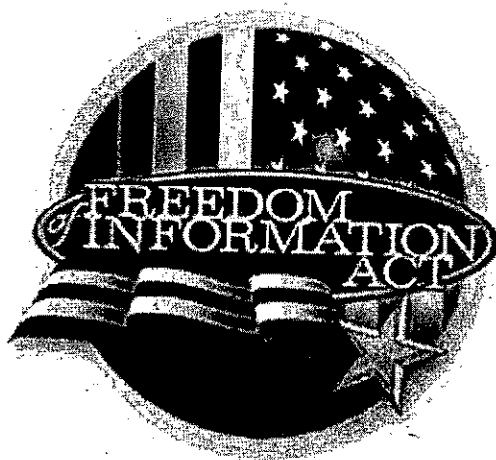

QUARTERLY PROGRESS LETTER

Set forth below is current information concerning the counterintelligence program being directed towards the captioned organization:

National Klouvation of UKA,
Salisbury, N. C., 6/27-28/70

Referenced Charlotte airtel set forth counterintelligence recommendations, and referenced Bureau airtel authorized certain counterintelligence techniques to be used in connection with the National Klouvation.

In accordance with the recommendations and authorization granted, the following action was accomplished:

(1) Undated letter on the letterhead of North Carolina State of UKA, bearing the signature of North Carolina [redacted] and setting forth the fact that the National Klouvation was to be held on the college campus, was forwarded anonymously by mail to one member of the Board of Trustees of Catawba College, Salisbury, N. C., who resided

Following this mailing and allowing sufficient time for delivery, anonymous telephone calls critical in nature of the college furnishing facilities to the Klan for its National Klouvation were made to the following officers and members of the Board of Trustees of Catawba College:

(2) Information concerning the National Klonvokation was furnished to reliable news sources at the "Salisbury Post", Salisbury, N. C., and at the "Charlotte Observer", Charlotte, N. C., the latter giving coverage throughout the State of North Carolina. These articles were timed to appear a day or so before the Klonvokation so as not to give notification to a large number of Klansmen who may not have been intending to attend the Klonvokation. The articles were used merely as a basis for the anonymous calls subsequently made to the abovementioned individuals.

(3) Anonymous telephone calls were made to the Reservations Clerk at the Howard Johnson and Quality Courts motels, Salisbury, N. C., and reservations for individuals were cancelled. These were primarily a group of men coming to the Klonvokation from Philadelphia who had reservations in the name of [REDACTED] and involved six to eight rooms with two to three men per room. It is felt that these individuals in all probability were able to relocate or obtain space but we believe this added to the aggravation.

Recommendations for Possible Future Action

The Charlotte Division recommends Bureau consideration for the following possible counterintelligence techniques:

(1) In reference to the lottery which the automobile of Imperial Wizard ROBERT BOWEN was raffled off and subsequently won by [REDACTED] it is recommended that consideration be given to furnishing local FBI agents information concerning the lottery, the amount of money allegedly received by the Klan as a result of the lottery, and the identity of the subsequent winner of the car with the purpose of having [REDACTED] contacted regarding declaring the car under taxable income as a "prize". There

Has been some dissension in the past among klansmen to indicate that the lottery may have been "fixed", and it is felt that additional questioning or bringing the matter back into the klansmen's discussions would have a disruptive effect from a financial support standpoint at this time.

(2) At the recent National Klavokation in Salisbury, a resolution was passed which will assess each Klavern \$200 and is to be placed in the National Defense Fund in an effort to build this fund up to \$250,000.

In this connection, it is recommended that Charlotte be authorized to arrange for wide distribution throughout North Carolina a copy of a news article and comments [REDACTED]

[REDACTED] Comments relate to ARTHUR HANES as being paid \$12,500 and whether he was actually paid or whether this was a fraudulent scheme by the National and North Carolina state Klan officers.

A copy of this article is enclosed for the Bureau, and it is felt that this wide distribution throughout the Klan may further serve to discourage contributions to the National Defense Fund.

The Bureau is requested to consider the above recommendations, and Charlotte will keep the Bureau advised regarding any additional opportunities for counterintelligence action. Charlotte will take no counterintelligence action without prior Bureau approval.

3 Klansmen, 12 Negroes Refused Court Appeals

RALEIGH W.—The North Carolina Court of Appeals has refused because of late filing to consider the appeal of three members of the United Klans of America convicted of inciting to riot.

In other case, also from Hyde County in the eastern part of the state but unrelated, the court refused to overturn the sentences of 12 young Negroes convicted of disrupting a county school during racial disturbances in 1958.

THE DECISIONS were handed down yesterday along with 62 others in what a court spokesman described as the largest group of opinions by the

nine-member court in its three-year history.

The court refused to consider the appeal of the admitted Klansmen because it said the case record was filed 12 days late.

The Klansmen—L. E. Daughtery, Jesse Matthews and James Scott—were convicted of inciting to riot and provoking breach of the peace during a Klan rally July 4, 1969, near the Hyde County community of Middletown. All three received suspended sentences.

Evidence at the trial showed that part of the Klan rally included the playing over a loud-speaker system of records containing songs and jokes insulting to the black race. The recordings could be heard for more than a mile, and Negroes converged on the rally site.

A gunfight broke out in which a Negro girl was shot in the leg and two highway patrolmen were slightly wounded.

In the other Hyde County case, the 12 youths were originally tried in state District Court, where they all received suspended four month sentences and \$100 fines.

They appealed to Hyde Superior Court, were again convicted and were sentenced to 12 months in prison.

Attorneys appealed on the ground that it was unconstitutional for the 12 to receive a more severe sentence in a second trial than in the first.

SPEAKING for the court yesterday, Associated Judge Hugh Campbell wrote: "It is settled law in North Carolina that imposition of a greater

sentence in superior court upon trial de nove (new trial) than was imposed in district court is constitutionally permissible."

The 12 are Larry Midgett, Bradley Johnson, Donnie Blount, Martin Collins, Lonnie Gibbs, Van Gibbs, Henry Johnson, Sammy Bryant, Felton Gibbs, Van Gibbs, Henry Johnson-Coward and Benjamin Phelps.

They were convicted of entering the predominantly Negro O. A. Peay School near Swan Quarter on Dec. 5, 1958, of locking the principal's secretary out of her office and destroying school property.

The youths were protesting a federally approved desegregation plan which would have closed the Peay School and another black school in the county and transferred all students to mostly white Mattamuskeet School.

In connection with your positive recommendations made in relet your attention is directed to Bureau letter dated 9/2/64 captioned "Counterintelligence, Internal Security, Disruption of Hate Groups."

The above Bureau letter set forth the requirement that quarterly letters concerning the Counterintelligence Program be submitted and also stated that recommendations for counterintelligence action should not be included in these quarterly letters.

Accordingly, the recommendations set forth in your letter of 6/30/70 should be resubmitted along with additional details.

The details should include the following:

1. Information in your files as to whether Internal Revenue Service was ever furnished information concerning the lottery conducted by the United Klans of America.

2. Information in your files as to whether [redacted] ever included in his income tax return the fact that he won the lottery conducted by the Klan.

3. Specific details as to how discussions concerning the lottery among klansmen would bring about a disruptive effect from a financial support standpoint at this time.

Recommendation For Counterintelligence Action

(1) At the time the automobile of Imperial Wizard
ROBERT SHELTON was raffled off many klansmen expressed the
feeling that the raffle had been "fixed". This feeling arose
from the fact that the winner of the automobile [REDACTED]

[REDACTED] During this time there
were also rumors prevalent among klansmen concerning a
statement by [REDACTED] that he had "paid" \$1,000 for the automobile.
Following this there were reports that [REDACTED] had
met with an attempt to resolve the fact that [REDACTED] had actually
"won" the automobile. Many of the klansmen were never
completely satisfied with the explanations furnished by [REDACTED]
and other Klan officers concerning this particular raffle.

It is recommended that consideration be given to
furnishing local IRS agents information concerning this
raffle, as well as the amount of money allegedly received by
the Klan as a result of the raffle, which was reported at the
recent National Klonvokation. IRS should also be furnished
the name of [REDACTED] as the winner with IRS to ascertain whether
the "prize" was reported by [REDACTED] on his income tax forms.

It is believed that in the event it is shown that [redacted] did not report the automobile as a "prize" his allegation will probably be that he bought the automobile in his normal course of business, inasmuch as [redacted]. Should this occur it is felt that considerable dissension could be created by publicizing through leaflets or other means to the UKA membership generally that the raffle for the Imperial Wizard's automobile was a fraud. This should deter members from participating in future raffles and other fund raising activities put forward by the Klan.

IRS has never been furnished information concerning the raffle of the Imperial Wizard's automobile, and it is not known whether [redacted] ever included in his income tax return the fact that he won the automobile in the raffle.

It is felt that such actions, if successful, would impair greatly future attempts by the Klan to raise money through lotteries or raffles.

(2) At the recent National Klonvokation in Salisbury, a resolution was passed which will assess each Klavern \$200 and is to be placed in the National Defense Fund in an effort to build this fund up to \$250,000.

NOTE:

While Robert Shelton was in jail the Klan had a raffle for his automobile. Charlotte recommends that the IRS locally be advised of the exact amount of money the Klan made as well as the winner so that IRS can conduct appropriate investigation in this matter. Charlotte also stated there has been some dissension in the past among klansmen to indicate that the lottery may have been "fixed" and it is felt that additional questioning or bringing the matter back into the klansmen's discussions would have a disruptive effect from a financial support standpoint. In addition, at the recent National Klansmen's convention it was passed that every klavern would be assessed \$200. [REDACTED], a former leader in the United Klans of America, has broken away and has alleged that there has been mishandling of Klan funds. He further alleged that in connection with a \$12,500 payment to an attorney that this was a fraudulent scheme by the National and North Carolina State Klan officers. [REDACTED] in connection with a newspaper article printed the following on this article, "What happened to the \$12,500 lawyer? Did he really get \$12,500 or was this a big fraud?" Charlotte recommended anonyr mailing of this newspaper article with Bryant's comments in order to bring about further dissension within the Klan ranks.

The Bureau also authorized for additional distribution throughout North Carolina a copy of a news article [redacted] relating to the payment of \$12,500 to ARTHUR HANES, indicating that this may have been a fraudulent scheme by Klan officers.

[redacted] additional mailings of this article have been made to various Exalted Cyclops and Units in the UKA, and informants have indicated that this has caused additional ill feeling particularly in regard to money matters among UKA Klansmen.

It is felt advisable to stress the continual demand for money in UKA in North Carolina, and Charlotte will continue to make recommendations in this regard as opportunities arise. It is felt that the additional mailings set out above have been productive from the standpoint of again irritating the membership on a point where many of them are already dissatisfied. Upon receipt of additional information from IRS in regard to the other matter, Charlotte will make further recommendations in that time.

By separate communication, Charlotte has requested the Bureau's consideration and approval in furnishing information to friendly press contact regarding the "500 Club." The operation of this was set out in Charlotte's letter to the Bureau, 9/30/70, and it is felt that publicity from such an article in the manner set out in the communication will have a tendency to reduce the effectiveness of [redacted] endeavors in this regard.

Charlotte will take no further counterintelligence action without Bureau approval and will make additional recommendations as opportunities arise.

During the National Klonvokation at Sal Shury, North Carolina, in June 1970, North Carolina [redacted] and Imperial Wizard SHELTON elaborated to some of the members concerning a "500 Club".

This Club was to provide the membership with protection during periods of racial violence. As explained to some of the members at a meeting following the formal Klonvokation, merchants would be asked to join the "500 Club" by making payments to the UKA. It was believed the payments were at \$500 per year, and the merchant would receive a membership card and the UKA's offer of protection for his business during a period of racial strife in the merchant's community.

Recently in Charlotte, North Carolina, the residence of a Negro family who had moved into a predominately white neighborhood was shot into and thereafter several self-appointed protectors went to the residence to stand guard.

The incident in Charlotte received publicity through the local press, and [REDACTED]

[REDACTED] who is a friendly press contact of the Charlotte Office, contemplates writing a feature article concerning protection by non-police and by hired guards.

[REDACTED] has received some information concerning the "500 Club" from his sources and desires to supplement it with information available in other areas of the state to show whether or not this is becoming a state-wide problem.

[REDACTED] has previously been furnished information concerning the Klan and has written numerous articles from information which has been furnished to him following Charlotte receiving Bureau approval.

Charlotte believes that additional information concerning the "500 Club" should be furnished to [REDACTED] for inclusion in his article as it is felt that his raising the issue in the article concerning legal liabilities and the possible criminal liabilities which might attach to self-appointed protectors will have a deterrent effect on [REDACTED] expansion of the "500 Club".

If the Bureau approves the furnishing of such information, it will be furnished to [REDACTED] and, as in the past, the articles will be written so as to provide complete security of the Bureau's position.

No further counterintelligence action will be taken without the Bureau's approval.

Re Charlotte airtel to Bureau 9/30/70 and Bureau airtel to Charlotte 10/7/70.

Referenced Bureau airtel requested information as to possible connection between the "500 Club" and the incident in referenced Charlotte airtel regarding the shooting into a residence of a Negro family who had moved into a predominantly white neighborhood.

There is no connection between the "500 Club" and the incident involving the shooting into the Negro residence. The article which is under consideration by [redacted] is to point up possible legal ramifications coming from situations in which "volunteer guards" are used in any given situation. [redacted] wishes to point out in his article that following the shooting into the Negro residence, approximately twelve to fifteen individuals appeared at the Negro residence armed with rifles and shotguns to "protect" the Negro family from any further attacks on their residence. These "guards" were not specifically requested by the Negro family, but once they appeared on the scene they remained for several days with the acquiescence of the Negro family. This situation created considerable tension in the neighborhood and [redacted] in his article, hopes to show that "amateur guards" can lead to more serious complications than if

[redacted] "500 Club" also provides for what [redacted] calls "amateur guards" who would take over the protection of various businesses where the owner of the business had joined the "500 Club". The "protection" would come in times of racial disturbances or riots and would involve Klansmen being called to the place of business to protect it from destruction.

In his article, [redacted] wants to point out these two instances of "amateur guards" taking over what should be handled by legitimate local law enforcement officers.

The information which Charlotte desires to furnish [redacted] is the identity of several known Klansmen whom [redacted] has used as "salesmen" in making contacts with various merchants seeking out their membership in the "500 Club". With this information, [redacted] should be able to develop the identities of some of the merchants who are members of the "500 Club" to obtain additional background for his article. As indicated previously, [redacted] already has some information concerning this operation by [redacted] but is in need of the identities of specific individuals whom he can contact for more detailed information. It is felt that the identities of these individuals can be given to [redacted] without endangering informants and [redacted] has handled previous information furnished in a most circumspect and discreet manner.

The Bureau is requested to consider furnishing [redacted] this information and upon receipt of Bureau approval, Charlotte will do so.

Charlotte will take no further counterintelligence action without prior Bureau approval.

Referenced Birmingham communication solicited counterintelligence suggestions from recipient offices for use during the National Klonvocation of UKA to be held in Tuscaloosa, Alabama, 11/26-29/70.

The Charlotte Division makes the following counter-intelligence suggestions for consideration by the Birmingham Division for possible use during the National Klonvocation:

1. During the National Klonvocation of the UKA held in Salisbury, N. C., on 6/27-28/70, a financial report for the fiscal year 1968-1969 was furnished to those in attendance. The National Office reported a total income of over some \$100,000 but there was no detailed or itemization of the expenses covering the expenditures of this \$100,000.

Charlotte informants in attendance at this klonvocation stated there were some remarks reflecting dissatisfaction among some of the members that the National Office had not given a more itemized or detailed accounting of where this \$100,000 had been spent.

It may be that informants attending the klonvocation at Tuscaloosa in November, 1970, could cause some additional dissatisfaction and possibly delays or disruption of the activities by demanding a more detailed accounting of expenditures for the fiscal year 1969-1970.

2. It has also been reported that during the klonvocation in Salisbury, N. C., [redacted] nominated a "hand-picked" candidate for [redacted] of Virginia. Following [redacted] nomination of [redacted] a klansman nominated [redacted] for the same position. Following this nomination, it is reported that [redacted] flew into a rage and told the klansmen who had nominated [redacted] that he did not have any business nominating a second party for this position. This incident furnished some members attending the klonvocation in Salisbury with an ample demonstration of [redacted] dictatorial operation concerning the Klan.

It is felt that some consideration could be given to instructing informants attending the klonvocation to be alert for this type of situation and to possibly bring up the fact that candidates for the Imperial Board were "hand-picked" at the klonvocation in Salisbury and should be removed from office and a new election held so as to give the membership a freedom of choice in selecting candidates for these positions.

3. At the klonvocation in Salisbury, [redacted] had the Saturday evening banquet catered and he charged each person in attendance \$5 for the dinner, however, information was subsequently received that the caterer furnished the meal for approximately \$2.50, which left [redacted] with approximately a \$2 profit for each plate which was served.

If a similar situation exists in the klonvocation in Tuscaloosa, informants could be alerted to this situation and make a demand that each member attending the banquet should be assessed only the exact amount which the caterer is going to charge for the meal rather than having an excessive price charged and having the profit go to the Imperial Wizard or Grand Dragon of the organization.

4. Coming out of the klonvocation at Salisbury, N. C. was a plan in which [REDACTED] has made some attempt to implement within North Carolina. This concerns the "500 Club" which is basically a protection-type racket in which [REDACTED] attempts to secure from individual merchants a commitment to pay from \$100 per year up to \$500 per year as protection for their businesses during times of riots or racial strife. The plan is to operate in such fashion that when the merchant has his place of business threatened by Negroes or any other faction during a riot, if he is a member of the 500 Club he can call upon the local klansmen to come to his place of business and afford protection.

Should the opportunity arise at the klonvocation of UKA at Tuscaloosa, Birmingham may wish to instruct informants attending the klonvocation to bring up pertinent questions concerning what the klan's liability might be to a family whose husband or father went off on a protective assignment to one of the merchants' establishment during a time of race rioting and was subsequently killed. This could be expanded into the possibility of the klan providing paid-up insurance policies for all members of the klan who are expected to be assigned to take part in these protective activities; it could be approached from the legal liability of the klan to provide for the welfare of the wife and children of klansmen who might be killed affording such protection; and the possible legal liability of the Imperial Wizard personally and the state Grand Dragons personally in these situations could be discussed with a view to pointing up the serious liabilities involved and perhaps an indication that the 500 Club operation should be discontinued throughout the klan organization.

5. Some consideration could also be given to the fact that ~~SHELTON~~ and the National Office in extending invitations to klansmen to participate in the Second Degree of Klancraft for which candidates to the second degree are to be charged \$25 initiation fees, stand to amass a small personal fortune from these payments. This could be utilized as another example of where "patriotism has a price" which has been used to varying degrees of success throughout North Carolina by continually

prodding individual klansmen with this phrase, pointing out that the klan hierarchy is placing the dollar sign on patriotism in all aspects of Klan craft. Demands could be made for an accounting as to what the \$25 from each member going into the Second Degree of Klan craft could be used for and possibly even question the necessity for any initiation fee whatsoever in these proceedings.

The above suggestions are furnished to the Bureau and Birmingham for whatever possible use Birmingham may be able to make of them in connection with the klonvocation to be held in Tuscaloosa.

No counterintelligence action should be taken without prior Bureau approval and Birmingham is requested to advise Charlotte should any of these suggestions be implemented so that informants of the Charlotte Division who may attend the klonvocation can be properly instructed in accordance with Birmingham's desires.

Charlotte's Quarterly Progress Letter of 10/5/70 set forth information concerning the furnishing to local IRS office with information concerning the raffle in which the automobile of Imperial Wizard SHELTON was won by [REDACTED]

The Bureau granted authority for furnishing the information which was previously set forth to IRS and this was done by furnishing detailed information to [REDACTED] IRS, Charlotte, N. C.

[REDACTED] has previously indicated that his office would request the pertinent tax returns of [REDACTED] and ascertain whether [REDACTED] reflected his winning the automobile on his tax return. To date, [REDACTED] has not been able to conduct the necessary analysis and has run into some delays in obtaining [REDACTED] return from Chamblee, Ga. Charlotte is following this matter with [REDACTED] and will make appropriate recommendations for further counterintelligence action in regard to this recommendation after [REDACTED] has conducted the analysis to determine whether [REDACTED] recorded the automobile as a prize or outright purchase.

Charlotte has previously received authorization for additional distribution throughout North Carolina of a news article [REDACTED] relating to the payment to ARTHUR HAYNES of \$12,500 in attorney's fees and in which he indicated that he believed that this was a fraudulent scheme by klan officers to secure additional funds.

[REDACTED] have indicated that the leaflets are the subject of conversation at klavern meetings and continues to create some ill will among the membership when these leaflets are read in open meetings.

Charlotte has previously received Bureau authorization to furnish information to [REDACTED]

[REDACTED] which [REDACTED] has been attempting to put into operation. [REDACTED] has been furnished information which has been authorized by the Bureau and will prepare an article utilizing this information along with other information which he has developed through independent interviews, which he has conducted. [REDACTED] has been most circumspect in his use of information as furnished in the past and it is felt he will continue to utilize such information to the complete protection of the Bureau as the source.

[REDACTED] has not as yet prepared the article due to having been given other assignments by the editor, which have of necessity required a great deal of his time. He has indicated he still intends to do such an article and will not come until probably shortly after the first of the year.

Charlotte will, by separate communication, make appropriate recommendations for counterintelligence action as the opportunities arise and will take no counterintelligence action without prior Bureau approval.
