Brunn-Minkowski inequalities for sprays on surfaces

Abstract

We propose a generalization of the Minkowski average of two subsets of a Riemannian manifold, in which geodesics are replaced by an arbitrary family of parametrized curves. Under certain assumptions, we characterize families of curves on a Riemannian surface for which a Brunn-Minkowski inequality holds with respect to a given volume form. In particular, we prove that under these assumptions, a family of constant-speed curves on a Riemannian surface satisfies the Brunn-Minkowski inequality with respect to the Riemannian area form if and only if the geodesic curvature of its members is determined by a function κ on the surface, and κ satisfies the inequality

$$
K + \kappa^2 - |\nabla \kappa| \ge 0
$$

where K is the Gauss curvature.

1 Introduction

The Brunn-Minkowski inequality asserts that for every $A, B \subseteq \mathbb{R}^n$, Borel measurable and nonempty, and for every $0 < \lambda < 1$,

$$
\text{Vol}_n((1-\lambda)A + \lambda B)^{1/n} \ge (1-\lambda) \cdot \text{Vol}_n(A)^{1/n} + \lambda \cdot \text{Vol}_n(B)^{1/n}.
$$
 (1)

Here, Vol_n denotes the Lebesgue measure, and

$$
(1 - \lambda)A + \lambda B = \{(1 - \lambda)a + \lambda b \mid a \in A, b \in B\}.
$$

For background on the classical Brunn-Minkowski inequality, see Schneider [\[17,](#page-24-0) Section 7.1]. The Brunn-Minkowski inequality admits a generalization to Riemannian manifolds, first proved in its stronger, functional version (the Borell-Brascamp-Lieb inequality) by Cordero-Erausquin, McCann and Schmuckenschläger [\[6\]](#page-24-1). It states that if M is a complete, n-dimensional Rie-mannian manifold with nonnegative Ricci curvature, then [\(1\)](#page-0-0) holds true, with Vol_n replaced by Riemannian volume, and with the set $(1 - \lambda)A + \lambda B$ naturally replaced by the set of points of the form $\gamma(\lambda)$, where $\gamma : [0, 1] \to M$ is a constant-speed minimizing geodesic joining the set A to the set B (for example, if $\lambda = 1/2$ then this equals the set of midpoints of geodesic segments joining the two sets). The Riemannian Brunn-Minkowski inequality in this formulation first ap-peared in Sturm [\[20\]](#page-24-2). The validity of the Brunn-Minkowski inequality for all A, B and λ is in fact equivalent to nonnegative Ricci curvature, see [\[13\]](#page-24-3).

The Brunn-Minkowski inequality combines two elements: volume and Minkowski summation. There is an extensive body of research in which the Riemannian volume form is replaced by an arbitrary measure μ with a smooth density, see [\[2,](#page-23-0) [12\]](#page-24-4). The Brunn-Minkowski inequality, with the exponent $1/n$ replaced by $1/N$ for some $N \in (-\infty, 0] \cup (n, \infty]$, then follows from nonnegativity of the generalized Ricci tensor $Ric_{q,\mu,N}$, see [\[20,](#page-24-2) [15,](#page-24-5) [16\]](#page-24-6).

In the present paper, we focus on the second element of the Brunn-Minkowski inequality: Minkowski summation. Instead of interpolating between two sets using geodesics, we propose to use an arbitrary family of curves. Restricting to the two-dimensional case, we seek to characterize families of curves for which a Brunn-Minkowski inequality analogous to [\(1\)](#page-0-0) holds.

Let (M, q) be a two-dimensional oriented Riemannian manifold. Fix a family Γ of smooth unit-speed curves on M, with the property that for any unit vector $v \in SM$, there is a unique curve $\gamma \in \Gamma$ with $\dot{\gamma}(0) = v$. Here SM is the unit tangent bundle of M. Equivalently, fix a function $k: SM \to \mathbb{R}$ and let Γ be the family of solutions to the ordinary differential equation

$$
\nabla_{\dot{\gamma}}\dot{\gamma}=k(\dot{\gamma})\dot{\gamma}^{\perp},
$$

where \perp denotes rotation by $\pi/2$ in the positive direction. Thus k prescribes the geodesic curvature of a curve $\gamma \in \Gamma$. Include in the family also all constant-speed orientation-preserving reparametrizations of the unit-speed curves above. Such a family of curves is uniquely determined by a vector field on TM, called a *spray*, which we shall also denote by Γ. The curves are then called Γ-*geodesics*. The precise definition of a spray, as well as definitions of the technical assumptions on Γ appearing in the formulation of Theorem [1.1](#page-1-0) below, are given in Section [2.](#page-3-0)

For two subsets $A, B \subseteq M$, denote by $\mathcal{M}_{\Gamma}(A, B; \lambda)$ the set of points of the form $\gamma(\lambda)$, where γ is a Γ-geodesic satisfying $\gamma(0) \in A$ and $\gamma(1) \in B$. This is a generalization of the Minkowski average $(1 - \lambda)A + \lambda B$ of two sets $A, B \subseteq \mathbb{R}^2$, since we can take our family to be all constant-speed lines on the Euclidean plane. We prove the following:

Theorem 1.1. *Let* Γ *be a simple, proper metric spray on* M*. The following are equivalent:*

1. The function k *is independent of the direction, i.e. there exists a smooth function* $\kappa : M \rightarrow$ R such that $k = \kappa \circ \pi$ where $\pi : SM \to M$ is the bundle projection, and moreover

$$
K + \kappa^2 - |\nabla \kappa| \ge 0,\tag{2}
$$

where $K : M \to \mathbb{R}$ *is the Gauss curvature of g.*

2. For every pair of Borel, nonempty subsets $A, B \subseteq M$ *and every* $0 < \lambda < 1$ *,*

Area
$$
(\mathcal{M}_{\Gamma}(A, B; \lambda))^{1/2} \ge (1 - \lambda) \cdot \text{Area}(A)^{1/2} + \lambda \cdot \text{Area}(B)^{1/2},
$$

where Area *denotes Riemannian area.*

Theorem [1.1](#page-1-0) is a special case of Corollary [4.8,](#page-21-0) in which the Riemannian area form is replaced by an arbitrary volume form on M.

Theorem [1.1](#page-1-0) generalizes the horocyclic Brunn-Minkowski inequality in the hyperbolic plane which was proved in [\[1\]](#page-23-1), as well as the classical Brunn-Minkowski in \mathbb{R}^2 . Moreover, by setting $\kappa \equiv 0$, we recover the equivalence between the (geodesic) Brunn-Minkowski inequality and the nonnegativity of the Gauss curvature (at least in the case where the geodesic spray is simple and proper). More examples are given in Section [5.](#page-22-0)

The main tool in the proof of the (harder) direction $1 \implies 2$ in Theorem [1.1](#page-1-0) is the needle decomposition technique, suggested and developed in the Riemannian setting by Klartag [\[11\]](#page-24-7). For our purposes we use a needle decomposition theorem for geodesically-convex Finsler surfaces whose proof can be found in [\[1\]](#page-23-1) and is based on the proofs found in Klartag [\[11\]](#page-24-7), Ohta [\[16\]](#page-24-6) and Cavalletti and Mondino [\[7\]](#page-24-8). The idea behind the needle decomposition technique is to decompose the space into Γ-geodesic arcs, localize the desired inequality into a one-dimensional inequality on each arc, and integrate the localized inequality. The technique employs L^1 -mass transport, and requires the Γ-geodesics to be minimizing geodesics of some Finsler metric, possibly after reparametrization. Fortunately, simple, proper metric sprays satisfying the Brunn-Minkowski inequality with respect to some volume form do have this property. Simplicity and properness are used mainly in this step; they can probably be replaced by other, possibly weaker, topological assumptions on the spray.

The fact that $\dim M = 2$ is used in several places. Firstly, our local analysis of the spray and derivation of condition [\(2\)](#page-1-1) is two-dimensional, but we believe that such a computation can be carried out in higher dimensions, at least for some classes of sprays. In a forthcoming paper we analyze magnetic sprays on manifolds of arbitrary dimensions, i.e. solutions to ODEs of the form $\nabla_{\dot{\gamma}} \dot{\gamma} = |\dot{\gamma}| Y \dot{\gamma}$, where Y is linear. Secondly, and most significantly, we rely on projective Finsler-metrizability of the spray. In dimension two, Brunn-Minkowski implies that the spray is magnetic, which in turn enables us to Finsler-metrize it. We do not know what the situation is in this regard in higher dimensions. Of course, there might be an approach to proving the Brunn-Minkowski inequality for sprays which does not require projective Finsler-metrizability. Finally, the needle decomposition theorem [4.4](#page-16-0) was proved in [\[1\]](#page-23-1) in dimension two. But most of the steps in the proof presented in [\[1\]](#page-23-1) were already carried out in [\[11,](#page-24-7) [16\]](#page-24-6) in general dimension, so we believe that it doesn't take much to extend it to arbitrary dimension.

The paper is organized as follows. In Section [2](#page-3-0) we first recall some basic facts about Riemannian geometry of surfaces and about sprays. We then prove Proposition [2.15](#page-9-0) regarding projective Finsler-metrizability of magnetic sprays. Finally, we give the necessary background and relevant results on needle decomposition. In Section [3](#page-10-0) we introduce the notion of a *nonnegatively curved weighted spray space*, and give a characterization of such spaces in the case of a metric spray on a Riemannian surface. We also mention an analogue of the curvature-dimension condition from the theory of metric measure spaces [\[20,](#page-24-2) [12\]](#page-24-4) in the setting of sprays on surfaces. In Section [4](#page-14-0) we prove the equivalence between the nonnegative curvature condition and the Brunn-Minkowski inequality in the case of simple, proper metric sprays (and, more generally, in the case of projectively Finsler-metrizable sprays on surfaces). In Section [5](#page-22-0) we provide some examples of weighted spray spaces satisfying the Brunn-Minkowski inequality.

2 Preliminaries

By a *Riemannian surface* we mean a two-dimensional oriented Riemannian manifold. For a tangent vector $v \in TM$ we denote by v^{\perp} the vector v rotated by $\pi/2$ in the positive direction, so that v and v^{\perp} have the same norm and (v, v^{\perp}) is an oriented orthogonal basis of the tangent space. We will occasionally use the Hodge star \star , which for one-forms on a Riemannian surface is simply the operator

$$
\star \eta = ((\eta^{\sharp})^{\perp})^{\flat},
$$

where \sharp and \flat are the musical isomorphisms.

We shall use the letter π to denote both the bundle projection from TM to M and the bundle projection from TTM to TM . Thus from TTM to TM we have two canonical maps: the bundle projection π , and the differential $d\pi$ of the bundle projection $\pi : TM \to M$.

We recall some basic facts about Riemannian surfaces which can be found in [\[19\]](#page-24-9). The unit tangent bundle SM of a Riemannian surface is the subbundle of TM consisting of unit vectors,

$$
SM := \{ v \in TM \mid |v|_g = 1 \}.
$$

The unit tangent bundle admits a natural global frame (E_1, E_2, V) . The flow of the vector field E_1 is the geodesic flow on SM, the flow of V restricts to rotation of each tangent circle (chosen according to the orientation of M), and we have the commutation relations

$$
[V, E_1] = E_2, \qquad [V, E_2] = -E_1, \qquad [E_1, E_2] = KV.
$$
 (3)

The dual coframe $(\theta_1, \theta_2, \psi)$ satisfies the relations

$$
d\pi(\xi) = \theta_1(\xi)\pi(\xi) + \theta_2(\xi)\pi(\xi)^{\perp}, \qquad \xi \in TSM,
$$
\n(4)

and the structure equations

$$
d\theta_1 = \psi \wedge \theta_2, \qquad d\theta_2 = -\psi \wedge \theta_1, \qquad d\psi = -K \theta_1 \wedge \theta_2. \tag{5}
$$

Here K is the Gauss curvature of the surface, which we view as a function on SM which is constant on each fiber. The Riemannian volume form, denoted by ω_g , satisfies

$$
\pi^* \omega_g = \theta_1 \wedge \theta_2. \tag{6}
$$

It is useful for us to consider the extensions of these objects to the full tangent bundle TM . On TM we have the canonical radial vector field R (sometimes called the Liouville vector field), which is the infinitesimal generator of the flow $v \mapsto e^t v$. Alternatively, for $v \in T_xM$, if by abuse of notation we identify T_xM with a subspace of T_vTM via translation, then

$$
R|_v = v.
$$

We again denote by E_1 the infinitesimal generator of the geodesic flow on TM , and by V the infinitesimal generator of rotation in the positive direction on each fiber of TM . Using [\(3\)](#page-3-1), [\(5\)](#page-3-2) and the homogeneity of E_1 and V, one can easily prove that on the full tangent bundle we have the commutation relations

$$
[V, E_1] = E_2,
$$

\n
$$
[R, E_1] = E_1,
$$

\n
$$
[R, E_2] = E_2,
$$

\n
$$
[R, V] = 0,
$$

and the dual coframe $(\theta_1, \theta_2, \psi, \rho)$ satisfies [\(4\)](#page-3-3) as well as the structure equations

$$
d\theta_1 = \theta_1 \wedge \rho + \psi \wedge \theta_2,\nd\theta_2 = \theta_2 \wedge \rho - \psi \wedge \theta_1,\nd\psi = -K \theta_1 \wedge \theta_2,\nd\rho = 0.
$$
\n(7)

Here (and from now on) we extend the Gauss curvature K to a 2-homogeneous function on TM whose value on SM coincides with the usual Gauss curvature.

Since the metric g, viewed as a function on TM , $v \mapsto g(v, v)$, is fiberwise 2-homogeneous and is invariant under the flows of E_1, E_2 and V, we have

$$
dg=2g\rho.
$$

The following lemma is proved easily using the formula relating the Christoffel symbols of conformal metrics. Observe that two conformal metrics have the same vector field V .

Lemma 2.1. Let (M, g) be a Riemannian surface and let $\tilde{g} = e^{2f}g$ be a metric conformal to g. *Then the geodesic sprays of q,* \tilde{q} *are related by*

$$
\tilde{E}_1 = E_1 - \star df \ V - df \ R.
$$

2.1 Sprays

A *spray* on a manifold M is a vector field $\Gamma: TM \rightarrow TTM$ satisfying

- 1. The semispray condition: $d\pi \circ \Gamma = id$, where id is the identity on TM, and
- 2. Homogeneity: $[R, \Gamma] = \Gamma$.

The semispray condition means that the integral curves of Γ are canonical lifts of curves on M, i.e. if $\tilde{\gamma}$ is an integral curve of Γ and $\gamma := \pi \circ \tilde{\gamma}$ is the projection of $\tilde{\gamma}$ to M, then $\dot{\gamma} = \tilde{\gamma}$. The homogeneity condition means that if $\tilde{\gamma}$ is an integral curve of Γ, then so is the dilated curve $t \mapsto \lambda \tilde{\gamma}(\lambda t)$ for every $\lambda > 0$. A curve of the form $\gamma = \pi \circ \tilde{\gamma}$, where $\tilde{\gamma}$ is an integral curve of Γ, is called a Γ*-geodesic*.

Example 2.2. The flat spray on \mathbb{R}^n is the spray whose geodesics are straight lines, parametrized by constant speed. In a coordinate chart $(x^{\overline{i}}, y^{\overline{i}})$ on $T\mathbb{R}^n$, the flat spray is given by $\overline{\Gamma} = y^i \partial_{x^i}$.

Example 2.3. More generally, the geodesic spray Γ_g of a Riemannian manifold (M, g) is the vector field generating the geodesic flow on TM. The Γ_q -geodesics are the constant-speed geodesics of the metric g. If x^i are local coordinates on M, and (x^i, y^i) are the induced local coordinates on TM, the geodesic spray is given in this local chart by $\Gamma_g = y^i \partial_{x^i} - (\Gamma_{ij}^k y^i y^j) \partial_{y_k}$, where Γ_{ij}^k are the Christoffel symbols of g in this chart. In case of a Riemannian surface, the geodesic spray is the vector field E_1 .

We recall some definitions and facts about sprays. For more details see [\[18\]](#page-24-10). For each $v \in TM$ there exists a unique Γ-geodesic γ_v satisfying $\dot{\gamma}_v(0) = v$, defined on a maximal open interval $I_v \subseteq \mathbb{R}$. If $v = 0$ then $\gamma_v \equiv \pi(v)$ and $I_v = \mathbb{R}$. Let

$$
\mathcal{U} := \{ v \in TM \mid 1 \in I_v \}.
$$

Define the exponential map of Γ by

$$
\exp^{\Gamma}(v) := \gamma_v(1), \qquad v \in \mathcal{U}.
$$

By the homogeneity of Γ, for every $v \in U$ and every $t \in I_v$,

$$
\exp^{\Gamma}(tv) = \gamma_v(t). \tag{8}
$$

For every $x \in M$ we set $\mathcal{U}_x := \mathcal{U} \cap T_xM$ and define

$$
\exp_x^{\Gamma} := \exp^{\Gamma}|_{T_xM}.
$$

Theorem 2.4 (Whitehead [\[21\]](#page-24-11), see also [\[18,](#page-24-10) Theorem 14.1.1]). *The exponential map* \exp^{Γ} *is* C^1 *on* U, and smooth away from the zero section. For every $x \in M$, the differential of \exp_x^{Γ} at 0 is *the identity (under the identification* $T_0T_xM \cong T_xM$).

As a consequence, \exp_x^{Γ} is a C^1 diffeomorphism from a neighborhood of 0 to a neighborhood of x . We also define the backwards exponential map by

$$
\overleftarrow{\exp}^{\Gamma}(v) := \gamma_v(-1)
$$

on the open set ←− $\mathcal{U} := \{v \in TM \mid -1 \in I_v\},$ and define $\overleftarrow{\mathcal{U}}_x$ and $\overleftarrow{\exp}_x^{\Gamma}$ similarly for all $x \in M$.

Definition 2.5 (Simple spray). A spray Γ will be called *simple* if for every $x \in M$ the maps \exp_x^{Γ} and $\overleftarrow{\exp}_x^{\Gamma}$ are both C^1 diffeomorphisms from \mathcal{U}_x to M and from $\overleftarrow{\mathcal{U}}$ \mathcal{U}_x to M , respectively.

Example 2.6 (Simple sprays). The flat spray in \mathbb{R}^n is simple. More generally, the geodesic spray of any Cartan-Hadamard manifold (i.e. complete, simply connected Riemannian manifold with nonpositive sectional curvature) is simple.

Let (M, g) be a Riemannian surface and let Γ be a spray on M. The semispray condition, together with [\(4\)](#page-3-3), imply that $\theta_1(\Gamma) = 1$ and $\theta_2(\Gamma) = 0$. Thus every spray has the form

$$
\Gamma = E_1 + kV + hR,\tag{9}
$$

for some smooth functions k , h on TM .

on $M \setminus \{x\}$. We also consider

In terms of covariant derivatives, if Γ is given by [\(9\)](#page-6-0), the Γ -geodesics are exactly the solutions to the second-order ordinary differential equation

$$
\nabla_{\dot{\gamma}} \dot{\gamma} = h(\dot{\gamma}) \dot{\gamma} + k(\dot{\gamma}) \dot{\gamma}^{\perp}.
$$
 (10)

Thus, if γ is a Γ-geodesic, then the (signed) geodesic curvature of γ with respect to g is given by $\langle \nabla_{\dot{\gamma}} \dot{\gamma}, \dot{\gamma}^{\perp} \rangle /|\dot{\gamma}|^3 = k(\dot{\gamma})/|\dot{\gamma}|.$

Definition 2.7 (Metric spray). Let (M, g) be a Riemannian surface and let Γ be a spray on M. We say that Γ is *metric* if the geodesics of Γ are constant-speed with respect to g, or equivalently if $\Gamma g = 0$. In terms of the representation [\(9\)](#page-6-0), the spray Γ is metric if and only if $h \equiv 0$.

Definition 2.8 (Magnetic spray). A spray Γ on a Riemannian surface (M, g) will be called *magnetic* with respect g if the function k defined above is independent of the direction, i.e. $Vk = 0$; equivalently, there exists a function $\kappa : M \to \mathbb{R}$ such that $k(v) = |v| \cdot \kappa(\pi(v))$ for all $v \in TM$. In this case we call κ the *geodesic curvature function* of Γ (with respect to g).

If Γ is metric and simple then for every $x \in M$ we may define a vector field V_x on $M \setminus \{x\}$ as the pushforward of the vector field $R/|R|_q$ on T_xM via the exponential map:

$$
V_x := \left(\exp_x^{\Gamma}\right)_* (R/|R|_g).
$$

The integral curves of $R/|R|_q$ are lines through the origin in T_xM ; by [\(8\)](#page-5-0), such lines are mapped by \exp_x^{Γ} to unit-speed Γ -geodesics. It follows that the vector field V_x is smooth on $M \setminus \{x\}$ and satisfies $|V_x|_g = 1$, and the integral curves of V_x are unit-speed Γ-geodesics emanating from x. Thus by [\(10\)](#page-6-1) we have

> $\nabla_{V_x} V_x = k(V_x)V_x^{\perp}$ $\eta_x := V_x^\flat$. (11)

The one-form η_x is defined and smooth on $M \setminus \{x\}$ and $|\eta_x|_g = |V_x|_g = 1$. Moreover

$$
d\eta_x(V_x, V_x^{\perp}) = V_x \eta_x(V_x^{\perp}) - V_x^{\perp} \eta_x(V_x) - \eta_x([V_x, V_x^{\perp}])
$$

\n
$$
= -\eta_x([V_x, V_x^{\perp}])
$$

\n
$$
= - \langle V_x, \nabla_{V_x} V_x^{\perp} - \nabla_{V_x^{\perp}} V_x \rangle
$$

\n
$$
= - \langle V_x, \nabla_{V_x} V_x^{\perp} \rangle
$$

\n
$$
= \langle \nabla_{V_x} V_x, V_x^{\perp} \rangle
$$

\n
$$
= k(V_x).
$$

In particular, if Γ is magnetic with respect to g and κ is its geodesic curvature function, then

$$
d\eta_x = \kappa \,\omega_g \qquad \text{on } M \setminus \{x\}. \tag{12}
$$

Definition 2.9 (Convexity). Let Γ be a spray on a manifold M and let $A \subseteq M$. The set A is said to be Γ*-convex* if for every Γ-geodesic γ , if $\gamma(0) \in A$ and $\gamma(1) \in A$ then also $\gamma(t) \in A$ for every $t \in (0, 1)$. The Γ-convex hull of a subset $A \subseteq M$ is the smallest Γ-convex set containing A.

We shall say that a spray Γ is *proper* if the Γ-convex hull of every precompact set is precompact. This condition is not satisfied by all sprays, see Example [2.11](#page-7-0) below.

Remark 2.10. If Γ is simple, then the interior A° of a Γ -convex set A is also Γ -convex. Indeed, the image of $A^\circ \times A^\circ \times (0,1)$ under the map $(x, y, t) \mapsto \exp_x^{\Gamma}(t(\exp_x^{\Gamma})^{-1}(y))$ is open (since Γ is simple), contains A° by Theorem [2.4,](#page-5-1) and is contained in A since A is Γ-convex, hence it equals A° .

Example 2.11 (Improper spray). Consider a spray on \mathbb{R}^2 with the following property: for every $n \geq 0$, the curve $\gamma_n(t) := (t, -\cos(3^n t) + 2n), t \in [-3^{-n} \cdot 2\pi, 3^{-n} \cdot 2\pi]$, is a Γ -geodesic, as well as the line $\ell_n(t) := (-t, 2n + 1), t \in \mathbb{R}$, see Figure [1.](#page-7-1) Note that since γ_n and ℓ_n move in opposite directions, there is no contradiction to the uniqueness of Γ-geodesics with given initial conditions. One can even take Γ to be a simple spray. The Γ-convex hull of the curve γ_0 contains all of the curves γ_n , and is therefore not compact.

2.2 Jacobi Fields

Let Γ be a spray on a manifold M and denote its flow on TM by Φ_t . Let γ be a Γ -geodesic. A vector field S along γ is called a Γ*-Jacobi field* if it satisfies one of the following equivalent conditions:

- 1. $S(t) = d\pi (d\Phi_t(\xi))$ where $\xi \in TTM$ satisfies $\pi(\xi) = \dot{\gamma}(0)$ and $d\pi(\xi) = S(0)$.
- 2. There exists a variation $F(s, t)$ through Γ -geodesics such that $S = dF(\partial_s|_{s=0})$.

Here, by a variation through Γ -geodesics we mean that F is smooth and $F(s, \cdot)$ is a Γ -geodesic for every s. Let us prove the equivalence of 1 and 2. Suppose first that such F exists. Recall that Γ-geodesics are curves of the form $\pi \circ \tilde{\gamma}$ where $\tilde{\gamma}$ is an integral curve of Γ. Thus by [\(8\)](#page-5-0) we can write

$$
F(s,t) = \exp^{\Gamma}(tc(s)) = \pi(\Phi_t(c(s))), \qquad (13)
$$

where c is a curve on TM with $c(0) = \dot{\gamma}(0)$. Write $\xi = \dot{c}(0)$. Then $\pi(\xi) = \pi(\dot{c}(0)) = c(0) = c(0)$ $\dot{\gamma}(0)$. By differentiating with respect to s we get $S(t) = dF(\partial_s(t, 0)) = d(\pi \circ \Phi_t)(\dot{c}(0)) =$ $d\pi(d\Phi_t(\xi))$, and by setting $t = 0$ we see that $S(0) = d\pi(\xi)$. In the other direction, if $S =$ $d\pi(d\Phi_t(\xi))$, then we can take any curve c on TM with $c(0) = \dot{\gamma}(0)$ and $d\pi(\dot{c}(0)) = S(0)$ and define F by [\(13\)](#page-8-0).

Definition 2.12 (Transversal Jacobi field). Let Γ be a spray on a two-dimensional oriented manifold M. We shall say that a Γ-Jacobi field S along a Γ-geodesic γ is *transversal* if $\omega(\dot{\gamma}, S) > 0$, where ω is any volume form on M.

2.3 Projective Finsler metrizability

A *Finsler metric* on a manifold M is a function $\mathcal{F}: TM \to [0,\infty)$, positive and smooth away from the zero section, which satisfies the following requirements:

- *positive homogeneity:* $\mathcal{F}(\lambda v) = \lambda \mathcal{F}(v)$ for all $v \in TM$ and $\lambda > 0$.
- *strong convexity*: Fix $x \in M$. Then the function \mathcal{F}^2 is convex in the linear space T_xM , and moreover its Hessian at any point $0 \neq v \in T_xM$ is positive definite.

A manifold endowed with a Finsler metric is called a *Finsler manifold*. A Finsler metric induces a metric on M by setting

$$
d(x, y) = \inf_{\gamma} \text{Length}(\gamma),
$$

where

$$
\mathrm{Length}(\gamma) := \int_0^1 \mathcal{F}(\dot{\gamma}(t)) dt,
$$

and where the infimum is taken over all C^1 curves joining x to y.

A *minimizing geodesic* of a Finsler metric is a constant-speed curve $\gamma : [a, b] \to M$ satisfying Length(γ) = $d(\gamma(a), \gamma(b))$. A *geodesic* is a curve $\gamma : [a, b] \to M$ that is locally a minimizing geodesic, i.e., for any $t_0 \in [a, b]$ there exists $\delta > 0$ such that the restriction of γ to the interval $[a, b] \cap (t_0 - \delta, t_0 + \delta)$ is a minimizing geodesic. Equivalently, a geodesic is a solution to the Euler-Lagrange equation associated with the Lagrangian $\mathcal{F}^2/2$. The *geodesic spray* of $\mathcal F$ is the spray on TM whose geodesics are the constant-speed geodesics of the metric \mathcal{F} . We say that (M, \mathcal{F}) is *geodesically convex* if any two points $x, y \in M$ are joined by a minimizing geodesic. We refer the reader to [\[3\]](#page-23-2) for more background on Finsler metrics.

Definition 2.13 (Projectively equivalent sprays). Two sprays Γ, Γ are said to be *projectively equivalent* if there exists a scalar function $f : TM \to \mathbb{R}$ such that $\Gamma - \tilde{\Gamma} = fR$. Equivalently, the geodesics of Γ and Γ coincide up to orientation-preserving reparametrization.

Definition 2.14 (Projectively Finsler-metrizable spray). A spray Γ on a manifold M is said to be *projectively Finsler-metrizable (pFm)* if there exists a geodesically convex Finsler metric $\mathcal F$ on M such that Γ is projectively equivalent to the geodesic spray of F, that is, if the geodesics of the Finsler metric F coincide with the geodesics of Γ up to orientation-preserving reparametrization. We remark that the usual definition of projective Finsler metrizability does not include geodesic convexity of $\mathcal F$. See [\[4\]](#page-23-3) and references therein for more information on projective Finsler metrizability. See Darboux [\[8\]](#page-24-12) and Matsumoto [\[14\]](#page-24-13) for a local resolution of the projective metrizabilty problem in two dimensions (here 'local' refers to locality also in the tangent space).

Proposition 2.15. *Let* M *be a two-dimensional manifold and let* Γ *be a simple proper spray on* M*. Suppose that there exists a Riemannian metric* g *on* M *such that* Γ *is magnetic with respect to* g*. Then for every compact set* A ⊆ M *there exists an open* Γ*-convex set* U ⊇ A *such that the restriction of* Γ *to* U *is projectively Finsler-metrizable.*

Proof. Let g be a Riemannian metric such that Γ is magnetic with respect to g, and let κ : $M \to \mathbb{R}$ be the corresponding geodesic curvature function. By replacing Γ with a projectively equivalent spray we may assume that Γ is metric with repsect to g. Since Γ is proper, there exists a precompact open set U containing A which is Γ -convex (see Remark [2.10\)](#page-7-2).

Lemma 2.16. *There exists a 1-form* η *on U such that* $|\eta|_g < 1$ *and* $d\eta = \kappa \omega_g$ *on U*.

Let us first finish the proof assuming Lemma [2.16.](#page-9-1) Let η be the 1-form from Lemma [2.16](#page-9-1) and define a Finsler metric $\mathcal F$ on U by

$$
\mathcal{F} := \sqrt{g} - \eta.
$$

Since |η|^g < 1, this is indeed a Finsler metric, of *Randers* type (see e.g. [\[3\]](#page-23-2)). Since Γ is simple and U is Γ convex, every pair of points in U is joined by a Γ -geodesic. We shall prove that this Γ-geodesic is uniquely length-minimizing with respect to F. It will then follow that Γ-geodesics coincide with the geodesics of $\mathcal F$ up to orientation-preserving reparametrization, and that $\mathcal F$ is geodesically convex. Let $p, q \in U$, let γ be a C^1 curve in U joining p to q and let $\gamma_0 : [0, 1] \to U$ be the Γ-geodesic joining p to q (which lies inside U since U is Γ-convex).

Since Γ is simple, the Γ-geodesic γ_0 can be extended to a geodesic $\bar{\gamma}: I \to M$, for some interval I containing [0, 1], so that $\bar{\gamma}|_{[0,1]} = \gamma_0$, and there exists some $t < 0$ such that γ and γ_0 are homotopic in $M \setminus {\{\bar{\gamma}(-t)\}}$. Set $x = \bar{\gamma}(-t)$, and let η_x be defined by [\(11\)](#page-6-2). See Figure [2.](#page-10-1) By [\(12\)](#page-7-3) we have $d\eta_x = \kappa \omega_g = d\eta$ on $M \setminus \{x\}$, and therefore $\int_{\gamma_0} (\eta - \eta_x) = \int_{\gamma} (\eta - \eta_x)$. Hence, in order to prove that γ_0 is shorter than γ with respect to F, it suffices to prove that

$$
\int_{\gamma_0} (\sqrt{g} - \eta_x) \le \int_{\gamma} (\sqrt{g} - \eta_x). \tag{14}
$$

Since γ_0 is part of the Γ-geodesic joining x to q, its tangent is proportional to V_x and therefore $\eta_x(\dot{\gamma}_0) = |\dot{\gamma}_0|$. Thus the left hand side vanishes, while the right hand side is nonnegative since

 $|\eta_x|_g = 1$. Moreover, equality implies that $\dot{\gamma}$ is proportional to V_x , whence γ coincides with γ_0 up to orientation-preserving reparametrization. □

Proof of Lemma [2.16.](#page-9-1) Choose $x, y, z \in M \setminus U$ which do not lie on a common Γ-geodesic. Define $\eta = \frac{1}{3}$ $\frac{1}{3}(\eta_x + \eta_y + \eta_z)$, with η_x, η_y, η_z defined as in [\(11\)](#page-6-2). Since $x, y, z \notin U$, the 1-form η is smooth on U, and by [\(12\)](#page-7-3) we have $d\eta = \kappa \omega_q$. Finally, since x, y, z do not lie on the same Γ-geodesic, the one-forms η_x, η_y, η_z do not all coincide at any point, and therefore $|\eta| < 1$. \Box

Remark 2.17. In the last proof we constructed a solution to the linear equation $d\eta = \kappa \omega_q$, under the constraint $|\eta| \leq 1$. If we set $X := (\eta^{\sharp})^{\perp}$, then this is equivalent to the equation $\text{div}X = \kappa$ subject to the constraint $|X| \leq 1$. There are several ways to solve this equation, such as stipulating $X = \nabla f$ and solving the Poisson equation $\Delta f = \kappa$. However, in order to satisfy the requirement $|X| \leq 1$, rather than using linear methods, we instead solved the nonlinear equation $\nabla_V V = \kappa V^{\perp}$ under the constraint $|V| = 1$, where we set $V := -X^{\perp} = \eta^{\sharp}$. Note that indeed div $X = \text{div}V^{\perp} = \kappa$.

3 Weighted spray spaces

A triple (M, Γ, ω) where M is a manifold, Γ is a spray and ω is a volume form will be called a *weighted spray space*. We shall only deal with the two-dimensional case. We denote the Lie derivative with respect to a vector field X by \mathcal{L}_X , and write $\mathcal{L}_X^2 := \mathcal{L}_X \mathcal{L}_X$. The interior product is denoted by ι .

Proposition 3.1. Let (M, Γ, ω) be a weighted spray space, dim $M = 2$. Then the following are *equivalent:*

- *1. For every* Γ*-geodesic* γ *and every transversal* Γ*-Jacobi field* S *along* γ*, the function* $J(t) := \omega(\dot{\gamma}(t), S(t))$ *is concave.*
- *2. There exists a nonnegative smooth function* Q *on* TM *such that*

$$
\mathcal{L}_{\Gamma}^2(\iota_{\Gamma}\pi^*\omega) = -Q \cdot \iota_{\Gamma}\pi^*\omega. \tag{15}
$$

Definition 3.2 (Nonnegatively curved weighted spray space). If any of the equivalent conditions in Proposition [3.1](#page-10-2) holds we shall say that the weighted spray space (M, Γ, ω) is *nonnegatively curved*.

Proof. It suffices to prove that condition 2 is equivalent to

1'. for every Γ -geodesic γ *and every transversal* Γ -Jacobi *field* S *along* γ *we have* $J''(0) \leq 0$ *.*

Indeed, the function J is always smooth for a transversal Jacobi field, so this condition is clearly weaker than condition 1, and on the other hand, if condition 1 does not hold for some Γ-Jacobi field, then by time translation we can find a Γ -Jacobi field for which $J''(0) > 0$.

Let γ be a Γ-geodesic and let S be a Jacobi field along γ . Let $\xi \in TTM$ satisfy $\pi(\xi) = \dot{\gamma}(0)$ and $d\pi(\xi) = S(0)$, so that $S(t) = d\pi(d\Phi_t(\xi))$. Note also that by the semispray condition $\dot{\gamma}(t) =$ $\pi\left(\Gamma|_{\dot{\gamma}(t)}\right) = d\pi\left(\Gamma|_{\dot{\gamma}(t)}\right)$. Thus

$$
J(t) = \omega(\dot{\gamma}(t), S(t))
$$

= $\omega(d\pi(\Gamma|\dot{\gamma}(t)), d\pi(d\Phi_t(\xi)))$
= $\pi^*\omega(\Gamma|\dot{\gamma}(t), d\Phi_t(\xi))$
= $\iota_{\Gamma}\pi^*\omega(d\Phi_t(\xi))$
= $\Phi_t^*(\iota_{\Gamma}\pi^*\omega)(\xi)$.

Since Φ_t is the flow of Γ , it follows that

$$
J(0) = \iota_{\Gamma} \pi^* \omega(\xi) \quad \text{and} \quad J''(0) = \mathcal{L}_{\Gamma}^2(\iota_{\Gamma} \pi^* \omega)(\xi).
$$

Note that if S is transversal then $\iota_{\Gamma} \pi^* \omega(\xi) > 0$. Indeed, by setting $t = 0$ in the above calculation we see that $\omega(\dot{\gamma}(0), S(0)) = \iota_{\Gamma} \pi^* \omega(\xi)$. Thus condition 1' is equivalent to the assertion that for every $\xi \in TTM$ such that $\iota_{\Gamma} \pi^* \omega(\xi) > 0$, it also holds that $\mathcal{L}^2_{\Gamma}(\iota_{\Gamma} \pi^* \omega)(\xi) \leq 0$. Since both expressions are linear in ξ , this is equivalent to condition 2. \Box

Lemma 3.3. Let (M, g) be a Riemannian surface, let $\Gamma = E_1 + kV + hR$ be a spray on TM, and let $\omega = e^{-\varphi} \omega_g$ be a volume form on M. Then

$$
\mathcal{L}_{\Gamma}^{2} \left(\iota_{\Gamma} \pi^* \omega \right) = -Q \cdot \iota_{\Gamma} \pi^* \omega + \alpha \tag{16}
$$

where

$$
\alpha := (Vk - 2d\varphi - h)e^{-\varphi}(\psi - k\theta_1)
$$

and

$$
Q := K + k^2 - h^2 + \Gamma(d\varphi) - (d\varphi)^2 + \Gamma h - E_2 k - 2hd\varphi.
$$
 (17)

Remark 3.4. In [\(16\)](#page-11-0), and in similar formulae below, the one-form $d\varphi$ is regarded as a function on TM, and the term $\Gamma(d\varphi)$ denotes its derivative with respect to the vector field Γ.

Proof. By [\(6\)](#page-3-4) we have

$$
\pi^*\omega = e^{-\varphi}\pi^*\omega_g = e^{-\varphi}\theta_1 \wedge \theta_2.
$$

Since $\theta_1(\Gamma) = 1$ and $\theta_2(\Gamma) = 0$, it follows that

$$
\iota_{\Gamma}\pi^*\omega = e^{-\varphi}\theta_2.
$$

From [\(7\)](#page-4-0) and Cartan's formula for a Lie derivative $\mathcal{L}_X = \iota_X d + d\iota_X$ we get

$$
\mathcal{L}_{\Gamma}\theta_1 = \rho - h\theta_1 + k\theta_2, \qquad \mathcal{L}_{\Gamma}\theta_2 = -h\theta_2 + \psi - k\theta_1, \qquad \mathcal{L}_{\Gamma}\rho = dh,
$$
\nand\n
$$
\mathcal{L}_{\Gamma}\psi = dk - K\theta_2
$$
\n
$$
= (E_1k)\theta_1 + (E_2k - K)\theta_2 + (Vk)\psi + (Rk)\rho.
$$
\n(18)

Observe that

$$
Rk = R\psi(\Gamma) = d\psi(R, \Gamma) + \Gamma\psi(R) + \psi([R, \Gamma]) = \psi(\Gamma) = k,
$$
\n(19)

where in the third passage we have used [\(7\)](#page-4-0) and the fact that $(\theta_1, \theta_2, \psi, \rho)$ is dual to (E_1, E_2, V, R) to show that the first two terms vanish, and then used the homogeneity $[R, \Gamma] = \Gamma$. Thus

$$
\mathcal{L}_{\Gamma}\psi = (E_1k)\theta_1 + (E_2k - K)\theta_2 + (Vk)\psi + k\rho. \tag{20}
$$

By [\(18\)](#page-12-0), [\(20\)](#page-12-1), [\(9\)](#page-6-0) and [\(19\)](#page-12-2) we have

$$
\mathcal{L}_{\Gamma}^{2} \theta_{2} = - (\Gamma h) \theta_{2} - h \mathcal{L}_{\Gamma} \theta_{2} + \mathcal{L}_{\Gamma} \psi - (\Gamma k) \theta_{1} - k \mathcal{L}_{\Gamma} \theta_{1} \n= - (\Gamma h) \theta_{2} + h^{2} \theta_{2} - h \psi + hk \theta_{1} + (E_{1}k) \theta_{1} + (E_{2}k - K) \theta_{2} + (Vk) \psi + k \rho \n- (E_{1}k + k(Vk) + h(Rk)) \theta_{1} - k \rho + kh \theta_{1} - k^{2} \theta_{2} \n= (-\Gamma h + h^{2} + E_{2}k - K - k^{2}) \theta_{2} + (Vk - h)(\psi - k \theta_{1}).
$$

If we view φ as a function on TM which is constant on each fiber, then we have $\Gamma \varphi = d\varphi$ on TM. Thus

$$
\mathcal{L}_{\Gamma}^{2}(\iota_{\Gamma}\pi^{*}\omega) = \mathcal{L}_{\Gamma}^{2}(e^{-\varphi}\theta_{2})
$$

\n
$$
= (\Gamma^{2}e^{-\varphi})\theta_{2} + 2(\Gamma e^{-\varphi})\mathcal{L}_{\Gamma}\theta_{2} + e^{-\varphi}\mathcal{L}_{\Gamma}^{2}\theta_{2}
$$

\n
$$
= (\Gamma^{2}e^{-\varphi} + e^{-\varphi}(-\Gamma h + h^{2} + E_{2}k - K - k^{2}) - 2h\Gamma e^{-\varphi})\theta_{2}
$$

\n
$$
+ (2\Gamma e^{-\varphi} + e^{-\varphi}(Vk - h))(\psi - k\theta_{1})
$$

\n
$$
= (-\Gamma(d\varphi) + (d\varphi)^{2} - \Gamma h + h^{2} + E_{2}k - K - k^{2} + 2hd\varphi) \cdot e^{-\varphi}\theta_{2}
$$

\n
$$
+ (-2d\varphi + Vk - h) e^{-\varphi}(\psi - k\theta_{1})
$$

\n
$$
= -Q \cdot \iota_{\Gamma}\pi^{*}\omega + \alpha
$$

as claimed.

 \Box

Corollary 3.5. Let (M, g) be a Riemannian surface, let $\Gamma = E_1 + kV$ be a metric spray on (M, g) and let $\omega = e^{-\varphi}\omega_g$ be a volume form on M. Then the following are equivalent:

- *1. The weighted spray space* (M, Γ, ω) *is nonnegatively curved.*
- 2. *The spray* Γ *is magnetic with respect to the metric* $e^{-4\varphi}$ *g, and*

$$
K + k^2 + \Gamma(d\varphi) - (d\varphi)^2 - E_2 k \ge 0.
$$
 (21)

In particular, the weighted spray space (M, Γ, ω_q) *is nonnegatively curved if and only if* Γ *is magnetic with respect to* g *and*

$$
K + \kappa^2 - |\nabla \kappa| \ge 0,
$$

where κ *is the geodesic curvature function of* Γ*.*

Remark 3.6. In the case $\varphi \equiv 0$, the quantity $K + k^2 - E_2k$ on the left hand side of [\(21\)](#page-13-0) coincides with the Ricci scalar of the spray Γ as defined in e.g. [\[18\]](#page-24-10).

Proof. Since Γ is metric, $h \equiv 0$. By Proposition [3.1](#page-10-2) and Lemma [3.3,](#page-11-1) the weighted spray space (M, Γ, ω) is nonnegatively curved if and only if $V k - 2d\varphi = 0$ and inequality [\(21\)](#page-13-0) holds. By Lemma [2.1,](#page-4-1)

$$
\Gamma = E_1 + kV = \tilde{E}_1 + (k - 2 \star d\varphi)V - 2d\varphi R,
$$

where \tilde{E}_1 is the geodesic spray of $\tilde{g} = e^{-4\varphi}g$. Thus Γ is magnetic with respect to \tilde{g} if and only if

$$
0 = V(k - 2 \star d\varphi) = Vk - 2d\varphi,
$$

as desired. Here the second equality holds true because, if (x, y) are normal coordinates at $p \in M$ and (x, y, u, v) are the corresponding canonical local coordinates on TM, then at p we have

$$
V(\star d\varphi) = (-v\partial_u + u\partial_v)(-\varphi_y u + \varphi_x v) = v\varphi_y + u\varphi_x = d\varphi.
$$

Suppose that $\varphi \equiv 0$. Then $(M, \Gamma, \omega = \omega_q)$ is nonnegatively curved if and only if Γ is magnetic with respect to g, and $K + k^2 - E_2 k \ge 0$. If Γ is magnetic then $V k = 0$, and therefore, writing $k = \sqrt{g} \cdot \kappa \circ \pi$ for a function $\kappa : M \to \mathbb{R}$, we have $E_2 k = [V, E_1]k = VE_1k - E_1Vk =$ $V(d\kappa) = -\star d\kappa$. It follows that (M, Γ, ω_g) is nonnegatively curved if and only if M is magnetic and the function κ satisfies $0 \leq K + \kappa^2 - |\star d\kappa| = K + \kappa^2 - |\nabla\kappa|$. □

Remark 3.7. In the spirit of curvature-dimension theory of Bakry-Emery [\[2\]](#page-23-0) and Lott-Sturm-Villani [\[12,](#page-24-4) [20\]](#page-24-2), one can extend the notion of a nonnegatively curved weighted spray space on a surface to that of a $CD(r, N)$ weighted spray space for any $r \in \mathbb{R}$ and $N \neq 1$, in which the requirement $J'' \le 0$ (with J defined as in Proposition [3.1\)](#page-10-2) is replaced by the condition

$$
\frac{J''}{J} - \left(\frac{N-2}{N-1}\right) \left(\frac{J'}{J}\right)^2 + r \le 0\tag{22}
$$

(see Theorem [4.6](#page-19-0) below for the motivation for this definition in the case $r = 0$). Let Γ be a spray on a Riemannian surface (M, g) and suppose for simplicity that Γ is metric. Let $\omega = e^{-\varphi}\omega_g$ be a volume form on M. Let $TTM^+ := \{\xi \in TTM \mid \theta_2(\xi) > 0\}$ and define a function $z:TTM^+\to \mathbb{R}$ by

$$
z(\xi) := \frac{\psi(\xi) - k\theta_1(\xi)}{\theta_2(\xi)}.
$$

A straightforward modification of Proposition [3.1](#page-10-2) and Lemma [3.3](#page-11-1) and their proofs shows that [\(22\)](#page-13-1) holds for every transversal Γ-Jacobi field if and only if

$$
-Q + Bz - \frac{N-2}{N-1}(z - d\varphi)^2 + r \le 0 \qquad \text{on } TTM^+, \tag{23}
$$

where

$$
Q := K + k^2 + \Gamma(d\varphi) - (d\varphi)^2 - E_2k \quad \text{and} \quad B := Vk - 2d\varphi.
$$

Note that Q and B are functions on TM. Since, by linear independence of the one forms $\psi - k\theta_1$ and θ_2 , the function z can attain any value on each fiber of TTM^+ , the expression on the left hand side of [\(23\)](#page-14-1), viewed as a polynomial in z whose coefficients are functions on TM , must be nonnegative for all values of z. For $N \notin [1, 2]$ this is equivalent to

$$
Q - d\varphi \cdot B - \frac{N-1}{N-2} \cdot \frac{B^2}{4} \ge r \quad \text{on } TM,
$$

or

$$
K + k^{2} + \Gamma(d\varphi) - E_{2}k - \frac{((N-1)Vk - 2 d\varphi)^{2}}{4(N-1)(N-2)} - \frac{(d\varphi)^{2}}{N-1} \geq r \quad \text{on } TM.
$$

We remark that when Γ is the geodesic spray, i.e. $k = 0$, the expression on the left hand side equals the generalized Ricci curvature of the weighted Riemannian manifold (M, g, ω) .

4 Brunn-Minkowski for sprays

Fix a two-dimensional weighted spray space (M, Γ, ω) . Given two subsets $A, B \subseteq M$ and $0 < \lambda < 1$, we define

$$
\mathcal{M}_{\Gamma}(A, B; \lambda) := \{ \gamma(\lambda) \mid \gamma \text{ is a } \Gamma \text{-geodesic }, \gamma(0) \in A, \gamma(1) \in B \}.
$$

For example, if $M = \mathbb{R}^2$ and Γ is the flat spray, then $\mathcal{M}_{\Gamma}(A, B; \lambda) = (1 - \lambda)A + \lambda B$, where + denotes Minkowski summation. If M is a Riemannian surface and Γ is its geodesic spray, then $\mathcal{M}_{\Gamma}(A, B; \lambda)$ is similar to the operation defined in [\[6,](#page-24-1) [20\]](#page-24-2), except that in our definition we do not require the geodesics in the definition of $\mathcal{M}_{\Gamma}(A, B; \lambda)$ to be minimizing.

Denote by μ the unique Borel measure on M which satisfies

$$
\mu(A) = \int_A \omega
$$

for every open set $A \subseteq M$. In this section we characterize, under some assumptions on the spray, two-dimensional weighted spray spaces (M, Γ, ω) satisfying the Brunn-Minkowski inequality

$$
\mu(\mathcal{M}_{\Gamma}(A,B;\lambda))^{1/2} \ge (1-\lambda) \cdot \mu(A)^{1/2} + \lambda \cdot \mu(B)^{1/2}
$$
 (BM)

for every nonempty Borel subsets $A, B \subseteq M$.

Theorem 4.1. *Let* (M, Γ, ω) *be a simple, nonnegatively curved, two-dimensional weighted spray space. Suppose that* Γ *is projectively Finsler-metrizable. Then* [\(BM\)](#page-15-0) *holds for every nonempty Borel subsets* $A, B \subseteq M$ *of positive measure and every* $0 < \lambda < 1$ *.*

The central tool in the proof of Theorem [4.1](#page-15-1) is Theorem [4.4](#page-16-0) below, which is a needle decomposition theorem for sprays, similar to (and generalizing) the horocyclic needle decomposition theorem [\[1,](#page-23-1) Theorem 3.1].

Definition 4.2 (Jacobi needle). Let M be a two-dimensional oriented manifold, let Γ be a spray on M and let ω be a volume form on M. Let $\gamma = \gamma(t)$ be a Γ-geodesic. A measure μ on M will be called a (Γ, ω)*-Jacobi needle along* γ if there exists a transversal Γ-Jacobi field S along γ such that

 $\mu = \gamma_{\#} (J(t)dt),$ (24)

where

$$
J(t) := \omega(\dot{\gamma}(t), S(t))
$$

and $#$ denotes pushforward. A Dirac mass (i.e. a measure supported on a single point) is also considered a (Γ, ω) -Jacobi needle.

Intuitively, a (Γ, ω) -Jacobi needle should be thought of as the restriction of ω to an infinitesimally thin strip made out of Γ-geodesics. It is intuitively clear that the notion of a (Γ, ω) -Jacobi needle depends only on the projective class of Γ. Let us prove this fact, which will be useful for us.

Lemma 4.3. Let ω be a volume form on a two-dimensional manifold M and let Γ and $\tilde{\Gamma}$ be *projectively-equivalent sprays on* TM*. Then every* (Γ, ω)*-Jacobi needle is also a* (Γ˜, ω)*-Jacobi needle.*

Proof. Suppose that μ is a (Γ, ω) -Jacobi needle. We may assume that μ is not a Dirac mass (because then the statement is trivial), whence it takes the form [\(24\)](#page-15-2), with γ , S, J as in Definition [4.2.](#page-15-3) Let $F(s, t)$ be a variation through Γ -geodesics such that $S = F_*(\partial_s|_{s=0})$. Since Γ and $\tilde{\Gamma}$ are projectively-equivalent, their geodesics differ by an orientation-preserving reparametrization. Thus there exists a smooth function $t = t(s, \tau)$, strictly increasing in τ , such that the following holds: if we set

$$
\tilde{F}(s,\tau) = F(s,t(s,\tau))\tag{25}
$$

then the curve

$$
\tau \mapsto \tilde{F}(s, \tau)
$$

is a $\tilde{\Gamma}$ -geodesic for every s. In particular,

$$
\tilde{\gamma}(\tau) = \tilde{F}(0, \tau) = F(0, t(0, \tau)) = \gamma(t(0, \tau))
$$

is a $\tilde{\Gamma}$ -geodesic, and the vector field

$$
\tilde{S} = \tilde{F}_*(\partial_s|_{s=0})
$$

along $\tilde{\gamma}$ is a $\tilde{\Gamma}$ -Jacobi field induced by the variation \tilde{F} . By the chain rule,

$$
\tilde{S} = F_*(\partial_s|_{s=0}) + \frac{\partial t}{\partial s} \cdot F_*(\partial_t|_{s=0}) = S + \frac{\partial t}{\partial s} \cdot \dot{\gamma}.
$$

Thus

$$
\omega(\dot{\tilde{\gamma}}, \tilde{S}) = \omega((\partial t/\partial \tau)\dot{\gamma}, S + (\partial t/\partial s)\dot{\gamma}) = (\partial t/\partial \tau)\omega(\dot{\gamma}, S)
$$

and therefore

 $\mu = \gamma_{\#}(\omega(\dot{\gamma}, S)dt) = \tilde{\gamma}_{\#}((\partial t/\partial \tau)\omega(\dot{\gamma}, S)d\tau) = \tilde{\gamma}_{\#}(\omega(\dot{\gamma}, \tilde{S})d\tau).$

It follows that μ is a (Γ, ω) -Jacobi needle.

Theorem 4.4 (Needle decomposition for pFm sprays). *Let* M *be a two-dimensional manifold, let* Γ *be a projectively Finsler-metrizable spray on* M *and let* ω *be a volume form on* M*. Let* $\rho_1, \rho_2 : M \to [0, \infty)$ *be compactly-supported measurable functions with*

$$
\int_M \rho_1 \omega = \int_M \rho_2 \omega < \infty.
$$

Then there is a collection Λ *of disjoint* Γ -geodesics, a measure ν *on* Λ *and a family* $\{\mu_{\gamma}\}_{\gamma \in \Lambda}$ *of Borel measures on* M *such that the following hold:*

- *(i) For ν*-almost every $\gamma \in \Lambda$ *, the measure* μ_{γ} *is a* (Γ, ω) *-Jacobi needle along* γ *.*
- *(ii) ("disintegration of measure") For any measurable set* $S \subseteq M$,

$$
\int_{S} \omega = \int_{\Lambda} \mu_{\gamma}(S) d\nu(\gamma).
$$
\n(26)

(iii) ("mass balance") For ν *-almost any* $\gamma \in \Lambda$ *,*

$$
\int_{M} \rho_1 d\mu_{\gamma} = \int_{M} \rho_2 d\mu_{\gamma},\tag{27}
$$

and moreover

$$
\int_{M} \rho_1 d\mu_{\gamma^+} \le \int_{M} \rho_2 d\mu_{\gamma^+}
$$
\n(28)

whenever γ^+ is a positive end of γ . Here a curve γ^+ is said to be a positive end of γ if it *is a restriction of* γ *to a subinterval with the same upper endpoint, and the measure* $\mu_{\gamma+}$ *is the restriction of* μ_{γ} *to the image of* γ^{+} *.*

 \Box

Proof. If M is a geodesically-convex Finsler manifold and Γ is its geodesic spray, then the conclusion follows directly from [\[1,](#page-23-1) Theorem 4.7], except that the notion of a Jacobi needle is not discussed there, but we shall deal with this point below.

By assumption, there exists a geodesically convex Finsler metric F on M such that Γ is projectively equivalent to the geodesic spray of $\mathcal F$. Since the geodesics of $\mathcal F$ coincide with Γgeodesics as oriented curves, we immediately obtain conclusions (ii),(iii) of Theorem [4.4](#page-16-0) for our spray Γ. It remains to prove conclusion (i), namely, that μ_{γ} is a (Γ, ω)-Jacobi needle for v-almost every γ . To this end we recall some facts and notations from the proof of [\[1,](#page-23-1) Theorem 4.7].

For *ν*-almost every measure μ_{γ} , either μ_{γ} is a Dirac mass, in which case it is trivially a (Γ, ω) -Jacobi needle, or else it takes the following form. There exist

1. a Borel set $B \subseteq \mathbb{R}^2$ of the form

$$
B = \{(y, t) \in \mathbb{R}^2 \, ; \, y \in Y, \, a_y < t < b_y\},\tag{29}
$$

where $Y \subseteq \mathbb{R}$ is a Borel set and a_y, b_y are measurable in y with $a_y < b_y$, and

2. a locally-Lipschitz function $F : B \to M$ such that $F(y, \cdot)$ is a constant-speed geodesic of $\mathcal F$ for almost every $y \in Y$,

and μ_{γ} is given by

$$
\mu_{\gamma} := \gamma_{\#}\left(c \cdot |\det dF(y_0, t)|dt\right)
$$

for some $y_0 \in Y$ and some $c > 0$. In particular F is differentiable in (y_0, t) for all $t \in (a_{y_0}, b_{y_0})$. The determinant here is defined by $\det dF = (F^*\omega)(\partial_y, \partial_t)$. It is also proved in Lemma 4.9 in [\[1\]](#page-23-1) that the function $t \mapsto \det dF(y_0, t)$ does not change sign. By precomposing F with a map of the form $(y, t) \mapsto (\ell(y), t)$ where ℓ is affine, we may assume that $y_0 = 0$, $\det dF(y_0, t) > 0$ for all t, and $c = 1$. It is also not hard to replace F (which is only known to be locally-Lipschitz) by a smooth variation through geodesics of $\mathcal F$ which has the same Jacobian determinant at $s = 0$. We then immediately see that μ_{γ} is a $\Gamma_{\mathcal{F}}$ -Jacobi needle, where $\Gamma_{\mathcal{F}}$ is the geodesic spray of \mathcal{F} . Since Γ is projectively equivalent to $\Gamma_{\mathcal{F}}$, it follows from Lemma [4.3](#page-15-4) that μ_{γ} is a (Γ, ω) -Jacobi needle. \Box

With the needle decomposition theorem at hand, we are now ready to prove Theorem [4.1.](#page-15-1)

Proof of Theorem [4.1.](#page-15-1) The proof is practically the same as the proof of [\[1,](#page-23-1) Theorem 1.1]. The idea is to use Theorem [4.4](#page-16-0) to decompose the measure μ into a family of (Γ, ω) -Jacobi needles, prove Brunn-Minkowski on each needle (Lemma [4.5\)](#page-18-0) using the assumption of nonpositive curvature of the spray, and then integrate the one-dimensional inequalities to obtain [\(BM\)](#page-15-0).

Let $A, B \subseteq M$ be nonempty, Borel measurable sets and let $0 < \lambda < 1$. The set $\mathcal{M}_{\Gamma}(A, B; \lambda)$ is Lebesgue measurable. Indeed, the set

$$
\{(x, y, m) \mid x, y \in M, m \in \mathcal{M}_{\Gamma}(\{x\}, \{y\}; \lambda)\}\
$$

is a closed subset of $M^2 \times M$, and we have

$$
\mathcal{M}_{\Gamma}(A, B; \lambda) = \pi_2 \left(\pi_1^{-1} (A \times B) \right),
$$

where $\pi_1 : M^2 \times M \to M^2$ and $\pi_2 : M^2 \times M \to M$ are the projections, which are Borelmeasurable.

We may assume, by a standard approximation argument, that both A and B are compact, and in particular, $\mu(A)$ and $\mu(B)$ are finite. Apply Theorem [4.4](#page-16-0) with

$$
\rho_1 = \frac{\chi_A}{\mu(A)} \quad \text{and} \quad \rho_2 = \frac{\chi_B}{\mu(B)} \tag{30}
$$

to obtain measures $\{\mu_{\gamma}\}_{\gamma \in \Lambda}$ and ν with the properties (i)-(iii) in Theorem [4.4.](#page-16-0) Here χ_A is the indicator function of the set A. By [\(27\)](#page-16-1) and [\(30\)](#page-18-1), for ν -almost any $\gamma \in \Lambda$, if $0 < \mu_{\gamma}(A) < \infty$ then

$$
\frac{\mu_{\gamma}(A)}{\mu(A)} = \frac{\mu_{\gamma}(B)}{\mu(B)}.
$$
\n(31)

Since A has finite measure, by [\(26\)](#page-16-2) we know that $\mu_{\gamma}(A) < \infty$ for ν -almost any $\gamma \in \Lambda$.

Lemma 4.5. *For v*-almost any $\gamma \in \Lambda$, if $0 < \mu_{\gamma}(A) < \infty$ then

$$
\mu_{\gamma}(\mathcal{M}_{\Gamma}(A,B;\lambda))^{1/2} \ge (1-\lambda)\,\mu_{\gamma}(A)^{1/2} + \lambda\,\mu_{\gamma}(B)^{1/2}.\tag{32}
$$

Proof. For *ν*-almost any $\gamma \in \Lambda$, the measure μ_{γ} is a (Γ, ω) -Jacobi needle along γ . From the definition of a (Γ, ω) -Jacobi needle and the assumption that Γ is nonnegatively curved with respect to ω , it follows that there exists an interval $I \subseteq \mathbb{R}$ and a measure m on I with a concave density, such that $\mu_{\gamma} = \gamma_{\#}m$. From the definition of $\mathcal{M}_{\Gamma}(A, B; \lambda)$, it suffices to prove that

$$
m(\mathcal{M}(\tilde{A}, \tilde{B}; \lambda))^{1/2} \ge (1 - \lambda) \cdot m(\tilde{A})^{1/2} + \lambda \cdot m(\tilde{B})^{1/2},
$$

where $\tilde{A} := \gamma^{-1}(A), \tilde{B} := \gamma^{-1}(B)$ and

$$
\mathcal{M}(\tilde{A}, \tilde{B}; \lambda) := \{ (1 - \lambda)a + \lambda b \mid a \in \tilde{A}, b \in \tilde{B}, a \le b \}.
$$

From this point the proof is identical to the proof in [\[1,](#page-23-1) Section 3.2], using conclusion (iii) of Theorem [4.4](#page-16-0) together with a variant of the one-dimensional Borell-Brascamp-Lieb inequality. \Box

We now integrate inequality [\(32\)](#page-18-2) over γ to obtain inequality [\(BM\)](#page-15-0). By [\(26\)](#page-16-2), (32) and [\(31\)](#page-18-3),

$$
\mu(\mathcal{M}_{\Gamma}(A,B;\lambda)) \stackrel{(26)}{=} \int_{\Lambda} \mu_{\gamma} (\mathcal{M}_{\Gamma}(A,B;\lambda)) d\nu(\gamma)
$$

\n
$$
\stackrel{(32)}{\geq} \int_{\Lambda} ((1-\lambda) \mu_{\gamma}(A)^{1/2} + \lambda \mu_{\gamma}(B)^{1/2})^{2} d\nu(\gamma)
$$

\n
$$
= \int_{\Lambda} \mu_{\gamma}(A) \left((1-\lambda) + \lambda \left(\frac{\mu_{\gamma}(B)}{\mu_{\gamma}(A)} \right)^{1/2} \right)^{2} d\nu(\gamma)
$$

\n
$$
\stackrel{(31)}{=} \int_{\Lambda} \mu_{\gamma}(A) \left((1-\lambda) + \lambda \left(\frac{\mu(B)}{\mu(A)} \right)^{1/2} \right)^{2} d\nu(\gamma)
$$

\n
$$
\stackrel{(26)}{=} \mu(A) \left((1-\lambda) + \lambda \left(\frac{\mu(B)}{\mu(A)} \right)^{1/2} \right)^{2}
$$

\n
$$
= ((1-\lambda) \mu(A)^{1/2} + \lambda \mu(B)^{1/2})^{2},
$$
 (33)

and [\(BM\)](#page-15-0) is proved.

One can use the same proof to show that for a two-dimensional, pFm weighted spray space, and for $N \in [2,\infty)$ the $CD(0, N)$ condition from Remark [3.7](#page-13-2) implies the Brunn-Minkowski inequality with exponent $1/N$.

Theorem 4.6. Let (M, Γ, ω) be a two-dimensional weighted spray space satisfying the $CD(0, N)$ *condition from Remark [3.7](#page-13-2) for some* $N \in [2,\infty)$ *. Suppose that* Γ *is projectively Finslermetrizable. Then for every nonempty Borel subsets* A, B ⊆ M *of positive measure and every* $0 < \lambda < 1$,

$$
\mu(\mathcal{M}_{\Gamma}(A,B;\lambda))^{1/N} \ge (1-\lambda) \cdot \mu(A)^{1/N} + \lambda \cdot \mu(B)^{1/N}
$$
 (BM)

□

where μ *is the Borel measure induced by the volume form* ω *.*

We now prove a converse to Theorem [4.1.](#page-15-1) The end of the ensuing proof is similar to the proof that if a $1/2$ -concave measure on the real line has a continuous density then this density is concave; this is an instance of a more general theorem about s-concave measures in \mathbb{R}^n , see Borell [\[5\]](#page-23-4). See also [\[9,](#page-24-14) Theorem 3.17]. The only difference, which is completely immaterial to the proof, is that in our case we only know inequality [\(36\)](#page-20-0) when $x_0 \le x_1$.

Proposition 4.7. Let (M, Γ, ω) be a two-dimensional simple weighted spray space. Assume that [\(BM\)](#page-15-0) *holds for every Borel nonempty* $A, B \subseteq M$ *and every* $0 < \lambda < 1$. Then (M, Γ, ω) *is nonnegatively curved.*

Proof. Let γ be a Γ-geodesic and let S be a transversal Γ-Jacobi field along γ . Let $F(s, t)$: $[-\delta_0, \delta_0] \times I \to M$ be a variation through curves of Γ which induces the Γ-Jacobi field S along γ . By transversality of S, we may take F to be a diffeomorphism. Denote

$$
S = F_*(\partial/\partial s), \qquad T = F_*(\partial/\partial t)
$$

(which, by our choice of F, is consistent with the previous definition of S at $s = 0$). By the definition of a nonpositively curved weighted spray, we should prove that the function

$$
J(t) := \omega(\dot{\gamma}(t), S(t)) = \omega(T, S)|_{s=0}
$$

is concave. Let $[x_0, x_0 + \ell_0]$ and $[x_1, x_1 + \ell_1]$ be subintervals of I with $x_0 + \ell_0 \leq x_1$ and let $0 < \lambda < 1$. Choose $0 < \delta < \delta_0$ and set

$$
A := F([0, \delta] \times [x_0, x_0 + \ell_0]), \qquad B := F([0, \delta] \times [x_1, x_1 + \ell_1]).
$$

Since $F^*\omega = \omega(T, S) dt \wedge ds$, we have

$$
\mu(A) = \delta \int_{x_0}^{x_0 + \ell_0} J(t)dt + o(\delta), \quad \text{and} \quad \mu(B) = \delta \int_{x_1}^{x_1 + \ell_1} J(t)dt + o(\delta). \quad (34)
$$

Moreover, since Γ is simple, there is a unique Γ-geodesic joining any two points in $F([0, \delta] \times$ I), which depends smoothly on its endpoints. Uniqueness implies that we can choose δ small enough that $\mathcal{M}_{\Gamma}(A, B; \lambda) \subseteq F([0, \delta] \times I)$, because a Γ -geodesic joining A to B will not intersect $\partial F([0, \delta] \times I)$ twice. The smooth dependence of a Γ-geodesic on its endpoints implies that, for every $\varepsilon > 0$, we may choose δ small enough that

$$
\mathcal{M}_{\Gamma}(A, B; \lambda) \subseteq F([0, \delta] \times [x_{\lambda} - \varepsilon, x_{\lambda} + \ell_{\lambda} + \varepsilon])
$$

where

$$
x_{\lambda} = (1 - \lambda)x_0 + \lambda x_1
$$
 and $\ell_{\lambda} = (1 - \lambda)\ell_0 + \lambda \ell_1$.

Therefore

$$
\mu(\mathcal{M}_{\Gamma}(A, B; \lambda)) \leq \mu(F ([0, \delta] \times [x_{\lambda} - \varepsilon, x_{\lambda} + \ell_{\lambda} + \varepsilon])
$$

=
$$
\delta \int_{x_{\lambda} - \varepsilon}^{x_{\lambda} + \ell_{\lambda} + \varepsilon} J(t) dt + o(\delta).
$$
 (35)

Combining [\(34\)](#page-19-1), [\(35\)](#page-20-1) and [\(BM\)](#page-15-0), and taking δ , $\varepsilon \to 0$, we get

$$
\left(\int_{x_{\lambda}}^{x_{\lambda}+\ell_{\lambda}} J(t)dt\right)^{1/2} \ge (1-\lambda) \cdot \left(\int_{x_0}^{x_0+\ell_0} J(t)dt\right)^{1/2} + \lambda \cdot \left(\int_{x_1}^{x_1+\ell_1} J(t)dt\right)^{1/2} \tag{36}
$$

for all x_0, x_1 and ℓ_0, ℓ_1 as above. By considering the first-order Taylor approximations of the integrals in [\(36\)](#page-20-0), we see that if ℓ_0, ℓ_1 are sufficiently small then

$$
(\ell_{\lambda}J(x_{\lambda}))^{1/2} \ge (1-\lambda) (\ell_0J(x_0))^{1/2} + \lambda (\ell_1J(x_1))^{1/2}.
$$

But since both sides are homogeneous in the ℓ_j , the above inequality holds for all $\ell_0, \ell_1 \geq 0$. Set $\ell_i = J(x_i)$. Then

$$
\left(\left((1 - \lambda)J(x_0) + \lambda J(x_1) \right)J(x_\lambda) \right)^{1/2} \ge (1 - \lambda)J(x_0) + \lambda J(x_1),
$$

whence $J(x_{\lambda}) \geq (1 - \lambda)J(x_0) + \lambda J(x_1)$. Since x_0, x_1 are arbitrary, we conclude that J is concave. \Box

Corollary 4.8. Let (M, g) be a Riemannian surface, let $\Gamma = E_1 + kV$ be a simple, proper metric *spray on* M and let $\omega = e^{-\varphi} \omega_g$ be a volume form on M. The following are equivalent:

1. The spray Γ is magnetic with respect to the metric $e^{-4\varphi}$ g, and

$$
K + k2 + \Gamma(d\varphi) - (d\varphi)2 - E2k \ge 0.
$$
 (37)

In particular, if $\omega = \omega_q$ *then* Γ *is magnetic with repect to g and*

$$
K + \kappa^2 - |\nabla \kappa| \ge 0,\tag{38}
$$

where κ *is the geodesic curvature function of* Γ*.*

2. Inequality [\(BM\)](#page-15-0) *holds for every Borel, nonempty subsets* $A, B \subseteq M$ *and every* $0 < \lambda < 1$ *.*

Proof. Assume that 1 holds. By Corollary [3.5,](#page-13-3) the weighted spray space (M, Γ, ω) is nonnegatively curved. Let A, B be Borel, nonempty subsets of M . By an approximation argument, we may assume that both are compact. Since Γ is proper, there exists a Γ -convex open set U containing A and B, and by Proposition [2.15,](#page-9-0) the restriction of Γ to U is Finsler-metrizable; we may assume without loss of generality that $M = U$. If A, B have positive measure, inequality [\(BM\)](#page-15-0) then follows from Theorem [4.1.](#page-15-1)

Suppose that one of the sets has zero measure. In the case where $\mu(A) = \mu(B) = 0$, inequality [\(BM\)](#page-15-0) holds trivially. Suppose that $\mu(A) = 0$ but $\mu(B) > 0$. Since A is non-empty, we may pick a point $a \in A$. For $t > 0$ define a map $H_t : M \to M$ by

$$
H_t(x) = \exp_a \left(t \cdot \exp_a^{-1}(x) \right),\tag{39}
$$

where $\exp := \exp\left(-\frac{1}{2}\right)$ and observe that

$$
\mathcal{M}_{\Gamma}(A, B; \lambda) \supseteq \mathcal{M}_{\Gamma}(\{a\}, B; \lambda) = H_{\lambda}(B).
$$

Thus, since A has measure zero, in order to prove [\(BM\)](#page-15-0) it suffices to show that for $0 < \lambda < 1$,

$$
\mu(H_{\lambda}(B)) \geq \lambda^2 \cdot \mu(B).
$$

Let $\tilde{\omega} = \exp_a^* \omega$ and let $\tilde{\mu}$ be the Borel measure on T_aM induced by the volume form $\tilde{\omega}$. Making a change of variables via the map \exp_a , which is a C^1 diffeomorphism since Γ is simple, and using [\(39\)](#page-21-1), the last inequality becomes

$$
\tilde{\mu}(\lambda \tilde{B}) \geq \lambda^2 \cdot \tilde{\mu}(\tilde{B}),
$$

where $\tilde{B} := \exp_a^{-1}(B) \subseteq T_aM$. Introduce polar coordinates (r, θ) on T_aM , and write $\tilde{\omega} =$ $J(r, \theta) dr \wedge d\theta$ for a smooth function J on $T_a M \setminus \{0\}$. By Fubini's theorem, it suffices to prove that for every θ and every measurable subset $S \subseteq \mathbb{R}$,

$$
\int_{\lambda S} J(r,\theta) dr \geq \lambda^2 \int_S J(r,\theta) dr.
$$

If we set $T := (\exp_a)_*\partial_r$ and $S := (\exp_a)_*\partial_\theta$ then $J = \omega(T, S)$, and the vector field S is a Γ-Jacobi field along each Γ-geodesic of the form $r \mapsto \exp_a((r \cos \theta, r \sin \theta))$ whose tangent is T. Thus the function $r \mapsto J(r, \theta)$ is concave for every θ since (M, Γ, ω) is nonnegatively curved. Moreover $J \to 0$ as $r \to 0$ since $d \exp_a$ is the identity at the origin. We therefore have

$$
\int_{\lambda S} J(r,\theta) dr = \lambda \int_{S} J(\lambda r, \theta) dr = \lambda \int_{S} J((1-\lambda) \cdot 0 + \lambda \cdot r, \theta) dr \geq \lambda^{2} \int_{S} J(r,\theta) dr,
$$

as desired. The case $\mu(B) = 0$ and $\mu(A) > 0$ follows by reversing the spray Γ (i.e. replacing it with the spray whose geodesics are Γ -geodesics traversed backwards) and applying the previous case. This finishes the proof of the implication $1 \implies 2$.

The implication $2 \implies 1$ follows from Proposition [4.7](#page-19-2) and Corollary [3.5.](#page-13-3) \Box

5 Examples

In this section we give some examples of two-dimensional weighted spray spaces satisfying [\(BM\)](#page-15-0).

Consider the case of constant curvature $K \equiv$ const, and $\omega = \omega_q$. By Corollary [4.8,](#page-21-0) for a simple, proper metric spray, the Brunn-Minkowski inequality [\(BM\)](#page-15-0) holds if and only if the spray is magnetic with respect to the metric of constant curvature g_K and the geodesic curvature function κ satisfies [\(38\)](#page-21-2). Define

$$
\cot_K x := \begin{cases} \sqrt{K} \cot(\sqrt{K}x) & K > 0, \\ 1/x & K = 0, \\ \sqrt{-K} \coth(\sqrt{-K}x) & K < 0. \end{cases}
$$

Then [\(38\)](#page-21-2) holds if and only if either $\kappa = \cot_K(f)$, where f is smooth, 1-Lipschitz function on M, or $K \leq 0$ and $\kappa \equiv \sqrt{-K}$.

Example 5.1 (Horocycles). On the hyperbolic plane we can take $\kappa \equiv 1$. The resulting spray has as its geodesics constant-speed horocycles. Inequality [\(BM\)](#page-15-0) for this spray was proved in [\[1\]](#page-23-1). Since this spray is simple, metric and proper, [\(BM\)](#page-15-0) for horocycles follows from Corollary [4.8.](#page-21-0)

Example 5.2 (Norwich Spirals). Take $M = \mathbb{R}^2 \setminus \{0\}$ with the flat metric $g_0 = dx^2 + dy^2$ and $\kappa = 1/r$ where $r = \sqrt{x^2 + y^2}$. The geodesics of the corresponding spray are either circles centered at the origin, or so-called Norwich spirals [\[22\]](#page-25-0) which are curves of the form

$$
\gamma_{a,b}(t) = a(t^2 + 1)e^{i(t - 2\arctan t + b)}, \qquad t \in \mathbb{R}
$$
\n(40)

for $a > 0$ and $b \in (-\pi, \pi]$, reparametrized to have constant speed. This spray is not simple (its geodesics self-intersect), but it is projectively Finsler-metrizable by the Randers metric

$$
\mathcal{F} = \sqrt{dx^2 + dy^2} - r d\theta.
$$

Indeed, $d(r d\theta) = dr \wedge d\theta = (1/r)(r dr \wedge d\theta) = (1/r) \omega_{g_0}$. The parametrization [\(40\)](#page-22-1) is in fact proportional to arclength with respect to F , hence completeness (and in particular geodesic convexity) of the metric follows from completeness of the flow of the spray and the Hopf-Rinow theorem. Thus by Theorem [4.1,](#page-15-1) this weighted spray space satisfies [\(BM\)](#page-15-0). Analogues of the Norwich spirals exist on the (punctured) sphere and hyperbolic plane and also satisfy [\(BM\)](#page-15-0).

Example 5.3 (Seiffert Spirals). Take $M = S^2 \subseteq \mathbb{R}^3$ with the round metric g_1 . Consider the magnetic spray on S^2 whose geodesic curvature function is $\kappa = z$, where z is the third coordinate in \mathbb{R}^3 . The geodesics of this spray which pass through the poles are known as Seiffert spirals [\[10\]](#page-24-15). If ϕ denotes spherical distance from the north pole, then $z = \cos(\phi) = \cot(f)$ where $f = \operatorname{arccot}(\cos(\phi))$ is a smooth, 1-Lipschitz function on S^2 . Thus by the discussion above, [\(38\)](#page-21-2) is satisfied. If ϕ , θ are spherical coordinates, then the 1-form $\eta = (\sin^2 \phi/2)d\theta$ satisfies $d\eta = \cos \phi \sin \phi \, d\phi \wedge d\theta = \cos \phi \, \omega_{g1}$, hence the geodesic spray of the Randers metric $\sqrt{g_1} - \eta$ is projectively equivalent to this spray. This metric is geodesically convex by compactness and the Hopf-Rinow theorem. It thus follows from Theorem [4.1](#page-15-1) and Corollary [3.5](#page-13-3) that this spray satisfies [\(BM\)](#page-15-0).

Example 5.4 (Circular arcs). Let $0 < r \leq R$, let $D \subseteq \mathbb{R}^2$ be an open disc of radius r and consider the spray on D whose geodesics are arcs of circles of radius R , parametrized proportionally to Euclidean arclength. This spray is simple, metric and magnetic (with respect to the Euclidean metric) and inequality [\(38\)](#page-21-2) holds (with $K \equiv 0$ and $\kappa \equiv 1/R$). Thus this spray satisfies [\(BM\)](#page-15-0) by Corollary [4.8.](#page-21-0)

Example 5.5 (Perturbation). Under the assumptions and notation of Corollary [4.8,](#page-21-0) if inequality [\(37\)](#page-21-3) is strict, then a C¹-small perturbation of k and/or a C²-small perturbation of φ will preserve inequality [\(BM\)](#page-15-0), as long as the perturbed spray is still simple. For example, a simple metric spray on a spherical cap which is C^1 -close to the geodesic spray will satisfy [\(BM\)](#page-15-0) with respect to the standard area measure, and the circular spray from Example [5.4](#page-23-5) will satisfy [\(BM\)](#page-15-0) with respect to a C^2 -small density on D.
