Note on the field theory of neutrino mixing

Abstract

The problem of the diagonalization of the flavor-neutrino propagator matrix is investigated in the theory with flavor-mixing mass terms in Lagrangian. For this purpose we examine one-pole structures of flavor-neutrino propagators, leading to physical neutrino masses, and discuss the relation of the propagator diagonalizaion to the diagonalizaion of the mass matrix in Lagrangian. In connection with the paper by Blasone et al., it is pointed out that there is no compelling reason for fixing the mass parameters, althought this fixing is necessary in order to construct the flavor Hilbert space.

I. INTRODUCTION

Since Pontecorvo[[1](#page-20-0)] pointed out the possibility of the neutrino oscillation and, in addition, the solar neutrino problem was proposed[[2\]](#page-20-0), the oscillation has been much investigated experimentally and theoretically. Indications in favor of the neutrino oscillation from various kinds of experiments havebeen reported $|3|$.

The main aim of the present note is to investigate the field theory of neutrino mixing and to give a remark on the way how to define the physical neutrino masses on the basis of Green-function approach, which has not been noticed in current literatures. In Sec[.II,](#page-2-0) we investigate this problem in the two-flavor case as an simple illustration, and Sec.[III](#page-7-0) the three-flavor case is to be examined.

In Sec[.IV](#page-12-0), we give some remarks on the field theory of neutrino mixing and the construction of the Fock space of definite flavors. For the later convenience, here we summerize the problems included in such a field-theoretical approach. Blasone and Vitiello[[4\]](#page-20-0) have considered the field theory of neutrino mixing. Their consideration is based on the unitary inequivalence of the Fock space for definite flavor states to that for definite mass states. Although the investigated theme is very interesting[[5\]](#page-20-0), there are some problematic points in ref. [\[4](#page-20-0)]. The first point is that the expansion of the fermion field in terms of plane-wave eigenfunctions of the third component of the spin operator is employed. Such a way of the expansion causes an unnecessary and nonessential complications in presentation of the theory. When the plane-wave eigenfunctions of the helicity are employed from the outset, as finally done also in ref.[[4\]](#page-20-0), the description of the theory will be much simplified and becomes clearer.

Whereas the first point mentioned above is of technical character, the second point is more fundamental. The second point is related to the problem how to define the annihilation and creation operators for definite flavors and definite masses. The relations from (2.23a) to (2.23d) given in ref. [\[4\]](#page-20-0) are written as

where (in the case of the two flavors) $\{\sigma, j\} = \{e, 1\}$ and $\{\mu, 2\}$; $u_b(k, r)$, $b = \sigma$ or j, is the plane wave eigenfunction with the mass m_b and the spin component r; $G(\theta)$ is given by

Under the excuse of convenience, $u_{\sigma}(k,r)$ and $v_{\sigma}(k,r)$ have been chosen to be the eigenfunctions with the masses m_1 and m_2 for $\sigma = e$ and μ , respectively; that is, the authors of ref. [\[4](#page-20-0)] defined the operators α_{σ}^{BV} and β_{σ}^{BV} through $u_j \alpha_{\sigma}^{BV} \equiv u_{\sigma} \tilde{\alpha}_{\sigma}$ and $v_j^* \beta_{\sigma}^{BV} \equiv v_{\sigma}^* \tilde{\beta}_{\sigma}$. Thus, from (1.1) and (1.2), they obtained

Although the relation (1.1) and (1.2) employed for deriving (1.4) are not understandable, this lastrelation can be understood as follows. Any Heisenberg field $\nu_b(x)$ can be expanded [[6](#page-20-0)] in terms of the helicity-momentum eigenfunctions [\[7](#page-20-0)] as

Here, $u_b(k, r)$ and $v_b(k, r)$ satisfy

where $k = \gamma^{\alpha} k_{\alpha} = \vec{\gamma} \vec{k} + \gamma^4 i k_0$; $v_b(-k, r)$ and β_b^{\dagger} $\mathbf{b}(-k, r; t)$ are the quantities with the 3-momentum $-k$; the helicity eigenfunctions are used for technical simplicity in the following, and their concrete forms are given in Appendix A. The expansion coefficient operators in ([1.5\)](#page-1-0) satisfy the canonical commutation relations for the equal time, which are derived from the equal-time commutation relations, $\{\nu_b(x), \nu_b^{\dagger}\}$ $\{\delta_{b'}(y)\} = \delta(\vec{x} - \vec{y})\}\delta_{bb'}$ and others = 0. From the relation

where $\{u_{\sigma}, v_{\sigma}\}\$ and $\{u_j, v_j\}$ are the plane-wave eigenfunctions with masses m_{σ} and m_j , respectively. (1.8) is the relation which can be utilized instead of [\(1.1](#page-1-0)) and([1.2\)](#page-1-0), and leads to the general linear transformation between $\{\alpha_{\sigma}(k,r),\beta_{\sigma}^{\dagger}(-k,r),\sigma=e,\mu\}$ and $\{\alpha_{j}(k,r),\beta_{j}^{\dagger}(-k,r),j=1,2\}$ as

The concrete form of $\mathcal{G}(\theta)$ is easily obtained as given in Appendix A by utilizing the explicit forms of u_{σ} , v_{σ} , u_j and v_j [\[7](#page-20-0)]. If we take $m_e = m_1$ and $m_{\mu} = m_2$ as a special case of $(1.9)($ or $(1.8))$, we obtainthe relation (1.4) , which plays the basic role in ref. $|4|$. Thus it is necessary for us to make clear a logical basis of the above choice of m_e and m_μ , on which we examine in Sec[.IV](#page-12-0).

Giunti et al. [\[8](#page-20-0)] assert that it is impossible to define generally the creation and annihilation operators with a definite flavor, and that the construction of the Fock space of 'weak'(or flavor) states is approximately allowed only in the extremely relativistic case. Along a different context, we will obtain the same conclusion, although the second assertion mentioned above is evident, since in (1.9) all dependences of $\mathcal{G}(\theta, k)$ on mass diferences among m_j 's and m_σ 's become negligible and we obtain

as well as the same relation between $(\beta_e(k, r), \beta_\mu(k, r))$ and $(\beta_1(k, r), \beta_2(k, r))$. In Appendix B we add a related remark.

II. DIAGONALIZATION OF THE NEUTRINO PROPAGATOR —–THE CASE OF 2-FLAVORS —–

We examine the diagonalization of the neutrino propagator according to the procedure proposed by Kaneko, Ohnuki and Watanabe [\[9](#page-20-0)], which had been developed many years ago as the field theory of particle mixture interaction. In this section we consider the two-flavor case as an illustration. (In this paper we confine ourselves to the case of Dirac neutrino.)

A. Starting Lagrangian

Let us consider the following Lagrangian density with a mutual transition between two neutrino fields specified by the flavor degrees of freedom $\sigma = e$ and μ ;

Due to $M^{\dagger} = M$, required from the hermiticity of $\mathcal{L}(x)$, m_{ee} and $m_{\mu\mu}$ are real and $m_{e\mu}^{*}$ is equal to $m_{\mu e}$. \mathcal{L}_{int} in (2.1) is assumed to have no bilinear terms and no derivatives of the neutrino field operators; then the Hamiltonian is

B. Poles of the propagator matrix

With the aim of examining the propagation character of ν_{σ} -field, we consider the propagator

where $\nu_{\sigma}(x)$ is the flavor neutrino field appearing in the Lagrangian ([2.1\)](#page-3-0) and is called the unrenormalized Heisenberg operator in accordance with the Lehman's terminology [\[10](#page-20-0)]. It is necessary for us to define the vacuum $|0\rangle$. Here we assume that, corresponding to a given Hamiltonian, the vacuum with the lowest energy exists. The Fourier transform of the propagator (2.15), $S'_{\sigma\rho}(k) = \int d^4x exp(-ikx) S'_{\sigma\rho}(x)$, satisfies

Let us examine the pole structure of $S'_{\sigma\rho}$ under the approximation for the proper self-energy part $\Pi_{\sigma\rho}$ by neglecting $\mathcal{L}_{int}(x)$ in ([2.3\)](#page-3-0) and by taking into account only the contribution from e $\to \to \to \mu$ in the lowest order; thus, we have

Therefore, the physical one-particle masses given as poles of $S'_{\sigma\rho}(\hat{k})$ are seen to coincide with the eigenvalues of the mass matrix M.

It should be noted that there is an arbitrariness in separating $\mathcal{H}(x)$ into the "free" and "interaction" parts. So it is worthy to give a remark on this point. We rewrite the Hamiltonian([2.4\)](#page-3-0) as

Dropping contributions from $\mathcal{L}_{int}(x)$ to the proper self-energy part and taking account of the contribution from $H_{int}(x)$, we obtain

which shows the arbitrariness in defining $S_{\rho}(k)$ disappears in the physical one-particle masses.

C. Diagonalization of the pole part in the propagator

We examine diagonalization of the pole part in the neutrino propagator $S'_{\sigma\rho}(\mathcal{N})$. Writing the cofactor corresponding to $f_{\sigma\rho}$ as $F_{\sigma\rho}$, we have

III. CASE OF THREE FLAVORS

We examine the diagonalization of the flavor neutrino propagator in the three-flavor case along the same line of thought as given in the preceding section.

For the purpose of finding any logical basis of the choice([4.1\)](#page-12-0), we reexamine the consideration in ref.[[4](#page-20-0)]. We introduce the mass and the flavor vacua $|0\rangle_m$ and $|0(\theta, t)\rangle$ as

Thus one can construct Hilbert spaces \mathcal{H}_m and \mathcal{H}_f by operationg possible polynomials of $\{\alpha_j^{\dagger}$ [†]'s, β_j^{\dagger} 's, $j = 1, 2$ } and $\{\alpha_{\sigma}^{\dagger}$'s, β_{σ}^{\dagger} 's, $\sigma = e, \mu\}$, respectively, on the vacuum states $|0\rangle_m$ and $|0(\theta; t)\rangle$, where these state are defined by

thusone cannot obtain any constraint on m_{σ} 's. Therefore, the choice ([4.1\)](#page-12-0) has no compelling theoretical reason other than "convenience" and "simplicity" and there is no physical basis for fixing the m_{σ} values.

V. SUMMARY AND FINAL REMARKS

We have first examined the diagonalizaion of the flavor-neutrino propagator matrix by following the procedure proposed by Kaneko et.al.[[9\]](#page-20-0) (but without employing any intermediate fields $\{\phi_j, \tilde{\phi}_j, j = 1, 2, 3\}$. We have concretely shown that, in so far as the matrix of the proper self-energy part $\Pi_{\rho\sigma}(k)$ for the flavor-neutrino fields is allowed to be approximated by neglecting \mathcal{L}_{int} in [\(3.8](#page-8-0)), a set of the renormalized fields $\{\psi_j^r(x), \bar{\psi}_j^r(x)\}$ can be defined as

The matrix $[z^{\frac{1}{2}}]$, which may be called the generalized z-factor, has been shown to be essentially the same as that diagonalizing the mass matrix M in the starting Lagrangian (3.8) .

Under the adopted approximation for $\Pi_{\sigma\rho}$, the content summarized above seems consistent and, in some sense self-evident. We cannot go, however, beyond this approximation due to ignorance of the Higgs neutrino interaction included in $\mathcal{L}_{int}(x)$.

Under the same approximation we have reexamined in Sec[.IV](#page-12-0) the problem proposed by Blasone et al. [\[4](#page-20-0)]. The essential problem in the field theory of the neutrino mixing is to settle how to define appropriate creation and annihilation operators of the flavor(or weak[[8\]](#page-20-0)) states. We have shown that, by taking account of the general relation [\(4.18](#page-14-0)) as well as the relation between the two vacuum states,([4.19\)](#page-14-0), there is neither theoretical reason for choosing $m_e = m_1$ and $m_\mu = m_2$ adopted in ref. [\[4\]](#page-20-0) nor physical basis for fixing any special m_{σ} values. In this sense we cannot construct generally the flavor Fock space, except for the extremely relativistic case; this is in accordance with the assertion in ref. [\[8](#page-20-0)], though our reasoning is based on a different context.

In so far as we consider the transition or survival amplitudes by treating such a quantity as

we have to fix the mass parameters m_ρ 's in order to settle the relations of α_ρ 's to the fields $\nu_\rho(x)$'s. But we saw in Sec[.IV](#page-12-0) that there is no theoretical reason to specify the mass parameters. Instead, under theapproximation of neglecting \mathcal{L}_{int} in the Lagrangian ([3.8\)](#page-8-0), the propagator, $S'_{\sigma\rho}(k) = \text{F.T. of} <$ $0|T(\nu_{\sigma}(x)\bar{\nu}_{\rho}(y))|0\rangle$, has been shown to have a structure which is independent of the mass parameter m_ρ 's, that is, independent of the choice of the perturbative vacuum corresponding to the 'free' Hamiltonians,specified by the mass parameters $m_{\rho\rho}^0$'s as in ([2.22\)](#page-4-0) and [\(3.9](#page-8-0)). Thus, it is favorable for us to treat the neutrino oscillation problem by relying solely on the neutrino propagator. Related investigations have been done in ref. [\[12\]](#page-20-0), and the work developed by Grimus and Stockinger [\[13\]](#page-20-0) seems to be important from our viewpoint.

\{A_{\sigma\pm}(kr;t), A_{\rho\mp}^{\dagger}(k's;t)\} = \{B_{\sigma\pm}(kr;t), B_{\rho\mp}^{\dagger}(k's;t)\} = \sum_{j} U_{\sigma j} U_{\rho j}^{*} \frac{m_{j}}{2E_{j}} \delta_{rs} \delta(\vec{k}, \vec{k}'),

In the extremely relativistic limit, we have

\{A_{\sigma+}(kr;t), A_{\rho+}^{\dagger}(k's;t)\} \longrightarrow \delta_{rs}\delta(\vec{k},\vec{k}'),\{B_{\sigma+}(kr;t), B_{\rho+}^{\dagger}(k's;t)\} \longrightarrow \delta_{rs}\delta(\vec{k},\vec{k}'),\text{others} \longrightarrow 0;

the high momentum part in r.h.s. of([B6](#page-17-0))

$$
\sim \frac{1}{\sqrt{V}} \sum_{\vec{k}} \left(\begin{bmatrix} A_{\sigma+}(k\uparrow;t)w(k\uparrow) \\ A_{\sigma+}(k\downarrow;t)w(k\downarrow) \end{bmatrix} + \begin{bmatrix} B_{\sigma+}^{\dagger}(-k\downarrow;t)w(k\downarrow) \\ B_{\sigma+}^{\dagger}(-k\uparrow;t)w(k\uparrow) \end{bmatrix} \right) e^{i\vec{k}\vec{x}} \tag{B10}

with

A_{\sigma+}(kr;t) = \sum_{j} U_{\alpha j} \alpha_j(kr;t), \quad B_{\sigma+}^{\dagger}(-kr;t) = \sum_{j} U_{\alpha j} \beta_j^{\dagger}(-kr;t). \tag{B11}

According to the assertion in ref.[[8\]](#page-20-0), one may construct an approximate Fock space of weak states in terms of $\{A^{\dagger}_{\sigma+}(kr;t), B^{\dagger}_{\sigma+}(-kr;t)\}\$ give by (B11) only in the case of extremely relativistic neutrinos. This assertion is in some sense self-evident, since masses of neutrinos become irrelevant in the extremely relativistic neutrinos.

It is more natural, however, to define, instead of (B11), a set of independent operators

so that the independent number of $\{\tilde{A}_{\sigma}, \tilde{B}_{\sigma}^{\dagger}\}\$ are equal to that of $\{\alpha_j, \beta_j^{\dagger}\}\$. We obtain

\{\tilde{A}_{\sigma}(kr;t),\tilde{A}_{\rho}^{\dagger}(k's;t)\} = \delta_{rs}\delta(\vec{k},\vec{k}') = \{\tilde{B}_{\sigma}(-kr;t),\tilde{B}_{\rho}^{\dagger}(k's;t)\},\

\text{others} = 0. \tag{B13}

In ref.[[8\]](#page-20-0), a set of operators, the number of which is twice times larger than the independent number, are introduced (similar to [\(B5\)](#page-17-0) in the case of Dirac neutrinos). Instead of doing so, we have defined a set of necessary and sufficient number of independent operators (B12) as a kind of Bogolyubov transformation, and obtained the canonical commutation relations (B13), irrespective of the value of $|\vec{k}|$.

From([B4\)](#page-17-0) we obtain

$$
\nu_{\sigma}(x) = \frac{1}{\sqrt{V}} \sum_{\vec{k}} \left[\left(\tilde{A}_{\sigma}(k \uparrow; t) \begin{bmatrix} 1 \\ 0 \end{bmatrix} + i \tilde{B}_{\sigma}^{\dagger}(-k \uparrow; t) \begin{bmatrix} 0 \\ 1 \end{bmatrix} \right) \otimes w(k \uparrow) + \left(\tilde{A}_{\sigma}(k \downarrow; t) \begin{bmatrix} 0 \\ 1 \end{bmatrix} + i \tilde{B}_{\sigma}^{\dagger}(-k \downarrow; t) \begin{bmatrix} 1 \\ 0 \end{bmatrix} \right) \otimes w(k \downarrow) \right] e^{i \vec{k} \vec{x}}.

The important feature of this expansion is that the operators $\{\tilde{A}_{\sigma}, \tilde{B}_{\sigma}\}\$ depend explicitly on m_j 's as well as $|\vec{k}|$, but not on m_{σ} 's explicitly. In the case of 2-flavors(i.e. $\sigma = e$ and μ), we have

\tilde{\mathcal{G}}(\theta, k) = \begin{pmatrix} c_{\theta}c_1 & s_{\theta}c_2 & -ic_{\theta}s_1 & -is_{\theta}s_2 \\ -s_{\theta}c_1 & c_{\theta}c_2 & is_{\theta}s_1 & -ic_{\theta}s_2 \\ -ic_{\theta}s_1 & -is_{\theta}s_2 & c_{\theta}c_1 & s_{\theta}c_2 \\ is_{\theta}s_1 & -ic_{\theta}s_2 & -s_{\theta}c_1 & c_{\theta}c_2 \end{pmatrix}, \quad c_j = \kappa_{j+}, s_j = \kappa_{j-}.

(B16)is seen to be equal to $\mathcal{G}(\theta, k)$, ([A7](#page-16-0)), in which the mass parameters m_e and m_μ employed in the plane-wave expansion of the flavor neutrino fields ν_{σ} 's are set equal to zeros. Because, as seen from [\(B3\)](#page-17-0), we have e.g. $u(k \uparrow)$ for the zero mass is

u(k\uparrow) = \begin{pmatrix} 1\\0 \end{pmatrix} \otimes w(k\uparrow). \tag{B17}
$$
