M ass singularity and con ning property in QED₃

Abstract

We discuss the properties of the position space ferm ion propagator in three dimensional QED which has been found previously based on W ard-Takahashi-identity for soft-photon emission vertex and spectral representation in quenched approximation. There is a new type of mass singularity which governs the long distance behaviour. It leads the propagator vanish at large distance. This term corresponds to dynamical mass in position space and expressed as superposition of the propagator with di erent mass in momentum space. Our model shows con ming property and dynamical mass generation for arbitrary coupling constant. Since we used dispersion relation in deriving spectral function there is a physical mass which sets a mass scale. Low energy behaviour of the proagator is modi ed to decrease by position dependent mass. In the limit of zero infrared cut-o the propagator vanishes with new kind of infrared behaviour.

I. IN TRODUCTION

Infrared behaviour of the propagator in the presence of massless particle (i.e.photon and graviton) had been discussed assuming spectral representation of the propagator and the use of W ard-Takahashi-identity [1]. It is pointed out that the spectral representation is model independent and the asymptotic form of the scalar propagator in QED and G ravity theory were determined [1]. It has long been thought that the three dimensional QED is a conning theory since its infrared divergences is severe [3]. However it has not been known what we can observe as a connement Ω ne of these examples is a vanishment of the propagator have a new type of mass singularity in the same approach in ref[1] to QED [2]. There are two kinds of gauge invariant mass singularities in the evaluation of the O (e²) spectral function

by LSZ reduction formula A fter exponentiation of $O(e^2)$ spectral function we get the full propagator in position space which is a product of free propagator with physical mass and quantum correction. II. WARD-TAKAHASHI-IDENTITY AND THE SPECTRAL FUNCTION

First we consider about the charged particles which em itt and absorb massless photons J sually this process was described by spectral function; transition probability of particle into particle and photon state. This method is model independent and helpful in any dimension and leads to the so called B loch-N ordsieck approximation M ulti-photon em itted from external line is introduced by ladder type diagrams which satisfy W ard-Takahashiidentity. The proles of the (x) for various values of D 1 are shown in Fig.1. The ect of $(jx)^{C_{jxj}}$ in position space is seen to decrease the value of the propagator at low energy and shown in Fig.2.



In section III and IV we discuss dynamical mass, the renormalization constant, and bare mass in connection of each terms in F .

D. M ass generation

Since our model Q E D₃ is super renorm alizable mass generation occurs perturbatively. In other words, mass changes as in the case of operator insertion [8]. It is seen by the dimensional analysis of the propagator or self-energy For instance we take an example for the O (e^2) self-energy

which are a prioli assumed to be satis ed in the numerical analysis of Dyson-Schwinger equation.

III. ANALYSIS IN MOMENTUM SPACE

To search the infrared behaviour we expand the propagator in the coupling constant e^2 and obtained the Fourier transform of (x) [2]. In that case it is not enough to see the structure of infrared behaviour which can be compared to the well-known four dimensional QED . Instead we make Laplace transform ation of $(jx)^{c_{jxj}}$, which leads the general spectral representation of the propagator in momentum space A fler that we show the roles of C oulom b energy and position dependent mass. The form er determines the dimension of the propagator and the latter acts to change mass. Let us begin to study the elect of position dependent mass (Self-energy), C oulom b energy in momentum space

Sim ilar discussion was given to study the e ects of self-energy and bare potential in the stability of massless e⁺ e composite in the lattice simulation [11]. The position space free propagator

the short distance behaviour from the bare 1=jxj to $1=jxj^{1}$. The e ect of C oulomb energy for the infrared behaviour of the free particle with mass m can be seen by its fourier transform [2,10]

Above form ula shows the structure in momentum space is modiled for both infrared and ultraviolet regions JJ sually constant D represents the coel cent of the leading infrared divergence for xed mass in four dimension. Therefore C culom b energy has the same elects in three dimension as in four dimension but change the ultraviolet behaviour since the coupling constant e^2 is not renormalized N ow we consider the role of M (x) as the dynam ical mass at low momentum F inst we de ne Fourier transform of the (x);

Momentum dependence of (p) for various values of D is shown numerically in Fig.3 We notice that

which we can see from (70),(58)-(60). If we include $(jxj)^{cjxj}$ term it is easy to see that the value of the proagator (p = 0) decreases which is shown numerically in Fig.3. In the previous paper we expand the propagator (p) in powers of e^2 and see the logarithm ic infrared divergence at $p^2 = m^2$. In that case it is not clear the e ect of position dependent m ass. If we use Laplace transform ation it is easily seen that $(jxj)^{cjxj}$ acts as m ass changing operator m is s

near $p^2 = m^2 \ln Euclidean$ space it is natural that in the long-distance the propagator vanishes in the lim it ! 0.In M inkowski space we nd a vanishiment of the propagator as p = 1 p²=m² (ln (1 p²=m²)) ⁴ near p² = m² for the Yennie gauge at D = 1, which is a consequence of connement picture in our model. In comparison between our model and D yson-Schwinger equation, D = 1 is preferred for dynamical mass generation. It has been discussed that the propagator will have a branch point on the real p² axis associated with dynamical mass[12,13]. Therefore we can say that the radiatively connected fermion has not a simple structure as in QED₄; in QED₃ it has a superposition of dimension of dimension. There is a possibility to remove infrared cut-o by including photon mass as Chem-Simon term or vacuum polarization of photon [3,5,7].

IV. BARE MASS AND VACUUM EXPECTATION VALUE

In this section we exam ine the renorm alization constant and bare mass and study the condition of vanishing bare mass based on spectral representation. The equation for the renorm alization constant in terms of the spectral functions read

This means that propagator in the high energy limit has no part which is proportional to the free one and it shows con nement JJ sually mass is a parameter which appears in the Lagrangean For example chiral symmetry is de ned for the bare quantity. In ref[9] the relation between bare mass and renormalized mass of the fermion propagator in QED is discussed based on renormalization group equation with the assumption of ultraviolet stagnant point and shown that the bare mass vanishes in the high energy limit even if we start from the nite bare m ass in the theory. It suggests that sym m etry properties can be discussed in terms of renorm alized quantities. In QCD bare m ass vanishes in the short distance by asymptotic freedom And the dynam icalm ass vanishes too [8]. Since our model is super-reomalizable bare m ass m₀ does not vanish. In our apprximation this problem is understood that at short distance propagator in position space tends to

where we have (0) = finite at D = 1 case which is independent of the bare mass m₀. Thus we have a same e ect as vanishing bare mass in four dimensional model O f course we have a dynamical mass generation which is $m = \frac{1}{8}e^2$ (d 2 + 1)j + M (x) for m₀ = 0 in our approximation: There is a chiral symmetry at short distance where the bare or dynamical mass vanishes in momentum space but its breaking must be discussed in terms of the values of the order parameter. Therefore it is interesting to study the possibility of pair condensation in our approximation. The vacuum expectation value of pair condensate is evaluated

for nite cut-o For D < 1 case the (x) is divergent at x = 0 and it boks like a spike, for D = 1; (0) = finite and it boks like a wave packet at nite range where long range correlation appears, and for D > 1; (0) = 0 but it does not dam p fast for large x. In the weak coupling lim it we obtain $Z_2 = 1$; $m_0 = m$ and = 1 . If we introduce chiral symmetry as a global U (2n), it breaks dynamically into SU (n) SU (n) U (1) U (1) as in QCD [8,11] for D = 1 for nite infrared cut-o Ω urm odel may be applicable to relativistic m odel of super uidity in three dimension J sually we do not not the critical coupling D = 1 in the analysis of the D yson-Schwinger equation in momentum space where only continuum contributions are taken into account and we do not de ne physical mass.

V. SUMMARY

Infrared behaviour of the propagator has been exam ined in the Bolch-Nordsieck-like approximation to QED 3 U sing LSZ reduction formula for the one photon matrix element we nd two kinds of logarithm ic infrared divergent term s.T here are position dependent m ass and Coulom b energy both of which are gauge independent in our approximation. Con ning property is shown by position dependent m ass at large distance where propagator vanishes faster than the sloution of Dyson-Schwinger equation converted into position space with som e approximation Renormalization constant Z_2^{-1} vanishes for arbitrary coupling D in our approximation, which implies con nement Momentum space propagator is expressed as dispersion integral and it shows us that the e ects of dynam ical mass can be written as a superposition of the propagator with di erent masses. In our approximation there seems to be a critical coupling constant for vacuum expectation value which is independent of the bare mass 0 urm odel shows that the con ning property of charged ferm ion and dynam icalm assignmentation are realized in QED₃ (at critical coupling constant D = 1) as in QCD in four dimension with nite infrared cut-o which may be supplied by some dynamical origin of the photon m ass beyond the quenched approximation .

VII. A.GAUGE DEPENDENCE

In ref[2,5,9] gauge dependece of the propagator has been discussed. In order to understand the gauge dependence of the propagator away from the threshold, we will once exam ine the gauge covariance relation W riting D (k) = D⁽⁰⁾ (k) + k k M (k), we see that the ferm ion

In our approximation only mass terms changes under the gauge transformation and remaining terms in F are gauge invariant. In general gauge invariant part is approximation dependent.
