A bstract

A measurement of the direct CP violating charge asymmetries of the Dalitz plot linear slopes $A_g = (g^+ g^-)=(g^+ + g^-)$ in K ! and K ! 00 decays by the NA 48/2 experiment at CERN SPS is presented. A new technique of asymmetry measurement involving simultaneous K⁺ and K beam s and a large data sample collected allowed a result of an unprecedented precision. The charge asymmetries were measured to be $A_g^c = (1522) 10^4$ with 3:11 10^9 K ! decays, and $A_g^n = (1812) 10^4$ with 9:13 10^7 K ! 0^0 decays. The precision of the results is limited mainly by the size of the data sample.

Introduction

Form one than 20 years, after the discovery in 1964 that the long lived neutral kaon could decay to the same 2 nal state as the short lived one [1], dem onstrating that the mass eigenstates of the neutral kaons consist of a mixture of even and odd eigenstates under the combined operation of C harge conjugation and Parity, no other manifestation of CP violation was detected despite intensive experimental investigation. In the meanwhile the discovery of the three families of quarks and the development of the Standard M odel (SM) made it plausible that CP violation was in fact a general property of the weak interactions, originating from a single non-trivial phase in the CKM matrix of the coe cients involved in avour changing transitions. It was in particular realized that, barring accidental cancellations, CP violation should be relevant not only in meson-antimeson mixing but also in decays (direct CP violation) and in so called mixing induced transitions.

Two major experimental breakthroughs have since taken place. In the late 1990s, following an earlier indication by NA31 [2], the NA48 and KTeV experiments rm ly established the existence of direct CP violation [3, 4] by measuring a non-zero value of the parameter $\text{Re}("^0=")$ parameter in K⁰! 2 decays. More recently the B-factory experiments Babar and Belle discovered a series of CP violating elects in the system of the neutral B meson [5, 6].

In order to explore possible non-SM enhancements to heavy-quark loops, which are at the core of direct CP-violating processes, all possible manifestations of direct CP violation have to be studied experimentally. In kaon physics, besides the already investigated parameter R e("⁰="), the most promising complementary observables are the rates of G M - suppressed avour-changing neutral current decays K ! , and the charge asymmetry between K ⁺ and K decays into 3.

It is di cult to constrain the fundam ental param eters of the theory using m easurem ents of direct CP violation in decay am plitudes due to the presence of non-perturbative hadron e ects. Still, an intense theoretical program m e is under way to im prove predictions, aim ing to allow the direct CP violation m easurem ents to be used as quantitative constraints on the SM .

The K ~!~ 3 ~m atrix element squared is conventionally parameterized [7] by a polynom ial expansion 1

where g, h, k are the so called linear and quadratic D alitz plot slope parameters (j, j; k j j; j), and the two Lorentz invariant kinem atic variables u and v are de ned as

Here m is the charged pion mass, P_K and P_i are the kaon and pion four-momenta, the indices i = 1;2 correspond to the two pions of the sam e electrical charge (\even" pions, so that v is de ned up to a sign), and the index i = 3 to the pion of di erent charge (the \odd" pion). A di erence between the slope parameters g^+ and g^- describing the decays

of positive and negative kaons, respectively, is a manifestation of direct CP violation usually expressed by the corresponding slope asymmetry

where g is the slope di erence and g is the average linear slope. In general terms, the slope asymmetry is expected to be strongly enhanced with respect to the asymmetry of integrated decay rates [11]. A recent full next-to-leading order ChPT computation [12] predicts A_g to be of the order of 10⁵ within the SM. Another SM calculation [13] predicts the asymmetry in the K ! ⁰ decay to be of the order of 10⁶ (in agreement with [12] within the errors). Theoretical calculations involving processes beyond the SM [14] allow a wider range of A_g , including substantial enhancements up to a few 10⁴.

In the past years, several experiments have searched for the CP violating slope asymmetry in both $^+$ and $^{0\ 0}$ decay modes by collecting samples of K $^+$ and K decays [15, 16]. These measurements set upper limits on A_g at the level of a few 10 3 , limited by systematic uncertainties.

The prim ary goal of the NA 48/2 experim ent at the CERN SPS is the measurem ent of the slope charge asym metries A_g in both K ! ⁺ and K ! ⁰ processes with a sensitivity at least one order of magnitude better than previous experiments. The new level of precision can explore e ects, albeit larger than the SM predictions, induced by new physics, and is achieved by using a novel measurem ent technique based on simultaneous K ⁺ and K beam s overlapping in space.

M easurem ents of A_g in both decay modes, performed with approximately half of the NA 48/2 data sample have been published [17, 18]. This paper presents the nalresults, superseding these earlier results.

The plan of the paper is the follow ing. In Section 1 the experim ental setup is described. Section 2 contains the description of the m ethod developed for the m easurem ent of the slope di erence which is common to both decay modes, and which aims to cancel rst order system atic biases. The analyses of the K ! + and K ! ⁰ decay modes are discussed in Sections 3 and 4, respectively. D iscussion of the results follows in Section 5.

1 Beam s and detectors

1.1 Simultaneous K⁺ and K beams

A high precision measurement of A_g (at the level of 10⁴) requires a dedicated experimental approach together with collection of very large data samples. A novel beam line providing for the rst time two simultaneous charged beams of opposite signs superimposed in space over the decay ducial volume was designed and built in the high intensity hall (ECN3) at the CERN SPS. The beam line is a key element of the experiment, as it allows decays of K⁺ and K to be recorded at the same time, and therefore leads to cancellation of several systematic uncertainties for the charge asymmetry measurement. Regular alternation of magnetic elds in all the beam line elements was adopted, which contributed to symmetrization of the average geometrical acceptance for K⁺ and K decays. The layout of the beam s and detectors is shown schematically in Fig.1.



Figure 1: Schem atic side view of the NA 48/2 beam line (TAX17,18: motorized beam dum p/collim ators used to select the momentum of the K⁺ and K beam s, FD FD /D FD F: focusing quadrupoles, KABES1{3: kaon beam spectrom eter stations), decay volum e and detector (D C H 1{4: drift cham bers, H O D : hodoscope, LK r: EM calorim eter, H A C : hadron calorim eter, M UV : m uon veto). Thick lines indicate beam axes, narrow ones the projection of their envelopes. Note that the vertical scales are di erent in the two parts of the gure.

The setup is described in a right-handed orthogonal coordinate system with the z axis directed downstream along the beam, and the y axis directed vertically up. Thus the horizontal x coordinate is such that the negative (positive) x point to the Saleve (Jura) m ountains. The Saleve/Jura notation is used in the following analysis to denote the spectrom eter m agnet polarity.

The beam s are produced by 400 G eV/c protons (delivered from the CERN SPS with a duty cycle of 4.8 s/16.8 s) in pinging on a beryllium target of 40 cm length and 2 mm diam eter. Both beam s leave the target on axis at zero production angle, thereby ensuring that their source is geom etrically sim ilar and that the K $^+$ =K ux ratio rem ains stable. It was demonstrated that the sm all residual di erence of K $^+$ and K m om entum spectra produces a negligible e ect on them easurem ent. Charged particles with m om enta (60 3) G eV/c are selected in a charge-symmetric way by an achromatic system of four dipole m agnets with zero total de ection ('achromat'), which splits the two beams in the vertical plane and then recombines them on a common axis. Then the beam s pass through a de ning collimator and a series of four quadrupoles designed to produce horizontal and vertical charge-symmetric focusing of the beam s towards the detector. Finally the two beam s are again split in the vertical plane and recombined by a second achrom at, where three stations of a M icrom egas-type [19] detector operating in TPC m ode form a kaon beam spectrom eter KABES [20] (not used in the present analyses).

A fter passing through the cleaning and nal collim ators, the beam s enter the decay volume housed in a 114 m long cylindrical vacuum tank with a diameter of 1.92 m for the rst 65 m, and 2.4 m for the rest. Both beams follow the same path in the decay volume: their axes coincide to 1 mm, while their lateral sizes are about 1 cm. W ith 10^{11} protons per burst incident on the target, the positive (negative) beam ux at the entrance of the decay volume is 3:8 10^{7} (2:5 10^{7}) particles per pulse (primarily

charged pions), of which 5:7% (4.9%) are K⁺ (K). The K⁺=K ux ratio is about 1.8 and stable to within 1%; no correlations were observed between its variation in time and time-dependent ine ciencies of the setup. The fraction of beam kaons decaying in the decay volume at nom inalm on entum is 22%.

1.2 Main detectors

The decay volume is followed by a magnetic spectrom eter [21] used to reconstruct tracks of charged particles. The spectrom eter is housed in a tank led with helium at nearly atm ospheric pressure, separated from the vacuum tank by a thin $(0:31\% X_0)$ K evlar com – posite window. A thin-walled alum inium beam pipe of 16 cm outer diameter traversing the centre of the spectrom eter and all the following detectors allows the undecayed beam particles and the muon halo from decays of beam pions to continue their path in vacuum. The spectrom eter consists of four identical drift cham bers (DCH): DCH1, DCH2 located upstream, and DCH3, DCH4 downstream of a dipole magnet. The magnet has a eld integral $B_v dz = 0.4$ Tm, providing a horizontal transverse m om entum kick $P_x = 120 \text{ M} \text{ eV} = c \text{ for charged particles}$. The DCHs have the shape of a regular octagon with transverse size of about 2.8 m and ducial area of about 4.5 m². Each chamber is com posed of eight planes of sense wires arranged in four pairs of staggered planes oriented horizontally, vertically, and along each of the two orthogonal 45 directions. The spatial resolution of each DCH is x = y = 90 m. The nom inal momentum resolution of the magnetic spectrom eter is p = p = (1.02)p)% (pexpressed in GeV/c). The mea-0:044 sured resolution on the reconstructed 3 invariant m ass varied during the data taking time in the range of (1:65 1:72) M eV /c in 2003 data, and (1:76) 1:82) M eV / \dot{c} in 2004, depending on DCH perform ance (generally, the chambers were operated at lower high voltage in 2004).

The magnetic spectrom eter is followed by a plastic scintillator hodoscope (HOD) used to produce fast trigger signals and to provide precise time measurements of charged particles. The HOD, with a transverse size of about 2.4 m, consists of a plane of vertical and a plane of horizontal strip-shaped counters, each plane comprising 64 counters arranged in four quadrants. Each quadrant is logically subdivided into 4 subquadrants (\segments") which take part in the trigger logic. Counter widths (lengths) vary from 6.5 cm (121 cm) for central counters to 9.9 cm (60 cm) for peripheral ones.

The HOD is followed by a liquid krypton electrom agnetic calorim eter (LK r) [22] used to detect electrons and photons. It is an almost hom ogeneous ionization chamber with an active volume of 7 m³ of liquid krypton, segmented transversally into 13248 projective cells, 2 2 cm² each, by a system of Cu Be ribbon electrodes, and with no longitudinal segmentation. The calorim eter is $27X_0$ deep and has an energy resolution (E)=E = 0.032 = E = 0.0042 (E is expressed in GeV). The spatial resolution for a single electrom agnetic shower is x = y = 0.42 = E = 0.06 cm for the transverse coordinates x and y.

The LKr is followed by a hadronic calorim eter (HAC) and a muon detector (MUV), both not used in the present analyses. A detailed description of the components of the NA 48 detector can be found elsewhere [23].

1.3 Trigger logic

The event rate of 500 kH z is dom inated by K ! and K ! 0 decays, which are of limited physics interest as such within the NA 48/2 program m e. A two-level trigger system is used to select the K ! 3 decay m odes for readout, reducing the event rate to 10 kH z.

At the rst level (L1), the K ! ⁺ decays are triggered by requiring coincidences of hits in the two HOD planes in at least two of the 16 segments (the L1C condition). The K ! ^{0 0} decays are triggered by requiring a coincidence of the two HOD planes in at least one segment, and the presence of at least two distinguishable clusters of energy deposition in the LKr (the L1N condition). In some periods of data taking the L1N condition also used as input the total LKr energy deposition (see Section 4.4). The L1C signal is produced by the HOD logic, while the L1N signal consists of HOD and LKr components. These two components require separate analyses in order to study possible biases to the asymmetry measurement.

The second level trigger (L2) is based on a real time system computing coordinates of DCH hits using DCH drift times, and a farm of asynchronous m icroprocessors performing a fast reconstruction of tracks and running a decision-taking algorithm .

The L2 algorithm selecting the K ! ⁰ ⁰ events (L2N) examines the events passing the L1N condition, and requires the existence of a reconstructed track which, assumed to be a pion, has an energy E < 230 M eV in the rest frame of a K having a momentum of 60 G eV/c directed along the z axis. This condition suppresses the K !

⁰ decays (which have E = 248 MeV), while keeping the K ! ⁰ decays (for which E ranges between 140 M eV and 193 M eV).

The L2 algorithm selecting the K ! ⁺ events (L2C) examines the events passing the L1C condition, and requires at least two tracks to originate in the decay volum e with the reconstructed distance of closest approach below 5 cm. L1C triggers not satisfying this condition are exam ined further and accepted if the L2N condition is satis ed.

NA 48/2 collected data during two runs in 2003 and 2004, with 50 days of e cient data taking in each run. About 18 1° triggers, and 200 TB of data were recorded in total.

2 The m ethod of the slope di erence m easurem ent

2.1 Data taking strategy

Charge symmetrization of the experimental conditions is to a large extent achieved by using simultaneous superimposed K⁺ and K beam swith similar momentum spectra. However, the presence of magnetic elds in both the beam line (achromats, focusing quadrupoles, etc.) and the magnetic spectrometer, combined with some asymmetries in detector performance, introduces residual charge asymmetries. In order to equalize the local elds on the acceptance, the polarities of all the magnets in the beam transport system were reversed during the data taking on an approximately weekly basis (corresponding to the periodicity of SPS technical stops), while the polarity of the spectrometer magnet was alternated on a more frequent basis (approximately once per day in 2003 and once every 3 hours in 2004).

Data collected over a period which has all four possible setup con gurations (i.e. com binations of beam line and spectrom eterm agnet polarities), spanning about two weeks of e cient data taking, represent a \supersam ple" and is treated as an independent and self-consistent set of data for the asym m etry m easurem ent.

For the K ! + analysis, nine supersam ples num bered 0 to 8 were collected in two years of data taking (supersam ples 0{3 in 2003 and supersam ples 4{8 in 2004). For the K ! $^{0 \ 0}$ analysis, a fraction of the data sam ple was rejected due to poor trigger perform ance, and another fraction of data was merged into a larger supersam ple to im prove the balance of magnet polarities, which resulted in seven supersam ples num bered I to V II (supersam ples I{III in 2003 and supersam ples IV {V II in 2004).

2.2 Fitting procedure

The u-projection of the Dalitz plot is su cient to extract the inform ation about g at the desired level of precision. The m easurem ent m ethod is based on com paring the reconstructed u-spectra of K⁺ and K decays (denoted as N⁺ (u) and N (u), respectively). In the fram ework of the param eterization (1), the ratio R (u) = N⁺ (u)=N (u) is in good approximation proportional to

the contribution of the kv^2 term integrated over v being negligible. The slope di erence g can be extracted from a t to R (u) involving the measured slope parameters g and h [7, 24], and A_g can be evaluated as in Eq. (3).

The param eters describing the D alitz plot distribution explicitly appear in the thing function. This generates a certain dependence of the results on the assumed shape of the event density, which in our case is Eq. (1). These e ects will be discussed later.

2.3 Cancellation of system atic e ects

It should be noted that any instrum ental e ect can induce a fake slope di erence only if it is: (1) charge asymmetric and (2) correlated with u.

For a given decay mode, each supersample contains four sets of simultaneously collected K⁺ ! 3 and K ! 3 samples corresponding to the four di erent setup congurations (eight data samples in total). To measure the charge asymmetry, exploiting the cancellations of system atic biases emerging due to polarity reversals, the following \quadruple ratio" $R_4(u)$ is evaluated. It involves the eight corresponding u spectra, and is formed by the product of four $R(u) = N^+(u)=N^-(u)$ ratios with opposite kaon sign and a deliberately chosen setup con guration in numerator and denominator:

Here the indices U/D denote beam line polarities corresponding to K⁺ passing along the upper/lower path in the achrom ats of the beam line, while the indices S/J denote spectrom eter m agnet polarities (opposite for K⁺ and K⁻) corresponding to the \even" (i.e. the two identical) pions from a K⁻ decay being delected to negative/positive x (i.e. towards the Saleve/Jura mountains). For example, R_{US} (u) is the ratio of the u

distribution for K⁺ transported along the upper path in the beam line achrom ats and collected with a certain polarity of the spectrom eterm agnetic eld, to the distribution for K transported along the lower path and collected with the opposite analyzing m agnet polarity. A t of the quadruple ratio (5) with a function of the form

results in the determ ination of two parameters: the norm alization n and the dierence of slopes g. The norm alization is sensitive to the K $^+$ =K ux ratio, while g is not.

The rationale for choosing the four ratios R (u) appearing in (5) as the basic ones (which is not the only possibility) lies in the fact that they intrinsically cancel at rst order instrum entale ects linked to the imperfect left-right sym m etry of the apparatus. As will be seen below, time variation of the left-right asym m etry (which is primarily due to variations of spectrom eter m isalignment and beam geometry) is the largest instrum ental e ect, and has been the primary subject of the analysis.

The quadruple ratio technique logically completes the procedure of magnet polarity reversal, and allows a three-fold cancellation of system atic biases in the data, without the need to rely on an accurate simulation of the instrum ental asymmetries:

due to spectrom eter m agnet polarity reversal, local detector ine ciencies cancel between K⁺ and K samples with decay products reaching the same parts of the detector in each of the four ratios R (u) appearing in the quadruple ratio R_4 (u);

due to the sim ultaneous beam s, global tim e-variable biases cancel between K^{t} and K sam ples recorded at the sam e tim e in the product of R_{s} (u) and R_{J} (u) ratios;

due to beam line polarity reversal, local beam line biases, resulting in slight di erences in beam pro les and momentum spectra, largely cancel between the $R_{\rm U}$ (u) and $R_{\rm D}$ (u) ratios.

The method is independent of the K $^+$ =K ux ratio and the relative sizes of the sam ples collected with di erent setup con gurations. However, the statistical precision is limited mainly by the smallest of the sam ples involved, therefore the balance of sam ple sizes was controlled during the data taking. The result remains sensitive only to time variations of asymmetries in the experimental conditions which have a characteristic time smaller than the corresponding eld alternation period.

2.4 Control quantities

In order to demonstrate that the level of cancellation of the system atic uncertainties achieved using the quadruple ratio technique is su cient, the quantities cancelling in (5) have to be measured. For this purpose, slopes of two other control quadruple ratios built out of the eight u spectra are evaluated. These control ratios can be written as the products of the four ratios of the u spectra for same sign kaons recorded with di erent setup con gurations. As a result, any physical asymmetry cancels in these ratios, while the setup asymmetries do not. The fake slope di erence g_{SJ} introduced by global time-dependent detector variations does not cancel in a ratio with opposite spectrom eter polarities and identical beam line polarities in numerator and denom inator, or equivalently, in the adopted notation

Similarly, the fake slope di erence g_{UD} introduced by the di erences of the two beam paths does not cancel in a ratio with opposite beam line polarities and identical spectrom eter polarities, namely:

It should be noted that time stability of the beam line conditions is much better than the (itself sm all) di erence between the upper and lower beam paths.

The intrinsic left-right asymmetry of the experimental apparatus which, as already mentioned, cancels in each of the basic ratios appearing in (5), can not be directly measured by the above two control ratios (although it is accessible within an analysis based in diment choice of the basic ratios). These asymmetric elects, being the largest of the residual elects and the central subject of investigation, have been taken into account with dedicated methods (see Sections 3.2, 3.4).

Any possible system atic bias remaining in (5) is of a higher order e ect than g_{SJ} and g_{UD} . Thus, a measurement of fake slope di erences compatible with zero, within their statistical uncertainties, validates the measurement method.

2.5 A veraging over the independent data sets

As described in Section 2.1, the data sample is divided into several independent selfcontained supersamples. Two methods of averaging the independent results over the supersamples were considered:

averaging the measured quadruple ratios \mathfrak{Z}) independently for each u bin, and then thing the resulting grand quadruple ratio with the function (6);

independent thing of the quadruple ratios in every supersample, and then averaging the results on g.

The rst method allows the results to be presented in a compact form, i.e. in terms of a single spectrum for each of the two decay modes. On the other hand, the second method allows a cross-check concerning several aspects of the analysis, in particular the time stability of the results.

As will be demonstrated below, the two methods lead to similar results due to the good balance of statistics which was maintained between the supersamples.

2.6 M onte Carlo sim ulation

Due to the m ethod described above, no M onte Carlo (M C) corrections to the acceptance are required. N evertheless, a detailed G EANT-based [25] M C simulation was developed as a tool for the studies of possible system atic e ects; this includes full detector geom etry and m aterial description, stray m agnetic elds simulation, local D C H ine ciencies, D C H

m isalignment, and the beam lines simulation (which allows for a reproduction of kaon momentum spectra and beam proles). Moreover, time variations of the above e ects during the running period were simulated.

A large-scale MC production was carried out for both K ! 3 decay modes, providing samples of sizes comparable to those of the data. Namely, 10^{0} events were generated for each decay mode with the correct balance for each beam and detector conguration closely matching that of the data.

3 Slope di erence in K ! 3 decay

3.1 Event reconstruction and selection

Reconstruction of K ! 3 events is based on the magnetic spectrom eter inform ation. Tracks are reconstructed from hits in DCHs using the measured magnetic eld map rescaled to the recorded value of the electric current in the spectrom eter analyzing magnet. System atic uncertainties arising from this procedure due to spectrom eter m isalignment and imperfect knowledge of magnetic elds are discussed in Sections 3.2 and 3.3, respectively.

Three-track vertices, com patible with the K ! 3 decay, are reconstructed using the K alm an lter algorithm [26] by extrapolation of track segments from the upstream part of the spectrom eter into the decay volume, taking into account multiple scattering in the K evlar window and helium volume, and the stray magnetic eld in the decay volume due to the Earth's eld and parasitic magnetization of the vacuum tank.

The stray eld is non-uniform, and has a typical magnitude of 0.5 G (com parable to the Earth eld); the eld map was measured in the entire vacuum tank before the 2003 run. Its e ect is to induce a transverse deviation of about 1 mm and an angular deviation of about 10⁵ rad to a 20 G eV/c charged particle traversing longitudinally the whole decay volume. A coounting for the stray eld in the vertex reconstructed 3 invariant m ass with respect to the azim uthal orientation of the odd pion by m ore than an order of m agnitude, to a level below 0.05 M eV/c². The event kinem atics is calculated using the reconstructed track m om enta and directions as extrapolated to the decay vertex.

Several stages of compaction and ltering of the data were applied, reducing the data volum e from 200 TB to 1:23 TB, while reducing the number of events in the sam ple from 18 10° to 4:87 10° . The applied ltering algorithm includes rejection of low quality data and also soft kinem atic constraints: the main requirement is the presence of at least 3 reconstructed tracks in the event, which rejects about 55% of the recorded triggers.

The principal selection criteria applied to the reconstructed variables are listed below. Note that corrections to track momenta for spectrom eterm is alignment and magnetic eld, discussed in the following Sections 3.2 and 3.3, are applied before the kinematics of the event is reconstructed and the selection is made.

Total charge of the three pion candidates: Q = 1.

Total transverse m om entum with respect to the z axis: P < 0.3 GeV/c, consistent with the angular spread of the beam s and spectrom eter resolution.

Longitudinal vertex position Z_{tx} is within the decay volum e: $Z_{vtx} > Z_{fc}$, where Z_{fc} is the longitudinal coordinate of the nalcollim ator of the beam line. This condition is in posed since the stray magnetic elds upstream of the nalcollim ator have not been measured, and therefore appropriate corrections can not be made. An upper cut on Z_{vtx} is not in posed, as the geometric acceptance diminishes to zero towards the spectrom eter by itself due to the presence of the beam pipe.

Transverse decay vertex position within the beam spot: its distance from the z axis R $_{\rm vtx}$ < 3 cm .

Consistent track tim ing from DCHs: $jt = t_{avg} j < 10$ ns for each track i = 1;2;3, where $t_{avg} = (t_1 + t_2 + t_3)=3$, which leads to a reasonably low event pile-up probability.

Reconstructed kaon m om entum is required to be consistent with the beam m om entum spectrum : 54 G eV = $c < p_K j < 66$ G eV = c.

Reconstructed 3 invariant mass: $M_{\rm K}$ M_K j< 9 M eV/ c^2 , where M_K is the PDG charged kaon mass [7].

The distribution of the 3 invariant m ass (before the cut on that quantity) and its comparison to M C are presented in Fig. 2. The non-G aussian tails of the m ass distribution are mainly due to ! decay in ight (the spectrom eter reconstructing the resulting m uon)², which is charge-symmetric. The tails are well understood in terms of M C simulation, and are considered as part of the signal. A decit of M C events observed in the low m ass region does not in uence the analysis, since it is mostly outside the signal region; moreover the analysis does not rely on the M C for acceptance computation. D ue to the absence of background and the presence of a non-G aussian contribution of pion decay the selection condition for M ₃ corresponds to ve times the resolution.

This principal stage of selection leaves a sample of $3.82 \quad 10^{\circ}$ K $! \quad 3$ events which is practically background free, as K $! \quad 3$ is the dom inant decay mode of the charged kaon with more than one charged particle in the nalstate. The fact that backgrounds due to other decays of beam kaons and pions are negligible was con med by a MC simulation.

3.2 Correction for spectrom eter m isalignm ent

The transverse positions of DCH s and individual wires were measured and realigned at the level of reconstruction software every 2{4 weeks of data taking using data collected during special alignment runs in which muon tracks were recorded with no magnetic eld in the spectrometer. This allows an alignment precision of 30 m to be reached. Spectrometer m isalignment itself can not bias the asymmetry measurement. However, time variations of DCH alignment on a short time scale potentially can, since an uncorrected shift of a DCH along the x axis leads to charge-antisymmetric mismeasurement of the momenta.

An unambiguous measure³ of the residual transverse horizontal misalignment is the dierence between the average reconstructed 3 invariant masses corresponding to decays of K⁺ and K , denoted as \overline{M} . The following sensitivities were determined from the

data: a shift of the DCH4 along the x axis by 1 m with respect to its nom inal position induces a measured mass difference of $M = 1.4 \text{ keV}/\text{c}^2$; a difference of 1 m between the DCH4 x-positions between the data sets taken with opposite spectrom eter polarities induces a fake slope difference of $(g^c) = 0.03 \quad 10^4$. Sensitivities to shifts of the other DCHs are similar.

M onitoring of M revealed signi cant transverse movem ents of the DCH s between the individual alignment runs, at a rate of typically below 5 m/day and never exceeding 20 m/day⁴, which introduces spurious slope dierences of the order of a few units of 10⁵. Introduction of time-dependent corrections to the measured momenta based on the observed M reduces these fake slope dierences by more than an order of magnitude to a negligible level of $(g^c) < 0.1 = 10^4$.

3.3 E ects due to spectrom eter m agnetic eld

The measurement of pion momenta is based on the knowledge of the magnetic eld in the spectrometer magnet. The variation of the current in the magnet biases the overall momentum scale of the spectrometer. This variation can be directly measured with a relative precision of 5 10^4 ; smaller variations are continuously monitored with a precision of 10^5 using the deviation of the reconstructed charge-averaged kaon mass from the nominal PDG value [7]. A time-dependent correction can be introduced by scaling the reconstructed track momenta symmetrically for positive and negative tracks. However, the momentum scale e ects are a priori highly charge-symmetric by design, due to the simultaneous K⁺ and K beams (this was also explicitly veri ed by com paring the

results obtained with and without the correction). Therefore no correction was applied for spectrom eter current.

On the contrary, the elects caused by a non-uniform perm anent (not inverting with the spectrom eter magnetic eld polarity) component of the magnetic eld in the region of the spectrom eter magnetic eld polarity) component of the magnetic eld in the region of the spectrom eter magnet are potentially charge asymmetric. They were studied by articially introducing the corresponding distortions to measured track momenta depending on the coordinates of impact points in the magnetic plane, consistent with the measurement precision of the magnetic eld map and the expected size of the permanent eld (1G). The resulting variation of the result of $(g^c) = 0.3$ 10^4 was considered as a residual system atic uncertainty due to this elect.

Remarkably, a statistically signi cant g^{c} measured with the events from the side bands of 3 mass distribution (i.e. outside the signal region) can be achieved by introducing certain realistic con gurations of a non-uniform permanent magnetic eld in the region of the spectrom eter magnet.

3.4 Correction for instability of beam geometry

The geometric acceptance for the K ! ⁺ decays is mainly determined by the vacuum beam pipe traversing the centres of the DCHs, and the material in the central region of each DCH where certain groups of DCH wires term inate⁵. Moreover, the beam optics can only control the average transverse beam positions to $1 \text{ mm} \cdot \text{T}$ in evariations of the transverse beam positions within the mentioned precision generate a sizable charge-asymmetric bias to the acceptance inducing instrum ental slope asymmetries of the order of a few units of 10⁴. It would require a stability of the transverse beam positions to the level of 100 m in order to reduce the bias to a negligible level. How ever it is possible to determine the average K⁺ and K beam positions as functions of time to this order of precision and apply charge symmetric cuts, as explained below.

Inner DCH geometrical acceptance cuts which fully contain the beam pipe and the surrounding DCH regions are applied to the positions of pion impact points $\mathbb{R}^{1,4}_{-i}$ in the planes of DCH1 and DCH4 relative to the average beam intercepts in the DCH planes. These vary slightly with time and dier for K⁺ and K⁻.

The transverse coordinates of a beam kaon $\mathbb{R}_0^{1,2}$ in the planes of DCH1 and DCH2 for each event are reconstructed as the momentum -weighted averages of the coordinates $\mathbb{R}_1^{1,2}$ of the three reconstructed pions: $\mathbb{R}_0^{1,2} = \Pr_{i=1}^{P_3} (\mathbb{R}_i^{1,2} \mathcal{P}_i) = \Pr_{i=1}^{P_3} \mathcal{P}_i j$, where $\mathcal{P}_i j$ is reconstructed momentum of a pion. Transverse coordinates of a beam kaon in the plane of DCH4 \mathbb{R}_0^4 corresponding to absence of the bending by the analyzing magnet are computed by linear extrapolation using \mathbb{R}_0^1 and \mathbb{R}_0^2 .

The average beam positions in the planes of DCH1 and DCH4 $h \mathcal{R}_0^{1,4}$ i are computed on the basis of the distributions of \mathcal{R}_0^1 and \mathcal{R}_0^4 for the selected event sample. A bias introduced to $h \mathcal{R}_0^{1,4}$ i by the fact that $\mathcal{R}_i^{1,2}$ j and \mathcal{P}_i j are them selves a ected by the acceptance is negligible. A database of the average beam positions $h \mathcal{R}_0^{1,4}$ i depending on kaon sign, time (excursions of 1 mm), kaon momentum (excursions of 1 mm in the horizontal plane,

1 cm in the vertical plane), and time within SPS spill (excursions of 1 mm) was created.

⁵Due to a relatively small Q -value of the K ! 3 decay, Q = 75:0 M eV, the outer edges of the DCHs do not bias the acceptance.

The conditions $\mathfrak{R}_{i}^{1,4} = \mathfrak{R}_{0}^{1,4}$ ij> 11:5 cm, i = 1;2;3, are applied to symmetrize the beam geometry e ects. These cuts cost 12% of the statistics, leading to a sample of 3:36 10[°] events. The minimum distance of 11.5 cm is chosen to ensure that the region of the beam pipe and the adjacent central insensitive areas of the DCHs are securely excluded by the cut.

The residual system atic e ects arise from the stray magnetic eld in the decay volume, which de ects $\mathbb{R}_{1}^{1,4}$ with respect to $\mathbb{R}_{0}^{1,4}$ i in a charge-antisymmetric way. Corrections for the stray eld to the measured $\mathbb{R}_{0}^{1,4}$ were performed. However, the precision of these corrections is limited by the precision of magnetic eld measurement, which leads to a residual systematic uncertainty of $(g^c) = 0.2 \quad 10^4$.

3.5 Correction for trigger ine ciency

Only charge-asymmetric trigger ine ciencies correlated with u can possibly bias them easurement. Ine ciencies of the individual trigger components were directly measured as functions of u using control data samples from prescaled low bias triggers collected along with the main ones. This allowed for an accounting for time variations of the e ciencies, and for a propagation of the statistical errors of the measured ine ciencies into the nal result.

The trigger logic is described in Section 1.3. The control trigger condition for the L1 e ciency m easurem ent requires at least one coincidence of hits in the two planes of the HOD. The control triggers for the L2 e ciency m easurem ent are L1 triggers recorded regardless of the L2 response. The statistics of each of the two control sam ples is roughly 1% of the main sam ple⁶.

The L1 trigger condition requires the coincidence of hits in two of the 16 non-overlapping HOD segments. This condition is bose as there are three charged particles in a fully reconstructed event, and the resulting ine ciency is low. It was measured to be 0.9 10⁻³ and found to be stable in time. Due to a few short-term malfunctions of a HOD channel, several subsamples of the data sample are a ected by higher ine ciency (up to 7 10⁻³), the source of the ine ciency being localized in space. This kind of ine ciency was reduced (and symmetrized) in the selected data sample by applying appropriate geometric cuts to the pion in pact points on the hodoscope surface for the relevant supersamples. This procedure led to the loss of 7.1% of the statistics, reducing the nal sample to 3:11 10[°] events. Due to good time stability of the L1 ine ciency, no bias from the L1 trigger is assumed. An overall uncertainty of the L1 bias was conservatively estimated to $(\alpha^2) = 0.3 - 10^4$ limited by the statistics of the constructed to the loss of loss of the loss of loss of

 $(g^{c}) = 0:3$ 10^{4} , limited by the statistics of the control sample.

Two components of the L2 trigger ine ciency were idential ed: one due to trigger timing m isalignment, and the other due to local DCH ine ciency (so called \geometrical"). The part related to timing m isalignment has a size of 0.2%, and a priori does not a ect the result, being uncorrelated to the kinematic variables. Its charge symmetry was checked with a detailed MC simulation of pile-up elects, and a study of the dependence of the result on the number of allowed accidental tracks. On the contrary, the geometrical part is correlated to event kinematics, and varies in time due to variations of the local DCH ine ciencies. These ine ciencies a ect the trigger more than the oline reconstruction

due to lower redundancy and worse online resolutions. For this reason the measured u spectra are corrected for this part of the ine ciency. The size of the ine ciency for the selected sam ple was measured to be close to 0.6 10^3 , but some periods are a ected by higher ine ciency of up to 1.5% (its sources not being localized in space in a sim ple way). The correction to the whole statistics amounts to $(g^c) = (0.1 \ 0.3) \ 10^4$, where the error is statistical owing to the limited size of the control sam ple.

The above procedure leads to over-estimation of the systematic uncertainties related to trigger ine ciencies, since the correlations of trigger ine ciencies in bins of u (in other words, sm oothness of variation of trigger e ciency over u) are not taken into account.

3.6 Fits to g^c and cross checks

The reconstructed Dalitz plot distribution of the events passing the selection and the corrections described in the previous Sections (corresponding to a fraction of the sam ple) is presented in Fig. 3a. Its projection to the u axis is presented in Fig. $3b^7$.

The quadruple ratios of the u spectra (5) were computed, and g^c was measured by the two methods described in Section 2.5 by tting with the function (6). The values of slope parameters $g^c = 0.21134$, lf = 0.01848 recently measured by NA 48/2 [24] using 55% of the 2003 data sample, and consistent with the world averages, were used. The uncertainties on the values of the above slope parameters lead to negligible elects on the result.

The grand quadruple ratio obtained by averaging quadruple ratios over supersam ples in each bin of u (corrected for L2 trigger e ciency) is tabulated in Table 1, and presented

along with the result of the corresponding tin Fig. 4.

The results of the independent ts for each supersample, including the numbers of events selected, the \raw " values of g ° obtained without applying the trigger corrections, and the nalvalues of g ° with the L2 trigger corrections applied are presented in Table 2. The independent results obtained for the nine supersamples are shown in Fig. 5(a): the individual measurements of g ° are statistically compatible with a 2 =ndf = 9:7=8.

The m easured control quantities g_{SJ}^{c} and g_{UD}^{c} , which are the slopes of the control ratios (7) and (8), for the nine supersam ples are presented in Fig. 5(b) and 5(c), respectively (data points are overlayed with MC ones). The sizes of these slopes induced by residual time-variable imperfections of the apparatus which cancel in the result (5) are of the same order of m agnitude as the statistical errors (10⁴), indicating that second order e ects which could induce non-zero values for them are negligible. M oreover, the comparison with MC simulations shows that the sizes of the apparatus asymmetries are well understood in terms of local ine ciencies and variations of beam optics.

3.7 Residual system atic e ects

insensitive to the largest di erences between $\,^+p$ and $\,p$ cross sections occurring at p $\,1$ G eV/c. The integral charge-asymmetric elects were found to be of the order of 10 4 , however their u-dependence was found to be negligible, inducing a bias of only the order of g $\,10^{6}$.

The e ects due to the di erence of K $^+$ and K $\,$ production spectra by the primary protons [28]do not cancel in the quadruple ratio. The di erence between the K $^+$ and K spectra was quanti ed by m easuring the slope of the quadruple ratio of the reconstructed K $^+$ and K $\,$ m om entum spectra. The slope of the K $^+$ /K $\,$ spectra ratio f (p) norm alized by f (60 G eV) = 1 was determ ined to be df (p)=dp = 0.6\% = (G eV /c). This induces charge asym m etry of geom etrical acceptance leading to a fake slope di erence of (g c) = 0.3 10 3 , as estim ated by a M C simulation. This value was conservatively taken as the corresponding system atic uncertainty.

Taking into account that the composition of the beam s is not charge symmetric (in particular, the K ⁺ and K uxes di er), event distortions caused by pile-up with the products of another kaon decay or a beam halo particle traversing the sensitive region of the spectrom eter is a potential source of system atic bias. To study the pile-up e ects an accidental activity generator was introduced into the MC. This generator was tuned using the measured composition of beam and halo uxes, and a production of 10° correlated pairs of an original kaon decay event and a piled-up event was carried out. No charge-asymmetric e ects were observed in the reconstructed u distributions nor in the L2 trigger ine ciencies down to a level of (g $^{\circ}$) = 0:2 10^{4} , limited by MC statistics.

Biases due to resolution e ects were studied by using various m ethods of expressing the u variable in terms of directly m easured quantities (using only the invariant m ass of the pair of even pions in the laboratory frame; using the energy of the odd pion in the kaon rest frame; using a 3C kinematic t constraining kaon m ass and direction) di ering in resolution as a function of u. Stability of the result with respect to variation of bin size in u has been studied as well. An estimate for the systematic uncertainty due to resolution e ects of $(g^{\circ}) = 0.2$ 10^4 has been obtained.

3.8 The resulting A_{a}^{c}

A sum mary of the system atic uncertainties, including a correction for L2 trigger inefciency, is presented in Table 3. The di erence in the linear slope parameter of the Dalitz plot of the K ! $^+$ decays, measured with the full NA 48/2 data sam ple of 3:11 10° events, is found to be

Here the individual system atic errors are added in quadrature, and the errors due to trigger ine ciencies are of statistical nature. Converted to the direct CP violating charge asym m etry (3) using the value of the D alitz plot slope $g^c = 0.21134 = 0.00017$ recently m easured by the NA 48/2 [24],

4 Slope di erence in K ! ^{0 0} decay

4.1 Event reconstruction and selection

The K ! ⁰ ⁰ decays are reconstructed considering ⁰ ! decays of each of the ⁰s and hence the reconstruction of the four photons is required. The principal selection criteria are described below.

An energy deposition cluster in the LK r is considered to correspond to a photon candidate if the following conditions are fulled: 1) it has an energy E > 3 GeV, which m inimizes e ects of nonlinearity of the LK r response (typically 2% at 3 GeV and becoming negligible above 10 GeV); 2) it is situated at distances larger than 10 cm from other clusters, and at distances larger than 15 cm from in pact points of the reconstructed charged particles, which m inimizes e ects of energy sharing between the reconstructed clusters due to overlap; 3) it satis es requirements on distances from the outer LK r edges and the beam pipe, which ensures full lateral containment of the electrom agnetic showers.

The event is required to have at least one reconstructed track of a charged particle, and at least four photon candidates.

To suppress the charge asymmetric DCH acceptance bias induced by the time instability of beam geometry, cuts are applied to distances between the track in pact points in DCH1 and DCH4 planes $\mathbb{R}^{1,4}$ and the average reconstructed beam positions $h \mathbb{R}_0^{1,4}$ i. These cuts are similar to those applied in the K ! + analysis; the rationale and a description are contained in Section 3.4.

For each selected event, a K ! 0 ⁰ decay is reconstructed as follows. A ssum ing that a pair of photon candidates i; j (i; j = 1,2,3,4) originates from a 0 ! decay occurring at a distance D_{ij} from the LKr front face, then D_{ij} is calculated to very good approximation as D_{ij} = R_{ij} $E_{i}E_{j}$ =m \circ , where E_{i} and E_{j} are the energies of the i-th and j-th photon candidates, R_{ij} is the distance between their in pact points at the LKr front plane, and m \circ is the PDG 0 m ass [7].

To search for two ⁰! decays occurring at the same point of the decay volume, am ong all the combinations of non-overlapping photon candidate pairs (i; j) and (k; l) the one with the sm allest value of D_{ij} $D_{k1}j$ is selected. Moreover, the sm allest of D_{ij} $D_{k1}j$ is required to be less than 500 cm, while the resolution on the di erence D_{ij} D_{k1} for photon pairs originating from the same point of space is 100 cm. For the best selected (if any) combination (i; j) and (k; l), the value of $(D_{ij} + D_{k1})=2$ is used to de ne the longitudinal position of a K decay vertex Z_{vtx} .

No geom etrical information about the track is used for vertex reconstruction in order to avoid the related charge asymmetric biases induced by beam geometry variation and stray magnetic elds.

The following selection criteria are applied to the reconstructed event kinematics.

The longitudinal vertex position required to be within the decay volum e: $Z_{tx} > Z_{fc}$, where Z_{fc} is the longitudinal coordinate of the nalcollim ator.

Consistent photon and track timing: t_{yg} $t_{j} < 5$, t_{avg} $t_{j} < 20$ ns, where t_i are times of the four selected LK r clusters, t is the time of the selected track, and $t_{avg} = t_i^P = 4$.

Reconstructed kaon m om entum is required to be consistent with the beam m om entum spectrum : 54 G eV = $c < p_K j < 66$ G eV = c.

Reconstructed 3 invariant mass: $M_{\rm K}$ M_K j < 6 M eV / c^2 . This cut is narrow er than in the K ! 3 case due to a better mass resolution.

The above requirements lead to the nal sample of 9:13 10^7 events. Fig. 6 shows the 0 0 invariant m ass distribution (before a cut on this quantity). The resolution on the invariant m ass is $0.9 \text{ M} \text{ eV}/c^2$. The tails of the m ass distribution originate from w rong photon pairing (the fraction of these events estimated by a MC simulation is 0.2%) and ! decays. The background is negligible for the applied m ass cut.

It can be seen from (2) that the kinem atic variable u can be computed using only the 0 invariant m ass. Thus a measurement of u uses the information from the LKr only, not involving the DCH data. This provides a certain charge symmetry of the procedure,

as the LK r is a \charge blind" subdetector, except for e ects of sm all di erences between ⁺ and interaction characteristics.

The reconstructed D alitz plot distribution of the selected events is shown in Fig. 7(a), and its projection on the u axis is presented in Fig. 7(b).

4.2 Fits to gⁿ and cross checks

Q uadruple ratios of the u spectra (5) were computed, and g^n was measured by the two methods described in Section 2.5 involving thing with the function (6). The nom inalvalues of slope parameters $g^n = 0.626$, $h^n = 0.052$ [7] were used. Unlike the K ! + case, no trigger corrections to the u spectra are required, as discussed in Section 4.4.

A grand quadruple ratio obtained by averaging quadruple ratios over supersam ples in every bin of u is tabulated in Table 4, and presented along with the result of the corresponding t in Fig. 8.

Numbers of selected events and the results of the ts in every supersample are presented in Table 5. The independent results obtained in the seven supersamples are shown in Fig.9(a): the individual measurements are compatible with a 2 =ndf = 1.5=6.

The m easured control quantities g_{SJ}^n and g_{UD}^n , which are the slopes of the control ratios (7) and (8), in the seven supersam ples are presented in Fig.9(b) and (c), respectively (data points are overlayed with M C ones). These instrum ental asym m etries do not exceed the size of the statistical errors, and are well reproduced by the M C simulation.

4.3 System atic e ects due to calorim eter perform ance

A s discussed above, the LK r calorim eter is the prim ary detector for K ! ⁰ ⁰ decay reconstruction, and the only detector used for m easurem ent of the variable u. The only charge-asym m etric e ect in LK r perform ance is related to the di erence between ⁺ and

interaction cross sections. Variation of the cut on the minimum allowed distance between the photon candidate clusters and the impact point of the charged track on LK r front face led to a conservative estimation of the corresponding systematic uncertainty:

 $(g^n) = 0.5$ 10^4 . Introduction of a shower energy sharing correction leads to a consistent estimate.

O there ects related to the LK r reconstruction are not expected to induce fake charge asymmetries. However the following stability checks were performed.

Stability with respect to variation of the resolution on the reconstructed u variable for K $^+$ and K $\,$ decays was studied with a large sample of events simulated by M C . The result was found to be stable within 0:1 $\,10^4$.

The result is stable to 0:1 10° with respect to introducing various ways of correcting the measured photon energies to account for nonlinearity of the LK r response at low energy.

The e ect of wrong photon pairing in the reconstruction of the 0 pair was studied by a large sample of simulated events. The result was found stable to better than $0.1 \quad 10^4$.

The result was found to have negligible sensitivy to variation of the cluster radial distance cut value around the beam pipe.

4.4 Uncertainties due to trigger ine ciency

The trigger logic is described in Section 1.3. Charge sym metry of every trigger component was studied either by direct measurement using samples recorded with low bias control triggers, or by simulation, as discussed below.

The ine ciency of the HOD component of the L1N trigger, which is due to ine ciency of the HOD counters, was measured using a control sam ple of all events with exactly one reconstructed track, triggered by conditions requiring activity in the LKr. The integral ine ciency for the selected K ! 0 0 sam ple was measured to be about 0.25%. It increased up to 2.0% during short periods due to malfunctioning of a few HOD counters; this e ect was reduced and symmetrized, as described in Section 3.5. The measured map of ine ciency measured as a function of the (x, y) coordinates at the HOD plane allowed

a precise estimation of trigger ineciency elect to be made. It was found to be consistent with no spurious asymmetry at the level of $(g^n) = 0:1$ 10^4 .

The ine ciency of the LK r component of the L1N trigger was measured with a sample of minimum bias triggers. It amounted to 0.7% in supersamples I and II, and 3% in supersamples III and IV. For supersamples V, VI and VII the L1N condition was relaxed to compensate for the above degradation by adding in OR " a condition requiring the total LK r energy deposition to exceed 15 G eV to the initial condition based on the presence of at least two clusters, which resulted in a stable ine ciency of 0.03%. The degradation of the trigger perform ance at the beginning of supersample III was later identied to be due to a small time m isalignment between parts of the hardware trigger logic.

The ine ciency of the LK r component of L1N is a priori charge symmetric, since it is based on LK renergy deposit conditions. To conm this, the ine ciency has been studied using a MC simulation, with an LK r m ap of local trigger ine ciency (measured directly from the data) used as a reference. Several checks have been performed, in particular by articially increasing the measured ine ciency or by including totally ine cient regions. No systematic elects have been observed at a level of $(g^n) = 0:1$ 10^4 , which is considered a systematic uncertainty due to the LK r component of the L1 trigger.

The ine ciency of the L2N trigger was mostly due to local ine ciencies of the DCHs, and varied from 4% to 6%. The e ects due to such ine ciencies, being of geom etrical nature, have been simulated by a MC.No charge asymmetry was found; upper limits of system atic uncertainties from other (smaller) possible e ects, including those related to variations of timing o sets between subdetectors and data bu errover ow s, were estimated directly by variation of the selection conditions. The total system atic uncertainty induced by L2N ine ciency was estimated not to exceed $(g^n) = 0.3 \quad 10^4$.

4.5 Other system atic e ects

E ects related to the magnetic spectrom eter do not a ect the result signi cantly, since the charged track is only used for the identi cation of the kaon charge and in the mass

cut. In particular, system atic e ects due to spectrom eter m isalignm ent (see Section 3.2), m om entum scale (see Section 3.3), and geom etrical acceptance for the charged track (see Section 3.4), which are important issues for the analysis in the K ! 3 m ode, were found to be negligible for the K ! 0 analysis.

Uncertainties related to imperfect know ledge of the perm anent magnetic eld in the decay volume were found not to exceed $(g^n) = 0:1 \quad 10^4$ by articially varying the eld map in accordance with the precision of its measurement. Stability of the result with respect to variation of the selected 0 invariant mass interval was checked, and no systematic deviation was found.

System atic uncertainty due to the di erence of K⁺ and K production spectra was conservatively estimated in the same way as for the K ! + mode (described in Section 3.7), and found to be $(g^n) = 0.3 \quad 10^4$.

System atic uncertainties due to event pile-up were found not to exceed $(g^n) = 0.2 \quad 10^4$ by varying the selection conditions on the allowed extra activity in the detectors, and by checking the stability of the result with respect to the tim ing cuts.

Charge-asym metric materiale ects, which are negligible, were discussed in Section 3.7.

4.6 The resulting A_{a}^{n}

The system atic uncertainties are sum marized in Table 6. The dimension of the linear slope parameters of K⁺ and K decays into 0 was measured with the full NA 48/2 data sample of 9:13 10^{7} events to be

The uncertainties of the measured A_g^c and A_g^n are similar, despite a ratio of the sam ple sizes of N^c=Nⁿ = 34. The main reason for compensation of the difference in sam ple sizes is a small ratio of the linear slope parameters of the two decay modes: $jg^c=g^n j=0.34$.

5 Discussion of the results

The measurement of g di erences between the linear Dalitz plot slopes was chosen as a representative quantity of a possible direct CP violation e ect, and is the quantity on which most theoretical and experimental investigations are focused. In absence of a speci c model for physics beyond the SM it is not possible to state in general term s which di erence in K $^+$ and K decay distributions is expected to give the most signi cant CP violating e ect.

D iscussing the asymmetry of linear slopes, it should be remarked that the recent discovery by NA 48/2 [29] (and theoretical interpretation [8, 9, 10]) of the distortion of the

⁰ ⁰ D alitz plot distribution due to nal state interactions between pions indicated the need for alternative param eterizations. Rescattering terms can be conveniently accommodated into a param eterization based on a polynom ial expansion of the decay amplitude itself (rather than the event density) which, for the non-rescattering part, would be:

The relation between the slope parameters appearing in (1) and (13) is, at rst order, $g^0 = g$, $h^0 = h$ $g^2=4$, $k^0 = k$. M easurement of g^0 in the framework of the parameterization (13) involves thing of the quadruple ratio of measured u distributions (5) with a function

rather than (6).

The results of the m easurem ent of g in the fram ework of param eterizations (1) and (13) were compared. The result in the K ! 3 m ode is stable within 0:1 10^4 , and its error is insensitive to the param eterization. On the other hand, the result in the K ! 0 m ode obtained with (13) is

to be compared with (11). The signi cant variation of the central value and its error is mostly due to the relatively large values of the slope parameters g^n and h^n . Introduction of the additional rescattering term to the amplitude (13) does not considerably change the result with respect to (15).

The sensitivity discussed above is one of the reasons to publish the tabulated quadruple ratios along with the results of the ts.

Conclusions

NA 48/2 has measured the charge asymmetries of D alitz plot linear slopes in both threepion K decay modes to be

which is an improvement in accuracy over the previous measurements [7] by more than one order of magnitude. NA 48/2 precisions are limited mainly by the available statistics.

The measured asymmetries do not show evidences for large enhancements due to non-SM physics. They are consistent with the SM predictions, in particular with a full next-to-leading order ChPT calculation [12] predicting

Due to the high precision achieved, the results can be used to constrain extensions of the SM predicting enhancements of the CP violating elects.
