Exotic Non-relativistic String

We construct a classical non-relativistic string model in 3+1 dimensions. The model contains a spurion tensor eld that is responsible for the non-commutative structure of the model. Under double dimensional reduction the model reduces to the exotic non-relativistic particle in 2+1 dimensions.

I. INTRODUCTION

The free m assive non-relativistic particle in D dimensions has as a symmetry group, the G alileigroup, with a central extension associated to the mass of the particle. Instead, in 2+1 dimensions, there is a two-fold central extension [1,2,3], where the second central element is interpreted as a non-commutative parameter. These central extensions are related to a

nontrivial Eilenberg-Chevalley cohomology of degree two. In fact every closed invariant 2-form that locally is the dierential of a 1-form, which is not invariant, produces an extension of the algebra, see for example [4,5,6].

The exotic (2+1)D Galilei symmetry has appeared in the context of non-commutative geometry and condensed matter physics [7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17]. It is a symmetry of a free relativistic particle in a non-commutative plane in a special non-relativistic limit [9, 11, 12].

Instead, if one consider the non-relativistic lim it of a relativistic particle in the AdS in 2+1 dimensions, one nds a system with an exotic Newton-Hooke symmetry [18]. The system has three essentially dierent phases [19], depending on the values of the two central charges, which are present in the model. The subcritical and supercritical phases (describing 2D isotropic ordinary and exotic oscillators) are separated by the critical phase (one-mode oscillator).

Non-relativistic extended objects has been recently considered in the literature. In particular, non-relativistic string theory [20] (see also [21]) in at space is a consistent decoupled sector of the bosonic string theory, whose worldsheet, in the conformal eld theory description [20], possesses the appropriate Galilean symmetry. Non-relativistic string theory can be derived as a certain decoupling limit of the original relativistic theory, even though the theory can be written down without any reference to the original parent theory. The basic idea behind the decoupling limit is to take a particular non-relativistic limit, in such a way that only states satisfying a Galilean invariant dispersion relation have nite energy, while the rest of the states decouples.

The action of non-relativistic bosonic string theory, for a at D dimensional space-time, can be obtained with them ethod of non-linear realizations [22] as a Wess-Zum ino (WS) term of the appropriate (string) Galilean group [23, 24]. The extended algebra has non-central elements that transform non-trivially under the stability group.

Particle models can be obtained by a double-dimensional reduction of strings models. It is natural to ask if it is possible to construct an exotic non-relativistic string in 3+1 dimensions, with other additional extended charges, such that by reduction one could obtain the exotic particle models appeared in the literature [7, 8, 11, 12]. To this end we construct the classical action for exotic Galilean non-relativistic strings, using the method of non-linear realizations. We arst construct the exotic string Galilei algebra in 3+1 dimensions. This

algebra contains new extra extended generators. As we will see, the parameters associated to these new extensions are related to non-commutative parameters. The string action is constructed from a 2-form, which is the product of two invariant M aurer-Cartan (MC) 1form s of the exotic extended string G alilei algebra. The param eters of the string action are the tension and a tensor parameter (spurion), generalizing the magnetic eld in the case of a particle.

We perform a classical Hamiltonian analysis of the model. The hamiltonian turns out to be non-local in the original variables. If we introduce an appropriate change of variables, we can elim inate the non-locality, ending with a theory form ally equivalent to the ordinary non-relativistic one for particular boundary conditions. Therefore, in this last case, the sym m etry group of the model in the new variables is the non-exotic Galilei group.

The organization of the paper is as follows. In Section II we consider the extended exotic Galilei algebra. In Section III we introduce the string action and in Section IV we study the dynam ics in the static gauge, showing that there are second class constraints in the model, then we proceed to evaluate the D irac brackets. This analysis shows that the D irac brackets of the position variables are not zero, giving rise to a non-commutative theory. In Section V we show that it is possible, through a change of variables, to make the model equivalent to the non relativistic string model, only for particular choices of the boundary conditions. We conclude with an outlook and a discussion in Section VI.

II. EXOTIC EXTENDED GALILEISTRING ALGEBRA

Let us consider a non-relativistic string in a D dimensional at space time.

We will denote by x^0 ; x^1 and x^2 ; x^2 the longitudinal (along the string) and transverse coordinates respectively. The symmetry algebra of this system is the extended Galilei algebra, G [23] [24], which is given by

Observe that the com m utator of M and M is zero. This is due to the fact that in 2 dim ensions (; = 0;1) there is only one generator of Lorentz transform ations, and no rotations.

The action of non-relativistic string can be obtained by the m ethod of non-linear realizations [23, 24, 25]. Let us consider the coset G = H, w ith the stability group H generated by $(M \quad ; M_{ab})$.

Locally we param etrize a coset element as [28]

The (Goldstone) coordinates of the coset depend on the parameters $\,$; of the world-sheet, The MC 1-form is given by

In the case of a four dimensional space-time the extended Galilei algebra has a further extension. In fact, owing to the existence of the two dimensional Levi-Civita tensor, we can construct a non-trivial closed invariant 2-form $_2$, that transforms as a symmetric tensor of order two under the stability group

The 1-form ${}_{ab}v$ adv b is not invariant, therefore the Eilenberg-Chevalley cohomology of degree two is non trivial [4, 5, 6]. This implies the possibility of further extending the algebra. We denote the new generators of the algebra by $\mathcal{I}_{(-)}$, where (-) means symmetric with respect the interchange of and .

The new non vanishing commutation relations are

In the new extended algebra the M C 1-form has one m ore term , given by $\frac{1}{2}\Gamma_z$ $Z_{(-)}$, and the coset element is

where $\mathbf{c}^{(\)}$ are the group parameters associated to generators $\mathbf{Z}^{'}$. The new term in the MC 1-form is given by

III. EXOTIC STRING ACTION

The ordinary non-relativistic string action can be written as the pullback on the world-sheet with coordinates (;) of the invariant 2-form [4]

In four dimensions we can also consider a tensor valued 2-form [29]

which allows us to construct an action for an exotic string. If we elim in ate the closed 2-form dx dc and we add the antisymmetric part in ; , which is a closed form, we get

is a closed invariant 3-form. Since 2 is not an invariant 2-form of the unextended string Galileialgebra we conclude that the Eilenberg-Chevalley cohomology of degree three is not trivial.

The string action is obtained by taking a linear combination of the pullback of the previous 2-form s on the world sheet. T is the string tension and is a spurion tensor eld that generalizes the magnetic eld appearing in the case of a particle in a magnetic eld in 2+1 dimensions.

Here $\ell_i = (\ell_i = \ell_i)$. The metric tensor is as before $\ell_i = \ell_i$. The $\ell_i = \ell_i$ are the zweibein, ℓ_i are the inverse zweibein, and ℓ_i and ℓ_i is the corresponding determinant. Notice that ℓ_i and ℓ_i and ℓ_i and ℓ_i is a spurion tensor.

If we want to get by double dimensional reduction the action for the exotic particle [7, 8, 9, 10, 11, 12, 13, 14, 15, 16] we have to make a particular choice for the parameters. By performing the dimensional reduction of the exotic term in eq. (20) we not

Therefore the unique choice is to take

IV. DYNAM ICSOFTHE EXOTIC STRING

In this section we will study the dynamics of the exotic string that under dimensional reduction produces the exotic particle. We will use eq. (23) without the restriction on . In the static gauge, where we make the identication $(x^0; x^1) = (;)$, the complete string action becomes

The boundary conditions in general in ply

where L is the length of the string.

These conditions can be satis ed, for example, in the following ways

- 1. By choosing both x^a and v^a as periodic functions.
- 2. By choosing xa periodic and va with xed values at the boundaries.
- 3. By choosing periodic v a and x with xed values at the boundaries.
- 4. By choosing both x^a and v^a with xed values at the boundaries.
- 5. By choosing $v^a = 0$ at the boundaries.

Notice that the cases 1) and 5) correspond to a closed and an open string respectively (case = 0). Notice too that, for = 0, one can elim inate the variables v, which are essentially the derivative of the variable x.

In order to understand which are the physical degrees of freedom of the model and their dynamics we will now study the ham iltonian formalism.

Let us start by evaluating the canonical mom enta:

One nds the following primary constraints:

where $_a$ are the momenta conjugated to v_a and P_a the ones conjugated to x_a , where, for a generic eld , -= 0 =0t=0 0 x^0 , with x^0 = t.

The canonical Hamiltonian density turns out to be:

where a prime denotes derivative with respect to $(or x_1)$.

It is easily veri ed that the following combinations of primary constraints

are rst class. By taking the independent combinations

one sees that the primary constraints separate as the rst class, K_a , and the second class ones ($_a$; S_a).

The matrix of the Poisson brackets among the second class constraints, ($_a$; S_a), is given by:

The determ inant of the ; 0 independent part of this matrix turns out to be proportional to z^4 . We can now evaluate the D irac brackets with respect to these constraints. Remember that the general form for the D irac brackets, given a set () of constraints, with a Poisson bracket matrix given by C ; , is

By requiring the stability of the primary constraints, that is by requiring that the Poisson brackets of the primary constraints with the hamiltonian be zero, one nds the following secondary constraints:

W ith these two constraints the primary rst-class constraints (K $_a$; $_a$) become second-class. In fact, the D irac matrix of the constrains

has a determ inant proportional to $T^4 \in O$. We now iterate the procedure to evaluate the nal D irac brackets, including the new set of second class constraints. The nal result is (we write only the non vanishing D irac brackets)

with the brackets evaluated as in (34), using the inverse of the matrix (37). At this point we can use the full set of constraints and the nalphase space can be taken as $(x_a; p_a)$.

Notice that using the constraints a we can form the combination

we see that the last three terms of the previous identity coincide with the last three terms in H_c , except for a sign and a total derivative in , containing only the v^a variables. This total derivative is zero for periodic boundary conditions and it is a constant for xed boundary conditions. Therefore, apart from this constant, we get

V. EQUIVALENCE WITH THE FREE NON-RELATIVISTIC STRING

In order to express the ham iltonian in terms of the independent variables x^a and p_a one has to solve the constraints $_a$ and $_a$. Since these constraints in general depend on v_{1a}^0 , the ham iltonian density that one gets is generally non-local. See appendix A for the expression in terms of x^a ; p_a . However, we can show that this non-locality can be eliminated by a convenient change of variables. Let us start considering the simpler case $_1=0$, where the constraints do not depend on v_{1a}^0 . By solving the constraints we get

the ham iltonian can be written as

Since the variables v_{1a} (and correspondingly y_a) have zero D irac brackets with them selves, the theory is equivalent to a non relativistic free string [27].

Com ing back to the action in eq. (24) for the general case $_1 \in 0$, if we integrate by parts the last term (neglecting again the total derivative for the reasons explained above) we get

By de ning now the new variables

we see that the model is equivalent to the free non relativistic string [23] also for $^1 \notin 0$, since the new action coincides with the rst term in eq. (20). Also in this case the Dirac brackets of the y_a^0 s vanish making the theory a commmutative one.

However we have to consider the boundary conditions discussed in Section IV.W hen x_a and y_a satisfy the same boundary conditions, as for instance in cases 1), 4) and 5), there is a complete equivalence of this exotic string with the ordinary one. In the cases 2) and 3) the y_a variables do not satisfy de nite boundary conditions and we loose the equivalence. Notice also that, when the equivalence is realized, the invariance group (in the y_a variables) is isomorphic to the extended Galilei group without the extended generator $\mathcal{I}_{(a)}$.

VI. DISCUSSION

In this paper we have constructed an exotic classical non-relativistic string in 3+1 dim ensions. The model contains, apart from the ordinary non-relativistic action, an extra term with a spurion eld that exists only in 3+1 dimensions. The existence of this extra term is associated to the existence of a new term in the extended Galilei algebra in 4 dimensions. In general the model is non-commutative in the sense that the Dirac bracket of the physical coordinates are not vanishing. It is possible to introduce a new set of coordinates in which the model becomes commutative if the boundary conditions of the old and the new coordinates coincide. We should point out that the transformation properties of the old and the new coordinates are different with respect to the Galilei transformations.

This exotic string by double dimensional reduction reproduces the exotic Galilei particle in 2+1 dimensions.

It should be noticed that the model considered in this paper could be obtained from an exotic relativistic model in 4 dimensions as non-relativistic limit.

We conclude by saying that it will be interesting to see if exists an exotic string theory for a non-at case, in such a way that under double dimensional reduction it could reproduce the exotic New ton-Hooke particle in 2+1 dimensions.

APPENDIX A: THE HAM ILTONIAN DENSITY IN THE REDUCED CANONICAL SPACE

From the constraints $_a$ and $_a$ the variables v_a can be obtained as a function of the canonical coordinates of the reduced space fx^a ; p_ag . To this end we must solve the following dierential system

The other variables v_{0a} are easily obtained from the constraints $_a$. In these equations we have put! = $T = {}^1$. Observe that! becomes in nite when 1 is zero. In this limit the system degenerates to an algebraic system, which was already discussed in Section V. The system (A1) can be easily integrated and the solution is

In these equations the complex constant of integration d is determined by the boundary conditions discussed in Section IV.W ith these expressions one can evaluate the canonical Hamiltonian H_c (see eq. (42)). The resulting hamiltonian is manifestly non-local in the variables ($x^a; p_a$).
