The NA60 experiment at the CERN SPS has studied low-mass dimuon production in 158 AG eV In-In collisions. An excess of pairs above the known meson decays has been reported before. We now present precision results on the associated transverse momentum spectra. The slope parameter T_e extracted from the spectra rises with dimuon mass up to the , followed by a sudden decline above. W hile the initial rise is consistent with the expectations for radial ow of a hadronic decay source, the decline signals a transition to an em ission source with much smaller ow. This may well represent the rst direct evidence for thermal radiation of partonic origin in nuclear collisions.

Am ong the observables used for the diagnostics of the hot and dense reball form ed in high-energy nuclear collisions, lepton pairs are particularly attractive. In contrast to hadrons, they directly probe the entire spacetime evolution of the reball and freely escape, undisturbed by nal-state interactions. In the invariant mass region 1 GeV, therm al dilepton production is largely m ediated by the broad vector m eson (770). Due to its strong coupling to the channel and its short lifetim e of only 1.3 fm /c, its in-medium properties like mass and width have long been considered as the prime signature for the restoration of chiral symmetry, associated with the QCD phase transition from hadronic to partonic matter [1, 2, 3]. In the mass region > 1 G eV, therm ald ileptonsm ay be produced in either the early partonic or the late hadronic phase of the reball, based here on hadronic processes other than annihilation.

In contrast to real photons, virtual photons decaying into lepton pairs can be characterized by two variables, mass M and transverse momentum p_T . Historically, the interest has largely focused on mass, including most recently the rst measurement of the space-time averaged

spectral function in nuclear collisions [4]. Transverse m om entum, on the other hand, contains not only contributions from the spectral function, but encodes the key properties of the expanding reball, tem perature and in particular transverse (radial) ow. In the description of hadron p_T spectra, the study of collective ow has con-

tributed decisively to the present understanding of the reball dynam ics in nuclear collisions [5, 6]. However, while hadrons always receive the full asymptotic ow reached at the moment of decoupling from the owing medium, lepton pairs are continuously emitted during the evolution, sensing small ow and high temperature at early times, and increasingly larger ow and smaller temperatures at later times. The resulting space-time folding over the temperature—ow history can be turned into a diagnostic tool: the measurement of p_T spectra of lepton pairs potentially o ers access to their emission region and may thereby di erentiate between a hadronic and a partonic nature of the emitting source [7].

Experim entally, dilepton p_T spectra associated with direct radiation in the mass region 1 GeV were previously only investigated by the CERES/NA45 experiment at the CERN SPS [8], but with low statistics. In this Letter, we present the rst precise data on such spectra, obtained by the NA60 experiment at the CERN SPS for 158 AG eV In-In collisions. Mass spectra in di erent p_T windows [9], uncorrected for acceptance, and preliminary results on acceptance-corrected p_T spectra were presented before [10, 11].

D etails of the NA 60 apparatus are contained in [12,13]. The di erent analysis steps follow the same sequence as described in our previous Letter [4], including the critical assessment of the combinatorial background from

and K decays by a mixed-event technique [14]. The

centrality-integrated net m ass spectrum of the naldata sam ple used here is shown in Fig. 1. It contains about 430 000 dim uons in the m ass range 1.4 G eV. The narrow vector m esons ! and are com pletely resolved; the m ass resolution at the ! is 20 M eV. Fig. 1 also contains the expected contributions from the electrom agnetic decays of neutral m esons, i.e. the 2-body decays of the ,! and resonances and the D alitz decays of the , ^o and !. The peripheral data can be described by the sum of these \cocktail" contributions plus the [4, 9]. This is not possible for the total data as plotted in Fig. 1, due to the existence of a strong excess of pairs. To isolate this excess with a priori unknown characteristics without any

ts, the cocktail of the decay sources is subtracted from the data using local criteria which are solely based on the measured mass distribution itself. The is not subtracted. The procedure is illustrated in Fig. 1. Each centrality window is treated separately. The space of p_T is subdivided in the range 0 p_T 2 G eV into 10 bins of equalwidth, and each bin is also treated separately. The yields of the narrow vector mesons ! and are xed so as to get, after subtraction, a sm ooth underlying continuum, leading to an accuracy of about 2% for the and 3-4% for the !; at very low p_T , even an error of 20% on the ! would still translate to an error of only 5% of the excess in the mass region 0.6 < M < 0.9 GeV. The yield of the relative to the ! and , relevant only for m asses

 $0.4~{\rm G\,eV}$, is xed from the data at $p_T>1.0~{\rm G\,eV}$, pro ting from the very high sensitivity of the spectral shape of the D alitz decay to any underlying adm ixture from other sources. The yield at lower p_T , subject to lower statistics due to acceptance, is determined using the NA60 hadron-decay generator G ENESIS [15] tuned to the cock-

taildata. The estim ated uncertainty on the subtraction is 3%, transform ing to a system atic error of 20% on the excess in the mass region 0.2 < M < 0.4 GeV. Having xed the three main sources, the two-body and ! Dalitz decays are then bound as well; the ratio $^{\prime}$ is assumed to be 0.12 [15]. Open charm, measured to be 0.30 0.06 of the total yield in the mass interval 1.2< M < 1.4 G eV by NA60 [16], is subtracted throughout (but not yet in Fig.1), with the spectral shape in M and p_T as described by Pythia [16]; the resulting uncertainty of the excess is 8% in this region and 1% everywhere else. A fter subtraction of the meson decays and charm, the remaining sam ple contains 150000 dim uons. The subtracted data them selves are subject to the same for the ,! and further steps as the excess data and are used later for com parison.

In the last step, the data are corrected for the acceptance of the NA60 apparatus and for the centralitydependent pair reconstruction e ciencies. The accep-

tance shows strong variations with mass and p_{T} [9, 10], but is understood on the level of < 10% , mainly based on a detailed study of the peripheral data for the particle ratios =! and =! [4, 9]. In principle, the acceptance correction requires a 3-dim ensional grid in M $-p_T$ -y space. To avoid large statistical errors in low -acceptance bins, the correction is performed in 2-dimensional M- p_T space (with 0.1 GeV bins in mass and 0.2 GeV bins in pr), using the measured rapidity distribution of the excess as an input [10]. The latter is determ ined with an acceptance correction in y found, in an iterative way, from MC simulations matched to the data in M $% p_{T}$. Separately for each centrality window, an overlay M C m ethod is used to include the elects of pair reconstruction elections. The resulting values vary from mostly 0.9 down to about 0.7 at low mass and low transverse momentum for the highest centrality window. All sources are simulated with a uniform distribution in cos cs, where cs is the polar angle of the muons in the Collins-Soper frame, consistent with (yet unpublished) NA 60 data for the !, the

and the excess.

R esults on acceptance-corrected p_T -spectra for the m ass window 0.6 M 0.9 G eV and the three upper centralities are shown in Fig. 2; equivalent data for other m ass windows are contained in [10]. System atic errors, not contained in Fig. 2, m ainly arise from the uncertainties of the combinatorial-background and fake-m atches subtraction and range from 10% to 30% for sem iperipheral up to central collisions at low p_T , decreasing rapidly to a level of only a few % at higher p_T . All other uncertainties are discussed below, in connection with Fig. 4. The data of the three centrality windows agree within their errors; this also holds for the other mass windows [10].

Fig. 3 (upper) displays the centrality-integrated data vs. transverse m ass m_T, where m_T = $(p_T^2 + M^2)^{1=2}$, for four m ass windows; the is included for com parison. The system atic errors due to the background subtraction are, at low m_T, 30%, 25%, 15% and 15% in the four windows, respectively, falling again rapidly to a level of a few % at high m_T; for the , they are smaller by a factor of 5. At very low m_T, a steepening is observed in all four m ass windows, rem iniscent of pion spectra and opposite to the expectation for radial ow at m asses above the pion m ass. This increased rise cannot be due to unsubtracted background which increases by a factor of 3 vs. centrality, while the data are independent of it (see

above). It cannot be due to ill-understood acceptance either, since the , placed just between the two upper m ass w indow s, does not show it. W hile some rise still persists in the peripheral bin, it nally disappears for very peripheral collisions with $4 < dN_{ch} = d < 10$ as show n in Fig. 3 (low er); the ! does not show it either. The lines in Fig. 3 are ts with the function $1/m_T dN = dm_T / exp(m_T = T_e)$, where the e ective tem perature parameter T_e characterizes the slope of the distributions. For the excess data in Fig. 3 (upper), the ts are restricted to the range $0.4 < p_T < 1.8 \text{ GeV}$ (roughly $0.1 < (m_T M) < 1.2 \text{ GeV}$), to exclude the increased rise at low m_T ; for all other spectra, the ts start at zero.

The extracted values of T_e vs. pair mass are sum marized in Fig. 4 (open squares), supplemented by a set of further t values from narrow slices in M (closed triangles). Preliminary NA60 data from an independent analysis [16] of the intermediate mass region $(\M R")$ 1.16 < M < 2.56 GeV , corrected for the contribution from D rell-Y an pairs, are shown for comparison. Finally, the hadron data obtained as a by-product of the cocktail subtraction procedure are also included; the value for the has been obtained by tuning the GENESIS code [15] to the Dalitz decay and then referring back to the required $T_{\rm e}~$ of the mother. The errors shown for the low-mass data (\LM R") are purely statistical. System atic errors only enter to the extent that the slopes of the p_T spectra are a ected, not their absolute level. The errors due to the background subtraction are about the same as the statistical errors of the ne-bin data (7 M eV). The errors associated with the subtraction of the decay sources, though signi cant for the yields (see above), lead to errors of only 1-4 M eV for Te (dependent on the source), due to both them ostly local nature of the subtraction and the closeness of T_e for dim uons and hadrons (see Fig. 4). All other error sources considered - relative acceptance, the sensitivity to the input y-distribution, cuts vs. no cuts in y (none are used), cuts vs. no cuts in $\cos c_s$ (none are used) - also lead to di erences considerably sm aller than the statistical errors. A correction for D rell-Yan, using an extrapolation down to M < 1 GeV [17], would system atically lower the values by 5-10 M eV , depending on mass.

The results displayed in Fig.4 can be sum marized and interpreted as follows. The slope parameter $T_{\rm e}$ rises nearly linearly with mass up to about 270 MeV at the pole position of the , followed by a sudden decline to values of 190-200 MeV for masses > 1 GeV. The excess yield in the mass region $0.2 < M < 0.9 \ GeV$ has generally been attributed to thermal radiation from the reball, dom inated by pion annihilation $^+$!! $^+$, and the NA60 data, before acceptance correction, have directly been interpreted as the space-time averaged inmedium spectral function of the [4]. Following earlier work [3], they are now nearly quantitatively described by the new est theoretical developments [17, 18, 19]. The

linear rise of $\mathrm{T}_{\mathrm{e}}~$ with M ~ over the whole region up to the

peak is rem iniscent of radial ow of a hadronic source. W hile the hadron data show a sim ilar linear rise, their absolute values are surprisingly close to the excess values, contrary to the expectation for the tem perature- ow folding expressed in the introduction. The seem ing contradiction can be resolved by com paring the (free) itself rather than the other hadrons with the in-medium em ission. This is accessible as the peak on the broad continuum (Fig. 1), generally interpreted as the freeze-out without in-medium e ects [17, 18, 19]. By disentangling the peak from the continuum as done before [9, 10], we nd $T_e = 300$ 17 MeV for the peak and 231 7 for the underlying continuum in the window 0.6 < M < 0.9 M eV. The high value of the peak, added as a further hadron point into Fig. 4, should then be interpreted as characteristic for the true freeze-out param eters of the reball, in plying the ,! and to freeze out earlier, due to their smaller coupling to the pions. By modeling a with this tem perature, its contribution can be subtracted from the total for each of the ner binned data points in Fig. 4, low ering T_e by 4 20 M eV depending on the closeness to the pole, and shifting the maximum of the resulting \inmedium "values up to the mass bin just below 1 G eV . In any case, the large gap in $T_{\rm e}$ between the vacuum and the excess points (corrected or not for the subtraction) restores the expected di erence between a freely em itted hadron and its in-medium decay part, making the observed linear rise of Te with M now consistent with the expectations for radial ow of a hadronic source (here

!) decaying into lepton pairs. Theoretical modeling of our results is underway [17, 18, 19], but does not yet describe the data in a satisfactory way.

It is interesting to note that the large gap of > 50

M eV in $T_{\rm e}$ between the vacuum and the ! (same m ass) decreases towards the peripheral window, but only closes for the lowest peripheral \pp-like" selection $4 < dN_{\rm ch} = d < 10$ shown in Fig.3 (lower), with $T_{\rm e}$ = 198 6 M eV for the and 201 4 M eV for the !. This in plies that both the \hot " and the low-m $_{\rm T}$ rise discussed before are intim ately connected to pions, disappearing together as the contribution to production vanishes (with only the cocktail left).

The sudden decline of T_e at masses > 1 GeV is the other m ost remarkable feature of the present data. Extrapolating the lower-mass trend to beyond 1 GeV, a jump by about 50 MeV down to a low - ow situation is extremely hard to reconcile with emission sources which continue to be of dominantly hadronic origin in this region. If the rise is due to ow, the sudden loss of ow is most naturally explained as a transition to a qualitatively di erent source, im plying dominantly early, i.e. partonic processes like qq ! ⁺ for which ow has not yet built up [18]. While still controversial [17], this may well represent the rst direct evidence for thermal radiation of partonic origin, breaking parton-hadron duality for the yield description in the mass domain.

In conclusion, we have found strong evidence for radial ow in the region of therm ald ilepton emission which has previously been associated with the spectral function. The transition to a low - ow region above may signal a transition from a hadronic to a partonic source.
