K ac{M oody Spectrum of (H alf{)M axim al Supergravities

A bstract: We establish the correspondence between, on one side, the possible gaugings and m assive deform ations of half (m axim al supergravity coupled to vector multiplets and, on the other side, certain generators of the associated very extended K ac{M oody algebras. The difference between generators associated to gaugings and to m assive deform ations is pointed out. Furtherm ore, we argue that another set of generators are related to the so-called quadratic constraints of the embedding tensor. Special emphasis is placed on a truncation of the K ac (M oody algebra that is related to the bosonic gauge transform ations of supergravity. We give a separate discussion of this truncation when non-zero deform ations are present. The new insights are also illustrated in the context of m axim al supergravity.

1. Introduction

In describing the eld theoretic representation of a supersymm etry algebra, one usually species those elds that represent physical states only. It is known that other elds can be added to the supermultiplet that do not describe physical states but on w hich nevertheless the full supersym m etry algebra can be realized (for an early discussion of such potentials, see [1]). In this paper we will focus on the following two classes of such elds.

The rst class consists of $(D \t 1)$ {form potentials in D dim ensions, which we will call \deform ation potentials" for the follow ing reason. The equations of m otion of these deform ation potentials can be solved in term s of integration constants that describe deform ations of the supersym m etric theory. The forem ost exam ple of a deform ation potential is the nine{form potential of type IIA string theory that couples to the D 8{brane $[2{4}]$. The integration constant corresponding to this nine{form potential is the m asslike param eter m of m assive IIA supergravity [5]. T he relation between the two is given by

The second class of elds that do not describe physical states consists of D {form potentials in D dim ensions, which we will call \top top {form s potentials", or top-form s for short. The prime exam ple of a top{form is the R am ond {R am ond ten{form that couples to the D 9{brane of type IIB string theory [2]. It turns out that this ten{form is part of a quadruplet of ten-form s transform ing according to the 4 representation of the $SL(2;R)$ duality group, while also a doublet 2 of ten-form s can be added in IIB supergravity [6].

It has been known for a num ber of years that one can reproduce the physical degrees of freedom ofm axim alsupergravity from the very extended K ac{M oody algebra E_{11} [7{9]. Furtherm ore, this K ac{M oody algebra contains generators corresponding to the deform ation potential of IIA $[9,10]$ and the top{form potentials of IIB $[9,11,12]$. Recently, the representations under the duality group of the deform ation and top {form potentials of all m axim alsupergravities have been calculated [13,14]. R em arkably, the E_{11} results on deform ation potentials are in agreem ent w ith those of [15{24] w here m axim algauged supergravities are classi ed w ithin a supergravity approach¹. In particular, this agreem ent show s that the components of the embedding tensor $[15, 16, 18]$ can be identi ed w ith the m asslike deform ation param eters of the supergravity theory. Therefore, the eld strength $F_{(D)}$ of the deform ation potential A_(D 1) is proportional to the embedding tensor :

This relation can be viewed as a duality relation, like the ones between potentials and dual potentials.

It is natural to extend the analysis of $[13,14]$ to other cases. In this paper we will do this for the class of half {m axim al supergravity theories. The K ac{M oody analysis for this case show sa num ber of new features. First of all, one can add m atter vector multiplets and consider m atter{coupled supergravity $[9,27]$. Our results on the deform ation and top{form potentials w ill depend on the num ber of vector multiplets. A nother new feature is that one encounters duality groups that are not m axim al non-com pact. Only a lim ited num ber of vector multiplets lead to a m axim al non $\{\text{com }$ pact duality group. Finally, the duality groups are not necessarily sim ply laced, and hence we w ill have to address the issue of non-sym m etric C artan m atrices and roots of dierent lengths. For m ore details on the latter, see appendix C .

 1^1 A n exception to this correspondence are the gauging of the 'trom bone' or scale sym m etry of the eld equations and B ianchi identities [25], as discussed in e.g. [23,24,26], for which no corresponding deform ation potentials have been identied in E_{11} .

An additionalm otivation to study the case of half{m axim alsupergravities is that for D < 10, e.g. $D = 4$ or $D = 6$, the corresponding m atter-coupled supergravities are related to com pacti cations of string theory and M -theory w ith background uxes. The nonzero uxes lead to the additionalm ass param eters. Especially the $D = 6$ case is interesting due to the existence of a chiral and a non-chiral theory. These two theories are related via S- and Tdualities between Type I string theory on T 4 and Type II string theory on K 3. The m ass param eters of these theories have been investigated [28,29] and the m assive dualities between them have been studied [30,31].

In this paper we w ill pay particular attention to the bosonic algebra that the dierent $p\{$ form K ac $(M \text{ body generators} w$ ith $p > 0$ satisfy am ongst each other. We will call this algebra the \p{form algebra". This algebra, w ithout the deform ation and top-form generators, also occurs in $[32,33]$ as the bosonic gauge algebra of supergravity. The p{form potentials corresponding to these generators, together w ith gravity and the scalar elds, constitute the part of the very extended K ac{M oody spectrum that does not require the introduction of the dualgraviton. W e w ill show how the possible deform ation and top{form potentials, w ith w hich the p{form algebra can be extended, follow from the K ac{M oody algebra. In particular, we will show that for the case of half ${m \text{ ax in all supergravity}}$ the deform ation potentials of the p ${f \text{ form } }$ algebra, and hence also the em bedding tensor in generic dim ensions, can be w ritten in term s of the fundam ental and three-form representation of the duality group.

O ne encounters the follow ing subtlety in establishing the connection between the $p\$ form algebra and supergravity: w hereas for each physicalstate the K ac{M oody algebra gives rise to both the potential and the dual potential this is not the case for the deform ation potentials. The K ac{M oody algebra does give rise to the deform ation potentials but not to the dualem bedding tensor. Indeed the duality relation [\(1.2\)](#page-2-0) does not follow from the K ac{M oody approach. We know from supergravity that the inclusion of a m ass param eter or an em bedding tensor leads to deform ations of the transform ation rules. We will show that in speci c cases these deform ations cannot be captured by the p{form algebra alone but that, instead, one is forced to introduce further m ixed symm etry generators whose interpretation has yet to be clari ed .

T his paper is organized as follow s. In section [2](#page-4-0) we brie
y sum m arize the K ac{M oody approach to supergravity. In section [3](#page-6-0) we introduce the p {form algebra and uncover interesting properties of the deform ation and top{form potentials in the context of this algebra. We will use the case of m axim al supergravity to elucidate a few of these general properties. In the next section we apply the K ac{M oody approach to the case of half{m axim al supergravity. In section [5](#page-19-0) we will show that the addition of the em bedding tensor leads to the introduction of additional sym m etry generators to obtain closure. Finally, in the conclusions we com m ent on our results. W e have included four appendices. [A](#page-26-0) ppendix A shortly sum m arizes the term inology we introduce in this paper. A ppendix [B](#page-26-0) contains a brief summ ary of the physical degrees of freedom and duality groups of m atter-coupled half{m axim al supergravity. A ppendix [C](#page-28-0) covers som e group{theoretical details concerning the K ac{M oody algebras that are non{sim ply laced. Finally, appendix [D](#page-30-0) contains lists of tables w ith the relevant low level results of the spectrum of the relevant K ac{M oody algebra.

2. T he K ac{M oody approach to supergravity

T he spectrum of physical states of the dierentm axim alsupergravity theories can be obtained from the very extended K ac-M oody algebra E_{11} [7{9]. This has been extended to the set of all possible deform ation and top{form potentials in $[13,14]$. A sim ilar analysis could be done for E₁₀ [34{36]except for the top{form potentials. In addition, non{m axim alsupergravity and the associated very extended K ac ${M}$ oody algebras have been discussed in $[9,27,37]$. In the present paper we will apply the \K ac{M oody approach" to extract the deform ation and top{ form potentials of half(m axim al supergravity. In general this approach breaks down into four steps:

- 1. R educe to $D = 3$ over a torus and determ ine the G =K (G) scalar coset sigm a m odel.
- 2. Take the very extension $G^{+++} = K (G^{+++})$.
- 3. O xidize back to 3 D D_{max} .
- 4. Read o the spectrum by means of a level decomposition.

A s steps 2 , 3 , and 4 can be autom atically carried out on the com puter [38], this approach is very sim ple to carry out in practice. We will now take a close look at each of these steps.

The rst step is to determ ine the G =K (G) scalar coset sigm a m odel in three dim ensions for the toroidally reduced supergravity in question, w here K (G) is the m axim alcom pact subgroup of G. If there is no such a sigm a m odel, w hich often is the case for theories w ith less than 16 supercharges, the K ac ${M}$ oody approach com es to a standstill. But when the coset does exist, as is the case form axim aland half(m axim alsupergravity, we can go on and take the very extension $G^{+++} = K(G^{+++})$. The rstextension corresponds to the (untwisted) ane version of G, which has been shown to be the symmetry group of various supergravities in $D = 2$ [39]. A lso the second (over) extension and the third (very) extension are conjectured to be sym m etry groups of m axim alsupergravity: the form er has been em ployed for a $D = 1$ coset $[34{36}]$ while the latter has been used for non-linear realisations of the higher-dim ensional theory $[7\{9]$.

O nce $G^{+++} = K(G^{+++})$ has been constructed, we are in the position to oxidize back to 3 D D_{max} dim ensions using group disintegrations. The valid disintegrations for G⁺⁺⁺ are always of the type G_D SL(D;R), w here G_D is the duality group in D dim ensions and SL(D;R) refers to the space-tim e symm etries. Extended D ynkin diagram s are a useful tool to visualize these group disintegrations: the disintegrations then correspond to 'disabling' certain nodes of the diagram in order to obtain two disjoint parts, of which one is the SL(D ;R) gravity line and the other is the G_D duality group. A s an exam ple we give the cases of m axim alsupergravity in D = $11;10$ in gure [1.](#page-5-0) Note that the duality group G $_{\text{D}}$ contains an extra R $^+$ factor whenever there is a second disabled node. This explains why the duality group of IIA supergravity is R⁺ and w hy those of IIB and $D = 11$ supergravity do not have such a factor.

Them axim um oxidization dim ension is determ ined by the largest SL(D $_{\text{max}}$;R) chain possible starting from the very extended node in the (extended) D ynkin diagram $\mathrm{of}\,\mathsf{G}^{\,++\,+}$ [40,41]. In our conventions these w ill always start at the right hand side of the extended D ynkin diagram.

Figure 1: The D ynkin diagram s of E₈ (a), the very extended E_{n}^{++} (b), and its decompositions corresponding to 11D (c), IIA (d) and IIB (e) supergravity. In these decompositions the black nodes are disabled, the white nodes correspond to the gravity line SL (D, R) and the gray node in the last diagram corresponds to the duality group A_1 .

The lower lim it on the oxidization dimension stems from the fact that below $D = 3$ the duality group G_D becomes in nite-dimensional, and there are currently no computer{based tools available to analyze these cases.

A fter the group disintegration has been xed, the generators of $G^{+++} = K(G^{+++})$ can be analyzed by means of a level decomposition [34,35]. A level decomposition comes down to a branching of G⁺⁺⁺ with respect to the G_D SL(D;R) disintegration. The disabled nodes then induce a grading on G^{++} which will be indicated by the so-called levels. W hen G^{++} is of real split form, i.e. m axim ally non-compact, m odding out by the subgroup K (G^{++}) in plies truncating all the negative levels in the representation and generically also modding out the scalars at level 0 by the compact part of the duality group G_D . For clarity we will restrict our discussion to the split form s, although with some slight modi cations everything also holds for the non-split cases, as follow s from [42]. Indeed, we have veri ed for various non-split cases that the computer calculations give rise to the general results discussed in this paper.

The spectrum is obtained by associating to each generator a supergravity eld in the same representation. This leads to the following elds at each level: At the low est levels the physical states of the supergravity we started out with appear together with their duals². The duality relations them selves are not reproduced by the level decomposition; in the absence of dynamics

these relations have to be im posed by hand (for a discussion of dynam ics in the context of E_{10} and E_{11} , see e.g. [11,34,36] and [7,8] respectively). At higher levels there are the socalled \dual" generators, w hich can be interpreted as in nitely m any exotic dual copies of the previously m entioned elds [37,43]. The rem aining \non-dual" generators do not correspond to any physical degrees of freedom. Am ongst these are the $(D \ 1)$ { and D {form potentials we are interested in.

In short, once the relevant $G = K$ (G) coset in three dim ensions is known, all we have to do is consider the dierent decom positions of its very extended D ynkin diagram . The deform ation and top{form potentials can then be read o from the spectrum the computer has calculated.

3. T he p{form algebra

In this section we will consider the bosonic algebra that the dierent p{form K ac{M oody generators w ith $p > 0$ satisfy am ongst each other. Subsequently it w ill be show n how the sam e algebra arises in supergravity. In the follow ing two subsections we w illdiscuss two classes of special generators. Frequently, we w ill clarify general features of the algebra by the exam ple of m axim alsupergravities. In the next section we w illdiscuss the case of m atter{coupled half{m axim al supergravities.

3.1 Truncation to p{form s

It is convenient to introduce a special algebra, which we call the π (form algebra". It can be obtained as a truncation from the very extended K ac{M oody algebra in a particular G_D SL(D ;R) decom position by deleting all generators except those at positive levels in a purely antisym m etric SL(D;R) tensor representation of rank³ 1 p D. Em bedded within the K ac{M oody algebra this is generically not a proper subalgebra (it is not closed), but on its own it nonetheless is a Lie algebra. W hat one ends up w ith after the truncation is an algebra of generators represented by com ponents of p {form sthat satisfy com m utation relations of the form

Suppressing the SL(D ; R) indices, we w ill w rite this m ore concisely as

H ere we have introduced the shorthand notation p, which w ill be used throughout this paper⁴. In the above com m utator the ranks of the p{form sadd up: $r = p + q$. In other words, the rank of the third form is equal to the sum of the ranks of the rst and second form s.

An im portant property of the p{form algebra is the existence of \fin dam ental" p-form s w hose m ultiple com m utators give rise to the w hole algebra by using the Jacobi identity. These

is a $(D \ 3;1)$ {form w ith m ixed symm etries and possibly $(D \ 2)$ {form generators, w hich are interpreted as the dual graviton and dual scalars, respectively.

 3 O ne could also include the p = 0 or scalar generators, which are the generators of the duality group G $_D$.

 $4N$ ote that p indicates the com ponents of p{form s and not p{form s them selves. In this way we avoid the anti{com m utators w hich are used in [33].

fundam entalp{form scorrespond to the positive simple roots of the disabled nodes in the K ac{ M oody algebra. From the decom posed D ynkin diagram one can thus deduce the num ber and type of these fundam entalp-form s: any disabled node connected to the nth node of the gravity line (counting from the very extended node) gives rise to a $(D \t n){f}$ form. Furtherm ore, if the disabled node in question is also connected to a node of the duality group the $(D \ n)$ form carries a non {trivial representation of the duality group.

In the sim plest case w hen there is only one disabled node, and thus only one fundam ental p{form ,we can schem atically w rite for each p{form

w here q is the rank of the fundam ental form and $p = 'q$. The num ber of tim es the com m utators are applied corresponds to the level ' at w hich the p-form occurs in the level decom position of the K ac{M oody algebra. By de nition the fundam ental generators occur at level one. This is the structure of e.g. 11D supergravity, which only has a fundam ental three{form 3 , see gure [1c](#page-5-0). In addition there is a six-form 6,w hich can be obtained from the 3 by the com m utation relation

A ccording to the de nition above the 6 {form generator occurs at level $\prime = 2$. Note that this p {form algebra is de ned in any dim ension D . It is only after we impose dynam ics, i.e. duality relations, that we should restrict to $D = 11$ in order to m ake contact with $D = 11$ supergravity.

A nother exam ple m ight further clarify the above. C onsider again the D ynkin diagram of E_{11} and the em bedding of an SL(10;R) gravity line that corresponds to IIB supergravity, see qure [1e.](#page-5-0) We now associate to each generator a supergravity eld. There are two nodes outside of the w hite gravity line. One is the grey node not connected to the gravity line. This node corresponds to the SL($2;R$) duality symmetry. The other is the black node attached to the gravity line at the 8th position counted from the right, and hence corresponds to a fundam ental two-form . Since this node is also connected to the internalsym m etry node the two-form is in a non {trivial representation of $SL(2;R)$: the IIB theory contains a doublet of N S-N S and R -R two-form s. We denote these two{form s by 2 . U sing the same notation for the higher-rank form swe have the follow ing p{form algebra

w here all SL(2;R) representations are symmetric and is the Levi-C ivita tensor. There are other non-zero com m utators but, due to the Jacobi identity, they follow from these basic ones involving the fundam ental 2 {form generators. The commutators (3.5) specify the level \prime at w hich each generator occurs. This level can be read o from these commutators by counting

the number of times the fundamental generators $2 \cdot \text{occur}$ in the multiple commutator that expresses the generator in term s of the fundam ental ones. In this way we obtain that the and 10 occur at level $' = 2,3,4,5$ and 5, respectively. qenerators $4;6;8;10$

The p{form algebra contains generators corresponding to the following IIB supergravity elds: a doublet of two {form s, a singlet four-form potential, the doublet of six-form potentials that are dual to the two-form s, a triplet of eight-form potentials that are dual to the scalars 5 [44] and, nally, a doublet and quadruplet of ten-form potentials [6].

It was shown in [45] that the algebra of bosonic gauge transform ations of IIB supergravity can be brought to precisely the form (3.5) . This was achieved after making a number of rede nitions of the elds and gauge parameters, as was also done in the \doubled" form alism of [32]. The correspondence goes as follows. The p{form gauge transform ations of IIB supergravity can be w ritten as [45]

Here we use the notation $_{(2n)}$ $\left(\begin{array}{cc} 0 & \text{if } \\ 0 & \text{if } \\ 0 & \text{if } \end{array} \right)$, following [32]. By dention each parameter is closed. In contrast to [45] we have rede ned the gauge param eter of the doublet ten {form potential such that the gauge transform ations of this potential precisely agree with the K ac{M oody algebra or its truncation to p {fom s. This can always be done for top{fom transfom ations. Note that the sam e structure also follows from a superspace calculation [46].

In order to compare with the p{form algebra we now truncate the bosonic gauge algebra to a nite{dimensional subalgebra as follows:

where it is understood that the spacetime coordinate x is contracted with the rst index of $_{(2n)}$. Note that this indeed is a consistent truncation due to the fact that the local gauge param eters $_{(2n 1)}$ = $_{(2n 1)}$ (x) always occurs in the transform ation rules (3.6) with a derivative acting on it. Furtherm ore, we could have included a constant part in $_{(2n\ 1)}$, but this drops out of the gauge transform ations for the sam e reason.

The commutator algebra corresponding to (3.6) , for constant, is now precisely of the form (3.5) provided we associate to each p{form in (3.5) the gauge transform ation, with parameter $_{(p)}$, of a p{form potential in (3.6). The p{form algebra arises as a Lie algebra truncation, de ned

by [\(3.7\)](#page-8-0), of the bosonic gauge algebra 6 , see qure 2. The p{form gauge eld transform ations [\(3.6\)](#page-8-0) can now be viewed as a nonlinear realisation of the p{form algebra [\(3.5\)](#page-7-0)⁷. Note that the p{form gauge elds not only transform under their ow n gauge transform ations but also under those of the other gauge eks . Consequently, the curvatures of these gauge eks will contain Chem-Sim onslike term s.

We would like to stress that the truncation of the bosonic gauge algebra to a p{form Lie algebra is only possible in a particular basis of the supergravity theory. In particular, the gauge transform ations need to be expressed only in term s of the gauge potentials and not their derivatives. It will not always be possible to bring the gauge transform ations of any supergravity theory to such a form .A n exam ple ofthisw illbediscussed in section [5](#page-19-0) in the contextofgauged and m assive supergravities.

The above reasoning can be applied to any very extended K ac ${M}$ oody algebra. It provides a usefultruncation to the part of the spectrum that contains all p-form potentials, including the deform ation and top-form potentials, which will be discussed next.

3.2 D eform ation potentials

W e now w ish to discuss some properties of the deform ation and top-form potentials in the light of the p{form algebra introduced above. We rst consider the deform ation potentials. It has been argued in, e.g., $[2,4,13,14]$ that deform ation potentials are in one-to-one correspondence w ith deform ations of the supergravity theory, such as gaugings or m assive deform ations. Indeed, the D {form curvatures of the $(D \ 1)$ {form potentials can be seen as the duals of the deform ation param eters: in the presence of a deform ation, one can only realize the supersymm etry algebra on a $(D \t 1)$ {form potential provided its eld strength is the H odge dual of the deform ation param eter. A s far as the deform ation param eters are concerned one can distinguish between gauged and m assive deform ations, as we will discuss below.

 6 T he relation between the bosonic gauge algebra and the p{form algebra, in the sense that the latter is a Lie algebra truncation of the form er, can also be introduced for dieom orphism s. R estricting the general coordinate transform ations to x ! x , where is a constant G L(D) m atrix, these span a Lie algebra.

 7 N ote that the gauge transform ations [\(3.6](#page-8-0)) contain no term s that are higher order in the potentials, as would occur in a generic non {linear representation. It turns out that all higher order term s (but not the 0^{th} order one) can be elim inated by m aking appropriate eld rede nitions.

The m ost fam iliar class of deform ed supergravities are the so-called \gauged" supergravities. They are special in the sense that the deform ations can be seen as the result of gauging a subgroup H of the duality group G. N ot all deform ed supergravities can be viewed as gauged supergravities. In the case of m axim al supergravity there is one exception: m assive IIA supergravity cannot be obtained by gauging the R $^+$ duality group [5]. The gauged supergravities can be seen as the rst in a series of \type p deform ations". There is a a sim ple criterion that de nes to w hich type of deform ation param eter each deform ation potential gives rise to. The central observation is that to each $(D \t 1)$ {form one can associate a unique com m utator

w here p corresponds to a fundam entalp-form and w here we have suppressed the representation of the duality group. The deform ation potential corresponding to such a deform ation generator gives rise to a type p deform ation param eter.

W e observe that each type p deform ation is characterized by the fact that a fundam ental p{form gauge eld becom es m assive. For $p = 1$ this leads to gauged supergravities, in which a vector can becom e m assive by absorbing a scalar degree of freedom 8 . N ote that other nonfundam ental gauge elds m ay become m assive as well. The case $p = 2$ entails a fundam ental two{form that becom esm assive by \eating" a vector. The prime exam ple of this is m assive IIA supergravity in ten dim ensions [5]. A nother exam ple is the non-chiral half (m axim alsupergravity in six dim ensions [47]. An example of a $p = 3$ deform ation is the half (m axim al supergravity theory of $[48]$ w here a fundam ental three-form potential acquires a topologicalm ass term . D ue to the restricted num ber of dim ensions it can be seen that there are no p 4 deform ations of supergravity theories.

Table 1: Fundam entalp{ form s for m axim al supergravity [7,8,13,14], w here we have suppressed the duality group indices and multiplicities.

It is interesting to apply these general observations to the case of m axim al supergravity. In that case all deform ations are gauge deform ations except m assive IIA supergravity. T his can be easily understood from the K ac ${M}$ oody approach. In D 9 all fundam entalp{form s are vectors (see table 1) and thus one can never realize the commutation relation (3.8) for $p \notin 1.0$ nly in D = 10 we have a fundam ental 2 {form m aking m assive supergravity possible. In $D = 10$ a deform ation potential is a 9{form and eq. (3.8) becom es $[7;2]=9$. Instead we have that $[8;1]$ vanishes. Note that IIA supergravity allow sa m assive deform ation butIIB supergravity does not. The reason for this, from the K ac $(M \text{ oody point of view})$, is that in w riting the commutator $[7;2]=9$ it is understood that there is either a fundam ental 7 {form, w hich is not the case, or this

representation can be w ritten as a m ultiple comm utator of fundam ental p {form s. The latter is only possible if there is at least one fundam ental p {form w ith an odd num ber of indices. This condition is only satis ed in the case of IIA supergravity.

N ote that in $D = 11$ we have a single fundam ental 3{form, but in $D = 11$ a deform ation potential is a 10{form w hich cannot be w ritten as a m ultiple com m utator of 3 {form s. T herefore, there is no m assive deform ation in $D = 11$.

 8 In the p = 0 case there is only a m assive vector w hen an isom etry of the scalar m anifold is being gauged.

3.3 Top{form potentials

Finally, we consider the top{form potentials and point out an intriguing relation w ith the deform ation potentials and param eters. G iven a supergravity theory w ith deform ation param eters in di erent representations of the duality group, it is not obvious that these deform ation param eters can be turned on all at the same time. In fact, in the case of gauged supergravities it is know n that the deform ation param eters satisfy certain quadratic constraints [16,18].

To illustrate the need for quadratic constraints on the deform ation param eters and observe the relation w ith the top{form potentials it is instructive to consider $D = 9$ m axim algauged supergravity with duality group R^+ SL(2;R) [23]. There is a triplet m of deform ations, corresponding to the gauging of a one-dim ensional subgroup of $SL(2;\mathbb{R})$, and a doublet m of deform ations, corresponding to an R $^+$ gauging:

A ll com ponents of the triplet and of the doublet can be obtained via generalized Scherk {Schwarz reductions of IIB and of m assless IIA supergravity, respectively. In addition, one com ponent of the triplet, corresponding to the R^+ 2 SL(2;R) gauging, can be obtained via a K aluza-K lein reduction of the m assive IIA theory. Note that it is impossible to perform a generalized Scherk {Schwarz reduction in the m assive case, since the m ass param eter breaks the relevant scale sym m etry.

D ue to the dierent origins of the triplet and the doublet it is im possible to obtain them sim ultaneously from ten dim ensions. However, one m ight wonder whether they can be turned on at the sam e tim e, independent of any higher-dim ensional origin. This question has been answered in the negative [23], w hich can be sum m arized by im posing the follow ing quadratic constraint:

T hese constraints occur in the 4 and 2 representation w hich are in one-to-one correspondence w ith two of the three representations of top{form s, as can be seen in $[13,14]$. So for each constraint there is a corresponding top{form potential.

A lso in lower dim ensions, both for m axim al supergravity in 3 D 7 [15,16,18] and half {m axim al supergravity in $D = 3,4,5$ [17,49], the quadratic constraints have been calculated w ith the em bedding tensor approach. In each case we observe that there is an exact one-toone correspondence between the quadratic constraints and the top{form potentials in term s of representations of the duality group.

In the em bedding tensor approach this correspondence can be explained as follow s. Starting w ith a gauged supergravity Lagrangian L_{square} one can always replace the constant em bedding

tensor by a scalar eld that is constant only on {shell due to the eld equation of a deform ation potentialA_(D 1), see also e.g.[4,33]. Furtherm ore, for each quadratic constraint one introduces a top{form Lagrange m ultiplier A $_{(D)}$ in the same representation to enforce the constraint 9 . The totalLagrangian thus becom es (suppressing duality group indices)

where is the embedding tensor. O ne might wonder how a gauge eld can act as a Lagrange m ultiplier. It turns out that the gauge transform ation of the top{form in (3.11) is cancelled by adding an extra term to the gauge transform ation of the deform ation potential in the follow ing way

The eld equation for the embedding tensor eld leads to a duality relation of the form (1.2) . This provides a concrete way of explaining why the deform ation potentials and the embedding tensor m ust be in the sam e representation of the duality group, and \sin ilarly for the top{form potentials and the quadratic constraints.

We conclude that one can divide the top{form potentials into two classes: the rst class consists of all top{form s that are Lagrange m ultipliers enforcing quadratic constraints on the deform ation param eters, w hile the second class contains all the other independent top{form s w hose role is unclear from the present point of view . Exam ples of supergravity theories with independent top{form potentials are the half{m axim al chiral supergravity theory in six dim ensions and IIB and $D = 9$ m axim alsupergravity. The rst theory does not contain deform ation potentialsand hence no quadratic constraints. T he sam e appliesto IIB w hich containsan independent quadruplet of potentials that is related to the D 9{brane and an independent doublet of top{form s that sofar has no brane interpretation. Finally, in $D = 9$ m axim al supergravity there is another top{form representation, in addition to (3.10) , that does not correspond to a quadratic constraint.

4. M atter coupled half{m axim al supergravity

We now proceed with the case of matter coupled half (maxim al supergravity. In subsection 4.1 we rst investigate the structure of the K ac-M oody and p{form algebras. In the next two subsections we discuss the deform ation and top {form potentials that are contained in it.

4.1 K ac{M oody and p{form algebras

H alf ${m \text{ ax in a}}$ l supergravities, coupled to $D = 10 + n$ vector m ultiplets, reduce to the scalar coset SO $(8,8+n)$ =SO (8) SO $(8+n)$ when reduced to three dim ensions. In other words, the relevant groups for supergravity theories w ith 16 supercharges are the B and D series in the above real

 $9W$ e thank H enning Sam tleben for pointing this out to us. See also the recent paper [50].

form . Of these, only three are of split real form, i.e. m axim ally non-compact, which are given by $n = 1;0;+1$. These correspond to the split form s of B₇, D₈ and B₈, respectively.

W e are interested in the decom position of the very extensions of these algebras w ith respect to the possible gravity lines. An exhaustive list of the possibilities for the algebras of real split form is given in table [2](#page-14-0). A s can be seen from this table, these correspond to the unique D dim ensional supergravity theory w ith 16 supercharges coupled to $m + n$ vector m ultiplets w ith $m = 10$ D. The corresponding duality groups G_D in D dim ensions are also given in table [2](#page-14-0). N ote that there is no second disabled node and therefore no R $^{\mathrm{+}}\,$ factor in the duality group for the 6b case and in $D = 3;4$.

In appendix [D](#page-30-0) the result of the decomposition of the D $_8^{++}$ + algebras with respect to the dierent SL(D ;R) subalgebras is given. In addition, the decom positions of the other two split form s B⁺⁺⁺ can be found on the website of SimpLie [38]. It can be seen that these decompositions give rise to exactly the physical degrees of freedom [9]. In addition there are the deform ation and top-form potentials in the K ac{M oody spectrum. In particular, table [3](#page-17-0) sum m arises our results for the deform ation and top{form potentials for half{m axim al supergravity in D dim ensions.

To discuss the p{form algebra it is easiest to start with 8 D 10 dim ensions where there is a uni ed result valid in any dim ension $D = 8;9;10$. We will refer to this as the \generic" situation. In lowerdim ensions this generic pattern rem ains but there are extra generators speci c for each dim ension $D < 8$, see table [3.](#page-17-0) We will not discuss all the details of the lower dim ensions but its should be clear that they follow the sam e pattern as the higher dim ensions except that the expressions involved are a bitm essier.

In 8 D 10 dim ensions the p{form algebra is given by the follow ing generators and com m utation relations. A s can be seen from table [2,](#page-14-0) except in a few special (lower{dim ensional) cases to be discussed below, in each dim ension the fundam ental p {form s of the algebra are a 1^M and a (D 4). The form er is in the fundam ental representation of the duality group G_D w hile the latter is a singlet. T he other generators follow from the follow ing basic com m utators describing the p{form algebra:

From these commutators we read o the levels $('_1; '_2)$ of the dierent generators. Here $'_1; '_2$ is the num ber of times the fundam ental (D 4);1^M generators occur in the m ultiple com m utators expressing the generator in term s

of the fundam ental ones. Suppressing the duality indices we obtain that the generators 2 , 1) and D occur at the levels $(0;2)$, $(1;1)$, $(1;2)$, $(1;3)$ and $(1;4)$, 2), $(D$ (D) $3)$, (D) respectively. These results are in agreem ent with the tables in appendix C 10 .

Wewillnow turn to the potentials associated to the di erent generators. We will rst discuss the potentials corresponding to the physical degrees of freedom of half(m axim al supergravity. A summ ary of these can be found in appendix B and in particular table 4. A fterwards we will discuss the non {propagating deform ation and top-form potentials.

The 2 corresponds to the two-form potential, which is indeed present in any half (m axim al supergravity. Note that the rst commutator in (4.1) tells us that the two-form potential transform s in a Chern-Sim ons way under the vector gauge transform ations:

Hence, the K ac{M oody approach autom atically leads to the C hem {Sim ons gauge transform ations that are crucial for anom aly cancellations in string theory [51]. The (D $3)^{M}$, (D 2) 2)^{MN} orrespond to the duals of the vectors, the dilaton and the scalar coset, respecand (D) $(2)^{\mathbb{M}|\mathbb{N}|}$ {fom s exceeds that of the scalars, since the latter tively. Note that the num ber of (D take values in the scalar coset $G = K$ and hence are modded out by the compact subgroup K of G. Therefore, we expect that there will be a num ber of linear relations between the eld strengths of the $(D \t2)$ (form s, similar to what has been found for the 8 (form s of IIB supergravity [44].

Extrem e cases occur when the symmetry group is compact, i.e. $m = 0$ or $m + n = 0$. These correspond to ten dim ensions or pure supergravity, without vector multiplets, respectively. These theories do not have any other scalars than the dilaton and hence one expects supersymm etry to require all of the eld strengths of the $(D \t 2)^{M N}$ ^l-form s to vanish. A lithough we are not aware of a discussion of this phenom enon in the context of half(m axim al supergravity, it has recently been encountered in pure $D = 5, N = 2$ supergravity [52].

We should also mention two exceptions that dier from the above pattern. The $D = 10$ theory w ithout vector multiplets and the $D = 6b$ theories do not contain any vectors. Rather, the simple roots correspond to a 2 and a 6 in the $D = 10$ case and to a 2^M in the $D = 6b$ case. These generate the follow ing gauge transform ations:

For instance, pure D = 10 half(m axim al supergravity has no 1 (form generators and the fundam ental generators are a 2 (form and a 6 (form . A nother exception is pure $D = 9$ half(m axim al supergravity which has an R⁺ SO (1;1) duality group. We now need three level num bers $\binom{r}{1}$; $\binom{r}{2}$; $\binom{r}{3}$ in order to distinguish between the dierent Poincare dualities under SO (1;1).

for the six{dim ensionalcase.

In yet lower dim ensions a sim ilar pattern occurs. The m ain dierence, however, is that for half{m axim al supergravity in $D = 5$ dim ensions, all fundam ental p{form s are vectors. This is in contrast to higher dim ensions where there are also fundam ental p {form s of higher rank. The explicit form ulae are a bitm essier in the lower dim ensions, as can also be seen from table 4 , and hence we w ill refrain from giving them . It should be stressed that they follow exactly the same pattern as above. The sam e applies to the deform ation and top-form potentials discussed in the next two subsections where there is a plethora of representations in the lower dim ensions, see table [3](#page-17-0).

This nishes the discussion of the physical degrees of freedom and their duals $[9,27]$. The generators corresponding to these potentials are already present in the ane K ac{M oody extension [41]. Potentials of yet higher rank do not correspond to propagating degrees of freedom and only occur in the over{ and very{extended K ac{M oody algebras. W e now discuss the deform ation and top{form potentials of half{m axim al supergravity.

4.2 D eform ation potentials

Turning rst to the $(D \t 1)$ -form s, it follow s from (4.1) that in generic dim ensions these occur in a fundam entaland an anti-sym m etric three-form representation. In dim ensions 8 D 10 this is the com plete story as well.

In lower dim ensions, however, there are m ore possibilities. For exam ple, in $D = 7$ one can generatean additionaldeform ation potential6 from a m ultiplecom m utatorofthedualtwo-form D 4, w hich is a 3 in this case. This corresponds to the singlet in table [3.](#page-17-0) In addition there is another top-form representation 7^M . The additional commutators are:

In fact, also the commutator $[1^M; 6]$ is non-vanishing and leads to a 7^M . However, this commutator is related to the one above by the Jacobi identity and hence $7^{\, \rm M}$ and $7^{\, \rm M}$ are linearly dependent.

In $D = 6$ one has $D = 4 = 2$, i.e. the dual of the two-form is itself again a two-form. To avoid confusion, we will denote the fundam ental 2{form by 2 and the one com ing from the com m utator of the vectors by 2⁰. In this theory there are again a num ber of extra com m utators that contribute to the deform ation and top-form potentials:

T here are also other non-vanishing commutators but these are related by the Jacobi identity.

We now turn to the question to which types of deform ations the deform ation potentials correspond. G iven that there are only a few of these, we will start with them assive deform ations.

Table 3: The representations of deform ation{ and top{form s in all half{m axim al supergravities. The representations refer to the duality group G_D given in table [2](#page-14-0). W e also indicate which type p of deform ations they correspond to, and to w hich top{form s one can associate a quadratic constraint on type 1 deform ation param eters.

A s can be seen from the previous discussion, type 3 deform ations of half (m axim al supergravity are only possible in $D = 7$, for the sim ple reason that only here there is a fundam ental 3-form. The deform ation is a singlet of the sym m etry group R^+ $SO(3;3 + n)$ and has been explicitly constructed for $n = 3$ [48]. Sim ilarly, type 2 deform ations of half (m axim al supergravity are only possible in $D = 6a$ and occur in the fundam ental representation of the symmetry group R^+ 50 (4;4 + n). The deform ed theory has been explicitly constructed for the special cases of $n = 4$ [47] and $n = 16$ [29].

A ll rem aining deform ation potentials correspond to type 1 deform ations, i.e. to gaugings. N ote that in every dim ension D 4 there is a fundam ental and three-form representation of such deform ation potentials. To be able to do m ore general gaugings one needs m ore space-time vectors than only the fundam ental representation, which is present in all these dim ensions. For exam ple, in $D = 5$ an additional vector is provided by the dual of the two-form, giving rise to an extra two-form representation of possible gaugings. In $D = 4$ the extra vectors are the H odge duals of the original ones, leading to an SL $(2;R)$ doublet of possible gaugings. Finally, in $D = 3$ scalars are dual to vectors. This is the underlying reason for the sym m etry enhancem ent in three dim ensions, and also gives rise to the m ore general possibilities of gaugings in this case.

M any of these gaugings have been obtained in the literature. Explicit calculations of the

possible gaugings using the em bedding tensor form alism in $D = 3;4;5$ have uncovered exactly the sam e representations [15,49]. In addition, one can obtain com ponents of the three-form representation of gauging in any dim ension D by a Scherk-Schwarz reduction from D + 1 dim ensions using the SO $(m, m + n)$ symmetry, see e.g. [28,31].

A prediction that follow s from the above analysis is that in the dim ensions w here the possible gaugings have not yet been fully analyzed, i.e. in $D = 6$, it will be possible to introduce a fundam entaland a three-form representation of gaugings. In term s of the em bedding tensor, which describes the embedding of the gauge group in the duality group G [16,18], this would read

where $_{\text{M}}$ = $_{\text{M N}}$ $_{\text{N}}$ and $\text{f}_{\text{M N P}}$ are the fundam entaland three-form representations of gaugings, respectively. The notation here is as follow s: the subscript index $M = 1;::::;2m + n$ refers to the generators of the gauge group and the superscript indices f0;M N q label the generators of the duality group R^+ SO (m $,m + n$). The em bedding tensor thus encodes which subgroup is gauged by the vectors $1^\text{\tiny{M}}\,$. N ote that the R $^+$ factor is crucial for the introduction of $_{\text{\tiny{N}}}$, as can be seen from the $\ _{\textrm{N}}$ 0 com ponent. The dierent com ponents of $\ _{\textrm{M}}$ $^{\textrm{N-P}}$ and $\ _{\textrm{N}}$ 0 specify which linear com binations of the gauge elds are used to gauge R^+ and a subgroup H SO (m;m + n), respectively:

4.3 Top{form potentials

Subsequently, we consider the top $\{\text{form }$ potentials and their relation to the quadratic constraints.

In generic dim ensions these top {form soccurin a singlet and anti-sym m etric two-and fourform representations. U sing the em bedding tensor approach, an analysis of the quadratic constraints on the possible deform ations has been explicitly carried out in $D = 3,4,5$ [15,49]. It turns out that the representations of the quadratic constraints exactly coincide w ith the representations of the possible top-form s in these dim ensions.

For D 6 the em bedding approach has not yet been applied and the K ac{M oody approach leads to a prediction. T he generic top-form s occur in the singlet, two- and four-form representations. In addition, from the lower-dim ensional analysis [15,49] one would expect them to correspond to a quadratic constraint. In term s of the em bedding tensor these would take the follow ing form :

The prediction is that the m ost general gauging of half ${m \text{ ax in all supergravity in D}}$ 6 is described by the em bedding tensor (4.7) subject to the quadratic constraints (4.9). It would

be interesting to explicitly construct these gauged theories. Note that the fundam ental representation $_M$ cannot be non-zero in D = 10, since the quadratic constraint requiring it to be a null vector can not be satis ed for an SO (n) representations. The gauging w ith deform ation param eters $f_{M NP}$ can be viewed as a gauging of a subgroup H SO (n) with structure constants $f_{M \ N P}$. In this sense D = 10 half-m axim alm atter{coupled supergravity with gauge groups SO (32) or E₈ E₈, i.e. the low {energy lim it of type I or heterotic string theory, can be viewed asthe gauged deform ation ofD = 10 half-m axim alsupergravity coupled to 496 M axwell m ultiplet 11 .

In addition, it would be interesting to investigate the possibilities of including the type 2 and 3 m assive deform ations in six and seven dim ensions, respectively, in the gauged theories; in other words, to see which types of deform ations can be turned on simultaneously.

5. D eform ations

U p to this point we have only considered the role of the deform ation potentials in the K ac-M oody or p{form algebra but not the deform ation param eters them selves. T hese param eters can be seen as the duals of (the eld strengths of) the deform ation potentials, see eqs. (1.1) and (1.2) . This is in contradistinction w ith the lower-rank potentials in which case the p{form algebra gives rise to both the potentials and their duals. In this section we will brie y consider how the inclusion of the deform ation param eters in supergravity eects the p{form algebra. In particular, we will discuss how the bosonic gauge transform ations could be truncated to a Lie algebra in the deform ed case, rst for m assive IIA supergravity and in the next subsection for gauged half{m axim al supergravity.

5.1 M assive IIA supergravity

For m assless IIA supergravity the fundam ental generators are a 1-form generator 1 and a 2{ form generator 2, see gure [1d.](#page-5-0) The other generators are the R -R generators 3;5;7;9 and the N S-N S generators 6 ; 8 ; 10 ; 10 0 . The basic com m utators are given by

W e have not included the 0{form generator corresponding to the duality group R ⁺ . In fact, also the commutator [2 \mathfrak{z} 6] is non-vanishing and leads to an 8 $^0.$ H owever, this commutator is related to [1 ;7] by the Jacobi identity and hence 8 and 8 0 are linearly dependent. A s can be seen from (5.1) , the IIA theory has a type 2 deform ation potential and two top{form potentials. T here is no quadratic constraint associated to either of the top{form s.

Let us now turn to the realisation of this symmetry on the IIA potentials. In the following we w illonly consider the truncation to the low { level potentials corresponding to 1;2;3 as this

w ill be su cient for our purpose. The gauge transform ations of m assless IIA supergravity are given by

w here the gauge param eters are all closed and hence $_{(p)} = 0$ $_{(p 1)}$. The restriction to the p-form algebra corresponds to constant $_{(p)}$'s, or equivalently $_{(p 1)}$'s with linear coordinate dependence, as discussed around (3.7) . It can easily be veri ed that this truncation to a Lie algebra satis es the rst com mutator of (5.1) . Similarly, it is possible to include all potentials of IIA and truncate to the p{form Lie algebra, that satis es the full (5.1) [45].

T here are several form ulations of the m assive IIA theory. T he original form ulation by R om ans [5] contains a constant m ass param eter m and no deform ation potential. Later, it was shown that there is an alternative description with a scalar m ass function m (x) and a $9\{$ form deform ation potential[4]. T here is even a third form ulation [4]w ith only a deform ation potential and no param eter but the bosonic gauge transform ations of this form ulation are highly non-linear and have not been explicitly worked out yet. We will consider the original R om ans form ulation here.

It turns out that the IIA bosonic gauge transform ations can be written as in the m assless case:

Note that, up to this level, the m assive m odication of the gauge transform ations only occurs via $\sim_{(1)}$. The ; param eters can be expressed in term s of the local gauge param eters $_{(p 1)}$ as follow s:

If we perform the same truncation [\(3.7\)](#page-8-0) as in them assless case to $_{(p)}$'s with linear coordinate dependence¹², the m assive transform ation param eters reduce to

A new feature is the appearance of an explicit coordinate dependence in the m assive case. Thishasbeen interpreted from the point of view of the p{form algebra in the follow ing way. The coordinatex can beseen asa new potentialw ith itsassociated sym m etry being thetranslations [53]. U sing the term inology of $[33]^3$ we will call x a \(-1){form potential". Follow ing [53] the m assive deform ation param eter m can be introduced to the p{form algebra by including an additional generator, which will be denoted by 1 . Subsequently one must de ne the com m utators between the translation generator and the fundam ental generators of the $p\$ form algebra. In the case of m assive IIA, the non-zero com m utators are $[53]$

T his com m utator is realized by the truncated m assive IIA gauge transform ations [\(5.5\)](#page-20-0) due to the term w ith explicit coordinate dependence.

The commutator (5.6) , or equivalently the gauge transform ation (5.4) , tells us that the 1{form is transform ing w ith a shift, proportional to m, under the gauge transform ations of the 2 {form. Therefore, the 1{form is\eaten up" by the 2 {form and the two potentials $(2;1)$ together form a so{called Stuckelberg pair describing a m assive $2\{\text{form . }T\}$ he commutator (5.6) de nes a deform ation of the direct sum of the p{form algebra and the translation generator [53].

It is not guaranteed that the truncation [\(3.7](#page-8-0)) is consistent in the m assive case, since (1) also appears w ithout an accom panying derivative. Therefore, closing the algebra m ight force us to introduce m ore sym m etries. Indeed, we nd that the following com mutator does not close:

A lthough the three-form potential transform s w ith a shift by a closed three-form, this is not covered by the present A nsatz for the gauge param eter (2) , as it leads to a constant, x{ independent, shift only. To obtain closure one m ust introduce an additional term of the form

The additional param eter is anti-symmetric in the last three-indices and satis es $\begin{bmatrix} 1 \\ 2 \end{bmatrix} = 0$. In term s of Lorentz representations, this corresponds to a $(3;1)$ representation with m ixed sym m etry and its trace, w hich is a 2. Since the trace properties play no role here, we will denote both together by $_{(3;1)}$.

O ne can see the need to include such a symmetry also from the $p\{f\}$ om algebra point of view. G iven the commutator (5.6) between the translation generator and the fundam ental 2, the Jacobi identity between the $f2;2;1$ g generators im plies

H ence, in the m assive case, $[2, 2]$ m ust be non-vanishing. It is anti-symm etric in a pair of two anti-symmetric indices and hence has $\frac{1}{8}$ (D + 1)D (D - 1)(D - 2) components in D dimensions. This is equal to the num ber of components of a (traceful) $(3;1)$ representation. Therefore we w rite

W e have checked that the rst commutator of (5.1) together with (5.6) , (5.11) and (5.12) lead to a closed Lie algebra. Schem atically we have

Note that 1 does not appear on the right-hand side of any commutator, i.e. the complem entary generators form an ideal, and the form er can therefore be quotiented out. However, the same cannot be said for the $(3;1)$ due to the commutator (5.11) .

We conclude that a truncation of them assive IIA gauge transform ations forces us to consider extensions of the p{form algebra with additionalm ixed symmetry generators. It is expected that m ore such generators are needed when also the higher rank potentials are included. It rem ains to be seen whether a consistent truncation exists when all p (form generators are included.

It is interesting to compare the present result with the approach of $[33]$ which takes the same m assive IIA gauge transform ation rules as their starting point. Before doing any truncation one rst rew rites the m assive transform ation rules such that every param eter occurs with a derivative, like in the m assless case. This m akes it possible to perform the same truncation as in the m assless case. For this to work it is crucial that one rst form ulates the transform ation rules in term s of form s and next form ally write the O{form m as the exterior derivative of a \setminus (-1){fom potential" A₍₁₎:

O nce every param eter occurs under a derivative one can write the transform ation rules as the non-linear realization of an algebra that includes a form al \(-1){form generator". We understand that in this procedure one should not convert to component notation in the presence of the (-1) {form potential. Only after all (-1) {form potentials have been converted into deform ation parameters a transition to component notation can be made. In particular, one should not consider a component form ulation of (5.14) since this would lead us back to our earlier discussion w ith the need to introduce extra m ixed symmetry generators. It would be interesting to see whether the \setminus (-1){form s" needed in this procedure can be given a rigorous mathem atical basis.

Sofar, we have discussed two ways to proceed in them assive case. Either one starts extending the direct sum of the p-form algebra and the translation generators with new mixed symmetry generators or one extends the p{form algebra with the form al concept of a new \setminus (-1){form

generator". There is even a third way to proceed in the m assive case which uses E_{10} instead of E₁₁ [54]. The spectrum of E₁₀ leads to precisely the same representations as E₁₁ except for the top{form s w hich only follow from E_{11} . By using E_{10} one is able to not only consider kinem atics but also dynam ics consistent w ith E_{10} . By using the dynam ics the authors of [54] seem to be able to derive the equations of m otion of m assive IIA supergravity w ithout the need to introduce new sym m etry generators. It would be interesting to m ore carefully com pare the dierent approaches and to obtain a better understanding of what the role of the dynam ics is.

5.2 H alf-m axim alsupergravity

We now discuss the case of half (m axim al supergravity. For simplicity we will consider only the three{form representation $f_{M N P}$ and not the m ost general deform ation. This will be sucient for the present purpose.

The starting point will be the original ungauged p{form algebra of half{m axim alsupergravity, which we truncate to the vectors 1^M . In addition we include the scalars $0^\text{M-N}$, which are the generators of the special orthogonal part of the duality group $G_D = R^+$ SO (m ; m + n). T hese generators satisfy

while other commutators vanish (including $[1^{\,M}\;;1^{\,N}\;]$ in this truncation).

Subsequently we introduce the three-form deform ation $f_{M \ N P}$, which is dened by the follow ing non {zero com m utators between the translation generator 1 and the fundam entalgenerators, see also [13]:

Based on our experience w ith the m assive IIA case we do not expect the above deform ation to lead to a closed algebra. Indeed, from the f1; 1; 1g Jacobiidentity it follow sthat one is led to extend the algebra w ith a new generator that transform s in the sym m etric $(1;1)$ representation. The additionalcom mutators take the form

The above Jacobi identity then vanishes.

Unlike in them assive IIA case, there are additionalnon-trivialJacobiidentities, for exam ple of the form f1; $1;$ $1;$ $(1;1)$ g. To satisfy these one needs to introduce additional symmetric three-index tensor generators w ith commutator relations \sin ilar to (5.17) . Subsequently one nds that there are Jacobi identities involving the symm etric three-index tensors, that require the introduction of symm etric four-index tensors. This iterative procedure does not term inate. In term s of the local gauge param eters M of the vector transform ations, the new symm etries can be understood as the expansion

H ence it appears that the gauge transform ations of gauged half-m axim al supergravities can only be truncated to an in nite num ber of generators.

It would be interesting to see if there exist an interpretation (or modi cation) of the approaches [13,33,53,54] that can reproduce all the results that follow from the em bedding tensor m ethod [15,16,18].

6. C onclusions

In the rst part of this paper we have rened the correspondence between the $Kac{M}$ oody spectrum of deform ation and top{form potentials and the gaugings and m assive deform ations of the associated supergravity. It was shown that there is a truncation of the K ac{M oody algebra to a Lie algebra of p{form s, w hich encodes all the relevant inform ation for the physical states (apart from gravity and scalars) plus the non-propagating deform ation and top{form potentials. A special role is played by the fundam ental p {form s, from w hich all other potentials can be constructed via com m utators. In particular, one has comm utators of the form (3.8) giving rise to the $(D \t1)$ {form s, from w hich the corresponding type of supergravity deform ation can be deduced. In addition, the p{form algebra contains commutators leading to D {form s, and these m ay be associated to quadratic constraints on the deform ation param eters. W e should stress that the properties derived from (3.8) and the relation to the quadratic constraints are em pirical observations. It would be interesting to understand how these follow from the bosonic gauge transform ations of supergravity.

In the second part we have established that the correspondence also holds for half ${m \, ax \, m \, al}$ supergravity. In particular, in table [3](#page-17-0) the spectrum of deform ation and top{form potentials of the associated K ac{M oody algebras is sum m arized. These possibilities agree perfectly w ith the known gaugings and m assive deform ations of half(m axim al supergravity and the ensuing quadratic constraints, respectively. In addition it gives a prediction for them ost general gaugings in 6 D 10: these are encoded in a fundam ental and three-form representation of the duality groups sub ject to the quadratic constraints (4.9) .

N ote that we have only realized a nite-dim ensional part of the K ac-M oody algebra as a sym $$ m etry. H ow ever, in dierentdim ensions, this p{form algebra constitutes a dierent truncation of the K ac-M oody algebra. The latter contains all sym m etry groups of half-m axim al supergravity in D dim ensions. This show show the very extended K ac $(M \text{ oody}$ algebra SO $(8, 8 + n)^{+ + +}$ plays a unifying role in describing the sym m etries of half (m axim alsupergravity coupled to 10 D + n vector m ultiplets.

Finally, we considered the eect of the deform ation itself on the p{form algebra. It was found that in the deform ed case, the bosonic gauge algebra can not be truncated to a p{form algebra. Instead, to obtain a closed algebra, one needs to include additional generators with m ixed sym m etries w hose role from the K ac-M oody point of view rem ains to be claried.

In addition to the open issues m entioned above, we see a number of interesting venues to extend the present results. First of all, a relevant question is w hether the above correspondence, w hich holds for m axim al and half{m axim al supergravity, can also be extended to theories w ith

less supersym m etry. A num ber of such supergravities are given by a scalar coset G =K (G) after reduction to three dim ensions. Restricting to groups G with a real split form these cosets have been classi ed [40]. It is natural to investigate w hether the over and very extensions of G contain deform ation and top{form potentials corresponding to all deform ations of the associated supergravities as well. Furtherm ore, these cosetm odels $G = K$ (G) are special points in a landscape ofm ore generalgeom etries. It would be interesting to learn m ore about the deform ation and top{form potentials associated to the generalnon{coset geom etries.

R ecently, an exam ple w here the correspondence between supergravity and very extended algebras does not hold straightforwardly was found in the theory that reduces to the coset m odel G $_2$ =SO (4) in three dim ensions. W hile m inim al D = 5 sim ple supergravity allow s for a triplet of deform ation potentials, related to the gauging of a U (1) subgroup of the SU (2) R -symmetry, there are no such potentials in the associated K ac{M oody algebra G $_2^{\mathrm{+++}}$ [52]. A possible explanation for this phenom enon m ay be that in this case the R {sym m etry does not act on the original bosonic elds of the theory [37]. A nother possibility m ay be that there is an extension of G $_2^{++}$ that does take the gauging into account. It would be worthwhile to nd m ore exam ples of this phenom enon and to understand it in m ore detail.

It would also be interesting to study the brane interpretation of the deform ation and top{ form potentials. They naturally couple to dom ain walls and space{ lling branes, respectively. It isknow n that in IIA supergravity the deform ation potential 9 couples to the half-supersym m etric D 8{brane and that the top{form potential $10⁰$ couples to a half-supersymm etric space-lling brane w hose string interpretation has yet to be clari ed [45]. The other top-form potential 10 couples to a non-supersymm etric space-lling brane. Similarly, the quadruplet 4 of top{ form potentials of IIB supergravity couples to a half{supersymm etric nonlinear doublet of 9{ branes, including the D 9{brane $[55]$. The doublet 2 of top{form potentials couples to half{ supersymm etric space{ lling branes w hose string interpretation is yet unclear. It would be interesting to perform a similar analysis for the other dim ensions as well and see how all these branes tinto string theory.

Furtherm ore, while in this paper the possibilities of adding deform ation and top {form potentials to m atter coupled supergravity theories have been discussed, one m ay ask w hetherm atter m ultiplets not coupled to supergravity can be extended w ith such potentials as well. It turns out that this is indeed the case. In fact, it has been suggested that a dom ain wall structure on a D {brane, interpolating between dierent values of the brane tension, should be described by a worldvolum e deform ation potential [56], sim ilar to the way strings ending on such a brane are described by a worldvolum e vector. In the case of the $D9$ {brane this m eans that the $D = 10$ M axwell multiplet can be extended with a nine{form potential, which is indeed possible [56]. T hiscould correspond to the fundam entalrepresentation ofdeform ation form sin table [3](#page-17-0). T his fundam ental representation does not correspond to a deform ation of supergravity due to the third quadratic constraint in [\(4.9\)](#page-18-0). We expect that all fundam ental representations in table [3](#page-17-0) correspond to possible extensions of the $D < 10$ vector multiplets with deform ation and top{ form potentials as well. It m ight be worthw hile to consider the brane interpretation of these possibilities in further detail.

A. Term inology and notation

Below we shortly summarize the term inology we have introduced in this paper.

Deform ation potential A (D 1) { form potential in D dim ensions.

Top { form potential A D { form potential in D dim ensions.

- p{form algebra Truncation of the K ac{M oody algebra in a particular G_D SL(D;R) decom position by restricting to only the generators at positive levels in a purely antisymm etric SL (D, R) tensor representation of rank 1 p D. A lso arises by considering the bosonic gauge algebra with constant gauge param eters of the associated supergravity.
- Fundam entalp{form A p-form corresponding to a positive simple root of one of the disabled nodes in the decomposed Dynkin diagram of the K ac-M oody algebra. G enerates the p{ fom algebra.
- Type p deform ation A deform ation of the p{form algebra in which a fundamental p{form becom es m assive.

Furtherm ore we indicate components of p (form s by a boldface italic number equal to their rank, e.g. 5 stands for 5 $\frac{1}{1}$, $\frac{1}{5}$. This is not to be confused with group representations, which are represented with a boldface num ber equal to their dim ension. Our convention for the norm alisation of products of p {form s is the same as in [45]; in particular, we (anti-)symm etrize with weight one.

B. Physical states of half{m axim al supergravity

We consider half(m axim al supergravity in any dimension and coupled to an arbitrary number of vector multiplets. Starting with the graviton multiplet of D-dim ensional half (m axim al supergravity, its bosonic part consists of a m etric, m vector gauge elds w ith $m = 10$ D, a two-form gauge eld and a single scalar which is the dilaton. It has a global SO (m) symmetry, under

w hich the vectors transform in the fundam ental representation. The only exceptions are $D = 4$ and $D = 3$ w here there are non-trivial hidden symm etries. In $D = 4$ there is one extra scalar due to the duality of the two-form potential to an axionic scalar. Together with the dilaton this leads to an enhanced SL(2;R) SO (6) hidden symmetry. Similarly, in $D = 3$ there are 7 extra scalars due to the duality in $D = 3$ dim ensions between the vectors and scalars. In this case all physical degrees of freedom are carried by a scalar coset SO $(8;1)$ =SO (8) .

T he other possible m ultiplet in generic dim ensions is the vector m ultiplet, w hich contains a vector and m scalars. The eect of adding $m + n$ vector m ultiplets is to enlarge the symmetry group from $SO(m)$ to $SO(m;m + n)$. The scalars param eterize the corresponding scalar coset w hile the vectors transform in the fundam ental representation. In four dim ensions the symm etry becom es $SL(2;R)$ SO $(6;6 + n)$ while in three dim ensions it is given by SO $(8;8 + n)$. In the latter case there again is sym m etry enhancem ent due to the equivalence between scalars and vectors. The entire theory can be described in term s of the corresponding scalar coset (coupled to gravity).

The above multiplets belong to non-chiral half ${m \times m}$ alsupergravity and are the correct and com plete story in generic dim ensions. In six dim ensions, how ever, the half{m axim altheory can be chiral or non-chiral, sim ilar to the m axim altheory in ten dim ensions. The non-chiral theory is denoted by $D = 6a$ and follow s the above pattern. The chiral theory, $D = 6b$, instead has dierent m ultiplets. In particular, the graviton m ultiplet contains gravity, ve scalars and ve self-dual plus one anti-self-dualtwo-form gauge elds. The global symmetry is given by SO (5;1). The other possible multiplet is that of the tensor, which contains an anti-self-dual two-form and ve scalars. Adding $4 + n$ of such tensor multiplets to the graviton multiplet enhances the symmetry to SO $(5;5 + n)$.

U pon dim ensional reduction over a circle, the graviton m ultiplet splits up into a graviton m ultiplet plus a vector m ultiplet. A vector (or tensor) m ultiplet reduces to a vector m ultiplet

in the lower dim ensions. T his was the reason for adding m + n instead ofn vector or tensor m ultiplets in any dim ension; it can easily be seen that n rem ains invariant under dim ensional reduction. That is, a theory w ith a certain value of n reduces to a theory w ith the same value ofn in lower dim ensions.

For the reader's convenience we have given the physical states corresponding to $D = 10$ m half{m axim alsupergravity coupled to $m + n$ vector (or tensor) multiplets in table 4 , see, e.g., [57].

C . G roup theory

In this appendix we will generalize the analysis of $[14]$ to allow for non $\{\sin p\}$ laced D ynkin diagram s. The key dierence between a simply laced and a non{simply laced diagram is that for the latter the associated C artan m atrix is not symmetric, and no longer ful lls the role of a m etric on the root space. M oreover, the m etric on the weight space is no longer given by the inverse of the C artan m atrix.

The root spacem etric is in portant in constructing the root system { one needs it to com pute inner products between roots. The weight spacem etric plays a sim ilar role for the highest weight representations, which are a necessary ingredient for the level decom position. We will show how both m etrics can be obtained from appropriate sym m etrizations of the (inverse) C artan m atrix.

We start out from the dening equation for the C artan m atrix, which reads

T he latter norm alization is particularly convenient for com puter-based calculations, because then the root metric B has only integer values.

By construction G is symmetric, just like the root metric B.

As explained in [9,35], the level decom position of in nite-dim ensional Lie algebra entails scanning for subalgebra representations at given levels. The subalgebra representations are de ned by their D ynkin labels, and have to satisfy three conditions:

- (i) T he D ynkin labels allhave to be integer and non-negative.
- (ii) The associated root labels have to be integers.
- (iii) The length squared of the root m ust not exceed the m axim um value.

T he subalgebra is obtained by 'disabling'nodes from the D ynkin diagram . W e can then split up the index of the full algebra into $i = (a; s)$, where a runs over the disabled nodes and s over the subalgebra. To see w hether condition [\(ii\)](#page-29-0) is satis ed for particular values of p_s , we can invert equation [\(C .8](#page-29-0)) in order to obtain

H ere G $_{\rm sub}$ is the weight m etric of the subalgebra, and $_{\rm max}^2$ is given by the norm of the longest $\sin p$ ple root. N ote that for this form ula to be valid, we have to m ake sure that a long (or short) root in the fullalgebra is also a long (short) root in the subalgebra, w hich in generalis not autom atically the case. Luckily we are always free to choose a norm alization such that root lengths m atch.

W hen using (C .12) to scan for representations, it is im portant for G $_{\rm sub}$ to only have nonnegative entries. If this is not the case, then the root norm 2 is not a m onotonically increasing function of the D ynkin labels p_s at xed levels l^a , and one m ight m iss representations using a sim ple scanning algorithm . H ow ever, as we always shall be decom posing with respect to (direct products of) nite dim ensional subalgebras, G_{sub} w ill never contain negative entries.

D . Low level D_{8}^{++} decompositions

H ere we list the output of S in pL ie [38] at low levels, using the various decom positions of D $^{\rm ++}_8$ as indicated by the D ynkin diagram accom panying the tables. The regular subalgebra splits into a part belonging to the gravity line A_n (the w hite nodes) and a part belonging to the internal duality group G_D (the grey nodes).

In the follow ing tables we respectively list the levels, the D ynkin labels of A_n and G_D , the root labels, the root length, the dim ension of the representations of A_n and G, the m ultiplicity of the root, the outer m ultiplicity, and the interpretation as a physical e k. The deform ation { and top{form potentials are indicated by 'de' and 'top', respectively. W hen the internal group does not exist, we do not list the corresponding columns. In all cases the D ynkin labels of the low est weights of the representations are given. A ll tables are truncated at the point when the num ber of indices of the gravity subalgebra representations exceed the dim ension. The order of the levels, D ynkin labels, and root labels as they appear in the tables are determ ined by the order of the node labels on the D ynkin diagram . This ordering is always rst from left to right, then from top to bottom .

T he interpretation of the representations at level zero as the graviton is, unlike the p-form s at higher levels, not quite straightforw ard. The graviton em erges w hen one com bines the ad joint representation of A_n w ith a scalar com ing from one of the disabled nodes, see [9,34]. We have indicated these parts of the graviton by g and g , respectively.
