Cascading DGP

We present a higher codim ension generalization of the DGP scenario which, unlike previous attem pts, is free of ghost instabilities. The 4D propagator is m ade regular by embedding our visible 3-brane within a 4-brane, each with their own induced gravity term s, in a at 6D bulk. Them odel is ghost-free if the tension on the 3-brane is larger than a certain critical value, while the induced metric rem ains at. The gravitational force law \cascades" from a 6D behavior at the largest distances $\operatorname{followed}$ by a 5D and nally a 4D regin e at the shortest scales.

The DGP model [1] provides a simple mechanism to m odify gravity at large distances by adding a localized graviton kinetic term on a codimension 1 brane in a at 5D bulk. The natural generalization to higher codimension, how ever, is not so straightforward. On one hand these models require some reqularization due to the divergent behavior of the G reen's functions in higher codim ension. M ore seriously, m ost constructions seem to be plaqued by ghost instabilities [2, 3] (see [4] for related work). The purpose of this letter is to show that both pathologies can be resolved by em bedding a succession of higher-codim ension DGP branes into each other.

T. SCALAR

We shall focus on the codimension 2 case. As a warm up exercise, we consider a real scalar eld with action,

describing a codim ension 2 kinetic term embedded into a codim ension 1 one in 6D. We will impose throughout the paper Z_2 Z_2 orbifold projection identifying y! \overline{V} and z ! z. The m odel possesses the two m ass scales,

In absence of the 4D kinetic term the propagator on the codim ension 1 brane (4-brane) is the DGP propagator [1],

where p is 4D m om entum and y the coordinate orthogonal to the codim ension 2 brane (3-brane). To nd the exact 5D propagator we can treat the 4D kinetic term (located at $y = 0$) as a perturbation and then sum the series. One nds,

In particular the 4D brane-to-brane propagator is determ ined in term s of the integral of the higher dim ensional G reen's function,

For $p > 2m_6$, the analytic continuation of this expression is understood.

Remarkably, the 5D kinetic term makes the 4D propagator nite, thereby regularizing the logarithm ic divergence characteristic of pure codimension 2 branes. In particular, when M_5 goes to zero one has G_4^{exact} ! M_6^4 log(p=m 6), reproducing the codimension 2 G reen's function with physical cuto given by m_6 . The corresponding 4D N ew tonian potential scales as $1=r^3$ at the largest distances, show ing that the theory becomes six dimensional, and reduces to the usual 1=r on the shortest scales. Its behavior at intermediate distances, however, depends on $m_{5,6}$. If $m_5 > m_6$ there is an interm ediate 5D regim e; otherw ise the potential directly tums 6D at a distance of order $(m_5m_6)^{-1=2}$ log $(m_5=m_6)$.

II. GRAVITY

Let us now turn to gravity. In analogy with the scalar we consider the action,

where each term represents the intrinsic curvature. This guarantees that the m odel is fully 6D general covariant.

To nd the propagator it is convenient to follow the sam e procedure as for the scalar and sum the diagram s with insertion of the lower dimensional kinetic term, i.e. the E instein's tensor E. For our purpose we only compute the propagator on the 3-brane. G iven the higher dim ensional propagator, the brane-to-brane propagator due to the insertion of a codim ension 1 term is in compact form,

where G^0 is the 4D part of the higher dimensional G reen's function evaluated at zero. The tensor H sat is es by de nition,

Requiring that this satis es Eq. (7) leads to a system of linear equations whose solution determines the coe cients a;b;c;d;e;f. U sing this information one then reconstructs the exact propagator from Eq. (6).

It is straightforw ard to apply this technique to the cascading DGP. Starting from 6D, the propagator on the 4 -brane is $[5]$,

where M ;N ::: are 5D indices and $p_5^2 = p_M p^M$. G⁰ is obtained by integrating the 5D propagator with respect to the extra-m om entum. To com pute the propagator on the 3-brane, then, we determ ine the coe cients a;b;c;d;e;f through the system of linear equations (7).

All these coe cients are nite show ing that the reqularization is also e ective for the spin 2 case.

H aving determ ined the coe cients of the tensor H the full propagator is given by Eq. (6). To linear order the am plitude between two conserved sources on the brane is rather simple,

and only depends on the rst integral I_1 .

The coe cient in front of the am plitude is exactly as for the scalar how ever there is a non-trivial tensor structure. One worrisom e feature of this am plitude is that the relative ∞ e cient of T T^0 and TT⁰ interpolates between $1=4$ in the IR and $1=2$ in the UV. The $1=4$ in the IR gives the correct tensor structure of gravity in 6D and is unavoidable because at large distances the physics is dom inated by 6D E instein term. From the 4D point of view this can be understood as the exchange of m assive gravitons and an extra-scalar. The $1=2$ in the UV on the other hand signals the presence of a ghost. This agrees with previous results $[2, 3]$ which used a dierent reqularization. From the 4D point of view the theory decom poses into m assive spin 2 elds and scalars. Since the m assive spin 2 gives an am plitude w ith relative coe cient $1=3$ the extra repulsion must be provided by a scalar with wrong sign kinetic term. Separating from Eq. (10) the m assive spin two contribution, we identify the scalar propagator as

This propagator has a pole with negative residue therefore it contains a localized (tachyonic) ghost mode in addition to a continuum of healthy modes.

III. G HOST FREE THEORY

To clarify the origin ofthe ghost it is illum inating to consider the decoupling lim it studied in [\[6\]](#page-3-5). T his w ill allow us to show how a healthy theory can be obtained by sim ply introducing tension on the lower dim ensional brane w hile retaining the intrinsic geom etry
at.

In the 6D case the decoupling lim it [\[6](#page-3-5)] corresponds to taking M_5 ; M_6 ! 1 with s ${}^{2}_{6}M$ ${}^{3=2}_{5}$ \rangle ²⁼⁷ = $(M₆¹⁶=M₅⁹)¹⁼⁷$ nite. In this lim it, the physics on the 4-brane adm its a local 5D description, w here only the non-linearities in the helicity 0 part of the m etric are kept, and are suppressed by the scale s . The eective 5D lagrangian is given by

where $(Eh)_{M,N} = h_{M,N} + \dots$ is the linearized E instein tensor, M ; N ::: are 5D indices and ; ::: are four dim ensional.W e have rescaled and h so that they are dim ensionless, and the physical 5D m etric is

The rst line of [\(12\)](#page-2-0) is the 5D version of the ' La-grangian' introduced in [\[6](#page-3-5)] for the DGP m odel. In addition to this, we have the localized curvature term on the 3-brane, w hich depends on 4D physicalm etric \hbar .
This introduces a kinetic m ixing between and the 5D This introduces a kinetic m ixing between m etric.

W e now take a further step and com pute the boundary e ective action valid on the 3-brane. At the quadratic order by integrating out the fith dim ension the 5D kinetic term of produces a 4D \m assterm " $M₅³$ $^{-}$ 4 w hile the Einstein tensor gives rise to Pauli-Fierz (PF) struc-ture for h on the boundary [\[10\]](#page-3-6),

N ote that the kinetic term for is com pletely absorbed by that of \hbar and only a cross term between and \hbar rem ains.

From this it is straightforward to show the presence of a ghost. The scalar longitudinal com ponent of h acquires a positive kinetic term by m ixing w ith the graviton $[6,7]$ $[6,7]$. By taking

which has obviously a negative eigenvalue corresponding to a ghost.

H aving understood the origin of the ghost we are now ready to show how to cure it. To achieve this we clearly need to introduce a positive localized kinetic term for

. T hiscan arise from extrinsic curvature contributions. The sim plest and m ost natural choice is to put a tension on the 3-brane. This produces extrinsic curvature w hile leaving the m etric on the brane
at since the tension only creates a de cit angle.

T he solution to the 5D equations follow ing from [\(12\)](#page-2-0) for a 3-brane w ith tension is [\[8\]](#page-3-8)

T his is an exact solution including the non-linear term s for { they vanish identically for this pro le. The background corresponds to a locally at 6D bulk with de cit angle $=$ M $_6^4$ and w ith at 4D sections.

T he crucial point is that on this background the lagrangian acquires contributions from the non-linear term s. These can be found considering the perturbations,

T his is a localized kinetic term for that contributes to the 4D e ective action w ith a healthy sign when > 0 . Therefore for large enough the kinetic m atrix for the 2 scalars [\(17\)](#page-2-3) becom es positive and the ghost is absent.

T his can also be seen by com puting the one particle exchange am plitude. W ith the addition of (20) , the effective 4D equations are

in the UV. The am plitude above corresponds to the exchange ofm assive spin 2 elds and a scalar obeying Eq. [\(24\)](#page-3-10). The (DGP-like) kinetic term for the scalar is positive as long as,

In this regim e we see that the localized ghost disappears and the scalar sector is com posed of a healthy resonance.

In the lim it we are considering the tension required is consistent w ith having six non com pact dim ensions. Indeed, requiring that the de cit angle in the bulk is less than 2 leads to \leq 2 M $_6^4$. It follows that,

w hich is always satised in the 5D decoupling lim it and displays the necessity of the induced term on the codim ension 1 brane. M oreover the condition above is

equivalent to having $m_6 < m_5$, which suggests that in order to avoid the ghost one should cascade from the highestdim ension dow n to 4D 'step by step'.

From a phenom enological point of view, observations require that m_5 . H₀, the present H ubble scale. The m ost interesting possibility is w hen the 6D crossover scale is larger but of sim ilar order. A ssum ing that the form ulas above can be extrapolated in this regim e for a Planckian M₄ this implies that M₅ is of order 10M eV and M₆ m eV. The latter also sets the scale of.

IV . D ISC U SSIO N

In thisnote we have presented a six dim ensionalD G P m odelw ith cascading localized kinetic term s.T he m odel interpolates between a 6D behavior at large distances and a 4D one at short distances w ith an interm ediate 5D regim e. T he kinetic term s regularize the divergent codim ension 2 behavior. The m odel is ghost-free at least for a certain range of param eters if on the codim ension 2 brane there is a large enough tension.

We have left several questions for future study. At linear-level the tensor structure of the graviton propagator is inconsistent w ith observations. In the context of DGP this was shown not to be a problem because the non-linearities restore the correct tensor structure [\[9](#page-3-11)]. A hint of a sim ilar phenom enon in the present model is given by the longitudinal terms of the graviton propagator [\(6\)](#page-1-1). T hese are singular w hen the m ass param eters $m_{5,6}$ vanish and give large contributions to nonlinear diagram s. In fact, we expect a 'double' Vainshtein e ect. For dense enough sources, the non-linearities should rst decouple the extra 5D scalar m ode restoring 5D behavior followed by another step to 4D . A nother im portant direction to study is cosm ology. T he m odelhas the intriguing codim ension 2 feature that tension does not curve the space. T his obviously of interest for the cosm ological constant problem.
