## Cascading DGP

W e present a higher codim ension generalization of the DGP scenario which, unlike previous attem pts, is free of ghost instabilities. The 4D propagator is made regular by embedding our visible 3-brane within a 4-brane, each with their own induced gravity terms, in a at 6D bulk. The model is ghost-free if the tension on the 3-brane is larger than a certain critical value, while the induced m etric remains at. The gravitational force law \cascades" from a 6D behavior at the largest distances followed by a 5D and nally a 4D regime at the shortest scales.

The DGP model [1] provides a simple mechanism to modify gravity at large distances by adding a localized graviton kinetic term on a codimension 1 brane in a at 5D bulk. The natural generalization to higher codimension, however, is not so straightforward. On one hand these models require some regularization due to the divergent behavior of the G reen's functions in higher codimension. More seriously, most constructions seem to be plagued by ghost instabilities [2, 3] (see [4] for related work). The purpose of this letter is to show that both pathologies can be resolved by embedding a succession of higher-codimension DGP branes into each other.

## I. SCALAR

W e shall focus on the codim ension 2 case. As a warm up exercise, we consider a real scalar eld with action,

describing a codimension 2 kinetic term embedded into a codimension 1 one in 6D.We will impose throughout the paper  $Z_2$   $Z_2$  orbifold projection identifying y ! y and z ! z. The model possesses the two mass scales,

In absence of the 4D kinetic term the propagator on the codim ension 1 brane (4-brane) is the DGP propagator [1],

where p is 4D m om entum and y the coordinate orthogonal to the codim ension 2 brane (3-brane). To nd the exact 5D propagator we can treat the 4D kinetic term (bcated at y = 0) as a perturbation and then sum the series. One nds,

In particular the 4D brane-to-brane propagator is determ ined in term s of the integral of the higher dim ensional G reen's function,

For the case at hand,

For  $p>2m_{\rm 6}$  , the analytic continuation of this expression is understood .

Remarkably, the 5D kinetic term makes the 4D propagator nite, thereby regularizing the logarithmic divergence characteristic of pure codimension 2 branes. In particular, when M<sub>5</sub> goes to zero one has  $G_4^{\text{exact}}$ ! M<sub>6</sub><sup>4</sup> log(p=m<sub>6</sub>), reproducing the codimension 2 G reen's function with physical cuto given by m<sub>6</sub>. The corresponding 4D New tonian potential scales as  $1=r^3$  at the largest distances, showing that the theory becomes six dimensional, and reduces to the usual 1=r on the shortest scales. Its behavior at intermediate distances, how ever, depends on m<sub>5/6</sub>. If m<sub>5</sub> > m<sub>6</sub> there is an intermediate 5D regime; otherwise the potential directly turns 6D at a distance of order (m<sub>5</sub>m<sub>6</sub>) <sup>1=2</sup> log(m<sub>5</sub>=m<sub>6</sub>).

Let us now turn to gravity. In analogy with the scalar we consider the action,

where each term represents the intrinsic curvature. This guarantees that the model is fully 6D general covariant.

To nd the propagator it is convenient to follow the same procedure as for the scalar and sum the diagrams with insertion of the lower dimensional kinetic term, i.e. the E instein's tensor E. For our purpose we only compute the propagator on the 3-brane. G iven the higher dimensional propagator, the brane-to-brane propagator due to the insertion of a codimension 1 term is in compact form,

where  $G^0$  is the 4D part of the higher dimensional G reen's function evaluated at zero. The tensor H satisfies by denition,

To nd H one can write the most general Lorentz covariant structure com patible with the sym metries,

Requiring that this satis as Eq. (7) leads to a system of linear equations whose solution determ ines the coe – cients a;b;c;d;e;f. U sing this inform ation one then reconstructs the exact propagator from Eq. (6).

It is straightforward to apply this technique to the cascading DGP. Starting from 6D, the propagator on the 4-brane is [5],

where M ;N ::: are 5D indices and  $p_5^2 = p_M p^M$ . G<sup>0</sup> is obtained by integrating the 5D propagator with respect to the extra-m om entum. To compute the propagator on the 3-brane, then, we determ ine the coe cients a;b;c;d;e;f through the system of linear equations (7).

One nds,

All these coe cients are nite showing that the regularization is also e ective for the spin 2 case.

Having determ ined the coe cients of the tensor H the full propagator is given by Eq. (6). To linear order the am plitude between two conserved sources on the brane is rather sim ple,

and only depends on the rst integral  $I_1$ .

The coe cient in front of the amplitude is exactly as for the scalar how ever there is a non-trivial tensor structure. One worrisom e feature of this am plitude is that the relative coe cient of T T<sup>0</sup> and TT<sup>0</sup> interpolates between 1=4 in the IR and 1=2 in the UV. The 1=4 in the IR gives the correct tensor structure of gravity in 6D and is unavoidable because at large distances the physics is dominated by 6D Einstein term . From the 4D point of view this can be understood as the exchange of massive gravitons and an extra-scalar. The 1=2 in the UV on the other hand signals the presence of a ghost. This agrees with previous results [2, 3] which used a di erent regularization. From the 4D point of view the theory decom poses into massive spin 2 elds and scalars. Since the massive spin 2 gives an amplitude with relative coe cient 1=3 the extra repulsion must be provided by a scalar with wrong sign kinetic term . Separating from Eq. (10) the massive spin two contribution, we identify the scalar propagator as

This propagator has a pole with negative residue therefore it contains a localized (tachyonic) ghost mode in addition to a continuum of healthy modes.

## III. GHOST FREE THEORY

To clarify the origin of the ghost it is illum inating to consider the decoupling lim it studied in [6]. This will allow us to show how a healthy theory can be obtained by simply introducing tension on the lower dimensional brane while retaining the intrinsic geometry at.

In the 6D case the decoupling lim it [6] corresponds to taking M<sub>5</sub>;M<sub>6</sub> ! 1 with  $_{\rm s}$   $({\rm m}_{6}^{2}{\rm M}_{5}^{3=2})^{2=7} =$  $({\rm M}_{6}^{-16}={\rm M}_{5}^{-9})^{1=7}$  nite. In this lim it, the physics on the 4-brane admits a local 5D description, where only the non-linearities in the helicity 0 part of the metric are kept, and are suppressed by the scale  $_{\rm s}$ . The elective 5D lagrangian is given by

where  $(Eh)_{M N} = h_{M N} + :::$  is the linearized E instein tensor, M; N::: are 5D indices and ; ::: are four dimensional. We have rescaled and h so that they are dimensionless, and the physical 5D metric is

The rst line of (12) is the 5D version of the 'Lagrangian' introduced in [6] for the DGP model. In addition to this, we have the localized curvature term on the 3-brane, which depends on 4D physical metric  $\mathbf{\hat{f}}$ . This introduces a kinetic mixing between and the 5D metric.

W e now take a further step and com pute the boundary e ective action valid on the 3-brane. At the quadratic order by integrating out the fth dimension the  $\frac{5D}{5}$  kinetic term of produces a 4D \m ass term " M  $\frac{3}{5}^{1}$   $\frac{1}{4}$  while the E instein tensor gives rise to Pauli-Fierz (PF) structure for h on the boundary [10],

where h and now denote the 5D elds evaluated at the 3-brane location.

In terms of the physical metric, (14) takes the form,

Note that the kinetic term for f is completely absorbed by that of f and only a cross term between and f remains.

From this it is straightforward to show the presence of a ghost. The scalar longitudinal component of h acquires

a positive kinetic term by m ixing with the graviton [6, 7]. By taking

one nds that there are in fact two 4D scalarm odes whose kinetic matrix in the UV is

which has obviously a negative eigenvalue corresponding to a ghost.

Having understood the origin of the ghost we are now ready to show how to cure it. To achieve this we clearly need to introduce a positive localized kinetic term for

. This can arise from extrinsic curvature contributions. The sim plest and most natural choice is to put a tension on the 3-brane. This produces extrinsic curvature while leaving the metric on the brane at since the tension only creates a de cit angle.

The solution to the 5D equations following from (12) for a 3-brane with tension is [8]

This is an exact solution including the non-linear terms for { they vanish identically for this prole. The background corresponds to a locally at 6D bulk with de cit angle =M  $\frac{4}{6}$  and with at 4D sections.

The crucial point is that on this background the lagrangian acquires contributions from the non-linear term s. These can be found considering the perturbations,

Plugging (19) in (12) and dropping , one obtains at quadratic order (up to a total derivative),

This is a localized kinetic term for that contributes to the 4D elective action with a healthy sign when > 0. Therefore for large enough the kinetic matrix for the 2 scalars (17) becomes positive and the ghost is absent.

This can also be seen by computing the one particle exchange amplitude. W ith the addition of (20), the effective 4D equations are

Combining (21), (23) and (24), one derives that the physicalm etric is, up to pure gauge term s,

where  $0 = 4 2m_5^{p}$ . The tensor structure of the amplitude interpolates between 1=4 in the IR and

in the UV. The amplitude above corresponds to the exchange of massive spin 2 elds and a scalar obeying Eq. (24). The (DGP-like) kinetic term for the scalar is positive as long as,

In this regime we see that the localized ghost disappears and the scalar sector is composed of a healthy resonance.

In the lim it we are considering the tension required is consistent with having six non compact dimensions. Indeed, requiring that the decit angle in the bulk is less than 2 leads to  $< 2 M_6^4$ . It follows that,

which is always satised in the 5D decoupling limit and displays the necessity of the induced term on the codimension 1 brane. Moreover the condition above is

equivalent to having  $m_6 < m_5$ , which suggests that in order to avoid the ghost one should cascade from the highest dimension down to 4D 'step by step'.

From a phenom enological point of view, observations require that m  $_5$ . H  $_0$ , the present Hubble scale. The most interesting possibility is when the 6D crossover scale is larger but of sim ilar order. A ssum ing that the form ulas above can be extrapolated in this regime for a P lanckian M  $_4$  this implies that M  $_5$  is of order 10M eV and M  $_6$  meV. The latter also sets the scale of .

## IV . D ISC U SS IO N

In this note we have presented a six dimensionalDGP modelwith cascading localized kinetic terms. The model interpolates between a 6D behavior at large distances and a 4D one at short distances with an intermediate 5D regime. The kinetic terms regularize the divergent codimension 2 behavior. The model is ghost-free at least for a certain range of parameters if on the codimension 2 brane there is a large enough tension.

We have left several questions for future study. At linear-level the tensor structure of the graviton propagator is inconsistent with observations. In the context of DGP this was shown not to be a problem because the non-linearities restore the correct tensor structure [9]. A hint of a similar phenomenon in the present model is given by the longitudinal terms of the graviton propagator (6). These are singular when the mass parameters m 5;6 vanish and give large contributions to nonlinear diagram s. In fact, we expect a 'double' Vainshtein e ect. For dense enough sources, the non-linearities should rst decouple the extra 5D scalar m ode restoring 5D behavior followed by another step to 4D. Another important direction to study is cosm ology. The model has the intriguing codim ension 2 feature that tension does not curve the space. This obviously of interest for the cosm ological constant problem .
