Four Zero Neutrino Yukawa Textures in the M inim al Seesaw Fram ework

A bstract

We investigate, within the Type I seesaw fram ework, the physical in plications of zero textures in the Yukawa couplings which generate the neutrino D irac m ass matrix m_D. It is shown that four is the maximal number of texture zeroes compatible with the observed leptonic mixing and the assumption that no neutrino mass vanishes. We classify all allowed four-zero textures of m_D into two categories with three classes each. We show that the di erent classes, in general, adm it CP violation both at low and high energies. We further present the constraints obtained for low energy physics in each case. The rôle of these zero textures in establishing a connection between leptogenesis and low energy data is analysed in detail. It is shown that it is possible in all cases to completely specify the parameters relevant for leptogenesis in terms s of light neutrino masses and leptonic mixing together with the unknown heavy neutrino masses.

1 Introduction

Recent in pressive experim ental progress tow ards determ ining the masses and mixing angles of the three known light neutrinos has brought urgency to the task of unravelling the avour structure of the neutrino mass matrix m . It has been pointed out [1] that, in the case of M a prana neutrinos, it is not possible to com pletely determ ine the structure of m from feasible experiments. This is one of the motivations for introducing som e theoretical input aim ed at reducing the num ber of free param eters. O ne interesting possibility is the imposition of zeroes in the elements of m [1]. Another is to assume the vanishing of det m [2]. Several papers have analysed in detail the consequences of imposing zeroes directly in the elements of m, starting with at least two zero textures [1], [3]. Im plications of single texture zeroes were studied in detail in [4]. In fact, the existence of vanishing m ass m atrix elements m ay reject the presence of a fam ily symmetry acting in the leptonic sector [5], [6]. It is then more natural to investigate and classify the appearance of zeroes in the fundam entalm ass matrix appearing in the Lagrangian rather than in m which, at least within the seesaw fram ework, is a derived quantity. Therefore we focus our attention on the Yukawa couplings which lead to the neutrino D irac m ass matrix $m_{\rm D}$, once spontaneous sym – metry breaking occurs. One can then see how zeroes in m_D a ect m which we take to be related to m_D by the Type I seesaw relation. Throughout, by "texture" we shall refer to a con guration of $m_{\rm D}$ containing zeroes in some of its elements. In the Froggatt-Nielsen approach [7] texture zeroes correspond to extrem ely suppressed entries, which can be taken e ectively as zeroes. The stability of zeroes in neutrino massmatrices under quantum corrections in type I seesaw models has been studied in Refs. [8], [9], [10]. One also needs to be aware that renorm alisation group e ects can be quite large in the case of quasi-degenerate (inverted hierarchical) light neutrino m asses [11], [12].

In this paper we classify and analyse the physical in plications of all neutrino Yukawa coupling matrices with four zero textures in the W eak B asis (W B) where the charged lepton and the righthanded M a jorana neutrino mass matrices are diagonal and real. For simplicity, we work within the fram ework of the Type I seesaw, where three righthanded singlet neutrinos are added to the Standard M odel (SM). The case of only two righthanded heavy neutrinos leads to one zero neutrino mass and in this case only one zero textures and some of the two zero textures are allowed experimentally [13], [14]. W ith three heavy righthanded neutrinos and the additional requirement that none of the physical neutrino masses vanishes, we show that four is the maximal number of zeroes in textures of m_D that are compatible with the available data on neutrino mixing. W e organize all such four zero texture zeroes in the Y ukawa couplings has the advantage of allowing for the possibility of establishing a connection between low energy physics and physics at high energies, in particular leptogenesis [15].

It is by now established that new sources of CP violation beyond the K obayashi-

M askawam echanism of the Standard M odel (SM) are required in order to dynam ically generate the observed Baryon A symmetry of the Universe (BAU) [16], [17], [18], [19], [20], [21]. The scenario of baryogenesis through leptogenesis has been rendered especially appealing by the discovery of neutrino oscillations which provides evidence for nonvanishing neutrino m asses. In general, there is no direct connection between CP violation at low energies and that entering in leptogenesis [22], [23]. It has been shown, how ever, that such a connection arises in m odels with texture zeroes in m_D [1], [13] [24], [25]. This is a question that we analyse in the present work for each one of the classes of allowed four zero textures and we conclude that it is possible in all cases to com pletely specify the param eters relevant for leptogenesis in terms of light neutrino m asses and leptonic m ixing together with the unknown heavy neutrino m asses.

Texture zeroes are clearly not W B invariant. For de nitness we analyse the allowed four zero textures in the W B in which both the charged lepton m assmatrix and the heavy righthanded M a jorana neutrino m ass matrix are diagonal, as mentioned earlier. The question of how to recognize a avour model corresponding to a given set of texture zeroes, when written in a di erent basis, was addressed in R ef [26]. It was shown there that some sets of texture zeroes im ply the vanishing of certain CP-odd W B invariants. The relevance of CP-odd W B invariants in the analysis of texture zero ansatze is due to the fact that texture zeroes lead in general to a decrease in the num ber of CP violating phases.

This paper is organised as follows. In section 2 we set the notation and present our fram ework. We show in section 3, based on what is already known experimentally about leptonic mixing and on the condition that no neutrino mass vanishes, why textures with ve or more zeroes in m_D are ruled out. In section 4 we enumerate the possible classes of four zero textures that are allowed and give for each one of them low energy relations leading to physical constraints. CP violation and related W B invariants for the surviving four zero textures are discussed in section 5. In section 6 we analyse the physical in plications of four zero textures both for low energies and for leptogenesis. O ur conclusions are summarised in section 7.

2 Notation and fram ework

W e work in the context of the minimal Type I seesaw with three generations of righthanded neutrinos which are singlets of SU (2). W e do not extend the Higgs sector and therefore we do not include M a jorana m ass terms for lefthanded neutrinos. A fter spontaneous symmetry breaking, the leptonic m ass terms are given by:

where n_L is a column vector with $n_L^T = ({}_L^0; ({}_R^0)^c)$, while M_R , m_D , and m_1 respectively denote the righthanded neutrino M a jorana mass matrix, the neutrino D irac mass matrix and the charged lepton mass matrix in family space. The superscript 0 signiles the fact that the corresponding elds are eigenstates of avour. The matrix M is given by:

W e assume that the scale of M_R is much higher than the electroweak scale v ' 246 G eV. U pon diagonalisation of the matrix M , we are left with D = diag(m₁; m₂; m₃, M₁; M₂; M₃), containing three light and three heavy M a jorana neutrinos. The charged current interactions can then be written as

where $_{j}$ and N $_{j}$ denote the light and the heavy neutrinos respectively and K and G are 3 x 3 blocks of a unitary 6 x 6 m atrix that diagonalises the symmetric m atrix M . The light neutrino masses and m ixing angles are obtained to an excellent approximation from :

where $m_{eff} = m_D M_R {}^{1}m_D^T$ m computed in the W B where m_1 is diagonal, and $d = diag (m_1; m_2; m_3)$. The unitary matrix U in Eq. (4) is the Pontecorvo, M aki, N akagawa and Sakata (PM N S) matrix [27] relating the mass eigenstate neutrinos $_i$ (i = 1; 2; 3) to the avour eigenstate neutrinos $_f$ (f = e; ;) by $_{f_L} = U_{fi iL}$. It coincides with K in Eq. (3) up to corrections of order v²=M², which we ignore. The Yukawa textures that we analyse are imposed in the weak basis where M_R and m_1 are real and diagonal. In this W B, all CP violating phases are contained in m_D . From Eq. (4) and the de nition of m_{eff} , one can write m_D in the Casas and Ibarra param etrisation [28]:

where D stands for M_R in the W B where it is diagonal and R is a general complex orthogonal matrix. It is clear, by construction, that mixing and CP violation at low energies are blind to the matrix R. However this last matrix is relevant for leptogenesis.

3 Inadm issibility of more than four zero textures

W e shall now demonstrate that, in the fram ework specied earlier, all ve zero textures in m $_{\rm D}$ are ruled out. Let us start with the general form

Since we are assuming that none of the neutrino masses vanishes we conclude from the de nition of m_{eff} that the determinant of m_D cannot be zero. Therefore patterns of m_D with one full row of zeroes or one full column of zeroes are ruled out, as well as patterns with zeroes distributed in a quartet, i.e. in four elements (ij), (lk), (ik), (lj) where i,jk,l can be 1, 2 or 3, with $l \in i, k \in j$. We are thus left with patterns where the zeroes are placed in such a way that invariably two rowns and two columns would have two zeroes simultaneously. Together with the requirement that there is no quartet of zeroes this leads to several dierent possibilities where, in each case, one nonzero entry of m_D is in a row and a column where all other entries are zeroes. Som e examples are

Since we work in a W B where M_R is diagonal the resulting matrix m_{eff} , for the ve zero textures under discussion, is always block diagonal. Furtherm ore, the fact that we are in a W B where the charged lepton mass matrix is also diagonal, in plies that these textures lead to two-fam ily mixing only, which is already ruled out experimentally. Indeed, it is already known that there are two large mixing angles in the PM NS matrix and as a result all ve zero textures are ruled out.

4 Four zero textures

In this section, we classify all di erent possible four zero textures for m_D in a W B where M_R and m_1 are real and diagonal with no vanishing neutrino mass. Among patterns of four zero textures in m_D , the nonvanishing det m_D condition rules out the occurrence of three of the zeroes in the same row or in the same column, as well as zeroes distributed in a quartet, as explained in the previous section. B lock diagonal patterns such as

lead to two-fam ily m ixing only and are therefore ruled out.

The allowed remaining patterns can be split into two categories:

(i) those with two orthogonal rows;

(ii) those with two orthogonal columns and no pairs of orthogonal rows;

The rst category can be divided into three classes corresponding to:

(i)(a) orthogonality of the rst and second rows, leading to:

There are eighteen di erent cases in (i)(a). Six of them have two zeroes in the rst row and two zeroes in the second row, as for example:

A nother six di erent cases have two zeroes in the rst row, one zero in the second row and one zero in the third row as in:

F inally, six di erent cases are obtained with one zero in the rst row, two zeroes in the second row and one zero in the third row as in:

There are another eighteen di erent cases in (i)(b). These are obtained from those in (i)(a) exchanging the second with the third row. The cases in (i)(c) are also eighteen di erent ones obtained from those in (i)(a) by exchanging the rst row with the third one. Each case in category (i) has one symmetric pair of nondiagonal zero entries in m_{eff} . Since m_{eff} is symmetric by construction, due to its M a prana character, o diagonal zeroes always com e in pairs.

Textures in category (ii) are obtained by transposing those in category (i) and discarding those already considered in (i). There are eighteen cases altogether in category (ii). In all of these, two columns are orthogonal to each other, each having two zeroes, and there is one column without zeroes. This category can again be divided into three classes:

(ii)(a) six cases with two zeroes in the rst row, these cases are given explicitly by:.

These verify the conditions:

Note that arg(m $_{ii}$ m $_{jk}$ m $_{ij}$ m $_{ik}$) is rephasing invariant. In Ref. [26] one example of this class was discussed.

(ii)(b) six cases with two zeroes in the second row, which are obtained from the patterns in (ii)(a) by interchanging the rst with the second row. These verify the conditions:

(ii)(c) six cases with two zeroes in the third row, which are obtained from the patterns in (ii)(a) by interchanging the rst with the third row. These verify the conditions:

with i; j;k di erent from each other and no sum im plied.

It can be checked that all allowed cases in category (i) as well as in category (ii) contain the same number of independent parameters in m_D and in all such cases one can rephase away three of the phases. The counting of independent parameters in m_{eff} is also the same in all cases, as will be seen in the next section. Moreover, we shall analyse in section 6 the implications of Eqs. (9), (10), (11), (16), (17), (18) corresponding to the two categories, each one with three di erent classes.

Notice that, although we are considering weak bases with the maximum number of zeroes allowed by experiment, together with the assumption that no neutrino mass vanishes, the resulting matrix m_{eff} contains at most one zero nondiagonal entry.

W e are not considering here the possibility of ne-tuning between the parameters of m_D and those of M_R leading to additional zeroes due to special cancellations. This indicates that in posing texture zeros in the W B where m_1 and M_R are diagonal does not allow to generate any of the two zero patterns considered in R ef. [1]. It is already known that not all of these patterns can realised through seesaw [29], [30]

5 CPV iolation and Weak Basis Invariants

W e start by recalling the general counting of the num ber of param eters contained in the lepton m assm atrices and then consider the special case of textures with four zeros in m $_{\rm D}$. In the W B where M $_{\rm R}$ and m $_{\rm 1}$ are diagonal and real, leptonic m ixing and CP violation are encoded in m_D , which is an arbitrary complex 3 3 m atrix. The latter contains nine real moduli and nine phases. Of these, only six phases are physical, since three phases can be rem oved by simultaneous rephasing of $_{\rm L}$, $1_{\rm L}$. So m $_{\rm D}$ is left with nine realm oduli plus six phases. Taking into account the three eigenvalues of M_R, we have in this W B a total of eighteen parameters including six phases. This equals the num ber of physical parameters to wit, three light neutrino m asses, three heavy neutrinom asses, plus six m ixing angles and six CP violating phases in the rst $6 \operatorname{com} p$ lex unitary m atrix $\beta 1$] which we have denoted as K and G three row s of a 6 in Eq. (3). It is interesting to notice that the num ber of independent physical phases in Eq. (5) is also six, three in the PMNS matrix and three required to parametrise the orthogonal com plex m atrix R .

Textures with four zeros in m_D lead to a strong reduction in the number of param eters, since there are only ve real param eters and two phases after rephasing. This gives rise to interesting phenom enological in plications which are analysed in detail in the next section. In particular, it will be shown that in all four zero textures classi ed by us, the matrix R, which plays an important rôle in leptogenesis, can be fully expressed in terms of low energy param eters entering in U and d. This establishes a direct connection between leptogenesis and low energy data. M oreover, this link exists both in the cases of un avoured and avoured leptogenesis.

In scenarios where avour does not play an important rôle, the lepton number asymmetry resulting from the decay of the N $_{\rm j}$ heavy M a jorana neutrino is given by [32]:

In Eq. (20) M $_k$ are the heavy neutrino m assess and we have neglected terms of order $v^2=M_k^2$. The variable x_k is defined as $x_k = M_k^2=M_j^2$ and the function $I(x_k)$ is given by

 $I(x_k) = \frac{p_{x_k}}{x_k}(1 + (1 + x_k)(\log x_k \log(1 + x_k)))$. Eq. (20) has been obtained after sum ming over all charged leptons l_i (i = e, ,). From the Casas and Ibarra parametrisation we obtain:

In this fram ework, leptogenesis is insensitive to the low energy CP violating phases appearing in U and can occur even w ithout CP violation at low energies [23]. A ctually, leptogenesis depends on other param eters beyond " $_{N_j}$ and involves therm odynam ic processes that have been analysed by several authors [33], [34] [35], [36]. It was pointed out recently that, under certain conditions, avour matters in leptogenesis [37], [38], [39], [40], [41], [42]. In this case we must take into account the separate lepton i fam ily asymmetry generated from the decay of the kth heavy M a prana neutrino which depends on the combinations [38] Im $(m_D^{Y} m_D)_{kk^0} (m_D)_{ik} (m_D)_{ik^0}$ and Im $(m_D^{Y} m_D)_{kk^0} (m_D)_{ik} (m_D)_{ik^0}$ C learly, when one works with separate avours, the matrix U does not cancel out and one is led to the interesting possibility of having viable leptogenesis even in the case of R being a realmatrix [43], [44], [45], [46].

Next, we show explicitly that four zero textures lead in general to CP violation both at low and high energies. The strength of leptonic CP violation of D irac-type, which can be observable through neutrino oscillations, is controlled by the W B CP-odd invariant [47]

where $h_{eff} = m_{eff} m_{eff}^{y}$, $h_1 = m_1 m_1^{y}$ and $= (m^2 m_e^2)(m^2 m_e^2)(m^2 m_e^2)$. In order to show that this CP-odd invariant does not vanish, in spite of the four zeroes in m_D , we have to exam ine the structure of h_{eff} . For de niteness, let us consider the con guration 2 3

belonging to case (c), category (i). Three phases can be rephased away so that one is left with only two phases which can be placed for instance at the entries (1,1) and (1,2). From Eq. (23) and the de nition of m_{eff} one obtains the following structure for the latter:

where entries labelled with a c are complex and those labelled with an r are real. W ith these choices there are two complex entries in m_{eff} . From this equation we obtain:

O ne may note that each one of the three terms contributing to I_{CP} is rephasing invariant. It is clear that I_{CP} does not vanish for the m_{eff} of Eq. (24).

It is well known that at low energies there are three CP violating phases in U, one of the D irac type and two of the M a jorana type. The question of nding the CP-odd W B invariants that would be su cient to control CP violation at low energies was rst adressed in R ef. [47], and m ore recently in R ef. [48]. In particular it was pointed out that requiring the vanishing of the W B invariant of Eq. (22) together with the two W B invariants:

provides in general, necessary and su cient conditions for low energy CP invariance [48]. The invariant of Eq. (27), was rst proposed in R ef. [49] where it was shown that it has the special feature of being sensitive to M a jorana type CP violation even in the lim it of three exactly degenerate M a jorana neutrinos. O ther relevant cases can be found in R ef. [50]. The fact that, for the four zero texture of Eq. (23), none of the three W B invariants vanishes in general, shows that this texture leads to both D irac and M a jorana-type CP violation at low energies. The sam e applies to the other four zero textures.

So far, we have only considered leptonic CP violation at low energies. Leptogenesis is a high energy phenom enon requiring CP violation. In the un avoured case the relevant phases are those in $m_D^{y}m_D$ as shown in Eq. (20). In this case one may also write a set of three independent W B invariants [22]

where $h_D = m_D {}^{Y}m_D$ and $H = M_R {}^{Y}M_R$. These three would have to vanish if CP were to be conserved. The condition for the vanishing of I_4 was rst given in Ref. [51]. The evaluation of these invariants, in the W B with diagonal M_R , shows that, in the case of a nondegenerate D and assuming no cancellations, they can all simultaneously vanish only if all in aginary parts of $(h_{D \ ij})^2$ are absent. Now it turns out that textures of category (ii) always have one zero o -diagonal entry in h_D due to the orthogonality of two columns of m_D , but the other two o -diagonal elements are in general nonzero. The same goes for those textures in category (i) that also have two orthogonal columns. The remaining textures in category (i) have, in general, three nonzero com plex $h_{D \ ij}$ but their phases are constrained to be cyclic, i.e., Im $(h_{D \ 12}h_{D \ 31}h_{D \ 23}) = 0$. The fact that not all in aginary parts of $(h_{D \ ij})^2$ vanish simultaneously in any of the four zero textures, shows that they adm it CP violation at high energies, relevant for leptogenesis.

6 Implications from models with four zero textures

6.1 Low energy physics

Let us start by summarising what is presently known about neutrino masses and leptonic mixing. We choose to parametrise the PMNS mixing matrix as [52]:

where c_{ij} cos $_{ij}$; s_{ij} sin $_{ij}$, with all $_{ij}$ in the rst quadrant, being a Diractype phase and P = diag (1; e^i ; e^i) with and denoting the phases associated with the M a prana character of neutrinos.

The current experim ental bounds on neutrino masses and leptonic mixing are [52]:

with m $_{ij}^2$ m $_j^2$ m $_i^2$. The allowed ranges for the parameters listed above correspond to an impressive degree of precision. The angle $_{23}$ may be maximal (i.e., =4). In contrast, maximalmixing for $_{12}$ is already ruled out experimentally. At the moment there is only an experimental upper bound on the angle $_{13}$. A value of $_{13}$ close to the present bound would be good news for the prospects of detecting low energy leptonic CP violation, mediated through a Dirac-type phase. The strength of the latter is given by:

which would in this case be of order 10 2 , for sin of order one. A similar quantity de ned in terms of the elements of the Cabibbo K obayashiM askawa matrix is mean-ingful in the quark sector [53] [54], and the corresponding value is of the order of 10 5 . It is not yet known whether the ordering of the light neutrino masses is normal, i.e. $m_1 < m_2 < m_3$, or inverted, i.e. $m_3 < m_1 < m_2$. The scale of the neutrino masses is not yet established. The spectrum may vary from a large hierarchy between the two lightest neutrino masses to three quasi-degenerate masses. Examples of the possible extrem e cases are:

corresponding to norm al spectrum, hierarchical, or else:

(b) $m_3 = 0$ (oreg. 10^6eV); $m_1 ' m_2 ' 0.05 \text{eV}$

corresponding to inverted spectrum , hierarchical, or else:

(c) m_1 ' leV; m_2 ' leV; m_3 ' leV

corresponding to alm ost degeneracy.

As explained below, the conditions obtained in section 4, are not all compatible with each of these scenarios. Finally, we note that it is not yet established whether or not neutrinos are M a prana particles and therefore at the moment there are no restrictions on the M a prana phases ,

The low energy in plications of patterns in category (i) which, as was already pointed out lead to one o diagonal set of zeroes in the symmetric matrix m_{eff} were studied in detail in R ef [4]. Them ain conclusions in this paper are that no o -diagonal entry in m_{eff} can vanish in the case of ₁₃ equal to zero. Implications of one zero in the rst row of m_{eff} do not di er much in the two possible such cases due to the approximate exchange symmetry [55], [56], [57]. In this case all values of m₁ are allowed from extrem e hierarchy to alm ost degeneracy; so are both possible orderings of neutrino masses. For (m_{eff})₂₃ = (m_{eff})₃₂ = 0 both norm al hierarchy and inverted hierarchy are excluded.

Let us consider category (ii) which implies the constraints of Eq. (19). Taking into account Eq. (4) this equation can be written as:

with i, j, k di erent from each other and no sum implied, and the indices r, s ranging from 1 to 3.

W ith the explicit parametrisation of Eq.(31) we obtain simple exact analytic relations for each of the classes in category (ii).

For class (ii) (a) the exact form of this constraint is:

An interesting feature of this expression is the fact that all terms sensitive to D irac type CP violation are doubly suppressed since they are multiplied, either by s_{13}^2 or by the factor (c_{23}^2 s_{23}^2) s_{13} , and it is already known experimentally that $_{13}$ corresponds to smallor nomixing and $_{23}$ is maximalor close to maximal. Therefore, this expression can be very well approximated by:

This equation can be obtained from the previous one by interchanging s_{23} with c_{23} and by changing the sign of the term s that do not depend on the D irac phase.

It is clear from these expressions that the main features of low energy physics coming out of these textures do not crucially depend on the possible existence of CP violation. In order to get a feeling of the main features of the implications of the constraints given by Eqs. (39), (41) and (42), let us take as a rst approximation the Harrison, Perkins and Scott (HPS) mixing matrix [58]

which is consistent with present experimental data, and corresponds to $_{23}$ maximal, $_{13}$ zero and $c_{12} = 2 = 6$ and no CP violation. Obviously, a detailed analysis would require the variation of $_{13}$, as well as of $_{12}$ and $_{23}$, inside their allowed ranges and also to take into consideration the possibility of CP violation.

Eqs. (39) and (43) lead to

and, as already explained, Eq. (44) corresponds to ignoring terms with a double suppression. In the CP conserving limit, light neutrinosm ay have dierent CP parities [59], therefore there are several possible ways of obtaining the necessary cancellations. Norm alordering with strong hierarchy is ruled out since form $_1 m_2$ there would be only one dom inant term, the one in m $_2m_3$. Hierarchy in the masses in plies that the magnitude of term in m $_2m_3$ is close to 7 10^{5}eV^2 . The strongest allowed hierarchy consistent with the above constraint favours the larger $_{13}$ values; a num erical example obtained for maximal $_{23}$ and the central value of $_{12}$, with cancellations already of order 10 $^{10} \text{eV}^2$ is:

O by iously the num ber of signi cant digits in the above num erical result is meaningless from the experimental point of view and is only given to be consistent with the degree of cancellation claim ed above. Here m₂ is no more than a factor of three higher than m₁, which corresponds to a weak norm al hierarchy. As m₁ decreases, cancellations cease to occur and the di erence tends to the value of the dom inant term which is the term in m₂m₃. The situation would change for larger values of ₁₃ which are already ruled out. Likewise for instance, for a sm all solar angle, (₁₂), already excluded, as was pointed out in [25], where a particular exam ple of a texture of this class was considered, since in this case the term in m₂m₃ present in Eq. (40) would be suppressed by s²₁₂. Strong inverse hierarchy is also ruled out since it would leave the dom inant term in m₁m₂ without the possibility of cancellation. Quasi-degeneracy can be accomm odated within the present range of experim ental values for the m ixing angles.

C ase (b) in category (ii) obeys the constraint of Eq. (41). The coe cient of m $_1$ m $_2$ is zero for the HPS matrix and in this case we are left with

For nonzero $_{13}$ the term in m $_1$ m $_2$ is suppressed but cannot be discarded for m $_3$ m $_1$; m $_2$, i.e., inverse hierarchy. In the case of inverse hierarchy the necessary cancellation of the three term s m ay occur. A lm ost degeneracy can also be accom m odated provided $_{13}$ is dimensional from zero. For $_{13} = 0$ the coe cient of m $_1$ m $_3$ would be exactly equal to the coe cient of m $_2$ m $_3$ and this relation could not be verified, since it would im ply m $_1 = m_2$.

Case (c) in category (ii) is very similar to case (b). The resulting equation for the HPS matrix coincides with Eq. (45) and the conclusions are the same as in case (b), category (ii).

A ll cases in category (ii) are thus incom patible with a strong hierarchy and norm al ordering, i.e. for $m_1 = m_2$.

6.2 Relating leptogenesis to low energy physics

Zero textures in m_D allow one to relate the matrix R, relevant to leptogenesis, to the light neutrino masses and low energy leptonic mixing. In fact, it is clear from Eq. (5) that each zero in m_D leads to an orthogonality condition between one column of the matrix R and one row of the matrix U⁻ d of the form :

It was already pointed out [26] that the connection between leptogenesis and low energy physics could be easily established in a particular case that falls into category (ii), since in this case one can fully express the matrix R in terms of light neutrino m asses and low energy leptonic m ixing. The same is true for all other cases in category (ii) as well as for the cases that fall into category (i) as shown below. The example given in R ef. [26] can be generalised in the following way.

In category (i) there is always in m_D one colum n with two zeros and two colum ns with one zero each. Let l be the colum n with two zeros and a and b the colum ns with one zero only. In this case we can write

where p and q are the rows with zeros in the colum n l. M oreover, r and s are the rows where the zeros are in colum ns a and b respectively. The \tilde{R}_i are the colum ns of the matrix R and the N_i are complex normalization factors, with phases such that $\tilde{R}_i^2 = 1$. It is easy to show that the colum ns \tilde{R}_a and \tilde{R}_b are indeed orthogonal to each other by using the constraint m_{effrs} = 0 valid for each case in category (i).

In Ref. [25] the relation between leptogenesis and CP violation at low energies in two cases falling into category (i), were analysed in detail in the case of hierarchical heavy M a jorana neutrinos and also in the case of two fold quasi-degeneracy of the heavy neutrinos.

In category (ii) there is in m_D always one column without zeros and each of the other two columns has two zeros. Now let l be the column without zeros and a and b the columns with two zeros. In this case we can write:

Here p and q are the rows with zeros in colum n a. Furtherm ore, r and s are the rows with zeros in colum n b, while N_i denote norm alization factors. It is easy to show that \tilde{K}_a and \tilde{K}_b are indeed orthogonal to each other for each case in category (ii) by using Eq. (19).

All four zero textures analysed in this paper allow one to completely specify the matrix R, in terms of light neutrino masses and the elements of the PMNS matrix. It is clear that R can only be complex if there is CP violation at low energies.

7 Summary and Conclusions

We have made a systematic study of all allowed four zero textures in the neutrino D irac mass matrix m_D, in the fram ework of Type I seesaw mechanism, without vanishing neutrino masses. In order for this study to be meaningful, one has to choose a speci c weak basis (W B). Without loss of generality, we have chosen to work in the W B where the charged lepton and the righthanded neutrino mass matrices are both diagonal, real. A sum ing that no neutrino mass vanishes and taking into account the experimental evidence that no leptonic family decouples from the other two, we have shown that four is the maximal number of zeros allowed in m_D. We have found the follow ing remarkable result: the allowed four zero textures in the neutrino Yukawa coupling matrices automatically lead to one of two patterns in m. Either the latter has only one pair of symmetic o -diagonal zeros or else it has no zero element but a vanishing subdeterm inant condition. In the derivation of this result, we have im plicitly assumed the absence of any ne-tuning between the parameters of m_D and those of M_R which would lead to special cancellations.

Our analysis also applies to scenarios where instead of zeroes, one has a set of extrem ely suppressed entries [60], as one often encounters in the Froggatt-Nielsen approach. Of course, renorm alisation group e ects, especially for quasi-degenerate and inverted hierarchical neutrinos [12] will change at least som e of the zeroes in m_D into sm all entries.

We have also explored the phenom enological consequences of the above mentioned textures. In particular we have shown that they lead to a close connection between leptogenesis and low energy measurables such as neutrino masses and mixing angles. The establishment of such a connection in the leptonic sector between physics at low and very high energies is an important goal and provides an additional motivation for considering texture zeroes in the leptonic sector.
