# Hadronic dissipative e ects on transverse dynamics at R H IC

A bstract. We simulate the dynamics of Au+Au collisions at the Relativistic Heavy Ion Collider (RHIC) with a hybrid model that treats the quark-gluon plasma m acroscopically as an ideal uid, but models the hadron resonance gas m icroscopically using a hadronic cascade. We nd that much of the mass-ordering pattern for  $v_2$  ( $p_T$ ) observed at RHIC is generated during the hadronic stage due to build-up of additional radial ow. We also nd that the mass-ordering pattern is violated for meson due to small interaction cross section in the hadron resonance gas.

#### 1. Introduction

W hether the quark-gluon plasm a (QGP) behaves like a \perfect liquid" is one of the important question in heavy ion collisions at the R elativistic H eavy Ion Collider (RHIC) [1, 2, 3, 4]. The observed elliptic ow parameter  $v_2$  and its transverse momentum dependence agree wellw ith predictions from ideal uid dynam ics assuming zero viscosity [5, 6]. The ideal uid dynamical description, how ever, gradually breaks down as one studies peripheral collisions or moves away from m idrapidity [5, 6]. This requires a more realistic treatment of the early and late stages in dynamical modeling of relativistic heavy ion collisions. In previous work [7, 8] we have shown that a large fraction of these deviations from ideal hydrodynam ics is due to \late viscosity". Here we report additional results from the hybrid model study focusing our attention on a detailed investigation of dissipative e ects during the late hadronic rescattering stage.

## 2.M odel

For the space-time evolution of the perfect Q G P uid we solve numerically the equations of motion of ideal uid dynamics for a given initial state in three spatial dimensions

and in time [9, 10]. For the high temperature (T >  $T_c = 170 \text{ MeV}$ ) QGP phase we use the equation of state of massless parton gas (u, d, s quarks and gluons) with a bag pressure B. We switch from ideal hydrodynamics to a hadronic cascade model at the switching temperature  $T_{sw} = 169 \text{ MeV}$ . The subsequent hadronic rescattering cascade is modeled by JAM [11], initialized with hadrons distributed according to the hydrodynamic m odel output, calculated with the C ooper-Frye form ula [12] along the  $T_{sw} = 169 \text{ MeV}$  hypersurface. JAM implements experimental hadronic scattering cross section data where available and uses the additive quark model where data do not exist, assuming the follow ing form ula for the total cross section [11, 13, 14, 15]:

Here  $_{NN}^{tot}$  is the total nucleon-nucleon cross section,  $n_i$  is the number of constituent quarks in a hadron and  $n_{si}$  is the number of strange quarks in a hadron. For hadrons composed entirely of strange quarks, such as = (ss) and = (sss), the cross sections become very small due to the suppression factors in brackets in Eq. (1). We note that, to study mesons in our hybrid model, we stabilize them by turning o their decay channels during the hadronic cascade. For initial conditions in hydrodynam ic equations, we employ the G lauber model suitably generalized to account for the longitudinal structure of particle multiplicity [7, 16].

In Fig. 1 (left), we compare  $v_2(p_T)$  for pions, kaons and protons from the hybrid m odelw ith the STAR data [17]. We reasonably reproduce mass-splitting behaviour seen in the data. We note that we also reproduce the data in other centralities (not shown) except for very central collisions due to absence of eccentricity uctuation [18]. Figure 1 (right) shows how mass-splitting of  $v_2 \, (p_T)$  is generated during evolution by switching o hadronic rescatterings in a hadronic cascade. Slope of pion  $v_2 \, (p_T)$  becomes steeper due to additional development of elliptic ow and reduction of mean  $p_T$  [19]. For heavy hadrons, on the other hand, radial ow reduces  $v_2$  at low  $p_T$  [20]. Assuming positive elliptic ow ,  $v_2$  ('=0; ) >  $v_2$  '= $\frac{1}{2};\frac{3}{2}$ , the stronger transverse ow  $v_2$  in the reaction plane pushes heavy particles to larger  $p_T$  more e ciently in the reaction plane than perpendicular to it. The generation of additional radial ow in the hadronic stage is responsible for the mass-splitting of  $v_2 \, (p_T)$  observed in the low  $p_T$  region. From these observations we conclude that the large magnitude of the integrated  $v_2$  and the strong mass ordering of  $v_2 \, (p_T)$  observed at R H IC result from a subtle interplay between perfect uid dynam ics of the early QGP stage and dissipative dynam ics of the late hadronic stage.

mesons have considerably smaller scattering cross sections than non-strange hadrons [21]. They are therefore expected to show larger dissipative e ects in our hybrid model and not to fully participate in the additional radial ow generated during the hadronic rescattering stage. Figure 2 shows  $v_2(p_T)$  from the hybrid model (left) and the ideal hydrodynamics (right) for , p and . As a result of rescattering the proton elliptic ow ends up being smaller than that of the meson,  $v_2^p(p_T) < v_2(p_T)$  for  $0 < p_T < 1.2 \text{ GeV}/c$ , even though m  $> m_p$ . The large cross section di erence between the protons and mesons in the hadronic rescattering phase leads to a violation of the hydrodynam ic mass ordering at low  $p_T$  in the nal state.

# 4. Sum m ary

We have studied e ects of hadronic dissipation on dierential elliptic ow in Au + Au collisions at RHIC, using a hybrid model which treats the early QGP phase

m acroscopically as a perfect uid and the late hadronic phase m icroscopically with a hadronic cascade. The well-known m ass-splitting of the di erential elliptic ow observed in hydrodynam icm odels is seen to be mostly generated during the hadronic rescattering phase and to be largely due to a redistribution of the momentum anisotropy built up during the QGP stage. This redistribution is caused by the mass-dependent attening of the transverse momentum spectra by additional radial ow generated during the hadronic stage. The much more weakly interacting m esons do not participate in this additional radial ow and thus are not a ected by this redistribution of momentum anisotropies: their di erential elliptic ow remains almost una ected by hadronic rescattering. The net result of dissipative hadronic rescattering is therefore that the di erential elliptic ow of protons drops below that of the mesons, in violation of the hydrodynam ic m ass-ordering.
