#### The impact of cosm ic neutrinos on the gravitational-wave background

We obtain the equation governing the evolution of the cosm ological gravitational-wave background, accounting for the presence of cosm ic neutrinos, up to second order in perturbation theory. In particular, we focus on the epoch during radiation dom inance, after neutrino decoupling, when neutrinos yield a relevant contribution to the total energy density and behave as collisionless ultrarelativistic particles. Besides recovering the standard dam ping e ect due to neutrinos, a new source term for gravitational waves is shown to arise from the neutrino anisotropic stress tensor. The importance of such a source term, so far com pletely disregarded in the literature, is related to the high velocity dispersion of neutrinos in the considered epoch; its com putation requires solving the full second-order Boltzm ann equation for collisionless neutrinos.

#### I. IN TRODUCTION

A n important discrim inator among di erentmodels for the generation of the primordial density perturbations is the level of the gravitational-wave background predicted by these models. For example, within the in ationary scenario the tensor (gravitational-wave) amplitude generated by tiny initial quantum uctuations during the accelerated in ationary expansion of the universe depends on the energy scale at which this in ationary period took place, and it can widely vary among di erent in ationary models [1, 2]. On the other hand, some alternative scenarios, such as the curvaton model, typically predict an amplitude of primordial tensor modes that is far too small to be everdetectable by future satellite experiments aim ed at observing the B-m ode of the Cosm ic M icrowave Background polarization.

There is however another background of stochastic gravitational waves of cosm ological origin. G ravitational waves (as well as vector modes) are inevitably generated at second order in perturbation theory by scalar density perturbations [3, 4, 5, 6, 7]. This is due to the fact that the non-linear evolution always involves quadratic source terms for tensor (and vector) perturbation modes made of linear scalar (density) perturbations.

Since the level of density perturbations is well determ ined by CMB anisotropy measurements and largescale structure observation [8, 9], we know that these secondary vector and tensor modes (produced after the prim ordial curvature perturbations have been generated) must exist and their am plitude must have a one-to-one relation with the level of density perturbations. In this sense, the scalar-induced contribution can be computed directly from the observed density perturbations and general relativity, and is independent of the speci c cosm ologicalm odel for generating the perturbations.<sup>1</sup>

Such a background of gravitational waves could be interesting in relation to future high-sensitivity CMB polarization experiments or for small-scale direct detectors, such as the space-based laser interferom eter B ig Bang O bserver (BBO) and the D eci-hertz Interferom eterG ravitational W ave O bservatory (DECIGO) operating in the frequency range 0:1 { 1H z [11] with an improved sensitivity (in term softhe closure energy density of gravitational waves,  $_{\rm GW}$  10  $^{17}$  10  $^{15}$ ). In particular, in R ef. [12] the e ects of secondary tensor and vector m odes on the large scale CMB polarization have been computed, show – ing that they dom inate over the prim ordial gravity-wave background if the tensor-to-scalar perturbation ratio on large scales is r < 10  $^{6}$ . M ore recently, R ef. [13] com –

puted the power-spectrum of the secondary tensors accounting for their evolution during the radiation dom inated epoch, to see their e ects on the scales relevant for sm all-scale direct detectors, and R ef. [14] extended this analysis by accounting for a more detailed study of the transfer function for the secondary tensor modes.

In this paper we consistently account for the presence of cosm ic neutrinos to analyze their in pact on the evolution of the second-order gravitational-wave background. At linear order it has been shown that there is a dam ping e ect due to the anisotropic stress of free-stream ing neutrinos that strongly a ects the prim ordial gravitationalwave background on those wavelengths which enter the horizon during the radiation dom inated epoch (at the levelof30%) [15,16,17,18,19,20,21] (see also R ef. [22]). At second order, along with the analogous dam ping effect, we nd that free-stream ing neutrinos are an im portant source for the second-order gravitational-wave background during the radiation-dom inated epoch. We nd com pletely new source term s, arising because of the fact that neutrinos give a relevant contribution to the total energy density during this epoch and they behave as ultrarelativistic collisionless particles after their decoupling: their high velocity dispersion acts as an extra source for the second-order gravitational waves. To compute such a contribution we evaluate the second-order tensor part of the neutrinos' an isotropic stress tensor, that has been neglected so far. This is achieved by com puting and solving the Boltzm ann equation for neutrinos. Approximating the neutrino contribution as a perfect uid of relativistic particles during the radiation era leads to a serious underestim ate of their role. Let us stress that the new contribution is at least of the same order of magnitude as that computed by adopting a uid treatment in the source of the scalar-induced gravitational waves. M oreover it has a clear physical interpretation. It arises in the Boltzmann equation from a \lensing" e ect of the neutrinos as they travel through the inhom ogeneities of the gravitational potential.

The paper is organized as follows. In Secs. IIA and IIB we derive the evolution equation for the tensor (gravitational-wave modes) at second order, accounting for photons and neutrinos. In Sec. IIIA we present the Boltzm ann equation for neutrinos approxim ated as being collisionless massless particles (see Appendix A, B and C for details about the Boltzm ann equation for massive neutrinos) and give an integral solution for it. Sec. IIIC contains the computation needed to determ ine the tensor part of the second-order an isotropic stress tensor of neutrinos, which leads to one of our main results, Eq. (52). Finally, in Sec. IV we derive the photon contribution, consistently accounting for the presence of neutrinos, which leads also to a new source of gravitational waves. In Sec.V we present the sum mary and our main conclusions.

## II. SECOND-ORDER GRAVITATIONAL WAVES

#### A. M etric perturbations in the Poisson gauge

The second-order metric perturbations around a at Friedmann-Robertson-Walker (FRW) background can be described by the line-element in the Poisson gauge

In this gauge one scalar degree of freedom is eliminated from  $g_{0\,i}$  and one scalar and two vector degrees of freedom are removed from  $g_{i\,j}$ . As usual a( ) is the scale factor and  $\,$  is the conform altim e. The functions  $\,$  and  $\,$ 

are scalar functions which correspond to the New tonian potential and to the spatial curvature perturbations, respectively. W ithin second-order perturbation theory, they consist in the sum of a linear and a second-order term, such that and can be written as

Since the choice of the exponentials greatly helps in sim – plifying the computation of many expressions, they will be kept where it is convenient. It is worth remarking here that all the equations in the following where the exponential show up are meant to be second order equations, therefore the exponentials are to be thought as im plicitly truncated up to second order in all these expressions e.g.  $e^2 - (1 + 2)^{(1)} + (2)^2 + 2(-(1))^2$ .

The remaining functions that appear in Eq. (1) account for second-order vector (! i) and tensor ( ii) modes. Tensor perturbations are traceless and transverse:  $\frac{1}{1} = 0$ ,  $Q_i^{ij} = 0$  and vectors have vanishing spatial divergence:  $Q^{i}!_{i} = 0$ . Linear vector modes have been neglected as they are not produced by standard mechanisms, such as in ation, that generate cosm obgical perturbations [23], [24]. As discussed, for example in Refs. [23] and [24], indeed linear vectorm odes have decreasing am plitudes and they are not generated in the presence of scalar elds, while the rst-order tensor part gives a negligible contribution to second-order perturbations. Second-order vector and tensor modes how ever must be taken into account, even if they were initially zero. This is because scalar, vector and tensor modes are dynamically coupled at this stage and second-order vectors and tensors are generated by rst-order scalar mode-mode coupling. First-order perturbations behave as a source for the intrinsically second-order uctuations [5].

Since our main task is to provide the second-order E instein's equations that describe the evolution of tensor modes, we are interested in the spatial components of both the E instein and the energy-momentum tensors. Here we nd that, using the C hristo elsymbols obtained in Appendix A and accounting only for the term s up to second order, the spatial E instein tensor reads

where  $H = a^{0}=a$ , and a prime denotes di erentiation w.r.t. conform altime.

## B. Second-order gravitational-wave evolution equation during the radiation-dom inated era

In Fourier space the equation which describes the evolution of second-order gravitational waves (GW ) can be put in the form :

where the subscript refers to the two possible polarization states of a gravitational wave. Each mode  $_k$  is in fact transverse with respect to the direction along which it propagates and, for a mode traveling in the z direction,  $_{ij}$  can be written as:

The two degrees of freedom account for the two polarization states  $_{\scriptscriptstyle +}$  and  ${\scriptstyle \cdot}$ 

The source term  $S_k$ ; for GW in the radiation era consists in the sum of three di erent parts:  $E_k$ ; that comes from the Einstein tensor,  $\binom{()}{k}$  that comes from the neutrino anisotropic stress tensor term and  $\binom{()}{k}$  that accounts for the photon contribution. We then have:

In making the source term  $S_k$ ; explicit, the rst step is to extract the tensor part of the E instein and energymom entum tensors to get the corresponding transverse traceless component.

This can be done by making use of the projection op-

The explicit form for the product  $"_i^{j+} k_{1\,j} k_2^i$  is given by the analogous of eq. (36).

The next sections are devoted to the computation of the neutrino source term  $\binom{(\ )}{k_i}$ , since the term due to the photons is already known and we will recall it later. Notice how ever that Sec. IV presents a non trivial case accounting for both neutrinos and photons: here in fact the contribution of the rst-order collision less neutrinos is fully accounted for the rst time when explicitly calculating the second-order photon quadrupole in the tight coupled lim it (Eq. 59).

W e will proceed by steps. First we solve the secondorder Boltzm ann equation for the neutrinos in order to give the expression for the neutrino energy momentum tensor. Then we will give the expression for the spatial components of the energy momentum tensor of neutrinos in terms of the their distribution function perturbed up to second order, and nally we can extract the transverse and tracelees part of it.

#### III. NEUTRINOS AND SECOND-ORDER TENSOR MODES

# A . Solution of the second-order Boltzm ann equation for neutrinos

The Boltzm ann equation up to second-order for decoupled neutrinos can be written as

param etrizes the particle's path and x = (t;x) represents a space-time point. The unit vector n, with components  $n^{i}$ , represents the neutrino momentum direction and it is therefore such that: p = pn and  $n^{i}n^{j}_{ij} = 1$ . Equation (16) refers to the general case of massive neutrinos (g P P = m<sup>2</sup>).

The neutrino distribution function F at this stage will consist in an unperturbed, a rst-order and a second-order term, such that we can put it in the form

The explicit forms for the di erent contributions in Eq. (16) are listed in Appendix C.

Since we are interested in evaluating the neutrino contribution during the radiation-dom inated epoch, we can specialize the second-order Boltzm ann equation for ultrarelativistic (massless) neutrinos. Replacing E with the com oving 3-m om entum q as one of the independent variables in Eq. (16) such that p = E and q = ap, the relevant equation takes the form :

Here  $V_{II}$  accounts for the second-order vector perturbations modes, see Eq. (C17). We will keep it in this implicit form, since we already know that second-order vectors do not take part to the tensor contribution we are interested in.

# ${\rm B}$ . The second-order neutrino energy-m om entum $${\rm tensor}$$

The contribution to the energy momentum tensor of a given species  $\i"$  is

If we now want an expression for the second-order spatial component of the neutrino energy momentum tensor, we nd that it will consist of the sum of four parts. There are in fact four terms which contain the perturbations: the product of the 3-m omentum  $P^{i}P_{j}$ , the component  $P^{0}$ , the distribution function F and the determ inant of the metric (1), g. As far as the rst and the second term are concerned we must remember that

The overline refers to unperturbed quantities and we have  $\overline{q}^i = a^{-1} qn^i$ ,  $\overline{q}_i = aqn_i$  and  $\overline{q}^0 = q=a$ .

S in ilar to the linear case, vectors and tensors do not show up because of the angular integration.

#### C. The neutrino contribution to the source term .

In order to get the transverse traceless part of the neutrino energy-m om entum tensor we now have to make use of the operator de ned in Eq. (12). Before proceeding notice that we are interested only in the tensor contribution to the energy mom entum tensor. Therefore it is very useful to keep in m ind the decom position of the distibution function into its scalar, vector and tensor parts, according to the splitting of R ef. [22]. For example the tensor part is given by

This greatly helps in sim plifying all the expressions: it is telling us that the only tensor contributions to the energy momentum tensor are those that can be built out of the product of two momentum direction  $n^i$ . Looking back to Eq. (31) and Eq. (18) we see that, apart from the straightforward term depending on the gravitational waves  $_{ij}$ , there is just one term of this type, namely

Therefore, from now on we will focus just on this term in Eq. (32), and we will drop all the others since they correspond to scalar and vector modes.<sup>5</sup> It is interesting to notice that the term (34) has a clear and simple physical

interpretation. It arises in the Boltzm ann equation from a \lensing" e ect of the neutrinos as they travel through the inhom ogeneities of the gravitational potential. In the Boltzm ann equation (16) it derives from Eq. (C11), which describes how the neutrinosm om entum direction changes in tim e due to the potential wells they pass trough.

Let us now continue our computation and apply the projection operator (12) to Eq. (32), keeping only the term (34) in G $_k$ ( $^0$ ) and the \pure" tensor contribution  $T_k$ ( $^0$ ). We see that this operator will act on the product of the two direction unit vectors  $n^rn_s$  contained in  $T_s^{r(\ )}$ . This equation is clearly telling us that collisionless free stream ing neutrinos contribute with new terms to the source of second-order gravitational waves, with respect to the uid treatment adopted in the literature so far, where the tensor part of j at second order has never been taken into account.

Even with a qualitative approach, we can state that if low 1 contributions (up to 1 = 2) can have a correspondence with respect to a source where neutrinos and photons are treated as a single-uid radiation, higher multipoles surely do not. These in fact come from the high neutrino velocity dispersion and can be found only if neutrinos are treated as collisionless particles.

M or eover, during the radiation-dom inated epoch, the neutrino fraction f ( ) = =  $_{\rm R}$  is not negligible. Since all the terms in  ${( \ )}_{\rm k}$  are multiplied by – , they are therefore non-negligible at that time.

## IV. THE PHOTON TENSOR QUADRUPOLE

In order to complete the expression of the source term for gravitational waves during the radiation era in Eq. (4), we now have to add the photon contribution. Following [29], the second-order photon quadrupole in the tight coupling lim it is given by:

To get the photon contribution to the second-order gravitational waves source we then have to extract the transverse and traceless component.

It is worth stressing that this expression contains at most multipoles with l = 2. Therefore, if we had used a uid treatment for the neutrinos as well (e.g.  $^{ij(2)} / v^{(1)i}v^{(1)j}$ ), we would have found in the second-order neutrino contributions term swith lnothigher then l = 2. This is clearly in contrast with the neutrino source term Eq. (52).

#### V. CONCLUSIONS

This paper represents the rst step towards the quantitative evaluation of the impact of cosm ic neutrinos on the evolution of the gravitational wave background; it provides, rst of all, a complete study of the Boltzm ann equations for neutrinos at second order and the expression for the second-order anisotropic stress tensor.

Free stream ing neutrinos are an important source of second-order gravitational waves during the radiationdom inated epoch. A long with the fact that neutrinos yield a relevant contribution to the total energy during this epoch, this is due to the large neutrino velocity dispersion and it em erges from the calculations perform ed in this paper when assuming that neutrinos are collisionless particles, as it is the case after their decoupling.

The uid treatment adopted so far for describing neutrinos turns out therefore to be a poor approxim ation that leads, in particular, to underestimating the role of neutrino free-stream ing as a source of gravitational waves. In particular, in this paper we have made the rst full consistent computation of the second-order tensor part of the neutrino anisotropic stress tensor, Eq. (52). This has been achieved by computing and solving the second-order Boltzmann equation for the neutrino distribution function. Besides recovering the second-order counterpart of the dam ping e ect studied in Ref. [15, 16, 17, 18, 19, 20, 21, 22], Eq. (52) represents a completely new source term for the evolution of gravitational waves.
