C ausal relativistic hydrodynam ics for viscous uidsz

A bstract. We report on recent results from VISH 2+1, a code that solves the relativistic Israel-Stewart equations for causal viscous hydrodynam ics for heavyion collisions with longitudinal boost invariance. We nd that even \m inimal" shear viscosity = $s = \sim = (4)$ leads to a large reduction of elliptic ow compared to ideal uid dynamics. We explore system atically the sensitivity of this reduction to the equation of state, system size, initial conditions, and the microscopic relaxation time in dierent formulations of the Israel-Stewart equations.

1. Introduction

A good m otivation for studying relativistic hydrodynam ics for viscous uids in order to describe the expansion of the reballs created in relativistic heavy-ion collisions is given in Chaudhuri's plenary talk [1]. We here describe results from system atic studies done with VISH 2+1, our num erical code for solving viscous Israel-Stewart [2] hydrodynam ics for longitudinally boost-invariant system s in two transverse space dim ensions. We will concentrate on the most important results and refer the reader to the original publications $[3, 4, 5, 6]$ for details. We include only the eects of shear viscosity, neglecting bulk viscosity and heat conduction.

2. Israel-Stew art form alism

The Israel-Stewart form alism [2] resolves problem s of acausality and numerical instbility of the relativistic Navier-Stokes equation by allowing the shear viscous pressure com ponents of the energy m om entum tensor to evolve dynam ically, on a short m icroscopic time scale , towards their N avier-Stokes lim it. D i erent form s of the equations governing the evolution of are being discussed in the literature (see references in $[1, 6]$). A lihough they all converge to the same N avier-Stokes lim it ! 0, their results disagree for nite (which is necessary for stable num erical as in plem entation) $[1, 4, 5, 6, 7]$. Recent work [6] has shown that the weakest sensitivity of physical observables to the "requlator" is obtained by employing the so-called "full" Israel-Stew art equations used in [6,7,8] w hereas "sin pli ed" versions advocated in $[2, 3]$ that are obtained by dropping certain terms in the "full" equations and were used in [1, 4, 5, 9] give results that depend strongly on the (presently poorly constrained) value for \therefore As shown in [3] at the end of section IV, the extra term s in the "full I-S" form ulation cause a reduction of the e ective kinetic relaxation time , especially in rapidly expanding systems. This keeps the viscous pressure for

sm aller than in the "simplied I-S" form alism, holding it always close to its Navier-Stokes lim itx and thereby elim inating large excursions of that increase viscous entropy production and lead to a stronger viscous reduction of the elliptic ow as is increased [6]. The Ottinger-G mm ela fram ework used in [10] appears to give very sim ilar results as the "full I-S" onek [11].

3. Cooling rates for ideal and viscous heavy-ion reballs

In the early expansion stage of a heavy-ion collision, shear viscosity leads to a reduction of the longitudinal and an increase of the transverse pressure. The reduced longitudinal pressure decreases the work done by longitudinal expansion, thereby reducing the initial cooling rate of the reball. This leads to a som ew hat increased lifetime of the quark-gluon plasm a phase. The increased transverse pressure, on the other hand, causes larger transverse acceleration and stronger radial ow of the matter than in ideal uid dynam ics. Due to the larger transverse ow, the center of the viscous reball cools m ore quickly during the late stages than an ideal uid, thereby slightly reducing the total reball lifetime until freeze-out for central and near-central collisions (see Fig. 1). The viscous reballs created in peripheral collisions don't live long enough for this m echanism to m anifest itself; they live longer than their ideal counterparts, due to the decreased initial cooling rate arising from the sm aller longitudinal pressure $(\text{left points in Fig. 1}).$

For an equation of state $(EO S)$ with a rst-order quark-hadron phase transition, the m ixed phase m atter is free of pressure gradients and hence not accelerated. Velocity gradients in the m ixed phase generate, how ever, viscous pressure components

w hose gradients continue to accelerate the viscous
uid even w hile it passes through the m ixed phase w here the therm alpressure gradients vanish. A s a result, the viscous uid spends less tim e in the m ixed phase than the idealone.

In ideal hydrodynam ics, a rst-order phase transition w ith a m ixed phase $(M P)$ generates large velocity gradients near the $QGP-MP$ and $MPHG$ (HG = hadron gas) interfaces. In viscous
uids such gradients generate viscous pressures that act against building up large velocity gradients. In consequence, all prom inent structures in idealhydrodynam ics that arise from discontinuities in the speed of sound in ideal hydrodynam icsarewashed outby viscouse ects. Shear viscosity thuse ectively turns a rst-order phase transition into a sm ooth cross-over transition.

4. M om entum anisotropy in non-central collisions

In viscous hydrodynam ics the totalm om entum anisotropy $\mathbf{v}_p = \frac{h T^{xx} - T^{yy} i}{h T^{xx} + T^{yy} i}$ $\frac{hT}{hT} \frac{1771}{x \times x + T}$ has two contributions. T he rst arises (as in ideal
uids) from anisotropies in the collective ow velocity. The second is due to anisotropies of the viscous shear pressure tensor which contribute a m om entum anisotropy even in the local rest frame of the uid. In heavy-ion collisions, these two contributions are found to be of opposite signs: the viscous pressure e ects reduce the total om entum anisotropy. In the early stages of the expansion, the collective ow anisotropies evolve very similarly in viscous and ideal uids; however, due to the large longitudinal expansion rate $1=$, the viscous pressure eects are large at early tim es, leading to a strong reduction of the total m om entum anisotropy. At late tim es, the viscous pressure e ects are dram atically reduced, but by then their tim e-integrated e ect has led to a slower buildup of collective ow anisotropies com pared to ideal uids. So the totalm om entum anisotropy at late tim es is again much sm aller for the viscous uid, even though the negative viscous pressure contributions to this anisotropy are now alm ost neglegible. O verall, shear viscous e ects are seen to cause during allevolution stages a signi cant reduction of the m om entum anisotropy com pared to ideal uids.

5. Spectra and elliptic
ow

The larger radial ow caused by the viscous increase of the transverse pressure gradients re
ects itself through
atter transverse m om entum spectra for the nally em itted hadrons.To obtain sim ilarspectralslopesin viscousand idealhydrodynam ics thus requires a retuning of initial conditions and/or freeze-out conditions. Starting the viscous expansion later w ith lower initial energy densities works [\[9](#page-3-8)[,7\]](#page-3-6), but this neglects transverse
ow generated during the earlier pre-equilibrium stages. A consistent retuning of initial conditions that is com patible w ith dynam icalm odels for the prehydrodynam ic stage rem ains an open issue.

T he sm allerm om entum anisotropiesofviscousreballsdiscussed above m anifest them selves in a reduction of the elliptic ow coe cients extracted from the nalhadron spectra. Initial elliptic ow results from our group [\[4,](#page-3-3) [5\]](#page-3-4) and R om atschke [\[7\]](#page-3-6) seem ed to show large disagreem ents: where we saw for $b = 7$ fm C u+ C u collisions at $p_T =$ 2G eV /c a reduction of pion v_2 by about 63% from the ideal uid value, R om atschke saw $for b = 7$ fm $A u + A u$ collisions only a 25% reduction. These dierences have been understood and resolved in [\[6\]](#page-3-5). The largest part of the discrepancy results from the dierent system sizes: going from C u+ C u to A u+ A u at the sam e im pact param eter

cuts the viscous reduction of v_2 alm ost in half, to 39%. V iscouse ects are m uch m ore dram atic for sm all collision reballs than for larger ones, due to larger transverse velocity gradients. A ccounting for dierent EO S used in $[4,5]$ $[4,5]$ and $[7]$ rem oves m ost of the rem aining dierence: replacing SM \pm 0 S Q (with a rst order phase transition) by EO S L (w ith a sm ooth cross-overtted to lattice Q C D data) reduces the viscous suppression of v_2 by about another third, to 28%. A nal 5-10% relative reduction of the suppression results from replacing the "simplied I-S" treatm ent of $[4, 5]$ $[4, 5]$ $[4, 5]$ with the "full I-S" form alism used in [\[7\]](#page-3-6). The combined eect of these changes is a viscous suppression of v_2 of 25% in b= 7 fm A u+ A u at p_T = 2G eV /c, w hich agrees w ith [\[7\]](#page-3-6).

6. M ultiplicity scaling of elliptc
ow and viscous entropy production

Voloshin and collaborators pointed out (see [\[12\]](#page-3-11) and references therein) that the eccentricity-scaled elliptic ow $v_2 = "x$ scales with the nal hadron multiplicity per unit overlap area, $(1=S)(dN_{ch}=dy)$. A ll dependence on system size, beam energy, and im pact param eter can apparently be subsum ed in this variable. T he em pirical scaling function rises m onotonically w ith m ultiplicity density, approaching the ideal uid prediction at high m ultiplicities but rem aining well below it at low m ultiplicities.

We investigated this "multiplicity scaling" for ideal and viscous hydrodynam ics, for both $v_2 = "x$ and the viscous entropy production fraction S=S $_0$ [\[6\]](#page-3-5). Even in the ideal uid case we found weak scaling violations that can be traced back to the freezeout condition w hich introduces an external scale that a ects the reball lifetime (see Fig. 1). Perfect multiplicity scaling of $v_2 = v_x$ in ideal uid dynamics [\[13\]](#page-3-12) can only be achieved only ifdecoupling happens late enough that the m om entum anisotropy can fully saturate.In [\[6\]](#page-3-5)we found this to be the case for very high collision energies.

Scale breaking is m ore pronounced in viscoushydrodynam icsand increasesw ith =s. Experim entally seen weak scale breaking eects appear to be qualitatively consistent w ith viscous hydrodynam ic predictions [\[6\]](#page-3-5)but require m ore precise data for con mation.

A pproxim ate m ultiplicity scaling isalso found forthe viscousentropy production fraction. S=S $_0$ depends strongly on the hydrodynam ic starting time $_0$. For $_0 = 0.6$ fm /c and EOS L we nd entropy production fractions ranging from about 10% athigh m ultiplicity densitiesto about12-13% atlow m ultiplicities;again sm aller system s or m ore peripheral collisions exhibit stronger viscous e ects.
