m eson production is studied by the NA49 Collaboration in central Pb+ Pb collisions at 20A, 30A, 40A, 80A, and 158A G eV beam energy. The data are compared with measurements at lower and higher energies and with m icroscopic and them alm odels. The energy dependence of yields and spectral distributions is compatible with the assumption that partonic degrees of freedom set in at low SPS energies.

I. INTRODUCTION

The production of strange particles is considered one of the key observables for understanding the reaction mechanism s in ultrarelativistic heavy-ion collisions. Enhanced strangeness production with respect to proton-proton collisionswasoriginally proposed as a signature of the transition to a decon ned state of quarks and gluons during the initial

stage of the reactions [\[1](#page-17-0)]. The enhancem ent was predicted to arise from gluon fragm entation into quark-antiquark pairs w hich is believed to have a signi cantly low er threshold than strange-antistrange hadron pair production channels. Indeed, it has been observed $[2,3]$ $[2,3]$ $[2,3]$ that the ratio of the num ber of produced kaons to that of pions is higher by a factor of about 2 in centralS + S and Pb + Pb reactions than that in $p + p$ collisions at the top energy available at the CERN Super Proton Synchroton (SPS).

The fact that the hadronic nal state of the collision resembles a hadron gas in chem icalequilibrium has been interpreted as a consequence ofthe hadronization process [\[9\]](#page-17-8)or as a result ofa fast hadronic equilibration process involving m ultiparticle collisions [\[10](#page-17-9)]. In this hadron gas picture, enhanced production of strange particles in collisions of large nuclei arises as a consequence of the increased reaction volum e, relaxing the in uence of strangeness conservation [\[11](#page-17-10)]. Technically, this requires the application of the canonical ensemble to sm all collision system s,w hile for larger volum es such as those encountered in central collisions of heavy ions, the grand-canonicalapproxim ation is valid. It has been shown that this \canonical strangeness suppression" also applies to a partonic system [\[12\]](#page-17-11).

In addition to this volum e e ect, the strange particle phase space appears to be undersaturated in elem entary interactions. The deviation of the strange particle yields from a hadron gas in full equilibrium was param etrized by a strangeness undersaturation factor $_{S}$ [\[8](#page-17-7)[,13\]](#page-17-12). The additional suppression becom esm uch weaker in heavy-ion collisions. H ow ever, ts to the hadron m ultiplicities in full phase space are still unsatisfactory when not taking into account $\,$ s [\[8\]](#page-17-7). A possible interpretation is that the total am ount of strangeness available for hadronization is determ ined in a prehadronic stage of the collision. A change in $\,$ s between p + p and A + A would then re ect the dierence in the in itial conditions of the respective reballs.

T he hadron gas m odelwas extended to describe the energy dependence of produced hadron m ultiplicities by a sm ooth param etrization of the t param eters T and B , determ ined at energies available at the BNL A lternating G radient Synchroton (AGS), SPS, and BNL R elativistic H eavy Ion Collider (RHIC), as a function of collision en-ergy [\[14](#page-17-13)]. H ow ever, this extended m odel failed to reproduce the detailed features of the energy dependence of relative strangeness production m easured by NA 49 in its energy scan program . In particular, the sharp m axim um at around 30A G eV beam energy [\[15](#page-17-14)[,16](#page-17-15)] could not be described. The same holds true for m icroscopic reaction m odels such as U rQ M D [\[17\]](#page-17-16). On the other hand, this feature was predicted as a consequence of the onset of a phase transition to a decon ned state at the respective beam energy [\[18\]](#page-17-17).

In this context, it is certainly interesting to investigate speci c strangeness-carrying hadrons. Am ong these, the m eson is of particular interest because of its ss valence quark com position. In a purely hadronic scenario, being strangeness-neutral, it should not be sensitive to hadrochem icale ects related to strangeness. If on the other hand, the am ount of available strange quarks is determ ined in a partonic stage of the collision, the is expected to react m ore sensitively than singly strange particles. In particular, one would expect the meson yield to be suppressed by $\,$ 2_s w ith respect to equilibrium . A nalogously, the canonical suppression m echanism $\,$ in sm all system s should have a strongere ect on the , leading to a larger relative enhancem ent in Pb + Pb collisions w ith respect to p+ p reactions than observed for kaons.

In the evolution of the reball after hadronization, mesons can be both form ed by kaon coalescence and destroyed by rescattering. In addition, when decaying inside the reball, the daughter particles can rescatter, leading to a loss of signal in the invariantm ass peak of the respective decay channel. This is more likely to happen for slow mesons, which spend m ore time in the reball. Thus the e ect could lead to a depletion of the m eson yield at low p_t in central nucleus-nucleus collisions [\[19](#page-17-18)].

T heoretical investigations have suggested that the properties of the m eson m ight be m odi ed in a dense hadronic m edium. In particular, a decrease of its m ass of the order of 10 M eV¹ [\[20](#page-17-19)] and an increase of its width by a factor of 2{3 [\[21](#page-17-20)] were predicted. So far, there is only one experim ental claim for a broadening of the width in $p + Cu$ collisions[\[22\]](#page-17-21).

In an earlier publication $[23]$, we reported on production at top SPS energy, where we found the enhanced by a factor of about 3 , com pared to m inim um bias $p + p$ collisions at the same beam energy. to 158A GeV. Together with the data obtained at the AGS and the RHIC, our ndings enable the study of energy dependence of production over a large range of collision energies.

II. E X P E R IM E N T

T heN A 49 experim entatC ER N isbased on a xed-targethadron spectrom eterusing heavy-ion beam sfrom theSPS accelerator. Its m ain com ponents are four large-volum e tim e projection cham bers for charged-particle tracking, two of which operate inside the m agnetic eld of two superconducting m agnets, thus providing an excellent m om entum m easurem ent. Two larger m ain time projection chambers (M TPCs) are placed downstream, outside of the ell , and enable particle identi cation by the m easurem ent of the speci c energy loss in the detector gas. The particle identi cation capabilities are enhanced by a tim e-of- ight (TOF) scintillator system behind the MTPCs, albeit in a restricted geom etricalacceptance.

A thin lead foilw ith 1% interaction probability for Pb nucleiwas used as a target. For the dierent runs, the m agnetic eld was scaled proportionally to the beam energies in order to have sim ilar acceptance in the cm. system.

The centrality of the reactions was determ ined from the energy deposited by the beam spectators in the zero-degree calorim eter, placed 20 m downstream of the target. By setting an upper lim it on this energy, the online central trigger selected the 7.2% m ost central collisions at 20A {80A G eV and the 10% m ost central collisions at 158A G eV. The latter data set was restricted to 5% centrality in the o ine analysis. The corresponding m ean num bers of wounded nucleons were obtained by G lauber m odel calculations (see Table [I\)](#page-2-0). D etails of the experim ental apparatus can be found in R ef.[\[31](#page-17-30)].

III. DATA ANALYSIS

A . E vent and track selection

O ine quality criteria were applied to the events selected by the online centrality trigger to suppress nontarget interactions, pileup, and incorrectly reconstructed events. The cut variables include the position and 2 of the reconstructed vertex and the track m ultiplicity. For the central data sets used in this analysis, however, the im pact of these quality cuts is m arginal; only about 1% of all events were rejected. Table [I](#page-2-0) show s the event statistics used in the analysis for the ve data sets.

The analysis was restricted to tracks reconstructed in the M TPC s which could be assigned to the prim ary vertex. A m inim altrack length of2 m out ofthe m axim al4 m in the M T PC s was required to suppressghost orsplit tracks and to ensure a good resolution in dE =dx. D etailed studies including reconstruction of simulated tracks em bedded into real raw data events showed that for such a selection of tracks, losses due to track reconstruction and high track density are negligible.

B . Selection of kaon candidates

N A 49 observes the m eson through its hadronic decay into charged kaons. To reduce the large contribution of pions and protons to the com binatorialbackground, kaon candidates were selected based on their speci c energy loss dE =dx in the M T PCs. The mean dE =dx of pions, kaons, and (anti-)protons was determ ined from T O F-identi ed

particles in the acceptance of the time-of-ight detectors and param etrized as a function of as shown in Fi-1(a) . This allowed one to extend the m om entum range for the identi cation from the TOF acceptance to higherm om enta. The lower m om entum lim it was given by either the M TPC acceptance or the crossing of the Bethe-Bloch curves of pions and kaons.T he m om entum lim its for the dierent data sets are sum m arized in Table [I.](#page-2-0)

Fixing the m ean dE =dx of kaons and protons to this param etrization, the resolution was obtained by unfolding the energy-loss spectra in m om entum bins into the G aussian contributions of the particle species (p, K, \cdot, \cdot) and e). The resolution is about 4% and has a slightm om entum dependence which was again param etrized [Fig[.1\(](#page-3-0)b)].

K aon candidates were selected by a m om entum -dependent dE =dx w indow around the expectation value, the size of w hich was chosen to optim ize the signalquality. In addition, the w indow had to be symm etric and large enough to m inim ize the sensitivity to the errorsin the determ ination ofthe dE =dx expectation value and resolution.A w indow of 1:5 was found to be the best choice. This selection contains 87% of all kaons, giving an eciency of 75% for the pair. The fraction of true kaons w ithin the selected candidate track sam ple varies between 40% and 60%.

C . E xtraction of raw yields

The signal was obtained by calculating the invariant m ass of all com binations of positive and negative kaon candidates in one event. To reconstruct the com binatorialbackground of uncorrelated pairs, candidates from dierent events were com bined. The m ixed-event spectrum was subtracted from the sam e-event spectrum after norm alization to the sam e num ber of pairs [\[32\]](#page-17-31). Figure [2](#page-4-0) show s the background-subtracted invariant-m ass spectra in the total forward acceptance for dierent collision energies. In all cases, clear signals are observed at the expected position.

W hile the subtracted spectrum is at on the right side of the signal, a depletion is observed between the peak and the threshold. As a possible source of this undershoot, the correlation of kaons stem m ing from dierent mesons has been discussed in R ef. [\[32](#page-17-31)]. In our case, it was shown by simulation that this e ect is sm all thanks to the large acceptance of the NA 49 M TPC s. A nother possible source of the distortion is the re ection of other resonances, eg., 0 ! p, into the K $^+$ K spectrum by m isidenti cation of pions and protons, as discussed in detail in R ef. [\[33](#page-17-32)]. This e ect was shown to be present in our previous analysis of another data set [\[23\]](#page-17-22), where the dE =dx resolution was signi cantly worse. However, all such resonances would distort the spectrum over a broad range above threshold, w hich can be excluded by the observed atness at higher m asses. This conclusion is further strengthened by the observation that the depletion does not vanish w hen applying a stricter dE =dx cut on the kaons. Hence, the undershoot is likely to originate from a true correlation of kaon pairs. Simulations show that it can be explained by nalstate strong interaction of kaons [\[34](#page-17-33)]. This is dem onstrated in Fig. 3 by show ing the K $^+$ K correlation

function in q_{inv} = p $\overline{(p_1 p_2)^2 (E_1 E_2)^2}$ [Fig. 3(a)] and in m _{inv} [Fig. 3(b)]. W hile the repulsive interaction causes a depletion in m_{inv} , the stronger attractive C oulom b e ect is squeezed into 0.8 M eV above threshold and is thus hardly seen. In com bination w ith the steeply rising unsubtracted m $_{\text{inv}}$ distribution, this depletion can easily account for the de cit observed in the subtracted spectrum.

To correct this eect quantitatively by sim ulation is dicult and would m oreover be m odeldependent. A s the narrow signal is easily distinguished from the broad residual background, we accounted for the depletion by tting a straight line in the vicinity of the peak. For the description of the signal itself, we used a relativistic p-wave Breit-W igner distribution [\[35\]](#page-17-34) of the form

This distribution was folded with a G aussian representing the invariant-m ass resolution μ of the spectrom eter. Since in general, m ass resolution and width cannot be determ ined separately, we xed the width to its book value $_0 = 4.26$ M eV [\[36\]](#page-17-35), leaving m $_0$, $_m$, a norm alization and two param eters for the linear background as free param eters for the t, which was perform ed in the m ass range 994{ 1050 M eV. It was checked by sim ulations that this procedure gives the correct values for position, width and integral of the distribution. A s F ig. 2 dem onstrates, the t gives a good description of the signal. The num ericalvalues of the tted param eters are listed in Table [II.](#page-8-0)

To obtain longitudinal and transverse spectra, the signal was extracted in rapidity and in p_r bins, respectively, in the sam e way as in the total acceptance. G enerally, the lim ited statistics prevented a simultaneous division into $y-p_t$

bins. Thus, transversem om entum spectra could only be derived averaged over rapidity. To reduce the number of free t param eters, m_0 and $_m$ were xed for the ts in the phase space bins to the values obtained from the signal in the total acceptance. For the 158A GeV data set, where the statistics in the signal allowed to do so, we checked that leaving these param eters free did not signi cantly alter the results. In particular, no signi cant dependence of m_0 or $_m$ on rapidity or p_t was observed.

Since the straight-line background is only an approximation for the residual background in the vicinity of the signal, the stability of the tagainst the variation of the tregion was checked. The parameters m₀ and $_m$ show no signi cant dependence. The variation of the nom alization constants, which detem ine the t integral, is in all bins far below the statistical error returned by the t procedure. We conclude that the latter properly takes into account the possible variations of the baseline.

The raw yields in the phase-space bins were obtained by integrating the t function from threshold up to m₀+30₀ 1.148 M eV. This m ass cuto is som ehow arbitrary; the corresponding integral varies by about 3% for cuto values from $m_0 + 10_0$ to in nity. We take this as a system atic uncertainty due to the m ass cuto. Using alternatively a (analytically integrable) nonrelativistic Lorentz distribution for the t does not change the integral by m ore than 1%.

D. Geometricalacceptance

The geom etrical acceptance of the NA49 detector for the decay \cdot K $^+$ K \cdot was obtained double-di erentially in y and p_t (integrated over azimuth) by geant simulations of the decay including in-ight decay of the kaon daughters, assum ing an azim uthally at em ission and isotropic decay. The resulting acceptance is shown in Fig. 4 for 20A and 158A G eV. W hile the upper m om entum lim it for the daughter candidates restricts the acceptance at forward rapidity for the top SPS energy, at lower beam energies there is lack of acceptance near m idrapidity because of the lower m om entum lim it for the daughter tracks and the increased losses due to in-ight decay for low-m om entum kaons.

As the acceptance is a function of y and p_t , the proper correction factor for a given extended phase-space bin (integrated either over y or p_r) as used in the analysis is the m ean acceptance

where S denotes the region in the y ; p_T plane, a(y; pt) the acceptance probability averaged over the azimuthal angle, and $f(y,p_c)$ the dierential meson yield. For the rapidity distributions, the dierential yields have in addition to be extrapolated to the full p_t range. The extrapolation factor, how ever, is sm all $($ < 5%) due to the large p_t range covered by the experiment.

Both the acceptance correction and the extrapolation to full p_r require the know ledge of the y and p_r dependence of meson yields, which leads to an iterative procedure (see Sec. IIIE).

E. Spectra and yields

A part from the di erential acceptance correction, the raw yields obtained from the t to the invariant-mass spectra were corrected for the branching ratio $\pm K$ K ^+K (49.1%) and the e-ciency of kaon dE =dx selection (75% for the pair), and norm alized to the number of collisions. These global correction factors are common for all bins in phase space and for all beam energies.

A s the param eters T and y m ust be obtained by the analysis itself, an iterative procedure was em ployed. Starting from some reasonable parameter values, the acceptance correction was calculated according to Eq. (3), assuming factorization of the em ission function $f(y; p_t)$ into the transverse and longitudinal distributions (4) and (5), i.e., independence of T on rapidity. The corrected yields in the p_t and y bins were then tted with the distributions (4) and (5) , respectively, obtaining new values for T and $_{y}$ which serve as input for the next iteration. Convergence of the m ethod was reached after three to ve steps. It was checked that the nal results do not depend on the choice of start values for the param eters.

A fter the nal step of the iteration, the yields in full phase space were obtained by summing up the measured yields in the rapidity distributions and num erically extrapolating Eq. (5) to the full rapidity range. In a similar way, the quantities $tp_{+}i$, $tm_{+}i$, and v_{y} were determ ined. The m idrapidity yield dn=dy was obtained directly from the t function.

As dem onstrated later in Fig. 7, the G aussian param etrization gives a satisfactory description of the rapidity distribution for all data sets. However, because of the lack of m idrapidity data points at the lower beam energies, an am biguity for the extrapolation to full phase space arises. To check the sensitivity of the results to the assum ed shape ofthe rapidity distribution,we alternatively param etrized the latter by the sum oftwo G aussian functions displaced sym m etrically around m idrapidity by a shift a:

The w idth of this distribution w ill be characterized by its m s value. Total yield h i, m idrapidity yield dn =dy and m s_y were calculated for both param etrizations [\(5\)](#page-6-3) and [\(6\)](#page-7-0). The nalvalues listed in Tables [V](#page-11-0) and [V I](#page-12-1) were calculated as the m ean of the results of the two m ethods; their dierences enter the system atic errors.

F . Statistical and system atic errors

Statistical errors in the raw dierential m eson yields originate from the statisticalbin-by-bin errors in the sameevent and m ixed-event invariant m ass spectra, w hich were found to be in good approxim ation Poissonian and uncorrelated between m ass bins. Then, the statistical errors in the event-m ix subtracted invariant-m ass spectrum was calculated as [\[32\]](#page-17-31)

w here $n_{0;i}$ is the num ber of entries in m ass bin i in the sam e-event spectrum , $n_{em\;ji}$ the sam e num ber in the m ixedevent spectrum , and k the norm alization constant for the event m ix. These errors were propagated toward the raw dierentialyields by the least-squares t of the Breit-W igner distribution to the signal peak.

The acceptance calculation was perform ed w ith su ciently high statistics such that the relative statistical error of the dierential acceptance is below 1% and thus far below the uncertainty in the raw yields over the entire y, p_t region used for the analysis. Finally, the errors in the acceptance-corrected dierential yields are propagated through the least-square ts to the spectra to obtain the statistical uncertainties in the spectral param eters and the integrated quantities.

System atic uncertainties in the uncorrected yields arise from the approxim ation of the residual background in the invariant-m ass spectra as a straight line. This approxim ation is only valid in a lim ited m ass range around the signal peak. Thus, the stability of the results of the Breit-W igner t against the variation of the trange was checked. W e found no signi cant dependence of the param eters m_0 and m_i ; the variation of the norm alization constant, detem ining the t integral, was in ally and p_t bins found to be sm aller than the statistical error.

A nother source of system atic error arises from the dE =dx selection of kaon candidates. U ncertainties in the param etrization of the m ean kaon dE =dx and the resolution result in system atic deviations of the eciency correction from its true value. To estim ate this error, the analysis was repeated for dierent widths of the dE=dx selection w indow around the kaon expectation value, applying the respective eciency correction. T his error was found to be the dom inating one; for m ost raw yields, it is com parable to or slightly larger than the statisticalone.

Im perfect detector description in the sim ulation leads to system atic uncertainties in the acceptance correction. To reduce possible errors, the analysis was restricted to phase-space regions where the acceptance is above 1%. The rem aining error was estim ated by repeating the analysis w ith varying acceptance conditions (m inim altrack length in the M T PC s). It was in allcases found to be m uch sm aller than the error originating from the kaon selection by $dE = dx$.

A s the spectral param eters enter the acceptance correction through Eq. [\(3\)](#page-5-1), their uncertainties add to the system atic errors of the corrected yields. This was accounted for by determ ining the range of acceptance values allowed by the errors in T and y. In addition, for the rapidity bins close to beam rapidity, a possible deviation of the slope param eter by 50 M eV from its averaged value was taken into account in the acceptance correction. The resulting error, however, is $\mathfrak m$ all thanks to the large and approxim ately uniform $\, {\rm p}_{\rm t}$ acceptance.

The system atic errors in the corrected dierentialyields were assum ed to be independent and added in quadrature. They were propagated to the respective errors in the spectral param eters by repeating the t of Eqs. [\(4\)](#page-6-2) $\{$ [\(6\)](#page-7-0) w ith statisticaland system atic errors added and com paring the resulting errors to those obtained from the twith statistical errorsonly.

For the determ ination of the averaged quantities h i, tp_r i, lm_t , and $rm s$, the sum m ation of the m easured dierentialyields as well as extrapolation to full phase space are required. The system atic errors of these observables were determ ined from the errors of the dierential yields and the uncertainties in the spectral shapes.

IV. RESULTS

A. Line shape

Table II sum m arizes the param eters obtained from the invariant-m ass signals in the total acceptance. The signal quality decreases when going to lower beam energy because of both the reduced meson yield and the reduced acceptance due to the increased in-ight decay probability for the daughter kaons. At all ve energies, the tted peak position is slightly below the literature value of 1019.43 M eV [36]. We investigated the e ect of an error in the nom alization of the m agnetic eld used for m om entum determ ination in the reconstruction chain and found that a bias of 1% in the m agnetic eld is needed to explain the observed shift. This is slightly above the m om entum scale uncertainty deduced from a precision study of the K $_8^0$ signal. We thus cannot exclude that the deviation of the peak position is due to experimentale ects.

The widths of them asspeaks obtained from the ts are consistent with those obtained from a full detector simulation and reconstruction. Their slight increase tow ard lower beam energies can be understood as the increasing in uence of multiple scattering on lowerm om entum tracks. For the signal at 158A GeV, we tted simultaneously width and mass resolution and obtained $_0 = (4.41 \ 0.61)$ M eV, $_m = (1.81 \ 0.26)$ M eV, i.e., no deviation from the free-particle w idth. Thus, w ithin experim ental uncertainties, we do not observe indications for a m ass shift or a broadening of the m eson.

The observation that the m ass and width of the meson agree with the Particle D ata G roup values is in line with the results of AGS and RHIC experiments [27, 28, 29, 30]. It should be noted that because of the long lifetime of the

 m eson (= 46 fm), only a fraction decays inside the reball. Thus, only a part of the m esons can be expected to be in uenced by the surrounding medium.

B. Transverse m om entum spectra

The transversem om entum spectra obtained for the ve beam energies are shown in Fig. 5; num ericaldata are given in Table III. In all cases, the therm aldistribution (4) gives a good description of the data; the t parameters are sum m arized in Table IV. At top SPS energy with the best signal quality, a m odest deviation from the t function is indicated by the 2 =ndf of 1.5. A slight curvature of the transverse m ass spectrum at this energy, as expected from a hydrodynam ical expansion scenario, is visible for this energy in Fig. 6(a). For the other energies, no deviations from pure exponential behavior can be seen within the experimental uncertainties.

The transverse m om entum spectrum can be also characterized by its rst m om ent or the average transverse m ass. These param eters were calculated from the measured data points and extrapolated to full p_r using the exponential t function. As the extrapolation contributes only m arginally because of the large p_r coverage, hp_r i and lm_f i m $_0$ are largely independent of the spectral shape. Their values are also listed in Table IV.

The assum ption of the slope parameter being independent of y could be checked for 158A GeV, where statistics allowed us to extract transverse spectra in four di erent rapidity bins. The resulting slope parameters are shown in Fig. 6(b). W ithin the measured rapidity range, we observe no signi cant change of the slope parameter with y. U sing the y-dependent slope param eters for correcting the rapidity distribution had no sizable e ect on the results.

The spectrum obtained for 158A GeV agrees with that from an earlier publication [23] of the NA 49 experiment, which was based on the analysis of an older data set at the same beam energy. For comparison, the previously

published data are shown by the square sym bols in Figs. 5(e) and [6\(](#page-9-1)a). There is agreem ent with the results of the CERES experiment in both decay channels $\,$! K $^+$ K and $\,$! e^+e^- [\[25\]](#page-17-24), as also demonstrated in Fig. 6(a). The data disagree with the spectrum measured by the NA 50 experiment in the di-muon decay channel $\;!$ $\;$, where a signicantly sm aller slope wasobtained [\[24](#page-17-23)].

C. Rapidity distributions and yields

Figure 7 shows the rapidity distributions, which for all ve energies are in good agreement with both the single-G aussian and the double-G aussian param etrization (see curves). Num ericaldata are given in Table III. For the data sets at 20A and 30A GeV, due to the low number of data points, the double-G aussian twas constrained to a = $_{\rm y}$ as suggested by the data at 40A and 80A G eV.

Only at 80A GeV is the complete forward hem isphere covered. At 158A GeV, large rapidities are not measured because of the upper m om entum cut on the secondary kaons. Since kaons below 2 G eV laboratory m om entum cannot be reliably identi ed by dE =dx because of the crossing of the B ethe-B loch curves, no signal could be extracted at m idrapidity for the lower three beam energies. The uncertainties in the extrapolation toward m idrapidity is dem onstrated by the dierence of the two param etrizations. It adds to the system atic error of the total yield and, in particular, to that of dn=dy atm idrapidity. Table V lists the parameters obtained by the two t functions, respectively.

A Itematively, the rapidity distributions can be characterized by their second m om ents in a model-independent fashion. The root mean square of the distributions was calculated from the measured data and extrapolated to the full rapidity range using the param etrizations (5) and (6). The average of the two results is listed in Table V.

Total yields were obtained by summation of the data points in the rapidity spectra and extrapolation to the full rapidity range by the average of the t functions. The m idrapidity yield dn=dy was calculated analytically from the average of the t functions. For the determ ination of statistical and system atic errors, the correlation of the spectral parameters were properly taken into account. The results for the mean multiplicity of mesons h i and for the m idrapidity yield dn =dy are listed in Table VI.

A ll results obtained at 158A G eV are consistent within statistical errors with NA 49 results published earlier [23], which were obtained from a data set taken in 1995 (squared symbols in Fig. 7(e). The main di erence of the two data sets is an improved dE =dx resolution, resulting in a reduced pion contamination of the kaon candidate sample. The cleaner kaon identi cation reduces the distortions in the background-subtracted invariant-m ass spectrum induced by resonances with a pion as decay daughter [33], thus leading to a sm aller system atic error of the Breit-W igner t to the spectrum. We thus prefer to use the new ly obtained results at 158A GeV for the discussion.

V . D ISC U SSIO N

The enhancem ent of relative strangeness production in heavy-ion collisions w ith respect to proton-proton reactions is a well-known fact. In an earlier publication [\[23\]](#page-17-22), the enhancem ent factor for the m eson at top SPS energy was found to be 3:0 0:7, thus larger than for kaons and , but sm aller than form ultistrange hyperons. We calculate the

enhancem ent by norm alizing the m easured m eson yield in $A + A$ by the num ber of wounded nucleon pairs and dividing by the corresponding yield in $p + p$. For the lower beam energies, no reference m easurem ents in elem entary collisions are available. H ere, we em ploy a param etrisation of the excitation function in $p + p$ collisions as described in R ef. [\[27\]](#page-17-26). For top SPS energy and RH IC, the m eson yield m easured in $p + p$ [\[23](#page-17-22), 29] was used. Figure [8](#page-13-0) shows the resulting enhancem ent factor

as a function of energy per nucleon pair. The m easurem ent of the E917 C ollaboration at AGS (p_{beam} = 11.7A G eV) was extrapolated to full phase space assum ing the sam e rapidity distribution as for K as suggested by the authors [\[27\]](#page-17-26).

In the AG S/SPS energy region, the value of E lies between 3 and 4, and w ithin our experim ental uncertainties we nd no system atic variation here. A t R H IC energies, the enhancem ent appears to be lower, signi cantly so, should the PH EN IX result be validated. It should be noted, how ever, that the R H IC values were derived from m idrapidity data w hile at low er energies phase-space integrated yields were used.

In the context of statisticalm odels, the enhancem ent of strangeness production can be interpreted as a result of the release of suppression due to strangeness conservation w hen going from $\sin \alpha$ (p+ p)to large (centralA + A) system s. Technically, this is re ected in the application of the canonical ensemble for sm all system s, while large system s can be described by the grand-canonical ensem ble. In this picture, a sm aller enhancem ent at RHIC energies points to the fact that at such high energies, strangeness is produced w ith su cient abundance for the canonical suppression to be relaxed even in $p + p$ collisions. However, in a purely hadronic picture, canonical suppression does not act on the m eson because it is a strangeness-neutralhadron. Enhanced production can thus be attributed either to enhanced strangeness production in a partonic stage of the collision or to the coalescence of kaons which su er canonical suppression also in a hadronic scenario.

The hadrochem icalm odels have been extended not only to thadron m ultiplicities for a given reaction but also to describe the energy dependence of particle yield ratios by a sm ooth variation of the relevant param eters T and B w ith collision energy $[14, 37]$ $[14, 37]$. H ere, the energy dependence of tem perature and baryochem ical potential is obtained by a param etrization of the values for T and $_B$ obtained from ts to particle yield ratios at various collision energies. The m odel reproduces m any yield ratios of the bulk hadrons; however, this does not hold for the meson, as show n in Fig. 9(a), where the measured excitation function of the h i=h i ratio [h i = $1:5(h^+i+h-i)$] is compared with the m odel prediction. The relative meson yields at the SPS are overpredicted by factors of up to 2. The situation rem ainsessentially unchanged w hen m idrapidity ratiosare considered instead ofintegrated yields [Fig[.9\(](#page-14-0)b)]. A t the R H \mathbb{C} , there is a large experim ental am biguity as a result of the dierent results on production obtained by the STAR and PHEN IX experim ents [\[29](#page-17-28)[,30\]](#page-17-29).

A better description of the data is obtained if a strangeness saturation param eter s is allowed. The corresponding m odel predictions [\[8\]](#page-17-7) for the multiplicity, resulting from a t to the hadron abundances at 11.7A,30A,40A,80A, and 158A G eV, are com pared w ith the data in Fig. [10](#page-14-1) (solid points). Note that this m odel does not provide a continuous description of the energy dependence; the points are only connected to quide the eye. The agreem entw ith the m easurem ents at the higher SPS energies is very good. The successful application of the saturation param eter s on the strangeness-neutral m eson for p_{beam} 40A G eV again suggests that the strangeness content at chem ical freeze-out is determ ined on a partonic level for these energies.

Finalstate interactions after chem icalfreeze-out could change the equilibrium yield and spectra. In particular, scattering of the daughter kaons w ith other produced hadrons would lead to a loss of the signal in the experim entally

observed decay channel, predom inantly at sm all rapidities and low values of p_t . Such a loss is not expected in the leptonic decay m odes, since electrons or m uons w ill leave the reball w ithout interaction. A com parison of the m easured m $_{\rm t}$ spectrum via the K $^+$ K and ${\rm e}^+$ e decay channels [see Fig[.6\(](#page-9-1)a)] indicates that the e ect cannot be large. To study the eect on the totalyield, we used the string-hadronic transport modelU rQMD [\[17\]](#page-17-16). It was found that only about 8% of the decayed mesons are lost for detection due to rescattering of their daughter particles, independent of collision energy. Sim ilar results have been obtained w ith the RQM D m odel [\[19\]](#page-17-18). The eect is thus

not su cient to account for the deviation of the relative multiplicities from their equilibrium values.

On the other hand, m esons can be produced by K K scattering. In fact, kaon coalescence is the dom inant (70%) production m echanism for the in U rQ M D, again for all investigated collision system s. A s show n by the dotted curve in Fig. 10, the m odelgives a reasonable description of the m eson yields at lower energies, w hereas it starts to deviate from the m easurem ents at interm ediate SPS energies. The discrepancy w ith data is m ore pronounced when studying the h i=h i ratio (Fig[.9\)](#page-14-0) because U rQ M D overestim ates the pion yields at SPS energies by about 30%.

T he hypothesis that the m eson is produced predom inantly by kaon coalescence can be tested by com paring the and kaon distributions in phase space. Figur[e 11\(](#page-15-1)a) show s the w idth of the rapidity distribution as a function of beam rapidity at SPS energies, together with that m easured for γ , K $^+$, and K $[38, 39]$ $[38, 39]$. The m eson width does not t into the system atics observed for the other particle species but increases m uch faster w ith energy. W hile at 20A G eV, the rapidity distribution is narrow er than that of K, we nd it at top SPS energy comparable to the pions. In addition,at 158A G eV it is m uch larger in centralPb + Pb collisions than m easured in p+ p collisions at the sam e energy [\[23\]](#page-17-22), a feature w hich is not observed for other particle species.

In the kaon coalescence picture, there would be a tendency for the rapidity distribution to be narrow er than those of the kaons. In an ideal case, neglecting correlations,

w here the distributions were approxim ated by G aussians. A s shown in Fig. 11(b), the data rule out kaon coalescence as dom inant form ation m echanism for beam energies above 30A G eV . O nly at 20A G eV, the observed rapidity w idths are consistent w ith the coalescence picture. A s m entioned before, this would also explain the enhancem ent at low energies, where a transient decon ned state is not expected.

T he observation that m odels based on a purely hadronic reaction scenario have serious problem s in describing relative strangeness production in the upper SPS energy range is not unique to the m eson but holds for kaons and other strange particles, too. It has been related to the onset of decon nem ent at around 30A G eV as predicted by the statisticalm odel of the early stage [\[18\]](#page-17-17). A striking experim entalevidence is the narrow m axim um in the K $^+$ = $^+$ ratio at this energy [\[38](#page-17-37)[,39\]](#page-17-38). A sim ilar structure is, w ithin experim ental errors, not observed for the m eson (Fig[.9\)](#page-14-0); instead, the energy dependence of the relative m eson yield resem bles that of the K . This can be understood since the K⁺ yield is in good approxim ation proportional to the total strangeness production, which is not the case for K and because a large, energy-dependent fraction of s quarks is carried by hyperons.

The energy dependences of both the inverse slope param eter and them ean transversem ass of the m eson are show n in Fig. 12. The transverse m ass spectra of the are well described by exponential ts [see Fig. 6(a)]; consequently, the two param eters show a sim ilar behavior. O ver the energy range AGS{SPS{RHIC, there is an overall tendency for both param eters to increase. However, a constancy of the values in the lower SPS energy range, as has been observed for pions,kaons,and protons [\[39\]](#page-17-38)| a fact interpreted as being consistent w ith a m ixed partonic/hadronic phase [\[40\]](#page-17-39) cannot be excluded.

V I. SU M M A R Y

W e have presented new data on production in central Pb+ Pb collisions obtained by the NA49 experim ent at 20A, 30A, 40A, 80A, and 158A G eV beam energies. No indications of medium modi cations of the meson mass or w idth were observed. The energy dependence of the production characteristics was studied by comparing them w ith m easurem ents at AGS and RHIC energies. We nd that at low SPS energy, the data can be understood in a hadronic reaction scenario; while at higher energies, hadronic m odels fail to reproduce the data. A statistical hadron gas m odelw ith undersaturation of strangeness gives a good description of the m easured yields. This suggests that production is ruled by partonic degrees of freedom , consistent w ith the previously found indications for the onset of decon nem ent at low er SPS energy.
