# Study of -delayed 3-body and 5-body breakup channels observed in the decay of <sup>11</sup>Li

#### A bstract

The -delayed charged particle em ission from  $^{11}L$  ihas been studied with em phasis on the three-body n  $^{6}H$  e and ve-body 2 3n channels from the 10.59 and 18.15 M eV states in  $^{11}Be$ . M onte C arlo simulations using an R-matrix formalism lead to the conclusion that the  $^{A}H$  e resonance states play a signi cant role in the break-up of these states. The results exclude an earlier assumption of a phase-space description of the break-up process of the 18.15 M eV state. Evidence for extra sequential decay paths is found for both states.

## 1 Introduction

The nucleus <sup>11</sup>Lihas provided many challenges to nuclear physicists over the last decades, see e.g. [1] for a recent overview. Its beta-decay presents one of these challenges that have not yet been fully solved. The large Q -value (20.68 M eV) for the decay and the low particle separation energies in the daughter <sup>11</sup>Be in plies that many decay channels are open. The most extrem e channel has a vebody nalstate consisting of two alpha particles and three neutrons. D ecays into this channel, am iniaturem ultifragm entation, and the fact that the constituents (n and ) are barely kept together allows structure interpretations in term s of cluster or few-body models to be tested. On the experim ental side, a thorough investigation of the decay is only possible through the recording of the decay products in coincidence. This has so far only been reported in one earlier experim ent [2] that had a quite lim ited angular resolution.

The <sup>11</sup>Li -decay involves the largest number of decay channels ever detected and experimental results have been reported for n [3], 2n [4], 3n [5], t [6] and d [7]. The established channels involve the emission of particles (2 + 3n), <sup>6</sup>He (<sup>6</sup>He+ + n), tritons (<sup>8</sup>Li+t), deuterons (<sup>9</sup>Li+d) and the emission of 1n and 2n feeding states in <sup>10</sup>Be and <sup>9</sup>Be, respectively. The -delayed charged particle emission of <sup>11</sup>Lihas been the subject of several previous studies [2,6,7,8]. The two channels involving coincident particles were studied in one previous experiment [2]. The 2 3n channel was established to have contributions from the break-up of two states in <sup>11</sup>Be, one at 10.59 M eV and the other at around 18.5 M eV. The <sup>6</sup>He n channel was established as the <sup>6</sup>H e+ break-up of a state at about 9.4 M eV in <sup>10</sup>Be fed in the neutron decay of the 10.59 M eV state in <sup>11</sup>Be.

By means of a gas-detector telescope for particle identication, the dimension of He n, 2 3n,  ${}^{10}Be+n$ ,  ${}^{9}Be+2n$ ,  ${}^{8}Li+t$  and  ${}^{9}Li+d$  decay channels of the 18.5 MeV state in  ${}^{11}Be$  and its branching ratios were determined [8]. An R-m atrix analysis established the energy of this state to be 18.15(15) MeV. The large reduced width of the  ${}^{9}Li+d$  channel with respect to the W igner limit [9] was interpreted as evidence of the  ${}^{11}Li(gs)$  -decaying directly into the  ${}^{9}Li+d$  continuum.

A recent - n coincidence experiment using polarized  $^{11}\text{Li}[10]$  determined the spin and parity of several levels fed in  $^{11}\text{Be}$  (E < 11 M eV). In that work the 10.59 M eV level was found to contribute to the neutron spectrum via transitions to the  $^{10}\text{Be}(\text{gs})$  and tentatively to the rst 2 state at 3.4 M eV

and to the unresolved doublet at 9.27 MeV (4) and 9.4 MeV (2<sup>+</sup>). The -decay asymmetry of these three neutron transitions consistently determines the spin and parity of the 10.59 MeV level in <sup>11</sup>Be as 5/2. Its 210(40) keV width was determined from the reaction  ${}^{9}\text{Be}(t,p)^{11}\text{Be}$  [12].

A dditional inform ation about the decay of the 10.59 and 18.15 M eV states in <sup>11</sup>Be is obtained from three-neutron em ission probability, which is equal to the branching to the vebody (2 3n) nalstate. From the average branching ratio to the only bound state in <sup>11</sup>Be, and the  $P_{2n}/P_{1n}$ ,  $P_{3n}/P_{1n}$  ratios determ ined by A zum a et al. [5] a value of  $P_{3n} = 1.9(2)$  % is obtained.

The di erent experiments sum marized above paint a fairly complicated picture of the -delayed charged particle break-up of  $^{11}$ Li. It is neither well understood which levels in  $^{11}$ Be are contributing to the charged particle channels nor their break-up mechanism s. One should notice that signi cant -decay strength in the 10–18 MeV energy range is predicted in shellmodel calculations [13].

Fig.1 shows schem atically the  $^{11}$ Li -fed states in  $^{11}$ Be above the charged particle thresholds and the decay channels discussed above as established prior to this experiment. Since it is still not clear whether the  $^{9}$ Li+ d channel proceeds sequentially through a state in  $^{11}$ Be at 18.15 MeV or directly from  $^{11}$ Li [8],

the gure displays both possibilities as dashed lines.

The main aim of the present paper is to provide signi cantly improved data on the -delayed branches, especially those including two charged particles. These data allow a leap to be taken in the description of the break-up process following the weak decay. The interpretation presented here is based on known resonances in <sup>11</sup>Be and intermediate nuclei in the decay chain. We consider not only decays through <sup>10</sup>Be, but also channels involving <sup>A</sup>He intermediate resonances. The following section describes the experiment, section 3 presents the analysis of the data, and the nal section summarizes the results.

# 2 Experiment

The experiment was carried out at the ISO LDE PSB Facility at CERN, where the <sup>11</sup>Liactivity was produced in fragmentation reactions in a Ta target irradiated with 1.4 G eV protons from the CERN PS Booster. The target container was connected to a surface ion source and the produced ions were accelerated to 30 keV. The 1<sup>+</sup> lithium ions were mass selected from the di erent isobars using the G eneral Purpose Separator. The <sup>11</sup>Li beam was subsequently brought to the center of the particle detector setup where it was stopped in a 60 g/cm<sup>2</sup> carbon foil. The use of a thin foil, which m inim izes the energy loss of the emitted charged particles, was possible due to the low acceleration voltage used in this experiment.

The setup, shown in Fig. 2, consisted of 4 particle telescopes with thin doublesided silicon strip detectors (DSSSD) in front stacked with thick silicon pads, for detection. The telescopes were mounted on the surfaces of a 10x10x10 cm<sup>3</sup> cubic frame, each covering 4% of 4 . Charge collection in these DSSSD's was carried out by 16 vertical and 16 horizontal strips, constituting 256 detector pixels, with an angular resolution of  $3.5^{\circ}$ . Each telescope combines large solid angle with high segmentation which gives large coverage with good angular resolution. The geometry of the setup de nest three possible types of two-particle coincidences, depending on which detectors were hit. Hits in DSSSD D2 and DSSSD D4 (see Fig. 2), classi ed as 180° coincidences, covered angles from 127° to 180° between the detected particles. Hits in DSSSD D3 and either DSSSD D2 or DSSSD D4, classi ed as 90° coincidences, covered angles from 37° to 143° between the detected particles. Finally, coincidences detected in the same detector, classi ed as 0° coincidences, covered angles from 0° to 50° between the detected particles. From here on we will concentrate on the 180° coincidences, which have an eliency estimated from the simulations of 5% on average.

The silicon detectors were calibrated using standard <sup>148</sup>G d and triple alpha sources (<sup>239</sup>Pu, <sup>241</sup>Am and <sup>244</sup>Cm). Furtherm ore, the elective thickness of the carbon foil used as stopper was obtained from the analysis of the particles coming from an online <sup>20</sup>N a beam in planted in the foil before and after the experiment. The energy bases in non-active layers, such as the carbon-foil and the surface dead-layer of the silicon detectors are approximately 100 keV for particles of energies around 1 M eV. Since 60% of the <sup>11</sup>Li -delayed charged particles are expected to be emitted with 1 M eV energy or less [8], it is crucial to take these energy bases into account. The method developed within our collaboration [14] takes advantage of the highly segmented nature of the D SSSD 's to precisely de ne the path of the detected particle and thus allow ing for the reconstruction of the energy bases in the non-active layers. The combined e lect of the dead-layers and low energy noise gives detection thresholds around 180 keV.

## 3 Analysis

The use of highly segmented DSSSD detectors gives to this experiment a signi cant advantage compared to the previous studies of the<sup>11</sup>Li -delayed charged particle emission. By using segmented detectors not only the energy of the particle is measured but also its direction with a good suppression of unwanted – and  ${}^{6}$ H e pile-up events. This technique has successfully allowed to determ ine the decay mechanism of states in  ${}^{9}$ Be [15,16],  ${}^{9}$ B [17] and  ${}^{12}$ C [18]. We apply here this technique to the study of the decay mechanism of the  ${}^{11}$ Li -delayed  ${}^{6}$ H e n and 2 3n channels, trying to determ ine which levels in  ${}^{11}$ Be and  ${}^{10}$ Be are involved. Moreover we discuss the possible role played by the  ${}^{7}$ H e and  ${}^{5}$ H e resonances in the break-up of  $-\text{fed} {}^{11}$ Be states.

We concentrate here on the analysis of <sup>11</sup>Li -delayed double coincidences detected in the DSSSD 's. The <sup>11</sup>Li -delayed events are enhanced over daughter activities by gating on the rst 40 m s after the proton in pact on the target. The combined e ect of the release from the target and the half-life  $of^{11}Li$  $(T_{1=2} = 8.5(2) \text{ ms [19]})$  makes this time window optimum for the study of the <sup>11</sup>Liactivity with minimum contribution from the -delayed <sup>7</sup>Li+ branch of the daughter nucleus <sup>11</sup>Be (see Fig. 3a). The particle em itting channels follow ing <sup>11</sup>Li -decay are 5-body 2 3n, 3-body n <sup>6</sup>He, 2-body <sup>8</sup>Li+t and <sup>9</sup>Li+d. All these channels involve the emission of two charged fragments, but the low recoil energy of the <sup>9</sup>Li ions (. 160 keV [8]) makes the contribution of the <sup>9</sup>Li+d channel negligible. The <sup>8</sup>Li+t channel is sorted out from the data by kinem atics. The deduced branching ratio of 0.014(3)% is in agreem ent with the literature value [7,8]. The total number of events assigned to this decay channel, 224, is less than 3% of the total coincidence events. Thus, the study of the charged particle coincidences greatly enhances the 5-body and 3-body channels.

The study of the charged particle en ission in <sup>11</sup>Li is connected with several experimental diculties. First, we lack complete kinematics information in the ve body channel, as we cannot reconstruct the three missing neutron momenta. Second, although it is possible to calculate the missing neutron momentum in the three body channel, the lack of particle identication in our setup, makes the reconstruction rather inaccurate. Because of these shortcomings, the analysis concentrates on studying direct observables, the individual energy and direction of the detected particles and simple transformations of these energies, such as sum s and dicerences. The sum energy spectrum enhances the contribution of the channels where the two detected particles formed a resonance. The energy dicerence, decay kinematics group the events across the scatter plot instead of scattering them evenly, as expected from pure phase space kinematics.

Fig. 3a shows the sum energy spectrum corresponding to the coincidences observed in the two opposite detectors D2 and D4 for a time interval t< 40 m s. The sum energy spectrum compares well with the one previously measured (see Fig. 10 of R ef. [2]). The 0.7 and 2.2 M eV peaks were assigned [2] to the break-up of the 10.59 M eV state in <sup>11</sup>Be [12] into 5-body (2 3n) and 3-body (n <sup>6</sup>He) channels, through an intermediate state in <sup>10</sup>Be around 9.5 M eV, see Fig. 1. The continuous distribution at higher energy was assigned to the 5-body break-up of the 18.15(15) M eV state in <sup>11</sup>Be [2,8]. In the inset of Fig. 3a the sum energy spectrum for the rst 200 m s after the proton impact is shown. For this longer time interval a low intensity peak at around 1.2 M eV appears, corresponding to the decay channel of the daughter nucleus <sup>11</sup>Be ! <sup>11</sup>B ! <sup>7</sup>Li+ (T<sub>1=2</sub>=13.81(8) s [19]). This channel was used for norm alization of the branching ratios as explained later on.

The red dashed histogram in Fig 3a shows a Monte-Carlo simulation of the charged particle energy distribution assuming the previously described decay channels (Fig. 1). The detector e ciency for each channel is included in the simulation. The <sup>10</sup>Be and <sup>11</sup>Be levels are described using R-M atrix theory follow ing the approximation given in the Appendix of Ref. [20]. The parameters of the 10.59 M eV state in <sup>11</sup>Be were taken from the  ${}^{9}Be(t_{P})$  reaction [12] while those for the 18.15 M eV state were taken from [8]. The study of the three body n<sup>6</sup>He break-up channel through <sup>10</sup>Be states allows a determ ination of the energy and width of this interm ediate state from a t of the relative energy of the detected  $^{6}$ H e and particle. The energy and width of the interm ediate state in  $^{10}$ Be obtained from the tare 9.52(2) and 0.30(4) M eV respectively. Previous reaction studies indicated the existence of excited states in <sup>10</sup>Be in this energy region. In neutron exchange reaction an state is identi ed with energy and width values of 9.4 M eV and 290(20) keV respectively [21]. In a recent Li(<sup>7</sup>Li, <sup>6</sup>He) reaction study [22] a level is found at 9.56(2) M eV excitation energy and 141(10) keV width. Including a narrow state with the latter values in our simulation deteriorates the t considerably. Due to the di erence between our results and the one of reference [22] we cannot conclude that it is the same level. The di erent parameters used in the Monte-Carlo simulation

are given in Table 1.

Fig. 3b shows the scatter plot corresponding to coincidence events observed in the opposite detectors D 2 and D 4 for times t< 40 m s. The most signicant features of the plot are the intensity at low energy and the accumulation of events forming a transverse line at low energy, corresponding to the two peaks at 0.7 and 2.2 M eV in the sum energy spectrum. Careful inspection of the high energy region reveals that the coincidences are not evenly distributed, they rather form two elongated bumps or lobes, highlighted by the black dotted lines. C om parison of the experimental scatter plot of Figs. 3b and the M onte-C arlo simulation, shown in Fig. 4a indicates that although the main features of the data are reproduced by the simulation, the distribution of the high energy coincidences is not. This is not a surprise, as the 5-body and 3-body break-up of the 18.15 M eV state in <sup>11</sup>Be are simulated using a phase space m om entum distribution, which neglects the role of possible structure e ects.

As just noted, the incline of the lobes in the scatter plot of Fig. 3b corresponds to lines of slope 7/4 and 4/7. This structure corresponds to a mass-asymmetric two-body break-up where the initial state is broad. The only mass 4 and mass 7 isobars energetically allowed for <sup>11</sup>Li -decay are <sup>7</sup>He+. This comes naturally, as alpha emission is common to all Be isotopes. Furthermore, the <sup>7</sup>He(gs) is the only resonance in <sup>7</sup>He below the + 3n threshold, see Fig. 1, thus it is a natural choice as intermediate state in the 3-body break-up of <sup>11</sup>Be, i.e. <sup>11</sup>Be(18.15 MeV)! + <sup>7</sup>He(gs)! n+ <sup>6</sup>He+. The energy distribution of this decay channel appears as two body break-up, it keeps mem ory of the

rst step if this Q value is much larger than the second one. It is known that the  $^{7}\text{H}e(\text{gs})$  is situated 430 keV above the  $^{6}\text{H}e+$  n threshold [11], therefore the recoil energy given by the em ission of the neutron will be low (61 keV). Thus, the distribution of the two detected charged particles, and  $^{6}\text{H}e$ , in the scatter plot will kinem atically be very close to a two body break-up, but broadened by the recoiling neutron. O ther possible interm ediate steps involving the ground

state of  ${}^{6}\text{H}$  e and the  ${}^{5}\text{H}$  e(gs) resonance would also end up in the 3-body n  ${}^{6}\text{H}$  e channel, but in this case the slope of the two bands would be 6/5 and 5/6, quite di erent from the experim ental distribution.

It is in portant here to point out that the 3-body break-up of the <sup>11</sup>Be states through the ground state of <sup>7</sup>H e cannot be the only decay channel, as in previous experiments a factor of roughly 5 particles per <sup>6</sup>H e ion was determined [6]. This in plies that the majority of the high energy events correspond to the 2 3n channel. However, the phase space description of the 2 3n channel is not able to explain the energy distribution of coincidence events. On the contrary, if sequential decay is assumed, the rst step could be <sup>6</sup>H e(2<sup>+</sup>) + <sup>5</sup>H e(gs), as both states are above the + 2n and + n thresholds, resulting in the 2 3n nal channel. This channel is a very good candidate, as the states are broad, widths of 0.113 and 0.648 M eV respectively [11], spreading the coincidence data in a similar way as the 5-body phase space distribution, but with a dip in the central part,  $E_{D,2}$  '  $E_{D,4}$ , as observed in the scatter plot of Fig. 3b.

A new M onte-C arb simulation was performed. For the 10.59 M eV state in  $^{11}$ Be the two break-up channels from the literature [2] were included. Furthermore, the break-up of the 10.59 M eV state into  $+^{7}$ H e(gs) was considered as a possible contributing channel, since the ngerprint of this channel was

seen near the transverse line (see Fig. 3b). A lthough this channel is expected to contribute with ten times less intensity than the decay through <sup>10</sup>Be, the t of the sum energy spectrum improves by 20% if this channel is in-2 cluded. For the break-up of the 18.15 M eV state in <sup>11</sup>Be the new channels involving the 57 He resonances were considered. The 2 analysis of the energy di erence spectra indicates that up to a 20% admixture of the 5-body direct break-up channel is statistically equivalent to the simulation without any phase space contribution. Table 1 lists the parameters used to describe the various resonances involved and Table 2 sum marizes the di erent decay channels included in this simulation. The resulting sum energy spectrum is shown Fig. 5a. The experim ental data and the M onte-C arlo simulation of the proposed channels are in excellent agreem ent. There is a minor discrepancy between the total simulation and the experimental spectrum at around 7.8MeV. This could suggest the contribution of another state in <sup>11</sup>Be, as previously proposed [8,23], but the lack of statistics in this region prevents us from nding a conclusive explanation for this m inor discrepancy. The great in provem ent achieved by including the sequential decay channels through the <sup>A</sup> He resonances is shown in the comparison of the new scatter plot shown in Fig. 4b with the experim ental one of Fig. 3b. This is further supported by an excellent t of the coincidence energy spectrum.

The energy di erence distribution,  $E^0$ , in the  $8.2 < E_{D2} + E_{D4} < 10$  M eV region, is shown in the black histogram in Fig.5b.A sm entioned before, the  $E^0$  parameter enhances the decay channels where the detected particles are one from the rst step and the other from the nal resonance. We chose this high energy region because one or maximum two channels could contribute to the spectrum. The

phase-space break-up M onte-C arb simulation is shown in dashed green in Fig. 5b, while the sequential break-up including the  $^{7}$ H e(gs) channel is shown in dashed red. The data show a distribution with a clear dip in the middle that is contradicted by the phase-space model. On the other hand, the inclusion of the  $^{7}$ H e+ channel nicely reproduces the double peak shape of the plot. This region is clearly dom inated by the  $^{7}$ H e(gs) channel (see the black dashed line in Fig. 5a).

Table 3 shows the branching ratios to levels in  $^{11}$ Be obtained in this work. The values were calculated from the intensity distribution of the M onte-C arlo simulation, rather than from the direct experimental data, as the experimental coincidence e ciency is di cult to determ ine. In order to normalize the -branching ratios we need to estimate the absolute <sup>11</sup>Li activity. The activity was evaluated using the known branching ratio of the daughter, <sup>11</sup>Be, decay into  $^{7}$ Li(gs and 1/2)+ . The  $^{11}$ Li -decay branching ratio to the rst excited state in  $^{11}$ Be, 7.4(3) %, is the weighted average of the values from [24,25,26,27,28]. The value for <sup>11</sup>Be -decay branching ratio to the 9.8 M eV state in <sup>11</sup>B is 2.9(4) % [29]. The values shown in the second column in Table 3 were obtained assuming negligible -feeding to the <sup>11</sup>Be ground state. The third column shows the branching ratios obtained assuming 2% -feeding to the <sup>11</sup>Be ground state. A possible source of uncertainty in the estimation of the  $-\text{feeding values is the presence of}^{11}\text{Be ions in the incoming}^{11}\text{Libeam}$ . Direct production of <sup>11</sup>Be up to a few percent of the <sup>11</sup>Libeam has been observed previously at ISO LD E [24]. If this is the case, the branching ratios will increase in the same few percent as the direct production of  $^{11}\mathrm{Be}$ .

C om parison with previous branching ratio values [2] is not considered pertinent. A lthough the energy and width of the states in <sup>11</sup>Be are taken from the literature [12,8], the break-up channels are di erent in this and previous analysis, thus resulting in di erent distribution of the feeding. As an additional check, we compare the branching ratio of the 2 + 3n channel to the published  $P_{3n}$  value, 1.9(2)% [5,24], obtained assuming no -feeding to the ground state. The value obtained in this work, 1.4(5)%, is smaller, but one has to take into account that the 2 3n breakup of the 10.59 M eV state has a distribution that is below our particle threshold.

## 4 Summary and conclusions

The charged particles em itted in the -decay of <sup>11</sup>Li have been measured in coincidence using a highly segmented setup. The coincidence energy spectrum can be explained mainly by the 2 + 3n and n+ + <sup>6</sup>He channels. The analysis presented in this work shows that the phase space energy description of the 2 3n channel is not capable of explaining the correlations at high energy ob-

served in the -decay of<sup>11</sup>Li (Fig. 3b). In particular the lack of events in the central region of the scatter plot is intriguing. This was also visible in Fig. 9 of Ref. [2] although not considered by the authors, probably due to the low statistics. This minimum forms two lobes of slopes 7/4 and 4/7 indicating the involvement of mass 4 and mass 7 nuclei in the stage of a sequential decay. This naturally brings  $^{A}$  H e isotopes into play, as they are involved in the break-up of all other Be isotopes. A Monte-Carlo simulation was perform ed including these channels,  $^{11}Be(10.59, 18.15)! + ^{7}He! ^{6}He+ + n$ and <sup>11</sup>Be(18.15)! <sup>6</sup>He( $2^+$ )+ <sup>5</sup>He! 2 + 3n, plus the con med n <sup>6</sup>He breakup of the 10.59 M eV state in <sup>11</sup>Be through the 9.5 M eV state in <sup>10</sup>Be, whose energy and width have been determ ined in this work. The resulting simulation reproduces well the correlations observed in the scatter plot, thus rejecting a description of the break-up of the 18.15 MeV state in terms of phase space energy sharing only, although up to 20% m ixture of direct break-up can not be statistically excluded. We also check the energy di erence spectrum  $E_{D,2}$ - $E_{D,4}$  in the region where we expect the <sup>7</sup>He+ sequential decay channel to dom inate. Neither 5-body 2 + 3n break-up [2] nor 3-body n <sup>6</sup>He break-up [8] described by phase space energy distribution reproduces the structure observed in this spectrum . Only by introducing the sequential break-up through <sup>7</sup>He(qs) into n<sup>6</sup>He nal state we are able to explain the two-peak structure observed in the energy di erence distribution,  $E^0$ .

The study of the <sup>11</sup>Li -delayed particle em ission is an excellent tool to determ ine the highest excited states in <sup>11</sup>Be, a di cult task to be singled out by other experimental techniques. These results constitute a signi cant step beyond the previous -decay work [2]. The experimental data presented in this work indicate that the decay of excited states in <sup>11</sup>Be above the charged particle thresholds cannot be explained solely as a multi-particle break-up dom inated by the phase space energy distribution. We conclude that <sup>A</sup>He resonant states play a signi cant role in the sequential break-up of <sup>11</sup>Be excited states. This naturally suggests a more prominent role of nuclear structure effects in the description of the break-up process of these states than previously assum ed.
