Master Space, Hilbert Series and Seiberg Duality

A bstract

W e analyze the action of Toric (Seiberg) duality on the com bined m esonic and baryonic m oduli space of quiver gauge theories obtained from D 3 branes at C alabi-Yau singularities. W e analyze in particular the structure of the m aster space, the com plete m oduli space for one brane, for di erent toric phases of a given singularity. W e show that the H ilbert Series for the largest com ponent of the m aster space of di erent phases is the sam e, when re ned w ith all the non anom alous charges. T his re ects the fact that the quiver gauge theories associated w ith di erent phases are related by Seiberg duality when the num ber of branes is greater than one.

1 Introduction

The moduli space and the BPS operators are very in portant concepts for N = 1 supersymmetric eld theories. These have been recently analyzed, in the context of D 3 branes at singularities, using the concepts of M aster space, H ilbert series and P lethystic exponential in [1, 2, 3, 4, 5, 6, 7, 8, 9]. The moduli space and the chiral ring are sometimes modied by non perturbative dynamics. It is interesting to see if we can get some inform ation about this dynam ics using the M aster space and the H ilbert series 4 . In this paper we focus on Seiberg Duality. This is a quantum eld theory duality that it is realized as Toric Duality in the setup of D 3 branes at singularities. Toric Duality was discovered in [11], analyzed in [12, 13, 14] and identi ed as Seiberg duality in [15, 16]. It corresponds to a situation in which one singular CY manifold has more than one quiver gauge theory that has this manifold as its mesonic moduli space of vacua. Given a CY singularity, X there are in fact an in nite num ber of gauge theories that have X as their m esonic m oduli space of vacua and there are several studies of this in the literature. See for example the use of Picard Lefshetz transform ations introduced in this context in [17, 18] to generate the corresponding duality trees [19]. There is however a special subset of quiver gauge theories that are the focus of the present paper. If the singularity X is toric, then this

special subset is characterized by having the ranks of all the gauge groups equal, and each eld in the quiver appears pr! ecisely twice in the superpotential. Such a quiver theory is called a toric phase and the singularity X m ay have m ore than one toric phase. The num ber of toric phases is in fact a nite num ber and it is an interesting problem to count this num ber for a given singularity X. The analysis of toric phases for certain classes of quiver gauge theories called the Y^{pq} theories was done in [20] and was found to have an exponential grow th in p for small values of q.

From a eld theory perspective, for theories which are not necessarily living on D3 branes at singularities, Seiberg dual theories have the sam e m oduli space and the sam e spectrum of chiral operators. This nicely agrees with our understanding of the m esonic m oduli space for the theories on D3 branes at singularities. It is X in the abelian case, and Sym^N X in the non-abelian case, for all toric phases. This leaves a question on the baryonic m oduli space or alternatively the com bined m esonic and baryonic m oduli space for their subject of investigation in the present paper.

In this paper we look at a collection of examples, X, which have more than one toric phase and we will study their full moduli space, including baryonic directions. A system atic investigation of the full spectrum of chiral operators has been carried out in the series of papers [3, 5, 6, 7, 8, 9]. A crucial ingredient in the analysis is the concept of the master space, which is the complete moduli space for one brane. In the case of one brane all gauge groups, being abelian, decouple in the IR and we are left with a theory of chiral multiplets and no gauge interactions (these still play a crucial role and turn into qlobal baryonic symmetries). The master space is generically reducible into di erent components that have a variety of structures and a variety of dimensions. There is one large component called the coherent component and there are a number of other low er dim ensional (generically linear) components. Here linear means copies of som e C^{1} for som e value of 1. In this paper we study the action of toric duality on the master space and we compute the Hilbert series for each toric phase. It turns out that the coherent com ponent of the master spaces of di erent phases are in general not isom orphic and the num ber of lower dimensional components dier between the phases. Furtherm ore, the fully re ned H ilbert series for the coherent component, written in terms of fugacities for all the classical global sym m etries of the theory, are not equal for di erent phases. This is a som ew hat disappointing result but there is how ever a point of light. Som e of the global sym m etries are anom alous and som e are anom aly free. W e discover that the H ilbert series of the coherent component restricted to the set of non-anom alous charges is the same in all phases. In particular, for non-chiral theories, where all the abelian symmetries are non anom alous, we conclude that the coherent com ponents of di erent phases are isom orphic. This is the action of toric duality on the master space.

We interpret this result as a consequence (or a check) of Seiberg duality. Theories corresponding to di erent phases are Seiberg dual for N > 1 (here and henceforth N denotes the num ber of D 3 branes probing the singularity). D ual theories have the same spectrum of chiral operators, which can be organized into representations of the non-anom alous global sym m etry group. A nom alous sym m etries, on the other hand, are not physical and can be di erent in di erent phases. A s argued in [5, 7, 9], the generating

function for the largest component of the moduli space of the theory with N branes can be reconstructed from the know ledge of the H ilbert series for the coherent component of the master space. This is done by decomposing the H ilbert series into sectors with de nite baryonic charge and by counting symmetric products through the P letystic Exponential in each sector. It is then an interesting check of the procedure just explained that the H ilbert series for the coherent component of dierent phases is the same when expressed in terms of the non anom abus charges.

The paper is organized as follows. In Section 2 we discuss the general problem and present the main result of this paper in the form of a conjecture. We next proceed with exam ples. We analyze chiral and non-chiral theories. There is a class of toric non-chiral quiver gauge theories which is characterized by toric diagram s that have no internal points. This class is well studied in the literature and consists of the $C^3 = (Z_2 - Z_2)$ orbifold, together with the L^{aba} class of theories, introduced in [21, 22] and further studied in [23, 24, 25]. The $C^3 = (Z_2 - Z_2)$ model, being an orbifold of C^3 has only one toric phase ⁵ and therefore is trivial for the discussion at hand that requires toric singularities which have more than one toric phase. L^{aba} theories have a num ber of toric phases and their master space is studied in Section 3. The number of toric phases depends on a and b and is computed in section 3.2.1. In Section 4, we rst analyze in detail the case of the two phases of F_0 , which is the sim plest chiral model with more than one phase, and for which we can also com pute the generating functions for N > 1.W e then analyze selected exam ples of chiral theories, including dP_2 and dP_3 . In Section 5, we discuss the generating functions for N > 1. The paper ends with conclusions and an Appendix on technical details about the H ilbert Series.

2 The Coherent Component

W e analyze the quiver gauge theories living on D 3 branes at singularities focusing on toric phases where all gauge groups have the sam e rank, N, equal to the num ber of D 3 branes. The gauge sym m etry is thus U (N)^g, where g is the num ber of gauge groups.

The master space $F^{[}$ is defined as the set of solutions of the F-term constraints when all the chiral multiplets are regarded as c-numbers. Since all abelian groups decouple in the R, this is the same as the R moduli space of the quiver theory for N = 1. The master space $F^{[}$ is a toric variety of dimension g + 2. The g + 2 toric action corresponds to the global U (1) symmetries of the quiver theory: three mesonic symmetries corresponding to the isometries of X plus g 1 baryonic symmetries corresponding to the g 1 U (1) gauge symmetries that decouple in the R. There are g 1 gauge symmetries since the overall U (1) in the quiver is decoupled from the Lagrangian. Only d of the U (1) symmetries are anom aly free, where d is the number of external points in the toric diagram⁶. The three

⁶d counts the num ber of integer points on the perim eter of the toric diagram ; integer points on the sides of the diagram , which correspond to orbifold singularities of the base of X , should be counted.

m esonic sym m etries are always non-anom alous.

The master space is generically reducible. It decomposes into a large non-trivial component, called the coherent component and denoted ^{In}F[[], plus other lower dimensional pieces, typically linear. This is similar to the familiar decomposition of the moduli space of N = 2 supersymmetric theories into Higgs and Coulom b branches. As shown in [5,7], ^{Im}F[[] is a g + 2 dimensional Calabi Yau cone. For N = 1 there are no gauge groups and no strong gauge dynamics. The moduli space can be computed at the classical level. The A belian nature does not allow the use of Seiberg duality to argue that the N = 1 m oduli space is the same for dimensional process. In fact, we will see that, in general, dimensional components are dimensional to argue the toric duality that we now examine.

A very useful tool to characterize a toric variety is its fully re ned Hilbert series. We introduce a set of auxiliary parameters (fugacities) $ft_ig_{i=1}^{g+2}$ and de ne the generating function for holom orphic functions

where $n_{k_1,\ldots,k_{g+2}}$ is the number of holom orphic functions with charge $fk_1;\ldots;k_{g+2}g$ under the global U $(1)^{g+2}$ symmetry. The set of holom orphic functions on the master space is just given by all polynom ials in the chiral eldsmodulo the F-term s and the H ilbert series can be viewed as the generating function for the N = 1 chiral ring that includes both mesonic and baryonic objects. We can write H ilbert series for the full master space and for its coherent component. The latter being irreducible, a ne, and toric is completely specified by its set of holom orphic functions. The fully refer to H ilbert series contains all inform ation about the coherent component.

On an empirical basis, it was observed in [7] that the coherent components of di erent toric phases are not equal. A particular feature is their fully rened H ilbert series which are di erent. This fully rened H ilbert series contains how ever both anom abus and anom aly free charges. Since we are interested in applications to quantum eld theory, a generating function which is graded by all sym metries, including the anom abus ones, is too much to require. A nom abus charges are not good quantum numbers in theories with N > 1 and cannot be used in comparing di erent phases. Only global non-anom abus sym metries are invariant under Seiberg duality. Correspondingly, the number of chiral operators with equal non-anom abus charges. It then makes sense to consider a H ilbert series which is partially rened with respect to all the d non-anom abus charges. W e will see through exam ples that this partially rened H ilbert series is now an invariant under toric duality and we form ulate the follow ing

CONJECTURE Toric phases of quiver toric gauge theories have the same Hilbert Series of the Coherent Component of the master space $I^{T}F^{I}$, rened in terms of all the fugacities of the global non anomalous U (1) eld theory charges.

A special case of this conjecture is when the quiver theory is non-chiral. In all such cases all global U (1) sym m etries are anom aly free and the coherent components of the various toric phases are invariant under toric (Seiberg) duality. On the other hand, for chiral theories the coherent components of di erent toric phases are generically di erent. The di erent algebraic structure can be learned and is specified by their fully re ned (including anom alous charges) H ilbert Series.

3 Non-Chiral Theories

Quiver gauge theories are non-chiral if every edge in the quiver has the same number of arrows in both directions. See Figure 1 for simple examples of non-chiral quivers. The number of non anom alous U (1) global symmetries is g + 2; equal to the dimension of the coherent component of them aster space ^{In}F[[]. In this case our general C on jecture implies that the coherent components of Seiberg dual gauge theories are isomorphic algebraic varieties.

We use the L^{aba} theories as archetypal examples of non-chiral theories. They are particularly easy to analyze in the context of this paper since there are m any toric phases, all of which have a simple brane interval realization. For every b a, positive integers, we have a singularity L^{aba} and a quiver gauge theory that can be realized in Type IIA with D 4 branes on a circle with b NS branes and a NS⁰ branes (see Figure 2). Toric phases di er by a rearrangem ents of NS and NS⁰ branes on the circle. The num ber of all possible arrangem ents is counted in Section 3.2.1.

Before entering into technical details and discussing specic c examples of di erent phases, we summarize the results of our analysis. Dierent phases have dierent linear components, corresponding in part to a variety of Coulomb branches. The coherent component of them aster space for the L^{aba} theories is instead the same for all toric phases. It is a a + b + 2 dimensional manifold of complete intersection given by a collection of 2a + 2b variables which are subject to a + b = 2 quadratic equations. The corresponding H ilbert series in one variable can be simply written as

where t gives weight 1 for each generator and the relations are always quadratic. This can be further re ned by realizing that the master space has two non-abelian hidden global symmetries which are induced by the structure of the toric diagram and are related to the two singularities $C^2=Z_a$ and $C^2=Z_b$. There are two hidden global symmetries SU (a) and SU (b) under which the elds transform as one copy of the fundamental of each and one copy of the antifundamental of each, giving all together 2a + 2b elds. W ith the abelian charges the symmetry of the master space is SU (a) SU (b) U (1)⁴. We can parametrize the 4 U (1) charges by assigning a fugacity $t_i; i = 1; ::: 4$ to each of the 4 external points in the toric diagram. Under these charges each copy of the 4 multiplets above carries a di erent charge. The relations are singlets of the non-abelian groups. G etting all this information together, the H ilbert series takes the form

A special case is when a = 0 and the L^{0b0} singularity is the N = 2 supersymmetric orbifold $C^2=Z_b$ C with its corresponding N = 2 supersymmetric quiver. In this case the global symmetry of the master space reduces to SU (b) U (1)³ and the 2b generators of the coherent component of the master space transform as one copy of the fundamental [1;0:::;0] representation and one copy of the anti-fundamental [0:::;0;1] representation of SU (b). There are only 3 external points in the toric diagram and the 3 fugacities $t_i; i = 1;2;3$ can again be assigned one per each of the external points. The H ilbert Series takes the form

This coincides with equation (3.2) with a = 0, all non-abelian fugacities are set to 1, and all $t_i = t$.

3.1 The double conifold

The double conifold L^{222} is the singular Z_2 quotient of the conifold singularity. It is de ned by the quadric $x^2y^2 = wz$ in C^4 . The IR dynamics of a stack of N regular D 3 branes at the tip of the cone has two possible non-chiral UV descriptions. These are the two supersymmetric gauge theories with quivers given in Figure 1 and superpotentials:

These gauge theories have the same mesonic moduli space of vacua and they are related by toric (Seiberg) duality.

The IR properties of Seiberg dual gauge theories must be equivalent, and it is interesting to understand what is the e ect of Seiberg duality on the M aster Space. For this purpose let us compute the H ilbert series for the two phases.

The H ilbert series for the m aster space for each of the two phases, written as a function of the fugacity for the R charge, $t = t_i$ of equation (3.2) are

where we give charge 1 to all bifundamental elds, and charge 2 to all adjoint elds 7 . The two Hilbert series are dierent. This fact gives a rst hint that the two master

spaces are indeed not isomorphic. A direct analysis of the algebraic equations de ning the two M aster Spaces reveals that they are not isomorphic varieties. They are indeed both reducible and given by: $(F_{L^{222}})_{I} = ({}^{Irr}F_{L^{222}})_{I} [(L_{L^{222}}^{1})_{I}]$

and $(F_{L^{222}}^{[})_{II} = ({}^{Im}F_{L^{222}}^{[})_{II} [(L_{L^{222}}^{1})_{II} [(L_{L^{222}}^{2})_{II} [(L_{L^{222}}^{3})_{II}], where$

Here and in the following, V (ff_i(X)g) denotes the zero locus of the set of algebraic functions $f_i(X$).

Equations (3.7), (3.6) show two typical behaviors of the master space of non-chiral theories under Seiberg duality: the master spaces $F^{[}$ of di erent toric phases are in general non isom orphic and the num ber of smaller dimensional component L^{i} is in general di erent; the coherent components $^{In}F^{[}$ are instead isom orphic. In the case of the double conifold it is indeed easy to see that the coherent components de ned by the equations in (3.7), (3.6) are isom orphic and de ne the product of two conifolds:

O ne can also compute the H ilbert series of the coherent components of the two phases. They are obviously the same, equal to the H ilbert series of the product of two conifolds:

This is consistent with equations (3.2) and (3.3), setting a = b = 2; $t_i = t$ and the non-abelian fugacities to 1. M oreover one can compute the fully re-ned H ilbert series for the two coherent components with all the six fugacities t_i , i = 1;:::;4, for the abelian charges and x_1 ; x_2 , for the non-abelian charges, all of which being non-anomalous global symmetries:

which is consistent with equation (3.3), with x_1 and x_2 weights for the SU(2) SU(2) symmetry. The full set of fugacities for the elds in the two phases of L²²² are given in Table 1. For a d dimensional toric variety the fully rened H ilbert series, with all the d fugacities, associated with the U(1)^d toric action, contains information that is in one to one correspondence with the coordinate ring of holom orphic functions of the toric variety. Hence also a correspondence to the points in the dual cone "m odulo SL(d;Z) transformations. This means that the fully rened H ilbert series denes the algebraic variety m odulo isom orphisms (see Appendix A form ore details). Indeed equation (3.10) in plies that ($^{Im}F_{L^{222}}^{I}$)_I and ($^{Im}F_{L^{222}}^{I}$)_{II} are isom orphic algebraic varieties, as we already deduced from the direct analysis of the algebraic equations.

3.2 L^{aba}

 L^{aba} with b a is an in nite class of non isolated singularities that includes the double conifold, previously analized, as a special case: L^{222} . The L^{aba} singularities are described by the quadric $x^a y^b = wz$ in C^4 . It reduces to the equation for the double conifold for the particular values a = b = 2. The L^{aba} singularities contain two lines of non isolated singularities passing through the tip of the cone: $C^2=Z_a$ and $C^2=Z_b$.

3.2.1 The num ber of Toric phases for L^{aba}

W ith the help of the Polya's Enumeration Theorem we can count the number of toric phases for L^{aba}. The formula does not have an explicit expression but we can write a generating function which can compute the number of phases for given values of a and b. To start the counting we use the Type IIA brane realization of this set of theories with b NS branes and a NS⁰ branes. Toric phases di er by a di erent arrangement of these branes on the circle. We are thus led to count the number ways one can arrange a objects of one type and b objects of another type on a circle. The problem has obviously a cyclic symmetry as we are ordering objects on a circle but in addition it has a dihedral symmetry as a referitor of these objects on the circle does not change the theory under discussion and the toric phase remains the same under the referitor. We are thus led to

3.2.2 Toric phases for L^{aba} and Seiberg duality

The R dynam ics of N D 3 branes at the tip of the cone is a non-chiral gauge eld theory with gauge group $\int_{i=1}^{a+b} U(N)$. There are many di erent toric phases depending on the arrangement of the NS and NS⁰ branes on the circle. These theories have di erent UV Lagrangians, with di erent eld content and di erent superpotentials, but they are all equivalent in the R and are related by toric (Seiberg) dualities.

Let us denote by 'phase I' the phase with the chiral eld structure which is shown in the quiver in Figure 2 and superpotential:

where the index i is cyclic modulo a + b and the elds X_{ii} transform in the adjoint representation of the i-th gauge group, while X_{ij} transforms in the fundam ental representation of the i-th group and in the anti-fundam ental of the j-th group. We want to study the coherent component ${}^{ID}F_{L^{aba}}$ of the master space for this particular toric phase. The coherent component is by de nition the locus of the F-at term equations where generically each eld has a non-zero vev.

Let us start with the degenerate case a = 0, b = n. In this particular case the gauge theories have N = 2 supersymmetry and $L^{0n0} = C^2 = Z_n - C$. It is easy to show that ${}^{In}F_{C^2=Z_n-C}^{[} = F_{C^2=Z_n}^{[]} - C$, and

Namely ${}^{In}F_{C^2=Z_n-C}^{[}$ is a product of equation (3.18) and the complex line parametrized by the adjoint elds, which are all equal. To simplify the discussion we will ignore the adjoint elds and the complex line C in the geometry transverse to the D 3 branes. If we call x_i, i = 1;:::;n, the monom ial X_{i;i+1}X_{i+1;i} m ade with the fundamental elds at the right of every gauge group, the equations (3.18), dening the master space of C²=Z_n, are $x_1 = x_2 = \frac{\pi}{\pi} x = x_n$.

Let us now consider the generic L^{aba} case. Let us enumerate them onom ials X_{iji+1}X_{i+1;i} as follows: those drawn in solid line in Figure 2 are called x_i, i = 1;:::;a; the ones drawn with dotted line are called y_j, j = 1;:::;b; and the adjoint eds are called k, k = 1;:::;b a. The coherent components of the master spaces of the L^{aba} theories is the locus of the F-term equations where generically all the eds are di erent from zero. It is given by the equations: $x_1 = x_2 = \frac{\pi}{3} x = x_a$ and $y_1 = y_2 = \frac{\pi}{5} y = y_b = \frac{\pi}{5} = 2 = \frac{\pi}{5} a = \frac{\pi}{5} a = \frac{\pi}{5} a = \frac{\pi}{5} x^2 = \frac{\pi}{3} x = x_a$, $y_1 = y_2 = \frac{\pi}{5} y = y_b$ in C^{2b+2a}. These are the equations describing the master space of C²=Z_a and C²=Z_b respectively, and:

As explained above, a given singularity generically corresponds to many UV eld theories which are related by toric (Seiberg) dualities. The L^{aba} gauge theories have an easy description in Type IIA in term of D4, NS5, NS5⁰ branes as shown in Figure 2. In this setup a Seiberg duality corresponds to the exchange of one NS5 brane with one NS5⁰ brane. Starting with the branes disposition in Figure 2 there are only two exchanges of NS, NS⁰ branes that can a ect the eld theory content and the superpotential of the theory and they are shown in Figure 3.



Figure 3: Two relevant toric phases in L^{aba} quiver gauge theories. The labels x, y, w, z, u, are for the quadratic m onom ials in the bifundam ental elds, while the labels a, b are for the adjoint elds.

Seiberg duality is a local transform ation of the quiver and of the superpotential and thus it is a local change in the F-term equations de ning ${}^{\rm In}F_{L^{\rm aba}}^{[}$. We will show that the local equations for the coherent component of the di erent toric phases in Figure 3 are algebraically equivalent. Because the remaining part of the quiver is not changed by Seiberg duality the previous observation in plies that Seiberg duality is an isom orphism of ${}^{\rm In}F_{L^{\rm aba}}^{[}$.

Let us use the labels de ned in the Figure 3 for the quadratic m onom ials m ade with the bifundam ental elds. There are two possible elementary steps.

The equations de ning ^{In}F[[] for the upper left quiver are x = y = u and a = w, while the equations de ning the coherent component ^{In}F[[]_{Snl} of the Seiberg dual quiver on the upper right are x = w = u and y = a. The two sets of equations are clearly isom orphic, hence ^{In}F[[] = ^{In}F[[]_{Snl}.

Similarly, the equations de ning ${}^{Im}F$ [for the bottom left quiver are x = w = u, and y = z, while the equations de ning ${}^{Im}F$ [for the bottom right quiver are x = y = u = b, and w = z = a. Once again these two sets of equations de ne isom orphic varieties, hence ${}^{Im}F$ [= ${}^{Im}F$ [s.r.

All the possible Seiberg dual phases of L^{aba} can be obtained by combining the two elementary transform ations shown in Figure 3. This means that the coherent component of the master space $\lim_{Laba} I_{Laba}$ is invariant under Seiberg duality:

Because ${}^{In}F_{L^{aba}}$ is invariant under Seiberg duality the fully re ned H ilbert series is invariant under Seiberg duality, and our general C on jecture is right for the in nite class of the L^{aba} gauge theories.

4 Chiral theories

Chiral theories are very common in the setup of D3 branes at singularities and in the AdS/CFT correspondence. For chiral theories part of the global U (1) symmetries are anom alous and they do not have an explicit dual geometric interpretation. For this reason part of the U $(1)^{g+2}$ symmetries, which we use to completely characterize the toric varieties ${}^{In}F^{[}$, is lost due to quantum dynamics. The dual geometric analysis done in [9,7] points towards the relevance of the coherent components of the master space ${}^{In}F^{[}$ for the study of the complete moduli space and the BPS operators for N > 1. In the following subsections we will do a case by case analysis to see what we can learn about the quantum dynamics using the concepts of the Master space and Hilbert series as tools of study.

4.1 F₀

The F_0 theory is our st example of chiral gauge theory. It describes the low energy dynamics of a stack of D 3 branes at the tip of the complex cone over $P^1 = P^1$. It has two

toric phases [11, 12] with the quivers in Figure 4, and the superpotentials:

for the second phase. From the equations (4.21), (4.22) it is easy to to see that ${}^{In}F_{F_0^{I}}^{[}$ is a complete intersection in C⁸ and it is isom orphic to the product of two conifolds: C C; while ${}^{In}F_{F_0^{II}}^{[}$ is a quite complicated not complete intersection in C¹².

W e would like to get an understanding on how di erent these two varieties are. The rst step is to use a \m ore toric" description. Indeed the coherent component of the

m aster space ^{In}F [is in general a toric, g + 2 dim ensional, C alabiYau cone, and it can be described by a sym plectic quotient or a linear sigm a model language. In [7] it is shown that:

^{In}F[[]_{F⁰₀} can be described by a toric diagram in Z₆ (in this speci c case g + 2 = 6), with 8 vectors that satisfy 2 linear relations, while ^{In}F[[]_{F¹₀} can be described by a toric diagram in Z₆, with 9 vectors that satisfy 3 constraints. This means that the coherent components of the M aster Spaces for the two phases of F₀ are di erent toric varieties. Indeed the two ^{In}F[[] have two di erent toric diagram s that cannot be m apped one into the other by an SL (6;Z) transform ation. It is natural to wonder how much they are di erent.

To answer this question let us compute som e Hilbert Series as explained in the Appendix. The toric varieties ^{In}F[[] are g + 2 dimensional and naturally adm it g + 2 fugacities associated to the imaginary U (1) part of each C in the (C)^{g+2} action. From the eld theory point of view we can divide the fugacities into a set associated to the non anom abus sym metries and a set associated to the anom abus sym metries. Let us assign charges and fugacities to the elementary elds as in Table 2. F₁, F₂ are the avor symmetries, R is the R-symmetry, B is the baryonic symmetry and A₁, A₂ are two anom alous U (1) symmetries. We introduce a fugacity t for the R-charge, x; y for the avor charges, b for the non anom alous baryonic symmetry and a₁; a₂ for the anom alous ones with the normalization indicated in the table. We can compute the completely re ned H ilbert Series for the two phases obtaining the result:

This veries our C on jecture. We learn that the coordinate rings of the two varieties are exactly the same if labeled just in terms of the non-anomalous charges. This fact, in a sense, de nes how similar the two varieties are. If the two toric varieties ${}^{\rm IT}F_{F_0^{\rm I}}^{[}$, ${}^{\rm IT}F_{F_0^{\rm I}}^{[}$ are isom orphic then there must exist an SL (2;Z) transform ation on the a_1, a_2 fugacities that maps the H ilbert Series for the two phases. To see if this is possible let us expand the two functions in powers of the transformation.

It is easy to realize that the two series are quite sim ilar in terms of the non-anomalous charges but di er for the anomalous charges a_i , and there is no SL(2;Z) transformation that can map one series into the other.

$4.2 \, dP_2$

The dP₂ theory is our second example of a chiral theory. It is the low energy gauge theory living on a stack of D 3 branes at the tip of the complex cone over the second del Pezzo surface: C_c (dP₂). It has two toric phases [11, 12] with the matter content given by the quivers in Figure 5 and superpotentials:

To analyze the M aster Spaces and its coherent components we use the H ilbert Series. The m aster space is 7 dim ensional and therefore we expect 7 U (1) global sym m etries, 4 of which are baryonic that further divide to 2 anom alous and 2 anom aly free charges. These last two U (1) charges are expected to enhance to $E_2 = SU(2) = U(1)$ [27]. Let us re ne the H ilbert Series with all the fugacities associated with the non-anom alous U (1) global sym m etries. W e denote the 5 anom aly free fugacities by t_i , as given in Table 3. Note that, in this notation, the sym m etries Q_i are all R charges. The two baryonic charges x; b of E_2 are related to the t_i 's by $t_1 = x=b$; $t_2 = b^3=x$; $t_3 = 1=b^4$; $t_4 = xb^3$; $t_5 = 1=bx$: W e sum m arize the translation between anom aly free charges in Table 4.

Let us start by computing the H ilbert Series for the complete M aster Space F[[] of the two phases in terms of just one anomaly free charge, obtained by setting all $t_i = t$. It is important to stress that t is not a fugacity for the exact R symmetry, which is given in Table 4, but rather it is a fugacity for a computationally convenient R-symmetry. The H ilbert Series for the coherent component ImF[[] turn out to be exactly the same in the

On the other hand one can easily check that the full H ilbert series for the master space is di erent, H (t; F $_{(dP_2)_{II}}^{[}$) \in H (t; F $_{(dP_2)_{II}}^{[}$), meaning that F $^{[}$ for the two phases is di erent and possibly reducible into di erent irreducible components.

The Hilbert Series for ${}^{In}F_{(dP_2)_I}^{I}$ and ${}^{In}F_{(dP_2)_{II}}^{I}$, rened with the fugacities for all the non-anom abus symmetries are exactly the same:

thus con ming our general Conjecture.

We can also re ne the H ilbert series with the remaining two fugacities a_1, a_2 associated to the eld theory anom alous U (1) sym metries. A computation using the charges in Table 3 shows that the completely re ned H ilbert series are dierent: H ($t_1; a_1; a_2; \operatorname{Im} F_{(dP_2)_1}^{[}$) & H ($t_1; a_1; a_2; \operatorname{Im} F_{(dP_2)_1}^{[}$).

4.3 dP₃

The dP₃ theory is our last example of a chiral theory. It is the low energy gauge theory living on a stack of D 3 branes at the tip of the complex cone over the third del Pezzo surface: C_c (dP₃). It has four toric phases with the matter content given by the quivers in Figure 6 and superpotentials [15, 16]

There are six non anom alous charges corresponding to the six external points of the toric diagram . We use the assignment of charges given in [27] and reported in Table 5. We use the fugacity t to label the R symmetry and fugacities t_i ; i = 1 :::6 for the 6 anom aly free symmetries Q_i ; i = 1 :::6. As for dP_2 the Q_i are R-charges. A choice form esonic and baryonic anom aly free charges is reported in Table 6.

For simplicity, we consider only the coherent component of the four phases. The H ilbert series can be computed with the m ethods explained in [7]. Re ning with only one fugacity $t_i = t$ we nd

The fully re ned Hilbert series depending on eight fugacities is instead di erent for the various phases.

The H ilbert series simplies if the avor charges F_1 ; F_2 are neglected. The elds can be organized into representations of a symmetry SU (3)_H SU (2)_H, with y_1 ; y_2 weights for SU (3) and x weight for SU (2) as discussed in [27]. The H ilbert series can be written as

It is not clear whether this expression in plies the existence of a hidden symmetry, since the series expansion in representations contains negative signs. Moreover the SU(3)_H SU(2)_H symmetry does not commute with the avor symmetry. A dierent SU(3) SU(2), enhancing also anom alous symmetries, was used in [7] to nd a positive sign expansion for the H ilbert series of dP₃ into irreducible representations.

5 The partition function for N > 1

The plethystic program can be e-ciently applied to the study of the coherent component of the moduli space for N $\,>\,1\,$ [9]. The H ilbert series g_N (t;X), counting the combined

baryonic and m esonic gauge invariant operators param eterizing the coherent component at nite N, is obtained from the Hilbert series for N = 1, which we computed in the previous sections. In the notation of the previous Sections $g_1(t;X)$ H ($t;^{Im}F_X$). As shown in [9], the plethystic program requires a decomposition of the N = 1 generating function into sectors of de nite baryonic charge, to which the plethystic exponential is applied.

Since the quiver gauge theories corresponding to di erent toric phases are Seiberg dual, the validity of the Pletystic program requires that it commutes with toric duality. As is shown below this is indeed the case.

The general construction in [9] is based on a decomposition of the Hilbert series $g_1(t_i;X)$ rened with the non-anomalous charges

on the lattice (the GKZ fan) of an auxiliary toric variety, which is the space of K ahler parameters of the original toric threefold X. This variety is of dimension K = I = 3 + d, where I is the number of internal points and d is the number of vertices of the toric diagram of X. The lattice can be parametrized with a set of integer K ahler parameters $_1;:::;_{K}$. The generating functions $g_{1;_1;::;_{K}}$ are geometrical in nature and they can be computed using the equivariant index theorem, as given in Equation (4.18) of [9]. $g_{1;_1;::;_{K}}$ is given by a monomial in the baryonic fugacities multiplied by a non trivial function in the mesonic fugacities. m ($_1;:::;_{K}$) are integer multiplicities. We will not

enter in the details of this construction and we refer the reader to [9]. The important point for our ensuing discussions is that the plethystic program can be applied to the N = 1 partition functions at each point of the GKZ fan in order to obtain the nite N generating function

It is a general conjecture that all N = 1 generating functions for toric quivers can be decomposed as in (5.32). We tested this conjecture for a series of selected models. We will refer in the following to all the models where the previous construction is applicable.

Note that the construction is manifestly independent of the toric phase. In fact, as described above, $g_1(t_i;X)$, re-ned with the non-anom abus charges, is the same in all toric phases and $g_{1;1;:::;\kappa}$ can be computed from the geometry of X only. This ensures that the GKZ prescription, when applicable, commutes with toric duality.

The N = 1 m aster spaces of di erent phases are in general di erent algebraic varieties, but the spectrum of BPS operators param eterizing the coherent component, written in term s of the non anom alous charges, is the same, both for N = 1 and for arbitrary N > 1.

5.1 F_0 and multiplicities

We now consider the specic example of F_0 where we can write quite explicit form ulae and discuss the issue of multiplicity.

The K ahler moduli space for F_0 is of dimension two. The localization partition functions $g_{1; 1; i::; 2}$ have been computed in [9] and read

where we set $t_1 = tb; t_2 = t=b$. Note that the dependence on b of the functions $g_{1; 1;...; 2}$ is purely multiplicative and is given by $b^{1} 2$.

To use decom position (5.32) we need to com pute them ultiplicitiesm ($_1$;:::; $_K$) which in general is a di cult task. We proposed in [9] that, in simple models, the multiplicity of points in the GKZ lattice is counted by an auxiliary partition function, so-called Z_{aux} and de ned as follows. Take the simpler quiver than the original by neglecting any repeated arrows and then form the space of open but not closed loops in this simplified quiver. Z_{aux} is simply the (re ned) H ilbert series of the ring of open paths modulo loops and relations and it is a generating function form ultiplicities. For example, in the case of F_0 , we can grade the ring with t_1 ; t_2 which play the role of GKZ parameters. Multiplicities can be read from the expansion

The procedure to determ ine the re ned generating function g_1 in (5.32) is now to replace a term $t_1^{-1}t_2^{-2}$ in $Z_{aux}(t_1;t_2)$ by the expression for $g_{1;1;2}$.

We now compute the auxiliary partition function for F_0 . In addition to t_1 ; t_2 we can use the anom alous symmetries to grade the ring of open paths in the quiver. The auxiliary function depends on dimer combinatorics and, apparently, it depends on the toric phase. It is interesting to compute the fully rened auxiliary function $Z_{aux}(t_1;t_2;a_1;a_2)$ and compare the result obtained for the various toric phases.

In phase I we can form a single loop in the simplied quiver, and the GKZ ideal is abcd = 0. The auxiliary partition function is:

W e see that the fully re ned auxiliary partition functions are di erent in di erent phases. However, they become equal for $a_1 = a_2 = 1$. In particular the multiplicities m_{1;2} m^{1;II}_{1;2} ($a_1 = 1; a_2 = 1$) do not depend on the phase.

The N = 1 Hilbert series decomposition can be generalized to the fully rened $g_1(t_1;t_2;x;y;a_1;a_2)$. The two auxiliary partition functions can be expanded as

We see that the GKZ decomposition works in all toric phases of F_0 , with details that depend on the detailed form of the quiver when anom alous charges are introduced. Nevertheless, the H ilbert series $g_1(t_1;t_2;x;y;F_0)$, the auxiliary partition function $Z_{aux}(t_1;t_2;F_0)$ and the multiplicities m_{1;2} do not depend on the toric phase. As a result, the partition function for the chiral ring for N > 1 graded with non anom alous charges is the same in all phases. This is consistent with Seiberg duality.

A Toric geom etry and H ilbert Series

Consider an algebraic variety V de ned as the zero locus of a set of polynom ials $p_i 2 C[x_1; :::; x_k]$ in k variables. All regular algebraic functions on V are given by the restrictions of polynom ials $C[x_1; :::; x_k]$ to V. The set of regular functions has the algebraic structure of a ring, called the coordinate ring of V and denoted by C[V]. It is given explicitly by

$$C [V] = \frac{C [x_1; \dots; x_k]}{(p_1; \dots; p_1)}$$

The a nevariety V is completely characterized by its coordinate ring, in the sense that two varieties are isomorphic if and only if they have isom orphic coordinate rings 9 .

In this paper we make extensive use of the H ilbert Series (HS) to characterize the algebraic varieties we are interested in. Let us recall what a H ilbert Series is. G iven an algebraic variety V with an action of an abelian group U $(1)^m$, we have an induced action on the coordinate ring C [V]. Let us de ne a set of fugacities t_i , with i = 1; :::;m for the action of U $(1)^m$. The H ilbert Series is the generating function for the coordinate ring C [V]. It can be de ned as the rational function whose expansion in power series for sm all t_i is X

where c_{j_1,\ldots,j_m} is the number of (algebraic) holomorphic functions with U $(1)^m$ charges j_1,\ldots,j_m .

The H ilbert series contains a lot of inform ation about the variety V, but it is not in general a complete characterization of it. D i erent varieties m ay have the sam e H ilbert series. The story, however, is di erent in the context of toric geometry, which is the relevant case for this paper. A fter all the M aster Space ^{In}F[[] for a three dimensional toric CY singularity X is always a toric variety. A swe discuss in this appendix toric, a ne, irreducible varieties are completely determined by their fully re ned H ilbert series (m odub a change of basis).

Recall that a toric variety V of dimension n is a complex algebraic variety that adm its an action of the (C)ⁿ torus [28]. All the properties of an a ne irreducible n dimensional toric variety V and of its coordinate ring C [V] are encoded in a set of combinatorial data, the toric diagram , which is a rational polyhedral cone in Zⁿ de ned by a set of integer vectors V_i , i = 1;:::;d. Equally in portant for the algebraic characterization of the variety is the dual cone de ned by,

The importance of comes from the fact that there is a one to one correspondence between integer points in and monom ial functions $f(x_1; :::; x_k)$ in the coordinate ring. There is exactly one monom ial function for each point in the dual cone. This can be expressed at the algebraic level as

$$V = \operatorname{Spec} \mathbb{C} [V] = \operatorname{Spec} [\setminus \mathbb{Z}^{n}]:$$

The last equality in (A.44) means that the coordinate ring and the variety itself are completely determined by the dual cone completely.

We can now de ne the HS as in (A.42), and re ne it with as many fugacities t_i as the complex dimension of the variety. To write the HS we need to compute charges for all the elements in the coordinate ring. This is particularly simple in the toric case, where the charges of a monom ial function are given by the integer coordinates of the corresponding point in $\ \ Z^n$. In particular, there is a single holom orphic function with a speci ed set of charges j_1 ;::; j_n . This means that in Equation (A.42), the coe cients c_{j_1} ;::; j_n have value 0 or 1. Hence the HS becomes a generating function for the integer points in the dual cone and it determ ines the variety itself.

The entire construction depends on a choice of basis for Z^n . A ll such choices are related by SL (n;Z) transform ations and give isom orphic varieties. Due to the freedom in choosing a basis for the lattice of charges, the functions have the same degree of arbitrariness. We conclude that, in the toric case, the fully re ned HS with all the fugacities associated to the n toric actions de nes the toric variety up to SL (n;Z) transform ations.

For completeness, we describe the explicit algebraic-geometric description of the toric variety. We need to consider the cone as a sem i-group and nd its generators over the integer numbers. The primitive vectors pointing along the edges generate the cone over the real numbers but we generically need to add other vectors to obtain a basis over the integers. We denote by W_j, with j = 1; :::; k, a set of generators of over the integers.

The k vectors W $_{\rm j}$ generating the dual cone in Z $^{\rm n}$ are clearly linearly dependent for k> n , and they satisfy som e linear relations

To each vector W_j we associate a coordinate x_j in some am bient space C^k. The linear relations (A.46) translate into a set of multiplicative relations among the coordinates x_j ,

By clearing denom inators, we obtain a set of polynom ial equations for the a ne toric variety ${\tt V}$.

A.1 A sim ple exam ple

We give an example of two toric varieties which have the same H ilbert Series, when restricted to a particular set of fugacities, but di erent fully re ned H ilbert Series. We use two fam iliar three dimensional C alabiY au singularities: the conifold C and the $C^2=Z_2$ C singularity. They can be embedded in C^4 , with coordinates x;y;w;z, using the two quadrics, respectively:

$$xy = wz$$
; $xy = w^2$

These two singularities are clearly not isomorphic. Indeed if we de ne the charges of the coordinates as in Table 7, and we introduce the fugacities t_1 , t_2 , t_3 for the three U (1), the

fully re ned Hilbert Series for the two varieties are dierent

and not related by an SL (3;Z) transform ation. It is easy to check that if we restrict to the diagonal U (1) with fugacities $t_1 = t_2 = t_3 = t$, the H ilbert Series become equal

H (t;C) = H (t;C²=Z₂ C) =
$$\frac{1}{(1 + t)^4}$$

Here we see a situation similar to the ones studied in the main text: two di erent toric varieties, but with the same unre ned Hilbert Series.

In this speci c case we can understand what is going on. The two toric varieties are related by a complex deformation. Indeed they belong to the family of quadrics $xy = aw z + bw^2$, where a and b are two complex parameters, which interpolate between the conifold and the A₁ singularity. More generally, every quadratic equation in (x;y;w;z) has H ilbert Series

H (t;Q²()) =

if we associate the fugacity t to all the four variables = (x;y;w;z). From the unre ned H ilbert Series we learn that the conifold and the A_1 singularity belong to the same family of com plex varieties, obtained by considering all quadrics in x, y, w, z that preserve the diagonal U (1), but that generically break the other U (1)s.
