M ass m easurem ents beyond the major r-process waiting point ⁸⁰Zn

H igh-precision m assmeasurements on neutron-rich zinc isotopes 71m ;⁷² ⁸¹ Zn have been performed with the Penning trap m ass spectrometer ISO LTRAP. For the rst time the mass of 81 Zn has been experimentally determined. This makes 80 Zn the rst of the few major waiting points along the path of the astrophysical rapid neutron capture process where neutron separation energy and neutron capture Q -value are determined experimentally. As a consequence, the astrophysical conditions required for this waiting point and its associated abundance signatures to occur in r-process models can now be mapped precisely. The measurements also con rm the robustness of the N = 50 shell closure for Z = 30 farther from stability.

The rapid neutron-capture process (r process) is responsible for the synthesis of about half of the heavy elements beyond Ge in the cosm os [1, 2, 3, 4]. However, where this process occurs is not known with certainty. The characteristic abundance patterns of various competing models not only depend on the chosen astrophysical environm ent, but also sensitively on the underlying nuclear physics processes and param eters [5, 6, 7]. Reliable nuclear data on the extrem ely neutron-rich nucleiparticipating in the r process are therefore needed to com pare the signatures of speci cm odels with astronom ical data now emerging from observations of metal-poor stars [2]. Reliable nuclear-physics is also needed to disentangle contributions from many di erent processes to the observed stellar abundance patterns below A = 130, which were previously attributed to the r process [8,9].

-decay half-lives and nuclear-m ass di erences along isotopic chains, i.e., neutron-separation energies, are of particular in portance in r-process models, especially at the neutron-shell closures where the r process passes through the decay of some particularly long-lived \waiting-point" nuclei. The most prominent waiting points are believed to be 80 Zn, 130 Cd, and probably 195 Tm, responsible for producing the pronounced abundance peaks observed around m ass num bers 80,130, and 195, respectively. They serve as critical norm alization points to constrain the conditions required to produce a successful r process [5].

Q-value m easurem ents related to these waiting points were performed only recently for 130 Cd [10] using the - endpoint technique and yielding a -decay Q-value with an uncertainty of 150 keV. W hile these results provide

im portant new insights in nuclear structure and global m assm odels, their accuracy is not su cient for r-process calculations. Furtherm ore, they m ay have large system - atic uncertainties due to poorly-known level schemes, which can result in rapidly-increasing uncertainties as m easurem ents are extended to m ore exotic nuclei. In addition, to constrain the path of the r process, neutron-separation energies and neutron capture Q -values are needed, requiring m ass m easurem ents beyond the waiting point nuclei with a precision of the order of 10 keV.

In this letter, we report in portant experimental input for r-process nuclear physics: precision Penning-trap m ass m easurem ents reaching the r-process path at the ⁸⁰Zn major waiting point, including the rst mass measurem ent of ⁸¹Zn. Penning trap mass spectrom etry has been developed in recent years for the use with radioactive beam s, and continued re nem ents have enabled m ass measurements with uncertainties of a few keV for increasingly exotic nuclei [11, 12], which is in portant for astrophysics calculations. For example, Fig.1 shows possible r-process reaction ow s in the ⁸⁰Zn region. D epending on the stellar conditions, the r-process path either includes the slow -decay of ⁸⁰Zn making it a waiting point, or proceeds rapidly via neutron capture to ⁸¹Zn and beyond. For som e m ore extrem e conditions ⁸⁰Zn can also be bypassed altogether. W ith the present m easurem ents, ⁸⁰Zn is the rstmajorr-process waiting point where experimental values of the mass dierences with respect to its neighbors (⁷⁹Zn and ⁸¹Zn) are available and thus a precise neutron-separation energy as well as a precise neutron capture Q -value. The conditions and role of ⁸⁰Zn as a waiting point are discussed below .

The idea of a reduction of the strength of the closed neutron shell far from stability, discussed in the literature as \shell quenching", has been evoked in the past in an attempt to explain som er-process abundance anom alies. However, evidence for this phenom enon in mass regions relevant for the r process has not been conclusive [10, 13, 14]. The very recent mass measurements of Hakala et al. [15] of neutron rich Zn masses up to ⁸⁰Zn at JY FLTRAP indicate that the N = 50 shell strength is som ewhat dim inished down to Z = 31. Here, we provide som e evidence that the N = 50 shell closure is retained for the even m ore exotic case of Z = 30.

The masses of 71m ;72 81 Zn have been determined with the Penning trap m ass spectrom eter ISO LTRAP [16] at ISOLDE/CERN. The radionuclides were produced by impinging a 1.4-GeV proton pulse from the CERN Proton Synchroton Booster with 3 10¹³ protons every 2.4 s on a uranium -carbide target. In order to suppress a contam ination by isobaric Rb isotopes, several techniques have been used: First, the protons were focussed on a neutron converter, i.e., a tungsten rod m ounted next to the target container, thus enhancing neutron-induced ssion and reducing direct nuclear reactions of protons with the actinide m aterial. Second, further suppression of the a kali isotopes was achieved by introducing a quartz tube into the transfer line between the target container and the ion source [17]: Rb isotopes di using out of the heated target container freeze out on the surface of the quartz, while the ions of interest pass unim peded to the ionization region. Third, the atom swere selectively ionized by resonant laser ionization [18]. In total, a suppression factor for 80 R b of the order of 10^4 was achieved at a quartz tem perature of 680 C [17].

The Zn ions were accelerated to 60-keV kinetic energy and further puri ed by the high resolution mass separator HRS before being transferred to the ISOLTRAP setup. The ions were stopped in a helium -gas- lled linear radiofrequency quadrupole (RFQ) ion trap. The ion bunch was transferred to the rst Penning trap for the rem oval of any isobaric contam ination still present [19]. Finally, the puri ed bunch of zinc ions was sent to the precision Penning trap, where the cyclotron frequency $_{\rm c}$ = qB = (2 m) is measured with the well-established time-of- ight ion cyclotron-resonance technique [20].

In addition to isobaric cleaning, isom eric puri cation by resonant dipolar rf excitation [21, 22] was used in the precision trap in order to perform m easurements on clean ion ensembles. For ⁷⁷Zn an admixture of the excited ^{77m}Zn (E = 772:4 keV) needed to be removed [23] to measure the cyclotron frequency of the ground state ⁷⁷Zn⁺. In the case of ⁷¹Zn, the isom er was much m ore abundant than the ground state and therefore the cyclotron frequency of ^{71m}Zn⁺ has been measured after removing any remaining ⁷¹Zn⁺ ions. The determ ination of the cyclotron frequencies and the frequency ratios $r = _{cyref} = _{c}$ of the reference ion ⁸⁵Rb⁺ and the ion of interest with the respective uncertainties follow s the procedure described in [28]. All present uncertainties for the

frequency ratios are governed by the statistical uncertainties of the $_{\rm c}$ m easurem ents, which are of the order of a few times 10 8 . For 81 Zn, with a half-life of only 0.3 s, the m ass has been measured for the rst time and a relative m ass uncertainty below 7 10 8 has been achieved. The recent m ass values of 76 80 Zn m easured by JY FLTRAP [15] are in excellent agreem ent.

In Table I the resulting mass excess values are given. Some of them deviate from the AME 2003 literature values [24], especially ⁷³Zn, by m ore than four standard deviations. Therefore, the present frequency ratios have been taken as input values for a new mass evaluation. A new estimate for the mass excess of ⁸²Zn was derived from the system atic trends of the mass surface in that region of the nuclide chart. W ith M E = 42860(500)keV it is shifted by -400 keV as compared to the form er estim ated literature value [24]. Figure 2 shows the new neutron separation energies in the Zn isotopic chain as a function of neutron num ber together with predictions from globalm assm odels. The new data lead to accurate neutron separation energies across the N = 50 shell gap and show that the strength of the N = 50 shell closure is maintained for Zn. This is in agreement with the recent study of the N = 50 shell gap evolution [15] and extends its validity. Am ongst the mass models, the FRDM [25] shows the best agreem ent with the data, and there is no indication of a reduction of the N = 50 shell gap relative to this model. The new HFB-14 mass model [26] also ts the data reasonably well. The ETFSI-Q mass model [27] that had been developed to explore possible e ects of shell quenching clearly disagrees with the data.

For the subset of r-process models that are characterized by a neutron-capture ow through the N = 50 m ass region, the new results allow to determ ine the astrophysical conditions for which 80 Zn is a waiting point,

therefore producing an A = 80 abundance peak. To that end we carried out dynam ical reaction network calculations in the $^{\rm 80}{\rm Zn}$ region without the assumption of (n,) (n) equilibrium. The network includes isotopes from N = 44 to 56 and elements from Z = 28 to 31. (n,) reaction rates are taken from the statistical model NON-SMOKER [29] using the FRDM mass model [25]. The reverse (,n) reactions depend exponentially on neutron separation energies and are calculated using the detailed balance principle (see [1] Eq. 4.5) with our new Zn mass values and partition functions based on the same level densities and spin assignments as in NON-SMOKER.W ith this approach we neglect the mass dependence of the (n,) reaction rates them selves. This is typically not a strong dependence compared to the inherent uncertainty in the predicted rates. In addition, form ost of the relevant conditions, the r process is dom inated at least locally by (n,) (,n) equilibria where the resulting reaction ows only depend on masses and partition functions, not the reaction rates them selves. decay rates are taken from experiment when available [24, 30], otherwise we use the predictions from a global QRPA calculation [31].

W e start with an initial composition of 72 N i and neutrons only and run the network at a constant temperature and neutron density until all the abundance is accum ulated at N = 56. Figure 1 shows some of the results. W e then determ ine the fraction of the total reaction ow that has passed through the -decay of 80 Zn for such conditions. To account for m ass uncertainties, we run for each temperature and neutron density multiple calculations

for all possible permutations where the Zn isotope masses are either set to their lower or their upper 1 limit. From this we obtain the minimum and the maximum fraction of ow through the 80 Zn -decay as a function of the temperature T and the neutron density $n_{\rm n}$. C ontours for 90% -decay branching are used to de ne the conditions under which 80 Zn is a waiting point.

Figure 3 shows the results for AM E 2003 m asses [24] and the new experim ental data. C learly the m ass uncertainties of 200-500 keV in the AM E 2003 extrapolations for the isotopes around ⁸⁰Zn translate into uncertainties of several orders of m agnitude in neutron density and 0.2-0.4 GK in temperature. W ith our new data, in particular with the rst precision m ass value of ⁸¹Zn, the picture changes drastically and we have now a well dened m ap of conditions for a major r-process waiting point to be on the reaction path. This provides a rst reliable guide for r-processm odels with neutron capture in this m ass region. M odel conditions need to pass through our de ned region of tem perature and neutron density in order to produce the observed high A = 80 abundance.

Figure 3 shows two distinct tem perature regimes above and below about 1.5 GK with di erent tem perature and density dependencies and di erent sensitivities to mass uncertainties. Above 1.5 GK (n,) (,n) equilibrium is fully established and even N isotopes play the dom inant role because of their higher neutron separation energies. In this regime, the calculations are expected to be insensitive to neutron capture rates. Additional uncertainties from partition functions should be small as well, as the even N isotopes are even-even nuclei with ground state spin zero, and with a relatively low level density on excitation energy scales corresponding to the few 100 keV of therm all energy. The largest remaining uncertainty in this regime is the mass of ⁸²Zn, which governs the leakage out of ⁸⁰Zn.W hile our m easurem ents have im proved the mass extrapolation for ⁸²Zn, a precision m easurem ent would be desirable.

For tem peratures below 1.5 GK (n,) (n) equilibrium begins to break down. For the high neutron density boundary, leakage out of 80 Zn is governed by a local equilibrium between 80 Zn and 81 Zn, follow ed by neutron capture on 81 Zn. The most critical quantity in this regime is the mass di erence between 80 Zn and 81 Zn, which we have determ ined here experimentally for the rst timem aking the previously dom inating mass uncertainties negligible. For the low neutron density boundary the reaction ow is determined by competition between

-decay and neutron capture and becom es insensitive to m asses as Fig.3 shows. For this low tem perature regime, predictions of neutron capture rates and partition functions m ight contribute sm all additional uncertainties.
