Phenom enology of Production and Decay of Spinning Extra-D in ensional Black Holes at Hadron Colliders

A bstract: W e present results of CHARYBDIS2, a new M onte C arlo simulation of black hole production and decay at hadron colliders in theories with large extra dimensions and TeV-scale gravity. The main new feature of CHARYBDIS2 is a full treatment of the spin-down phase of the decay process using the angular and energy distributions of the associated Hawking radiation. A lso included are improved m odelling of the loss of angular m om entum and energy in the production process as well as a wider range of options for the Planck-scale term ination of the decay. The new features allow us to study the e ects of black hole spin and the feasibility of its observation in such theories. 1. Introduction

The idea that extra spatial dimensions may provide a solution to the hierarchy problem by lowering the scale of gravity to the TeV region [1{5] also raises the exciting possibility of black hole (BH) production in elementary particle collisions at high energies [6,7]. For a su cient number of \large" extra dimensions (three or more), the current experimental and astrophysical limits [8,9] do not rule out such a process occurring at the energy scales accessible to the Large Hadron Collider (LHC). Even if not realized at the LHC, the production and decay of extra-dimensional black holes poses an important problem in theoretical physics. G iven the number of dimensions D = 4 + n and the fundamental Planck scale M_D, one should be able to describe the production of black holes at collision energies well above M_D using classical general relativity extended to (4 + n)-dimensions [10{13}]. In addition, at least at black hole masses well above M_D, the decay of a black hole so form ed should be describable in terms of the Hawking radiation [14,15] expected from such an object.

A lthough m any in portant questions rem ain unanswered, there has been steady progress in the theoretical understanding of these issues in recent years. Lim its have been placed on the fractions of the collision energy and angular m om entum that can end up in the black hole, as functions of the impact parameter of the collision [18{22]. The fact that the black hole will in general have non-zero angular m om entum has led to detailed studies of the Hawking radiation from rotating higher-dimensional black holes [23{34], which have revealed interesting features such as di erences in the angular distributions of em itted particles with di erent spins, as well as modi cations of the energy distributions.

In parallel with the purely theoretical work, e orts have been m ade to incorporate the results obtained into M onte C arb program s [7,35{38] that generate simulated black hole events, for use in studies of the experimental detectability of this process. In the present paper we report on progress in renning the widely-used CHARYBDIS event generator [35, 39,40], to take into account the recent theoretical work on the production and decay of rotating black holes. This enables us to study the e ects of rotation on experimentally observable quantities, assuming that black hole production does indeed take place.

In the follow ing section we sum marize the current theoretical results on the form ation of black holes in particle collisions and the in plied constraints on their masses and angular momenta. We also describe how these results are incorporated into the CHARYBDIS2¹ simulation, with various models for the joint probability distribution of mass and spin within the allowed region. Then, in Sect. 3, we discuss the spin-down and decay of the black hole through Hawking emission of Standard-Model (SM) particles con ned to the physical 3-brane. Here again the simulation is re-ned to take full account of the theoretical results, and options are included for the modelling of aspects that are not well understood, such as back-reaction e ects.

In any simulation of black hole decay in theories with low-scale gravity, one eventually reaches the stage at which the mass and/or tem perature of the black hole are comparable

with the Planck scale, whereupon a complete theory of quantum gravity is required. In the absence of such a theory, various models for the term ination of black hole decay have been suggested [41{46]. In Sect. 4 we explain the extended range of options we have included for this phase of the simulation.

Section 5 presents som e results of the new CHARYBDIS2 simulation, with particular emphasis on consequences of black hole rotation. Our purpose here is not to perform a detailed experim ental analysis, but to illustrate new features that will need to be taken into account in attempts to extract fundam ental parameters from experim ental data, should this process actually occur.

Finally in Sect. 6 we draw some conclusions and make suggestions for further work. We also discuss the comparative features of CHARYBDIS2 and the black hole event generator BlackMax [37,38], which is currently the only other simulation that takes black hole rotation into account.

2. B lack hole production

Production of a black hole in a hadron-hadron collision occurs when two of the colliding partons pass su ciently closely that they become trapped by their mutual gravitational attraction. Prior to the collision, we may take these partons to be travelling in anti-parallel directions, with their directions of motion separated by an impact parameter b. A complex shaped event horizon form s, which must quickly relax to one of the axisym metric stationary black hole solutions of E instein's equations according to the 'no hair' theorem of classical general relativity [15]. For that reason this is sometimes called the balding phase. An emission of gravitational and gauge radiation accompanies the production event.

It has been argued [6] that the typical time scale for loss of such asymmetries is of the order of the horizon radius r_H (note we are using natural units { see appendix A). This is physically reasonable because the asymmetries are related to a distortion of the geometry (with respect to the stationary solution); regardless of the details of the interaction responsible for removing them , it will involve a signal propagating over a region of typical size r_H . On the other hand the time scale t for evaporation of a black hole with a mass well above the P lanck scale is controlled by the H awking energy ux. Since we are only interested in an order of magnitude, we can estimate it by using the D -dimensional Schwarzschild case combined with dimensional analysis (see for example Sect. 3 of [6]) to obtain

The prefactor is a constant of order unity containing the dimensionally reduced energy ux and other convention-dependent constants, and M_D is the Planck mass in D dimensions². For M M_D the time for evaporation will be much longer than for balding.

For the theoretical calculations involved in them odel for form ation and for the H aw king uxes used in the evaporation, we assume that the gauge charges of the incoming partons

are com pletely discharged during the production/balding phase by Schwinger em ission [16, 17]. Further, we assume that the black hole solution formed is always of the M yers-Perry type [47] (rather than the alternative 'black ring' type, which is known to exist in ve dimensions [48], and for which there is strong evidence for D 6 [49]). Given these assumptions, two questions are relevant to the theoretical modelling of the production phase. The rst is how small the impact parameter b has to be before two partons will produce a black hole, or equivalently, what is the parton-level cross section for black hole formation. The second is what fractions of the initial state m ass and angular m om entum are trapped within the M yers-Perry black hole during the production phase.

Theoretical techniques used in recent years have provided more rigorous and complete answers to these questions than were available at the last release of CHARYBDIS. Some of these techniques are discussed in Sect. 2.1. Their incorporation into the program, to produce a more accurate simulation of the production phase, is discussed in Sect. 2.2.

2.1 Theoretical studies of the production phase

In the production phase, the system may be described reasonably well using classical physics, provided the parton collision energy is su ciently far above the Planck scale [10{ 13]. In principle, one could nd reasonably accurate answers to the questions posed above by solving for the spacetime in the future of two colliding partons. However, this has not been achieved, even num erically in simplied scenarios.

The standard approach to studying the production phase has been the trapped surface m ethod [18{22]. Thism ethod utilizes the fact that the black hole horizon begins form ing in the spacetim e region outside the future lightcone of the collision event, where we can solve for the geom etry. By studying apparent horizons in spacetim e slices of this region, and in particular looking at certain areas associated with the apparent horizon as b is varied, one can set bounds on the parton-level cross section and the m ass M and angular m om entum J trapped for given b.

Few trapped surface calculations conducted thus far have attempted to obtain results for nonzero b, making them of limited use to our simulation. The most detailed that has, is that of Yoshino and Rychkov [22] who considered all of the numbers of dimensions used by CHARYBDIS2. They produced (M;J) bounds up to the maximum impact parameters which give rise to apparent horizons in their method. The results of this calculation are therefore the primary theoretical input to our simulation of the production phase. A more detailed discussion of the Yoshino-Rychkov method is given in Appendix B.

It should be noted that the Yoshino-Rychkov calculation models the colliding partons as boosted Schwarzschild-Tangherlini black holes, and so neglects the elects of the spin, charge, and nite size of the colliding partons. For each elect individually, trapped surface calculations have been carried out $[50{52}]$ - but all are only for b = 0. One important observation from the calculations is that charge elects may be signilicant. These will be included in CHARYBDIS2 when the relevant calculations are extended to nonzero impact parameter.

A longside the trapped surface m ethod, alternative techniques have been developed which use a perturbative approach and/or other approximations to estimate directly the

m ass lost in the production phase. In one setup [53], the collision is modelled as an ultra-relativistic particle falling into a Schwarzschild-Tangherlini black hole, and the gravitational emission is calculated by assuming that the gravitational elects of the in-falling particle may be treated as a perturbation on top of the Schwarzschild-Tangherlinim etric. A nother calculation [54] also uses a perturbative approach and assumes that the collision is instantaneous. As a nalexample, D'Eath and Payne [55{57] have estimated the mass loss in the D = 4 axisymmetric collision case by noting the rst two terms of Bondi's news function, and then extrapolating o axis. Here some assumptions about the angular dependence of the radiation are made.

The results produced so far by these m ethods have been limited to b = 0 and certain values of D. The b = 0 results from dimension techniques are compared with the trapped surface bound in Fig.1. The general indication from these is that much less mass is lost during the production phase than the Yoshino-Rychkov upper limits indicate.

2.2 Incorporation of the results into CHARYBDIS2

C ross section

In earlier versions of CHARYBDIS, parton-level cross sections for dierent D values were calculated according to the simple form ula $= r_s^2 \left(\begin{smallmatrix} p \\ s \end{smallmatrix} \right)$ which is based on Thome's hoop conjecture [58]. Here $r_s \left(\begin{smallmatrix} p \\ s \end{smallmatrix} \right)$ is the radius of the D-dimensional Schwarzschild black hole with mass $\stackrel{p}{s}$. Incorporation of the Yoshino-Rychkov cross section results simply requires multiplying these values by the 'form ation factors' given in Table II of [22]. The increase in ranges from a factor of 1:5 at D = 5 to 3:2 at D = 11. The maximum impact

parameters for black hole production, $b_{m ax}$, to be generated in CHARYBDIS2, is adjusted accordingly (the two are related through = $b_{m ax}^2$).

M ass and angular m om entum loss

Following Yoshino and Rychkov, we denote the fractions of the initial state m ass and angularmom entum, trapped after production, by and respectively. For a given number of dimensions D and in pact parameter b, the Yoshino-Rychkov bound on these quantities is a curve in the (;) plane. Examples of such curves for various D and b values are given as the solid lines in Fig. 2. A boundary curve $_{\rm b}()$ always possesses the following two key properties. First, it always passes through = 0 with a value between 0 and 1, where $_{\rm b}(0) = _{\rm lb}(b;D)$ in the language of [22]. Second, it increases m onotonically after this, passing through = 1 with a value satisfying $_{\rm lb} < _{\rm b}(1)$ 1. The allowed region is then delimited by this curve and the lines = 0, = 1, and = 1.

The new simulation of mass and angular momentum loss based on these curves consists of a point being generated at random in the square 0 1, 0 1. The probability distribution for generating this point goes to zero along the Yoshino-Rychkov bound corresponding to the D and b values of the event, such that the generated point is always inside the bound. The and coordinates of this point are then taken as the fractional m ass and angular momentum trapped during the production phase for that event.

The precise rules for the generation of the (;) point are as follows. First, the value for the point, , is generated, according to a linear ram p distribution. This distribution extends between = 0 and = 1, with value 0 at = 0 and value 2 at = 1. The value for the point is then also generated. The distribution in this case is similar, except that now it extends between = $_{\rm b}($) and = 1, ensuring that the point ends up inside the Yoshino-Rychkov bound. The details of how the program calculates $_{\rm b}($) for the D and b appropriate to the event are given in Appendix B.

The decision to implement a probability distribution favouring smaller mass losses than the Yoshino-Rychkov upper bound was made based on the results from the direct calculations given in Fig.1. In this gure we have plotted the mean mass lost in an event with b = 0 using the above probability distribution. The error bars represent the standard deviation in the b = 0 mass loss. We observe a reasonably good agreement between the mean values obtained with our chosen probability distribution and the estimation method results, especially in the important D = 4 case where the estimation method results agree closely. Given that we favour smaller mass losses, it then seems sensible to ensure that the probability distribution also favours smaller angular momentum losses { hence the ram p distributions in and $\frac{3}{2}$.

 $^{{}^{3}\}text{R}$ ecent results of simulations in four dimensions [59] indicate that 25% of mass and 65% of angular momentum are lost in collisions at the maximum impact parameter for black hole formation. However, the value obtained for the maximum impact parameter in this case is 50% above the Yoshino-Rychkov lower bound, corresponding to an initial-state angular momentum that is more than double the maximum value possible for the black hole that is formed. Therefore an angular momentum loss greater than 50% is inevitable in this case. In D > 5 dimensions there is no upper limit on the angular momentum of a black hole and such a large loss is not required.

One possible picture of the production phase is one in which the production phase radiation is 'ung out' radially in a frame co-rotating with the forming event horizon. In this scenario, the angular velocity of the event horizon does not change during the production process (where we have to regard the form ing black hole as a pseudo-M yers-Perry solution at all points during the production phase for this statem ent to have any m eaning).

Based on this picture, we have included an option to bias the above probability distribution such that (;) points corresponding to smaller changes in the horizon angular velocity are more likely. An additional condition is added to this bias { for the points to have their chance of being picked enhanced, they must also have an associated value of the oblateness parameter a , which is su ciently close to that of the initial state. This is to remedy the problem that, for D > 5, there are two curves with the same angular velocity as the initial state in the square 0 1, 0 1, but only one is connected to the initial state. The bias may be turned on or o using the user switch CVBIAS, and the details of its in plem entation are discussed in Appendix C.

In each of the plots in Fig. 2, there are 2000 (;) points generated for the appropriate D and b using the new simulation with the bias applied. One can see in each case that there is an increased density of points around the 'constant horizon angular velocity' curve.

Them ass-energy lost during the production phase is distributed between radiation and the kinetic energy of the form ed black hole. The production phase simulation must account for this. On the basis of several calculations $[60{62}]$, which indicate that gauge radiation is negligible compared to gravitational radiation in the production phase, we assume that all of the radiation is in the form of gravitons. Given that gravitons are missing energy, it is su cient for the simulation to represent the entire radiation pattern using a 'het graviton' with a four-momentum equal to the sum of those of the emitted particles.

The net graviton has an invariant mass $_{g}$, which may potentially lie anywhere between 0 and 1 (in units of the initial state mass). An invariant mass of 1 corresponds to a completely symmetric emission of gravitons, whilst lower values correspond to steadily more antisymmetric emissions (which might result if a small number of gravitons is released, and by chance they are emitted in similar directions). In CHARYBDIS2, the invariant mass is random by generated per event from a power distribution, $P(_{g}) / _{g}^{p}$. The mean of this distribution is set equal to FMLOST (1) by the quantity FMLOST= (p+1)=(p+2) (default value 0:99, corresponding to p = 98). The simulation of the production phase emission is then a two body decay from initial state object into form ed black hole plus net graviton, which is isotropic in the centre of mass frame of the initial state object.

2.3 Adding the intrinsic spin of the colliding particles

The results in the previous sections give a model for the angular momentum of the black hole after formation, which is based on using incoming particles with zero spin. Angular momentum conservation requires us to include the intrinsic spin of the incoming particles falling into the black hole. Since the results in the literature taking this elect into account are limited to special cases (see for example [51]) we assume a simple model where inst we combine the spin states of the incoming particles into a state

The collision axis is denoted by $z, s_i; h_i$ are the spin and helicity of the particles⁴ and $s; s_z$ are the angular momentum quantum numbers of the combined state in the rest frame. Since we have unpolarised beam s we give equal weight to each helicity combination. Then this angular momentum state is combined with the orbital contribution obtained from the model for angular momentum loss. We denote it by

where L is the nearest integer to J. Note that z^0 is an axis in the plane perpendicular to the beam axis (z-axis) chosen with uniform probability. Finally, using a W igner rotation [63] followed by a tensor product decomposition using C lebsch-G ordan coe cients, we obtain

where $d_{s_2 \circ s_z}^{(s)}$ is a W igner function and $C_{J;L;L;S;s_s \circ}$ is a C lebsch-G ordan coe cient for the tensor product decomposition of $J_{z};L_{z_0}$ $j_{z};s_{z}\circ i_{z^0}$. From (2.4) it is straightforward to determ ine the probabilities for all possible combinations of helicities and incom ing partons.

This model introduces a spread in the orientation of the initial black hole angular momentum axis around the plane perpendicular to the z-axis. Note that even though the model for angular momentum loss in the previous sections does not include such an e ect, in a realistic situation we would not expect the angular momentum to be exactly perpendicular to the beam axis after the production phase.

3. Decay of spinning black holes

A fter the black hole settles down to the M yers-Perry solution, evaporation will start. The stationary background geometry for an (4 + n)-dimensional black hole with one angular momentum axis on the brane is [47]

The only two independent parameters in (3.1) are f ;ag which are related to the physical parameters of the black hole. Those are respectively the extra dimensional generalisations of the ADM mass (M) and angular momentum $(J)^5$

Furtherm ore, we can switch to a third pair of param eters, closely related to the geom etrical properties of the black hole: fr_H ; a g. The rst param eter is de ned by the location of the horizon of the black hole at the largest positive root of $(r_H) = 0$. r_H is directly related to the surface curvature of the horizon and thus (in some sense) has a fram e independent m eaning. The second is $a = a = r_H$. This is easily interpreted as the oblateness of the spheroid at the horizon as seen from (3.3).

We are working in an ADD scenario where, the Standard-Model elds are con ned to a 4-dimensional brane. This type of setup has been proposed both for the case of at extra dim ensions [1{3] (ADD scenario) and curved extra dim ensions (for exam ple the R and all-Sundrum models [4,5]). This constraint is necessary to avoid bounds from electroweak precision observables. The upper bound on the extra dimensional width for such a brane is [64] R' (700 G eV)¹. This is many orders of magnitude below the scale needed in a large extra dimensions scenario (for n . 15) to explain the size of the P lanck m ass in the spirit of [2,3]. M ore elaborate setups have been proposed⁶ where different SM elds are placed on dierent branes in bedded in a thicker brane of size R . 1 (TeV) 1 [65,66]. In our model we assume black holes of mass well above 1 TeV, which means that the typical Schwarzschild radius will be above 1 2 (TeV)¹. Hence the minimum diameter should 4 (TeV)¹, which is already well above the upper bound on the width of the thick be 3 brane. So com pared to the size of the black hole, all branes should be well inside the black hole and for the purpose of evaporation, all elds e ectively behave as being em itted from a single brane. Thus, for brane degrees of freedom, we use the 4-dim ensional projected version of the m etric (3.1), where the coordinates on the n-sphere are xed. Higher order corrections from splitting the branes are neglected.

A related issue is that of brane tension. Here the results in the literature concerning transm ission factors are limited to the case of a codimension-2 brane in six dimensions [67]

71]. The main conclusion (see for exam ple [67,69,70]) is that the brane projected metric (and consequently the Hawking spectra) remains unchanged up to a rescaling of the Planck mass, so only the spectra for bulk elds are qualitatively different. These observations, together with the fact that brane emission should be dominant, justify neglecting such e ect for 6-dimensions (note that this case is anyway disfavoured from the bounds in [8,9]). For the phenom enologically favoured cases of codimension larger than 2, there are virtually no detailed studies on brane tension elds, in which case our model does not need to be adapted, but further work is required to understand if such an assumption holds.

For our description of the evaporation to hold, we require the black hole to be sitting on a background that is e ectively M inkow ski spacetime. This means that the typical size and curvature radius of the extra dimensions must be much larger than the horizon radius of the black hole. This holds for the ADD scenario, where the at extra dimensions are large enough to solve the hierarchy problem, and for the Randall-Sundrum (RS) model with an in nite extra dimension [5], where the hierarchy problem is solved using a large curvature radius.

We assume that the black hole remains stuck on the brane [72]. The possibility of ejection would come from graviton emission into the bulk [73,74]. Since the black hole is form ed from SM particles which are them selves conned, we assume that even if gravitons are emitted, the extra-dimensional recoiling momentum is absorbed by the brane, avoiding ejection. One could argue that whichever charges keep the black hole conned to the brane, they are lost at the start of the evaporation through Schwinger emission [16,17]. However it will be very unlikely that all the di erent gauge charges are simultaneously neutralized at any stage during the evaporation, if we assume that the black hole decays by emitting one quantum at a time. Furthermore, there are a bt more SM degrees of freedom than gravitational ones so even if the unlikely event of exact neutralisation occurs, it will still be unlikely that a graviton is emitted during the brief period of neutrality. Thus we would expect the number of events in which the black hole is ejected into the bulk to be at most a sm all fraction of the total.

Even though exact neutralisation seems unlikely, it is well known, at least in four dimensions, that black holes tend to discharge very rapidly compared to the evaporation time. So we would expect the charge to stay low^7 , and charge elects on the probabilities of emission to be less in portant. In the generator we use a simplied model based on this observation, such that whenever a charged eld is selected for emission, the electric charge of the state is selected as to reduce the total charge of the black hole (unless the BH is neutral, in which case equal probabilities for particles and anti-particles are used). To avoid complications in hadronization, baryon number conservation is assumed, and colours are assigned to ensure that colour singlet form ation is possible.

3.1 Energy distribution and greybody factors

Once the evaporation starts, the black hole loses its mass and angular momentum through the emission of Hawking radiation. The radiation is thought to be predominantly in the

form of SM elds on the brane, and gravitational radiation into the higher-dimensional bulk. It is believed [72] that \black holes radiate mainly on the brane", primarily due to the high multiplicity of the brane-con ned SM elds. The conjecture is supported by studies of the ratio of power emission of scalar elds in brane and bulk channels [33,34]. Determining the energy balance between the brane and bulk channels for graviton emission remains a key open question. The emission of 'tensor' gravitational modes into the bulk was recently considered in [75,76]. A comprehensive analysis, including all gravitational modes ('tensor', 'vector' and 'scalar' [77{79]) for a simply rotating black hole, has yet to be conducted. In the follow ing, we assume that emission on the brane is indeed the dom inant decay channel.

We assume further that the emission of Hawking radiation may be treated semiclassically. That is, that emission of radiation is a smooth, quasi-continuous process in which the black hole has time to reach equilibrium between emissions, and the energy of particles emitted is much less than the mass of the BH. These assumptions are valid as long as the mass of the black hole is much larger than the (higher-dimensional) Planck mass M_D, in which case the typical time between emissions is large compared to $r_{\rm H}$ (see for example (2.1)) and the Hawking temperature, which gives the typical energy scale of the emissions, is below M_D.

The Hawking tem perature of a M yers-Perry black hole is

where N, E, and J denote particle number, energy and angular momentum, respectively. Here, k = fh;j;m;!g is shorthand for the numbers, and $\frac{1}{2} = \frac{1}{2}$ m, where $= a = [(1 + a^2)r_H]$ is the horizon angular velocity. fh;j;mg are the spin weight, total angular momentum and azimuthal quantum numbers of the emission and ! its energy. In the denom inator, we select + 1 for ferm ionic ebls ($\frac{1}{2} = 1 = 2$), and 1 for bosonic ebls ($\frac{1}{2} = 0;1;2$). The dimensionless quantity $T_k^{(D)}(!;a)$ is the transmission factor, also known as the greybody factor.

In the context of H aw king radiation, a transm ission or greybody factor is the proportion of the ux in a given mode that escapes from the horizon to in nity. No closed-form expression for these factors is known, although a num ber of useful approximations have been derived [30{32]. Simulation with CHARYBDIS2 requires accurate transm ission factors across a wide parameter space; consequently a num erical approach was taken.

To determ ine transm ission factors one must solve the higher-dimensional Teukolsky equations [26,27,29]. A fter perform ing a separation of variables for a eld on the brane,

the resulting radial equation is

The transm ission factors $T_k^{(D)}$ are found by considering modes which are purely ingoing at the outer horizon (for details see e.g. [26,27,29]).

The separation constant $_{k}$ is found by solving the angular equation (3.12) discussed in the next section. Unlike the radial equation, the angular equation does not depend on the dimensionality (D = 4 + n) of the bulk spacetime. A range of methods for noting angular eigenvalues are detailed in [82]. For the purpose of calculation of transmission factors, we employed a spectral decomposition method (for example, see Appendix A in [83]) and a numerical shooting method [84]. We checked our results against known series expansions in a! [82].

The numerical methods employed to determ ine the transmission factors are described in detail in [26,27,29]. Transmission factors were computed numerically in the parameter range $n = 1;2;:::6, !r_H = 0:05;0:10;:::5:0$ and a = 0:0;0:2;:::5:0 for the angular modes j = hj;hj+1;:::hj+12 and m = j:::j. For each point we have computed the ux spectrum using (3.8). This quantity is used in CHARYBDIS2 as a probability distribution function for the quantum numbers of a particle with a given spin and to determ ine the relative probability of di erent spins (through integration of equation (3.8)). For convenience in the M onte C arlo, we have computed the following cumulative distributions from the transmission factors:

where x is energy in units of r_{H}^{1} , $_{H} = T_{H} r_{H}$, $x = x m = r_{H}$ and Q is an integer that counts modes. The modes are ordered with increasing j and within equal j modes they are ordered with increasing m.

Cumulative functions are more convenient since they allow for high e ciency when selecting the quantum numbers. This is done by generating a random number in the range [0;C(1)], followed by inversion of the corresponding cumulant. In CHARYBDIS2, when values of a between those mentioned above are called, linear interpolation is used. When a is larger than 5, we use the cumulative functions for a = 5. We have checked that for most of the evaporation such large values are very unlikely. The exception is the nal stage, when the black hole mass approaches the Planck mass. Here one of the remnant models takes over, as described in section 4.

The e ect of black hole rotation on the sem i-classical Hawking emission spectrum is described in detail in the studies [23{29]. Here we brie y recall som e qualitative features.

In the non-rotating (Schwarzschild) phase, the emission spectrum (3.8) is found from a sum over modes, and the modes are degenerate in m. In the 4D case, emission is dominated by the lowest angular mode $(j = j_1 j)$, whereas in the higher-dimensional case, higher modes $(j > j_1 j)$ are also significant. The Hawking temperature (3.7) increases monotonically with increasing n, and hence the total power (per particle species) increases steeply with increasing n.

Rotation splits the azim uthal degeneracy; modes of di erent m are distinguished. Radiation is emitted preferentially into the co-rotating (m > 0) modes and causes the BH to lose angularm on entum. The importance of co-rotating modes can be understood by examining the interplay between the transmission factors T_k (TFs) and the so-called Planckian (or therm al) factors ($[exp(!=T_H) 1]^1$) (PFs) in equations (3.8), as illustrated in Figs. 3 and 4. At xed j,we nd the TFs for counter-rotating (m < 0) modes generally exceed the TFs for co-rotating modes, im plying that (in some bose sense) the counter-rotating modes escape from the vicinity of the hole more easily that the co-rotating modes. However, the PFs are larger for co-rotating modes, im plying that more Hawking radiation is generated in co-rotating modes. We nd that this latter e ect dominates over the form er. In general, the e ect of rotation is to substantially enhance emission, even though the Hawking temperature depends only weakly on a for a xed BH mass.

For low dimensionalities (n = 0;1;2) and fast rotation (a = 1) the emission spectrum is dominated by the maximally-corotating modes (m = + jjj). This can lead to an oscillatory or 'saw-tooth' emission spectrum, which is clearly visible in Fig. 4. The dominance of

m = + jjjm odes will obviously lead to a rapid loss of angular m om entum. If the num ber of bulk dimensions is large, n & 6, then this e ect only occurs for very fast rotation a 1. In general for high n, all m modes contribute and the em ission pro le is much smoother.

In the case of bosonic elds, black hole rotation induces another e ect: the transm ission factor $T_k^{(D)}$ is negative for modes such that $! \cdot < 0$ (see right-hand side plots of Figs. 3 and 4) which can be checked from the W ronskian relations for the radial equation (3.9). That is, the transm itted part of 'in' wave modes with $! \cdot < 0$ falls into the rotating black hole carrying in negative energy and their rejected part returns to in nity with a gain in energy⁸. This classical phenom enon, which occurs for bosonic but not for ferm ionic elds, is known as superradiance [85{87]. W ithin the context of higher-dimensions, it has been shown [27] that spin-1 superradiance on the brane increases with the black hole intrinsic angular momentum a (as expected) and with the number n of extra dimensions; see also [25,88] for studies of scalar superradiance on the brane. It has been suggested [89] that the presence of superradiance m ight lead to spin-2 radiation into the bulk being the dom inant emission channel, thus disproving the claim that \black holes radiate m ainly on

the brane" m ade in [72]. However, it was shown in [34] (see also [90,91]) that superradiance for the scalar eld em ission in the bulk dim in ishes with the num bern of extra dimensions, and that the percentage of the total (i.e., brane plus bulk) scalar power which is em itted into the bulk is always below 35% for n = 1;2;:::;6. In the absence of a solution for the higher-dimensional spin-2 equations in the rotating case, these results for the scalar eld seem to indicate that the main em ission channel will be into the brane, rather than the bulk, in spite of superradiance.

3.2 A ngular distribution of H aw king radiation

The angular distribution of brane elds em itted from a black hole rotating on the physical (3+1)-brane is controlled by the spheroidal wave functions S_k (c;x = cos), which satisfy the dimension

where c = a! and $A_k(c)$ is the angular eigenvalue. In the generator, ourm ethod of solution for this equation is based on that of Leaver [92]: details may be found in Appendix D. G iven the values of k and $A_k(c)$, the probability distribution function for an emission with momentum in the direction cos is then given by the normalized square modulus⁹ of S_k . This follows from the decomposition of spheroidal one-particle states into plane wave oneparticle states, which is analogous to the decomposition of spherical waves into plane waves, for the usual case of scattering o a spherical potential. We work out the case of a massless D irac eld in Appendix E, in order to clarify the assignment of a spheroidal function of a certain spin weight to the correct helicity state in our convention. It turns out that in the convention of (3.12) the physical helicity of the particle is actually h.

Som e in portant properties of the angular distributions for our analysis follow from the observation of Fig. 5. W e have veri ed that in general, for any mode, higher rotation tends to make the spheroidal functions more axial. This means that at low energies (where the modes are departing from being degenerate), the angular distribution of H awking radiation will tend to become more axial. How ever, for higher energies, the e ect of rotation on the emission spectrum is to favour emission of modes with m = j in order to spin down the black hole. This will produce a more equatorial angular distribution, as we can see from Fig. 5 where the m = j mode is always more central (in x = cos) than the m = 0 mode (for $j \in 0$). So as we increase the rotation parameter we have a competition between the increase in the angular function's axial character and the increase in probability of emission of more equatorial modes (which are those with larger j). At low (high) energies the form er (latter) w ins. This observation is consistent with the energy dependence of the angular pro les shown in, e.g., Fig. 16 of [29].

Low energy vector bosons are more likely to be emitted close to the rotation axis, whereas high energy vector bosons are more likely to be emitted in the equatorial plane. A similar but far less pronounced e ect exists for spin-half particles.

Particles with a single helicity, such as the neutrino, will be emitted asymmetrically by a rotating black hole [93]. For example, if the black hole's angular momentum vector is pointing north, then (anti-)neutrinos will be preferentially emitted in the (northern) southern hemisphere. W and Z boson decays will exhibit similar asymmetries in the two hemispheres.

3.3 Back-reaction and spin-down

The di cult problem of studying the back-reaction is interesting, both from the theoretical and the phenom enological point of view, since it should start to in uence the evaporation as the mass of the black hole is low ered.

On the theory side, there is no well established fram ework to study the evolution of a H awking-evaporating black hole over the full range of possible initial conditions. The usual approach [14,94{96] is to write down mean value di erential equations for the variation of the parameters (M and J) such as (3.8) and integrate them with appropriate initial conditions. However, this is only valid for a continuous process of emission where the variation of the parameters is very slow and the symmetry of the background spacetime is kept. Thus, it ignores them om entum recoil of the black hole and the change in orientation of the angular momentum axis between emissions, which are certainly negligible for an ultra-massive black hole, but will start to become important as we approach the P lanck mass. Furtherm ore, since the H awking spectra at xed background parameters are used, it also neglects the e ect of the backreaction on the metric by the emitted particle. This point has been explored in simplied cases of j = 0 waves for elds of several spins using the method in [97] with some results regarding the modi cation of the therm alfactors, but a full treatment is still lacking.

In the program, we have included two possible models for the momentum recoil of the black hole set by the switch RECOIL, which takes the values 1 or 2.

RECOIL = 1 interprets the selected energy as the energy of the particle in the rest fram e of the initial black hole. The momentum orientation is computed in this fram e with probability distribution given by the square modulus of the spheroidal function (3.12) and the momentum of the nal black hole is worked out from conservation. The argument for this model comes from the observation that particles in the decay are highly relativistic. They propagate close to the speed of light, so the background they see is that of the initial black hole, since no signal of the back-reaction on the metric can propagate outwards faster than light. Thus the momentum of the emission is determined by the background metric in this picture.

RECOIL = 2 takes the energy of the em ission as being the loss in m ass of the black hole. This corresponds to the usual prescription for computing the rate of m ass loss. The orientation of the m om entum in the rest fram e of the initial black hole is computed as before with a probability distribution given by the square m odulus of the spheroidal function (3.12) and the 4-m om entum of the em ission as well as that of the black hole are worked out.

Note that for any of the previous options, full polarization inform ation of the emission is kept, as it is generated with the correct angular distribution. This will potentially produce som e observable angular asym m etries and correlations, which would not be present if angular distributions averaged over polarizations had been used.

The other quantity we need to evolve is the angular momentum of the black hole. W e have two options, controlled by the switch BHJVAR. The default BHJVAR = :IRUE: uses C lebsch-G ordan coe cients to combine the state of angular momentum M $_z$ = J of the initial black hole (i.e. taking as quantisation axis the rotation axis of the black hole), with the emitted j;m state for the particle. The probability of a certain polar angle and m agnitude for the angularm om entum of the nalblack hole is given by the squarem odulus of the corresponding C lebsch-G ordan coe cient, and the azim uthal angle is chosen with uniform probability. If BHJVAR=.FALSE., the orientation of the axis remains xed even though the m agnitude will change by subtraction of the m value of the emission.

From previous versions of CHARYBDIS, we have kept the switch TIMVAR which allows one to x the parameters of the black hole used in the spectrum (such as the Hawking tem perature) throughout the evaporation. This option corresponds to a model where the evaporation is no longer slow enough for the black hole to re-equilibrate between emission, so in e ect it represents a simultaneous emission of all the nal state particles from the initial black hole without any interm ediate states.

In Fig. 6 we plot the evolution of the physical parameters M and J for BH events with xed initial M, in the non-rotating case and the highly rotating case. In Fig. 7 we plot the horizon area and oblateness for the same cases as in Fig. 6.

Events were generated for two possible initial masses, 10 TeV (reachable at the LHC) and 50 TeV. The latter serves as a check of the sem i-classical limit. We focus on n = 2 and n = 6. An important quantity necessary to produce these plots, is the time between emissions. Since our model for the evolution relies on the mean value equation (3.8), before each emission, an average time can be computed (i.e. t for N = 1):

where a sum over all species is assumed (see Sect. 4 for further details).

Each plot contains 10^4 trajectories (one per event generated), each contributing with weight 1 to the density plot. The darker areas correspond to higher probability and in all the plots we can discern a tendency line which is sharper for the 50 TeV case and more di use for 10 TeV, rejecting the magnitude of the statistical uctuations.

The left colum ns of Figs. 6 and 7 show respectively the evolution of the m ass param eter and horizon area for non-rotating black holes. The centre and right colum ns show the evolution of the m ass and angular m om entum, or the horizon area and oblateness, for the highly rotating case (a \prime 3). The m ain features are as follow s:

Non-rotating case: Both M and A decrease approximately linearly with time except for the last 10 20 % when they drop faster. This is directed related to the behaviour of the temperature which increases slow ly (approximately linearly) for most of the evaporation and rises sharply near the end. The rates tend to be faster for higher n which is in agreement with the increase in Hawking temperature with n.

Highly-rotating case: Here the statistical uctuations tend to sm ear out the plots for the case of lowest mass. However, the same tendency can be seen as for the M = 50 TeV black holes; the latter display better a true sem i-classical behaviour. There is in general an initial period of roughly 10 15 % of the total time when M drops faster to about 60 70%. At the same time the angular momentum also drops

sharply to 20 %. This corresponds to the usual spin-down phase [95]. Note that the uctuations are quite large for the low-m ass n = 2 plots. As for the geometrical

parameters, they follow a similar tendency if we make the correspondences M $\$ A and J $\$ a . Again for the low-mass plots the statistical uctuations smear out

the sharper initial drop in area, in particular for n = 2 in which it can occasionally increase substantially. The a plots show how the black hole tends to become more spherical in this spin-down phase. The remainder of the evolution resembles the nonrotating case and can be identied with a Schwarzschild phase. Note how ever that by the end of the evaporation (when M approaches the Planck mass) this description breaks down and a rises again, since even only one unit of angular momentum has a very large e ect on this quantity at the Planck scale. This means that a ceases to have a well de ned geometrical meaning, as we reach the Planck phase. Similarly to the non-rotating case, we have checked that the temperature increases slow ly and approximately linearly for most of the evaporation except for a sharp rise as the Planck mass is approached.

These observations agree with the usual results in four dimensions¹⁰ and the results of [28] in D dimensions.

4. Term ination of black hole decay

O ur model for black hole decay relies heavily on the assumptions that we are in the sem iclassical regime and the evaporation is slow (i.e. there is enough time for re-equilibration between emissions) [6,98]. However, as the evaporation evolves, we will reach a point where neither of these assumptions will be true.

In the generator we introduce some options for the nal remnant decay based on dierent physical assumptions. First of all, we need a criterion to decide whether or not the remnant stage has been reached. The various options in the program are connected to a departure from semi-classicality. This occurs when the expectation value hN i for the number of emissions becomes small, which is a sign of the low number of degrees of freedom associated with the black hole. Together with the drop in hN i, the Hawking temperature will rise sharply. This is all related to the approach of the black hole mass to the Planck mass. The options are:

NBODYAVERAGE= .TRUE.: A n estim ate for the multiplicity of the nal state is com – puted at each step during the evaporation, according to the Hawking spectrum :

The sum s are over all particle species with appropriate degeneracies g_i . The integrated ux and power are computed using (3.8). A natural criterion for stopping the evaporation is when this estimate drops below some number close to 1. In the generator we use hN i NBODY 1 where NBODY gives the average multiplicity of the rem nant decay nal state (see Sect. 4.2 for further comments). Varying the parameter NBODY will give a measure of uncertainties in the rem nant model. In addition,

if we choose a rem nant m odel that decays, (4.1) gives an estimate of the nal state multiplicity for such a decay. W hen NBODYAVERAGE = **:**FALSE:, one of the options below, inherited from earlier versions of CHARYBDIS, is used.

KINCUT= .TRUE.: Term inate evaporation if an em ission is selected which is not kinem atically allowed. This is closely related to the rapid increase in temperature as we approach the Planck mass and consequently the generation of kinem atically disallowed energies for the emission. O therwise if KINCUT = :FALSE: the kinem atically disallowed emissions are rejected and the evaporation term inates when the mass of the black hole drops below the Planck mass¹¹.

4.1 Fixed-multiplicity model

The default remnant decay option is a xed-multiplicity model similar to that in earlier versions of CHARYBDIS. At the end of the BH evaporation, the remaining object is decayed isotropically in its rest frame, into a xed number NBODY of primary particles, where the parameter NBODY is an integer between 2 and 5. The decay products are chosen with relative probabilities appropriate to the nalcharacteristics of the black hole (i.e. weighted according to the integrated Hawking uxes for each spin).

The selection of the outgoing momenta of the decay products may be chosen either using pure phase space (NBODYPHASE=.TRUE.) or by using the following probability density function in the rest frame of the black hole (NBODYPHASE=.FALSE.):

which amounts to the usual phase space momentum conservation with an extra weight function for each particle

where k = fj;mg are chosen according to the cumulants (3.11) combined with angular momentum conservation. Here $E_i; i$ are the energy and momentum orientation of the emission in the rest frame of the remnant. This choice treats the nal state particles on an equal footing, keeping a gravitational character for the decay (since it uses Hawking spectra), as well as some correlations with the the axis of rotation through the spheroidal function factor. Furtherm ore, at this stage, slow evaporation should no longer be valid, so it makes sense to perform a simultaneous decay at xed black hole parameters. This remnant option can be used with any of the criteria for term ination.

4.2 Variable-multiplicity model

In addition to a xed multiplicity nalstate, an option has been introduced to select the multiplicity of the nalstate on an event-by-event basis. We follow an idea in [99], which has been used for example in the case of 2! 2 sub-processes in [44]. Here we im plem ent a more generalm odel for arbitrary multiplicity, which is invoked by setting the parameter NBODYVAR=.TRUE..

As argued previously, when the rem nant stage is reached, the black hole should no longer have time to re-equilibrate between emissions. Under this assumption, the probability distributions should become time independent. It is relatively straightforward to prove that under these conditions for a time interval t, the multiplicity follows a Poisson distribution [99]:

with som e constant. From the Hawking ux, we have computed an estimate for the average number of particles emitted during t (i.e. the time interval until all mass disappears), so is determined from this condition. The nal result is

where hN i is the estimate in (4.1). This expression gives us an estimate for the probability of emission of n particles from the remnant, so we choose to interpret n + 1 as the multiplicity of the nal system. In the generator we have removed the n = 0 case (i.e. multiplicity 1 nal state) since the probability of the remnant to have all the correct quantum numbers and mass of a standard model particle will be vanishingly small.

A fter the multiplicity is chosen, either the pure phase space decay or the model described in the previous section is used, according to the value of NBODYPHASE.

4.3 Boiling m odel

The boiling rem nant model, activated by setting RMBOIL=.TRUE., is bosely motivated by the expectation that at the P lanck scale the system becomes like a string ball [41,100], which has a limiting temperature due to the exponential degeneracy of the string spectrum [45]. In this model, evaporation of the BH proceeds until the H awking temperature for the next emission would exceed a maximum value set by the parameter THWMAX.From that point on, the temperature is reset to THWMAX and the oblateness is frozen at the current value. The remaining object evaporates like a BH with those characteristics, until its mass falls below a value set by the parameter RMMINM. It then decays into a xed number NBODY of primary particles, as in the xed-multiplicity model, or a variable number if the variable-multiplicity model is on.

4.4 Stable rem nant m odel

A number of authors have proposed that the endpoint of black hole evaporation could be a stable remnant [42,43,46]. This option is activated by setting RMSTAB=.TRUE.. In order for the cluster hadronisation model of HERWIG to hadronise the rest of the nal state successfully, the stable rem nant must be a colourless object essentially equivalent to a quark-antiquark bound state. Therefore it is required to have baryon number $B_R = 0$ and charge $Q_R = 0$ or 1.

The stable rem nant appears in the event record as Remnant0, Remnant+ or Remnant-, with PDG identity code 50, 51 or {51, respectively, according to its charge. This object will behave as a heavy fundam ental particle with conventional interactions in the detector.

If a rem nant with $B_R \notin 0$ or $\mathfrak{P}_R \mathfrak{j} > 1$ is generated, the whole BH evaporation is repeated until $B_R = 0$ and $\mathfrak{P}_R \mathfrak{j} = 1$. This can make the stable remnant option much slower than the other options, depending on the length of the black hole decay chain.

4.5 Straight-to-rem nant option

R ecently, there has been discussion of the possibility that the form ation of a sem i-classical black hole m ay lie beyond current experim ental reach, with low -m ultiplicity gravitational scattering m ore likely at the TeV scale [44]. To sim ulate this scenario, CHARYBDIS2 provides the option of bypassing the evaporation phase by setting the sw itch SKIP2REMNANT= .TRUE. and skipping directly to one of the rem nantm odels presented in the previous sections. This perm its the study of a wide range of qualitatively di erent possibilities, from sim ple 2 ! 2 isotropic scattering (xed multiplicity) to m ore com plicated variable-multiplicity 2 ! N sub-processes.

The 2! N model is particularly exible, allowing either a phase-space distribution or one using the Hawking energy and angular spectra (see Sect. 4.2). A part from this, all particle species are treated on an equal footing consistent with conservation laws. A l-ternatively the quantum -gravity motivated boiling model can be used. Further work will be presented in future publications exploring the phenom enological consequences of these scenarios.

5. R esults

In this section we present results from CHARYBDIS2 simulations of black hole production at the LHC.A range of CHARYBDIS2 sam ples were produced using HERWIG 6.510 [101,102] to do the parton showering, hadronisation and standard model particle decays. The results of which were then passed through a generic LHC detector simulation, AcerDET 1.0 [103]. CHARYBDIS2 parameter defaults are shown in Table 1. In all following discussion, the number of extra spatial dimensions is n = TOTDIM 4. Sam ples were generated with a 1 TeV Planck mass (in the PDG convention, i.e. MSSDEF = 3) so as to investigate the phenom enologically preferred region accessible at the LHC.B lack holes were generated with a lowerm ass threshold of 5 TeV such that the sem i-classical approximations for production are valid.

Our settings for AcerDET 1.0 are as follows: we select electrons and muons with $P_T > 15 \text{ GeV}$ and j j < 2.5. They are considered isolated if they lie at a distance $R = \frac{p}{()^2 + ()^2} > 0.4$ from other leptons or jets and if less than 10 GeV of energy was deposited in a cone of R = 0.2 around the central cluster. The same prescription is followed for photons. Jets are reconstructed from clusters using a cone algorithm of

R = 0.4, with a lower P_T cut of 20 GeV. Lepton m om entum resolutions were parameterised from ATLAS full simulation results published in [104].¹² W here reference is made to reconstructed multiplicities or spectra, the reconstructed objects are either electrons, muons, photons or jets from AcerDET.

5.1 Black hole m ass and angular m om entum

The cross-section for black hole production is a strong function of the Planck m ass. Though not a ecting the total black hole cross-section, simulating the mass and spin lost during black hole formation does have a large elect on the cross-section for a particular mass

range. The di erential cross-section will be reduced, for the sam e input state will produce a black hole of lesser m ass, as is illustrated in Fig. 8.

M ost collisions with su cient energy to create a black hole are between two (valence) quarks, however a m inority occur in collisions between a quark and a gluon. CHARYBDIS2 adds the spins of the colliding partons when form ing a black hole; the initial angular momentum is either integer or half-integer accordingly. An integer loss of orbital angular momentum in the form ation process is simulated by the Yoshino-Rychkov model described in Sect. 2.

At high n there is a large increase in the production of high spin states, as seen in Fig. 9. The average spin of the produced black hole rises from 5.0 units for n = 2, to 8.1 for n = 4 and 10.6 for n = 6. The generator switch MJLOST toggles a model of the loss of black hole mass and angular momentum in graviton emission during black hole production and balding, as described in Sect. 2.2. Setting this to .TRUE. decreases the spin slightly by an average of 30% for n = 2, 4, 6, whilst the mass drops by 18% (n = 2) to 30% (n = 6), as shown in Fig. 9.

The variation in the number of Hawking emissions is caused primarily by the black hole mass, though the black hole spin and temperature play a role { a more highly rotating, or higher temperature black hole will emit more energetically. Consequently, the decrease in the number of Hawking emissions follows the drop in mass and is greatest for higher numbers of extra dimensions, with an average of two fewer emissions (or 30%) manifest for n = 6.

The simulation of losses from production and balding has several major elects upon the produced particle spectrum. The reduction in the black hole mass and number of Hawking emissions leads to a decrease in the number of particles observed experimentally and to a reduced dimensions between samples with dimensions.

The decrease in initial black hole mass also leads to a softening of the emitted particle spectrum, with the high energy and transverse momentum tail of the distribution being reduced. Fig. 10 shows this for a xed 2-body remnant decay using the option in the second row of Table 2.

5.2 Rotation e ects

The inclusion of black hole angular momentum has several large e ects upon the em itted particles and their spectrum. The probability of a highly energetic em ission is enhanced for partial waves with high values of the azim uthal quantum number m. As discussed at the end of Sect. 3.1, this results from the interplay between Planckian factors and transm ission coe cients. The form er, which turn out to be the dom inant e ect, are enhanced strongly for large positive values of m due to the m term in the exponential of equation (3.8), reducing the Planckian suppression. Consequently, the particle energy and transverse m om entum (P_T) distributions for em issions from a rotating black hole are harder. The number of prim ary em issions is correspondingly reduced. Fig. 11 shows the em itted particle multiplicity and P_T spectra for di erent numbers of extra dimensions, for which the spin term (in the Planckian factors) has greater magnitude. This more than compensates for their slightly low er Hawking tem perature.

The e ect of black hole rotation on the pseudorapidity () distribution is more subtle. A ssum ing no strong spin recoil during the balding phase, the initial black hole form ed will have a spin axis perpendicular to the beam direction.

Since em ission in the equatorial plane is favoured, particularly for scalars and ferm ions, one would expect the component along the beam direction, and hence at high , to be enhanced, at least for initial em issions. This e ect is seen experimentally in (Fig. 12), but is slight.

Sim ilar trends can be seen in event variables such as m issing transverse energy (M E T)

and $\mathcal{P}_T j$. The reduced particle multiplicity increases the probability of minimal or no MET, where no neutrinos are present in the event (neither directly emitted by the black hole, nor in weak decays of other primary emissions). The greater energy of the Hawking emissions increase the very high MET tail: a neutrino emitted by a rotating black hole is likely to have higher energy and momentum. The result is a atter, longer tail for the rotating case, extending further beyond 1 TeV, as shown in Fig.13.

W hen compared to the number of primary emissions from the evaporation, a greater number of detector objects (leptons, photons, hadronic jets) are observed following fast detector simulation. Neutrinos emitted by the black hole will not be seen experimentally, whereas a single heavy quark or vector boson will result in the detection of multiple particles or jets of hadrons. Equally, the transverse momentum spectrum observed experimentally will be slightly softer in general than that of the primary particles emitted by the black hole, due to secondary emissions and radiation.

5.3 Particle production probabilities

B lack hole rotation has a large e ect on the particle production probabilities (Fig. 14). The most dram atic of these is the enhanced emission coe cient for vector particles. This is due to the larger uxes and agrees with the greater dierential power uxes per degree of freedom shown in Fig. 4 (see vertical axis).

The greater proportion of vector em issions would provide strong evidence of rotating, rather than Schwarzschild, black holes. However such measurements are dicult to make in practice { at the LHC it will not be possible to distinguish gluon jets from quark ones. Though highly boosted vector bosons provide experimental challenges, Z bosons can often be studied via their leptonic decay modes. Perhaps the most accessible other means to investigate black hole rotation might be the study of the photon multiplicity or its ratio to other particles, TeV energy photons being one manifestation of black holes reproduced by neither other new physics scenarios nor SM backgrounds. A nother experimental diculty

for the detection and the isolation of the black-hole signal is that rotation decreases the probability of producing a lepton { often useful in reducing jet-like SM backgrounds to black hole events [106].

The emission probabilities for each particle species are largely independent of the number of extra dimensions, which primarily a ects the emission energy and multiplicity, so that a reproduction of the distribution of particle species would be powerful evidence of black holes.

The particle antiparticle in balance in Fig. 14 is chie y caused by the (usually positively charged) input state. A coording to the mechanism described in Sect. 3, up-type quarks and down-type antiquarks are favoured, so as to meet the constraints of charge balance. Sim ilarly, the net positive baryon number of the input state and the need to conserve baryon number for hadronisation leads to a preference for quarks over antiquarks. The apparent increase in this with rotation is a relection of the reduced particle multiplicity: with fewer particles amongst which to share the charge in balance, the elect is magniled. This is potentially a source of uncertainty since, unlike charge, black holes do not have to conserve baryon or lepton quantum numbers. At present we are constrained to conserve

these by the needs of hadronisation generators.

5.4 B lack hole evolution

As the Hawking emission proceeds, the black hole evolves, becoming lighter, hotter and losing angularmomentum as detailed in Fig. 15. W ithout the simulation of losses in production/babling, the black hole spins down more quickly than it loses mass; for large black

hole angular m om entum, energetic em issions at high m are highly favoured. Turning on the simulation suppresses initial states with high black hole angular m om entum. Consequently this e ect is reduced in m agnitude, though the majority of the black hole angular m om entum is still lost before its m ass.

Initially the high angular m om entum of the black hole leads to a high em ission ux so the typical time interval between em issions is reduced relative to a non-rotating BH.

The higher spin term in the Planckian factor causes there to be fewer, more energetic emissions for few extra dimensions. Half the mass is lost in the rst 3 emissions for n = 2, compared with 4 (n = 4) and 5 for n = 6. The distribution does have a substantial tail how ever, with 1% of black hole events producing more than 11 primary emissions.

As is shown in the contour plots of Fig. 16, black holes with high initial angular momentum tend to been much of it during their rst few emissions, whereafter further emissions decrease the black hole mass more smoothly, whilst its angular momentum stays relatively low, but non-zero. Thus the spin-down phase persists throughout the black hole decay { only a small proportion of black holes settling into a Schwarzschild, non-rotating state. This is in direct agreem ent with the theoretical plots in Figs. 6 and 7.

As the black hole becomes lighter, its temperature rises, as does its oblateness (a) and the time interval between emissions drops. These e ects are gradual except when the

black hole m ass becomes very low, at the end of the Hawking radiation phase. At this point we have reached the remnant phase.

The striated, lined structure in the angularm on entum plots is due to the initial state: the probability of a quark-gluon interaction, and correspondingly a half-integer angular momentum state is much lower than the integer state above and below it.

5.5 R em nant options

CHARYBDIS2 includes several models for the rem nant phase. Both xed and variable body decays have parameter switches to enable the system atics to be studied, as detailed in Sect. 4.

The xed multiplicity model, present in CHARYBDIS and optional in CHARYBDIS2, is linked to the choice of the variable KINCUT. If KINCUT=.FALSE., proposed decays that are kinem atically disallowed are ignored; if KINCUT=.TRUE., their proposal term inates the evaporation phase. The form er choice will give a greater num ber of less energetic particles, as evidenced by Fig. 17 which constrasts a range of rem nant models de ned in Table 2.

CHARYBDIS2 uses the NBODYAVERAGE rem nant criterion as a default, where the uxes are used to calculate the expected number of further emissions. This provides a physically motivated model. Using this criterion with either a xed 2-body (\nbody2") or a variable multiplicity rem nant model (\nvar2") gives a distribution lying between the upper and

low er values obtained using the older model switches (upper plots of Fig. 17), indicating good control over the uncertainties mentioned in Sect. 4. The string-motivated boiling model gives a slightly higher multiplicity, since successive emissions are produced until the remnant mass drops below the remnant minimum mass, resulting in a greater number of softer particles produced in the remnant phase.

The new NBODYAVERAGE model is also more robust with respect to changes in the number of particles produced in the rem nant phase. This is because the ux calculation allows the spin-down phase to be term inated whenever the expected number of further emissions is fewer than that selected for the rem nant phase. This is illustrated in the lower plots of F ig. 17, where changing the number of particles produced in the rem nant phase results in similar multiplicities and spectra; events with 4-body rem nant decays do not always have two more particles than their 2-body analogues.

A nother advantage of the NBODYAVERAGE m ethod is that by using the integrated power and ux, the spin-down phase is term inated at a point that allows a smoother transition to the rem nant phase, as shown by their spectra in Fig. 18, where the NBODYAVERAGE (lower) m ethod gives a more concordant distribution of particle transverse momenta. Perform ing a rem nant decay only when the mass drops below the Planck mass gives a much softer momentum spectrum, in contrast to the high energies favoured by light rotating black

holes. The option to start the rem nant decay based on the drop of hN i provides a sm oother transition, since the naldecay particles will have a harder spectrum, m ore similar to the H awking phase. Em issions in the rem nant phase are predom inantly coloured, with positive baryon num ber favoured, so as to meet the constraints of baryon num ber conservation.

5.6 M ass reconstruction

In principle, it is possible to reconstruct the black hole m ass by com bining the 4-m om enta of all particles observed in the event and m issing transverse energy. M ass resolutions of 200-300 G eV can be achieved for som e sam ples as shown in F ig. 19, but there is signi cant variation with di erent sam ples and black hole parameters. Events with large am ounts of M ET (particularly from multiple sources) tend to be more poorly reconstructed. Invoking a 100 G eV cut on M ET results in better reconstruction at the cost of som e signale ciency. Such a cut m ay not be entirely conservative how ever, for there m ay be additional sources of M ET neglected in our simulation, such as that from H aw king em ission of gravitons.

5.7 Planck m ass conventions

A lthough a one-to-one mapping between di ering conventions for the Planck scale is straightforward to make, naively changing the convention without compensating for the Planck mass value leads to large apparent di erences in the output distribution, due to their di erent n dependence. This is particularly the case for high num bers of extra dimensions for which the de nitions vary most widely, as shown in Fig. 20 where the D im opoulos-Landsberg and PDG Planck mass de nitions are contrasted.

A 1 TeV Planck mass in the D in opoulos-Landsberg convention equates to a larger value in the PDG convention, especially for large n (the increase ranges from a factor of 1:1 at n = 1 to 2:7 at n = 6). Consequently they have a higher H awking tem perature and far fewer particles are em itted, but with higher energies and transverse m om enta.

6.Conclusions

We have presented in detail the physics content of the new black hole event generator CHARYBDIS2, together with some results illustrating important features of the simulation of the di erent phases of black hole production and decay. Them ain new features com pared to most earlier generators, including CHARYBDIS, are: detailed modelling of the cross section and the loss of energy and angular momentum during form ation of the black hole (the so-called balding phase), based on the best available theoretical inform ation; full treatm ent of angular momentum during the evaporation phase, including spin of the incom ing partons, rotation of the black hole, and anisotropy and polarisation of all Standard-M odel elds em itted on the brane; and nally a variety of options for the Planck-scale term ination phase, ranging from a stable rem nant to a variable-multiplicity model connecting sm oothly with the evaporation phase.

O urm ain nding is that angularm om entum has strong e ects on the properties of the nalstate particles in black-hole events. Even after allow ing for a substantial loss of angular m om entum in the balding phase, the isotropic evaporation of a spinless Schwarzschild-Tangherlini black hole is not a good approximation, nor is the notion of a rapid spindown phase followed by mainly isotropic evaporation at foreseeable energies. A lthough the Hawking temperature does not depend strongly on the angular momentum of a spinning black hole of a given mass, there is a strong bias in the emission spectra towards higherenergy emissions into higher partial waves, which help the black hole to shed its angular momentum. The resultant spectra are atter, with substantial tails beyond 1 TeV. As a consequence of these more energetic emissions, rotating black holes emit with reduced multiplicity relative to their non-rotating counterparts. However the absolute multiplicity can still be large.

The preferential equatorial emission of scalar, fermionic and high energy vector particles leads to slightly less central distributions at detector level. This e ect is reduced by the evolution of the spin axis during evaporation (away from the initial orientation perpendicular to the beam direction). The emission of polarised higher-spin elds is favoured, com pared to the spinless case, leading to increased vector emission and marking a further departure from a purely democratic distribution of particle species. This shows little dependence upon the number of dimensions.

These ndings will com plicate the interpretation of black-hole events, should they occur at the LHC or future colliders. W hile the basic signature of energetic, dem ocratic em ission of all Standard-M odel species and large m issing energy rem ains valid, the deduction of the fundam ental P lanck scale and the number of extra dimensions will be m ore di cult than was anticipated in earlier studies [39]. On the other hand, m any interesting new and potentially observable features em erge, such as the di erent angular distributions and polarisation of particles of di erent spins. W e intend to investigate possible analysis strategies in a future publication.

In view of the important e ects of angular momentum, we would counsel against the use of black-hole event generators that neglect these e ects. This leaves BlackMax and CHARYBDIS2 and the generators of choice for future studies. Both programs take black-hole angular momentum fully into account, but they have other features and emphases that are complementary. In the form ation phase, BlackMax uses a geometrical approximation for the cross section and parametrizes the loss of energy and angular momentum as xed fractions of their initial-state values, whereas CHARYBDIS2 incorporates a more detailed model based on the Yoshino-Rychkov bounds and comparisons with other approaches. The treatment of the evaporation phase in the two programs appears broadly similar, but BlackMax has options for brane tension and split branes, and for extra suppression of emissions that would spin-up the black hole, while CHARYBDIS2 includes treatment of the polarisation of emitted fermions and vector bosons. The conservation of quantum num bers is also treated som ewhat di erently. At the Planck scale, BlackMax emits a nal burst of particles with the minim almultiplicity needed to conserve quantum num bers, whereas CHARYBDIS2 has a wider range of options.

A de ciency of both program s is the absence of gravitational radiation in the evaporation phase. This is because the greybody factors have not yet been computed for this case, due to extra theoretical di culties in the separation of variables. Unlike Standard-M odel particles, gravitons will necessarily be em itted into the bulk, giving rise to a new source of lost energy and the possibility of recoil o the brane. In the non-rotating case, it is known [73,74] that bulk graviton em ission is sm all for low numbers of extra dimensions, but increases rapidly in higher dimensions due to the growing number of polarisation states. However, the large number of Standard-Model degrees of freedom ensures that brane emission remains dominant. Clearly a full treatment of the rotating case is desirable, but there is hope that the elects will not be too signi cant, taking into account the uncertainties in energy loss already allowed for in the formation phase. Furthermore, as already discussed in Sect. 3, we expect the residual SM charges of the black hole to prevent recoil of the brane in all but a small fraction of events.

In sum mary, the simulation of black hole production and decay at hadron colliders has seen rapid advances in recent years, but there remain substantial challenges in both theoretical understanding and data analysis, should such events be seen. It is hoped that CHARYBDIS2 will serve as a convenient basis for continuing theoretical re nem ent and as a useful tool in the design of analysis strategies for this exotic and com plex possibility.

B. The Yoshino-Rychkov mass/angular momentum bounds

This appendix is divided into two sections. The rst is a brief review of the method in the Yoshino-Rychkov paper [22], focusing on the key equations we used to implement the Yoshino-Rychkov boundary curves in CHARYBDIS2. The second section explains how CHARYBDIS2 calculates the boundary curve $_{\rm b}($) for a given D and b.

Sum m ary of the Yoshino-Rychkov m ethod

It should be noted that in the Yoshino-Rychkov calculation, the usual assumptions are made { namely, that the extra dimensions may be regarded as in nite in extent, and that the only e ect of the brane's gravitational eld is to restrict the black hole produced to lie on the brane (the 'probe brane' approximation).

The rst stage of the calculation is the choice of metric for each of the colliding partons. Yoshino and Rychkov use the Aichelburg-Sexlmetric [107]. This is the metric produced by boosting a Schwarzschild-Tangherlinimetric to the speed of light, whilst reducing its associated mass to zero in such a way that its energy remains nite. It is appropriate to an ultrarelativistic point particle with no spin or charge, and so the Yoshino-Rychkov calculation neglects the elects of spin, charge, and nite size of the partons.

In the spacetime outside the future lightcone of the collision event (i.e. regions I, II and III of Fig. 21), the metric for the complete system is obtained by combining two A ichelburg-Sex1m etrics corresponding to partons travelling in opposite directions (in the centre of mass fram e). This gives the correct spacetime outside region IV of Fig. 21, because the colliding partons are taken as travelling at the speed of light, so there can be no interaction between their gravity waves before the collision.





The next stage in the calculation is the selection of a spacetime slice som ewhere in the union of regions I, II and III, on which one will bok for an apparent horizon (AH). An AH is a surface whose outgoing null geodesic congruence has zero expansion. A ssum ing the cosm ic censorship hypothesis [108], an event horizon (EH) must be present outside any AH; thus noting an AH is su cient to show that a black hole form s. Furtherm ore, the

fact that the EH must lie outside the AH, combined with the area theorem [109] which states that the EH area never decreases, can typically be used to set bounds on the mass and angular momentum of the form ed black hole.

The slice used by Yoshino and Rychkov is the futurem ost slice outside region IV – i.e. the boundary of this region. This slice was chosen because it gives the most restrictive, and therefore best, bounds on the maximum impact parameter for black hole form ation b_{max} , and thus on the cross section $= b_{max}^2$. It also gives the best bounds on the mass and angular momentum trapped in the black hole following production. The reasoning behind these statements is detailed more fully below.

To obtain a bound $b_{YRm ax}$ on the maximum in pact parameter for black hole form ation for a given D, the in pact parameter is increased at the given D until one no longer nds an AH – the critical value of b at which an AH no longer appears is then $b_{YRm ax}$. This will be a lower bound – there may be in pact parameters greater than $b_{YRm ax}$ for which an AH form s, but only 'after' the slice considered.

From the above, the best lower bound on $b_{m ax}$ that can be achieved (given that we are not able to look for AHs in region IV) is obtained by using the futurem ost slice outside region IV – i.e. the Yoshino-Rychkov slice. The bounds that Yoshino and Rychkov have obtained for $b_{m ax}$, and the corresponding results for , are given in Table II of [22].

We now discuss the calculation of the mass and angular momentum bound for a given b and D in the Yoshino-Rychkov method. In a trapped surface method, this is achieved by calculating the D 2 dimensional area corresponding to the AH, A_{AH} . Since the AH has the true black hole EH outside it, and the black hole EH area can never decrease according to the area theorem, it is norm ally the case that the D 2 dimensional area of the nal produced black hole EH, A_{EH} , should be greater than A_{AH} :

To produce valid bounds from the approach of nding an (M ;J) bound outlined above, it is necessary that an arbitrary surface outside the AH in the slice used has a larger area. Unfortunately, for the particular case of the Yoshino-Rychkov slice, this does not hold. However, Yoshino and Rychkov found a di erent area, A _{lb}, which they demonstrated would be a true lower bound on A_{EH} (A _{lb} is equal to twice the area of the intersection of the AH with the transverse collision plane). The calculation of the (M ;J) bounds then proceeds as described above, with M _{lb} and A _{lb} replacing M _{AH} and A_{AH} in equations (B .1) – (B .12).

The Yoshino-Rychkov slice should give the best bounds in this case as well. This is because the use of the futurem ost slice outside region IV should give the largest AH areas obtainable outside this region [22]. As a result, one expects to get the largest, and therefore strictest, low er bounds on M $_{\rm irr}$ using this slice.

Calculation of the mass/angular momentum boundary

If we rewrite equation (B.12) in terms of the fractions of initial state mass and angular momentum and , replacing all M_{AH} symbols in the equation by M $_{\rm lb}$ (in accordance with the fact that the Yoshino-Rychkov calculation uses the latter quantity), then we obtain

In (B.13), stands for the energy of each colliding parton in the centre of mass frame. This equation can be used to calculate the Yoshino-Rychkov bound $_{\rm b}$ () for a given b and D, provided one is able to obtain $_{\rm lb}$ for the b and D values used.

The problem of in plementing the Yoshino-Rychkov bound in CHARYBDIS2 is then one of ensuring that the program has a means of obtaining b for all values of D and b (5 D 11, 0 $p_{\text{Rm ax}}$ (D)). Calculating be exactly (i.e. using the full analytic m ethod) for a given b b and D, requires repeating the entire Yoshino-Rychkov calculation each time { i.e. nd the AH num erically, compute the area of its intersection with the transverse collision plane A $_{\rm b}$, and then convert this to an $_{\rm b}$ value using an equation sim ilar to (B 2). In plan enting the full calculation in CHARYBDIS2, to be repeated on an event by event basis, would slow down the program considerably. Instead, we use the $_{\rm b}$ vs. bdata les for D = 5 to D = 11 that had already been generated by Yoshino and Rychkov, and which were used to produce the D = 5 to D = 11 plots in gure 10 of [22]. CHARYBDIS2 computes the value of $_{\rm lb}$ for a given b and D by linear interpolation on the points in these data les. Linear interpolation provides su cient accuracy due to the close spacing (in b) of the points in the data les.

C. Details of the 'constant angular velocity' bias

This section describes the implementation of the constant angular velocity bias in the simulation of the black hole production phase. W ith the bias o (CVBIAS=.FALSE.), the values of ($, \frac{1}{2}$ are simply those generated from the linear ram p distributions described in

Sect. 2.2. W hen the bias is turned on, the (;) point to be passed to the Yoshino-Rychkov boundary routine is obtained in a more complex fashion, which is outlined below.

First, a point is generated using the linear ram p distributions as before. The horizon angular velocity and a value corresponding to the point, (;) and a (;), are calculated using the standard equations, and com pared to those of the initial state, (1;1) and a (1;1). In particular, the quantities $j(;) (1;1) \neq (1;1)$ and $j\log[a(;) = a(1;1)]j$ are calculated, and com pared to the values of the constants and respectively (whose values will be discussed shortly). Note that $j(;) (1;1) \neq (1;1)$ and $j\log[a(;) = a(1;1)]j$ are essentially both m easures of the di erences between the values at the point and the initial state values.

The point is then assigned a number (;) between 0 and 1, whose value largely depends on whether both j(;) $(1;1) \neq (1;1)$ and $j\log[a(;)=a(1;1)]j$ or not (i.e. whether (;) and a(;) are su ciently close to (1;1) and a(1;1) or not). If one or both of the conditions are not satisticed, then the point is assigned a constant k < 1 (as de ned below). If both conditions are satisticed, the point is assigned the value of a function (;). The function (;) has the key properties k < (;) 1, and approaches 1 as (;) gets closer to (1;1). The details of our choices for k and (;) will be discussed shortly.

A random number is generated according to a uniform distribution between 0 and 1. If (;)> then the point is accepted, otherwise it is rejected. If the point is rejected, further (;) points have to be generated by the ram p distributions, and put through the above procedure, until a point is accepted. The nalpoint is passed to the Yoshino-Rychkov boundary routine.

It is reasonably clear that this procedure for generating a (;) point (to be passed to the Yoshino-Rychkov boundary routine) is equivalent to a procedure which generates a point from a biased probability distribution of the form asserted in Sect. 2.2. To be specied, the biased probability distribution resembles the basic ram p probability distribution, but all points whose and a values are su ciently close to those of the initial state have had their probabilities enhanced. The enhancement is greater the closer (;) is to (1;1).

We now discuss our choices for the function and the parameters used in the above procedure. A suitable choice for the function (;), which has the properties stated, is based on the Breit-W igner form (note that we introduce a further 'width' parameter):

The constant k m ay then be xed by imposing continuity on (;), such that the biased probability distribution represented by the above procedure does not possess any sudden jumps. Note that we hope the dividing curves between the enhanced region and the unenhanced regions to be j(;) $(1;1) \neq (1;1) =$ on either side of the 'connected' curve (;) = (1;1) (which is connected to the point = 1; = 1). As explained in the main text, the a condition is only present to rem ove probability enhancem ent around the other 'disconnected' (;) = (1;1) curve, and should not interfere with the angular velocity based enhancem ent around the right curve.

On the basis of these assumptions, continuity of (;) is assured by taking

Note that with this choice of (;) and k, is a constant which sets the 'width' of the probability peak around the connected (;) = (1;1) curve, and the 'height' of this peak. The smaller is, the sharper and stronger the probability enhancem ent around the appropriate curve. The default value of is 0.4 for a probability enhancem ent which is not too strong -how ever, the value of this variable could potentially be changed.

The values of and were chosen by boking at a large number of individual (b;D) cases used by CHARYBDIS2, and trying to nd a suitable combination of values that gave enhancement of a suitable region only around the connected curve. This procedure resulted in the choice = 0.2 and = 0.4 (these values should not be changed, as sm all changes can cause drastic changes in the regions where the probability is enhanced).

A nalcomment is appropriate explaining the slightly peculiar form of the a condition for probability enhancement { jlog[a (;)=a(1;1)]j . The reason for this form is because, when trying to nd a condition that discriminated points around the connected curve from those around the disconnected curve, we noticed that those around the disconnected curve, had a values that were one order of magnitude (or more) away from the a values of the points around the connected curve. To remove the enhancement around the disconnected curve, a condition based on the logarithm of the ratio a (;)=a(1;1) is then more appropriate.

D. Evaluation of spheroidal wave functions

In a paper by Leaver [92] the spheroidal wave functions for arbitrary spin are expanded as a series in $x = \cos$ around x = 1. In this paper there is an extra parameter which can take either sign. We can alternatively expand around x = +1. So in general, we can construct three more expansions. Even though all four of them converge uniform by in $x \ge [1;1]$, the num erical errors behave dierently if we consider a xed region. Therefore it is useful to bok at all the options and use dierent expansions for dierent regions. The only extra complication will be to match them in a common region.

which diverges at x = s and goes exponentially faster to zero as we move obser to x = s. So if we do not tune to particular values of A_k this is how the num erical errors will behave. However, from the analytical point of view we still want to have an expansion which converges uniform ly, which is not the case in general as suggested by (D.5). Therefore we need to know how the ratio $b_{n+1}=b_n$ behaves for large n. Following [110] we determ ine this by assuming that for large n

It is straightforward to check that uniform convergence for x 2 [1;1] is only achieved in the second case. A solution with these convergence properties is called a m inim al sequence solution [92]. Furtherm ore, there is a theorem (see Theorem 1.1 of [111] and the reasoning in [110]) which ensures that the sequence obtained from the eigenvalue problem in (D.3), with the initial conditions given above, is a m inim al sequence. Therefore, after determ ining the eigenvalue we can compute the solution (up to a norm alisation) by xing $b_0 = 1$.

However, from the num erical point of view, a sm allerror in the eigenvalues in plies that $b_{h+1}=b_h$ will fail to go to zero when num erically evaluated through (D.3). So the rem ainder

will actually behave as (D.5), since in practice we are approximating the eigenfunction by a nearby function, for which the sequence of expansion coe cients behaves as a dom inant solution of (D.3) when n is $arge^{15}$. Thus the num erical radius of convergence will be a bit smaller and the expansion will fail at x = s.

We avoid the above convergence problem by using two expansions, one around each singular point x = 1, and then matching the normalisation in a region where both converge appropriately. A simple procedure form atching follows from the observation that

For the expansions above to be useful we need to estimate an order of truncation, n_{trunc} . A simple condition is that the ratio of consecutive terms $b_{h+1}=b_h$ is approximately constant above the order of truncation. This is equivalent (in the region sx < 0 where there is strong convergence) to an exponentially suppressed upper bound on the remainder when n_{trunc} is large (see (D.5)). From this and (D.3)

An initial estimate of the truncation error is obtained from (D.5). A nother criterion for truncation is that the rst neglected higher order term is small compared to the truncated sum.

In practice, after the spheroidal function is calculated with a certain truncation, then ten m ore term s in the series are included and the two estimates are compared. Simultaneously, the rst neglected term is compared with the estimate for the sum. If these errors are still large then ten m ore term s are calculated. This procedure is repeated until the desired accuracy is obtained.

To compute the eigenvalues A_k e ciently, the recurrence relation can be put in a symmetric tridiagonal form by performing a change of basis,

This is a tridiagonal symmetric eigenvalue problem which can be solved numerically very e ciently, by starting with a truncation order (as estimated above) and checking for precision by repeating the calculation with some more corrections.

where the prefactor is independent of the angular variables. These expressions show how a state of a particle/anti-particle with helicity h decom poses into plane wave states with the same helicity and momentum orientations $_{\rm p}$. The probability of a certain orientation is given by the square modulus of the spheroidal function with spin weight h.

Since m assless scalar, spinor and vector perturbations all follow the sam e m aster equation, these conclusions apply similarly to the remaining cases.
