Evidence of a new state in 11 Be observed in the 11 Li $-decay$

A bstract

Coincidences between charged particles em itted in the $-$ decay of 11 Liwere observed using highly segmented detectors. The breakup channels involving three particles were studied in full kinem atics allow ing for the reconstruction of the excitation energy of the 11 B e states participating in the decay. In particular, the contribution of a previously unobserved state at 16.3 M eV in 11 Be has been identi ed selecting the $+7$ He! $+6$ He+ n channel. The angular correlations between the particle and the center of m ass of the $6H$ e+ n system favors spin and parity assignm ent of 3/2 for this state as well as for the previously known state at 18 M eV.

The study of the $-$ decay of 11 Li constitutes a challenge for experimentalists. The high Q value (20.557(4) M eV $[1, 2]$), combined with the low particle separation energies in ¹¹Be, opens a plethora of decay channels, β], $-$ n β], $-2n[4]$, $-3n[5]$, $- [6]$, $+ [7]$ and $- d[8]$. These decay channels involve a variety of em itted particles over a wide energy range, which only recently has

been open for detailed spectroscopic studies due to the availability of segm ented detectors. The $-$ n channel, corresponding to the lowest energy threshold, at $0.504(6)$ M eV, has recently been studied in a series of $-$ -n coincidence ex-perim ents [\[9,](#page-7-8) [10\]](#page-7-9) and -delayed doppler broadening studies [1[, 12](#page-7-11)], which m apped the states of 11 Be fed in the 11 Li -decay up to 10.6 M eV excitation energy. Inform ation about the spin and parity of some of these states has also been obtained [\[10](#page-7-9)]. T he rem aining -delayed channels include the fragm entation of $11B$ e states into m ore com plex channels, in particular the ve body 2 3n channelm akes the identication of the original state in 11 Be dicult.

The rst -delayed charged particle em ission study done in coincidences and w ith time of ight particle identi cation established the presence of two dierent decay channels, three-body n $6H$ e and ve-body 2 3n [\[13\]](#page-7-12). Two states in 11 Be were proposed from energy considerations to contribute to these decays, one at 10.59(5) M eV identi ed in reaction studies [\[14\]](#page-7-13) and a previously unobserved state proposed at 18.5 M eV [\[13](#page-7-12)]. The second state was later con m ed by an experim ent using a gas-Sitelescope for particle identication [\[15](#page-7-14)]. The energy spectra of the $9;10B$ e, $4;6H$ e and d,t decay products were studied and the recom m ended energy for the state was $18.15(15)$ M eV. This state will be referred from here on as the 18 M eV state.

Furtherm ore, there have been experim ental hints of feeding to states in between these two states in 11 Be. In the gas-Si telescope experiment it was reported [\[15](#page-7-14)] that a peak at 1.2 M eV in the 9 B e+ 10 Be spectrum could be interpreted either as neutron em ission from a^{11} Be14.5 M eV state to the ground state in 10 Be, or as neutron em ission from the 11 Be 18 M eV state to the rst excited state in 10 Be. A later experim ent [\[11\]](#page-7-10) that studied the neutron-recoil doppler broadening of λ -lines follow ing ¹¹Lidecay reported a 6% of λ -feeding to excited states in 11 Be in the region between the 10.6 and 18 M eV states.

A dditional inform ation on the 11 Be states above the charged particle thresholds has been obtained by two recent reaction studies [\[16,](#page-7-15)[17\]](#page-7-16). From the spinparity assignm ent given to these new states they are not expected to be fed in the $-decay$ of $11Li$.

On the theoreticalside, shellm odelcalculations [\[18\]](#page-7-17) predict that a signi cant am ount of the -decay strength lays in the region between 10 and 18 M eV in 11 Be. C ertainly, the shape of the G am ow -Teller strength distribution depends on the s/p m ixing of the 11 Liground state wave function.

These results underline the in portance of studying the 11 Li -delayed charged particle em ission in great detail. In this Letter we present the study of the 11 Be excited states, fed in the 11 Li -decay, using the 11 Be ! $+$ ⁷He! n+ $+$ ⁶He channel, previously proposed in [\[6](#page-7-5)]. We have established the presence of this channel in the breakup of the 11 Be 18 M eV state [\[13,](#page-7-12) [15\]](#page-7-14). C om plete kinem aticalanalysis is possible from the detection of the energy and direction of the em itted particles provided by the use of segm ented detectors, w hich allow s to reconstruct the $7H$ e+ channel to obtain the excitation energy spectrum of 11 Be. Here we nd the contribution of a previously unidenti ed state at 16 M eV, and determ ined, from the angular correlation study, the spin and parity of both states.

The experim ent was carried out at the ISO LD E PSB Facility at CERN, w here the 11 Liactivity was produced in fragm entation reactions in a Ta target irradiated w ith 1.4 G eV protons from the C ER N PS Booster. T he target container was connected to a surface ionization source and the produced ions were extracted with a voltage of 30 kV . The 1^{+} 11 Liions were m ass separated from the dierent isotopes using the general purpose separator (G PS). The 11 Libeam was subsequently brought to the center of the setup w here it was stopped in a 50 q/m^2 carbon foil. The use of a thin foil, which m inim izes the energy loss of the em itted charged particles, was possible due to the low extraction voltage used in the experim ent. T he production in our experim entalcham ber was estim ated to be 800 11 Liions/s, obtained from the daughter 11 Be activity [\[19\]](#page-7-18).

The experim ental setup consisted of three particle telescopes, w ith 60 m thick D ouble Sided Silicon Strip D etectors (D SSSD 's) backed by Sipads for detection. Each D SSSD has its charge collection divided in 16 verticaland 16 horizontal strips, obtaining an angular resolution of 3.5° per 3 3 m m^2 pixel. The telescopes were mounted in xed positions on the surface of an alum inum table. The two detectors facing each other covered solid angles of 4% and 6% of 4, respectively [\[20](#page-7-19)].

The silicon detectors were calibrated using $148G$ d and the standard triple alpha source $(^{239}$ Pu, 241 Am and 244 Cm). An analysism ethod developed w ithin our collaboration [\[21](#page-7-20)] takes advantage of the highly segm ented nature of the D SSSD 's to precisely de ne the path of the detected particle and thus allow ing for the reconstruction of the energy losses in the non-active layers. The combined e ect of the dead layers and electronic noise lim its the detection threshold to 160 keV for alpha particles.

W e concentrate here on the charged particle coincidences recorded in opposite detectors, setting the angle between the detected particles between 120° and 180° . This geom etry is optimum for the study of three body processes by detection of at least two of the products in coincidences. In our case 90% of the coincidences were recorded in the pair of opposite detectors. The time w indow for the analysis was set to the rst 60 m s after the proton im pact, time long enough to allow for the diusion of the products from the target. This tim e w indow enhances the observation of the ${}^{11}Li$ -decay over the decay of the descendants. The directions of the detected charged particles were determ ined from pixel identi cation, w hich allowed for the calculation of their m om enta as wellas the deposited energy. In case ofa three body process one can reconstruct the energy of the third undetected particle, the neutron. A ssum ing that the particle of low est energy is the m ost m assive one, the individual neutron,

and 6 H e energies are plotted versus excitation energy in 11 B e in Fig. [1\(](#page-10-0)a). The advantage of this scatter plot, for sequential breakup of broad states, is that the rst em itted particle w ill be along a line w hose slope and o set are given by the m ass ratio of the fragm ent to 11 Be and the Q -value of the breakup, respectively $[22]$. In the plot m ost of the events are $-$ coincidences from the ve body 2 3n channel $[13, 6]$ $[13, 6]$, w hich are not correctly assigned in this plot as the three neutrons are not detected. Therefore, the events associated with the

2 3n channelare distributed overthe plotand actasbackground for the other channels. There are two distinct features in Fig. [1\(](#page-10-0)a). First, a horizontal line at 10.6 M eV excitation energy, associated to the breakup of the $5/2$ 10.6 M eV state in 11 Be [\[10](#page-7-9)]. Second, a grouping along the line of 11/7 slope and w ith 8.35 M eV o set. In this type of scatter plot, in case of sequential breakup through an interm ediate resonance of energy Q_R and m ass M_R, the energy of the rst em itted particle E_1 w ill appear along a diagonal line follow ing $E = Q_R + \frac{M}{M_R} E_1$, where M and E are the m ass and excitation energy of the decaying state. In our case Q_R corresponds to the ⁷H e+ separation energy in ¹¹Be, $Q_R = 8.35(2)$ M eV $[2, 23]$. Therefore, the line in Fig. [1\(](#page-10-0)a) corresponds to particles en itted in the breakup of 11 Be states through the ground state of the 7 He resonance [\[6\]](#page-7-5). There are two regions with accum ulations of events on this line, around 16 M eV and 18 M eV excitation energy, indicating the presence of states in 11 Be at these energies.

We selected events in the 11 Be ! 7 H e(gs)+ $\,$! $\,{}^{6}$ H e+ $\,$ + n channel by gating on the charged particle w ith the highest energy, which is assumed to be the particle. The two dotted lines in Fig. 1(a) show the interval analyzed, between the lines of slope of 11/7 and offersets of 8.93 and 7.93 M eV. The 11 Be excitation energy spectrum for these events, obtained from the sum of n , and $6H$ e energy plus Q_n $_{6}$ $_{H e}$, is shown in Fig. [1\(](#page-10-0)b). The two groupings of events observed in the scatter plot of Fig. [1\(](#page-10-0)a) correspond to the clear peak around 16 M eV, plus the contribution at higher energies of the previously observed 11 Be state at 18 M eV [\[13](#page-7-12), 15]. The peak at around 16 M eV indicates the presence of a state in 11 Be previously unreported in the literature.

We perform ed a M onte-C arlo simulation of the breakup of the 16 and 18 M eV states in 11 Be into the three body n 6 H e and ve body 2 3n channels, the latter channel considered as a broad background. The resonances were described using the single-channelnon-interfering R -m atrix form alism as described in the A ppendix A of R ef. [\[24](#page-7-23)]. The particle penetrability was calculated using the orbitalangularm om entum values com patible w ith the spin-parity of the 11 Be states and the 3/2 ground state in $\frac{7}{1}$ He. The penetrability of the neutron connecting the 7 H e ground state w ith the 0^+ ground state in 6 H e was calculated for ± 1 orbital angular m om entum . The ve body 2 3n breakup for the two states was m odeled following the prescription given in Ref. [\[6\]](#page-7-5). The sim ulation including the contribution ofthe dierent channels is show n as the red histogram of Fig. [1\(](#page-10-0)b), with each component color-coded following the legend. The param eters used to describe the dierent resonances are listed in Table [1.](#page-9-0)

The resonance param eters were evaluated via $2 \text{ tests of the }^{11}\text{B}$ e excitation energy spectrum . W e perform ed a series of M onte-C arlo sim ulations varying the energy centroid and the reduced width individually, tting the resulting 2 values to a parabola to obtain the m inimum. We obtained $E_0 = 16.3(1)$ M eV and 2 = 0.05(1) M eV, with a full width at half m aximum (FW HM) of 0.7(1) M eV, for the rst state and $E_0 = 18.4(3)$ M eV and $^2 = 0.11(4)$, FW HM = 1.6(6) $M \text{ eV}$, for the second. For both resonances the channel radius was set to 4.9 fm , r= r_0 ($A_1^{1=3}$ + $A_2^{1=3}$) w ith r_0 = 1.4 fm , and the resonance shift param eter was

calculated using the form ulation of the single-channel non-interfering R-m atrix form alism as described in the Appendix A of Ref. [24]. The energy and width of the latter state were previously determ ined in [15] from the tof singles spectra. Values of $E_0 = 18.2(2)$ M eV and FW HM = 1.25(15) M eV were obtained from the ^{9,10}Be spectrum; E₀=18.0(1) M eV and FW HM = 0.8(1) M eV from the ^{4,6}He spectrum and $E_0 = 18.15(15)$; and FW HM = 1.3(3) from the triton spectrum. The resonance parameters obtained in this work coincide within error bars with the previously published param eters, although are m ore in line with the values obtained from the $9,10$ Be spectrum. Analysis of the triton spectrum from the sam e experim ent yields an energy and width of this state of $18.35(30)$ and $1.5(4)$ M eV respectively [20], consistent with the results obtained from the n 6 He channel presented here.

The fact that the three body breakup channel is sequential and occurs through an interm ediate state, 7 H e, w ith J \neq 0,1/2 perm it the use of the angular correlations to deduce the spin of the initial state in 11 Be. The angle between these two directions is distributed according to the expression $1+A_2(2\cos^2$ - $1/2$, where A_2 depends on the spin of the initial and interm ediate resonances. A s the 11 Li ground state is 3/2 [25], the selection rules for allowed transitions indicate that m ainly $1/2$, $3/2$ and $5/2$ states in 11 Be are populated, whereas the spin and parity of the interm ediate 7 H e(qs) resonance is 3/2 [26]. We calculated the appropriate A_2 param eters from the param eterization given in [27], obtaining $A_2 = 1$, 0 and -0.714 for $1/2$, $3/2$ and $5/2$ respectively, and perform ed $a⁻²$ test of the simulation of the angular distribution of the breakup assum ing every possible spin. In order to separate the contribution of each individual level we gated the sum energy spectrum in the following way: (i) the 15.7 to 16.6 M eV interval is chosen for the characterization of the 16 M eV state, as its contribution in this region is higher than the contribution of the 18 M eV state, see Fig. 1(b), (ii) the gate for the 18 M eV state was chosen between 17.4 and 18.6 M eV, asymmetric with respect to the known resonance centroid due to the weight of the Ferm i factor. The experimental angular distributions for both cases are shown in Figs. $2(b)$ and (a) respectively, with the simulations for the m ost favored spin assignm ent overlaid, and color coded according to the legend. One has to keep in m ind that the spin of the 18 M eV state had to be studied

rst, as part of the statistics in the region of the 16 M eV state com es from the tail of the 18 M eV state. The results of the $\frac{2}{3}$ test, for 19 degrees of freedom, for the 18 M eV state were 2 = 67.54 for 1/2, 16.62 for 3/2 and 30.62 for $5/2$, which show that a spin of $3/2$ is favored. In the case of the 16 M eV state, the results of the $^{-2}$ tests, setting the spin of the 18 M eV state to 3/2, again for 19 degrees of freedom, are $\frac{2}{5}$ = 70.50 for 1/2, 20.57 for 3/2 and 58.68 for 5/2, leaving 3/2 as the only possible spin. In sum m ary, the analysis of angular correlations in the ${}^{7}H e(qs)$ channel supports an assignment of spin of $3/2$ for both states in 11 Be.

The -decay branching ratios to the 11 Be states discussed in this Letter were obtained from the M onte-C arlo simulations, rather than directly from the coincidence data. This is due to the di culty in determ ining the experimental coincidence e ciency for the di erent channels discussed, as it depends on the

kinem atics of the channel in question. The M onte-C arlo simulation, including realistic detector solid angle coverages and energy thresholds, was matched to the observed intensity of the coincidences in opposite detectors, and the intensity of each channel was determ ined by the total initial intensity of the simulation before applying the experimental restrictions or the experimental conditions. The branching ratios were obtained using for normalization the activity from the decay of the daughter nucleus 11 Be (T₁₌₂=13.81(8)s [25]), measured w ithout any time restrictions. The branching ratio of the 11 Be channel follow ing ¹¹Libeta decay is obtained from the product of two term s, the ¹¹Li feeding to the rst excited state in 11 Be assum ing that the $-$ feeding to the 11 Be ground state is negligible, and the 11 Be -delayed branching ratio of the 11 Be

channel. The rst term, the feeding to the 11 Be 320 keV state is taken as the weighted average of the values from $[9, 28, 29, 30, 31]$, resulting in $7.4(3)$. The second term, the 11 Be channel has only been determ ined once before [19], with a value of $2.9(4)$ %. The resulting branching ratios are shown in the last column of Table 1. The sum of the branching ratios to the 16 and 18 MeV states, $0.31(5)$ %, is comparable to the previously published values of $-$ feeding to the 18 M eV state in 11 Be, 0.30(5)% [13] and 0.39(7)% [6].

The B (GT) values are calculated from the branching ratios. This approach can be problem atic for broad levels, as the B (GT) is norm ally de ned as a factor in the R-m atrix form alism (see e.g. $[24, 32]$). Instead, we used a m odied ftvalue, where the Ferm i function was substituted by its average over the state resonance shape, which was modeled using the single-level single-channel Rm atrix form alism [24]. In the case of the 18 M eV state in 11 Be we included the neutron em ission channels to states in 10 Be, with branching ratios taken from [15], and the t value obtained in this experiment [20]. The resulting B(GT) values are shown in Fig. 3(b), represented as solid bins. The B(GT) values for levels below the charged particle em ission thresholds are included for com pletion, and represented as open bins. These B (GT) values were calculated from the branching ratios of $[11, 10]$, assum ing the levels are narrow and using the reqular ft-value. The lled part of the 10 M eV bin in Fig. 3(b) shows the B (GT) deduced from the branching ratio corresponding to charged particle em ission from the 10.6 M eV state, taken from [6].

Fig. 3(a) show s the calculated B (GT) strength distribution to excited states in 11 Be from shell m odel done using unrestricted excitation space in the p and sd shells (for details see [28, 33]). The inset panels in Fig. 3(a) shows the partial B (GT) distribution assuming feeding only to 3/2 or 5/2 states in 11 Be, respectively. The shape of the calculated B(GT) distribution to 3/2 states at high excitation energy in 11 Be (E > 10.6 M eV) follows the trend of the experimental $B(GT)$ values, supporting the $3/2$ spin and parity assignment for these states given in this work. The experimental B (GT) strength for the 16 M eV state in 11 Be is low compared to our shell model prediction and to the $B(GT)$ strength calculated in [18]. It should be stressed that the $B(GT)$ values for the 11 Be excited levels given in this work correspond to decays were at least two charged particles are involved in the breakup. However, one should be aware that there is previous evidence of a feeding of up to 6% to levels in the

region between 14-17 M eV excitation energy in ¹¹Be decaying through neutron em ission to low excited states in 10 Be [11]. This could explain the di erence between the expected B (GT) distribution in this region and the experimental one. Unfortunately, with our setup, we just enhance the two-body and threebody decay channels involving at least two charged particles.

The study of the 11 Be ! + 7 He! n+ + 6 He breakup channel presented in this Letter shows the power of the full kinem atic analysis when three body channels participate in the decay. The presence of ve body decay channels can obscure the signature of the three body ones, unless one has a suitable setup as the one used in this work. Full kinem atics was achieved by detecting the

and the 6 H e in coincidence, and reconstructing the neutron energy and em ission angle from energy and m om entum conservation. This allowed us to disentangle the presence of this three body channel in the decay of two excited states in 11 Be, a known state at 18.4(3) M eV, and a state at 16.3(1) M eV, previously unreported in the literature. A lthough no experimental evidence of such state in 11 Be existed, previous shellm odel calculations [18,33] predicted strength in this region. The study of the angular correlations in the breakup of these two states indicates a 3/2 spin assignm ent for both states.
