## Processing of Cosm ological Perturbations in a Cyclic Cosm ology

The evolution of the spectrum of cosm obgical uctuations from one cycle to the next is studied. It is pointed out that each cycle leads to a reddening of the spectrum. This opens up new ways to generate a scale-invariant spectrum of curvature perturbations. The large increase in the am plitude of the uctuations quickly leads to a breakdown of the linear theory. M ore generally, we see that, after including linearized cosm obgical perturbations, a cyclic universe cannot be truly cyclic.

### I. IN TRODUCTION

R ecently, there has been renew ed interest in cyclic cosm ologies. The motivation comes in part from general efforts to construct non-singular cosm ological backgrounds (see e.g. [1] for a recent review), in part from attempts to construct a cyclic cosm ology [2] as an extension of the Ekpyrotic universe scenario [3].

A problem which faces most attempts at constructing a cyclic cosm ology and which was already pointed out by Tolm an [4] is that the background cosm ology cannot be cyclic if the fact that entropy is generated in each cycle is taken into account (see, how ever, [5] for a recent model which partially resolves this problem). How ever, as discussed in [6], the entropy of cosm ological perturbations does not grow as long as the uctuations remain well described by linear theory. This is due to the fact that each perturbation mode continues to describe a pure state if it starts out describing a pure state.

In this N ote we discuss a problem for cyclic cosm ology which arises even in the absence of entropy generation: since on super-H ubble scales the curvature uctuations do not evolve symmetrically - they grow in the contracting phase and are constant in the expanding phase - there is a net grow th of the uctuations from period to period which destroys the cyclic nature of the cosm ology [32].

Since long wavelength modes have a wavelength which in the contracting phase is larger than the Hubble radius for a longer time than short wavelength modes, the spectrum of uctuations on super-Hubble scales in the contracting phase is redder than the initial spectrum on sub-Hubble scales. Thus, both the amplitude and the slope of the spectrum of uctuations changes from cycle to cycle - an e ect which we call \processing of the spectrum of cosm ological uctuations". The reddening of the spectrum takes place in each contracting phase: the initial sub-Hubble scaling of the spectrum di ers from the later super-Hubble scaling.

The am ount of reddening depends on the contraction rate of the universe and hence on the equation of state of the dom inant form of matter. As noticed in [7,8,9], the reddening of the spectrum has the right strength to turn a vacuum spectrum on sub-Hubble scales into a scaleinvariant spectrum on super-Hubble scales if the universe is dom inated by cold m atter. M ore speci cally, on scales which exit the Hubble radius in a matter-dom inated phase, an initial vacuum spectrum on sub-Hubble scales is converted into a scale-invariant one on super-Hubble scales. This observation was used to propose the \m atter bounce" alternative to cosm ological in ation for creating a scale-invariant spectrum of cosm ological uctuations. Such a matter bounce is naturally realized [10] in the context of the \Lee-W ick" model [11] for scalar eld matter, which is a particular case of the more general quintom m atter bounce scenario [12]. M odi ed gravity theories such as the B iswas et al. [13] ghost-free higher derivative gravity theory or H orava-L ifshitz gravity [14] on spatially non- at spatial sections can also lead to matter bounce scenarios, as studied in [15] and [16], respectively [33].

In this Note we will compute the change in the am plitude and slope of the spectrum of cosm ological perturbations from one cycle to the next. We begin with a short review of the relevant form alism. Then, we com pute the change in the spectrum of cosm ological perturbations from one cycle to the next.

## II. FLUCTUATIONS IN A CYCLIC BACKGROUND COSMOLOGY

W e postulate the existence of a cyclic background cosm ology. The turnaround between the expanding phase and the contracting phase at large radius could be generated by a spatial curvature term (in the absence of a cosm ological constant), for the turnaround between the contracting phase and the expanding phase new ultraviolet (UV) physics which violates the weak energy condition is required. In the context of the E instein eld equations, such new UV physics can be modeled by quintom m atter [18]. A symptotically free higher derivative gravity actions such as the ones proposed in [13, 19] can also lead to a non-singular bounce. Finally, in a background with non-vanishing spatial curvature, H orava-Lifshitz gravity [14] can also lead to a bounce under the conditions on m atter spelled out in [16].

In Figure 1 we present a space-time sketch of a cyclic cosm obgy. We choose the origin of the time coordinate (verticalaxis) to coincide with a bounce point. The equa-

tions simplify if we work in terms of conformal time which is related to the physical time t via dt = a()d, where a() is the scale factor. During the time interval between  $_{c}$  and  $_{c}$ , the new UV physics which yields the non-singular bounce is dominant, for other times the elective equations of motion for gravity are assumed to reduce to those of E instein gravity.



FIG.1: Space-time sketch of the cyclic background cosm ology. Time is along the vertical axis, comoving length along the horizontal axis. The majenta curve (labelled by H) denotes the Hubble radius H<sup>-1</sup>(t), the vertical line labelled by k represents the wavelength of a perturbation mode which exits the Hubble radius at the time t<sub>H</sub> (k). The origin of the time axis is chosen to be the non-singular bounce point (around the bounce the Hubble radius diverges to in nity, an e ect not shown on the graph. The time to is the turnaround from the expanding phase to the contracting phase.

The horizontalaxis in Figure 1 denotes co-m oving distance x. The vertical line corresponds to the wavelength of a cosm ological uctuation mode. This mode crosses the Hubble radius (the dashed curve) at times  $_{\rm H}$  (k).

In the presence of cosm ological perturbations without an isotropic stress, the m etric in longitudinal gauge takes the form

where the function (x; ) describes the uctuations (see e.g. [20] for a review of the theory of cosm ological perturbations). We are interested in computing the spectrum of , the function describing the curvature uctuations in co-moving coordinates. is given in terms of via

H denoting the Hubble expansion rate in conform altim e, a prime indicating the derivative with respect of  $\$ , and

 The variable in turn is closely related to the variable v [21, 22] in terms of which the action for cosm ological uctuations has canonical kinetic term :

Here,  $z\left( \ \right)$  is a function of the background which for constant equation of state is proportional to the scale factor  $a\left( \ \right).$ 

At linear order in perturbation theory, the equation of motion for the Fourierm ode  $v_k\,$  of v is that of a harm onic oscillator with a mass whose time-dependence is given by the background cosm ology:

This shows that, whereas on sub-H ubble scales  $v_k$  is oscillating with approximately constant amplitude, on length scales larger than the H ubble radius (where the  $k^2$  term is negligible) the oscillations of v freeze out and the time-dependence of v is given by that of the background. One of the solutions of (4) on super-H ubble scales evolves as  $v \ z \ a$  and corresponds to a constant value of . The second mode of v corresponds to a decreasing mode of in an expanding universe. On the other hand, in a contracting phase it corresponds to an increasing mode.

We see that the evolution of the curvature uctuation is asymmetric between the contracting phase and the expanding phase. The dominant mode is constant on super-Hubble scales in the expanding phase whereas it is increasing in the contracting phase. It is this asymmetry which is responsible for the processing of the spectrum of uctuations in a cyclic background cosmology.

# III. PROCESSING OF THE SPECTRUM OF COSMOLOGICAL PERTURBATIONS

In this section, we will study the processing of the spectrum of cosm ological perturbations from one cycle to the next. W e will consider scales for which the background is expanding (or contracting) as a power of tim e:

In this case, the solutions of (4) are given by

W e are interested in the range of values 1=3 for which is a negative number. In the contracting phase

prior to the bounce at = 0, the dom inant solution of (4) thus scales as

There are two cases of special interest. First, in a matterdom inated universe p = 2=3 and hence the dom inant mode of  $v_k$  scales as

In fact, from (8) we see that for matter with an equation of state w > 1=3 the amplitude of v is decreasing as the bounce is approached, whereas for w < 1=3 the amplitude is increasing. W e will focus on the more physical second case.

Let us assume initial conditions for uctuations on sub-Hubble scales at some initial time  $_{\rm i}$  long before the bounce point:

where  $A_{\rm i}$  is the initial amplitude of the spectrum of  $\,$ ,  $n_{\rm i}$  is the initial slope, and  $k_0$  is the pivot scale. Our aim is to calculate the amplitude  $A_{\rm f}$  and slope  $n_{\rm f}$  after one cycle.

M aking use of the fact that  $\boldsymbol{v}_k$  oscillates until the tim  $\boldsymbol{e}$ 

 $_{\rm H}$  (k) when the wavelength exits the H ubble radius and subsequently increases in am plitude as given by (8), we see that at the time  $_{\rm c}$  immediately before the bounce, the time when the weak energy violating e ects which yield the non-singular bounce start to dominate, the am – plitude of  $v_{\rm k}$  is given by

The next step of the analysis is to follow  $v_k$  through the non-singular bounce from time  $_c$  to  $_c$ . The rst approach to do this would be to m atch the values of the uctuations at the two times using the Hwang-V ishniac [23] (see also [24]) m atching conditions. However, the applicability of this prescription is questionable [25] since the background does not satisfy these m atching conditions. In the case of a non-singular bounce we can, how – ever, follow the evolution of the uctuations through the bounce explicitly, assuming the validity of the Einstein equations for the uctuations. Since we are dealing with m odes which are in the far infrared (even at the bounce point) com pared to the characteristic scale of the bounce, this assumption is a safe one to m ake (as has been veri-

ed explicitly in [15] for the bounce model of [13]). The lesson that has been learned by following uctuations through the bounce in several models [12, 26, 27, 28] is that the spectrum of  $v_k$  does not change on scales for which the wavelength is long compared to the duration of the bounce. This is clearly satis ed for the case of interest to us.

In the expanding phase, the am plitude of  $_k$  is constant on super-Hubble scales. A fter the wavelength re-enters the Hubble radius, the am plitude of  $v_k$  does not change until the mode leaves the Hubble radius once more in the contracting phase of the following cycle. To obtain the change in the spectrum of cosmological perturbations, we need to evaluate the spectrum of uctuations at the time  $_i$ , the mirror in age of the initial time. The spectrum at  $_i$  will be identical to the spectrum at the time corresponding to  $_i$  in the next cycle.

To compute this spectrum, note that the amplitude of  $_k$  is decreasing between the time  $_{\rm H}$  (k) when the mode re-enters the H ubble radius and the time  $_{\rm i}$  since it is  $v_k$  which has constant amplitude during this time interval. Thus

The results (19) and (20) give the change in the slope and in the amplitude of the spectrum of cosm ological perturbations from one cycle to the next. Each cycle leads to a reddening of the spectrum and to an increase in its amplitude. The slope changes by  $2(3p \ 1)=(1 \ p)$ , The increase in amplitude soon leads to a breakdown of the validity of the perturbative analysis, with consequences for the multiverse discussed in [29]

A s m entioned in the Introduction, if p = 2=3, then an initial vacuum spectrum (n = 3) on sub-Hubble scales is transformed into a scale-invariant spectrum after the bounce. If we want an initial Poisson spectrum (n = 4) to be transformed into a scale-invariant spectrum after one complete cycle in the second expanding phase, the background needs to satisfy p = 7=13, i.e. an equation of state close to that of radiation. This is a sim ple application of the processing of the spectrum of cosm ological perturbations which we have discussed here.

### IV. CONCLUSIONS AND DISCUSSION

W e have studied the evolution of the linear cosm ological uctuations from one cycle to the next in a cosm ology with a periodic background. Due to the asymmetry in the evolution of uctuations in the contracting and expanding phases, there is a large increase in the am plitude of the perturbations from one bounce to the next. In addition, there is a characteristic reddening of the shape of the spectrum.

The immediate implication of our analysis is that the evolution of the universe in a cosmology with a cyclic background is not cyclic.

The characteristic processing of the slope of the spectrum of perturbations which we discuss in this note in principle opens up new avenues of generating a scaleinvariant spectrum of perturbations during a speci c cycle. For example, a matter-dom inated background with a spectrum with an initial steep blue index  $n_s = 5$  willyield a scale-invariant spectrum after two bounces, in the same way that an initial vacuum spectrum with  $n_s = 3$  yields a scale-invariant spectrum after one bounce [8]. The processing of uctuations also opens up new ways of generating a scale-invariant spectrum of curvature perturbations starting from therm al inhom ogeneities [30]. Note that a characteristic feature of such scenarios are large non-G aussianities with a particular shape, as worked out in [31].

However, the increase in the amplitude of the uctuations quickly leads to a breakdown of the linear analysis. The nonlinear evolution will then lead to entropy production and to the usual problem s for cyclic background cosm ologies rst discussed in [4].

We should note that the cyclic version [2] of the E kpyrotic universe scenario does not su er from the problem s discussed here since the scale factor of \our" universe in the E kpyroticm odel [3] is not cyclic. The only cyclicity in the E kpyrotic scenario is in the evolution of the distance between the two boundary branes. The scale factor of our universe is monotonically increasing. Thus, perturbations produced at a xed physical scale in one \cycle" are redshifted by the tim e the next \cycle" arrives.
