Production in In-In Collisions at 158 A GeV

Abstract. The NA60 experiment has measured muon pair production in In-In collisions at 158 AG eV at the CERN SPS. This paper presents a high statistics measurement of ! meson production. Dierential spectra, yields, mass and width are measured as a function of centrality and compared to previous measurements in other colliding systems at the same energy. The width of the rapidity distribution is found to be constant as a function of centrality, compatible with previous results. The decay muon polar angle distribution is measured in several reference frames. No evidence of polarization is found as a function of the medium. The T_{eff} parameter measured in In-In collisions suggests that the high value observed in Pb-Pb in the kaon channel is di cult to reconcile with radial ow alone. The absolute yield is compared to results in Pb-Pb collisions: though signi cantly smaller than measured by NA50 in the muon channel, it is found to be compatible with the PDG values at any centrality and at any $p_{\rm T}$: no evidence for in-medium modi cations is observed.

1 Introduction

QCD predicts the occurrence of a phase transition from hadronic matter to a decon ned plasm a ofquarks and gluons, when su ciently high energy densities are reached. Strangeness enhancem ent was proposed long ago as a signature of this phase transition [1,2]. The meson is a key experimental probe in this context: due to its ss valence

quark content it perm its to measure strangeness production. It was suggested that, being a hidden strangeness state, the should not be sensitive to canonical suppression, and can thus be used to test strangeness enhancementmodels [3,4,5,6,7].

M oreover, it has been argued that the spectral function of the or of its decay products could be m odi ed in the m edium. This would re ect in changes of its m ass and partial decay widths. M ass shifts of vector m esons, as a consequence of the change of the quark condensate in the m edium, were originally proposed by Brown and R ho [8]. Subsequently, the m eson m ass dependence on them edium density was calculated with Q C D sum rules [9]. M odi cations of the width in the context of this dropping m ass scenario were investigated, for instance, in the m odel of R ef. [10]. A s an alternative approach, both them ass and width changes were studied in the fram ework of hadronic m any body m odels (see [11] for an up-to-date discussion), which predict a broadening and no or sm all m ass shift. Finally, it was suggested that in-m edium changes could also appear in cold nuclear m atter [12,13].

It is in portant to point out that, contrary to the m eson which has a lifetim e of 1.3 fm , m uch sm aller than the lifetim e of the reball (7–10 fm), the has a lifetim e of 44 fm . Therefore in-m edium e ects on the m ass or width m ightbedi cult to isolate experimentally, and m ight only appear at very low p_T . A possible way of tracing down thosem odi cations is the comparison of the particle yields and spectra in the dilepton and in the kaon channel: since the is almost at the threshold for the ! KK channel, even a sm all change in its spectral properties should lead to a signi cant di erence in the two channels [14]. A discrepancy in the two channels could also be ascribed to nal state e ects related to in m edium kaon absorption or rescattering [15,16].

The KEK-PS E325 experiment reported evidence for a large excess to the low mass side of peak in p-Cu at 12 GeV for < 1.25, corresponding to slow mesons, having a higher chance to decay inside the Cu nucleus (the e ect was not observed in p-C and for higher values of) [7]. This excess was explained in terms of an inmedium modi ed component with mass decreased by 35 MeV and width broadened by a factor 3.6 with respect to the PDG value. The reported yield associated to this excess is very signi cant: 20% of the total yield.

production was studied extensively at the SPS by several experim ents. NA 49 m easured production in p-p, C-C, Si-Si and Pb-Pb at 158 AGeV in the ! K⁺K channel [18,19,20]. These data show that the yield breaks N $_{\rm part}$ scaling and that the $\,$ enhancem ent, quanti ed as h i=N_{part}, saturates already for Si-Si central collisions. Pb-Pb collisions were also studied in dierent experimental conditions by the NA 50 experiment, which found contrasting results. NA 50 studied the ! channel [21] with acceptance limited to $p_T > 1:1 \text{ GeV}$, while the NA 49 measurement in the ! K⁺K channel was limited to $p_T < 1.6 \text{ GeV}$ because of statistics. Both experiments observed an enhancem ent of the yield with the size of the collision system . The absolute yields, how ever, disagree by a factor 4 in full phase space [22]. A recent NA 50 analysis of a new sample con med previous ndings [23]. The NA 49 and NA 50 results disagree also on the T_{eff} param eters extracted from the transverse mass spectra tted with the therm alansatz. The NA 49 T_{eff} values are consistently larger and show a stronger centrality dependence than those measured by NA 50.W hile this could be partly due to the radial expansion, which attens the distribu-

tions at low m $_{\rm T}$, the e ect is too large to be explained by radial ow alone.

Naively, kaon absorption or rescattering could prevent the reconstruction of in-matter $\,!\,$ K K decays, in particular at low transverse momentum, while the mesons decaying in the lepton channelwould not be a ected. This would lead to reduced yields and enhanced T_{eff} in the K K channel compared to the channel. Meson modication in the medium could also lead to differences in the two channels, as mentioned above. The difference between NA 49 and NA 50, how ever, is larger than predicted by models including all these e ects [10,14,15,16,24]. The discrepancies in absolute yields and T_{eff} became known as the puzzle.

Production of in central Pb-Pb collisions was recently studied also by CERES [25] both in the kaon and dielectron channels. Them easured $T_{\rm eff}$ and yield are com – patible with the NA 49 results. How ever, due to the large uncertainty in the dielectron channel, the authors could not rule out com pletely a possible di erence in the two channels, though signi cantly sm aller than the NA 49/NA 50 di erence: the maximum possible enhancement in the leptonic overhadronic channelwas estimated to be 1.6 at 95% con dence level.

In this paper we report on new measurements in the m uon channeldone by the NA 60 collaboration in In-In collisions at 158 AG eV incident beam energy, which can help production in nuclear collisions. Transverse to clarify momentum and yields have been studied as a function of centrality.Transversem om entum spectra, measured in the range 0 3 G eV, and yields are com pared to previous results, providing further insight on the puzzle. The mass and width of the are studied as a function of centrality and p_T , in order to search for possible in-medium e ects. The results are compared to previous measurements and existing theoretical predictions for In-In collisions. In addition, the rapidity and the decay angular distributions in three reference fram es (Collins-Soper, Gottfried-Jackson and the helicity fram e) are also measured. In elementary collisions, the decay angular distributions can convey information on the production mechanism [26]. No measurements exist in p-p, while the ACCMOR collaboration perform ed m easurem ents of the polarization in pion, proton and kaon - Be interactions [27,28] . A small but signi cant transverse polarization was reported at low p_T in the Gott red-Jackson frame, which was related to the parton fusion model to estimate the average mass of the fusing partons. M ore recently, NA 60 m easured the angular distributions in In-In collisions, integrated in centrality and for $p_T > 0.6$ GeV , for the excess dim uons below 1 GeV (dominated by + ! ! +) and the vector mesons ! and [29]. The reported absence of any anisotropy indicates the completely random orientation of the interacting hadrons in 3 dim ensions as expected in the case of a therm alized medium. In this paper we extend these results by perform ing the study as a function of centrality and p_T .

2 The NA60 apparatus

In this section the detectors of the NA60 apparatus used in the analysis are brie y described. A more detailed description can be found in Ref. [30].

The 17-m -long m uon spectrom eter, previously used by the NA 38 and NA 50 experim ents [31], is com plem ented by new silicon detectors in the vertex region. The experim ental apparatus is shown in Fig. 1. The m uon spectrom eter is com posed of 8 m ulti-w ire proportional cham bers and 4 scintillator trigger hodoscopes, divided into a \forward" and a \backward" telescope by the 5-m -long ACM (A ir C ore M agnet) toroidalm agnet. A 120 cm thick iron wall, located just before the last trigger hodoscope and after the tracking cham bers, ensures that only m uons can trigger the apparatus, w ithout degradation of the tracking accuracy. The angular acceptance is 35 < 120 m rad; the rapidity coverage for the is $3 \cdot y \cdot 42$.

A 12 $_{\rm i}$ hadron absorber, mostly made of graphite, is placed in front of the tracking system of the muon spectrom eter, as close as possible to the target to minimize the fraction of hadrons that decay into muons. The identication provided by this \muon lter" leads to a very selective trigger, enabling the experiment to run at very

high lum inosities. However, the material in the hadron absorber also degrades the kinematics of the muons, because of energy loss uctuations and multiple scattering. This a ects in particular the angular resolution, which is

10 m rad for typicalm uons from decays.

The layout of the vertex region is shown schematically in Fig. 2. Downstream of the target and before the hadron absorber, a silicon tracking telescope [32] em bedded inside a 2.5 T m agnetic dipole eld m easures the charged tracks produced in the interaction. The muons in the vertex region are then identied by matching them to the tracks reconstructed in the muon spectrom eter. As described in the next section, this signi cantly improves the performance of the detector. The telescope used during the indium run consisted of 16 independent detector planes, providing 11 tracking points, arranged along the beam axis over a length of 26 cm, starting at 7 cm from the target centre. The telescope covers the angular acceptance of the muon spectrom eter, with the rst planes smaller than the last ones. Each plane consists of several single-chip pixel detector assemblies, 96 in total, which are mounted on a planar ceram ic support. The assemblies are made of radiation tolerant, 750 m thick ALICE1LHCb pixel readout chips [33], bum p-bonded to 300 m thick p-on-n

silicon pixel sensors, with 425 50 m² pixels. Each of the single chip assemblies is a matrix of 32 columns and 256 rows. They have been shown to remain fully functional up to a radiation dose of 12 M rad [34]. The detector coped wellwith the radiation level of 1 M rad per week, reached in the cells around the beam axis of the rst planes in the NA60 environment [35]. The telescope tracks all charged particles produced in the collision, thus providing an estimate of the collision centrality.

Incom ing ions are tracked by a silicon m icrostrip beam tracker, composed of two stations placed 20 cm apart (30 cm and 10 cm upstream of the target). The 400 m thick sensors have 24 strips of 50 m pitch, allowing to infer the transverse coordinates of the interaction point, at the target, with a resolution of 20 m [36]. They are operated at cryogenic temperatures (130 K), to remain sensitive to the beam ions even after collecting considerable radiation doses [37]. The \back planes" of the four sensors extend over a larger area and constitute a very good beam intensity counter.

Embedded inside the hadron absorber, a Zero Degree C alorim eter (ZDC) provides an alternative estimate of the collision centrality by measuring the energy carried by the projectile nucleons which have not taken part in the interaction (spectators) [38,39]. The ZDC and the beam tracker were used to measure the beam intensity in the absolute yield measurement ($\sec 4.4$).

3 Data sam ple and analysis procedure

D uring the 5-week-long run in 2003,230 m illion m uon pair (dim uon) triggers were recorded, with two di erent settings of the ACM m agnet current (4000 A and 6500 A). The results presented in this paper refer to the 4000 A data sample, which amounts to 50% of the total statistics, as the 6500 A setting suppresses the low m ass acceptance and it is optim al for the study of the J= .

The data were collected with a 158 A GeV indium beam , incident on 7 indium targets of 17% total inter-

action probability. The targets were placed in vacuum in order not to pollute the data sam ple with In-air interactions. The z coordinate of the interaction vertex is shown in Fig. 3. The resolution on the position of the interaction vertex is 10 20 m in the transverse coordinates and 200 m in the longitudinal coordinate. The target iden-

ti cation is extremely good, with negligible background between dierent targets. O ther elements present along the beam line are also clearly visible in the picture, like the target box windows and the beam tracker stations.

In the following subsections we illustrate brie y the most relevant aspects of the reconstruction and selection of events, background subraction and acceptance correction.

3.1 Event reconstruction and selection

As a rst step, the muon tracks are reconstructed in the m uon spectrom eter. About half of the triggers are discarded either because it was not possible to reconstruct twom uons or because at least one of the muons traversed the 4-m -long iron poles of the ACM. These tracks su er from a very strong multiple scattering, which would severly degrade the momentum resolution. The muon tracks reconstructed in the muon spectrom eter are then extrapolated back to the target region and m atched to the tracks reconstructed in the vertex spectrom eter. This is done comparing both their angles and momenta, requiring a m atching 2 less than 3.0 nce identied, the muons are re tted using the pint information of the muon and the vertex spectrom eters. These tracks will be referred to as m atched m uons. M uon pairs of opposite charge are then selected. The matching technique drastically in proves the signal-to-backround ratio and the dim uon m ass resolution, which decreases from 80 M eV (using only the inform ation from the muon spectrom eter) to 20 M eV at the peak, independent of centrality [40].

Events with m ore than one interaction vertex or with a (reconstructed) charged track multiplicity smaller than 4 are discarded [40]. The matched dimuon mass spectrum is shown in the left panel of Fig. 4. The same picture shows also the two background sources: combinatorial and fake matches. These are discussed in detail in the next subsection. As it can be seen, the dominant background is the combinatorial background { the fake match background is alm ost one order of magnitude smaller. The ! and peaks are very well resolved and the peak is also visible. The right panel of Fig. 4 shows an expanded view of the ! and

region after the subtraction of backgrounds. The sam ple consists of 70 000 events. The signal/background ratio, integrated over centrality, is 1=3 below the peak, ranging from about 3 in peripheral events to about 1/5 in central ones.

To study production, events in a sm allm ass window centred at the polem ass ($0.98 < M < 1.06 \, \text{GeV}$) are selected from the mass distribution after the combinatorial background subtraction. The continuum below the is accounted subtracting the events in two side mass win-

dows (0:88 < M $\,<\,$ 0.92 GeV and 1:12 < M $\,<\,$ 1:16 GeV), shown in the right panel of Fig. 4.

No specic cuts in transverse momentum, rapidity or Collins-Soperangle are applied. As already mentioned, the detector introduces an intrinsic rapidity cut 3 . y . 4:2 at the mass.

3.2 Background subtraction

The dimuon sample is a ected by two sources of background: the combinatorial background and the fake matches. The form er is the contribution of uncorrelated muon pairs, mostly coming from the decay of pions and kaons, and is subtracted with an event mixing technique [40,41]. The NA 60 apparatus triggers also on like sign pairs (

and $^+$), which, at SPS energies, contain only uncorrelated muons. Twomuons from di erent like-sign events are random ly paired to build a dimuon sam ple which is uncorrelated by construction. The comparison of the real and mixed spectra for the like-sign pairs leads to an estimate of the accuracy of the background subtraction of 1% over the full dimuon mass spectrum. The like sign sam ple is also used to determ ine the absolute normalization of the com binatorial background [40,41]. The com binatorial background is shown as a dashed line in the left panel of Fig. 4.

The background from fake track matches comes from the fact that, when the multiplicity is high, a muon track can be associated to more than one track in the vertex telescope with an acceptable matching 2 , and the track with the lowest 2 may not be the correct match. It can also happen that the correct track in the vertex telescope in absent altogether. The contribution of the fake m atches can be estimated in two di erent ways. The rst approach is an overlay M onte C arlo technique, w here a M onte C arlo dim uon is reconstructed on top of a real event. Selecting the match with the smallest matching 2 it is possible to determ ine the fraction of fake m atches as a function of mass, transverse momentum, etc. The left panel of g. 5 shows the matching 2 for the correctly matched tracks and for the fake matches, as obtained with an overlay M onte Carlo simulation. The stricter them atching 2 cut, the higher the signal to background ratio will be. How ever, a tight cut reduces signi cantly the statistics. The second m ethod is based on the event m ixing technique, which extracts the probability distributions of fake m atches from real data alone. The basic idea is to match the tracks in the muon spectrom eter from one event to the vertex tracks of a di erent event [40,41]. All the matches obtained in this way are fake by construction. The twom ethods agree within 5%.

The right panel of Fig. 5 shows the M onte C arb dim uon invariant m ass for events when one or both m uons are not correctly m atched, for signal events and for all reconstructed pairs. This gives an idea how incorrect m atching degrades the kinem atics, resulting in a broadened peak with 100 M eV. N otice how ever, that this is not the total fake m atches background under the peak, because also other processes can contribute - continuum from open charm or tails from the ! region. The total fakem atches distribution is shown in detail as a dashed line in the right panel of Fig. 4. This shows that the fake m atches, in the speci c case of the m eson, can also be directly elim i-

nated by the subtraction of the side w indow s, w ithout the need to estim ate them with the m ethods outlined above.

In the following, the analysis is repeated subtracting the fakes both with the event mixing technique and with the side window s.

3.3 Centrality selection

All results are studied as a function of the collision centrality. Events are divided into ve centrality bins by using the charged tracks multiplicity as summarised in Table 1. The reconstructed minimum bias multiplicity distribution depends on the target because of acceptance, reconstruction e ciency and secondary particles contam ination. The distributions in the seven targets are rescaled so that they overlap to that in the rst target. The latter is then tted with the multiplicity distribution obtained with a G lauber M onte Carlo simulation, assuming that the number of reconstructed tracks is proportional to the num ber of participants, with a sm earing due to the resolution and ine ciencies of the detector. It is assumed that the e ects due to acceptance, reconstruction e ciency and secondaries are embedded in the proportionality constant and sm earing factor. The distributions and mean values of the num ber of participants N $_{\rm part}$ and of the num ber of binary collisions N coll, are obtained applying the sam e multiplicity cuts used in the real data to the simulated data. A lternatively, the real data can be corrected for acceptance, reconstruction e ciency and secondaries using a M onte Carlo simulation [42,43]. The number of measured tracks can be thus converted to the number of primary particles event by event, as a function of target and centrality. The distribution of primaries is then matched to

the distribution of N $_{\rm part}$ obtained by a G lauber Simulation.W e nd N $_{\rm part}$ ' dN $_{\rm ch}=d$ j.7 [44,40].

The di erence on the m ean N $_{\rm part}$ and N $_{\rm coll}$ values for each bin obtained with the 2 m ethods is taken as an estim ate of the system atic uncertainty and is found to be about 10% for the peripheral bins and 5% for the central bins.

3.4 Acceptance and reconstruction e ciency correction

A fter subtraction of the combinatorial background, the physical continuum and the fake tracks, the data are corrected for acceptance and reconstruction e ciency. These are estimated with an overlay M onte C arb simulation, using the real hit occupancy in the detector superim posed to M onte C arb m uon pairs. The same cuts used for the real data were applied to the simulated data. An overall 95% e ciency was assumed for the pixel detector. The in-

put sources' kinem atics are generated using the G enesis event generator [45], tracked through the apparatus using G EANT 3.21 and reconstructed using the NA 60 analysis fram ework.

The study of the di erential spectra would require a multidim ensional acceptance correction in rapidity, transverse momentum and Collins-Soper angle. Since the low populated bins in the phase space corners can introduce large errors, a ducial cut should be applied, at the cost of reducing the e ective statistics. To avoid this loss, a one dimensional correction is applied to each kinematic variable under study, integrating over the rem aining ones. This requires a careful tuning of the M onte Carlo input kinem atics which was adjusted with an iterative procedure to the measured distributions for each of the ve centrality bins. To validate this procedure, the full analysis chain (event selection, reconstruction, acceptance correction, tting) is applied to M onte Carlo events. It is veri ed that the corrected kinematic distributions and the estimated param eters are consistent with those used as input in the M onte Carlo.

The acceptance times reconstruction e ciency for the as a function of p_T is shown in Fig. 6. The apparatus has a good acceptance down to zero p_T , due to the additional dipole eld in the vertex region. Indeed, low mass and low p_T dimuons, which would not be accepted by the muon spectrom eter, are bent into the acceptance by the vertex dipole magnet, as opposed to NA 50, which used the same muon spectrom eter, but had no acceptance for p_T . 1:1 GeV. Further details on the rapidity and angular distribution acceptance will be given in the speci c subsections on the results.

3.5 Systematic e ects

Them ain sources of system atic error are the uncertainties on the input parameters of the M onte C arlo simulation (which reject on an uncertainty in the acceptance) and on the estimate of the physical background below the . The former is estimated by changing the values of the parameters in the input M onte C arlo within 1 of the measured value. The latter, by varying the side windows o set (from 50 M eV to 70 M eV) and width (from 30 M eV to 50 M eV). The contributions from these two factors are added in quadrature. Uncertainties in the combinatorial background and in the fake matches subtraction play a small role here, as the peak is very well resolved.

Several consistency checks were perform ed to test for the presence of hidden system atic e ects [46]: the m atching 2 cut was varied between 2 and 3, the kinem atic cuts 2.9 < y < 3.9 and jcos $c_s j < 0.5$ were applied, the analysis was repeated independently in the 4 ACM /PT7 elds' com binations, a 2-dim ensional acceptance correction (vs. y and p_T) was used and the di erentm ethods for fake subtraction were im plemented. Most of those checks did not lead to signi cantly di erent results, with the exception 2 of the matching cut variation. This leads to a small but not negligible di erence which is added in quadrature to the system atic error. This di erence is most likely due to the uncertainty in the energy loss compensation or to a sm all residual m isalignm ent in the pixel telescope planes. The results on the yield, mass and width are affected by further sources of system atics, due to the param eters needed for their com putation. Details are given in sec. 4.4 and in sec. 4.6. The num ber of participants estim ated with the G lauber m odel is a ected by a 10% un-

certainty in the peripheral bins, which decreases to 5% in the most central, as explained in sec. 3.3.

4 Results

4.1 Rapidity

The rapidity acceptance for $0 < p_T < 0.5, 0.5 < p_T < 1$ and $p_T > 1 \text{ GeV}$ is shown in Fig. 7. The apparatus has acceptance in the interval 3-4.2 depending on the target. There is a small correlation $y p_T$ such that low y tends to select larger p_T . The rapidity is studied as a function of centrality and the width estimated with a gaussian t in the range 3:2 < y < 4:1. The midrapidity value is xed to 2.91. The width as a function of centrality is shown in Fig. 8 (left panel) and within the errors one can deduce either a constant or a slightly decreasing trend. The rapidity distribution integrated in centrality is shown in Fig. 8 (right panel). The resulting width is 1:13 0:06 0:09. This is in agreem ent with previous NA 49 m easurem ents in other collision systems at the same energy [19,20], as shown in Table 2.

4.2 Angular distributions

In general, the angular distribution of the decay m uons in the meson rest frame can be related to the elements of the spin density matrix.

In this paper the inclusive $dN = d \cos distributions$ are studied as a function of transverse momentum and centrality. The polar angle is the angle between the $^+$ and the z axis as measured in the following three widely used reference frames. In the helicity frame, the axis is de ned as the direction of ight of the meson in the targetprojectile rest frame. In the Gottfried-Jackson frame (GJ), the axis is de ned as the projectile direction in the rest frame [47]. Finally, in the Collins-Soper frame (CS) the axis is given by the bisector of the projectile and the negative target direction in the rest frame [48].

In all the three frames, the acceptance as a function of cos has a strong dependence on transverse momentum. In particular, the apparatus has zero acceptance for high joos j and low $p_{\rm T}$. The acceptance vs cos for the $p_{\rm T}$ windows 0 < $p_{\rm T}$ < 0.5, 0.5 < $p_{\rm T}$ < 1 and $p_{\rm T}$ > 1 GeV, is shown in Fig. 9 for the CS and GJ frames. The most

critical situation occurs for the Collins-Soper angle, while 4.3 Transverse m om entum the helicity fram e is sim ilar to the GJ fram e.

The dN = d cos distribution is tted with the function 1+ cos; where the parameter is related to the degree of polarization. The spectra, integrated in centrality and p_T, are shown in the left panel of F ig. 10. The polarizations obtained from the ts are zero within errors in all cases: $_{\rm H \, E \, L} = 0.07 \quad 0.06 \quad 0.06, \, _{\rm G \, J} = 0.07 \quad 0.06 \quad 0.06,$ $_{CS} = 0:13 \quad 0:07 \quad 0:06.$

The polarization is then studied di erentially in the three p_T windows $0 < p_T < 0.5, 0.5 < p_T < 1$ and $p_T > 1$ GeV, without centrality selection. No signi cant deviations from the p_T integrated values are found.

The results as a function of centrality and integrated in p_T are shown in the right panels of Fig. 10. The polarization is compatible with zero in the helicity and Gottfried-Jackson frames, independent of centrality. In the Collins-Soper fram e there is a hint for a negative polarization in the most peripheral bin. However, this is within 2 com patible with zero and then consistent with the absence of any e ect as seen in the other fram es.

These results as a function of p_T and centrality are consistent with the results integrated in centrality with $p_T >$ 0:6 GeV reported in a previous analysis by NA60 [29]. They show the absence of polarization, supporting the fact that particles are produced from a therm alized medium. The absence of polarization extends down to peripheral events, suggesting that it could be zero also in elementary collisions at this energy.

The acceptance-and-e ciency corrected transverse mass distributions are shown in the left panel of Fig. 11 for the di erent collision centralities, norm alized in absolute term s.

The transverse momenta are rst tted in the range $0 < p_T < 3 \text{ GeV}$ with the therm alansatz:

The e ective tem perature T_{eff} as a function of the num ber of participants is depicted in the right panel Fig. 11. In general one can notice that the T_{eff} shows an initial rise followed by a saturation in the most central bins.

The exponential form assumes therm alem ission from a static source. In heavy ion collisions, this is not correct due to the presence of radial ow, but eq. (1) was neverthe less used by several experiments to the data. Since the m T distributions are not purely exponential, The T_{eff} extracted from an exponential twilldepend in general on the tted p_{T} range. It can be shown that, at $\ensuremath{\mathsf{rst}}\xspace$ order, the T_{eff} value at low p_T is given by T_{eff} $T_0 + m_{T}^2$, where T₀ is the tem perature at freeze-out, m is the particle m ass and T is the average transverse velocity of the expanding source [49]. At high p_T , on the other hand, the T_{eff} extracted from the exponential t is approximated $T_0 (1 + T) = (1$ by T $_{\rm T}$) [49]. Thus, what is measured is a p_T dependent e ective tem perature, larger than the freeze-out tem perature because of the radial ow .

The in uence of radial ow is investigated by repeating the ts in two sub-ranges 0 < $p_{\rm T}$ < 1.6 GeV (low

 p_T) and 1:1 < p_T < 3 G eV (high p_T), which also correspond to the experimental windows covered by the NA 49 and NA 50 experiments, respectively. Since the statistics in the peripheral data at high p_T is limited, the twom ost peripheral bins are integrated for the t in the high p_T range. The numerical values of T_{eff} as a function of centrality and of the dierent transfers are summarised in Tab. 3. An increase of the average T_{eff} can be noticed when the t is restricted to the low p_T range, while a atter trend is observed from the t in the high p_T range. The dierence between the elective temperatures obtained in the two transfers is around 10 M eV (average over the three m ost central bins). This pattern indicates the presence of radial ow but it is rather small, as expected from the small coupling of the to the \pion wind"[50,51].

Further quantitative insight has been gained studying the spectra in the fram ework of the blast wavem odel [52]:

Transversem om entum distributions are then generated using eq. (2), with $_{\rm T}$ values tuned in order to reproduce the observed T_{eff} values. Fig. 12 shows the results for the and also for the negative charged hadrons (essentially pions), ,! and 51]. The study is perform ed for $p_T > 0.4$ GeV in order to exclude the rise in the low $p_{\rm T}$ region seen in the excess spectra [53]. The freeze-out component of the receives the strongest radial ow boost, with a $T_{eff} > 300 \text{ MeV}$, 50 M eV above the [51,53].

4.4 Yield

The average number of m esons per interaction h i is evaluated using the J= as a reference process. Once corrected for anom alous and nuclear absorption, hJ= i scales

anom alous absorption factors. The same centrality bins, selected using charged particle multiplicity as described in sec. 3.3, were used for both the and the J = . Invoking lepton universality, the value 2.97 $\,$ 10 4 m easured in the ! ee is used for the branching ratio, since it is known with better precision [55]. The nuclear absorption was accurately determ ined by severalm easurem ents in pA collisions at 400 and 450 G eV [54]. The anom alous absorption was determined from the J= analysis of the sam e In-In data sam ple [56]. The overall correction factor com es from the product of the nuclear and anom alous absorption. One has to notice that recent prelim inary p-A results from NA60 showed the nuclear absorption at 158 G eV is larger than previously assumed [57]. However, since the anom alous absorption is de ned relative to the nuclear one, the overall correction $f_{J=}^{Abs}$ rem ains largely insensitive to relative changes of these two factors. The system atic uncertainty arising from the anom alous and nuclear absorption is 11% [56]. This is the dom inating source of system atic uncertainty in the analysis of the yield.

By multiplying the ratio in eq. (4) by eq.(3), one obtains h i as a function of the number of binary collisions N_{coll}. The values of N_{coll} and of N_{part} for each centrality bin are obtained by tting the multiplicity distribution with a G lauber model, as described in sec. 3.3 and sum - m arised in Tab.1.

Processes having di erent scaling properties as a function of centrality, such as the and the J=, in general give rise to di erent multiplicity distributions and this could introduce a bias when using wide centrality bins. The analysis was repeated with a much ner centrality binning and this potential bias was found to be negligible.

The robustness of the m easurem ent is checked repeating the analysis integrated in centrality, with a di erent m ethod having largely independent system atics. The cross section is determ ined with the form ula:

where L is the integrated lum inosity, $_{ev}$ is the event selection e ciency, $_{trig}$ is the trigger e ciency, $_{DAQ}$ is the e ciency related to the DAQ live-time. The integrated lum inosity is given by L = N $_{inc}N_{tgt}$, where N $_{inc}$ is the num – ber of incident ions as measured by the ZDC and Beam Tracker detectors, while N $_{tgt}$ is the e ective num ber of indium atom s in the target system [58]. The latter is a ected by a system atic uncertainty of 10%, because the transverse pro le of the beam is wider than the targets (except for the rst one which had a radius of 0.6 cm). The trigger

e ciency was determ ined with special runs taken without the dim uon trigger. It is 81% and is a ected by a 6% system atic error.

The average yield is then obtained dividing the cross section by the fraction of total In-In inelastic cross section, corresponding to the cut N_{ch} > 4, as estimated with the G lauber M onte Carlo (see sec. 3.3). The total inelastic cross section calculated with the G lauber m odel is $\frac{\ln \ln}{\ln el}$ = 4.8 b, and has a 10% uncertainty, mostly due to the uncertainties on the nuclear density pro les. The centrality integrated cross section is = 6.83 0.08 b. This leads to h i = 1.73 0.02 0.27, in agreem ent with the result based on the standard m ethod, taking into account only the unrelated system atic errors in the two approaches.

The results as a function of centrality, obtained by taking the average of the two methods weighted by the system atic error, are summarised in Tab. 4. The ratio h $i=N_{part}$ is seen to increase with the collision centrality indicating the presence of an enhancement as in other collision system s.

4.5 D iscussion of the results on T_{eff} and yield

A sm entioned in the introduction, the discrepancies in absolute yields and T_{eff} values observed by NA 49 and NA 50 became historically known as the puzzle [14,22]. To explain those di erences, it was originally proposed that inmediume ects and kaon absorption or rescattering could

prevent the reconstruction of in-matter $\,$! KK decays, in particular at low transverse momentum, while the mesons decaying in the lepton channel would not be affected. This would lead to reduced yields and enhanced $T_{\rm eff}$ values in the KK channel as compared to the channel. In this section, all the measurements performed at the SPS, including the new one in In-In, are compared and the hypothesis of the physical mechanism described above is critically reviewed, considering the facts in favour of and against it.

Fig. 13 shows the NA 60 $T_{\rm eff}$ obtained performing the ts in the $p_{\rm T}$ windows corresponding to the coverage of NA 49 (left) and NA 50 (right). As mentioned in sec. 4.3, the di erence of the tem perature in the two $p_{\rm T}$ windows in In-In is around 10 M eV, indicating a modest radial ow e ect. A lthough a similar pattern is observed in Pb-Pb collisions { a stronger increase at low $p_{\rm T}$ (NA 49) and a attening at high $p_{\rm T}$ (NA 50) { the maximum di erence is, for the most central Pb-Pb collisions, about 70 M eV. This di erence seems not to be consistent with the $T_{\rm eff}$ variation in plied by radial ow as observed in the NA 60 data.

In the common trange, the NA 60 T_{eff} values in In-In are 10 MeV larger than those measured by NA 50, while

there is a seem ing agreem ent between NA 60 and NA 49 in the common trange. How ever, the NA 49 errors are large in this region and, in addition, a direct comparison of the values of T_{eff} between NA 60 and the Pb-Pb experiments for the same N_{part} is not straightforward, due to the different geometry of the collision (the relative weight of the thin nuclear halo is higher in peripheral Pb-Pb collision than in a sm aller system).

The temperature variation in di erent collision system s, when restricting to central collisions only, is shown in Fig. 14. This picture includes also the NA 49 results for C-C, Si-Si and the CERES result in the kaon channel for central Pb-Pb (the dielectron m easurem ent has a very large error). The NA 49 and CERES Pb-Pb points are above the In-In point by & 30 M eV. Part of this di erence can be related to radial ow, since in Pb-Pb a larger lifetime of the reball would lead to a larger e ect in central collisions. How ever, the T_{eff} m easured for central Pb-Pb collisions is 290 M eV, very close to that of the proton [59]. The blast-wave analysis of the NA60 data, on the other hand, shows a clear hierarchy in the freeze-out, with the having a maximal ow due to its coupling to pions and the being the least coupled m eson (Fig. 12). The tem perature of the freeze-out component of the in In-In reaches 300 M eV or m ore, 50 M eV above the .0 ne would therefore expect an even larger di erence in Pb-Pb collisions between the $T_{\tt eff}\,$ of the $\,$ and of the proton, which is strongly coupled to the pions via the resonance and with a mass larger than the . This suggests that the high T_{eff} seen by NA 49 and CERES in the kaon channel cannot be ascribed entirely to radial ow .

The enhancement in In-In is compared to previous SPS measurements [18,19,21,25] in Fig. 15.

A n unam biguous com parison to the NA 50 result in full phase space is not possible, due to lack of consensus on the value of the $T_{\rm eff}$ param eter in Pb-Pb collisions, but in general the NA 50 enhancement is considerably higher than what is seen in In-In at any centrality. An extrapolation to full $p_{\rm T}$ with the NA 50 $T_{\rm eff}$ values (T220~230 M eV independent of centrality) leads to values higher by a factor 2 or m ore with respect to In-In. Even extrapolating with the NA 49 $T_{\rm eff}$ values (T250~300 M eV) would lead to values signi cantly higher (as shown by the continuous line in Fig. 15, the dashed lines represent the propagated uncertainty on these values).

The NA49 m easurem ents¹ show that the h i breaks N_{part} scaling and that h i=N_{part}, for central collisions as a function of the colliding system, already saturates for Si-Si. The enhancem ent in In-In is closer to NA49 than NA50, but it is not in agreem ent either. The two In-In m ost peripheral points are in agreem ent with C-C and Si-Si. How ever, for increasing centrality there is no saturation in In-In, while the NA49 Pb-Pb points show a atter trend, which rem ains consistently sm aller at any centrality. O ne could ask whether the increase of the yield ratio NA 60/NA 49 as a function of centrality could be ascribed to a suppression mechanism present in Pb-Pb that tends to decrease the overallenhancement. Restricting the comparison among In-In and Pb-Pb central collisions, the dim uon NA 60 measurement remains larger than the kaon Pb-Pb points.

Sum m arizing, the large NA 49/NA 50 di erence in central collisions for T_{eff} (70 M eV) and the yield (a factor 4), was hardly accounted for by theoretical models. A di erence, though smaller, is also present in central collisions in T_{eff} and yield, when considering the NA 60 m uon m easurem ent. This di erence remains di cult to explain and hints for the presence of a physical e ect. W hether this is present also in In-In, or peculiar only to Pb-Pb, would require the com parison to ! KK in In-In.Prelim inary NA 60 results of $! K^+K$ suggest that there are no di erences within the errors among the two channels in In-In [60].

O ne has to notice that the CERES dielectron and kaon points for centralPb-Pb are in agreem ent and in addition, both the NA50 $T_{\rm eff}$ and yield do not agree with NA60 either. Thus, at the moment it is not possible to include into a coherent picture all the measurem ents perform ed so far in the di erent collision system s.

4.6 M ass and width

As mentioned in the introduction, the spectral function could be modied in the medium, resulting in of the changes of its mass and width. The lifetime of the is 44 fm, larger than the estimated reball lifetime (7 fm). Any medium modied component would therefore sit under a large unm odi ed peak produced after freeze-out. In order to distinguish a possible in medium component from instrum entale ects, a careful tuning of the M onte Carlo simulation is required. This was not strictly necessary in previous analysis of the low mass region excess [51,61], as this structure, mostly due to ! ! , represents a large fraction of the total yield (the lifetime of the is 1:3 fm).

Uncertainties in the detectors alignment, materials, energy loss compensation and precision of the magnetic eld maps lead to residual di erences between the Monte Carlo and the real data. These were compensated by ne-tuning the Monte Carlo against the peripheral data, where no inmedium e ects are expected. The tuning was performed considering the whole mass spectrum below 1 GeV and required a global 0.3% 0:1% mass shift and a 4% 1% change in the mass resolution (previous NA 60 analyses only included the mass shift correction). The uncertainties in this tuning are the main source of system atic error for the results discussed in this section.

In order to look for an in-m edium component around the peak, the excess was isolated using the same subtraction procedure already extensively used for the low m ass region [61]. The !, and D alitz were subtracted from the total data using the M onte C arlo shapes and xing the yield using solely local criteria; the ! D alitz and

the two body were then subtracted by binding them to these processes via branching ratios. The quality of the subtraction can be judged in Fig. 16 which show s, for data integrated over centrality, the excess before and after the ne tuning.W hile the tuning is essentially constrained by the narrow peak, it improves the subtraction over the whole mass spectrum : the evident artifacts visible in the left panel around all the narrow resonances (, ! and) disappear after the tuning. The continuum left after the subtraction under the peak is smooth: no evidence for can be seen in this gure. Indeed, a medium modied an in-m edium broadened com ponent would manifest itself as broader tails extending to the sides. In this case, the subtraction of the vacuum component should not leave a sm ooth continuum, but rather a broad structure or a dip, which is not observed.

Asmentioned in the introduction, the KEK-PS E325 experim ent reported evidence for a large excess to the left of peak in p-Cu at 12 G eV for < 1:25, corresponding to a produced moving very slow ly inside the heavy target nucleus at rest. This situation is not directly com parable to the high energy regimed iscussed in this paper. Here, a reball is produced with particle m om enta boosted in the forward direction, therefore the relevant variable to select mesons mostly sensing the medium is transverse momentum. Moreover, in a high energy heavy ion collision, as opposed to p-A, the can be produced not only at chem ical freeze-out, but also in the hot hadronic m edium via kaon reactions. Fig. 17 shows the region around the m ass peak for di erent p_T and centrality selections: the left panel shows the twom ost central bins and for $p_T < 0.6$ GeV, while the right panel shows the data integrated in centrality for $p_T < 0.2 \text{ GeV}$. The continuum from the subtraction is smooth also in this case. Furtherm ore, a t was perform ed using the M onte C arb shapes for the different processes. The continuum was described with the m odel of R ef.[11], which includes, besides the in-m edium , m ulti-pion and partonic processes relevant in this m ass

region. Them odel of R ef. [62], having di erent weights for the multi-pion and partonic processes, does not change the conclusions, since it produces a similar yield below the peak. The ²=ndf is 1 in all cases. There is no evidence of any mass shift or broadening, even at high centrality and low p_T , where one would expect to observe the strongest in-medium e ects.

In order to estim ate quantitatively the pole mass and total width of the peak, data were tted with the convolution of a relativistic Breit-W igner and of a function param etrizing the detector response, on top of a linear background. In a rst step, the parameters of the detector response were adjusted on the Monte Carlo simulation. The data are then tted leaving the mass and width of the Breit-W igner as free param eters. The quality of the t is very good, as shown in the left panel of Fig. 18, corresponding to the sem i-central bin, $N_{part} = 133$. The results the mass and width as a function of centrality are shown in the right panel of Fig. 18. The system atic error was estimated changing the trange, the background function and propagating the uncertainties in the M onte Carlo tuning. The mass and width are compatible with the PDG values and independent of centrality, although our sensitivity on the width is limited by the mass resolution, which is much larger than the natural width (this is re ected in the large statistical error in the right panel of Fig.18).

W hile the data can be described by a vacuum , we set an upper limit on a modied component using the only existing prediction for in-medium production of in 158 AGeV In-In collisions [11]. This corresponds to an in-medium spectral function folded over the phasespace reball evolution up to freeze-out and appears signi cantly broadened (> 80 M eV), so that the data should have su cient sensitivity - in terms of mass resolution - to discrim inate it. The region around the peak was tted adding an in-medium component to the unm odi ed one. In the centrality integrated data, the fraction in-medium /vacuum is compatible with zero within one sigm a with an upper limit of 0:08 0:03 (syst) at 95% con dence level. In the two most central bins the fraction remains compatible with zero within one sigma and the upper lim it increases to 0:15 0:03 (syst), due the larger statistical uncertainty. The fraction predicted by Ref. [11] for sem i-central data (roughly equivalent to centrality integrated data) is 4%. The limitation in statistics prevents us from setting a meaningful upper lim it at high centrality and low p_{T} .

5 Conclusions and outbok

In this paper a complete characterization of ! production in In-In collisions has been provided by m easuring the di erential spectra, yield, m ass and w idth.

The rapidity distribution width does not depend on centrality within errors, and is found to be compatible with previous SPS m easurements. The decay angle distributions show no evidence for polarization in any of the reference fram es used, independent of centrality and $p_{\rm T}$. This con m s the lack of anisotropy previously reported by NA 60. This is a necessary though not su cient condition for particle production from a thermalized m edium . Indeed, the centrality dependence suggest that the polarization is zero or very close to zero also in peripheral collisions, close to the lim it of p-p like interactions.

The study of the transverse m om entum distributions shows a small dependence of the $T_{\rm eff}$ parameter on the $p_{\rm T}$ window considered, to be ascribed presumably to radial ow .A blast wave analysis shows a clear hierarchy of the freeze-out, with the being the least coupled particle to the medium .The di erence between $T_{\rm eff}$ measured in Pb-Pb collisions by NA 49 and NA 50 is much larger and cannot be explained by the di erent $p_{\rm T}$ window s explored. The $T_{\rm eff}$ value form ost central collisions in In-In remains signi cantly low er than the kaon point in Pb-Pb measured by NA 49 and CERES.

The yield measured by NA50 at high $p_{\rm T}$, when extrapolated to fill $p_{\rm T}$, exceeds the NA60 data points for the same number of participants and seems to lie outside of the general system atics. The NA60 yield, on the other hand, remains consistently larger than the NA49 and CERES Pb-Pb measurement.

The new measurements in $T_{\rm eff}$ and yield, when compared to the kaon channel in Pb-Pb, suggest that there may be a physical e ect leading to a difference in the two channels. Further clarication may come from the NA60

m easurem ent of the $! K^+K$ channel in In-In collisions, which is currently in progress and will be reported in a forthcom ing paper. At the m om ent, it is not possible to include all the existing SPS m easurem ents in a coherent fram ew ork.

The mass and width were studied as a function of centrality and transverse momentum .No evidence for inmedium modi cations was found.Our data were also com pared to the only existing prediction for in-medium , produced in In-In collisions at 158 AG eV. The yield of such a component is compatible with zero, with an upper limit of about 8% for the centrality integrated data.
