A bstract. W e have searched for 14.4 keV solar axions or m ore generalaxion-like particles (ALPs), that m ay be em itted in the M 1 nuclear transition of 57 Fe, by using the axion-to-photon conversion in the C ER N A xion Solar Telescope (C A ST) w ith evacuated m agnet bores (Phase I). From the absence of excess of the m onoenergetic X -raysw hen them agnetwas pointing to the Sun, we setm odel-independent constraints on the coupling constants of pseudoscalar particles that couple to two photons and to anucleon g_a j $1:19\,g_{aN}^0 + g_{aN}^3$ j< 1:36 10 16 G eV 1 form $_a$ < 0:03 eV at the 95% condence level.

1. Introduction

 Q uantum chrom odynam ics (QCD) , one of them ost profound theories in m odern physics and now adays universally believed to be the theory of strong interactions, has one serious blem ish: the \strong CP problem ". It arises from the fact that the QCD Lagrangian has a non-perturbative term (the so-called \ -term ") which explicitly violates CP invariance in strong interactions. A very credible, and perhaps the m ost elegant solution to the strong CP problem was proposed by Peccei and Q uinn in 1977 $[1,2]$. It is based on the hypothesis that the Standard M odelhas an additionalglobalU (1) chiralsym m etry, now known as PQ (Peccei-Q uinn) symm etry U $(1)_{PQ}$, which is spontaneously broken at som e large energy scale f_a . An inevitable consequence of the Peccei-Q uinn solution is the existence of a new neutral pseudoscalar particle, nam ed the axion, which is the N am bu-G oldstone boson of the broken U $(1)_P$ g symm etry $[3,4]$. Due to the U $(1)_P$ g symm etry not being exact at the quantum level, as a result of a chiral anom aly, the axion is not m assless and is, m ore precisely, a pseudo N am bu-G oldstone boson.

The phenom enological properties of the axion are m ainly determ ined by the scale f_a and closely related to those of the neutral pion. The axion m ass is given by the relation

where $z = 0.56$ is assumed for the m ass ratio of the up and down quarks, while f ' 92 M eV and $m = 135$ M eV are the pion decay constant and m ass respectively. Furtherm ore, the e ective axion couplings to ordinary particles (photons, nucleons, and electrons) are inversely proportional to f_a as well, but they also include signi cant uncertainties originating from som e m odel-dependent num erical param eters. It was originally thought that the energy scale of the U $(1)_{PQ}$ sym m etry breaking is equal to the electroweak scale, i.e. $f_a = f_{ew}$, with f_{ew} ' 250 G eV. The existence of the axion corresponding to such a scale, known as the \standard" axion, was soon excluded by a num ber of experim ents. D espite the failure of the standard axion m odel, it was possible to retain the Peccei-Q uinn idea by introducing new axion m odels which decouple the U $(1)_{PQ}$ scale from the electroweak scale, assum ing that f_a has an arbitrary value m uch greater than 250 G eV, extending up to the P lanck scale of 10^{19} G eV. Since the axion m ass and its coupling constants with m atter and radiation all scale as $1=f_a$, the axion in the m odels with f_a f_{ew} is very light, very weakly coupled, and very long-lived, which m akes it extrem ely hard to detect directly. This is why such m odels are generically referred to as \invisible" axion m odels and they are still viable. Two classes of invisible axion m odels are often discussed in the literature: K SV Z (K im, Shifm an, Vainshtein, and Zakharov) or hadronic axions [5,6] and D FSZ (D ine, F ischler, Srednicki, and Zhitnitski) or G U T axions $[7,8]$. The m ain dierence between the K SV Z and D FSZ-type axions is that the form erdo not couple to ordinary quarks and leptons at the tree level. H owever, due to the axion's interaction with photons, there is a radiatively induced coupling to electrons present for this type of axions, which is a process of higher order and hence

extrem ely weak. A s far as the interaction with photons is concerned, once the scale f_a is xed, the axion-photon coupling constant g_a for D FSZ axions is also xed, while hadronic axion m odels suggest dierent values for g_a . Consequently, this coupling can be either suppressed or enhanced.

D epending upon the assumed value for f_a , the existence of axions could have interesting consequences in astrophysics and cosm ology. The em ission of axions produced in the stellar plasm a via processes based on their couplings to photons, electrons, and nucleons would provide a novelenergy-loss m echanism for stars. This could accelerate the evolutionary process of stars, and thereby shorten their lifetim es. A xions m ay also exist as prim ordialcosm ic relics copiously produced in the very early U niverse, which m akes them interesting candidates for the non-baryonic dark m atter.

So far the axion has rem ained elusive after over 30 years of intensive research, and none of the direct laboratory searches has been able to yield a positive signature for the axion. H owever, data from num erous laboratory experim ents and astrophysical observations, together with the cosm ological requirem ent that the contribution to the m ass density of the U niverse by relic axions does not overclose the U niverse, restrict the allowed values of axion m ass to a rather narrow range of 10 5 eV \lt m $_3$ \lt 10 2 eV , but with uncertainties on either side. Thus the question of whether axions really do exist or the Peccei-Q uinn m echanism is not realized in N ature still rem ains open, and the exhaustive search for axions continues. D etailed and updated reviews ofthe axion theory and experim ents can be found in [9{11].

It is expected that pseudoscalar particles like axions should be copiously produced in stars by nuclear reactions and therm alprocesses in the stellar interior. A powerful source of axions would be the Sun in particular. As the closest and the best known astrophysical object, it is the source of choice for axion searches. A xions or similar axion-like particles (A LPs) that couple to two photons could be produced in the core of the Sun via Prim ako conversion of therm alphotons in the electric and m agnetic elds of the solar plasm a. Such axions would have a continuous energy spectrum peaked near the m ean energy of 4.2 keV and dying o above 10 keV. M ost of the experim ents that have been designed to search for these axions are based on the coherent axion-to-photon reconversion in a laboratory transverse m agnetic $\,$ eld (the axion helioscope m ethod [11 { 21]), or in the intense Coulom b eld of nuclei in a crystal lattice of the detector (the Bragg scattering technique [22{26]).

D ue to the axion-nucleon coupling, there is an additional com ponent of solar axions. If som enuclei in the Sun are excited either therm ally $(e, q.$ those with low-lying levels like 57 Fe and 83 K r) or as a result of nuclear reactions (e.g. 7 Li nuclei produced by the 7 Be electron capture), axion em ission during their nuclear de-excitations could be possible. Such axions would be m onoenergetic since their energy corresponds to the energy of the particular nuclear transition which produced them . W ith axions being pseudoscalar particles, the allowed values of angularm om entum and parity carried away by them in such nuclear transitions are 0 ; 1^+ ; 2 ; $:::$; which means that axions can be em itted in m agnetic nuclear transitions. Up to now, these m onoenergetic solar axions have m ostly

been searched for by using the resonant axion absorption process in targets m ade of the sam e nuclides in a terrestrial laboratory $[27{33}]$, or via processes based on axionelectron interactions, like C om pton conversion of axion to photon and the axioelectric e ect $[34, 35]$.

In this paper we present the results of our search form onoenergetic 14.4 keV solar hadronic axions by using the CERN A xion Solar Telescope (CA ST) setup. W e assum ed that such particles could be em itted from the Sun by de-excitation of therm ally excited 57 Fe nuclei [36]. This stable isotope of iron (natural abundance 2.2 $\frac{1}{6}$) is expected to be a suitable em itter of solar axions. It is exceptionally abundant am ong heavy elem ents in the Sun (solar abundance by m ass fraction 2.8 10⁵). A lso, its rst excited nuclear state (E = 14.4 keV) is low enough to be relatively easily therm ally excited in the hot interior of the Sun $(kT - 1:3 \text{ keV})$. The excited 5^7 Fe nucleus relaxes to its ground state m ainly through the em ission of the 14.4 keV photon or an internal conversion electron. Since this de-excitation occurs dom inantly via an M 1 transition $(E2/M 1 m \times m$ ratio is 0:002), an axion could also be em itted.

In our attem pt to detect 57 Fe solar axions we relied on the axion helioscope m ethod by using the latest and currently the m ost sensitive solar m agnetic telescope, CA ST, which is located at CER N .W hen its 9.26 m long LH C dipole test m agnet is oriented towards the Sun, solar axions could convert to photons of the same energy via inverse Prim ako process while traversing the 9 T m agnetic eld produced in the two parallel bores inside the m agnet. W e have searched for a 14.4 keV peak in a spectrum recorded by the X-ray detector placed at the far end of the m agnet facing the apertures of the bores. If observed, this peak could be interpreted as the result of the conversion of the ⁵⁷Fe solar axions into photons inside the m agnet bores, and hence as the direct signal for such axions. As a contrast to the previous searches for these axions, which relied solely on the axion-nucleon coupling, our search involved not only the axionnucleon interaction (in the em ission process) but also the axion-photon interaction (in the detection process). This allowed us to explore the relation between axion-photon and axion-nucleon coupling constants for a wide range of axion m asses. A lthough we focus on the axion because of its theoreticalm otivation, our results also apply to similar pseudoscalar particles that couple to two photons and can be em itted in the nuclear m agnetic transition.

2. A xion em ission from 57 Fe nuclei in the Sun

The axion-nucleon coupling arises from two contributions: the tree-level coupling of the axion to up-and down-quarks, and a contribution due to the generic axion-pion m ixing, a phenom enon which is the result of the axion-gluon coupling, and the fact that axion and pion are bosons with the same quantum num bers, so they m ix. This means that even a hadronic axion has a coupling to nucleon, although it does not couple directly to ordinary quarks.

The e ective Lagrangian for the axion-nucleon interaction can be written as

where a is the axion eld, $_N = \frac{p}{n}$ is the nucleon doublet, and 3 is the Pauli m atrix. The isoscalar g_{aN}^0 and isovector g_{aN}^3 axion-nucleon coupling constants are m odel dependent, i.e., they depend on the details of the theory in plen enting the PecceiQ uinn m echanism. For exam ple, in hadronic axion m odels they are related to the scale f_a by expressions [37,38]

H ere, m_N is the nucleon m ass, while the constants $F = 0.462$ and $D = 0.808$ [39] are the antisym m etric and sym m etric reduced m atrix elem ents for the SU (3) octet axial-vector currents. They are determ ined from the hyperon sem ileptonic decays and avor SU (3) symmetry. The avor-singlet axial-vectormatrix element S is still a poorly constrained parameter. It can be estimated from the polarized nucleon structure functions data, but su ers from large uncertainties and am biquity.

We focused our attention on the decay of the 14.4 keV rst excited state of 57 Fe nucleus to the ground state via axion em ission, a process that competes with ordinary M 1 and E2 gamma decay. In general, the axion-to-photon em ission rate ratio for the M 1 nuclear transition calculated in the long-wavelength lim it is [40]

where k_a is the m om entum of the outgoing axion, k represents the photon m om entum, and \prime 1=137 is the ne structure constant. The quantities $_0 = 0.88$ and $_3 = 4.71$ are the isoscalar and isovector nuclear m agnetic m om ents respectively, given in nuclear m agnetons. The param eter denotes the E2/M 1 m ixing ratio for the particular nuclear transition, while and are nuclear structure dependent ratios. Their values for the 14.4 keV de-excitation process of an ⁵⁷Fe nucleus are = 0.002 , = 1:19, and $= 0.8$ [36]. U sing these values in equation (5) we nd

In the above expression we m ade approx in ation $(k_a/k)^3$ ' 1 for the phase space factor ratio. This is based on the assumption that the axion mass is negligible compared to the axion energy which equals, in our case, the transition energy of 14.4 keV. Since the coupling constants g_{aN}^0 and g_{aN}^3 are model dependent, we can consider the parameter $(1.19_{20}^0 + g_{10}^3)$ as a free unknown parameter characterizing not only the $\rm{g}_{\rm{aN}}^{\rm{e}}$ axion-nucleon coupling but also, more generally, the nucleon coupling to any axionlike particles that could be em itted in the M 1 nuclear transition. In term s of the axion

m ass, equation (6) can be expressed by combining equations (1) , (3) and (4) as

where $S = 0:4$ [41] is assumed.

To estimate the ux of monoenergetic solar axions em itted from ⁵⁷Fe nuclear de-excitations, the calculation was performed as in $[36, 42]$. The 57 Fe nucleus can be them ally excited to its rst excited state in the Sun since its excitation energy, $E = 14.4$ keV, is comparable to the Sun's core temperature (kT $1:3$ keV). The probability for this them al excitation is given by the Boltzm ann distribution

where $J_1 = 3=2$ and $J_0 = 1=2$ are total angular m om enta of the rst excited and ground states respectively. In further calculations we can neglect the second term in the denom inator because $e^{E = kT}$ 1. The 14.4 keV axion em ission rate per unit m ass due to the de-excitation of them ally excited 57 Fe nuclei in the Sun is

where N = 3:0 10^7 g¹ is the number of ⁵⁷Fe nuclei per 1 g of solar m atter [43], and $= 1.3$ 10⁶ s is them ean lifetime of the rst excited nuclear state of ⁵⁷ Fe associated with the partial gamma decay width of that state. Owing to Doppler broadening caused by the them alm otion of 57 Fe nuclei in the hot solar interior, the axion em ission spectrum is a G aussian with the standard deviation parameter

where T denotes the tem perature at the location in the Sun where the axion is produced, while m is the m ass of the 57 Fe nucleus. This spectrum is approximately centered at the transition energy $E_1 = E = 14.4$ keV because the axion energy shift, caused by the recoil of the ⁵⁷Fe nucleus in the em ission process (1.9 10^3 eV) and the gravitational redshift due to the Sun $(1.5 \t 10^1 \t eV)$, is negligible compared with the D oppler broadening of the spectrum $(FWHM = 2:35$ (T) 5 eV). Following these argum ents, we can write the dierential⁵⁷Fe solar axion wax expected at the Earth as

H ere E_a is the axion energy, d denotes the average distance between the Sun and the Earth, R is the solar radius, while $T(r)$ and (r) are the tem perature and the m ass density in a spherical shell with the radius r in the solar interior, respectively.

The total ux of ⁵⁷Fe solar axions at the Earth can be calculated by integrating the di erential axion ux (equation (11)) with respect to the axion energy. This leads to

w ith the help of equations (8) and (9). As in the fram ework of the standard solarm odel, we assumed that the number of 57 Fe nuclei per unit m ass in the Sun is uniform, i.e., that N is independent of r. U sing the standard solar m odel data for the tem perature and m ass density distributions in the Sun as functions of the radius r [44], we evaluated the integral in the above expression and found that

3. The detection of solar axions in the CAST experiment

The CERN Axion Solar Telescope (CAST) experiment is the most recent in plem entation of the axion helioscope technique [12]. It searches for solar axions and similar particles with unprecedented sensitivity in the sub-eV m ass range which is com parable to the astrophysical constraints on these particles. Like m ost of the axion search experim ents in the past 30 years, this experim ent relies on the axion coupling to two photons, a generic property of axions and ALPs given by the e ective Lagrangian

where a is the axion e^{td} , F the electrom agnetic eld strength tensor, and F its dual. This interaction can also be expressed in term s of electric E and m agnetic B eld of the coupling photons, as shown in the above expression. The e ective axion-photon coupling constant g_a is given by

Here E and N are the model dependent coe cients of the electrom agnetic and color anom aly of the axial current associated with the U $(1)_{P0}$ symmetry, respectively. In DFSZ axion m odels their ratio is $x \in \mathbb{R}$ = 8=3, while for the hadronic axions this ratio can take di erent values depending on the details of each model.

A xions and sim ilar particles with a two-photon interaction of the form given by equation (16) can transform into photons, and vice versa, in external electric orm agnetic elds. Therefore, these particles could be produced in stars by the Prim ako conversion

z Follow ing the calculations in [45] we estimated that processes like the Compton process on nuclei and proton-Helium brem sstrahlung, that are also based on the axion-nucleon coupling, are suppressed relative to the hadronic axion em ission from the M 1 nuclear transition of 57 Fe.

of them alphotons in the Coulom b elds of nuclei and electrons in the stellar plasm a. On the other hand, the reverse process has served as the basis for various experim ental m ethods to search for these particles. The axion helioscope technique [12] is one such m ethod. The essence of this idea is to search for solar axions using a long dipole m agnet in a laboratory. Inside the m agnet, while it is oriented towards the Sun, the incom ing axion couples to a virtual photon provided by the transverse m agnetic eld and converts into a realphoton via the reverse Prim ako process $a + \frac{1}{\text{virtual}}$. This photon has the energy equal to the axion energy and can be detected with a suitable X-ray detector placed at the far end of the m agnet opposite the Sun. A ssum ing that there is a vacuum in the conversion volume (i.e. m agnetic eld region), the axion-photon conversion probability is [14]x

where B is them agnetic eC , L is the length of the conversion volum e in the direction of the incom ing axion propagation, and $q = m_a^2 = 2E_a$ represents the m om entum dierence between the axion and the photon of energy E_a . The conversion probability ism axim all if the axion and photon elds rem ain in phase over the length of the conversion region, i.e., when the coherence condition $qL <$ is satis ed [14]. This restricts the sensitivity of a helioscope to a speci c range of axion m asses, e.g., for a 10 m long m agnet and axion energy of 10 keV the coherence condition sets the $\lim_{n \to \infty}$ if $\lim_{n \to \infty}$ and $\lim_{n \to \infty}$ and $\lim_{n \to \infty}$ axion m ass, up to which such an experim ent is sensitive. However, coherence can be m aintained for higher axion m asses if the conversion volume is Iled with a bu er gas such as helium $[13]$. In this case, photons acquire an e ective m ass m whose value is determ ined by the gas pressure, and the axion-photon m om entum dierence becom es $q = m^2$ m_a^2 =2 F_a . As a result, the coherence is restored for a narrow axion m ass range m_a ' m_a , where the eective photon m assm atches the axion m ass.

The rst experim ent to use the axion helioscope technique was perform ed at BN L in the early 1990s [14]. Following this experim ent, the Tokyo Axion H elioscope continued the search for axions using the sam e m ethod with m uch im proved sensitivity $[15\{17]$. At present, them ost sensitive axion helioscope is the CERN A xion SolarTelescope (CA ST). The m ain com ponent ofCA ST isa decom m issioned prototype ofa twin aperture LH C superconducting dipole m agnet, which serves as a m agnetic telescope. It provides a transverse m agnetic eld of 9.0 T inside the two parallel, straight, 9.26 m long bores. The aperture of each bore is 43 mm, so the total cross-sectional area is 2 $14:5$ cm². In term s of the param eter $(B L)^2$, which according to equation (18) determ ines the axionphoton conversion probability, the CAST m agnet is 80 times m ore e cient as an axion-to-photon converter than the best com peting helioscope in Tokyo. To optim ize $CAST$'s perform ance, the m agnet is installed on a m oving platform which allows it to track the Sun 8 vertically and 40 horizontally. Thus, it can be aligned with the Sun for approxim ately 1.5 h both during sunrise and sunset every day throughout the year. In

order to detect photons com ing from them agnet bores, as a result of axion conversion in the m agnetic eld, several low-background X -ray detectors are installed on both ends of the m agnet. U ntil 2007, a conventional T im e P rojection C ham ber (T PC) was located at one end, covering both m agnet bores, to detect photons originating from axions during the tracking of the Sun at sunset. It was then replaced by two M ICROM EGAS detectors, each attached to one bore. On the other side of them agnet, there is another M ICROM EGAS detector covering one bore, and an X-ray m irror telescope with a pn-CCD chip as the focalplane detector at the other bore, both intended to detect photons produced from axions during the sunrise solar tracking. M ore details about the CA ST experim ent and detectors can be found in [18{21,47{49].

To cover as wide as possible range of potential axion m asses, the operation of the CA ST experim ent is divided into two phases. During the Phase I (2003{2004) [19,20] the experim ent operated with vacuum inside the m agnet bores and the sensitivity was essentially lim ited to m $_{\alpha}$ < 0.02 eV due to the coherence condition. In the second phase (so-called Phase II) which started in 2005 , the m agnet bores are lled with a bu er gas in order to extend the sensitivity to higher axion m asses. In the rst part of this phase $(2005{2006})$ ⁴H e was used as a buergas. By increasing the gas pressure in appropriate steps, axion m asses up to 0.4 eV were scanned and the results of these m easurem ents supersede all previous experim ental lim its on the axion-photon coupling constant in this m ass range [21]. To explore axion m asses above 0.4 eV, $3H$ e has to be used because it has a higher vapor pressure than $4H e$. This allows us to further increase gas pressure in the m agnet bores and to reach axion m asses up to about 1 eV in the ongoing second part of Phase II that started in 2007 and is planned to nish by the end of 2010.

4. M easurem ent and data analysis

The CA ST experim ent isprim arily designed to search foraxionsoraxion-like particles that could be produced in the Sun by the Prim ako conversion of therm alphotons. Their expected energy spectrum [20],

(where energies are in keV) has the peak at 3 keV, m ean energy of 4.2 keV, and vanishes above 10 keV. Since the conversion of these particles inside the CA ST m agnet bores would produce photons of the sam e energies, the X-ray detectors used in CAST are optim ized for the e cient detection of photons in the $1-10$ keV range. To search for 14.4 keV photons that m ight originate from the conversion of the 57 Fe solar axions we used only the data provided by the TPC detector because the other detectors have very low sensitivity to photons with energies above 10 keV.

The CA ST TPC incorporates the well-known concepts of drift cham bers and M ulti-W ire Proportional Cham bers (M W PC). It has an active volum e of 10 15 30 cm^3 lled with an A r(95%) + CH₄ (5%) gasm ixture at atm ospheric pressure, where the incom ing particle interacts with the gas producing free electrons. The detector's volum e is 10 cm

long in the drift direction that is parallel to the m agnet axis, while the $15 - 30$ cm² cross section, covering both m agnet bores, is perpendicular to this direction. The drift region is bounded on the front side with a $15 - 30$ cm² drift electrode, biased at -7 kV, that is m ade of a thin alum inum layer and covers the entire inner side of the cham ber wall closest to the m agnet. On the opposite end, i.e., back side of the cham ber, there are 3 planes of sense wires parallel to the drift electrode: one anode plane at $+1.8$ kV with 48 wires placed between two grounded cathode planes with 96 wires each. The w ires in both cathode planes are perpendicular to the anode wires. The spacing between two adjacent wires of the same plane is 3 mm . The gap between the anode and the inner cathode plane (the one closest to the drift electrode) is 3 m m , while the distance between the anode and the outer cathode plane is 6 m m . This asymm etric con quration enhances the induced signals on the cathode wires in the inner plane, which are the ones being read out by the front-end electronics, together with the anode wires. Each of these w ires is read out individually, and since the anode w ires are perpendicular to the cathode wires, a very good two-dim ensional position resolution can be obtained. This allows us to distinguish spatially localized photon events that m ay represent the axion signal from the background events characterized by the long tracks of cosm ic rays. The detector is connected to the m agnet by two 6 cm diam eter entrance windows m ade of a thin alum inized m ylar foil stretched on a m etallic grid. These windows allow the photons com ing from the m agnet bores to enter the detector. For a detailed description of the TPC detector, its shielding, front-end electronics, and data acquisition system, we refer to [49,50].

To characterize the CA ST TPC detector, a series of calibration m easurem ents was perform ed using theX -ray beam swith very accurately calibrated energiesand intensities at the PANTER X-ray facility of MPE in M unich [49]. Photons originating from the axion conversion in the CA ST m agnet would enter the detector only through its two entrance windows, their direction being parallel to them agnet axis, i.e., perpendicular to the anode and cathode wire planes. Such a photon would norm ally produce a point-like energy deposition in the region of the detector's sensitive volum e facing the windows. From the analysis of the PANTER data it was realized that the pulses induced on the sense wires (hits) in such event are clustered on several contiguous anode wires (socalled anode signal cluster), as well as on several contiguous cathode wires (cathode cluster). This characteristic pro le of a photon event can be seen in the exam ple shown in qure 1. The left and the right plot display the time evolution of the pulse induced in each anode and each cathode wire, respectively, as recorded by the ash-ADCs. By studying the cluster properties and topology, and exploiting the two-dim ensional position reconstruction capability of the detector, we were able to establish a set of rules (cuts) to distinguish genuine photon events that m ight be an axion signalfrom background events com ing from cosm ic rays and natural radioactivity. These cuts take into consideration the total number of anode and cathode clusters in the event, their tim e correlation, clusterm ultiplicity given by the num ber of hits in each cluster, and the position ofclusters in the anode and cathode wire planes with respect to the entrance

w indows of the detector [49]. We should em phasize that these cuts were derived from the data obtained during calibration m easurem entsatPA N TER where m onochrom atic photon beam swith energies from 0.3 to 8 keV were used. This energy range was chosen because it covers the bulk of the expected spectrum of solar axions produced by the Prim ako process, and these axions are, as stated before, the m ain subject of CAST's search for solar axions. It is expected that the sim ilar cuts can be applied to single out 14.4 keV photon events that could indicate the conversion of 57 Fe solar axions inside the bores of the CA ST m agnet. In order to verify this assum ption, we m ade additional calibration m easurem ents with a $57C$ o source placed in front of each of the two TPC's w indows. $57C$ o was the source of choice for this task because in the course of the $57C$ o decay to the ground state of 57 Fe, several photons are em itted, and one of them has the energy of 14.4 keV.

Figure 2 shows the spectrum of $57C$ o source after the selection cuts were applied to the TPC data. As a starting point to reject events that were not produced by photon interactions in the detector's volum e, we followed the inform ation obtained from the PA N TER calibration m easurem ents and set the requirem ent thatonly events with one anode cluster and one cathode cluster should be considered as relevant photon events. This condition also allowed us to straightforwardly m atch these two clusters in order to obtain the two-dim ensional position of the point-like event. O ur study of the cluster properties in the events that constitute the 14.4 keV peak in the $57C$ o calibration s pectrum resulted in a set of additionalcuts given in table $1.$ The rst two cuts consider the spread of the clusters. The spread of the anode cluster is due to the diusion of the electron cloud along the drift distance from the interaction point of an incoming photon to the anode wires plane. The larger spread of the cathode cluster is due to the developm ent of the avalanche process along the anode wires. The \tim e correlation" cut re
ects the fact that in a realphoton event both anode and cathode cluster originate from the same avalanche process induced in the proximity of the anode wires by the initial ionization electron cloud. The purpose of this cut is to reject events with spurious

clusters that m ight be produced by the e ects of noise in contiguous wires and m in ic the realphoton events. The \no saturation" cut is related to the fact that energy deposited in each event is calculated using the total strength of the cathode cluster obtained by adding up the pulse height of every hit in the cluster. If any of the hits has a pulse higher than the one that the ash-ADC can handle, the calculated energy would be incorrect, and thus such event should be rejected. Finally, the \position" cut is used to reject events with two-dim ensional positions outside the region where the axion signalis expected, i.e., out of the area facing the two m agnet bores. The application of all these cuts in the o-line analysis of data recorded during norm alCA ST operation reduces the background by approxim ately two orders ofm agnitude with respect to the raw trigger rate without signi cantly reducing the e ciency of the detector.

The hardware eciency of the TPC to detect 14.4 keV photons was estim ated by M onte Carlo sim ulations, using the G EA N T4 software package. The geom etry of the detector, the transparency of the entrance windows, as well as the opacity of the gas inside the sensitive detector volum e were taken into account,giving the eciency of 13%. Here we note that the validity of the simulations was checked by comparing the com puted e ciencies with those obtained from the PANTER m easurem ents [49] for photon energies of 6.4 and 8 keV (the two highest energies at which m easurem ents were perform ed). The agreem ent between the corresponding eciencies is within 4 and 2 percent respectively. Therefore, we regarded the e ciency com puted by \sin ulation as a good approxim ation for the TPC hardware eciency at 14.4 keV . The additional eciency loss of 18% in the o-line analysis, due to the software cuts applied to reduce the background, was calculated using 57 Co calibration data. H ence, the overall (hardware+ software) TPC detection e ciency of 10.7 [%] for 14.4 keV photons that m ay com e from conversion of solar axions was obtained. Finally, data from $57C$ o calibration runs were also used to determ ine the energy resolution of the TPC at 14.4 keV which de nes the energy region of interest in our search for the signal of ⁵⁷Fe solar axions. It was found that the width of the 14.4 keV peak is characterized by the standard deviation param eter = $1:77$ keV, giving a full width at half m aximum of 4.16 keV.

For the study presented in this article, we used the data acquired with the TPC over the period of 5.5 m onths in 2004 during Phase I of the CA ST experim ent. The energy response of the detector was calibrated periodically using the $55Fe$ X -ray source. No system atic shift in the energy scale with time was found. Since the calibration runs took place every six hours, we were able to characterize, with very good precision, sm all gain variations due to the
uctuations ofenvironm entalparam eters that aected the gain of the detector, and to correct the calculation of the energy deposited in each event accordingly.

D ata quality checks were perform ed both on-line (during data acquisition) and o-line by using the \slow control" data that were continuously recorded during the operation of the experim ent to m onitor various experim ental param eters (e.g. the m agnetic eld strength, m agnet pointing direction with respect to the current position of the Sun, m agnet tem perature, various pressures, etc.). As a result, data quali ed for the analysis were accum ulated during 2819 e ective hours, out of which 203 hours correspond to the tracking data (data acquired in the \axion-sensitive" conditions, i.e., while the m agnet was tracking the Sun), and 2616 hours correspond to the background data (data acquired during the non-tracking periods). The background data were used to estim ate and subtract the true background contribution in the tracking data spectrum. Therefore, these data were taken while the m agnet was parked in well-de ned positions close to where it was passing during the Sun tracking, but at tim es when the Sun was not in view.

The energy spectrum of the events reconstructed from the tracking data that passed allthesoftwarecutsin theo-lineanalysis,aswellasthem easured background spectrum after applying the same cuts, are shown in gure 3 on the left side. Both spectra are properly norm alized so they can be com pared. The verticaldashed lines delim it the intervalwhere the peak com ing from the excess of 14.4 keV photon events, that would indicate a signal for 57 Fe solar axions, is expected. A s stated earlier, the TPC energy resolution ()atthe14.4keV peak is1.77keV .Therefore,weregarded this14:4 3:5keV interval as the 2 (95.45%) signal region. To extract the signal, we subtracted the background spectrum from the tracking one, and the resulting signal spectrum can be seen on the right side in gure 3. The num ber of detected photon events in the signal region is 71 57. Consequently, only an upper lim it on any axion signal expected in this energy range could have been set.

Since the energy resolution of the TPC detector does not allow us to look at the very narrow 14.4 keV line alone, one also picks up a fairly broad part of the Prim ako solar axion spectrum which could m ask the yield of 57 Fe solar axions. This m eans that our m ethod willnot be able to identify their contribution for certain com binations of axion-photon and axion-nucleon coupling constant values. To exclude cases where the 11-18 keV tail of the Prim ako ux exceeds the 57 Fe solar axion ux in the measured signal spectrum , we set a constraint on the Prim ako axion em ission by requiring

and thus restricts the region of q_a $\frac{c}{2N}$ param eter space in which our method, com plem ented by the use of the TPC detector, is strongly sensitive to 57 Fe solar axions, as can be seen on the right side in gure 4 (region below the \D et" line). In this view, our analysis involves searching for the G aussian-like energy spectrum of axion-induced photons,

that describes the shape of the expected 14.4 keV axion peak in the m easured signal spectrum. The analysis was performed by standard 2 m in in ization. The energy resolution = 1:77 keV and the position of the peak $E_a = 14.4$ keV were xed during the tting. W ith t= 203 hours of Sun tracking and $A = 2$ 14:5 cm² cross-sectional area of both m agnet bores, the m inim um of $^{2}/d$ of $= 11.47/13$ corresponds to the num ber of signalevents N $_{\rm s}$ = 42 27. This result is consistent with zero, thus giving no evidence for 57 Fe solar axions in our search. Therefore, an upper lim it on the num ber of signal events, N_S < 32 counts at 95% C L., was obtained following the Bayesian approach [9] by calculating the value of N_S that encompasses 95% of the physically allowed part $(N_S 0)$ of the B ayesian probability distribution. The corresponding ts are plotted in gure 3 (right side). The eect of the Prim ako axion tailon the result of our analysis was studied in the param eter space regions where the ⁵⁷Fe solar axion contribution is com parable to or signi cantly less than the Prim ako one and discussed in section 5.

5. Results and discussion

The number of photons expected to be detected by the TPC, coming from the magnet bores as a result of the conversion of 57 Fe solar axions in the m agnetic eld, is

where (E_a) is the TPC detection e ciency for the photons of energy E_a. We can rew rite the axion-photon conversion probability P_a (E_a), given by equation (18), in a m ore convenient form as

One should recall that the conversion probability depends in plicitly on the axion m ass m_a and the axion energy E_a through the axion-photon m om entum dierence $q = m_a^2 = 2E_a$. However, since the ⁵⁷Fe solar axions are nearly monoenergetic, which is the result of their energy spectrum being very narrow (FW HM 5 eV), it is a reasonable approxim ation that the conversion probability is constant over their energy range and equal to P_a P_a (14:4 keV). Hence, the equation (23) can be written as

where for the magnetic eld we used its e ective value of 8.83 T, due to the fact that during 82% of the data taking time the magnetic eld was $8:79$ T, while for the rest of the time its value was $9T$.

A ccording to equation (26), the upper lim it on the num ber of signal events N $_{\rm S}$ < 32, resulting from the non-observation of the signal above background in our search for 57 Fe solar axions, can be translated into the lim it on the product of the param eters q_a and g_{aN}^e ask

W e can consider this m odel-independent lim it to be a function of the axion mass m_a , as shown on the left side in qure 4. In the m ass range $m_a < 0.03$ eV, where the axion-photon conversion process is coherent and has m axim um probability, the lim it is m ass-independent and its value (95% $C.L.$) is

For higher axion m asses, an increase of the m om entum m ism atch q causes a loss of the coherence of the axion-to-photon conversion, and suppresses the conversion probability due to the factor $\sin^2(x)=x^2$ in equation (18), with x qL=2. A s a consequence, the sensitivity of the experim ent to 14.4 keV axions dim inishes rapidly with the increase of axion m ass above 0.03 eV, thus providing weaker, m ass-dependent lim it, as can be seen from the plot in gure 4 (left side).

This lim it, denoted as CRST-Fe , is shown on the right side in qure 4. The vertical bound labeled \Lum \pm e" at g_{aN}^e = 3:6 10⁶ is due to the requirem ent that the axion em ission from $57Fe$ nuclei in the Sun should not exceed 10% of the solar photon lum inosity, as was explained in section 2. The m ethod we used to search for 57 Fe solar axions can be applied in the region of g_a { g_{aN}^e param eter space given by equation (21) (i.e. below the line denoted as Δ) where the ⁵⁷Fe solar axion ux exceeds the tail of the Prim ako solar axion ux in the energy range of the expected 57 Fe axion signal. In this region, the dark brown area is excluded due to the 57 Fe solar axion lum inosity constraint and the \angle CAST-Fe" line given by equation (29), while the white area is allowed according to our search. D ue to the relatively low energy resolution of the TPC detector, the CAST search for 57 Fe solar axions is not signi cantly sensitive in the param eter space region (grey) above the ΔD et" line, where the Prim ako axion contribution dom inates, while in the proxim ity of this line we expect that these two contributions are com parable. To exam ine how the Prim ako axion tail a ects our result (28) , we perform ed two additional 2^2 analysis of the experim ental signal spectrum using as t functions: i) N $_{Fe}$ + N $_{P}$, and ii) N $_{P}$. H ere N $_{Fe}$ is given by equations (22) and (26), while N_P corresponds to the expected spectrum of the Prim ako axion tail (19) m ultiplied by the axion-photon conversion probability (24) and the detection e ciency. The results of these ts are shown in table 2. The suppression of our method's sensitivity to the 57 Fe axions in the region above the Δ et" line due to the Prim ako axions contribution resulted in the upper lim it of $q_a < 3:5 \, 10^{10}$ G eV 1 at 95% C.L., which is displayed as a red horizontal line in qure 4 (right side). A lso, according to table 2 , the eect of the Prim ako axion tailon our upper lim it g_a g_{aN}^e < 1:36 10¹⁶ GeV¹ is 10% in the proximity of the \Det" line, while the 57 Fe axions a ect the limit $q_a < 3.5$ 10¹⁰ G eV ¹ for about 9%.

The experim ental system atic uncertainties on the present lim its were studied. R egarding the background determ ination, the null hypothesis test (in areas of the TPC

detector where no signal is expected) was used in order to estim ate the system atic uncertainty induced by possible uncontrolled dependencies of the background on time, position or other experim ental conditions. These eects were considered by varying the background level until the null hypothesis test yielded a result with a probability sm aller than 5%. If taken as an uncertainty, this range corresponds to $^{+88}_{-108}$ variation of the upper lim its. A s stated earlier, the deviation of our result due to the inclusion of possible contribution of the Prim ako axion tail in the tting procedure was estimated to be less than $+10$ %. O ther e ects, such as uncertainties of the m agnet param eters, are negligible, while the TPC e ciency a ects the upper $\lim_{n \to \infty}$ if therefore, we estim ated, using the quadratic sum of the individual contributions, that the overall e ect of system atic uncertainties on our upper lim it of g_a g_{aN}^e is less than $\frac{+13\%}{10\%}$.

It is im portant to stress that the only axion properties we relied on in the entire procedure that led us to equation (27) were that its couplings to photons and nucleons have a general form given by the Lagrangians in equations (2) and (16). We did not use any speci c details regarding the coupling constants g_a , g_{aN}^0 and g_{aN}^3 from any of the axion m odels. Therefore, we can consider these coupling constants as free unknown param eters that characterize the couplings of axions or general axion-like particles to two photons and a nucleon. This allowed us to use equation (27) in order to set the upper lim it on g_a as a function of m_a for various values of g_{aN}^e . Figure 5 shows the exclusion

plots of g_a versus m_a obtained for two values of the param eter $g_{\mathrm{aN}}^{\mathrm{e}}$ in com parison with the \axion m odels band", i.e., the region of g_a { m $_a$ values expected from typical axion m odels with $E = N$ 1:95jin the range 0.07{7. The axion-nucleon couplings can vary from 3:6 10⁶ to 3:6 10⁷ re ecting constraints due to the 57 Fe solar axion lum inosity and detection sensitivity, respectively. The presented contours do not enter the range of param eters, indicated by the yellow band in gure 5 , that is predicted by plausible axion m odels to be the best-m otivated region to search for axions. Thus, they should rather be considered as the lim its on the two-photon coupling of axion-like particles that are som ewhat lighter for a given interaction strength than it is expected for axions.

These two contours serve as an exam ple to show how our result, given by the equation (27), can be used to scale the excluded region in the $q_a \{ m_a \}$ param eter space for various choices of g_{aN}^0 and g_{aN}^3 . In such am anner, it can be generally applied to im pose the constraints on exotic light pseudoscalar particles that could be em itted in the nuclear m agnetic transitions and couple to two photons. CA ST has also perform ed a similar search for high-energy solar axions and ALPs from $1/7$ Li (0.478 M eV) and D (p, $3/7$ He $(5.5 M eV)$ nuclear transitions, and the results are reported in [51].

6. C onclusion

The ongoing CA ST experim ent is prim arily designed to search for hadronic axions or m ore general A LPs of continuous energy spectrum, with an average energy of 4.2 keV, that could be produced abundantly in the solar core by the Prim ako conversion of therm al photons in the electric elds of charged particles in the plasm a. Since the reconversion of these particles inside the CA ST m agnet bores would produce photons of the sam e energies, the X-ray detectors used in $CAST$ are optim ized for the e cient detection of photons in the 1-10 keV range. H ere we explored the relation between the coupling constants of pseudoscalar particles that couple to a nucleon and to two photons by using the CAST setup during the Phase I to look for 14.4 keV m onoenergetic solar axions and ALPs that m ay be em itted in the M 1 nuclear transition of 57 Fe. The signal we searched for, i.e., an excess of 14.4 keV X -rays when the m agnet was pointing to the Sun was not found, and we set m odel-independent lim its on the coupling constants of g_a j 1:19 $\oint_{\rm aN}$ + g $_{\rm aN}^3$ j< 1:36 $\,$ 10 16 G eV $^1\,$ at the 95% con dence level. A s a contrast to other experim ents sensitive on the g_a^2 g_{an}^2 couplings [35,40,52,53] that put som e constraints in the 10^2 10 eV axion m ass range, we explored the low m ass region up to 0.03 eV .
