A bstract: In the fram ework of the Standard M odel we calculate the avour non-universal correction for neutrino refraction in a neutrino background and verify a similar previous result for the case of ordinary-matter background. The dominant term arises at loop level and involves leptons circulating in the loop. These $0 \left(G_F m^2 \right)$ corrections to the tree-level potential provide the dom inant refractive di erence between and unless the medium contains OY leptons. Our results a ect the avour evolution of dense neutrino gases and m ay be of interest for collective three- avour oscillations of supernova neutrinos. We spellout explicitly how these non-universal neutrino (neutrino interactions enter the avour oscillation equations.

1. Introduction

The dispersion relation of any particle is modied by a background eld or medium. For neutrinos this e ect is extrem ely faint, yet the m atter e ect is crucial for neutrino oscillations where the feeble refractive indices compete with the minuscule mass dierences $[1, 2]$.

Since neutral-current interactions am ong the three active neutrinos are avour universal, they can be usually ignored for neutrino oscillation phenom enology, where only the relative energy shift between avours is in portant. M oreover, energy scales of interest are well below the weak boson m ass M_W , so for low-energy neutrinos in ordinary m atter (no

or leptons) the potential-energy shift between avours can be calculated simply from the e ective charged-current H am iltonian density

Equation (12) provides a su cient description of the matter e ect in most practical cases, m ost notably solar neutrinos, but care m ust be taken in som e circum stances where either the leading term vanishes $(n_e \tcdot 0)$ or subtle three- avour e ects come into play. For example, it has long been appreciated that radiative corrections break the { degeneracy in an ordinary medium because the charged-lepton mass (m or m) in the loops distinguishes between avours $[3]$. In the low-energy $\lim_{t \to \infty} t$, the loop-induced { energy

that w ill appear in all of our results. Here and in the follow ing we neglect m_{e} , m_{e} , the rst-generation quark m asses and the neutrino energy relative to m and M $_W$.

The only known exam ple w here this sm alldensity can be of practical interest is the case of supernova (SN) neutrinos propagating in a dense environm ent after leaving the neutrino sphere of the collapsed core. At large distances they encounter two resonances w here the usualm atter e ect causes a level crossing w ith the \atop atm ospheric" and \setminus solar" m ass di erences, respectively [\[4\]](#page-13-0). M uch closer to the core the radiative e ect w ill cause sim ilar resonances [\[5](#page-13-0)]. However, the $\,$, , and uxes and spectra are probably equal, so one m ay think that { transform ations play no role.

This picture has radically changed with the insight that typically avour oscillations do occur close to the neutrino sphere. The refractive e ect of neutrinos on neutrinos is not fully captured by a refractive energy shift because if neutrinos oscillate, the sam e applies to the neutrino background, providing a \setminus avour o-diagonal refractive index" [\[6,7\]](#page-13-0). In other words, the neutrino oscillation equations becom e intrinsically nonlinear, leading to collective form s of oscillation $[8,9]$, a subject of intense recent investigation (see the recent review [\[10](#page-14-0)] and references therein). Since collective oscillations operate close to the neutrino sphere, here the $\{$ resonance can become important in a three-avour treatment $[11]$, [12](#page-14-0)]. On the other hand, collective oscillations are suppressed if them attere ect is too large, typically when $n_B \& n$ [\[13\]](#page-14-0). The SN m atter pro le and neutrino ux vary with time and depend strongly on the properties of the progenitor star, so depending on circum stances n can be larger or sm aller than n_B in the collective oscillation region a few hundred kilom eters above the neutrino sphere. W hen n & n_B and non-linear e ects becom e im portant, it is reasonable to expect that the leading e ect breaking the degeneracy between and is actually provided by loop-induced e ects due to the neutrino background itself. In this article we lla gap in the literature and calculate this non-universal radiative correction for neutrino refraction in a neutrino background.

O ur calculation is described in Sec. 2 w here we begin w ith a background of charged fem ions, con m ing the original result shown in Eq. [\(1.4\)](#page-2-0). From this starting point we include neutrinos as a background and derive our m ain result, an e ective neutrino{neutrino H am iltonian that includesm eects in the loop. In Sec. [3](#page-11-0) we spell out how to include our result in the non-linear avour oscillation equations before concluding in Sec. [4.](#page-12-0)

2. C alculation of the radiative corrections

T he energy shift between dierent neutrino species in a given m edium is proportionalto the dierence of forward scattering am plitudes $[14, 15]$. Since we dealw ith energies well below the electroweak scale, the results of the one-loop calculation w ithin the electroweak theory can be expressed in term sofan e ective four-ferm ion H am iltonian. G enerically, the quantum e ects m anifest them selves in the low -energy theory as corrections to the coe cients of the operators. (In addition they could induce higher-order operators mediating processes forbidden in the original theory.) The corrections, how ever, need not respect the original sym m etries of the interaction. T he case at hand m akes no exception: we shall see by explicit calculation that at one loop, although the Lorentz structure of the treelevel current-current interaction is preserved, avour universality of the \neutral currents" breaks dow n.

2.1 Tree level

To set up our problem and x the notation, we recall that neutrinos interact with m atter via the charged and neutralweak-current Lagrangian densities

H ere, g denotes the SU (2) weak coupling, c_w = $p \frac{1}{1 + s_w^2}$ is the cosine of the weak m ixing angle, and W and Z represent the charged and neutral gauge bosons with m asses M $_W$ and M $_Z$ = M $_W$ = C_W , respectively. These param eters are related to the Ferm i constant G $_F$ and the ne structure constant by

C harged-current interactions can be ignored since we consider only the potential-energy dierence between { and {neutrinos, which is a purely radiative e ect, and the m edium is free from { and {leptons.

where the spatial integral is over the norm alization volum e (containing one neutrino), $F_f(k; s)$ is the m om entum distribution of the ferm ion background (norm alized to 1), and s denotes the ferm ion polarization. T he m atrix elem ents are calculated between identical initial and nal states, both in m om entum and spin, i.e. they correspond to the forward scattering am plitude. T his leads to [\[16\]](#page-14-0)

W hen the m edium consists of unpolarized ordinary-m atter ferm ions $(f = e, u; d)$, the term linear in s averages to zero. Thus the neutrino potential is independent of the axial $\operatorname{coupling}\,c_{\!\scriptscriptstyle \mathrm{A}}^{\rm f}$ n_A^L and reads

w here v_p and v_k are the neutrino and ferm ion velocities, w ith m om entum p and k, respectively. In the last equality we also assum ed isotropy of the background distribution.

A s far as the tree-level neutral-current interaction in Eq. (2.7) is concerned, \blacksquare , and $_{\rm e}$ receive a common potential shift described by the avour-independent result of Eq.(2.10), w hich is irrelevant for neutrino oscillations. Note also that, in a neutralm edium, the sum over all species cancels the term sproportional to the electric charge Q_f in Eq.(2.6).

2.2 R adiative correction for a background of charged ferm ions

The e ect we are interested in is the avour-dependent part of the loop contribution to the neutral-current couplings $c_{V\!=\!A}^f$ in Eq. [\(2.7](#page-4-0)). Technically, the m atching of the e-ective H am iltonian coecients w ill be obtained by computing the $_1$ {f forward scattering am plitude. N ote also that the m om enta of the scattering particles w ill be set to zero, since their typicalvalues in SN e are very sm all compared to the relevantm ass scalesm and M $_W$. In this approxim ation allone-loop integrals reduce to tadpoles.

At tree level, $\frac{1}{1}$ forward scattering in a charged-ferm ion background is described by the Feynm an diagram in Fig.1. T he corresponding am plitude is

where the Lorentz indices and their contraction are implicitly understood. At one loop, neutrino- avour dependent contributions result only from diagram sw here a charged gauge boson (W) or would-be-G oldstone boson () couples to a neutrino line, giving rise to a virtual lepton. In practice we will restrict ourselves to this type of diagram s and we w ill retain only term s that depend on the m ass of the lepton and are thus sensitive to its avour. Flavour-independent contributions w ill be system atically neglected. Note that here and throughout we work in the 't H ooft-Feynm an gauge, in which $M = M_W$.

A swew ill see, it is convenient to classify the loop diagram saccording to their topology and to treat box and non-box diagram s separately. The latter represent the corrections to the $_1$ $_1$ Z vertex and com prise the vertex diagram s of Figs. [2{3](#page-6-0) as well as the selfenergy insertions ofFig.[4](#page-6-0).N ote thatalldiagram s ofnon-box type are independentofthe nature of the background ferm ions f in the sense that the tree-level ffZ vertex factorizes. Box diagram s can involve two charged bosons $(W \mid W)$ or) and are suppressed unless both of them are W bosons. Depending on the isospin nature of the background ferm ions, dierent box topologies contribute (Fig. [5\)](#page-7-0): in presence of a down-type background (f = e;d) only ladder boxes appear, w hile crossed boxes contribute only if the background ferm ions are of up type $(f = u \text{ and } f)$ for later application, also $f = 0$.

2.3 E xtension to neutrinos as background ferm ions

Now we turn to our m ain case of interest, namely when the propagating neutrinos ($_1$) interact w ith a neutrino background $(f = \rho)$. At tree level the relevant interactions are described by the four-neutrino neutral-current e ective H am iltonian

In principle, in addition to the vertices and selfenergies of F igs. $2\{4, w \text{ hid}$ contribute Z vertex, diagram scorresponding to the Z vertex should be included. to the H ow ever, for ϵ , such diagram s are free from $m^2 = M_{\text{W}}^2$ contributions and can thus be neglected.

Concerning the box diagram s of Fig. 5, the term s of order $m_{f0}^2 = M_W^2$ that we have neglected in Sec. 2.2 correspond to term s of order m²=M_W² and rem ain negligible.

Finally we consider the equal- avour corrections where the following dierences m ust be taken into account:

A ll scattering am plitudes are a factor two larger because in addition to the t-channel Z exchange diagram that contributes to the $\frac{1}{1}$ θ is interactions (left diagram in Fig. 6), also a u channel opens (right diagram in Fig. 6). M oreover, due to a Fierz identity, the am plitudes of the t-and u-channeldiagram s are identical. In particular, the tree-level $\{$ am plitude reads $[cf. Eq. (2.11)]$

In addition to the vertices and selfenergies of Figs. $2\{4$, sim ilar diagram s must be included, that describe the correction to the ff Z vertex with $f =$. In practice these two sets of \non-box" diagram s provide exactly the same correction. Including a further factor of two due to the presence of u-channel contributions we have $[cf. Eq. (2.19)]$

Finally the contribution of the box diagram s of Fig. 5 cannot be inferred from the calculation perform ed for the m atter-background case since the term s of order m $_{\rm f0}^2$ =M $_{\rm M}^2$ cannot be neglected when $f = p =$ and $f^0 = 1^0 =$. In this case, including again a factor two due to u-channel contributions, the ladder box diagram yields $[cf. Eq. (2.21)]$

In the context of neutrino oscillations (see Sec. 3) it proves useful to rew rite our results in a m ore com pact notation:

ie. the matrix T is a projector on the direction in avour space. Equation (2.36) holds at leading order in . Note that the renorm alization of the { coupling in plied by the rst term in Eq. (2.36) is 1 2 and has to be summed to the second term to provide the correct result $1 \quad 3 = 2$. In other words, not only is the original U (3) symmetry of the tree-level H am iltonian Eq. (2:26) broken, but a simple description by renom alizing the coe cients c_{$V = \mathbb{R}$} is not possible.

For comparison with the refractive energy shifts caused by a background of charged fem ions, we recall that at tree level a neutrino $\frac{1}{1}$ in a hom ogeneous and isotropic bath of 10 experiences

O f course, the usual ultra-relativistic approxim ation was used where neutrinos are purely left-handed and $n_{\eta0}$ is once more a net density of neutrinos minus antineutrinos. If neither I nor 1^0 are the avour, radiative corrections are negligible at our level of approximation. For $l =$ and $\hat{l} =$ θ our results in ply

How ever, in the context of neutrino oscillations these energy shifts do not provide a useful understanding of the role of neutrino {neutrino refraction because the background neutrinos them selves are, in general, coherent superpositions of weak interaction states.

3. Including radiative corrections in the oscillation equations

To see how neutrino (neutrino refraction in uences avour oscillations it is m ost econom ical to represent the ensemble by avour-space m atrices of occupation numbers $\hat{\sigma}_{ij}(p) =$ ha_1^y (p) a_1 (p) i where i and j are avour indices, a^y and a are creation and annihilation operators and h i is an expectation value for the ensemble $[7, 17]$. The diagonal elements of these avour-space m atrices are the usual occupation numbers, w hereas the o -diagonal elem ents encode relative phases between the dierent avour components. The simultaneous treatm ent of neutrinos and antineutrinos becom es particularly transparent if one de nes $\hat{\sigma}_{ij}(p) = ha_i^y(p)a_i(p)$ iw ith \crossed" avour indices where all over-barred quantities refer to antiparticles [7]. The equations of m otion (EOM) for the avour evolution are

where $[$; $]$ is a commutator and the \m atrices of oscillation frequencies" $_{\text{p}}$ and $_{\text{p}}$ play the role of H am iltonian operators in avour space for the evolution of mode p .

In an isotropic ensemble, vacuum masses, matter, and neutrinos provide at tree level the usual term s [7]

where M² is the neutrino m ass-squared m atrix and E = \dot{p} j for ultrarelativistic neutrinos. In the weak interaction basis, $M^2 = U D U^Y$ where $D = diag(m_1^2, m_2^2, m_3^2)$ and U is the usual m ixing m atrix. The m atrix of number densities N_1 for charged leptons is de ned in the weak-interaction basis with diagonal elements $n_1 = n_1$ n_1 . The corresponding neutrino matrix is

If the m edium is not isotropic, as in the case for neutrinos stream ing from a SN core, the usual factor $(1 \text{ v}_g \text{ v}_b)$ m ust be included under the integral and the m atrix N then also depends on p. This structure is identical in all that follows, so without loss of generality we can study the radiative modi cation assuming an isotropic medium.

To see how our radiative corrections modify the structure of N it is easiest to begin w ith a hypothetical case of non-universal neutrino interactions of the form

where G is a m atrix in avour space of dim ensionless coupling constants. The tree-level standard-m odelcase is $G = 1$ (unitm atrix in avour space). It was previously shown that the oscillation equation is to be m odied in the form [\[7\]](#page-13-0)

For $G = 1$ this expression is identical to N up to an additive term that is proportional to the unitm atrix and to the net total neutrino density

This quantity is conserved under oscillations, so N $\,$ and N $^{\rm e}$ (1) play identical roles and actually we could subtract Eq.(3.6) from Eq.(3.5) to achieve $N = N^e$ (1).

O ur calculation of the radiative correction of neutrino{neutrino interactions reveals that the avour-sensitive dierence of the scattering am plitudes can be expressed, at leading order and in the \largem lim it," in the form of Eq. (2.36) . Therefore, radiative corrections e ectively enter w ith two dierent m atrices of non-universal couplings. In the oscillation equation we thus need to substitute

where the projection m atrix T was dened in Eq. (2.37) . In the weak-interaction basis this is explicitly to leading order in

where we have neglected a term proportional to the unit matrix that is irrelevant for oscillations.

4. C onclusions

W e have calculated the avour non-universal correction for neutrino {neutrino refraction in the fram ework of the Standard M odel. The dom inant term arises at bop level and involves

leptons circulating in the loop. In the course of our derivation we have reproduced a sim ilar term for a background m edium of charged ferm ions that had been calculated previously by Botella, Lim and M arciano [\[3](#page-13-0)]. One novel feature of our result is that the radiatively corrected e ective neutrino{neutrino H am iltonian can not be expressed in term s

of renorm a lized tree-level coupling constants. This di erent structure derives from the box diagram swith the exchange of two W bosons.

The in pact of neutrino (neutrino refraction on collective neutrino oscillations is not easily assessed by comparing refractive energy shifts relative to those caused by an ordinarym atter background. The recent torrent of activities concerning collective SN neutrino oscillations was essentially triggered by the insight that the nonlinear nature of the equations allow s for large collective e ects even if the ordinary-m atter background causes larger energy shifts than the neutrino background. This is traced back to the phenom enon that the refractive-index m atrix caused by ordinary m atter and by background neutrinos are usually not diagonal in the same basis because of neutrino avor oscillations.

O ur radiative corrections provide non-universal neutrino (neutrino interactions sin ilar to, but not identical with, the case of non-standard interactions studied in Ref. [18], suggesting the possibility of interesting collective oscillation phenom ena. However, a realistic assessm ent requires a dedicated study including the impact of a dense ordinary-matter background and multi-angle e ects.

We also note that in certain supersymmetric scenarios the neutrino {ferm ion radiative corrections could be enhanced up to two order of m agnitudes with respect to the standard case [19, 20]. Sim ilar enhancem ents m ight be expected for neutrino (neutrino refraction.
