Flavour-dependent radiative correction to neutrino { neutrino refraction

A bstract: In the fram ework of the Standard M odelwe calculate the avour non-universal correction for neutrino refraction in a neutrino background and verify a similar previous result for the case of ordinary-matter background. The dominant term arises at loop level and involves leptons circulating in the loop. These O (G_Fm^2) corrections to the tree-level potential provide the dominant refractive di erence between and unless the medium contains or leptons. Our results a ect the avour evolution of dense neutrino gases and may be of interest for collective three- avour oscillations of supernova neutrinos. We spellout explicitly how these non-universal neutrino {neutrino interactions enter the avour oscillation equations.

1. Introduction

The dispersion relation of any particle is m odi ed by a background eld or m edium. For neutrinos this e ect is extremely faint, yet the m atter e ect is crucial for neutrino oscillations where the feeble refractive indices compete with the m inuscule m ass di erences [1, 2].

Since neutral-current interactions among the three active neutrinos are avour universal, they can be usually ignored for neutrino oscillation phenom enology, where only the relative energy shift between avours is important. Moreover, energy scales of interest are well below the weak boson mass M $_{\rm W}$, so for low-energy neutrinos in ordinary matter (no

or leptons) the potential-energy shift between avours can be calculated simply from the elective charged-current Ham iltonian density

where the second equality follows from the usual Fierz rearrangement. One thus nds the well-known tree-level energy splitting for electron neutrinos with respect to or,

where n_e is understood as net density of electrons m inus positrons. In lowest order of perturbation theory, the and dispersion relations coincide and E = 0.

Equation (1.2) provides a su cient description of the matter e ect in most practical cases, most notably solar neutrinos, but care must be taken in some circum stances where either the leading term vanishes (n_e ' 0) or subtle three- avour e ects come into play. For example, it has long been appreciated that radiative corrections break the { degeneracy in an ordinary medium because the charged-lepton mass (m or m) in the loops distinguishes between avours [3]. In the low-energy limit, the loop-induced { energy

shift has the same structure as Eq. (1.2) and thus can be represented by an elective net tau-lepton density in the form

Botella, Lim and Marciano [3] studied explicitly the case of an ordinary electrically neutral medium and found the equivalent of

where $n_B = n_p + n_n$ is the baryon density and $Y_n = n_n = n_B$ the neutron/baryon fraction, the rem ainder being protons. We have introduced the sm all parameter

that will appear in all of our results. Here and in the following we neglect m $_{\rm e},$ m $\,$, the rst-generation quark masses and the neutrino energy relative to m $\,$ and M $_{\rm W}$.

The quantity $Y_n=3$ in Eq. (1.4) is at most a 5% correction. Neglecting it provides

The only known example where this smalldensity can be of practical interest is the case of supernova (SN) neutrinos propagating in a dense environment after leaving the neutrino sphere of the collapsed core. At large distances they encounter two resonances where the usual matter e ect causes a level crossing with the \atm ospheric" and \solar" mass di erences, respectively [4]. Much closer to the core the radiative e ect will cause similar resonances [5]. However, the , , and uxes and spectra are probably equal, so one may think that { transformations play no role.

This picture has radically changed with the insight that typically avour oscillations do occur close to the neutrino sphere. The refractive e ect of neutrinos on neutrinos is not fully captured by a refractive energy shift because if neutrinos oscillate, the sam e applies to the neutrino background, providing a $\$ avour o -diagonal refractive index" [6, 7]. In other words, the neutrino oscillation equations become intrinsically nonlinear, leading to collective form s of oscillation [8,9], a subject of intense recent investigation (see the recent review [10] and references therein). Since collective oscillations operate close to the neutrino sphere, here the { resonance can become important in a three-avour treatment [11, 12]. On the other hand, collective oscillations are suppressed if the matter e ect is too large, typically when $n_B \& n$ [13]. The SN matter prole and neutrino ux vary with time and depend strongly on the properties of the progenitor star, so depending on circum stances n can be larger or sm aller than n_B in the collective oscillation region a few hundred kilom eters above the neutrino sphere. When n & n_B and non-linear elects become important, it is reasonable to expect that the leading e ect breaking the degeneracy between and is actually provided by bop-induced e ects due to the neutrino background itself. In this article we lla gap in the literature and calculate this non-universal radiative correction for neutrino refraction in a neutrino background.

O ur calculation is described in Sec. 2 where we begin with a background of charged ferm ions, con m ing the original result shown in Eq. (1.4). From this starting point we include neutrinos as a background and derive our main result, an elective neutrino {neutrino H am iltonian that includes methods in the bop. In Sec. 3 we spell out how to include our result in the non-linear avour oscillation equations before concluding in Sec. 4.

2. Calculation of the radiative corrections

The energy shift between di erent neutrino species in a given medium is proportional to the di erence of forward scattering am plitudes [14, 15]. Since we deal with energies well below the electroweak scale, the results of the one-loop calculation within the electroweak theory can be expressed in term s of an electror four-ferm ion H am iltonian. Generically, the quantum elects manifest them selves in the low energy theory as corrections to the coelectror operators. (In addition they could induce higher-order operators mediating processes forbidden in the original theory.) The corrections, how ever, need not respect the original symmetries of the interaction. The case at hand makes no exception: we shall see by explicit calculation that at one loop, although the Lorentz structure of the tree-level current-current interaction is preserved, avour universality of the \neutral currents" breaks dow n.

2.1 Tree level

To set up our problem and x the notation, we recall that neutrinos interact with m atter via the charged and neutral weak-current Lagrangian densities

Here, g denotes the SU (2) weak coupling, $c_w = {p \over 1 - s_w^2}$ is the cosine of the weak m ixing angle, and W and Z represent the charged and neutral gauge bosons with m asses M_W and M_Z = M_W = c_w , respectively. These parameters are related to the Ferm i constant G_F and the ne structure constant by

The indices l and i run over the lepton and quark generations, respectively. The vector and axial couplings of a ferm ion f = -, e, u or d are

where $Q_f = 0; 1; \frac{2}{3}; \frac{1}{3}$ is the electric charge and $T_{3f} = \frac{1}{2}; \frac{1}{2}; \frac{1}{2}; \frac{1}{2}$ is the third component of the weak isospin. In particular $c_V = c_A = 1=2$ for neutrinos. We need to calculate the shift in the potential of a neutrino $_1 =$; interacting with a medium consisting of ordinary matter, i.e. ferm ions f = u;d;e. This interaction is described by the electric neutral-current H am iltonian density

Charged-current interactions can be ignored since we consider only the potential-energy di erence between { and { neutrinos, which is a purely radiative e ect, and the medium is free from { and { leptons.

A ssum ing hom ogeneity, the potential in term s of the D irac spinors of the (left-handed) neutrino u (p) and of the ferm ion $u_f(k;s)$ is

where the spatial integral is over the norm alization volum e (containing one neutrino), $F_{f}(k;s)$ is the momentum distribution of the ferm ion background (norm alized to 1), and s denotes the ferm ion polarization. The matrix elements are calculated between identical initial and nal states, both in momentum and spin, i.e. they correspond to the forward scattering am plitude. This leads to [16]


where m_f is the background ferm ion mass and s its polarization four vector, such that s = 0; $s^2 = 1$.

W hen the medium consists of unpolarized ordinary-matter ferm ions (f = e;u;d), the term linear in s averages to zero. Thus the neutrino potential is independent of the axial coupling c_A^f and reads

where v_p and v_k are the neutrino and ferm ion velocities, with momentum p and k, respectively. In the last equality we also assumed isotropy of the background distribution.

As far as the tree-level neutral-current interaction in Eq. (2.7) is concerned, , , and $_{\rm e}$ receive a common potential shift described by the avour-independent result of Eq. (2.10), which is irrelevant for neutrino oscillations. Note also that, in a neutral medium, the sum over all species cancels the term sproportional to the electric charge Q_f in Eq. (2.6).

2.2 R adiative correction for a background of charged ferm ions

The e ect we are interested in is the avour-dependent part of the bop contribution to the neutral-current couplings $c_{V=A}^{f}$ in Eq. (2.7). Technically, the matching of the elective H am iltonian coecients will be obtained by computing the $_{1}$ {f forward scattering am plitude. Note also that the momenta of the scattering particles will be set to zero, since their typical values in SN e are very small compared to the relevant mass scales m and M $_{W}$. In this approximation all one-loop integrals reduce to tadpoles.

At tree level, $_1$ forward scattering in a charged-ferm ion background is described by the Feynm an diagram in Fig. 1. The corresponding am plitude is

where the Lorentz indices and their contraction are in plicitly understood. At one loop, neutrino- avour dependent contributions result only from diagram swhere a charged gauge boson (W) or would-be-G oldstone boson () couples to a neutrino line, giving rise to a virtual lepton. In practice we will restrict ourselves to this type of diagram s and we will retain only terms that depend on the mass of the lepton and are thus sensitive to its avour. F lavour-independent contributions will be system atically neglected. Note that here and throughout we work in the 't H ooft-Feynm an gauge, in which $M = M_W$.




Figure 2: Flavour-dependent vertex corrections involving Z ll interactions.

A swew ill see, it is convenient to classify the bop diagram s according to their topology and to treat box and non-box diagram s separately. The latter represent the corrections to the $_{1\ 1}$ Z vertex and comprise the vertex diagram s of Figs. 2{3 as well as the selfenergy insertions of Fig. 4. Note that all diagram s of non-box type are independent of the nature of the background ferm ions f in the sense that the tree-level ffZ vertex factorizes. Box diagram s can involve two charged bosons (W W , W or) and are suppressed unless both of them are W bosons. Depending on the isospin nature of the background ferm ions, di erent box topologies contribute (Fig. 5): in presence of a down-type background (f = e;d) only ladder boxes appear, while crossed boxes contribute only if the background ferm ions are of up type (f = u and, for later application, also f =).




Figure 3: Flavour-dependent vertex corrections involving ZW $^+$ W , Z $^+$, and ZW $^+$ interactions. In the latter case (rightm ost diagram), an additional contribution with W must be taken into account.




Figure 4: Flavour-dependent selfenergy insertions in the incom ing neutrino line. A nalogous diagram s for the outgoing neutrino must be considered. These diagram s have to be understood as on-shell renorm alization factors for the neutrino wave functions.




Figure 5: Flavour-dependent box corrections. The ladder box diagram s (left) contribute only for down-type (f = e;d) background ferm ions, whereas the crossed box diagram s (right) contribute only for up-type (f = u; def) ferm ions. Box diagram s involving exchange are suppressed.

The complete non-box contribution, i.e. the sum of the amplitudes Eqs. (2.13){(2.18), is free from ultraviolet divergences and reads

The results for down-and up-type ferm ions correspond to ladder and crossed box topologies, respectively.

Here the term s proportional to $c_{V=A}^{f}$ originate from non-box diagram s and the rem nant is due to boxes. The relevant shift for the electron component of the background is obtained by replacing d! e in Eq. (2.23).

Taking into account that in neutral, ordinary matter $n_e = n_p$, $n_u = 2n_p + n_n$, $n_d = n_p + 2n_n$ and using $n_B = n_p + n_n$, one obtains the { energy shift

2.3 Extension to neutrinos as background ferm ions

Now we turn to our main case of interest, namely when the propagating neutrinos ($_1$) interact with a neutrino background (f = $_{1^0}$). At tree level the relevant interactions are described by the four-neutrino neutral-current elective H am iltonian

which is of the same form as Eq. (2.7) upon identi cation of the ferm ion couplings with $c_V^{1^0} = c_A^{1^0} = 1=2$ and noting that each term with $l \in l^0$ enters twice in the sum. Note also that Eq. (2.26) has a U (3) symmetry in avour space.

The general form of the one-loop e ective Ham iltonian is

and one-loop terms proportional to m 2 -M $_W^2$ contribute only if either $_1$ or $_1^o$ is a . We rst consider the correction = with $\frac{1}{2}$. This case can be easily

related to the charged-ferm ion background results of Sec. 2.2. To this end we can regard as a neutrino that propagates in a background with f = . The one-loop diagram s that give rise to term s of order m²=M_W² are exactly the same as in Sec. 2.2:

In principle, in addition to the vertices and selfenergies of Figs. 2{4, which contribute to the Z vertex, diagram s corresponding to the Z vertex should be included. However, for ϵ , such diagram s are free from $m^2 = M_W^2$ contributions and can thus be neglected.

Concerning the box diagram s of Fig. 5, the term s of order $m_{f^0}^2 = M_W^2$ that we have neglected in Sec.2.2 correspond to term s of order $m^2 = M_W^2$ and remain negligible.

This implies that can be obtained from Eq. (2.24) for up-type ferm ions by simply replacing u ! . By comparing the corresponding H am iltonians Eqs. (2.7) and (2.27) we easily see that the relevant relation is




Figure 6: At tree level, neutrino forward scattering in a neutrino background proceeds through t-channel exchange of Z bosons (left diagram), plus u-channel exchange in the case of identical avours only (right diagram).

Finally we consider the equal- avour corrections where the following di erences must be taken into account:

All scattering am plitudes are a factor two larger because in addition to the t-channel Z -exchange diagram that contributes to the $_1 \in _{1^0}$ interactions (left diagram in Fig. 6), also a u channel opens (right diagram in Fig. 6). Moreover, due to a Fierz identity, the am plitudes of the t-and u-channel diagram s are identical. In particular, the tree-level { am plitude reads [cf. Eq. (2.11)]

In addition to the vertices and selfenergies of Figs. 2{4, sim ilar diagram s must be included, that describe the correction to the ffZ vertex with f = . In practice these two sets of \non-box" diagram s provide exactly the same correction. Including a further factor of two due to the presence of u-channel contributions we have [cf. Eq. (2.19)]

Finally the contribution of the box diagram s of Fig. 5 cannot be inferred from the calculation perform ed for the matter-background case since the term s of order m $_{f^0}^2 = M_W^2$ cannot be neglected when $f = _{1^0} =$ and $f^0 = 1^0 =$. In this case, including again a factor two due to u-channel contributions, the ladder box diagram yields [cf. Eq. (2.21)]

In the context of neutrino oscillations (see Sec. 3) it proves useful to rew rite our results in a more compact notation:

i.e. the matrix T is a projector on the direction in avour space. Equation (2.36) holds at leading order in . Note that the renormalization of the { coupling implied by the rst term in Eq. (2.36) is 1 2 and has to be summed to the second term to provide the correct result 1 3 =2. In other words, not only is the original U (3) symmetry of the tree-level Ham iltonian Eq. (2.26) broken, but a simple description by renormalizing the coe cients $c_{V=A}$ is not possible.

For comparison with the refractive energy shifts caused by a background of charged ferm ions, we recall that at tree level a neutrino $_1$ in a hom ogeneous and isotropic bath of $_1^{\circ}$ experiences

O f course, the usual ultra-relativistic approximation was used where neutrinos are purely left-handed and n $_{10}$ is once more a net density of neutrinosm inus antineutrinos. If neither

However, in the context of neutrino oscillations these energy shifts do not provide a useful understanding of the role of neutrino {neutrino refraction because the background neutrinos them selves are, in general, coherent superpositions of weak interaction states.

3. Including radiative corrections in the oscillation equations

To see how neutrino {neutrino refraction in uences avour oscillations it is most econom – ical to represent the ensemble by avour-space matrices of occupation numbers $\$_{ij}(p) = ha_i^{Y}(p)a_j(p)i$ where i and j are avour indices, a^{Y} and a are creation and annihilation operators and h is an expectation value for the ensemble [7,17]. The diagonal elements of these avour-space matrices are the usual occupation numbers, whereas the o-diagonal elements encode relative phases between the di erent avour components. The simultaneous treatment of neutrinos and antineutrinos becomes particularly transparent if one de nes $\$_{ij}(p) = ha_j^{Y}(p)a_i(p)i$ with \crossed" avour indices where all over-barred quantities refer to antiparticles [7]. The equations of motion (EOM) for the avour evolution are

where [;] is a commutator and the m atrices of oscillation frequencies" $_p$ and $_p$ play the role of H am iltonian operators in avour space for the evolution of m ode p.

In an isotropic ensemble, vacuum masses, matter, and neutrinos provide at tree level the usual term s [7]

where M² is the neutrino mass-squared matrix and E = jp j for ultrarelativistic neutrinos. In the weak interaction basis, M² = U D U^y where D = diag(m₁²;m₂²;m₃²) and U is the usual mixing matrix. The matrix of number densities N₁ for charged leptons is de ned in the weak-interaction basis with diagonal elements n₁ = n₁ n_{1⁺}. The corresponding neutrino matrix is Z

If the medium is not isotropic, as in the case for neutrinos stream ing from a SN core, the usual factor (1 v $_q$ v $_p$) must be included under the integral and the matrix N then also depends on p. This structure is identical in all that follows, so without loss of generality we can study the radiative modi cation assuming an isotropic medium.

To see how our radiative corrections m odify the structure of N it is easiest to begin with a hypothetical case of non-universal neutrino interactions of the form

where G is a matrix in avour space of dimensionless coupling constants. The træ-level standard-model case is G = 1 (unit matrix in avour space). It was previously shown that the oscillation equation is to be modified in the form [7]

For G = 1 this expression is identical to N up to an additive term that is proportional to the unit matrix and to the net total neutrino density

This quantity is conserved under oscillations, so N and N^e (1) play identical roles and actually we could subtract Eq. (3.6) from Eq. (3.5) to achieve N = N^e (1).

O ur calculation of the radiative correction of neutrino {neutrino interactions reveals that the avour-sensitive di erence of the scattering am plitudes can be expressed, at leading order and in the \large m limit," in the form of Eq. (2.36). Therefore, radiative corrections e ectively enter with two di erent matrices of non-universal couplings. In the oscillation equation we thus need to substitute

where the projection matrix T was de ned in Eq. (2.37). In the weak-interaction basis this is explicitly to leading order in

where we have neglected a term proportional to the unit matrix that is irrelevant for oscillations.

4.Conclusions

We have calculated the avour non-universal correction for neutrino {neutrino refraction in the fram ework of the Standard M odel. The dom inant term arises at loop level and involves

leptons circulating in the loop. In the course of our derivation we have reproduced a similar term for a background medium of charged ferm ions that had been calculated previously by Botella, Lim and Marciano [3]. One novel feature of our result is that the radiatively corrected e ective neutrino {neutrino H am iltonian can not be expressed in term s of renorm a lized tree-level coupling constants. This di erent structure derives from the box diagram s with the exchange of two W bosons.

The impact of neutrino {neutrino refraction on collective neutrino oscillations is not easily assessed by comparing refractive energy shifts relative to those caused by an ordinarymatter background. The recent torrent of activities concerning collective SN neutrino oscillations was essentially triggered by the insight that the nonlinear nature of the equations allows for large collective e ects even if the ordinary-matter background causes larger energy shifts than the neutrino background. This is traced back to the phenom enon that the refractive-index matrix caused by ordinary matter and by background neutrinos are usually not diagonal in the same basis because of neutrino avor oscillations.

O ur radiative corrections provide non-universal neutrino {neutrino interactions sim ilar to, but not identical with, the case of non-standard interactions studied in R ef. [18], suggesting the possibility of interesting collective oscillation phenom ena. How ever, a realistic assessment requires a dedicated study including the impact of a dense ordinary-matter background and multi-angle e ects.

W e also note that in certain supersymm etric scenarios the neutrino {ferm ion radiative corrections could be enhanced up to two order of m agnitudes with respect to the standard case [19, 20]. Sim ilar enhancem ents m ight be expected for neutrino {neutrino refraction.
