Origin and Phenom enology of W eak-D oublet Spin-1 Bosons

W e study phenom enological consequences of the Standard M odel extension by the new spin-1 elds with the internal quantum numbers of the electroweak H iggs doublets. We show, that there are at least three di erent classes of theories, all motivated by the hierarchy problem, which predict appearance of such vector weak-doublets not far from the weak scale. The common feature for all the models is the existence of an SU $(3)_W$ gauge extension of the weak SU $(2)_W$ group, which is broken down to the latter at some energy scale around TeV. The H iggs doublet then emerges as either a pseudo-N am bu-G oldstone boson of a global rem nant of SU $(3)_W$, or as a symmetry partner of the true eaten-up G oldstone boson. In the third class, the H iggs is a scalar component of a high-dimensional SU $(3)_W$ gauge eld. The common phenomenological feature of these theories is the existence of the electrow eak doublet vectors (Z ;W), which in contrast to well-known Z⁰ and W ⁰ bosons posses only anom alous (m agnetic m om ent type) couplings with ordinary light ferm ions. This fact leads to some unique signatures for their detection at the hadron colliders.

I. IN TRODUCTION

The main theoretical motivation for beyond the standard model physics around TeV energies is provided by the Hierarchy Problem, inexplicable quantum stability of the weak interaction scale with respect to the ultraviolet cuto. This problem suggests the existence of some new regulating physics not far above the weak scale. Needless to say, understanding experimental consequences of the latter is of fundamental importance.

R ecently [1], it was pointed out that possible existence of massive vector eds (V (Z ; W)) with the internal quantum numbers identical to the Standard M odel H iggs (or the lepton) doublet, can result in some interesting phenom enological consequences. Due to their quantum numbers, to the leading order such vectors can only have magnetic type interactions with the Standard M odel fermions,

where V^c (W⁺;Z) is the charge-conjugated doublet; Q_L (u_L ; d_L) and L ($_L$; e_L) are the left-handed quark and lepton doublets respectively. D are the usual SU (2)_W U (1) covariant derivatives, and the obvious group and family indexes are suppressed. M is the scale of the new physics and $g_{LR}^{u,d,e}$ are dimensionless constants.

Up until now, no theoretical motivation for the existence of such states was given. It is the purpose of this paper to provide such a motivation from the Hierarchy Problem point of view. We shall show that such states are predicted by three di erent classes of theories that represent di erent approaches for explaining the relative lightness of the Higgs doublets.

The crucial comm on feature of all three approaches is, that they are based on the existence of U $(3)_W$ SU $(3)_W$ U $(1)_W$ gauge extension of the SU $(2)_W$ U $(1)_W$ electroweak group, which is spontaneously broken down to the latter at scale M. The weak doublet vectors V are then identied with the SU $(2)_W$ doublet components of the 8-dimensional gauge multiplet of the SU $(3)_W$ group, which under SU $(2)_W$ subgroup decomposes as

where numbers refer to the dimensionality of the corresponding SU (2)_W representations. The vector eds V (V^Y) obviously belong to fragments 2 (2), and become massive during the spontaneous symmetry breaking U (3)_W ! SU (2)_W U (1)_Y. The lightness of the Higgs doublets is guaranteed, because they are related to V vectors by symmetry. This relation in three di erent approaches is established as follow s.

A. Pseudo-Goldstone Higgs

In the rst approach the lightness of the Standard M odel H iggs doublet is achieved because it is a pseudo-G oldstone boson of a spontaneously broken G_{global} G symmetry of the scalar potential, whereas only the diagonal G_{local} G part of it is gauged. This idea was originally proposed in the context of G = SU(6) grand uni cation [2], but our current focus will be the $G = U(3)_W$ realization of it [3]. In the latter realization SU(2)_W U(1) is embedded into $G_{local} = U(3)_W$ group as a maxim al subgroup. As explained above, the 8-dimensional gauge multiplet of SU(3)_W, on top of the 3 electrow eak gauge bosons and an extra singlet, contains

a com plex doublet V with the quantum num bers of the Standard M odel Higgs.

The spontaneous breaking of the local symmetry U (3)_{local} ! SU (2)_W U (1) is triggered by the two independent Higgs triplets, 3_H and 3_H^0 , which under the SU (2)_W subgroup decompose as $3_H = 1_H + 2_H$ and $3_H^0 = 1_H^0 + 2_H^0$ respectively. The fragments 2_H and 2_H^0 are doublets of SU (2)_W and have the quantum numbers of the electrow eak doublets. The non-zero vacuum expectation values (VEVs) are developed by the singlet components, $h1_H^0$ i é 0 and $h1_H$ i é 0. As a result of this breaking, gauge bosons V becom e massive. The follow-ing com bination,

is eaten-up and becom es a longitudinal components of V . W hereas the orthogonal state,

is a pseudo-N am bu-G oldstone, which is massless at the tree-level and gets the suppressed mass only at the loop level, and therefore remains lighter than the symmetry breaking scale. This pseudo-G oldstone plays the role of the Standard M odel H iggs doublet.

B. Goldstone Sister Higgs

In the second approach [4], the H iggs mass is protected because it is related by symmetry to an exact Gobbstone boson that becomes a longitudinal component of V. We shall refer to this scenario as \Gobbstone-Sister H iggs". The gauge symmetry structure of the simplest m odel is identical to the previous case. There is an exact U (3)_W gauge symmetry that incorporates the Standard M odel group as its maximal subgroup. Again, the spontaneous breaking is triggered by two H iggs triplets, 3_H and 3⁰_H. However, no approximate global symmetry is required. Instead, the two H iggs triplets are related by an exact custodial symmetry, such as, the permutation or an SU (2)_{cust} symmetry that transforms the triplets into each other 3_H 3⁰_H.

The lightness of the H iggs doublet is then guaranteed by the following e ect. B reaking of U (3) symmetry is triggered by the VEV of the singlet component of the $3_{\rm H}^0$ - triplet. During this breaking, V becomes massive and eats up the doublet $2_{\rm H}^0$. Thus $2_{\rm H}^0$ becomes a longitudinal polarization of a massive gauge eld

where M $_{\rm V}$ is the mass of V . Since $2^0_{\rm H}$ is a true eaten-up G oldstone, it cannot have any contribution to its mass from the scalar potential, but only from the kinetic m ixing with the gauge eld. But, since the un-eaten doublet

 $2_{\rm H}$ is related to $2_{\rm H}^0$ by the custodial sym m etry, the former also stays massless at the three-level. In this way the mass of the physicalH iggs doublet is protected by its sister doublet becoming a G oldstone particle. We shall consider this scenario in more details below .

C. Higgs as Extra D im ensional G auge Field

Finally, the third class of theories in which appearance of the doublet gauge elds is them ust, is the one in which the Standard M odel H iggs doublet H is an extra dim ensional component of a high-dimensional gauge eld [5, 6]. For understanding the key idea of this approach, it sufces to consider a simplest case of a vector eld in ve dimensional M inkow ski space, V_A , where A = ;5 is the ve dimensional Lorentz index. In the approach of [5, 6], the H iggs is identied with the fth component of the gauge eld, which is a four-dimensional Lorentz-scalar, H V_5 . O by iously, since H and V are the components of the same high-dimensional gauge eld, their internal quantum numbers m ust be identical.

Thus, the existence of the weak-doublet vector particles is reinforced by the high-dimensional gauge symmetry. This symmetry is spontaneously broken by compactication. In this way the mass of the Higgs doublet is controlled by the compactication scale, as opposed to the high-dimensional cuto of the theory. The realistic model building in this class of theories is much more involved than in the previous two cases. For us the only important aspect is the model-independent property of the existence of the massive vector doublet V. This property is guaranteed by the symmetry and is insensitive to the concrete model building.

Having speci ed the class of the theories of our interest, let us turn to the interaction between V and the Standard M odel ferm ions. In all three classes of theories, the coupling (1) even if not present at the tree-level can (and in general will) be generated by the loop corrections, as it is perm itted by all the sym metries of the low energy theory. We shall rst demonstrate how this generation happens by considering a toy model reduced to its bare essentials, and later illustrate it on a detailed exam ple of G oldstone-Sister Higgs [4].

II. TOY MODEL

In this section we shall discuss a generation of coupling (1) in a simple toy model. The latter consists of two sectors: Hypothetical heavy particles and chiral massless ferm ions of ordinary matter. The corresponding Lagrangian reads,

where the rst line represents the bilinear Lagrangian of the SU $(2)_W$ -doublet vector eds, V (V^Y) , and of a complex singlet scalar ed, '. The second line describes the kinetic and mass term s of a singlet $\begin{pmatrix} 0\\1 \end{pmatrix}$ and a doublet $\begin{pmatrix} 0\\2 \end{pmatrix}$ heavy ferm ions and their interactions with the doublet vector eds. The primed ferm ions are non-chiral, meaning that each of them comes in both left and right chiralities. The last two lines include the kinetic term s of the ordinary chiralm assless ferm ions, the left-handed doublets, 2, and the right-handed singlets, 1, and their interactions with the heavy eds.

The one-loop diagram in Fig.1 leads to new anom alous

is a slow varied function at q^2 m² M².

In this section we shall discuss an explicit example of the realistic model. As such we shall choose a model based on the idea of G oldstone-Sister Higgs [4]. As discussed above, in this theory the electroweak SU $(2)_{W}$

 $U(1)_{Y}$ -symmetry is enhanced to $U(3)_{W}$. Obviously the gauge sector contains an additional electroweakdoublet vector eld (V), which after spontaneous break $ing U(3)_W$! $SU(2)_W$ U(1) becom es massive. This breaking is realized by the VEV of a H iggs triplet $3^0_{\rm H}$, the weak-doublet part of which (2^0_H) becomes a longitudinal component of V . In order to trigger the second Standard M odel stage of sym m etry breaking SU $(2)_{W}$ U(1), ! U $(1)_{EM}$, the theory contains a second H iggs triplet 3_{H} . The key point is that the two triplets are related by an additional custodial SU (2)cust symmetry. The motivation for such sym m etry is, that the physical H iggs doublet $(2_{\rm H})$ is a partner of the G oldstone boson $2_{\rm H}^0$ that is eaten up via the Higgs e ect of U $(3)_W$! SU $(2)_W$ U(1) breaking. Due to this symmetry relation, the SM Higgs doublet remains naturally light.

It is the sim plest to discuss this mechanism directly in supersymmetric G rand Uni ed Theory (GUT) context, in which the U $(3)_W$ SU $(3)_W$ U $(1)_W$ group together with the color SU $(3)_C$ is embedded into the SU (6) group as a maximal subgroup, G_{CW} SU $(3)_K$ SU $(3)_W$ U $(1)_W$ SU (6). Notice that this embedding allows to treat color and weak SU (3)-groups in a completely democratic way.

Notice, that for our present purposes having the full SU (6)-sym m etry group is completely unessential. The latter is anyway broken down to its G_{CW} subgroup at scales much above the energies of our present interest. So we could have equally well lim it ourselves by G_{CW} sym m etry. However, the analysis is much more convenient in terms of SU (6) representations, rather than in terms of its subgroups. It also allow s us to understand the particle content in term of representations of a more fam iliar SU (5) subgroup. Due to this advantages, we shall use SU (6)-classi cation for the particles. If needed, the reader can easily perform decompositions into the G_{CW} -reduced representations instead.

The full symmetry of the model is thus SU(6) SU(2)_{cust}, where SU(2)_{cust} is an additional custodial symmetry that relates the SM Higgs doublet to an eaten-up G oblstone boson.

The chiral super eld content is:

- 1. Higgs sector: 35-plet $_{i}^{j}$ (i;j = 1;:::;6) and (6:2) $H_{A,j}$, (6:2) $H^{A,j}$, where i;j are SU (6) and A = 1;2 are SU (2)_{cust} indexes respectively.
- The SM fermions are embedded in the following anomaly-free set (per generation): 15_[ii], (6:2) 6^{A j} and a singlet 1.

W e shall denote the super elds by the sam e sym bols as their components. In each case it will be clear from the context which component we are referring to.

The symmetry breaking is achieved by the Higgs part of the superpotential, which has the following form ,

which leads to the symmetry breaking SU(6) ! SU(3)_c SU(2), U(1). The value of is undeterm ined in SUSY limit.

W e are interested in the situation when the scale is not very high, around TeV or so, whereas the scale M $^{0}=$ 0 ism uch larger. In this way, below the latter scale the low energy sym m etry group is G $_{\rm CW}$. The further breaking of this sym m etry to the Standard M odel group, is triggered at m uch low er scale by the VEV of the 6-plets.

As a result of this breaking, the Higgs doublets in H 1 and H $_2$ are eaten up by the SU (2) $_{W}$ -doublet gauge eds V (V $^{\rm y}$) that reside in the adjoint representation of SU (3) $_{W}$. The doublets in H 2 and H $_1$ are physical and at the tree level (in SUSY limit) have very sm all masses M 2 =M 0 . An additional contribution comes from loop corrections after supersymmetry breaking (see [4] for details).

Notice, that as a result of the symmetry structure of the theory, the color triplet partners of the Higgs doublets are autom atically super-heavy, with the masses 2M 0 , and decouple from the low energy spectrum. This solves the doublet-triplet splitting problem in SUSY GUTs.

The ferm ion masses are generated from the following interactions. The up-type quark masses come from

From the above couplings the following interactions between the doublet vector and light ferm ions are generated. The superdiagram containing external light uptype quarks is given in Fig. 2. The corresponding e ective operator of interest is,

where $(F_{j})^{a}_{j}$ is the SU(6) gauge eld strength, the ferm ionic components are taken from 15-plets and bosonic components from the rest. After substituting the VEVs of 6-plet H iggses, this operator reduces to the m agnetic coupling between V and the up-type quarks given by the last term in (1). Coupling to down-type quarks and leptons is generated through the diagram of Fig. 3, which leads to the follow ing e ective operator,

A fter substitution of the VEVs, the above interaction reduces to the magnetic coupling of V with d-quark and charged leptons, given by the rst two terms in (1).

Notice, that due to supersymmetry violating insertions in the vertexes, the avor structure of the operators (13) and (14) is not necessarily aligned with the avor structure of quark and lepton m assmatrixes. This means, that the exchange by V could potentially contribute into new avor and CP violating interactions.

Notice also, that the same operator (14) could potentially give a contribution to (g 2) of leptons. Indeed, if we instead of inserting the SU $(2)_W$ -doublet VEV of H₂, insert the VEV of a physical Higgs doublet living in H₁, the operator (14) will reduce to the magnetic moment coupling of photon. How ever, this magnetic coupling will m ix the light left-handed lepton residing in 15-plet with the heavy right-handed lepton from 6^2 , as opposed to the Standard M odel right-handed lepton residing in 6¹, thus, giving no contribution to (g 2). However, a non-zero contribution could arise in case of a small mixing between the doublets from H 1 and H 2 . Such m ixing could arise from the calculable radiative corrections, and thus, could relate the phenom enological signatures of V with the value of (g 2).

This study will not be attempted in the present work. Instead, we shall focus on characteristic signatures of resonance production and decay of V -bosons. In paper [7] it has been shown that tensor current current interaction leads to a new angular distribution in comparison with well-known vector interactions. It was realized later [1] that this property ensures distinctive signature for their detection at the hadron colliders.

The hadron colliders, due to their biggest center-ofm om entum (CM) energy $\frac{1}{5}$ several TeVs and their relatively compact sizes, still rem ain the main tools for discoveries of very heavy particles. The presence of partons with a broad range of di erent mom enta allows to ush the entire energetically accessible region, roughly, up to $\frac{1}{5}=6$. The production mechanism for new heavy bosons at a hadron collider is the qq resonance fusion.

In this paper we will consider the resonance production and decay of the above-introduced heavy spin-1 gauge bosons into the light lepton pairs, electrons or muons. For such high energies it is convenient to use the helicity form alism, since the helicity is a good quantum number for m assless particles.

This, in a way, xes the dom inant production and decay mechanisms. For example, the decay angular distribution in the CM frame of a particle with spin-s and helicity with s s decaying into two massless particles with helicities $_1$ and $_2$ can be written as [8]

is expressed through the di erence $_1 _2$ and the reduced decay am plitude M $_{1_2}^s$, which is a function of s and the outgoing helicities, but is independent of the polar () and the azim uthal () angles.

Up until now only resonance production and decay of spin-1 bosons with maximal helicities = 1 have been considered. They are associated with additional U $(1)^0$ gauge symmetries and are usually called Z⁰ particles. The Lorentz structure of its couplings to each ferm ion

avor is characterized by two generally independent constants $g_{L\,L}^f$ and $g_{R\,R}^f$

Experim ental determ ination of these coupling constants or disentangling am ong the di erent m odels is a rather hard task and cannot be fullled, for example, with the rst LHC data. In the best case only the specic c sym -

metric angular distribution over the polar angle ,

resonances.

Another possibility is the resonance production and decay of longitudinal spin-1 bosons with = 0, but this possibility is not widely discussed.

W hile the Z^{0} bosons with helicity = 1 are produced in left(right)-handed quark and right(left)-handed antiquark fusion, the longitudinal Z bosons can be produced through the new chiral couplings (1),

with the complex constants $g_{LR}^{f} = (g_{RL}^{f})$ in left-handed or right-handed quark-antiquark fusion [9].

The new couplings lead to a di erent angular distribution

than the previously considered ones. At rst sight, the small di erence between the distributions (18) and (23) seem s unim portant. However, the absence of the constant term in the latter case results at least in two potential experimental signatures.

F irst of all, the known angular distributions for scalar (19), vector (18) and spin-2 (20,21) bosons include a nonzero constant term , which leads to the kinem atic singularity in p_T distribution of the nallepton

This singularity is transformed into a well known Jacobian peak due to a nite width of the resonance. In contrast to this, the pole in the decay distribution of the Z bosons is canceled out and the lepton p_T distribution even reaches zero at the kinem atical endpoint $p_T = M = 2$. Therefore, the Z boson decay distribution has a broad

smooth hum p with the maxim um below the kinematical endpoint, instead of a sharp Jacobian peak (Fig. 4).

A nother striking feature of the distribution (23) is the forbidden decay direction perpendicular to the boost of the excited boson in the rest frame of the latter (the C ollins{Soper fram e [10]). It leads to a peculiar \sw allow - tail" shape of the angular distribution with a profound dip at $\cos_{CS} = 0$ in the C ollins{Soper fram e (Fig. 5) [9].

In conclusion, we would like to emphasize the di erence between group properties of the gauge spin-1 Z⁰ and Z bosons. While the Z⁰ bosons are described by real representations transforming as triplets or singlets of SU(2)_W U(1) group, the Z bosons, like the Higgs elds, are assigned to the complex representation and transform as doublets. This results in another important experimental consequence.

Together with the neutral Z bosons the doublets always contain also the charged bosons, W , which decay into a charged lepton and an undetected neutrino. Therefore, the angular distribution in Fig. 5 is experimentally unaccessible for them in the lepton channel. Only the p_T -distribution of the charged lepton can be measured. However, the distribution of the W bosons di ers drastically from the distribution of the W ⁰ bosons (Fig. 4). Hence, even relatively small decay width of the W bosons leads to a wide hum p without the Jacobian peak, that obscures their identi cation as resonances at the hadron colliders.

The only way to access the angular distribution for W bosons like in Fig.5 is kinem atical reconstruction of their decays into heavy quarks, tb, which, in spite of the strong QCD background, can be identied via b-tagging. The presence of the heaviest tquark in the nalstate will lead to an additional contribution,

to the angular distribution (23) proportional to the ratio m $_{t}^{2}$ =M 2 due to helicity ip of the tquark.
