O rigin and Phenom enology of W eak-D oublet Spin-1 Bosons

We study phenom enobgical consequences of the Standard M odel extension by the new spin-1 elds with the internal quantum numbers of the electroweak H iggs doublets. We show, that there are at least three di erent classes of theories, all m otivated by the hierarchy problem, which predict appearance of such vector weak-doublets not far from the weak scale. The common feature for all the m odels is the existence of an SU (3)_W gauge extension of the weak SU (2)_W group, which is broken down to the latter at some energy scale around TeV. The Higgs doublet then em erges as either a pseudo-N am bu-G oblstone boson of a global rem nant of SU (3)_W, or as a symmetry partner of the true eaten-up Goldstone boson. In the third class, the Higgs is a scalar component of a high-dim ensional SU $(3)_w$ gauge eld. The comm on phenom enological feature of these theories is the existence of the electroweak doublet vectors (Z \dot{W}), which in contrast to well-known Z⁰ and W^0 bosons posses only anom abus (m agnetic m om ent type) couplings with ordinary light ferm ions. This fact leads to some unique signatures for their detection at the hadron colliders.

I. INTRODUCTION

The m ain theoreticalm otivation for beyond the standard m odel physics around TeV energies is provided by the H ierarchy P roblem, inexplicable quantum stability of the weak interaction scale with respect to the ultraviolet cuto. This problem suggests the existence of some new requlating physics not far above the weak scale. Needless to say, understanding experimental consequences of the latter is of fundam ental im portance.

Recently [1], it was pointed out that possible existence of m assive vector elds (V W ; Z $)$ with the intemalquantum numbers identical to the Standard Model H iggs (or the lepton) doublet, can result in som e interesting phenom enological consequences. Due to their quantum numbers, to the leading order such vectors can only havem agnetic type interactionswith the Standard Model fem ions,

where V^c (W^+ ; Z) is the charge-conjugated doublet; Q_L (u $,d_{\rm L}$) and L $(\begin{smallmatrix}&1\\1&\end{smallmatrix},e_L)$ are the left-handed quark and lepton doublets respectively. D are the usual $U(1)$ covariant derivatives, and the obvious $SU(2)_W$ group and fam ily indexes are suppressed. M is the scale of the new physics and $g_{LR}^{\mu\nu\lambda}$ are dim ensionless constants.

Up until now, no theoretical motivation for the existence of such states was given. It is the purpose of this paper to provide such a motivation from the H ierarchy Problem point of view. We shall show that such states are predicted by three di erent classes of theories that represent di erent approaches for explaining the relative

lightness of the H iggs doublets.

The crucial common feature of all three approaches is, that they are based on the existence of U $(3)_W$ U $(1)_N$ gauge extension of the SU $(2)_W$ $SU(3)_W$ U (1) electrow eak group, which is spontaneously broken down to the latter at scaleM . The weak doublet vectors V are then identi ed with the SU $(2)_W$ doublet components of the 8-dim ensional gauge multiplet of the SU $(3)_W$ group, which under SU $(2)_W$ subgroup decom poses as

where numbers refer to the dimensionality of the corresponding SU $(2)_W$ representations. The vector elds V (V^Y) obviously belong to fragments 2 (2), and becom e m assive during the spontaneous symm etry breaking U $(3)_W$! SU $(2)_W$ $U(1)$. The lightness of the H iggs doublets is guaranteed, because they are related to V vectors by symmetry. This relation in three di erent approaches is established as follows.

A. Pseudo-Goldstone Higgs

In the rst approach the lightness of the Standard M odel H iggs doublet is achieved because it is a pseudo-Goldstone boson of a spontaneously broken $G_{\alpha\, \text{bbal}}$ G G symmetry of the scalar potential, whereas only the diagonal G_{local} G part of it is gauged. This idea was originally proposed in the context of $G = SU(6)$ grand uni cation [2], but our current focus will be the $G = U(3)_W$ realization of it [3]. In the latter realization SU $(2)_W$ U (1) is embedded into G $_{\text{local}} = U(3)_W$ group as a m axim al subgroup. As explained above, the 8-dim ensional gauge multiplet of SU $(3)_N$, on top of the 3 electrow eak gauge bosons and an extra singlet, contains

a com plex doublet V w ith the quantum num bers of the Standard M odel H iggs.

The spontaneous breaking of the local symmetry U (3)_{local} ! SU (2)_W U (1)_Y is triggered by the two independent H iggs triplets, 3_H and 3_H^0 , which under the SU $(2)_W$ subgroup decom pose as $3_H = 1_H + 2_H$ and 3_H^0 = 1_H^0 + 2_H^0 respectively. The fragm ents 2_H and 2_H^0 are doublets of SU $(2)_W$ and have the quantum num bers of the electrow eak doublets. The non-zero vacuum expectation values (V EV s) are developed by the singlet com ponents, $h\mathfrak{l}_{\mathtt{H}}^0$ i $\mathtt{6}$ 0 and $h\mathfrak{l}_{\mathtt{H}}$ i $\mathtt{6}$ 0. As a result of this breaking, gauge bosons V becom e m assive. The follow ing com bination,

is eaten-up and becom es a longitudinal com ponents of V . W hereas the orthogonal state,

is a pseudo-N am bu-G oldstone, w hich is m assless at the tree-level and gets the suppressed m ass only at the loop level, and therefore rem ains lighter than the symmetry breaking scale. T his pseudo-G oldstone plays the role of the Standard M odel H iggs doublet.

B . G oldstone Sister H iggs

In the second approach [\[4\]](#page-5-3), the H iggsm ass is protected because it is related by sym m etry to an exact G oldstone boson that becom es a longitudinal com ponent of V . We shall refer to this scenario as \G oldstone-Sister H iggs". The gauge symmetry structure of the simplest m odelisidenticalto the previouscase.T here isan exact U $(3)_W$ gauge sym m etry that incorporates the Standard M odelgroup as its m axim alsubgroup. A gain, the spontaneous breaking is triggered by two H iggs triplets, 3_H and $3⁰_H$. However, no approximate global symmetry is required. Instead, the two H iggs triplets are related by an exact custodial sym m etry, such as, the perm utation or an SU $(2)_{\text{cust}}$ symmetry that transform s the triplets into each other 3_H $_{\rm H}^0$.

The lightness of the H iggs doublet is then guaranteed by the following eect. Breaking of $U(3)$ symmetry is triggered by the VEV of the singlet component of the $3⁰_H$ triplet. D uring this breaking, V becom es m assive and eats up the doublet 2_H^0 . Thus 2_H^0 becom es a longitudinal polarization of a m assive gauge eld

where M $_{\rm V}\;$ is the m ass of V $\;$. Since $2_{\rm H}^0\;$ is a true eaten-up G oldstone, it cannot have any contribution to its m ass from the scalar potential, but only from the kinetic m ixing w ith the gauge eld. But, since the un-eaten doublet

 2_H is related to 2_H^0 by the custodial sym m etry, the form er also stays m assless at the three-level. In this way the m ass of the physical H iggs doublet is protected by its sister doublet becom ing a G oldstone particle. We shall consider this scenario in m ore details below .

C . H iggs as E xtra D im ensionalG auge F ield

Finally, the third class of theories in which appearance of the doublet gauge ek s is them ust, is the one in which the Standard M odel H iggs doublet H is an extra dim ensionalcom ponent of a high-dim ensional qauge e kl $[5, 6]$. For understanding the key idea of this approach, it sufces to consider a simplest case of a vector eld in ve dim ensionalM inkow skispace, V_A , where $A =$; 5 is the ve dim ensional Lorentz index. In the approach of [\[5](#page-5-4)[,6\]](#page-5-5), the H iggs is identied with the fith component of the gauge eb, w hich is a four-dim ensional Lorentz-scalar, H V₅. O bviously, since H and V are the components of the sam e high-dim ensional gauge eld, their internal quantum num bers m ust be identical.

T hus, the existence of the weak-doublet vector particles is reinforced by the high-dim ensionalgauge sym m etry. T his sym m etry is spontaneously broken by com pacti cation. In this way the m ass of the H iggs doublet is controlled by the compactication scale, as opposed to the high-dim ensional cuto of the theory. The realistic m odel building in this class of theories is much m ore involved than in the previous two cases. For us the only im $$ portant aspect is the m odel-independent property of the existence of the m assive vector doublet V . This property is guaranteed by the sym m etry and is insensitive to the concrete m odel building.

H aving specied the class of the theories of our interest, let us turn to the interaction between V and the Standard M odel ferm ions. In all three classes of theo-ries, the coupling [\(1\)](#page-0-0) even if not present at the tree-level can (and in generalw ill) be generated by the loop corrections, as it is perm itted by all the sym m etries of the low energy theory. We shall rst dem onstrate how this generation happens by considering a toy m odel reduced to its bare essentials, and later illustrate it on a detailed exam ple of G oldstone-Sister H iggs [\[4\]](#page-5-3).

II. T O Y M O D E L

In this section we shalldiscuss a generation of coupling [\(1\)](#page-0-0) in a sim ple toy m odel. T he latter consists of two sectors: Hypothetical heavy particles and chiral m assless ferm ions of ordinary m atter. The corresponding Lagrangian reads,

where the rst line represents the bilinear Lagrangian of the SU $(2)_W$ -doublet vector elds, V (V^Y) , and of a com plex singlet scalar eld, '. The second line describes the kinetic and m ass term s of a singlet $\binom{0}{1}$ and a doublet $\binom{0}{2}$ heavy fem ions and their interactions with the doublet vector elds. The primed ferm ions are non-chiral, meaning that each of them comes in both left and right chiralities. The last two lines include the kinetic term s of the ordinary chiralm assless fem ions, the left-handed doublets, $_2$, and the right-handed singlets, $_1$, and their interactions with the heavy elds.

The one-loop diagram in Fig. 1 leads to new anom alous

In this section we shall discuss an explicit example of the realistic model. As such we shall choose a model based on the idea of Goldstone-Sister Higgs [4]. As discussed above, in this theory the electroweak SU $(2)_W$

U $(1)_Y$ -symmetry is enhanced to U $(3)_W$. Obviously the gauge sector contains an additional electroweakdoublet vector eld (V), which after spontaneous breaking U $(3)_w$! SU $(2)_w$ U (1) becomes massive. This breaking is realized by the VEV of a H iggs triplet $3⁰_H$, the weak-doublet part of which $(2_H⁰)$ becomes a longitudinal com ponent of V . In order to trigger the second Standard M odel stage of symmetry breaking SU $(2)_W$ U (1) ! U $(1)_{E \text{M}}$, the theory contains a second H iggs triplet 3_H . The key point is that the two triplets are related by an additional custodial SU (2)_{cust} symmetry. The motivation for such symm etry is, that the physicalH iggs doublet (2_H) is a partner of the G oldstone boson 2_H^0 that is eaten up via the Higgs e ect of U(3)_W ! SU(2)_W $U(1)$ breaking. Due to this symmetry relation, the SM Higgs doublet rem ains naturally light.

It is the simplest to discuss this mechanism directly in supersymmetric Grand Unied Theory (GUT) context, in which the U $(3)_W$ $SU(3)$ U (1) group together w ith the color SU (3) ^c is embedded into the SU (6) group as a m axim al subgroup, G_{CW} $SU(3)$ $SU(3)$ SU (6). Notice that this embedding allows to $U(1)_W$ treat color and weak SU (3)-groups in a completely democratic way.

Notice, that for our present purposes having the full SU (6)-symmetry group is completely unessential. The latter is anyway broken down to its G_{CW} subgroup at scales much above the energies of our present interest. So we could have equally well lim it ourselves by G_{CW} symmetry. However, the analysis is much more convenient in term s of SU (6) representations, rather than in term s of its subgroups. It also allow s us to understand the particle content in term of representations of a m ore fam iliar SU (5) subgroup. Due to this advantages, we shalluse SU (6)-classi cation for the particles. If needed, the reader can easily perform decompositions into the G_{CW} -reduced representations instead.

The full symmetry of the model is thus SU (6) SU $(2)_{\text{cust}}$, where SU $(2)_{\text{cust}}$ is an additional custodial symm etry that relates the SM H iggs doublet to an eatenup G oblstone boson.

The chiral super eld content is:

- 1. H iggs sector: 35-plet $\frac{1}{i}$ (i; j = 1;:::;6) and (6.2) $H_{A,j}$, (6.2) $H^{A,j}$, where i; j are SU(6) and $A = 1:2$ are SU $(2)_{\text{cust}}$ indexes respectively.
- 2. The SM ferm ions are embedded in the following anom aly-free set (per generation): 15_{ii1} , (6.2) $6^{\text{A} \text{ j}}$ and a singlet 1.

We shall denote the super ebls by the same symbols as their components. In each case it will be clear from the context which component we are referring to.

The symmetry breaking is achieved by the H iggs part of the superpotential, which has the following form,

The vacuum of the theory is:

which leads to the symmetry breaking SU (6) ! $SU(2)$ $U(1)$. The value of SU $(3)_C$ is undeterm ined in SUSY lim it.

We are interested in the situation when the scale iS not very high, around TeV or so, whereas the scale M 0 = 0 ismuch larger. In this way, below the latter scale the low energy symmetry group is G_{CW} . The further breaking of this sym m etry to the Standard M odelgroup, is triggered at much lower scale by the VEV of the 6-plets.

As a result of this breaking, the Higgs doublets in H¹ and H₂ are eaten up by the SU $(2)_W$ -doublet gauge elds V (V^y) that reside in the ad pint representation of SU $(3)_w$. The doublets in H² and H₁ are physical and at the tree level (in SUSY lim it) have very sm all m asses $2\frac{1}{2}$ M⁰. An additional contribution comes from M loop corrections after supersymmetry breaking (see [4] for details).

Notice, that as a result of the symmetry structure of the theory, the color triplet partners of the H iggs doublets are autom atically super-heavy, with them asses 2M $\,^0$, and decouple from the low energy spectrum. This solves the doublet-triplet splitting problem in SUSY GUTs.

The ferm ion m asses are generated from the following interactions. The up-type quark m asses com e from

From the above couplings the following interactions between the doublet vector and light fem ions are generated. The superdiagram containing external light uptype quarks is given in Fig. 2. The corresponding e ective operator of interest is,

where $(F \t)_{i}^{a}$ is the SU (6) gauge eld strength, the fem ionic components are taken from 15-plets and bosonic components from the rest. A fter substituting the VEV s of 6-plet H iggses, this operator reduces to the m agnetic coupling between V and the up-type quarks given by the last term in (1). Coupling to down-type quarks and leptons is generated through the diagram of $Fig. 3$, which leads to the following e ective operator,

A fter substitution of the VEVs, the above interaction reduces to the m agnetic coupling of V with d-quark and charged leptons, given by the rst two term s in (1) .

Notice, that due to supersymm etry violating insertions in the vertexes, the avor structure of the operators (13) and (14) is not necessarily aligned with the avor structure of quark and lepton m assm atrixes. Thism eans, that the exchange by V could potentially contribute into new avor and CP violating interactions.

Notice also, that the same operator (14) could potentially give a contribution to $(q \ 2)$ of leptons. Indeed, if we instead of inserting the SU $(2)_W$ -doublet VEV of H₂, insert the VEV of a physical H iggs doublet living in H₁, the operator (14) will reduce to the m agnetic m om ent coupling of photon. How ever, thism agnetic coupling will m ix the light left-handed lepton residing in 15-plet with the heavy right-handed lepton from $6²$, as opposed to the Standard M odel right-handed lepton residing in 6^1 , thus, giving no contribution to (g 2). How ever, a non-zero contribution could arise in case of a small mixing between the doublets from H^{-1} and H^{-2} . Such m ixing could arise from the calculable radiative corrections, and thus, could relate the phenom enological signatures of V with the value of (q $2)$.

This study will not be attempted in the present work. Instead, we shall focus on characteristic signatures of resonance production and decay of V -bosons.

IV. CONSEQUENCES FOR COLLIDERS

In paper [\[7\]](#page-6-0) it has been shown that tensor current current interaction leads to a new angular distribution in com parison w ith well-know n vector interac-tions. It was realized later [\[1\]](#page-5-0) that this property ensures distinctive signature for their detection at the hadron colliders.

The hadron colliders, due to their biggest center-of-I he hadron counters, que to their biggest center-oi-
m om entum (CM) energy 5 several TeVs and their relatively com pact sizes, still rem ain the m ain tools for discoveries of very heavy particles. The presence of partons w ith a broad range of dierent m om enta allow s to ush the entire energetically accessible region, roughly, up to $\sqrt{5}$ =6. The production mechanism for new heavy bosons ata hadron collider is the qq resonance fusion.

In this paper we will consider the resonance production and decay of the above-introduced heavy spin-1 gauge bosons into the light lepton pairs, electrons or m uons. For such high energies it is convenient to use the helicity form alism, since the helicity is a good quantum num ber for m assless particles.

This, in a way, xes the dom inant production and decay m echanism s. For exam ple, the decay angular distribution in the CM frame of a particle with spin-s and helicity with s s decaying into two m assless particles w ith helicities $_1$ and $_2$ can be w ritten as [\[8\]](#page-6-1)

is expressed through the dierence $\frac{1}{2}$ and the reduced decay am plitude M $\frac{s}{1}$, which is a function of s and the outgoing helicities, but is independent of the polar () and the azim uthal() angles.

U p untilnow only resonance production and decay of spin-1 bosons w ith m axim alhelicities $=$ 1 have been considered. They are associated with additional U $(1)^{0}$ gauge symmetries and are usually called Z 0 particles. T he Lorentz structure of its couplings to each ferm ion

While the Z 0 bosonswith helicity $\quad = \quad 1$ are produced in left(right)-handed quark and right(left)-handed antiquark fusion, the longitudinalZ bosons can be produced through the new chiral couplings (1) ,

w ith the complex constants $g_{L\,R}^f \; = \; (g_{R\,L}^f \;) \;$ in left-handed or right-handed quark-antiquark fusion [\[9](#page-6-2)].

The new couplings lead to a dierent angular distribution

than the previously considered ones. At rst sight, the sm alldierence between the distributions [\(18\)](#page-4-0) and [\(23\)](#page-4-1) seem s unim portant. However, the absence of the constant term in the latter case results at least in two potentialexperim entalsignatures.

First of all, the know n angular distributions for scalar (19) , vector (18) and spin-2 $(20,21)$ bosons include a nonzero constant term , w hich leads to the kinem atic singularity in p_T distribution of the nallepton

T his singularity is transform ed into a wellknow n Jacobian peak due to a nite w idth of the resonance. In contrast to this, the pole in the decay distribution of the Z bosons is canceled out and the lepton p_T distribution even reaches zero at the kinem aticalendpoint $p_T = M =2$. Therefore, the Z boson decay distribution has a broad

sm ooth hum p w ith the m axim um below the kinem atical endpoint, instead of a sharp Jacobian peak (Fig. 4).

A nother striking feature of the distribution [\(23\)](#page-4-1) is the forbidden decay direction perpendicular to the boost of the excited boson in the rest fram e of the latter (the C ollins{Soperfram e[\[10\]](#page-6-3)). It leads to a peculiar \swallow tail" shape of the angular distribution with a profound dip at $\cos c_s = 0$ in the C ollins{Soper fram e(Fig[.5\)](#page-5-7)[\[9\]](#page-6-2).

In conclusion, we would like to emphasize the dierence between group properties of the gauge spin-1 $\frac{2}{3}$ and Z bosons. W hile the Z^0 bosons are described by real representations transform ing as triplets or singlets of SU $(2)_W$ U $(1)_Y$ group, the Z bosons, like the H iggs elds, are assigned to the com plex representation and transform as doublets. This results in another important experim ental consequence.

Together w ith the neutral Z bosons the doublets always contain also the charged bosons, W , w hich decay into a charged lepton and an undetected neutrino. T herefore, the angular distribution in Fig. [5](#page-5-7) is experim entally unaccessible for them in the lepton channel. Only the p_T -distribution of the charged lepton can be m easured. However, the distribution of the W bosons diersdrastically from the distribution of the W $^{\rm 0}$ bosons $(Fig.4)$ $(Fig.4)$. H ence, even relatively sm all decay width of the bosons leads to a w ide hum p w ithout the Jacobian peak, that obscures their identi cation as resonances at the hadron colliders.

The only way to access the angular distribution for W bosons like in Fig[.5](#page-5-7) is kinem atical reconstruction of their decays into heavy quarks, tb, w hich, in spite of the strong Q CD background, can be identi ed via b-tagging. The presence of the heaviest t quark in the nalstate will lead to an additional contribution,

to the angular distribution [\(23\)](#page-4-1) proportional to the ratio m_t^2 =M 2 due to helicity ip of the tquark.
