Abstract

A -decay study of ⁷⁷C u has been performed at the ISO LDE mass separator with the aim to deduce its -decay properties and to obtain spectroscopic information on ⁷⁷Zn. Neutron-rich copper isotopes were produced by means of proton- or neutron-induced ssion reactions on ²³⁸U. A fter the production, ⁷⁷C u was selectively laser ionized, mass separated and sent to diment detection system swhere and n coincidence data were collected. We report on the deduced half-live, decay scheme, and possible spin assignment of ⁷⁷C u.

I. IN TRODUCTION

Recently, theoretical as well as experimental studies indicate that the size of shell gaps can alter when changing the N/Z ratio leading to changes in magic numbers when going away from the valley of stability [1]. An interesting region of the nuclear chart to study this phenom enon is situated around 68 N i because of the closed proton shell (Z = 28) and the closed harm onic-oscillator sub-shell (N = 40). The robustness of the Z = 28 shell closure as neutrons are added in the unique parity orbit $g_{9=2}$ is of special interest and the induced core-polarization e ects have been studied together with the fragile nature of the N = 40 subshell closure by m eans of di erent experim ental approaches. C oulom b-excitation studies in the neutron rich N i isotopes [2, 3] resulted in sm all B (E 2) values for N = 40 suggesting a new sub-shell closure in concert with the high excitation energy of the 2^+_1 state [4]. On the other hand, Grawe et al. [5] and Langanke et al. [6] explained the sm all observed B (E2) strength and the high excitation energy of the 2_1^+ state in a di erent way. On the same ground, recent mass measurements in this region show a very weak irregularity in the two-neutronseparation energies around N = 40 giving no evidence for a well-established shell closure [7, 8]. The same mass region was further studied by means of Coulomb excitation and decay experiments in neighboring Cu and Zn neutron rich isotopes [9,10,11,12,13,14,15]. From those studies the fragile nature of the N = 40 sub-shell closure was con m ed and the key role of the $g_{9=2}$ orbit was revealed in the systematics. A common conclusion in the above m entioned surveys is the need for further spectroscopic inform ation in this region and especially towards the more exotic nuclei around the doubly magic 78 Ni.

A nother interest for the region around Z = 28 and 40 < N < 50 is related to the astrophysical rapid neutron-capture nucleosynthesis process i.e. the r-process. The r-process is responsible for the origin of about half of the elements heavier than iron. Nuclei with closed neutron shells represent a special set of waiting points which cause a vertical diversion of the r-process path in the neutron-rich side of the chart of nuclei. ⁷⁸N i is a doubly-m agic nucleus that represents the m ost important waiting point of the r-process [16]. For this reason the

-decay properties of the nuclei in the region as well as the spectroscopic information is of paramount in portance in r-process calculations.

In this paper we report on the -decay study of ^{77}Cu . This study is part of a system atic -decay study at ISO LDE, CERN [17] of neutron-rich Cu isotopes ranging from ^{71}Cu to

⁷⁸Cu. The odd-odd cases have been described in [10, 18, 19, 20, 21]. The results on the odd-m ass ⁷¹ ⁷⁵Cu are discussed in the PhD work of T. Faul [22]. The lowering of the rst-excited states with spin and parities 5/2 and 1/2, as the neutron number increases in odd copper isotopes with A > 69 [9], makes particularly ⁷⁷Cu an interesting physics case. More speci cally the lowering of the 5/2 relative to the 3/2 state is expected to be strong enough to have a 5/2 ground state in ⁷⁷Cu.

In the following, we discuss the experimental setup used (Sec. II) along with the obtained results (Sec. III). In the last section the proposed ground-state spin and parity of 77 Cu is discussed. In the same section a short interpretation is given for the spin and parity assignments of the ground state and low-lying excited states of 77 Zn.

II. EXPERIMENTAL SETUP

The neutron-rich copper isotopes were produced via proton-and neutron-induced ssion of 238 U target. More speci cally the 1 GeV proton beam delivered from the CERN PS-Booster in pinged either directly to the thick 50 g/cm² U ranium carbide target or it was sent to a tantalum proton-to-neutron converter to induce ssion through the produced spallation neutrons. For the case of 77 Cu, the latter technique was used as to suppress the Rb isobaric contam ination, produced through spallation and present in the mass-separated beam as the surface ionization of this element is not negligible. Another element that is easily surface ionized is Ga. The Ga isotopes are strongly populated by spallation-neutron-induced ssion and thus remain present in the mass-separated beam. The 77 Cu nuclei were selectively ionized by means of the Resonant Ionization Laser Ion Source (R ILIS) [23, 24, 25] and mass separated by the General Purpose Separator (GPS) of the ISO LD E facility [17].

A fterm ass separation, the radioactive beam with a typical energy of 60 keV, was delivered to the -decay experimental setup (Fig. 1). The 77 C u nuclei were implanted on a tape which was surrounded by three plastic E detectors for the -particles detection. The emitted

rays were recorded through two HPG e detectors with relative e ciencies 75% (left) and 90% (right). These two detectors were placed in close geom etry, typically at 2 cm distance, aim ing for the maximum possible detection e ciency. The full energy of the particles was recorded with the telescope which was installed behind the implantation tape at 0 with respect to the beam direction.

The electronics read-out was done in parallel by m eans of two di erent ways: the singles m ode where the energy signals of the two detectors were recorded together with the E part of the telescope and the List M ode D ata (LM D) acquisition m ode where the data were recorded in an event by event m ode. In the LM D m ode, the trigger was created whenever a , or a event was recorded. G iven the m uch higher e ciency of the detection setup m ost of the LM D data corresponds to -triggered events.

For a more precise lifetime determ ination the 77 Cu beam was sent to a second setup to detect the emitted -delayed neutrons. It consisted of the M ainz neutron long counter [26] with a built-in tape transport system to remove long-lived background after each measurement cycle. A thin plastic scintillator served for the detection of particles. Despite the selectivity of the R IL IS on mass 77 the activity was dominated by gallium. Therefore the rays of the 77 Cu decay could not be discriminated and no P_n value could be deduced. Nevertheless, the -delayed neutron signal was very clean since the isobaric contam inants do not emit neutrons. Measurements with the R IL IS lasers o or detuned from the resonance gave only a at background (cosmic radiation).

The tim ing signals of the neutron counters were fed into an 8-input multichannel-scaler (module 7884 from Fast Comtec) that can handle data rates above 1 M H z. It was read out by a M PA 2 D A Q from Fast Comtec. For calibration, the entire acquisition system was tested at up to two orders of magnitude higher data rates (abundant R b and C s isotopes)

but showed no signi cant deadtim e e ects.

In Table I, a sum m ary of the experim ental conditions for the decay study of 77 Cu is given. Each run is simply a repetition of cycles, where each cycle has a characteristic in plantation and decay period depending on the half life of the isotope under study. A fter such a cycle, the tape is m oved in order to suppress the long-lived background activity. For each isotope, a certain am ount of beam time was used without using the lasers (lasers-o runs) as to determ ine the beam contam ination (m ainly G a) and the room background. A m ore detailed description of the experimental setup can be found in [15, 18, 19]

III. RESULTS

The know ledge about the -decay properties of 77 Cu is limited. The half life has been determined to be 469 8 ms in [27] and 450_{21}^{+13} ms in [28]. Concerning the levels of the daughter nucleus 77 Zn only a few of them have so far been identied. The 772 keV (1/2 isomeric state, T₁₌₂=1.05 0.10 s) has been identied in [29] and the 114.7 keV level together with the 800 keV level have been identied in the -delayed neutron emission of 78 Cu [15]. Only recently, more levels were identied in a decay study at HR IBF [30, 31].

The data set for ⁷⁷Cu can be divided into two parts: the data acquired with the laserson resonance and the data with the lasers-o resonance. In Fig. 2 the main part of the LM D-based data using both HPG e detectors is presented. Both the lasers-on and laserso spectra correspond to the data recorded during the rst 1575 m s after the starting of the implantation period. In this way almost the full statistics of the decay lines from the short-lived ⁷⁷Cu decay are obtained while the intensity of the lines corresponding to the long-lived beam contam inants is reduced. A s can be seen in Fig. 2 the great m a prity of the transitions observed are non resonant, m ainly from the decay of the surface-ionized ⁷⁷G a. The decay scheme of ⁷⁷G a is not very well known [32] but the identi cation of the -ray

lines from the decay was feasible given its prominent presence in both on-resonance and o -resonance spectra. The most intense lines related to ⁷⁷G a decay are indicated with a diam ond sym bol (). O ther lines that appear both in the lasers-on and lasers-o spectra are from the decay of long-lived daughter nuclei originating mainly from ⁷⁷G a or from other isotopes deposited in the tape system during previous runs associated with di erent m ass settings. A s can be seen in F ig. 3 the laser-enhanced lines can easily be identi ed after norm alizing the two spectra of Fig. 2 and subtracting them. The resulted spectrum contains only the peaks related to the 77 Cu decay and daughter activity (77 Zn). At this point it is worth noting that even in the subtracted spectrum the strongest 77 G a lines are still present. The negative counts are due to long-living ⁷⁷G e (11.3 h) which has been growing in since the measurements started. Given the fact that the measurement started with the lasers on resonance and then later with lasers o relatively more counts of ⁷⁷G e are present in the lasers-o spectrum. The 772 keV transition is not present in the coincidence spectra due to the long half-life time (1s [29]) of the isomeric state. Since the decay of ⁷⁷Zn is well known [32] the identication of resonant lines attributed to the 77 Cu decay or to its daughter 77 Zn was feasible. In Figs. 2 and 3 the lines assigned to the decay of ⁷⁷Cu are labelled with a num ber.

Inform ation on the observed ⁷⁷Cu decay lines is sum marized in Table II. The rather high uncertainty on a number of intensities rejects the fact that many of the lines were contaminated. In these cases, the uncertainty of the resulted peak area is much higher than in the cases of single isolated peaks – free of contaminants (e.g. the 1409.3 keV line). As a second step of control of the intensities rejected to the procedure, the net area of each transition in the subtracted spectrum was determined by setting different conditions on the absolute time of each coincident event with respect to the proton pulse of the primary beam. In this way for all the cases reported in Table II the time evolution of the net area counts was determined and was found to be compatible with the expected half-life of ⁷⁷Cu. The coincidence rays were derived from background-subtracted in any spectra are presented. As can be seen in both spectra, several lines are coming from the ⁷⁷G a activity – especially for the 505.7 keV case which is a doublet. These background lines could be identified since they are also present in the laser-o spectra generated with the same gate conditions.

Due to the fact that most of the lines were contam inated with other lines, an accurate

half-life could only be deduced from the time behavior of two lines: the 957 keV and the 1409 keV line. The resulted half-life ($T_{1=2}$ = 467 43 m s) is less precise than but consistent with the reported values in [27, 28] and with our value out of the -delayed neutron m easurem ent. A s can be seen in F ig. 5, a single exponential tof the neutron-counting rate gives a half-life of 467.4(21) m s for ⁷⁷C u, consistent with, but far m ore precise than the published values [27, 28]. The latter value will be further used.

The Mainz neutron long counter consists of three concentric rings of ³He tubes. Low -

energy neutrons are most likely detected in the innermost ring, higher-energy neutrons cover a larger distance before being moderated and detected and are therefore more likely detected in the middle or outer ring. The so-called \ring ratios", i.e. the relative rate of neutrons detected in the middle to inner or outer to inner ring allow to conclude on the average energy of the -delayed neutrons [33]. The energy-dependent detection e ciency was simulated with the M onte C arlo neutron transport code M C N P. The simulations were validated with well-known emitters of -delayed neutrons. Thus, from the ring ratio we found an average neutron energy of about 450(150) keV for 77 C u decay.

W ith a Q value of 10.1(4) M eV for ⁷⁷Cu from the Audi-W apstra system atics [34], a neutron binding energy of 4.557 M eV for ⁷⁷Zn [35], and apparent feedings of 21.6% and 4.7% respectively to the 2_1^+ and 4_1^+ states in ⁷⁶Zn we deduce apparent log ft values of 4.1(2) and 4.4(2) to the neutron em itting states populating by neutron em ission the 2_1^+ and 4_1^+ states in ⁷⁶Zn. N ote that frequently several neutron em itting levels populate the sam e level in the A 1 daughter. Therefore the given log ft values are cum ulative over all neutron em itting states populating the 2_1^+ and 4_1^+ states in ⁷⁶Zn. The uncertainty of the log ft values is dom inated by the uncertainty in the Q value of ⁷⁷Cu.

The decay scheme for ⁷⁷Cu shown in Fig. 6 could be constructed based on the coincidence relations given in Table II. Furtherm ore, use has been m ade of the -delayed neutron-decay data from ⁷⁸Cu [15] (see also Fig. 7). In this decay, rays of 115 keV and 686 keV were seen in cascade and are also observed here in the -decay of ⁷⁷Cu. The strong 115 keV line is only coincident with the 686 and 1170 keV lines. The three lines have no connection with other ⁷⁷Cu decay transitions. In principle, as long as no connecting transitions are found, the 115 keV line could be feeding the (1/2) isomeric level at 772 keV instead of the ground state as proposed in [15] and also assumed here. The present level scheme is in general agreement with the partial level scheme in [30, 31] but extends it considerably.

The relative -ray intensities were calculated from the LM D-based data taking into account the variation of the detection e ciency with respect to the -ray energy. W here necessary, the lines were connected for contam inating rays using the o -resonance data. The relative intensities were calculated with respect to the most intense line at 505.7 keV and are given in Table II. The close detection geom etry can, depending on the multiplicity of the -decay cascade, lead to sum m ing distortions in the intensities. A sonly relative -ray intensities are given and the quoted intensity uncertainties are rather high, these distor-

tions can be neglected. Concerning the isom eric 772.0 keV line, the observed counts were corrected for the mother-daughter decay relation taking into account the implantation and decay cycle. For those transitions observed only in the coincidence spectra, coincidence relations and comparison with other lines were used to extract the intensities.

The feeding shown in Fig. 6 was estimated from the intensities given in Table II assuming the feeding to the ground state and to the isomeric state at 772 keV equal to zero. The same was assumed for the 1363 keV level since the intensity of the 591 keV line de-exciting this level is within the error-bars equal to the total intensity of the rays

that feed this level. The experimental determination of the possible existence of feeding to the ground state and to the isomeric state was in possible since no singles spectrum was acquired that could be compared with the coincidence spectrum. Therefore, and also due to unobserved -ray feeding, the given -branching values should be considered as upper limits and the log ft values as lower limits. The quoted Q value was taken from [34]. Based on the assumption that there is no direct feeding to the (1/2) state at 772 keV, a lower limit of 52% for the -decay probability of this state can be deduced on the basis of the balance of feeding and de-excitation -ray intensities. A remarkable feature of the ⁷⁷Cu decay scheme is the fact that the rays de-exciting the high-energy levels are feeding a limited number of excited states avoiding intense feeding of the (1/2) isomeric state or the (7/2⁺) ground state. A similar pattern is observed in the decay of ⁷⁵Cu and ⁷³Cu [22].

In Fig. 7, a partial decay scheme of 78,77 Cu is presented with emphasis on the -delayed neutron-em ission branch. The strong feeding of the 4⁺ and especially 2⁺ level in 76 Zn in the -delayed neutron-em ission of 77 Cu, indicates that one or more 77 Zn high-energy levels above the neutron binding energy get a large fraction of the overall branching. From the

intensity balance of the 598.3 keV ray and the ⁷⁷Zn rays, a lower lim it for the probability for neutron emission in 77 Cu was obtained: P_n 26% in agreem ent with the recent results of W inger et al [31] and much higher than reported in [36]. Taking into account the spin and energy selection rules for decay and neutron emission and the fact that the -delayed neutron channel relatively populates for 18% the 4^+ state and for 82% the 2^+ state in 76 Zn lim its the possible spin for the 77 Cu ground state to 5/2 and 7/2. Com bining this inform ation with the fact that the -delayed emission of ⁷⁷Cu does feed levels that nally ends up for relatively 54% on the (1/2) isom eric state and for 46% on the $(7/2^+)$ ground state favours a 5/2 assignment for the ground state of ⁷⁷Cu. In this relative feeding, the 772 keV isomeric transition from the (1/2) to the $(7/2^+)$ is not taken into account. The proposition for a 5/2 spin and parity of ⁷⁷Cu is in agreement with recent results from laser spectroscopy experiments at ISO LDE where a 3/2 assignement could be excluded leaving only 5/2 or 7/2 as possible spins [37]. In reference [30], the -decay study of ⁷⁸Cu seems to point to a di erent feeding pattern than observed in our study of 78 Cu [15] where the 910 keV 6⁺ ! 4⁺ transition in ⁷⁸Zn was not seen. Reanalysis of the data con rm s the decay scheme of [30] (see also Fig. 7) through the observation of the 576 keV line de-exciting the 3107 keV level with an intensity of 17 10 % relative to the 730 keV 2⁺ ! 0⁺ transition and a weak peak at 910 keV line (6⁺ ! 4⁺ transition) with a relative intensity of 12 9%. The observation of the 6^+ level, fed in the decay of ^{78}Cu , suggests a spin of at least 5 for the ground state of ⁷⁸Cu. This high spin makes it unlikely that the transitions observed in the -delayed neutron em ission of 78 Cu (115 keV, 686 keV) can be placed on top of the (1/2) isom er in 77 Zn but rather are connected to the ground state (7/2⁺). The spin and parity suggestion of $(9/2^+)$, $(11/2^+)$ of respectively the 115 keV, 800 keV levels is based on the feeding pattern observed in the ^{77,78}Cu decay. The present decay scheme of ⁷⁷Cu is certainly not complete as the relative strong population of the low -lying positive parity states cannot result from direct feeding from the (5/2) ⁷⁷Cu ground state. Two explanations are possible: m issed -ray feeding from higher-lying levels or the existence of a -decaying isomer in ⁷⁷Cu. The latter can propably be excluded as there is no evidence seen in the laser spectroscopy studies of⁷⁷Cu [37].

IV. DISCUSSION

A coording to the results of the present work, a 5/2 spin assignment is proposed for the ground state of ⁷⁷Cu. In Fig. 8, the systematics of the 1/2, 5/2 and 3/2 states which correspond to the ground and instructived states of the neutron-rich odd Cu isotopes are presented. As can be seen in this gure for ⁶³ ⁶⁹Cu, the position of the rst 5/2 level lies almost constantly 1 MeV above the 3/2 ground state. However, when the $g_{9=2}$ neutron orbital starts to be lled, the gap between those levels is dramatically decreased. From the experimental determination of the B (E2; 5/2 ! 3/2) values it has become clear that the nature of the rst 5/2 state in the odd Cu isotopes changes from a core-coupled state in the N < 40 isotopes to a single particle state in the N 40 isotopes. The single particle daracter of the 5/2 state is established from ⁶⁹Cu onwards [9]. The lowering of the 5/2 state is strong enough to become the ground state in ⁷⁵Cu [37]. The observed sharp drop in energy of the 5/2 level, knowin also as monopole migration, is believed to be caused by the attractive proton-neutron j –j tensor force [38] (see also [9, 39]).

The low-energy level structure of the neutron-rich odd-m ass Zn nuclei is dom inated by the $p_{3=2}$, $f_{5=2}$, $p_{1=2}$ and $g_{9=2}$ neutron orbitals. The gradual lowering in energy of the unique parity state $g_{9=2}$ as a function of increasing neutron num ber leads from 69 Zn on to isom erism. In fact, from there on the states based on the $p_{1=2}$ and on the $g_{9=2}$ orbitals lie within 500

keV of each other [22]. The situation is di erent in ⁷⁷Zn as the (1/2) state has risen up to 772 keV above the $(7/2^+)$ ground state. The positive parity levels assigned as $7/2^+$ and $9/2^+$ can be produced by quasi-particle couplings of the $(g_{9=2})^3$ con guration. A similar system where three quasi-particles in $g_{9=2}$ orbit lead to a low-lying $7/2^+$ state has been also observed in the Ag isotopes where three holes in the $g_{9=2}$ shell result in a similar ordering of the $7/2^+$ and $9/2^+$ levels. The $1/2^-$ isom eric state can be interpreted as a $p_{1=2}^$ single particle state. C oulom b-excitation and laser-spectroscopy studies for the odd-m ass Zn isotopes that can be performed in the future as well as the results of the recently perform ed laser spectroscopy experiments for the neutron rich C u isotopes [37] could contribute for a better understanding of the residual proton-neutron interaction in this mass region and the role of the $1q_{9=2}$ orbital.
