N-Body Nuclear Forces at Short D istances in Holographic QCD

W e provide a calculation of N-body (N $_3$) nucleon interactions at short distances in holographic QCD. In the Sakai-Sugim oto m odel of large N_c m assless QCD, N baryons are described by N Y ang-M ills instantons in 5 spacetime dimensions. We compute a classical short distance interaction ham iltonian for N 'thooft instantons. This corresponds to N baryons sharing identical classical spins and isospins. We nd that genuine N-body nuclear forces turn out to vanish for N 3, at the leading order. This suggests that classical N-body forces are always suppressed compared with 2-body forces.

Introduction. Recent developments in computational nuclear physics reveals that the m icroscopic description of nucleus in terms of nucleon degrees of freedom requires three-nucleon interactions. In fact, although the nuclear three-body interaction is weaker than the two-body interaction, the binding energies of light nuclei [1] and the saturation density of nuclear matter [2] cannot be understood without taking into account the three-body term s. This is due to a large cancellation of the kinetic energy and two-body attraction. The main component of the three-body interaction is associated with two-pion exchange, such as the Fujita-Miyazawa force [3]. However, in addition to this, a repulsive threebody interaction of short range is required for quantitative description of nuclear systems [1, 4]. The shortrange three-nucleon interaction, which is assumed to be spin-isospin independent in m any cases, is im portant for determ ination of the nuclear equation of state at high density [2, 5].

The two-body interactions adopted in those manybody calculations are determined by the phase-shift analysis of nucleon-nucleon scattering data. How ever, much less information is available for the N-body forces (N 3). Of course, we know that, in principle, the nuclear

properties should be derived from QCD [6]. However, QCD is strongly coupled at the nuclear energy scale, which leads to a huge gap between QCD and nuclear many-body problem s.

A recent progress in string theory can bridge this gap, analytically. It is called holographic QCD, an application of of gauge/string duality [7] to strongly coupled QCD. We apply the holographic QCD to N-body nuclear force (N = 3).

In holographic QCD, one of the most successful D-brane models is Sakai-Sugim oto model (SS model)[8,9]. The theory, which is a U (N $_{\rm f}$) Yang-M ills-Chem-Simons (YM-CS) theory in a warped 5-dimensional space-time, was conjectured to be dual to low energy massless QCD with N $_{\rm f}$ avors, in the large N_c and large limits (

 $N_{c}g_{QCD}^{2}$ is a 'thooft coupling of QCD). Modes of the gauge elds correspond to meson degrees of freedom and this model reproduces surprisingly well various expected features of hadrons, incorporating very nicely the nature of chiral Lagrangians.

Baryons are identi ed with soliton solutions localized in the spatial 4-dim ensions [8]. This is quite analogous to that in pion e ective theory, baryons are identi ed with Skymions. Quantization of a single soliton in the SS model [10, 11] gives baryon spectra, and also chiral properties such as charge radii and magnetic moments [12] (for other approaches to baryons, see [13]). M esonbaryon-baryon couplings [12] give a basis of a 2-body nuclear force at long distances, a la one-m eson-exchange picture. Short-distance nucleon-nucleon forces were com puted [14], which generates a repulsive core with analytic formula for potentials in the large N_c limit. A key is that the warping can be absorbed into the rescaling of the YM-CS theory and brings the string scale to QCD scale. Furtherm ore, when two solitons are close to each other, the warping factor is alm ost constant, therefore the e ects of the curved geom etry can be ignored so that an exact two-soliton solution is available.

In this letter, we compute N -body nuclear forces for arbitrary N , with exact N -instanton solutions, generalizing the m ethod in R ef. [14]. The exact treatm ent is in contrast to the Skyrm ion and other chiral soliton m odels, in which multi-soliton solutions are quite di cult to obtain.

| N uclear Force at Short R ange. Baryons, including nucleons, are identieed with solitonic solutions in the SS model [8], and we provide a brief review of the construction of the soliton and the 2-body nuclear force at short range for two avors ($N_f = 2$) computed in [14].

The following rescaling of the coordinates [10] can allow one to understand the system as a 1= perturbation around a at space, which is suitable for studying the instanton solution:

and accordingly $\hat{R}_0(t; \mathbf{z}) = A_0(t; \mathbf{z})$ and $\hat{R}_M(t; \mathbf{z}) = {}^{1=2} A_M(t; \mathbf{z})$. In the following we omit the tilde for simplicity. In these new variables, there are essentially

two deviations from the YM theory in the $% 1^{2}$ at space, at the leading order in 1= expansion: (i) the e ect of the CS term , and (ii) the e ect of the space weakly curved along the x^4 direction. The additional ham iltonians are

respectively, with a $1=(216^{-3})$. Note that we work in the unit M_{KK} = 1, where M_{KK} is the unique scale parameter appearing in the model, and it can be xed by tting the meson mass, giving M_{KK} = 949 [MeV].

In particular, for a single baryon, the leading order solution is a single instanton in the at 4-dim ensional space, that is BPST instanton [15]. The instanton has moduli parameters: the instanton location X^M, the size and the orientation in SU (2). These ham iltonians induce potentials in the moduli space of the instanton, and and X⁴ prefer particular values classically, $(_{cl})^2 = \frac{1}{8^{-2}a} - \frac{6}{5}$, X⁴_{cl} = 0. For multi-instantons, there appears a potential for the moduli representing the distance between the instantons, which is in fact the nuclear force.

In Ref. [14], this 2-body nuclear force was evaluated explicitly. Multi-instanton solutions are available in at space, while in this particular curved space it is di – cult to nd them. However, when instantons are close enough to each other, the e ect of the curved space can be neglected, and as a leading order solution we can use the multi-instanton solutions in the at space. Therefore, the distance r_{ij} between the i-th and the j-th nucleons allowed in this approximation is $\dot{r}_{ij}j < M_{KK}^{-1}$ ($\dot{r}_{ij}j < {}^{1=2}M_{KK}^{-1}$) in the original (rescaled) coordinates. Thus we probe only the short range for the nuclear force.

The construction of the two-instanton solution owes to the renowned ADHM (A tiyah-D rinfeld-H itchin-M anin) m ethod [16, 17]. The m oduli parameters of generic N instanton solutions are completely encoded in the real N N matrix function L (x;X;). The O shorn's m ula [18] tells us the instanton density

where $Q_{M} @_{M}$. Using this expression, the equation of motion for the U(1) part of the gauge eld which is sourced by the instanton density is solved as [10]

W ith this explicit dependence on the instanton m oduli param eters in L, one can compute the ham iltonians (2) and (3) as functions of them. Then, the expectation value of the ham iltonians for given baryon states (the wave functions are written by the m oduli param eters) gives the nuclear force at short range [14].

There is the third contribution to the additional ham iltonians, H_{kin} , which is present only in multi-instanton

case. This comes from the metric of the instanton moduli space. In R ef. [14], it was shown that it is higher order in $1=N_c$ compared to the other two ham iltonians (2) and (3), so we need not compute it in this paper.

| 3-body Nuclear Force. The 2-body nuclear force computed in Ref. [14] is for generic spin/isospin components. But since explicit generic N instanton solution is not available, we consider a special solution called 'tH ooft instanton which has 5N = 3 m oduli parameters (while generic instanton solution has 8N = 3 m oduli parameters). It is important to notice that once we restrict our m oduli space by hand like this, we cannot get the generic expression for the nuclear force for given baryon states. Instead, what we will obtain is a classical analogue of the nuclear force.

The moduli parameters of the 'thooft instantons are only the size $_{i}$ and the location X_{i}^{M} of each instanton (i = 1;2;; N). The missing parameters, the orientations of the instantons in SU (2), are responsible for the spin/isospin wave functions of the baryons. Thus our analysis with the 'th ooft instantons is restricted to \classical" baryons, where all the spin/isospins of the baryons are identical classically.

First, let us show that $H_{pot}^{SU(2)}$ given in Eq. (3) is irrelevant to the three-body nuclear forces. We can use the generic form ula obtained in Appendix C of Ref. [14],

for the N 'tH ooft instantons. The expression consists of just a sum of each instanton sector, which m eans that there is no term involving the inter-nucleon distance, that is, no contribution to the nuclear force. Therefore, we compute the other ham iltonian (2) in this paper. (The contribution from H_{kin} is suppressed as in the case of the 2 instantons [19].)

In this section, we concentrate on the case for N = 3, i.e. the 3-body force.

). The O shorm's for-For three 'th ooft instantons, which correspond to nucleons sharing classically identical spins/isospins, we have

where we om it the index M and denote $(x^{M})^{2}$ by x^{2} . Then the O shorn's form ula becomes particularly simple,

The rst term in Eq. (8) is a self-energy which was already computed, and f is a harmonic function, i.e., f = 0. Thus, all we need to evaluate is only the last term in Eq. (9), $(\mathbb{Q}_{M} f)^{2} = f^{2}$.

For three instantons, we can expand the expression for $(x \quad X_1)^2 \quad (x \quad X_2)^2$; $(x \quad X_3)^2$. In particular, we can approximate $(x \quad X_2)^2 \quad (X_1 \quad X_2)^2 \quad X_{12}^2$, and a similar expression for X₁₃. Furthermore, for simplicity we put X₁^M = 0. Then, the expansion is

W e like to compute the potential (2). As seen from the expression for $\hat{A_0}$, the leading term of the nontrivial three-body force has the form $\frac{1}{X_{12}^2 X_{13}^2}$. This means that, we should expect the nuclear force appearing in proper to the 3-body is, at the leading order,

in the original coordinates. Let us consider only term s of this leading form (11). We obtain

Perform ing the derivatives, and using the follow ing integration formulas

we nd that the right hand side of Eq. (2) vanishes. Therefore, the leading term of the order $1=(X_{12}^2X_{13}^2)$ vanishes. This means that the expansion starts from the next-to-leading order,

is xed to be () by a dimensional analysis. The expectation value of this () at the leading order in large N_c is given by the classical value given before. Then, rescaling the coordinates back as X₁₂ ! $^{1=2}X_{12}$ and write it as the 3-dimensional inter-nucleon distance r_{12} since we substitute the classical value X_i⁴ = 0, we obtain, at the leading order in 1=N_c,

again represents term obtained by permutation for the indices 1;2;3.

Note that we are working in a regime $^{1=2}$ X $_{12;13}$ 1 in the unit M $_{KK}$ = 1. The natural scale for the 2-body force [14] is 0 (N $_{c}$ = X $^{2}_{12}$). So, if we consider a natural separation of the nucleons as X $_{ij}$ 1=M $_{KK}$, the 3-body force is suppressed com pared to the 2-body force. W e conclude that the 3-body force at short range is sm all, for baryons carrying classical and equal spin/isospins.

| N-body Nuclear Force. We can easily extend the analysis in the previous section to N 'thooft instantons. The result for the leading term vanishes again, as we explain brie y below.

The quantity necessary for computing $\hat{A_0}$ is

A gain, we have rescaled back the coordinates to the original coordinates and represents permutation terms. In the previous section, we showed that for N = 3 this leading contribution vanishes, for the 'th ooft instantons. In this section, we prove that for any N this leading contribution vanishes.

First, in the integral (2), it is straightforward to obtain

where represents term s obtained by permutation for sing the form ula (13), this can be easily integrated with the indices 1;2;3. Here the dependence on $_i$ (i = 1;2;3) d^4x to give 0.

In the ham iltonian (17), there are additional term s

com ing from the statem in Eq. θ). In the sam emanner this is shown to vanish at the order (17). Therefore, we conclude that the leading order N-body nuclear force (17) vanishes, for arbitrary N. Note that the 2-body nuclear force does not vanish at the leading order, as N = 2 com putation is exceptional.

| Sum m ary and D iscussions. U sing the SS m odel of holographic QCD, we have found that the N-body nuclear force at short range (N 3) is order of N_c (r^2)^N, for nucleons sharing identical classical spin/isospins. This is small compared to the 2-body force which is O (N_c(r^2)¹) in contrast, and it leads to a hierarchy of the (N + 1)-body / N-body ratio V (N + 1)=V (N) 1=(r^2) 1 for N 3, in the unit M_{KK} = 1. This suppression is consistent with our empirical know ledge.

E ects of the short-range m any-body interaction becom esm ore prom inent for higher-density nuclearm atter. Therefore, for physics of neutron stars and supernovae, for instance, properties of N -body interactions such as what is revealed in this letter are in portant, even if qualitative.

Our computation is not fully satisfactory since the quantum spin/isospin states of each baryon have not been incorporated. The wave function of the classical

spin/isospin is a delta-function of the SU (2) orientational m oduli of the instantons, thus it is di cult to relate it with the quantum spin/isospins. Nevertheless, it is quite rem arkable that the generic N -body nuclear force can be obtained by analytic com putations. The successful perform ance of this com putation owes in particular to the sim plicity of the SS m odel, in contrast to other chiral soliton m odels.

Furtherm ore, the theory on which our computations of the nuclear force is based is not a phenom enological model but a theory which has been \derived" from large N_c QCD at strong coupling, through the gauge/string duality. Therefore, in principle, we can try to address theoretically what is di erent from QCD and what is inherited from it. The present computations go beyond the limitations of argum ents using universality of chiral symmetry breaking.

A lthough the m odel at hand is for large N $_{\rm c}$ QCD, these two properties of baryons in holographic QCD would be su ciently strong motivations for studying holographic QCD and its relation to nuclear physics further.

- r^2 =16 2 aN $_c$ gives [19] Let us explain brie y why H _{kin} sm aller contributions com pared to the other two ham iltonians. Here r² is the metric on the multi-instanton moduli space. W e evaluate the expectation value of r 2 with the baryon states. The dimension of r 2 is [length] 2 . The leading 2-body forces are / $1=X_{12}^2$, so the rem aining factor should be dimensionless. Thus r² originating in the metric is written only by using a dimensionless operator y @=@y twice, where y is the moduli and the SU(2) orientations. Then it was found in Ref. [14] that $hr^{2}i = O(N_{c})$, so, in total, after rescaling back $\chi f ! \chi f$, one obtains $hH_{kin}i = O(1)$, which is smaller than hH $^{SU(2)}i$ hH $^{U(1)}i$ O (N $_{c}$ =) by the factor of 1=N $_{\rm c}$. This suppression by 1=N $_{\rm c}$ is expected to any instanton number, that is, general N-body force, and so in this paper we don't consider H $_{kin}$.
