Scalar gluons and D irac gluinos at the LHC

The hybrid N = 1/N = 2 supersymmetric model predicts scalar gluons (sgluons) as SUSY partners of the Dirac gluino. Their strikingly distinct phenomenology at the CERN Large Hadron Collider is discussed.

1. Introduction

A m ong m any propositions for the physics beyond the Standard M odel (SM), supersym m etry (SUSY) is generally considered m ost elegant and respected. It can accomm odate or explain some of the outstanding problem s of the SM. In fact this is the only m athem atically consistent UV completion of the SM that stabilizes the gap between electroweak and P lanck scales. It provides the gauge coupling uni cation, radiative electroweak sym m etry breaking, a candidate for dark m atter (DM), o ers new ideas on the m atter-antim atter asym m etry etc.

The sim plest N = 1 supersymmetric extension calls for each SM particle a sparticle that di ers in spin by half a unit. The Lagrangian must be supplemented by SUSY breaking terms that keep unseen superpartners out of the current experimental reach while retaining all goodies of the model: renormalizability and perturbatively stable hierarchy of scales. With ever improving experimental constraints on SUSY breaking parameters, mainly

from avor and Higgs physics, the model building of successful SU SY breaking scenarios becom es more and more di cult.

However, the successes of SUSY do not rely on its simplest realization. In fact, non-m inim al realizations m ay am eliorate some of the above problem s. For example, D irac gauginos (in contrast to M a jorana in N = 1) forbid some of the couplings and m ay lead to additional suppression of loop contributions with gauginos in avor-changing processes. Such scenarios can be based on D-term supersymmetry breaking models [1, 2] or continuous R-symmetries [3].

A D irac gaugino requires additional ferm ionic degrees of freedom. They can be provided by adding chiral super-multiplets in the adjoint representations of the corresponding gauge group, as realised in N = 2 SU SY [4]. When extending to N = 2, the additional supersymmetry also requires the introduction of mirror matter super elds. In order to avoid chirality problems the N = 2 mirror (s)ferm ions have to be assumed to be heavy. Thus electively we consider a hybrid model that expands to N = 2 only in the gaugino sector [5].

Here we will present elements of the phenom enology of the scalar partner of the D irac gluino (sgluon), as worked out in a recent paper [6]; see also [7]. For an independent analysis of sgluons at the LHC, we refer to R ef. [8].

2. Basics of the N = 1/N = 2 hybrid m odel

If gluinos are seen at the LHC one of the main experim entalgoals will be to verify if they are M a prana or D irac ferm ions. To address properly this issue a theoretical model is needed that allows a smooth D irac/M a prana transition, as for example the hybrid model constructed in R ef. [5].

In N = 1 gluinos are M ajrana elds with two degrees of freedom to m atch gluons in the color-octet vector super-multiplet. To provide the two additional degrees of freedom for Dirac elds, the usual N = 1 gluon/gluino fg^a;g^ag super-multiplet W₃^a = g^a + D^a + () G^a + ::: (a = 1;:::;8) is supplemented by an additional N = 1 color-octet chiral super-multiplet ^a = ^a + ^b 2 g^{0a} + F^a of extra gluinos g^{0a} and scalar ^a elds to form a vector hyper-multiplet of N = 2 SUSY. Sim ilarly, the electrow eak sector, not to be discussed here, is supplemented by additional SU (2)_L and U (1)_Y super-multiplets [9].

2.1. D irac/M a jorana gluinos

Standard g and new gluinos g⁰ couple m in in ally to the gluon eld

as required by the gauge symmetry. Here g_s denotes the QCD coupling, the eds g; g; g^0 are color-octet matrices (e.g. for the gluon $g = \frac{1}{p_2^2} a^2 g^a$ with

the G ell-M ann m atrices ^a); g and g⁰ are two 4-com ponent M a prana spinor elds. Q uark and squark elds interact on ly with the standard gluino,

since only their m irror partners (assumed to be heavy) couple to $g^0,$ as required by $N=2\;\text{SUSY}$.

Soft supersymmetry breaking generates masses for the gluino elds g and q^0 ,

D isogonal terms are induced by the individual M a prana mass parameters M₃ and M₃⁰ while an o-diagonal term corresponds to the D irac mass. It can arise from the D term, $d^2 \frac{P_2}{M_0} W^0 W_3^a = h c: W$ hen a hidden sector spurion eld W⁰ gets a vacuum expectation value, $W^0 i = D^0$, the D irac mass is generated, $M_3^D = D^0 = M_0$.

D iagonalization of (3) gives rise to two M a jorana m ass eigenstates, g_1 and g_2 , with m asses m₁ and m₂. There are two limiting cases of interest: in the lim it M $_3^0$! 1 the standard M a jorana gluino is recovered; in the lim it of vanishing M a jorana m ass param eters M $_3$ and M $_3^0$ with M $_3^D \notin 0$, them ixing is maxim aland the two M a jorana gluino states are degenerate. O ne can draw a sm ooth path interpolating these two limiting cases by introducing an auxiliary param eter y 2 [1;0] and param eterizing M $_3^0 = yM _3^D = (1 + y)$, M $_3 = yM _3^D$. With M $_3^D = m_{g_1}$ kept xed, the param eter y allows for a continuous transition from y = 1, where the standard limit is reached with one M a jorana gluino (the second being in nitely heavy), to y = 0 that corresponds to two degenerate M a jorana elds combined to a D irac gluino

The phenom enology of D irac gluinos is characteristically di erent from M a jorana. The detailed discussion can be found in R ef. [5], from which we borrow an exam ple for illustration. Fig. 1 shows the partonic cross sections $qq^0! qq^0$ (left) and $qq^0! qq^0$ (right) for di erent- avor squark production, in both cases m ediated by the gluino t-channel exchange, plotted as a function of a D irac/M a jorana control param eter y (for partonic center-of-m ass energy r s = 2000 GeV, $m_q = 500 \text{ GeV}$ and $m_{g1} = 600 \text{ GeV}$). We see that $[qq^0! q_L q_R^0]$ and $(qq^0! q_L q_L^0) = (qq^0! q_R q_R^0)$ are non-zero in the M a-jorana lim it but vanish in the D irac, while $[qq^0! q_L q_L^0] = [qq^0! q_R q_R^0]$ and $(qq^0! q_L q_R^0)$ are non-zero for any y and reach the sam e values in both lim its. For equal- avor quark-antiquark scattering the additional gluino s-channel exchange m ust be added to the t-channel exchange diagram s.

2.2. Sgluons

The gluinos g^{0a} are accompanied by a color-octet complex scalar eld a^{a} . In parallel to the case of degenerate M a jorana gluinos combined to the D irac, the real and imaginary components of the scalar eld will be assumed degenerate with the spluon m ass denoted by M [6].

A lthough spluons are R-parity even, they cannot be singly produced at tree level in gluon-gluon or quark-antiquark collision. This is so because they couple only in pairs to gluons, g and gg, as required by the gauge sym m etry, and singly only to D irac gluino pairs via the Y ukaw a-type gauge interaction

where f^{abc} are the SU (3)_c structure constants. It is interesting to note that even the loop-induced gg coupling due to gluino exchange vanish as a consequence of Bose symmetry since the coupling is even in momentum space but odd, f^{abc} , in color space.¹

W hen SUSY is broken spontaneously, the D irac gluino m ass generates, via the super-QCD D term, a scalar coupling between and squark pair [1]

Note that the L and R squarks contribute with opposite signs. Since squarks couple to gluons and quarks, the loop diagram s with squark/gluino lines, Fig. 2, generate gg and qq couplings. The interaction Lagrangian how – ever, eq. (6), in plies that all L – and R –squark contributions to the couplings

com e with opposite signs so that they cancel each other for m ass degenerate squarks. In addition, the quark-antiquark coupling is suppressed by the quark m ass as evident from general chirality rules.

3. Sgluon production and decays at the LHC

Since solutions have a large color charge they m ight be m ore copiously produced than squarks at the LHC. In addition they have quite spectacular decay m odes, as discussed below .

3.1. Sgluon decays

Sgluons can decay into a variety of di erent channels that include gluinos, squarks, gluons and quarks. At tree level the particles can decay only to a pair of D irac gluinos g_D or into a pair of squarks (if kinem atically open),

where $g_{\mathcal{P}_{a}}$ are the velocities of $g_{\mathcal{P}_{a}}$ (a = L;R). If $M < 2M_{g_{D}}$; $2m_{q}$, one or both of these sparticles can be virtual. Squarks and gluinos will further cascade to SM particles and LSP.

Decays into gluon or quark-antiquark pairs can proceed only via loop-induced couplings. In the case of no L=R squark m ixing² the decay widths

take the form

where $q_{L,R} = 4m_{q_{L,R}}^2 = M^2$ and f() is the standard function from a squark circulating in the loop [10], while the elective scalar (I_S) and pseudoscalar (I_P) qq couplings are given by (i = S;P)

In the above expression $w_S = 1$ x y, $w_P = 1$, $z_S = (x + y)=9$, $z_P = 0$, and the squark/gluino denom inators are (a = L ;R)

Because of the chirality, decays to quark-antiquark pairs are suppressed by the quark m ass. Therefore the decays into top quark pairs will dom in ate. In addition both bop-induced decays ! gg and ! qq are absent if L and R squarks are degenerate. Therefore squarks with substantial mixing (m ostly top squarks) will contribute to the decay widths.

The hierarchy between the tree-level and loop-induced decay modes depends on the values of various soft breaking parameters. The tree{level, two{body decays of eqs. (7,8) will dominate if they are kinematically allowed. Well above all thresholds the partial width into gluinos always dominates: it grows / M since the supersymmetric gg coupling is dimensionless, while the partial width into squarks asymptotically scales like 1=M due to dimensionfull SUSY-breaking gq coupling.

W hen the above decay channels are shut kinem atically, even for sm all L-R squark mass splitting the loop-induced spluon decays into two gluons, and to a tt pair if kinem atically allowed, always dom inate over tree-level o shell four{body decays ! gqq~ and ! qq~~. Increasing the gluino mass increases the qq coupling. As a result, the partial width into two gluons (due to pure squark loops) increases, while the tt partial width (due to m ixed squark{gluino loops) decreases since the increase of the qq couplings is over{com pensated by the gluino m ass dependence of the propagators.

The above qualitative features are veried numerically in Fig. 3, where the branching ratios for decays are shown for two dimensional squark/gluino

m ass hierarchies. P lots are done for m oderate m ass splitting between the L and R squarks of the ve light avors, and som ew hat greater for soft breaking tm asses: m $_{\mathfrak{T}_{R}} = 0.95m _{\mathfrak{T}_{L}}$; m $_{\mathfrak{t}_{L}} = 0.9m _{\mathfrak{T}_{L}}$; m $_{\mathfrak{t}_{R}} = 0.3m _{\mathfrak{T}_{L}}$ with the o {diagonal element of the squared tm ass matrix X $_{t} = m _{\mathfrak{T}_{L}}$; the gluino is taken to be a pure D irac state, i.e. $m_{\mathfrak{q}} = 3M _{\mathfrak{I}_{L}}^{D}$ j.

3.2. Sgluon production at the LHC

The signatures for single production are potentially very exciting. They can be produced singly in gluon-gluon collisions via squark loops since the production via qq annihilation is negligible for light incom ing quarks. The partonic cross section is given by

where the partial width for ! gg decays is given in eq.(9). The expected cross section for single production can be quite large at the designed LHC energy, of the order 100 fb. Its dependence on the sgluon mass is shown by the curves (c) and (d) in Fig.4 (with the LO CTEQ 6L parton densities [11]). In the scenario of the right fram e of Fig. 3, the single cross section can exceed the -pair production cross section for M 1 TeV (solid curve (c)); the dashed one (d) is for the benchm ark point SPS1a⁰ [12] with the gluino m ass interpreted as a D irac m ass. Since the latter scenario has a som ew hat sm aller gluino m ass, it generally leads to sm aller cross sections for single production.

It would be very exciting to observe the spluon as an s-channel resonance. This how ever will not be easy since (a) the 2-gluon decay channel must be discrim inated from large background, (b) large production cross section in the gluon fusion in plies dim inished decay rates to other channels, which in addition do not allow a direct reconstruction of M . D etailed experimental simulations are needed to see if the single production can be detected as a resonance above the SM and SUSY backgrounds.

Sgluons can also be pair-produced in qq and gg processes at tree-level,

where p is the invariant parton-parton energy, M and are them ass and center-of-m ass velocity of the particle, and L = $1 \log(1 +)=(1)$. The cross section for -pair production at LHC, pp ! , is shown by the solid curve (a) in Fig.4 for the -m ass range between 500 G eV and 2 TeV. W ith values from several picobam downwards, a sizable event rate can be generated. As expected, due to large color charge of the spluon, the cross section exceeds stop or sbottom -pair production (dashed line

(b)), mediated by a set of topologically equivalent Feynm an diagram s, by more than an order of magnitude.

W ith the exception of ! gg, all the decays give rise to signatures that should easily be detectable. M ost spectacular ones come from ! gg decay followed by the gluino decays giving at the end at least four hard jets and two invisible neutralinos as LSP's. The -pair production then generates nalstates with a minimum of four LSP's and eight jets with transverse m om enta distributions markedly di erent from the corresponding standard gluino or squark production with the same m ass con gurations [6]. O ther interesting nal states are four top squarks $t_1 t_1 t_1 t_1$, which can dom inate if $m_q < m_g$ and L-R mixing is signi cant in the stop sector, and qq gg if $M > 2m_g > 2m_q$. They also give rise to four LSP's in the nal state and a large num ber of hard jets.

The gg + gg and tt+ tt nalstates, which can be the dom inant modes if the two{body decays into squarks and gluinos are kinem atically shut, m ight also allow the direct kinem atic reconstruction of M \cdot P relim inary analyses of the gg + gg channel show that pairing the four hardest jets in the central region of rapidity with no m issing E_T could reveal the signal and provide a m eans to reconstruct the mass directly [13]. In addition, the observation of tctc nal states would signal a substantial m ixing in the up-type squark sector.

4.Summary

M odels with D irac gauginos o er an interesting alternative to the standard SUSY scenario. They predict the existence of scalar particles in the adjoint representation of the gauge groups. The color-octet scalars, sgluons, can be copiously produced at the LHC since they carry large color charge. Their signatures at the LHC are distinctly di erent from the usual topologies. D epending on the assum ed scenario of m asses and SUSY breaking param eters, either multi-jet nal states with high sphericity and large m issing transverse m on entum are predicted, or four top quarks and/or four gluon jets should be observed in 2 production. In the latter the sgluon m ass could be reconstructed directly. If the m ass splitting between L and R squarks is not too sm all, loop {induced single production m ay also have a sizable cross section. It rem ains to be checked by detailed experim ental sim ulations whether such a single resonant production is detectable on the large SM and SUSY background.
